DESCRIPTION

FIG. 1 is a frontal perspective view of a flat-panel switch, showing our new design;

FIG. 3 is a side elevational view thereof;

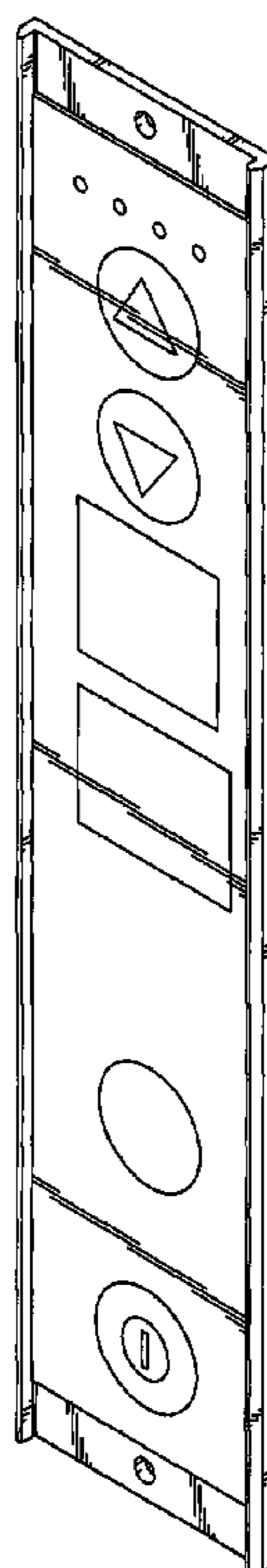
FIG. 4 is a top plan view thereof;

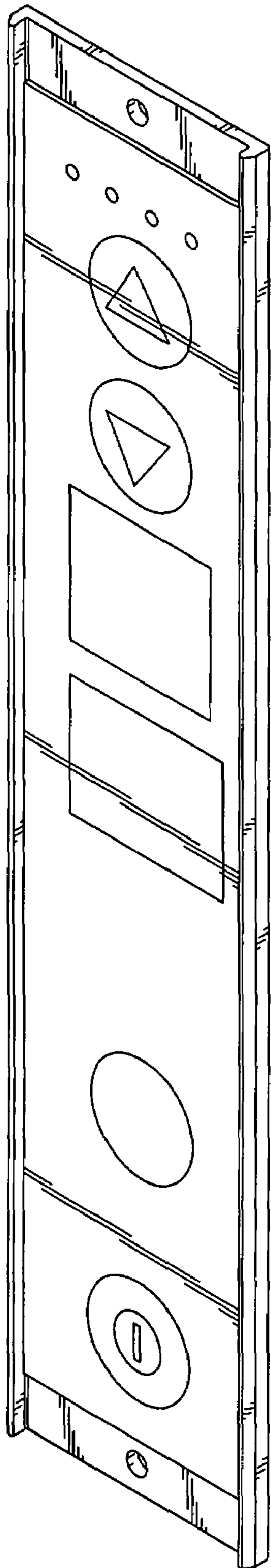

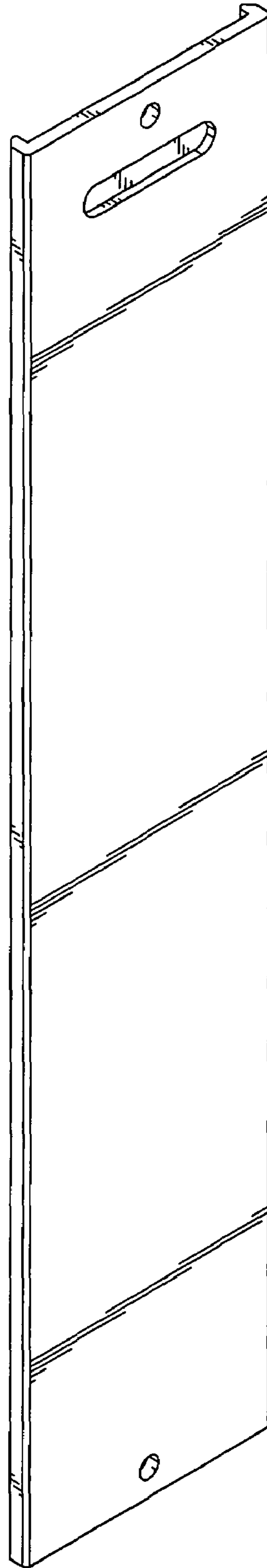

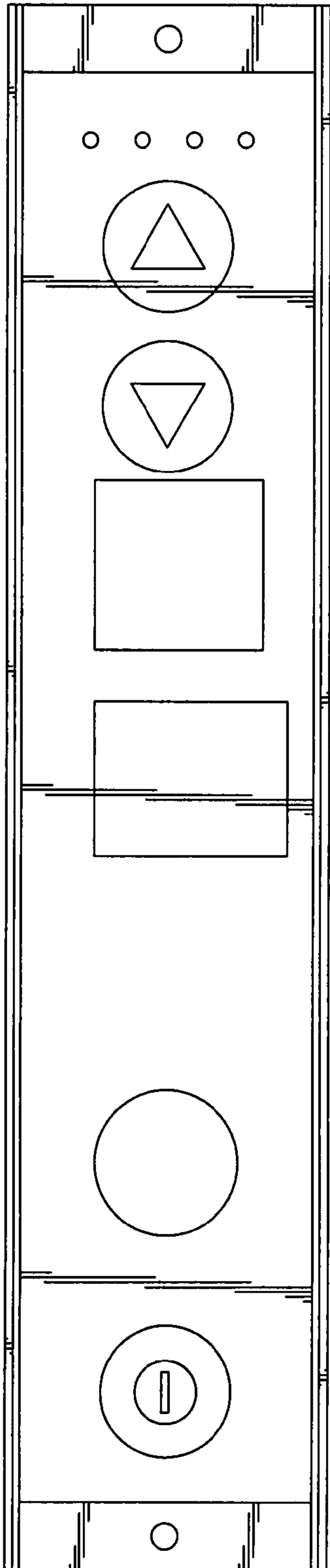

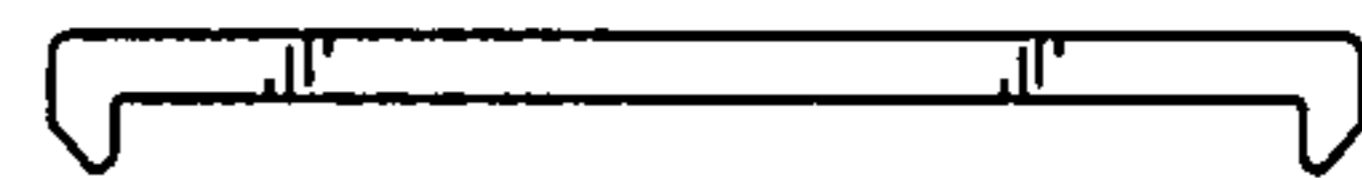

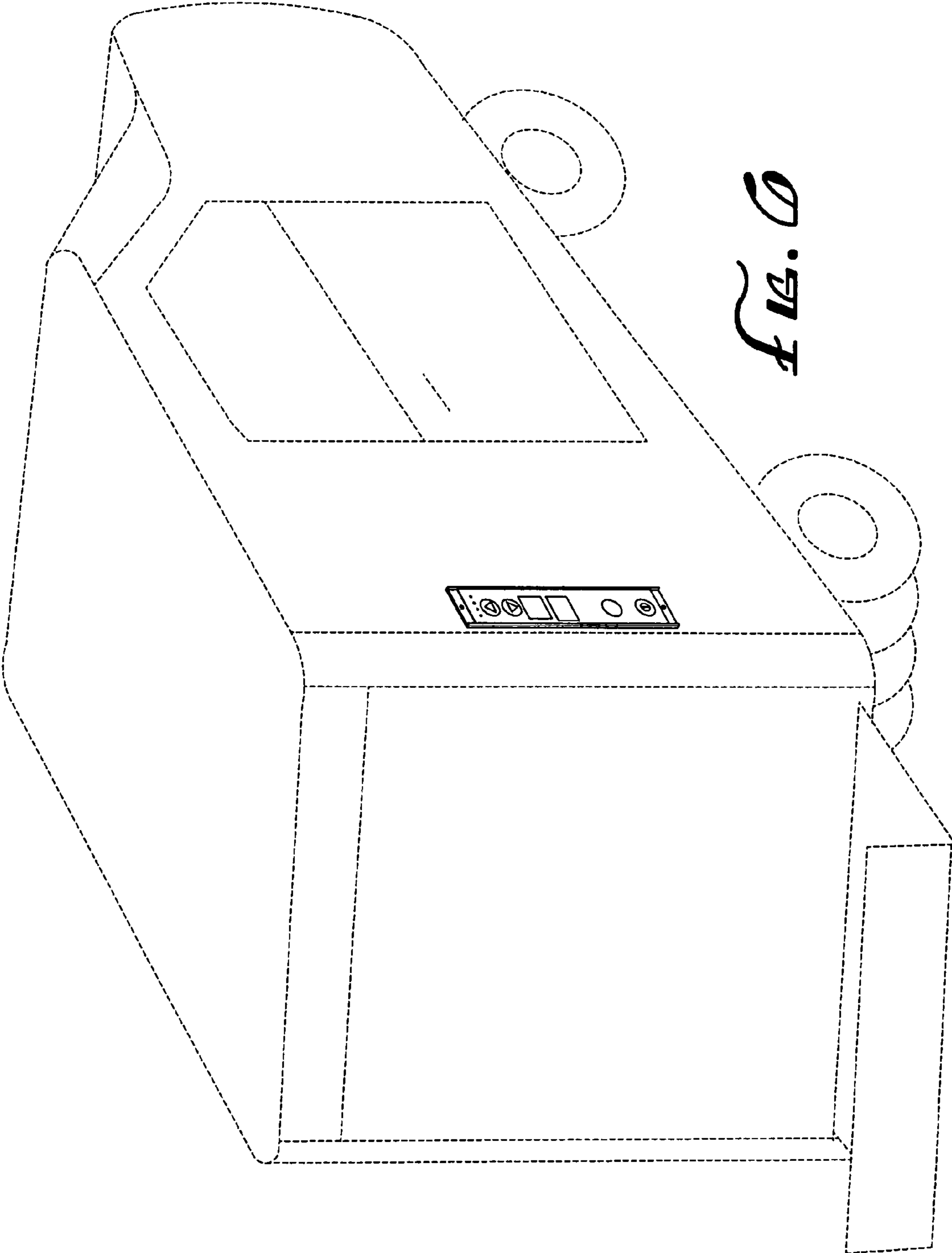
