**DESCRIPTION**

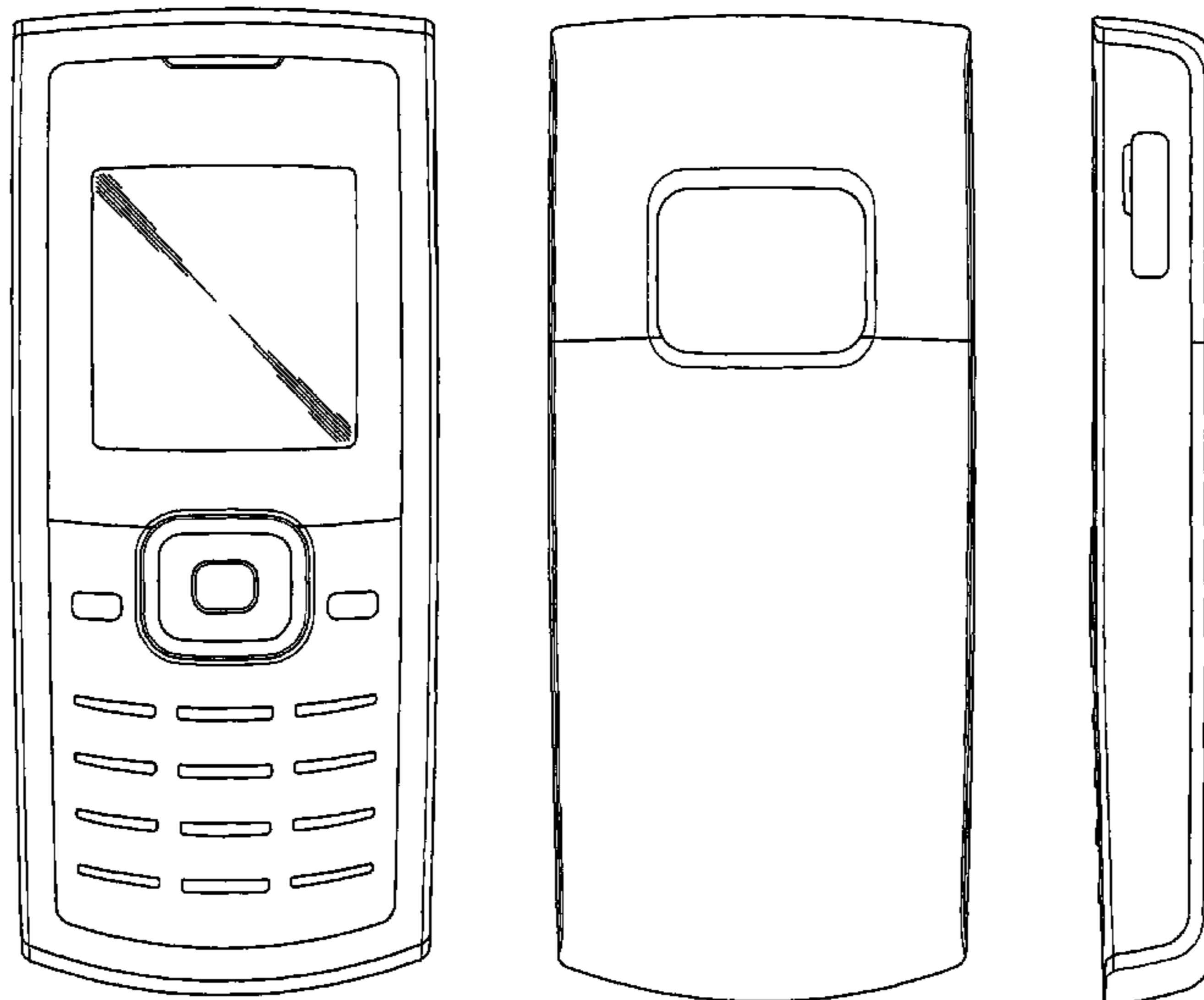

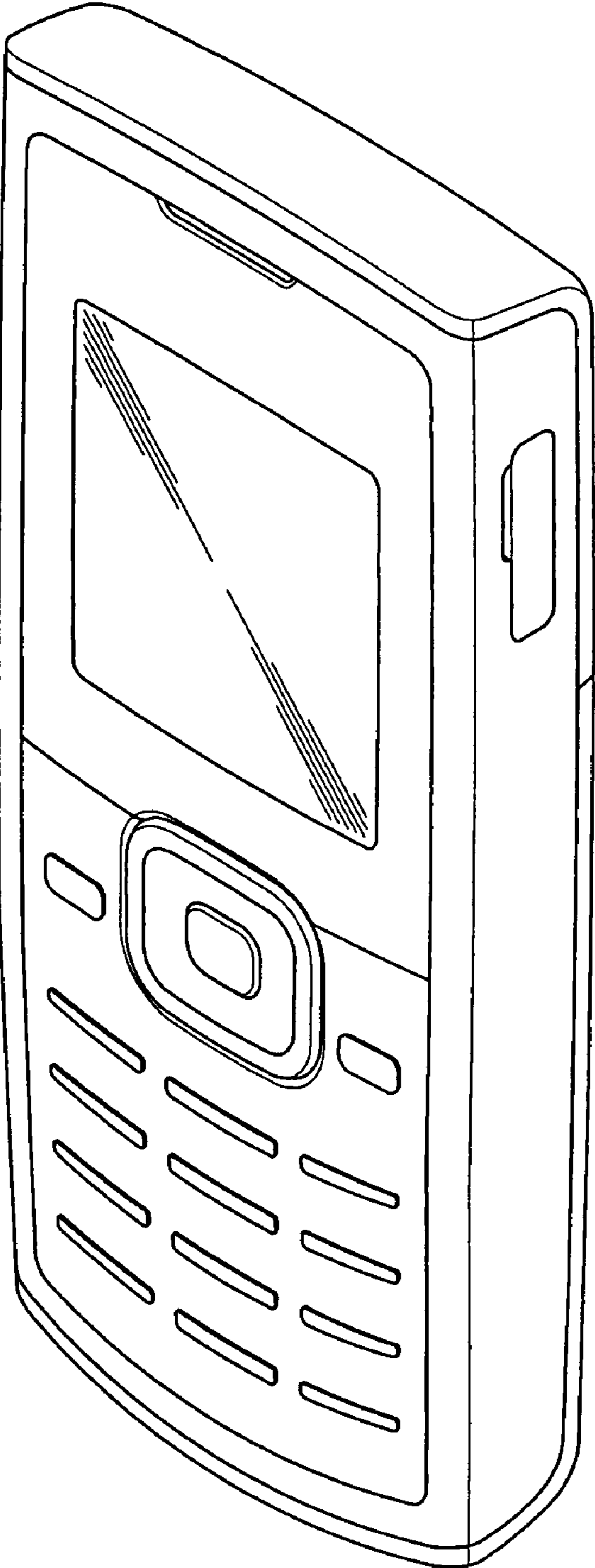

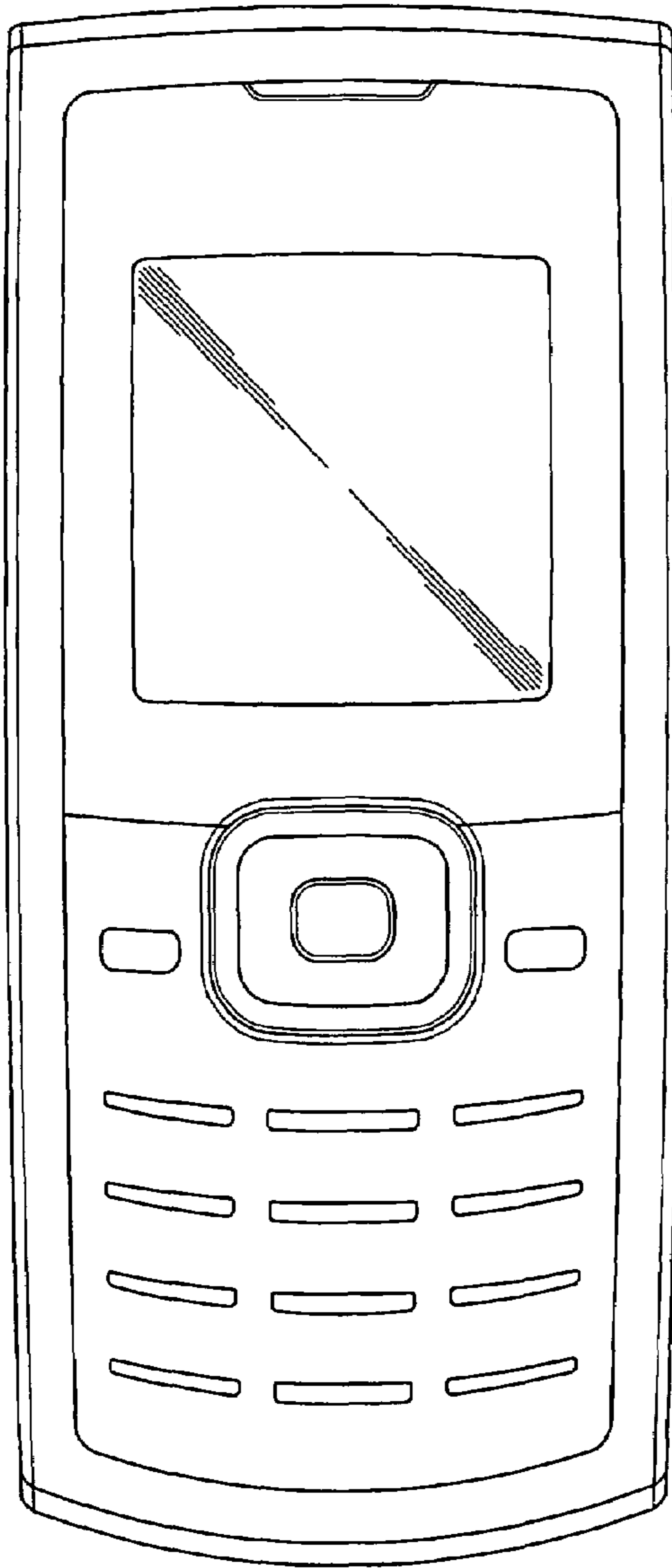
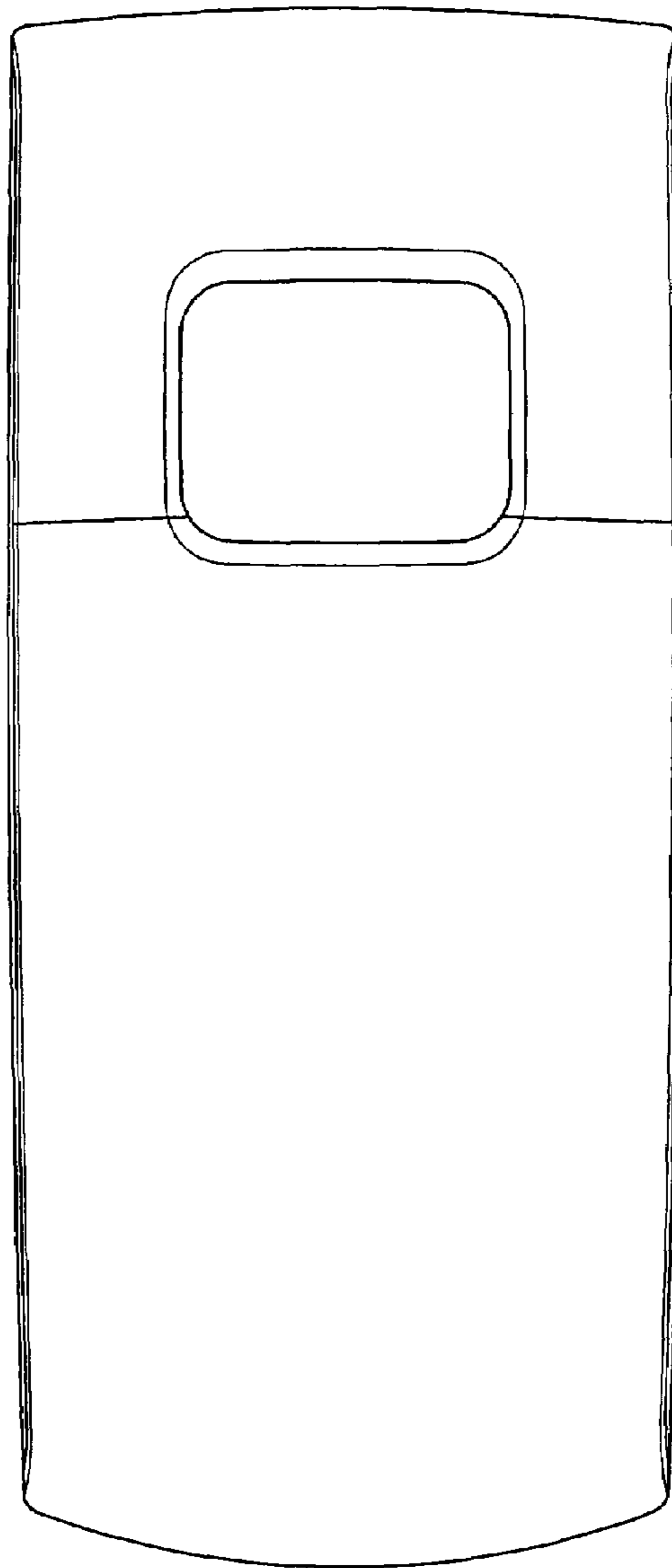
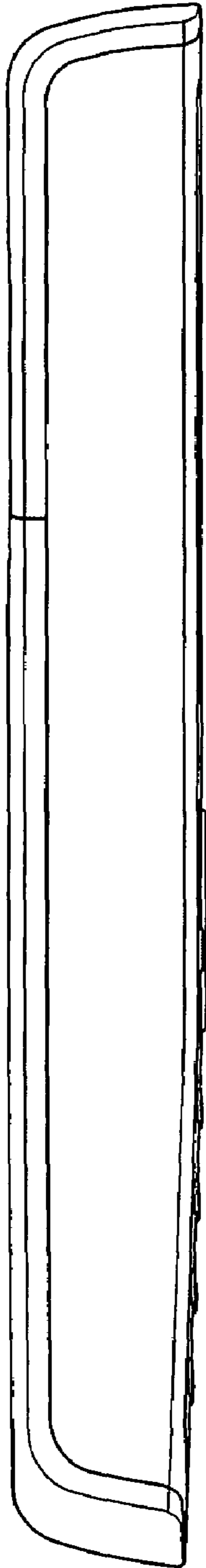


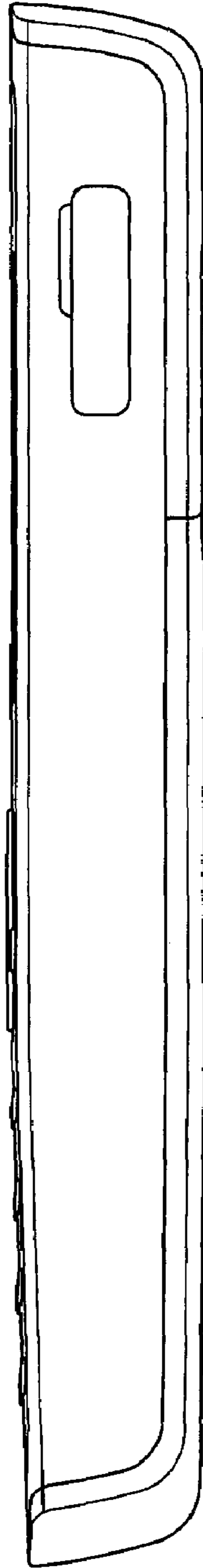

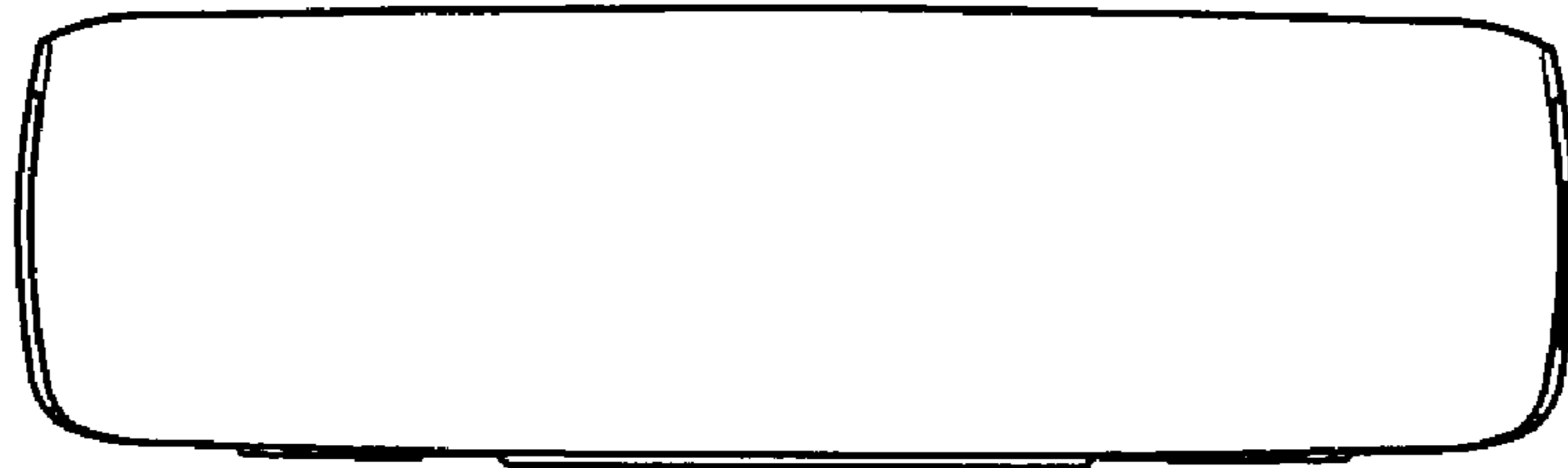
