(57) **CLAIM**

The ornamental design for a door, as shown and described.

DESCRIPTION

In a preferred embodiment, the nature of this product is as a door for an internal compartment of a cooling unit, such as a compact refrigerator, freezer, beverage cooler, ice maker, combinations thereof and the like.

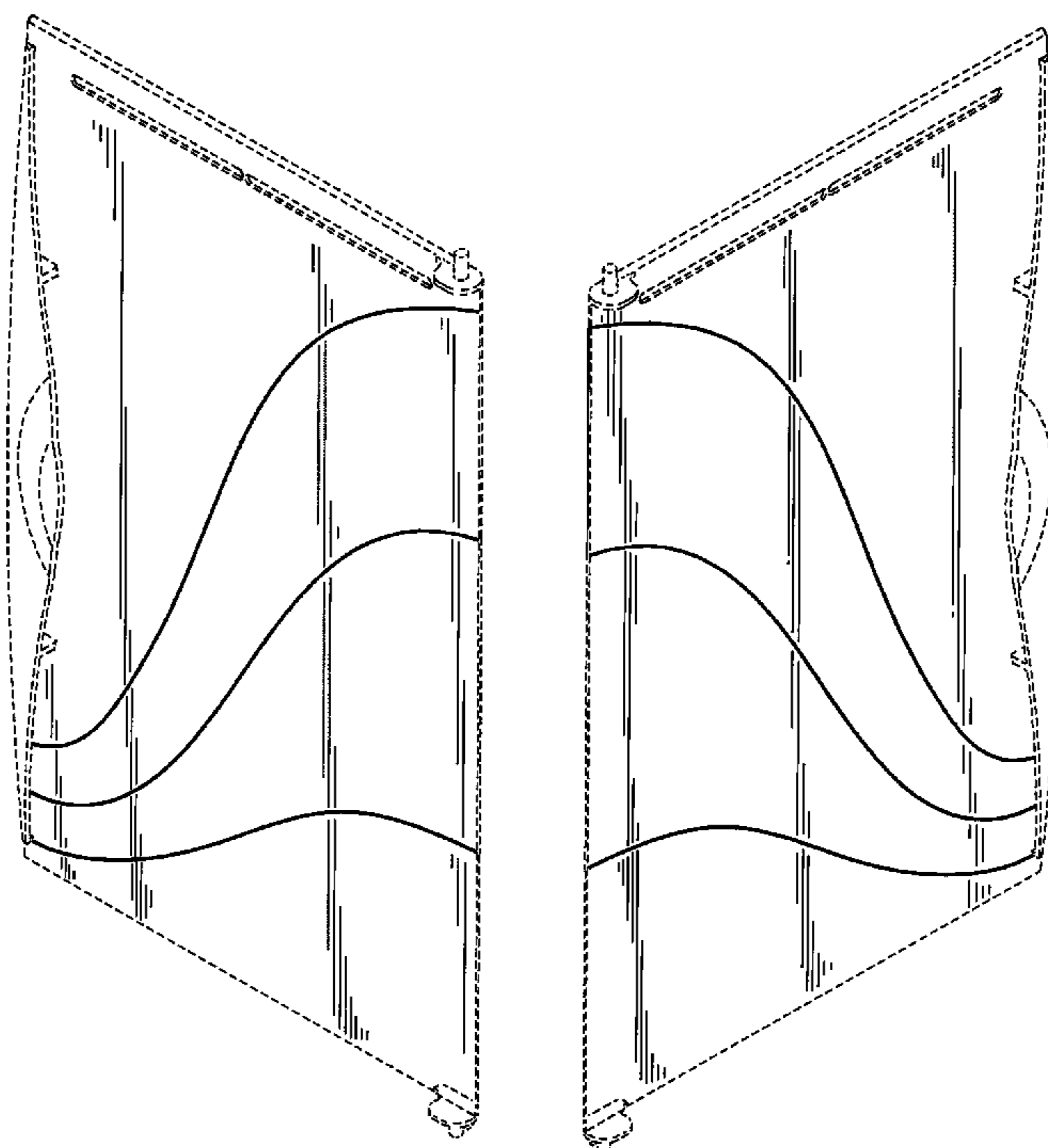
FIG. 1 is the first embodiment of a door showing our new design;

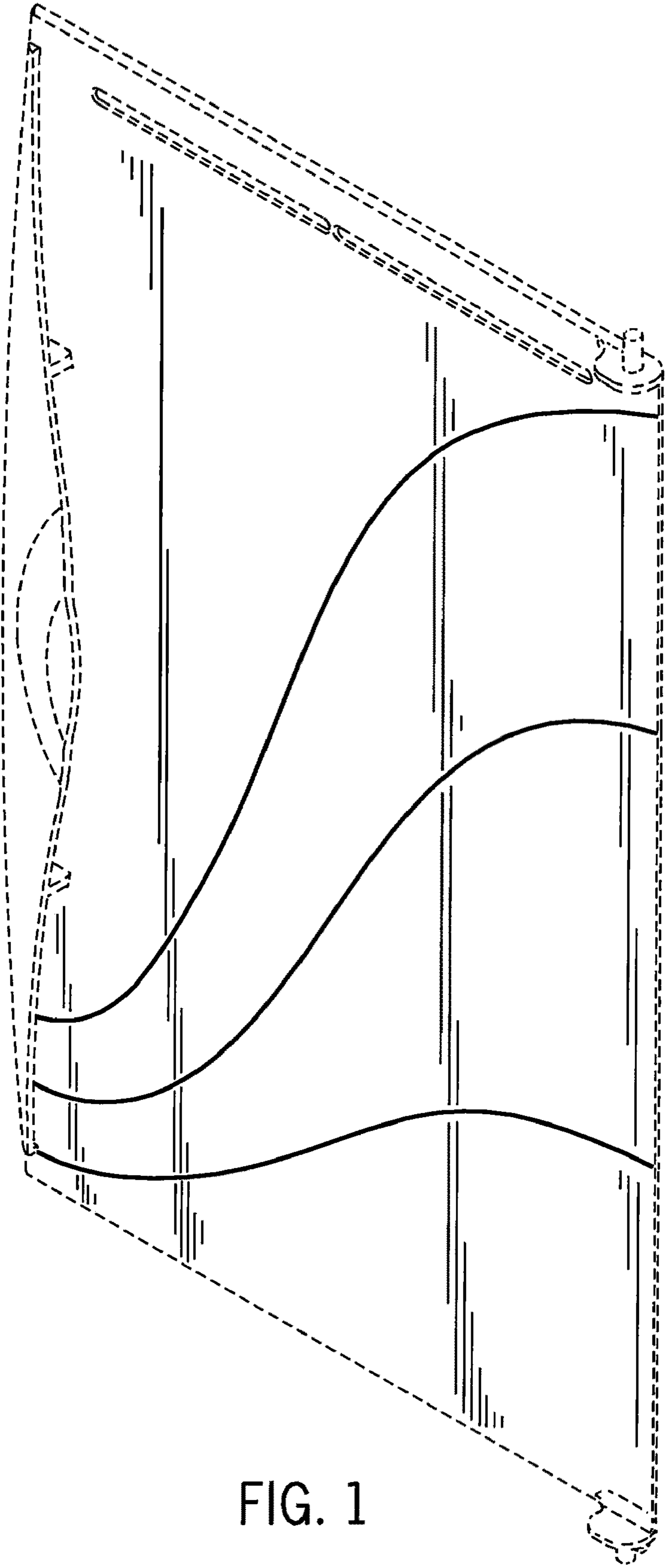
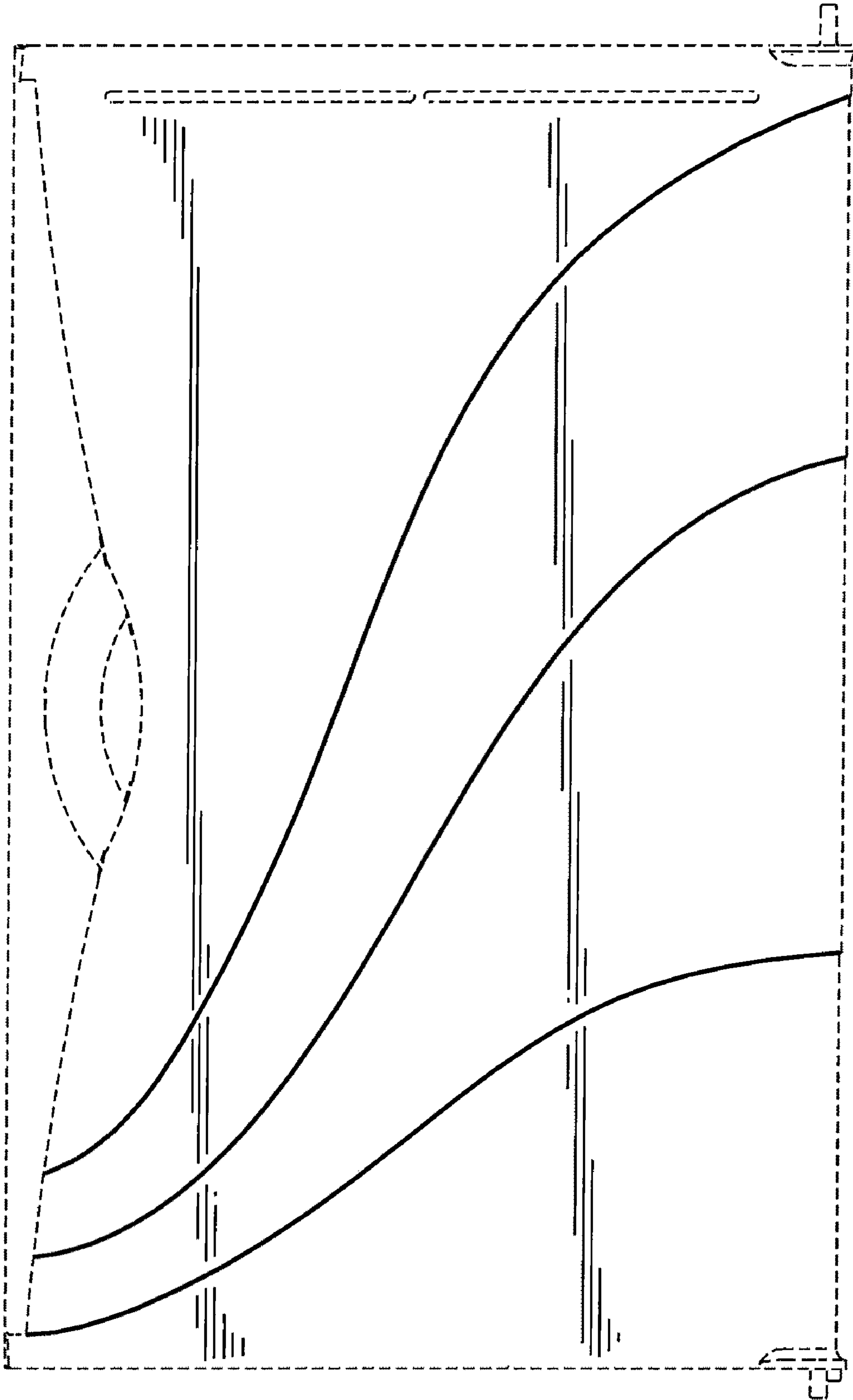

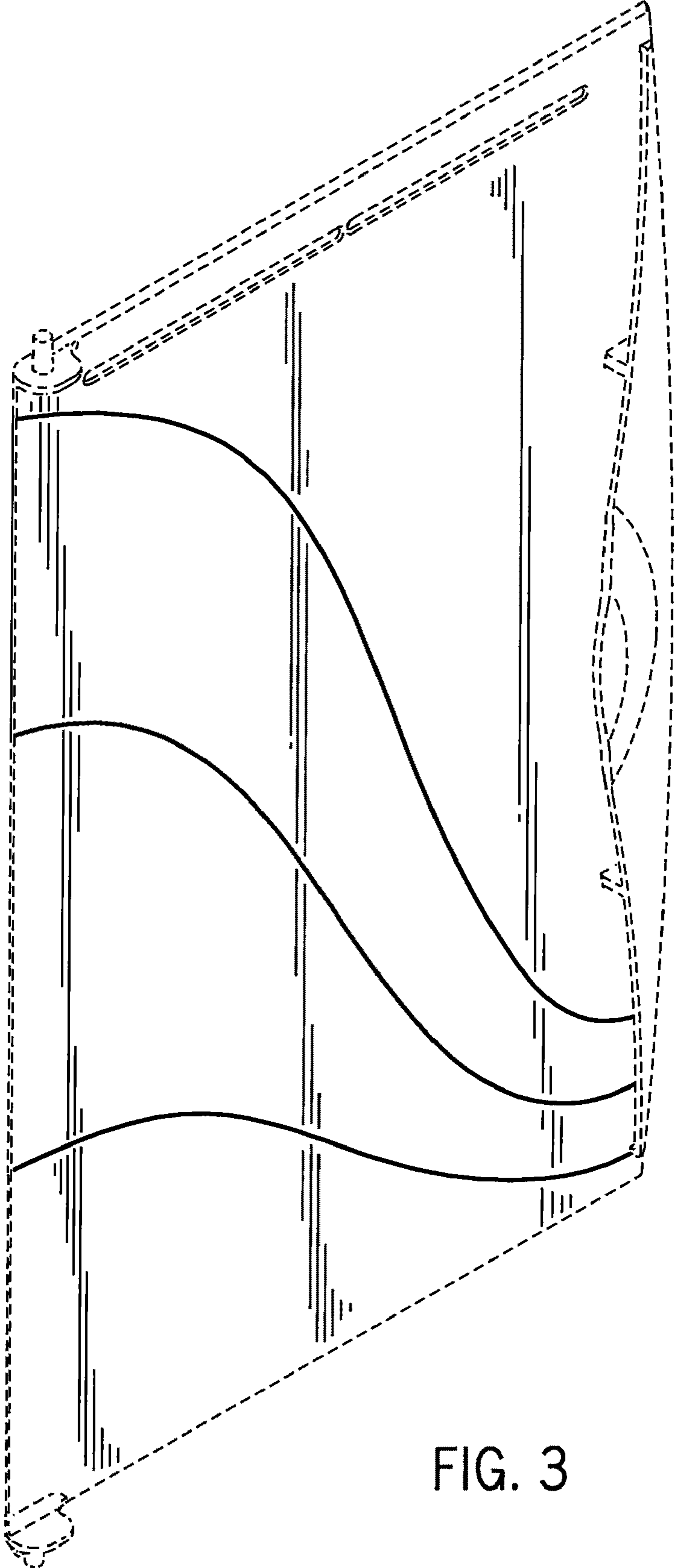
