**DESCRIPTION**

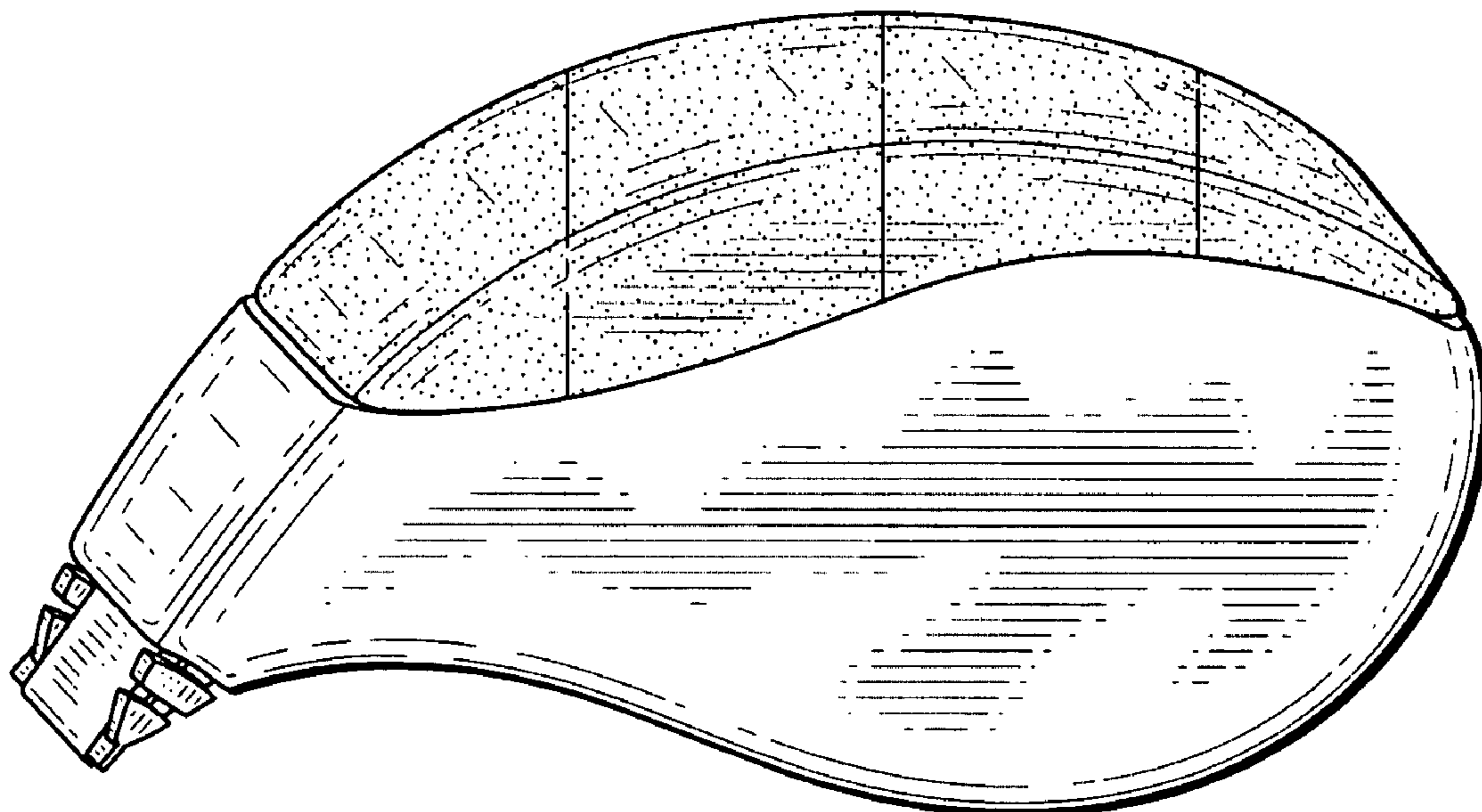
FIG. 1 is a perspective view of a first embodiment correction tape dispenser, in accordance with the present invention;

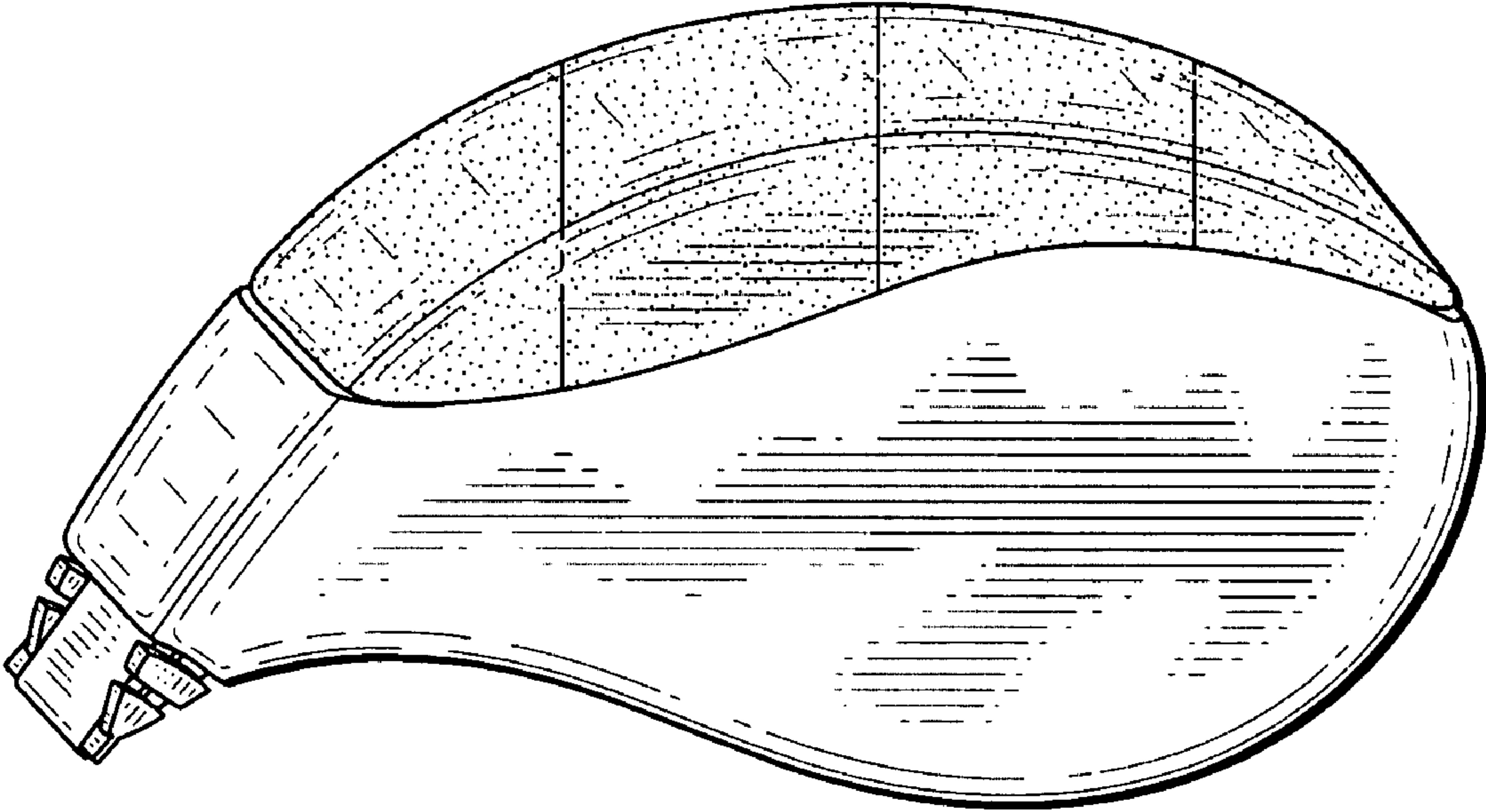

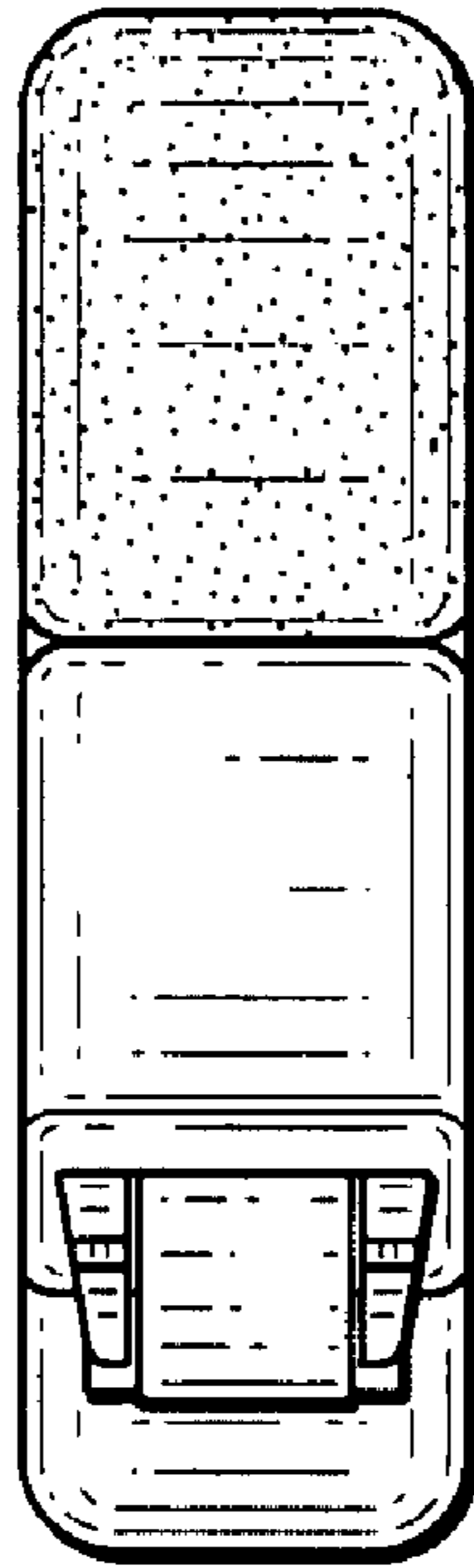

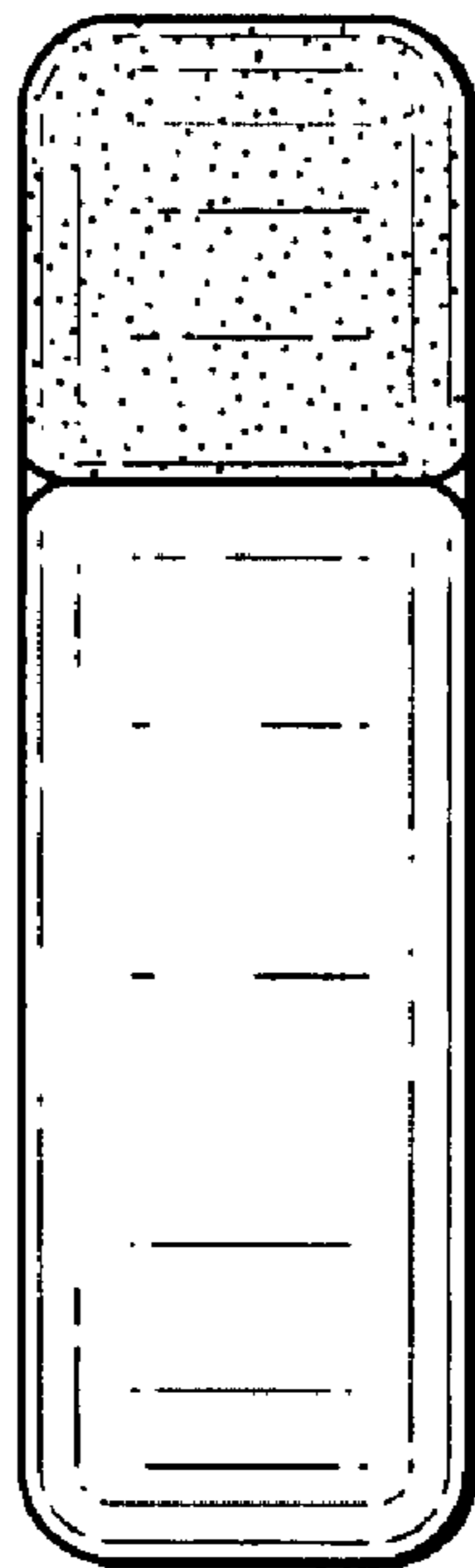

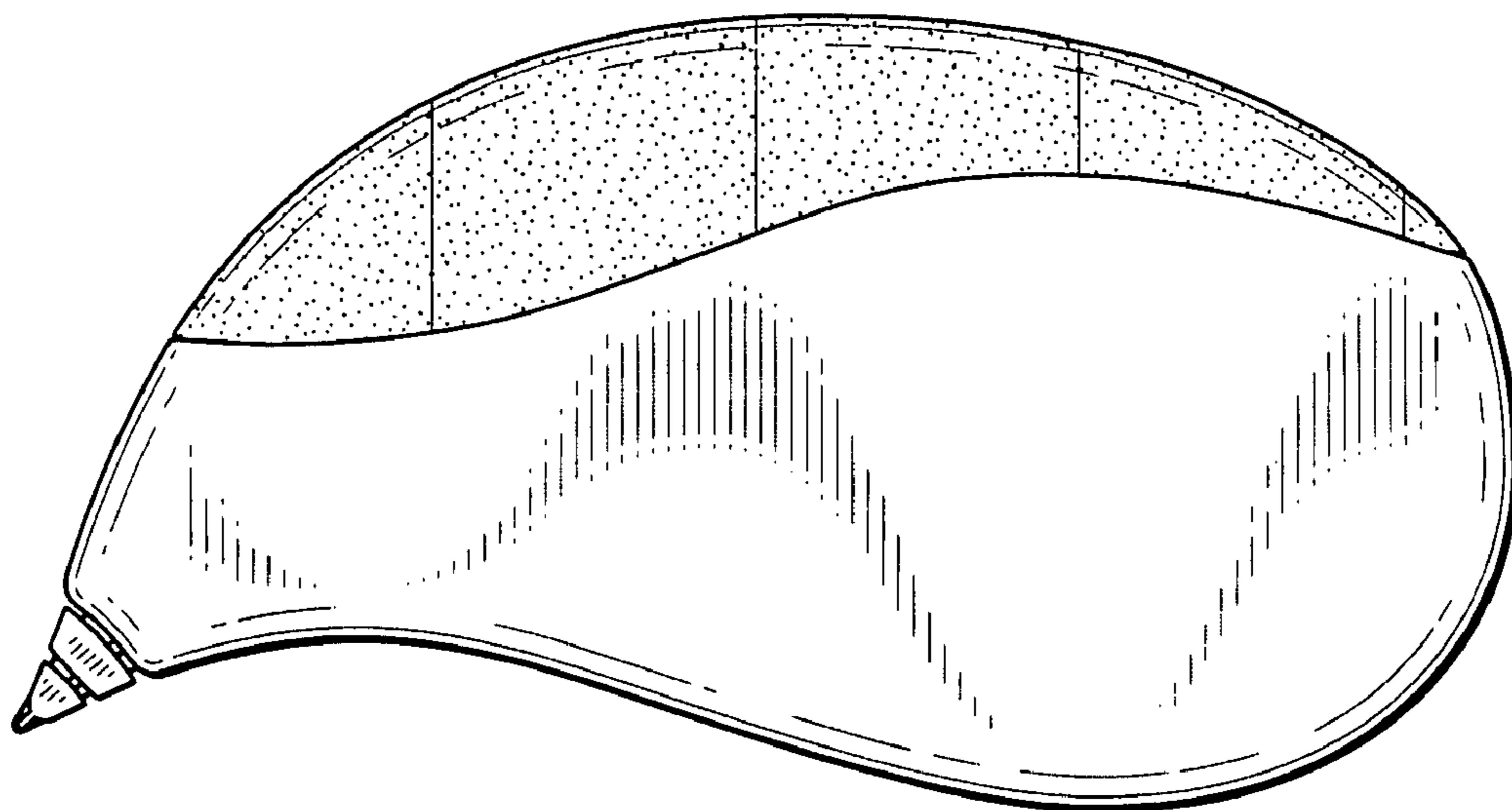

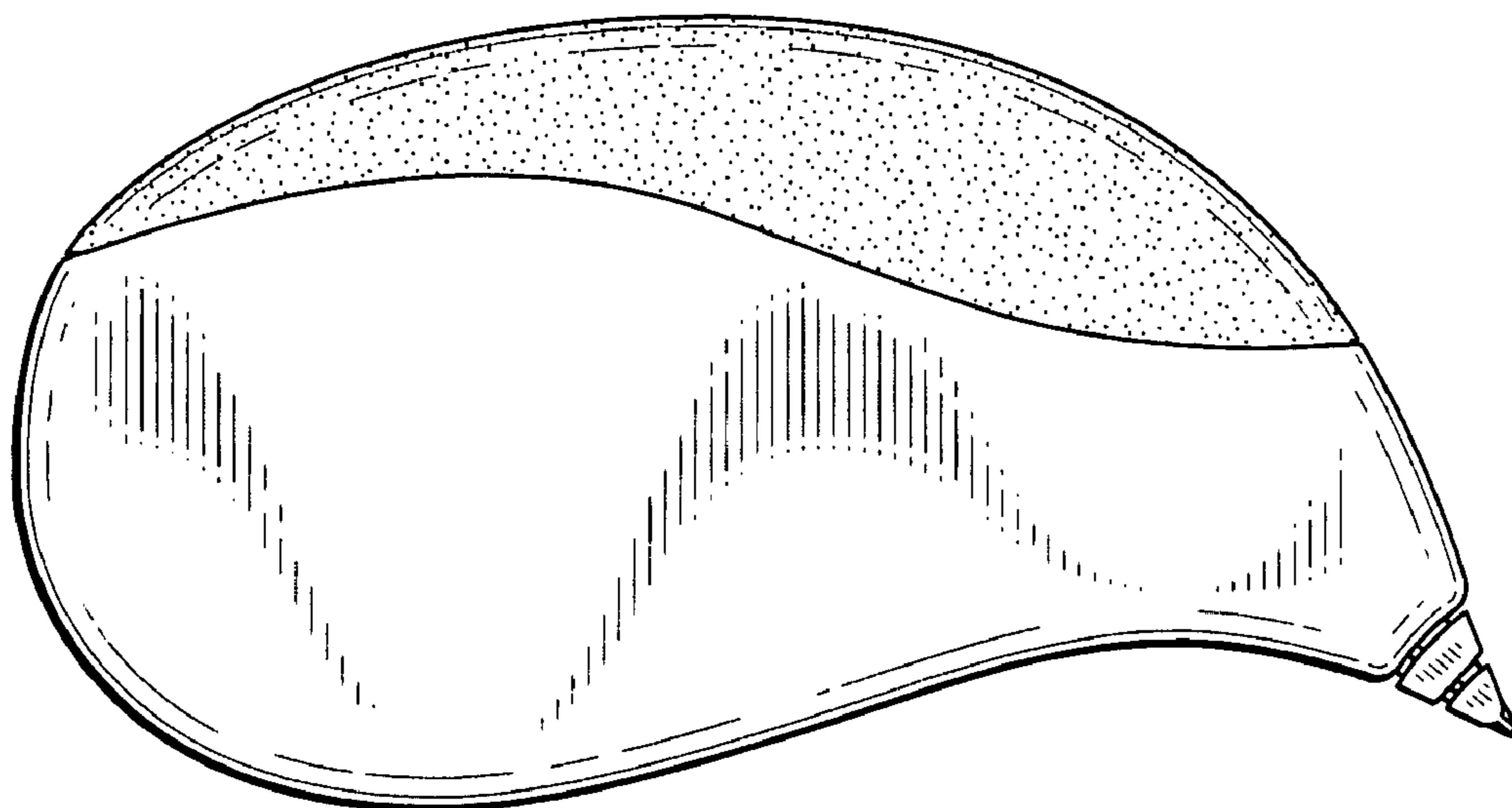

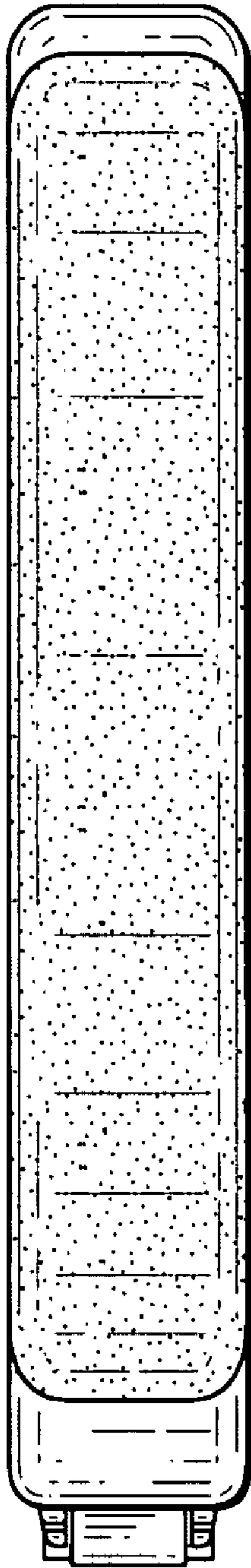

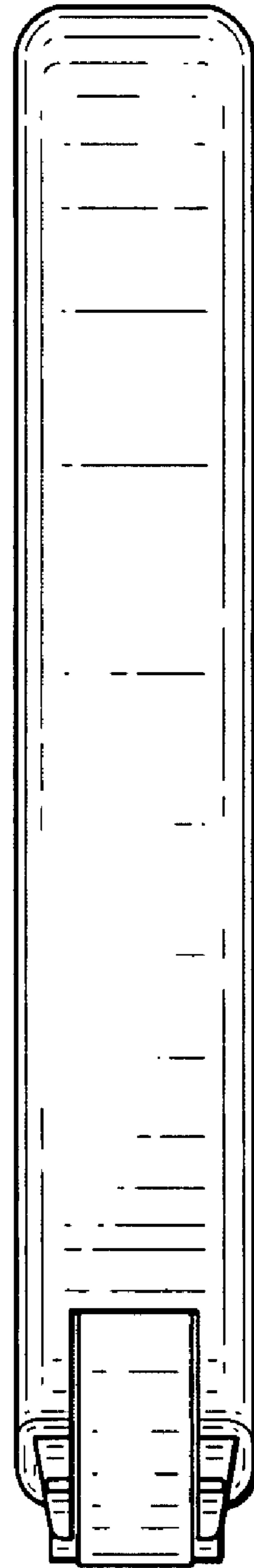
