FIG. 4 is an enlarged top end perspective view thereof;

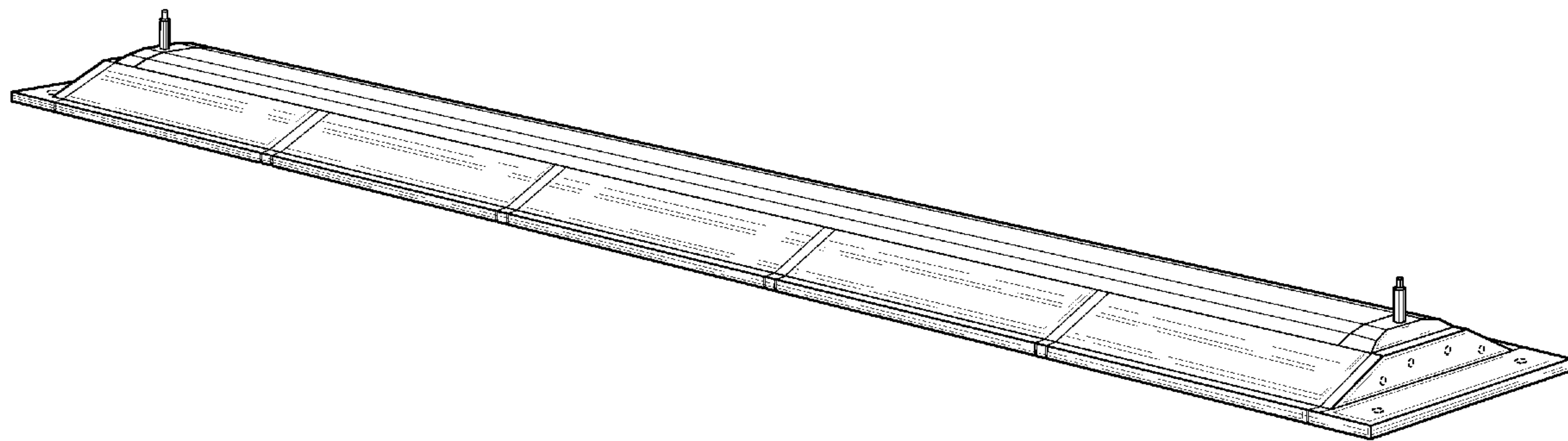
FIG. 5 is an enlarged end elevation view thereof;

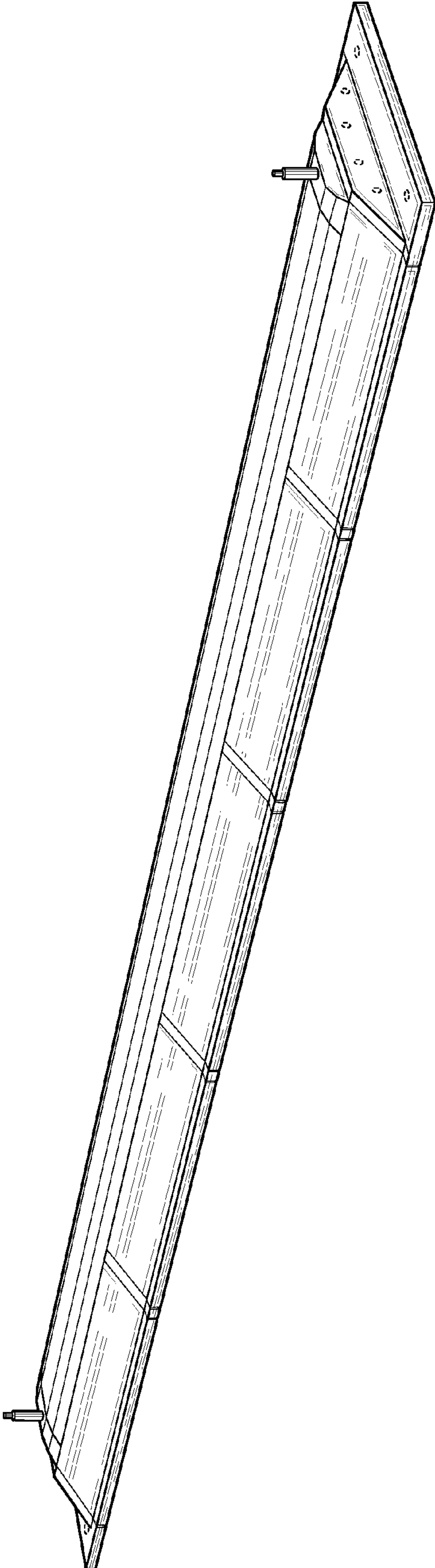

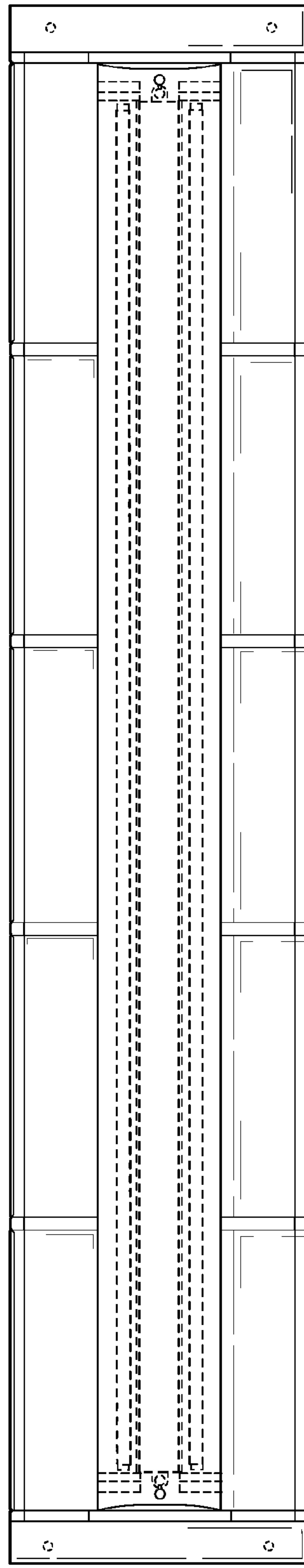

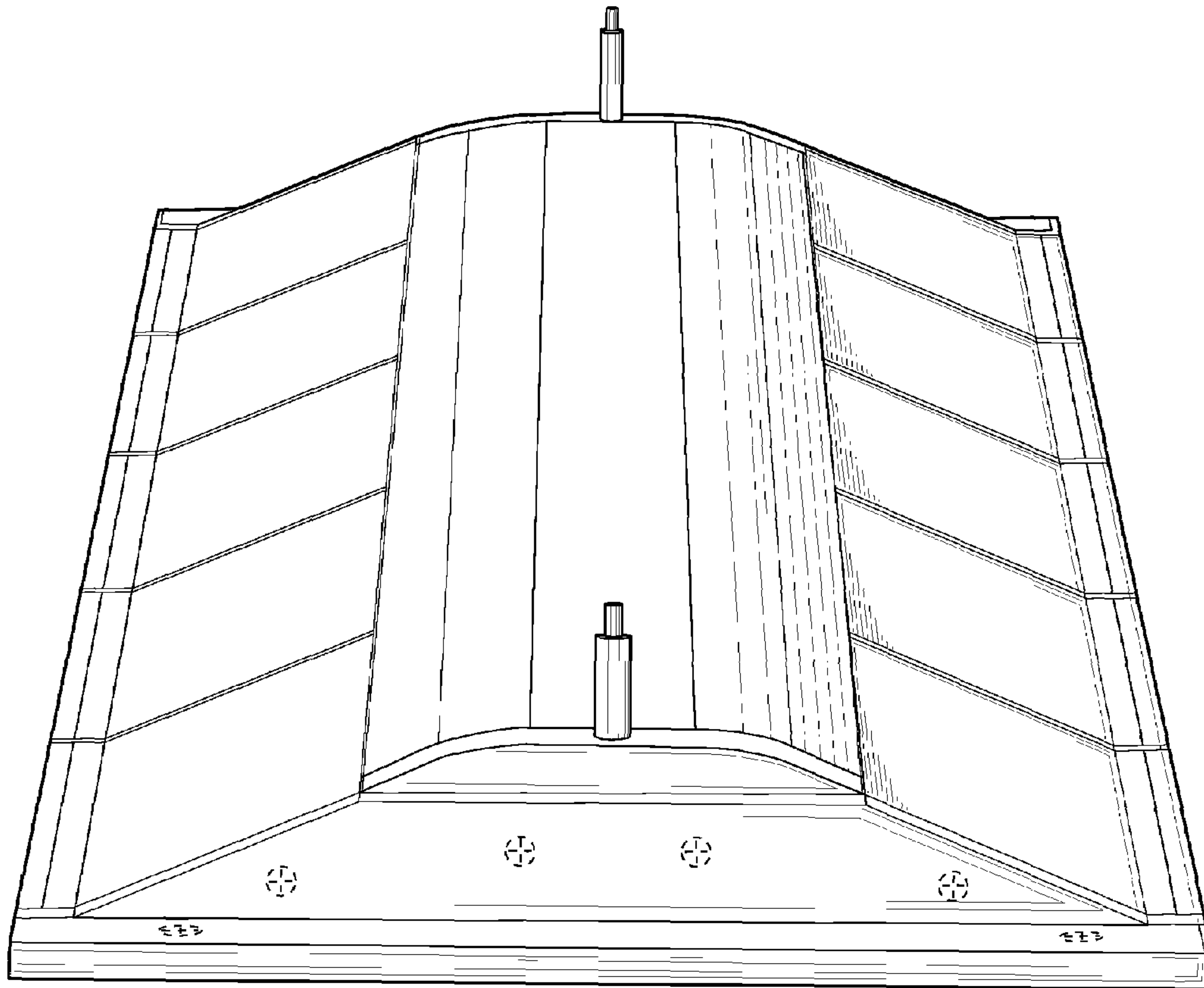

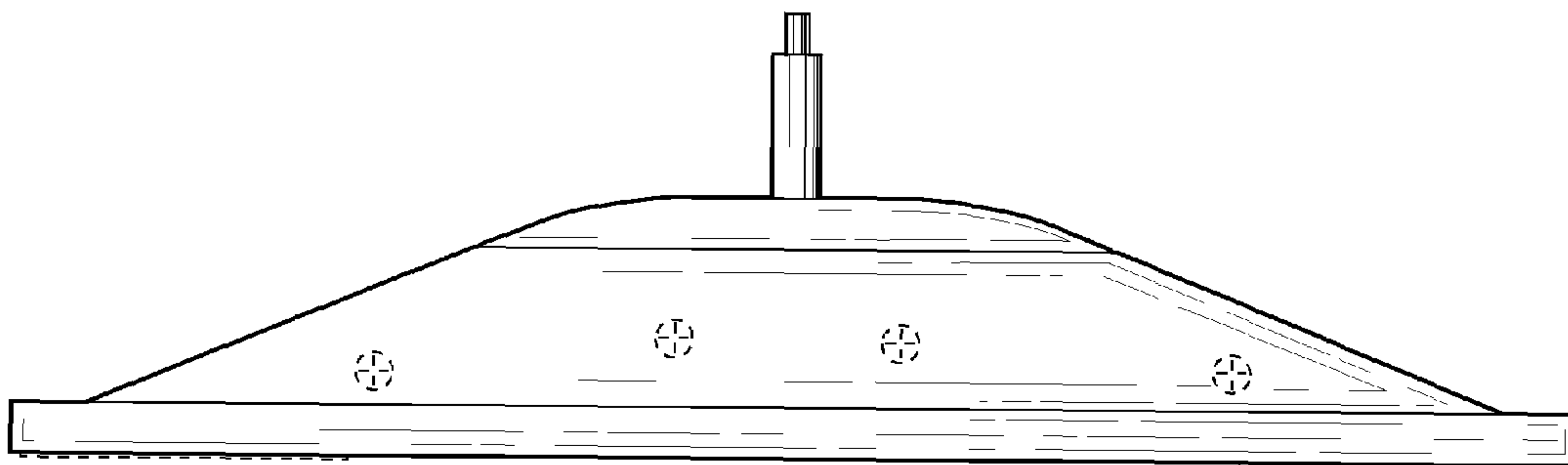

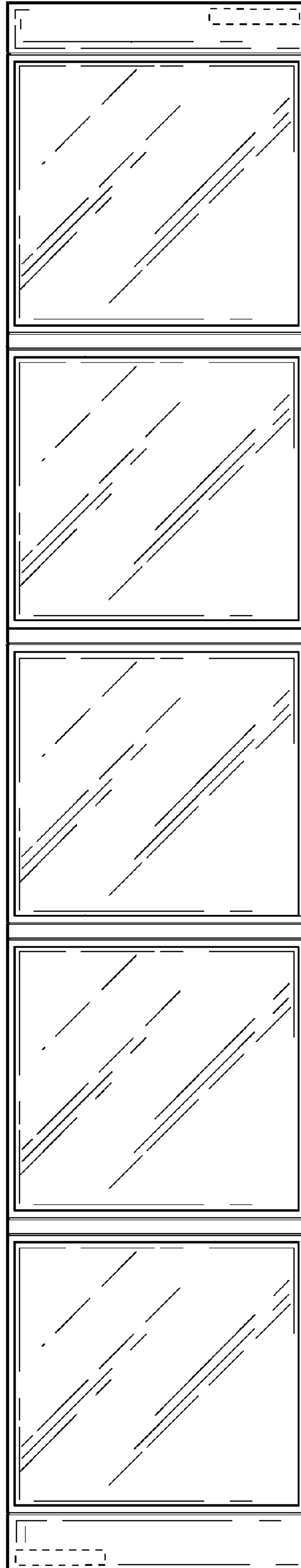

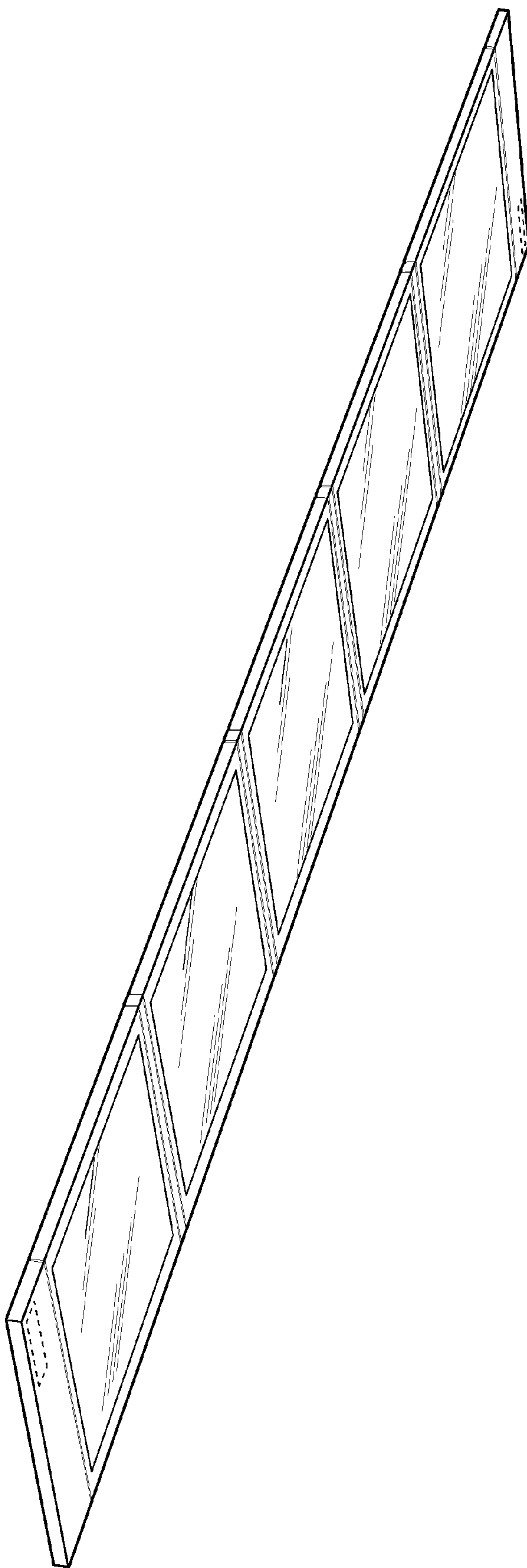
