FIG. 4 is a side elevation view thereof;

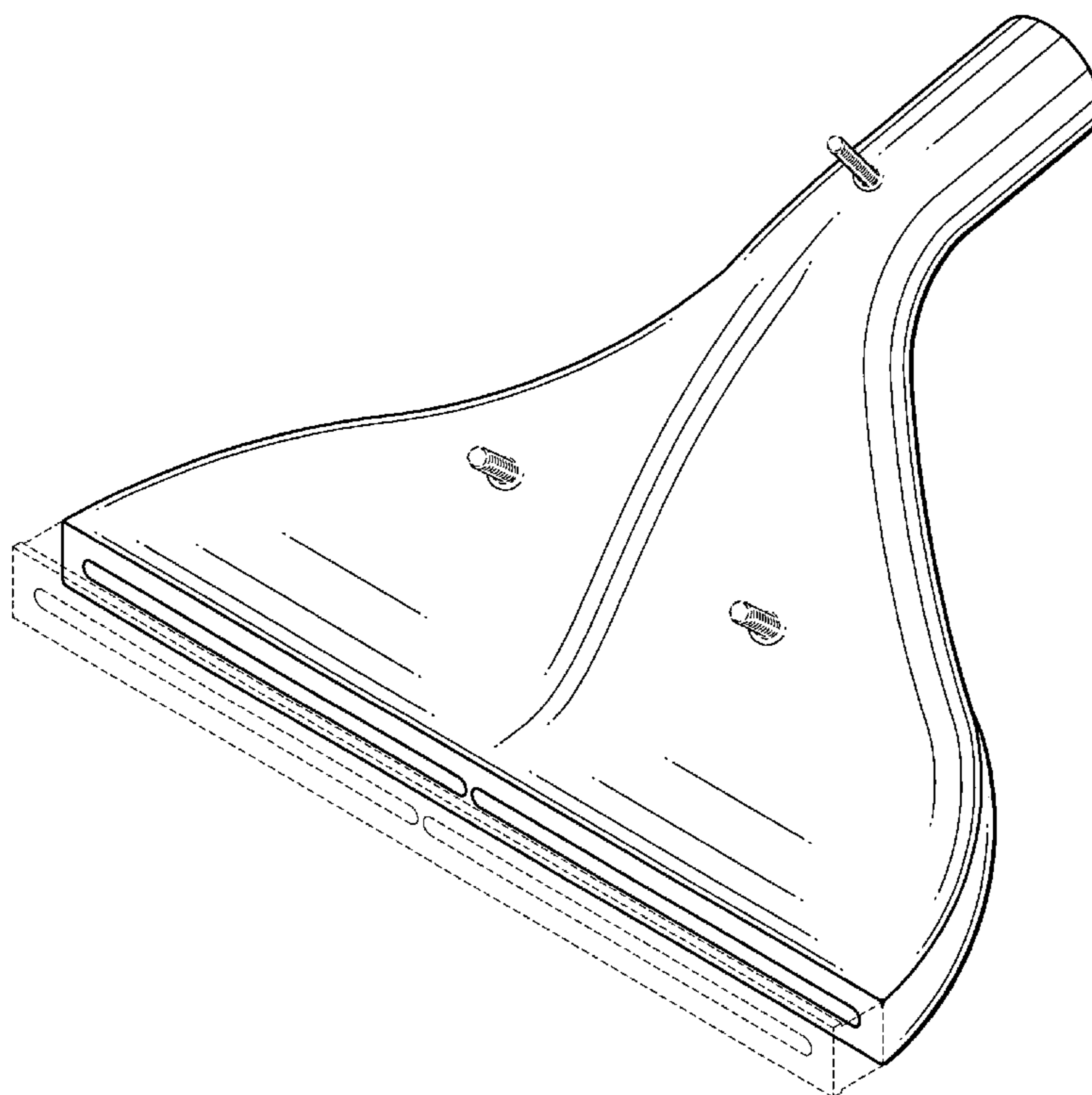
FIG. 5 is an opposite side elevation view thereof;

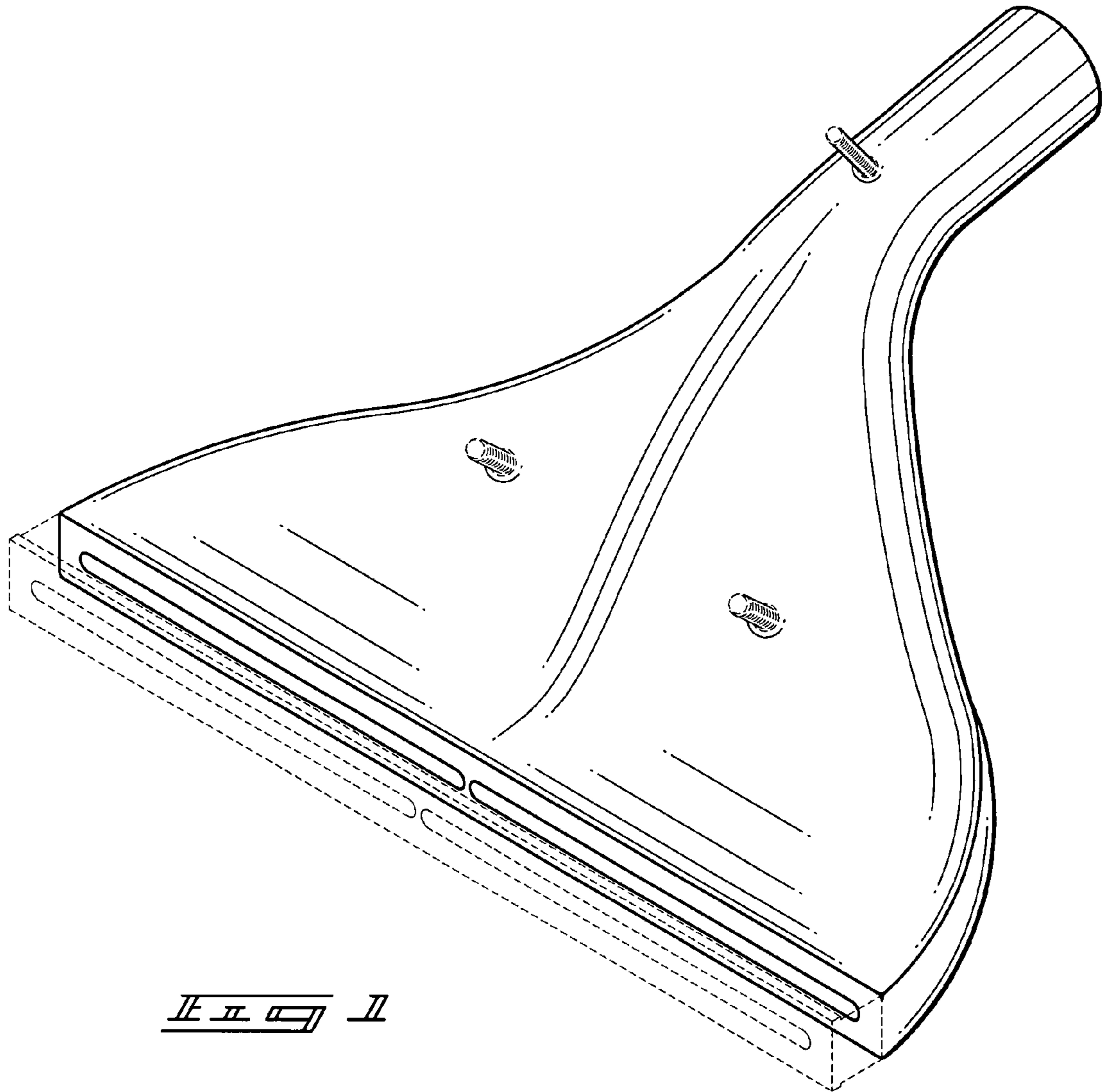
FIG. 6 is a top view thereof; and,

FIG. 7 is a bottom front view thereof.

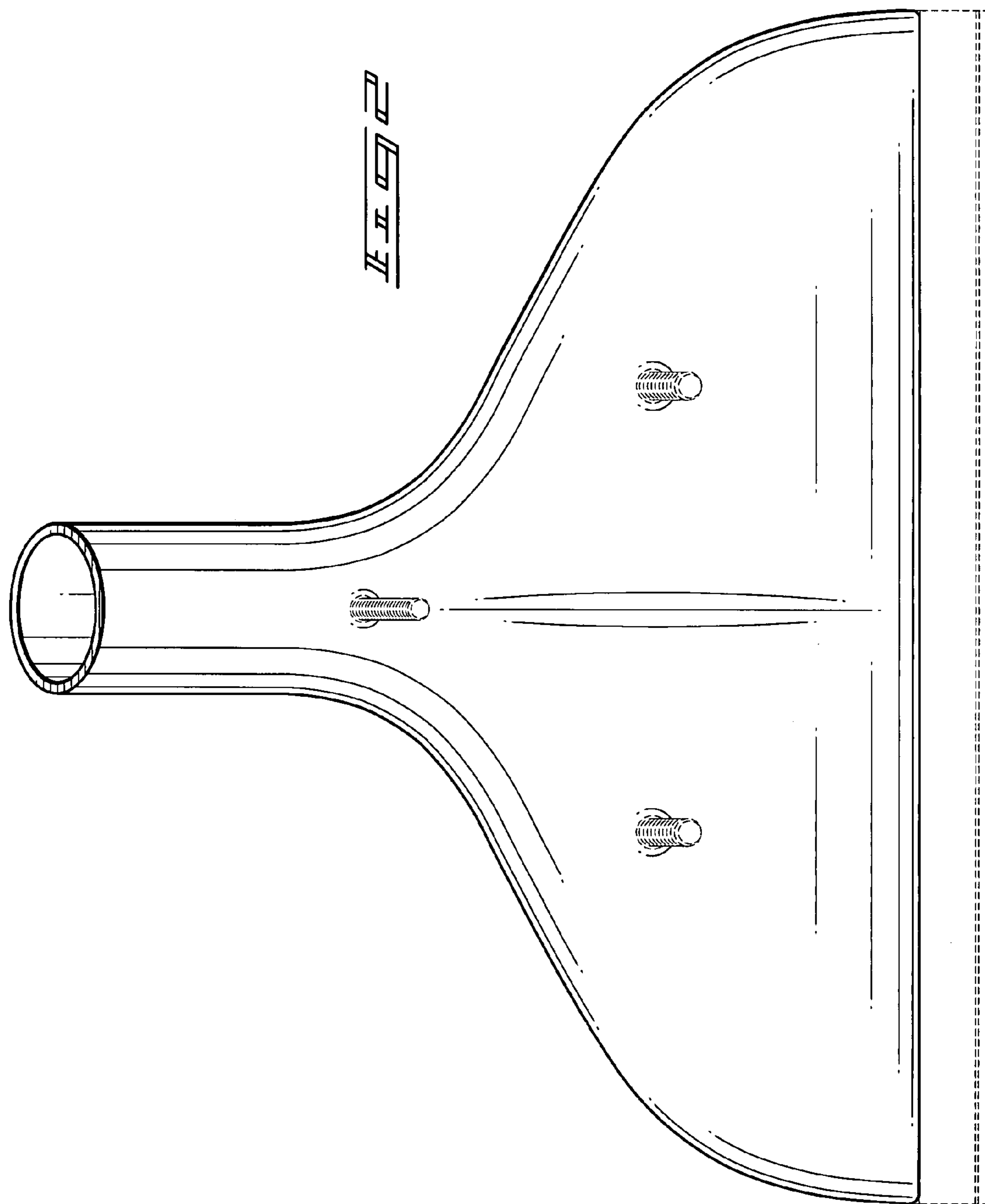
The broken line showing of details in FIGS. 1-7 is included for the purpose of illustrating portions of the floor cleaning tool that form no part of the claimed design.

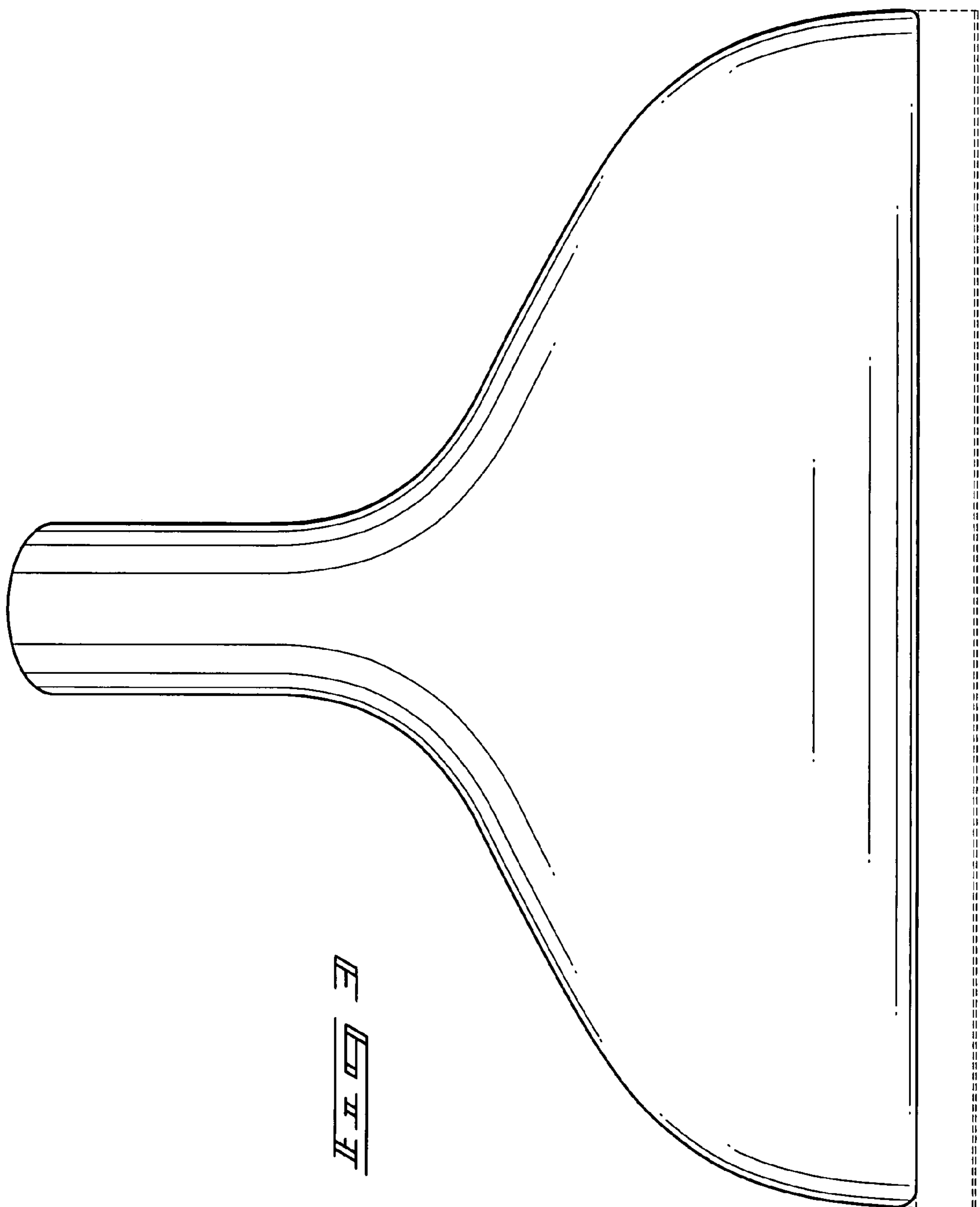

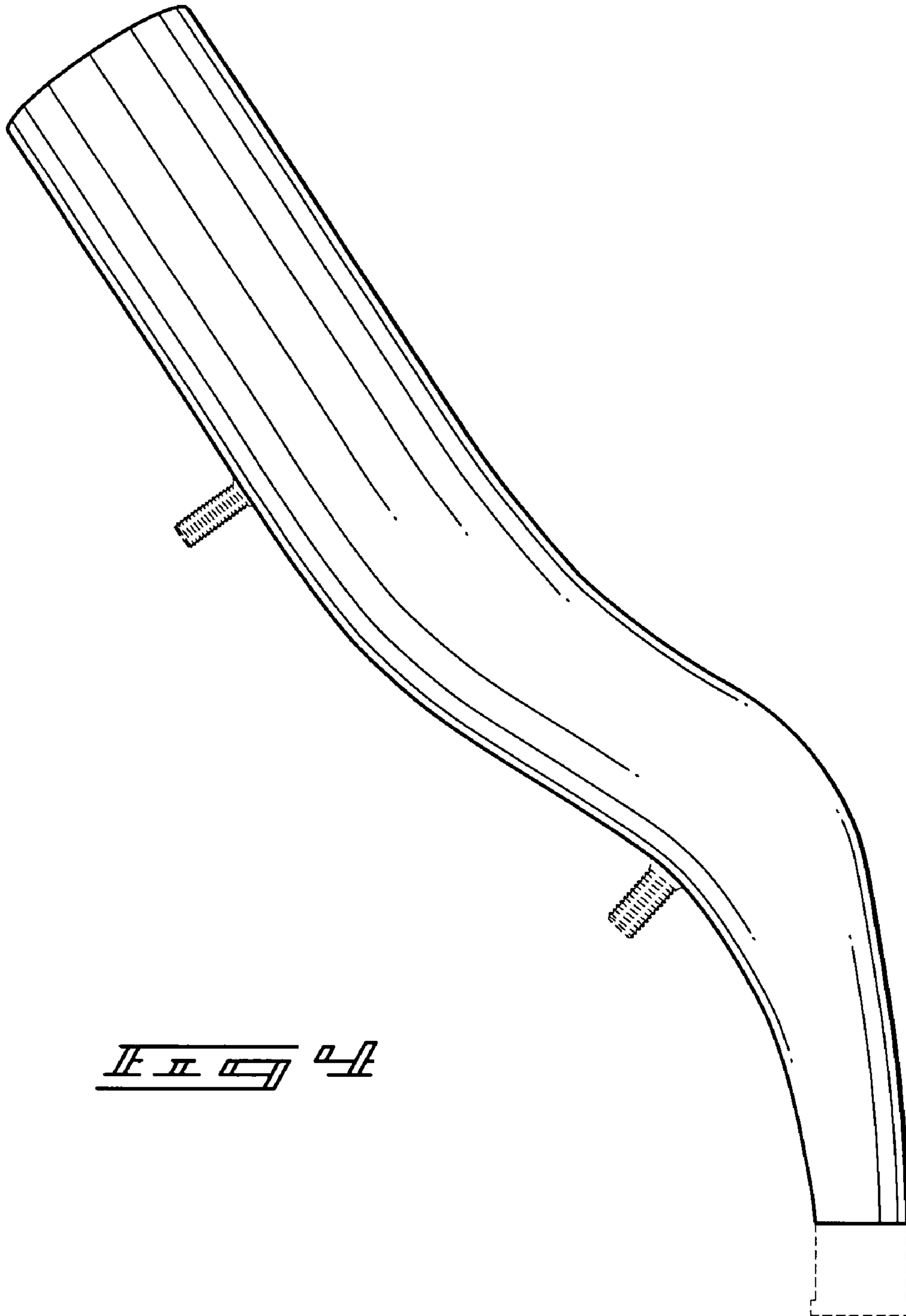

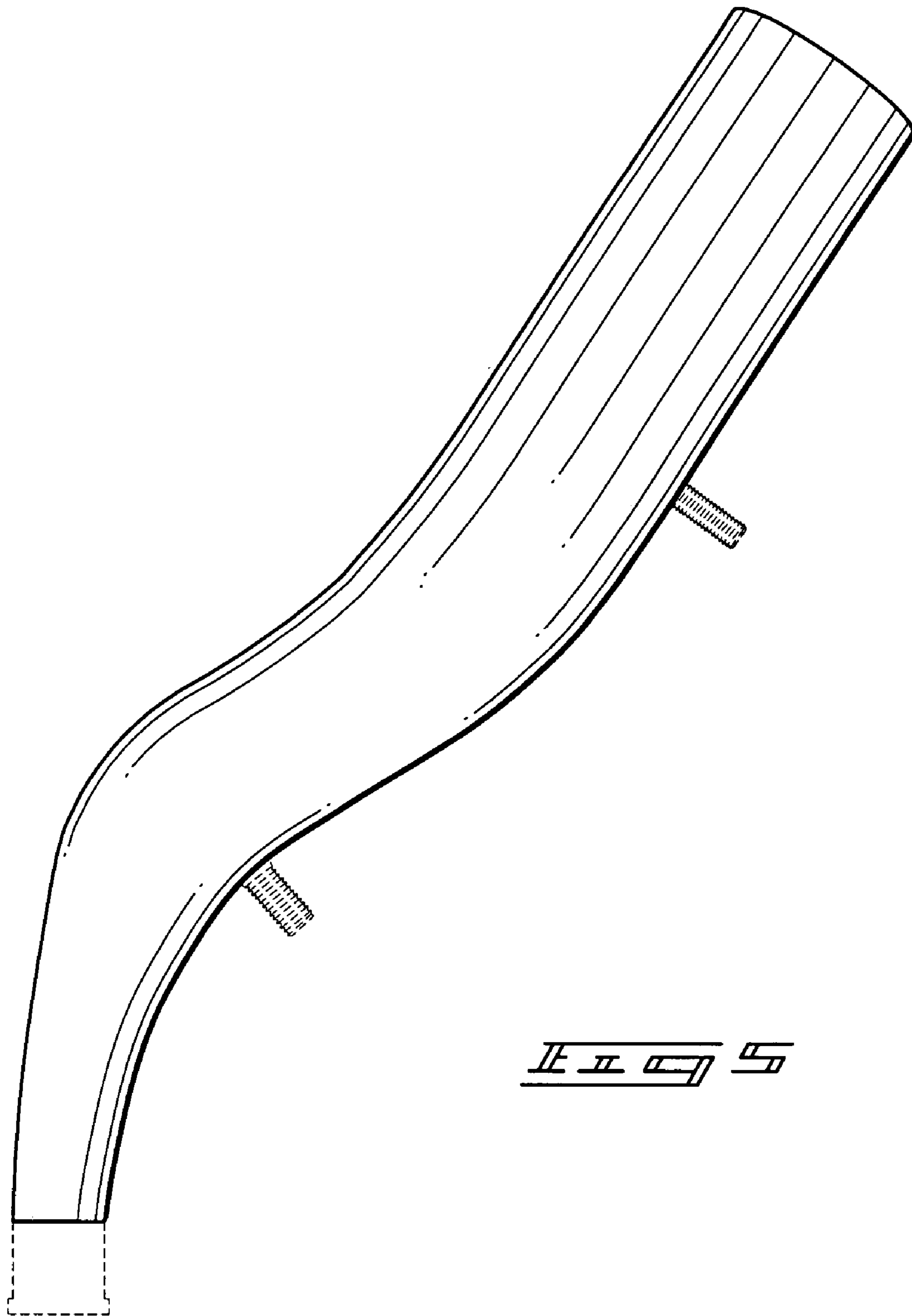
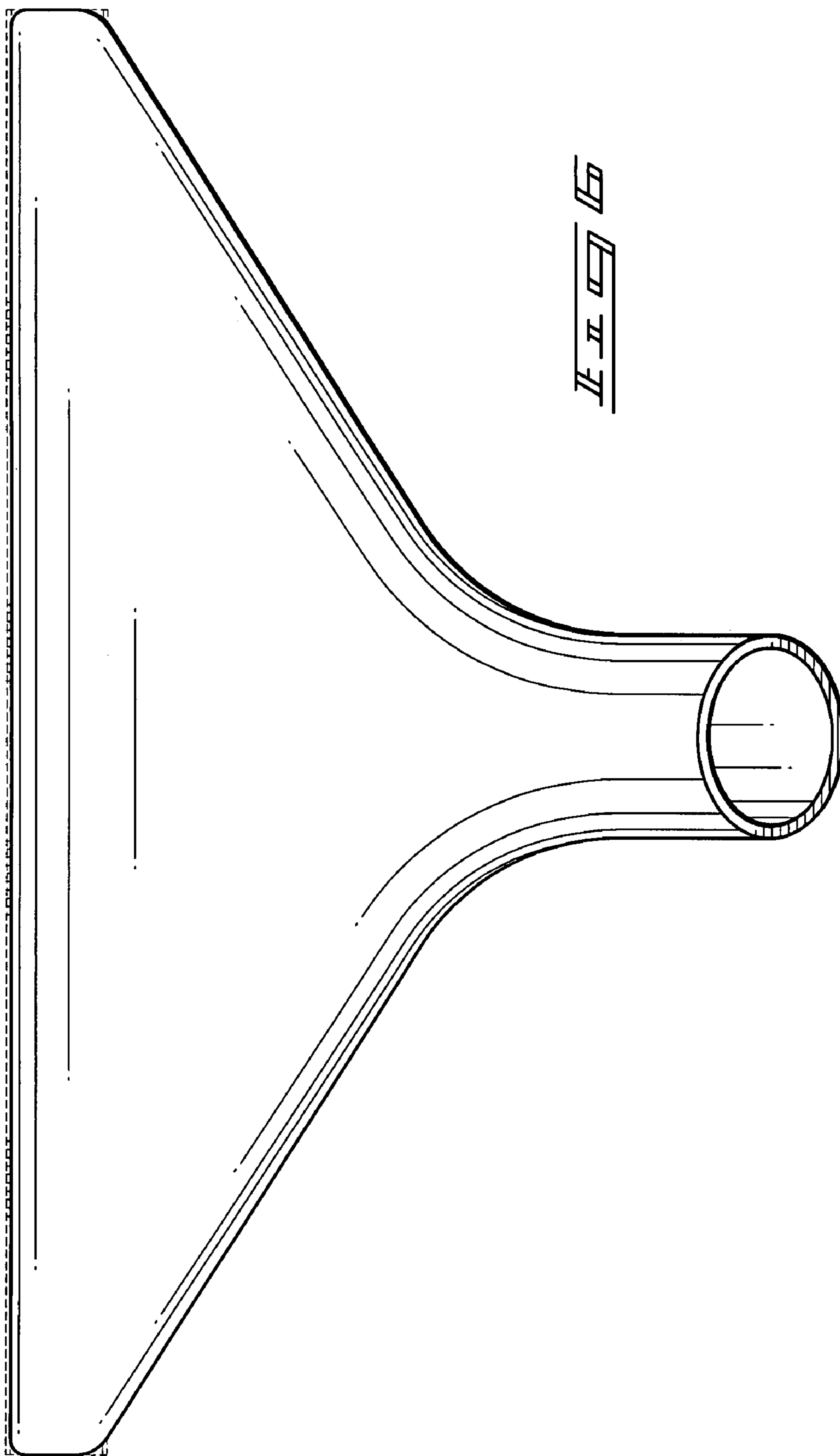

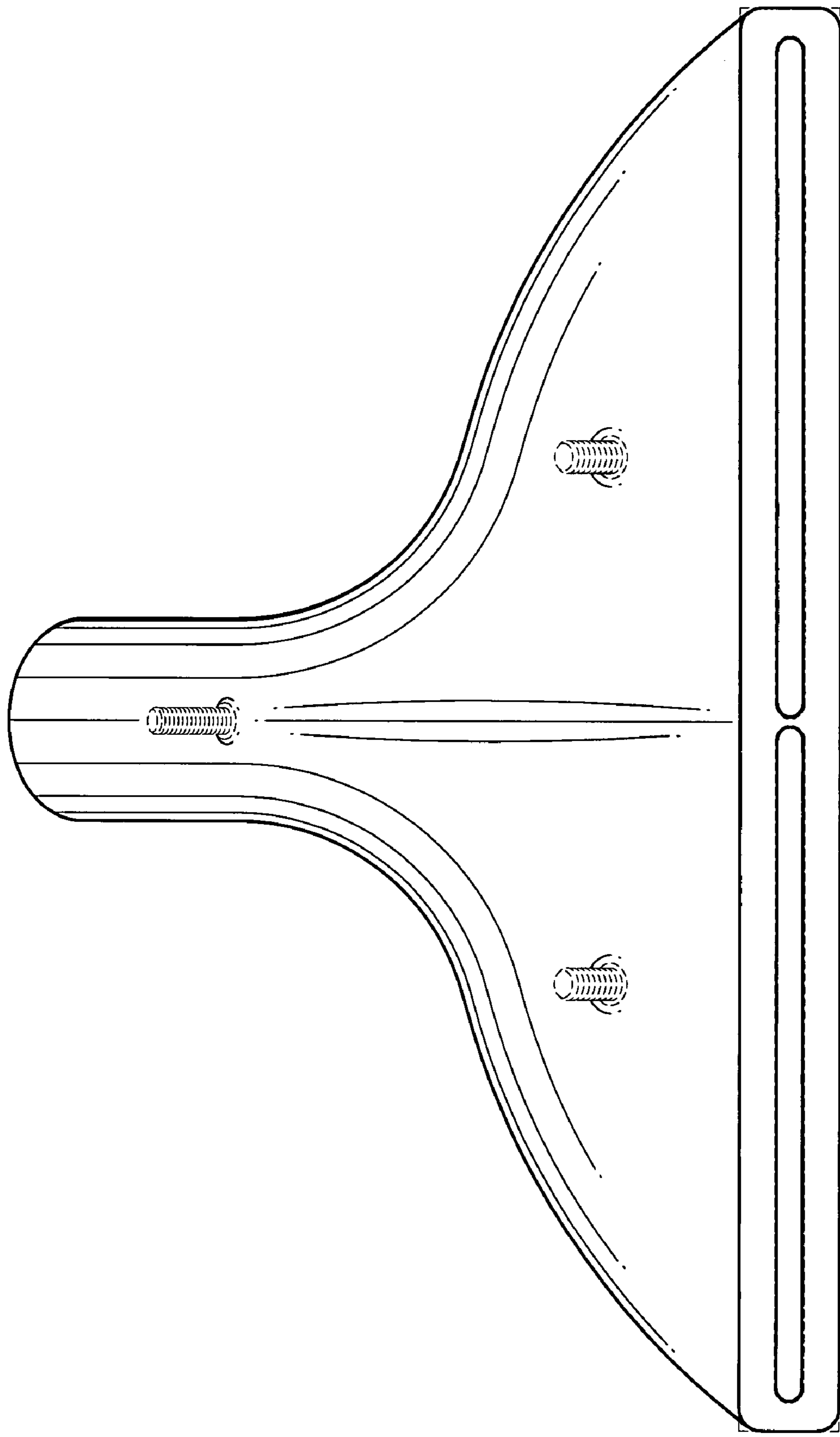
