FIG. 4 is a top plan view thereof;

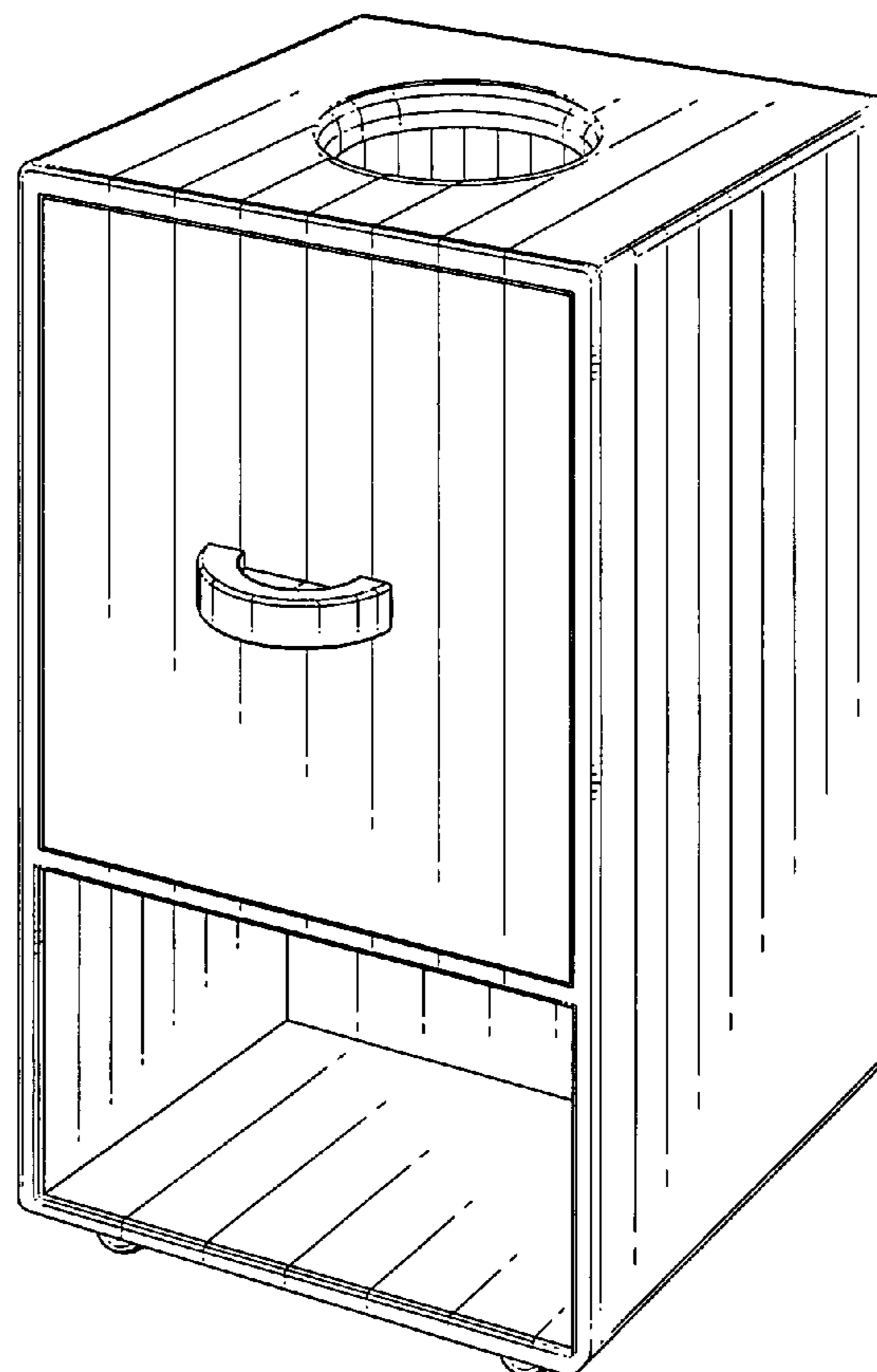
FIG. 5 is a bottom plan view thereof;

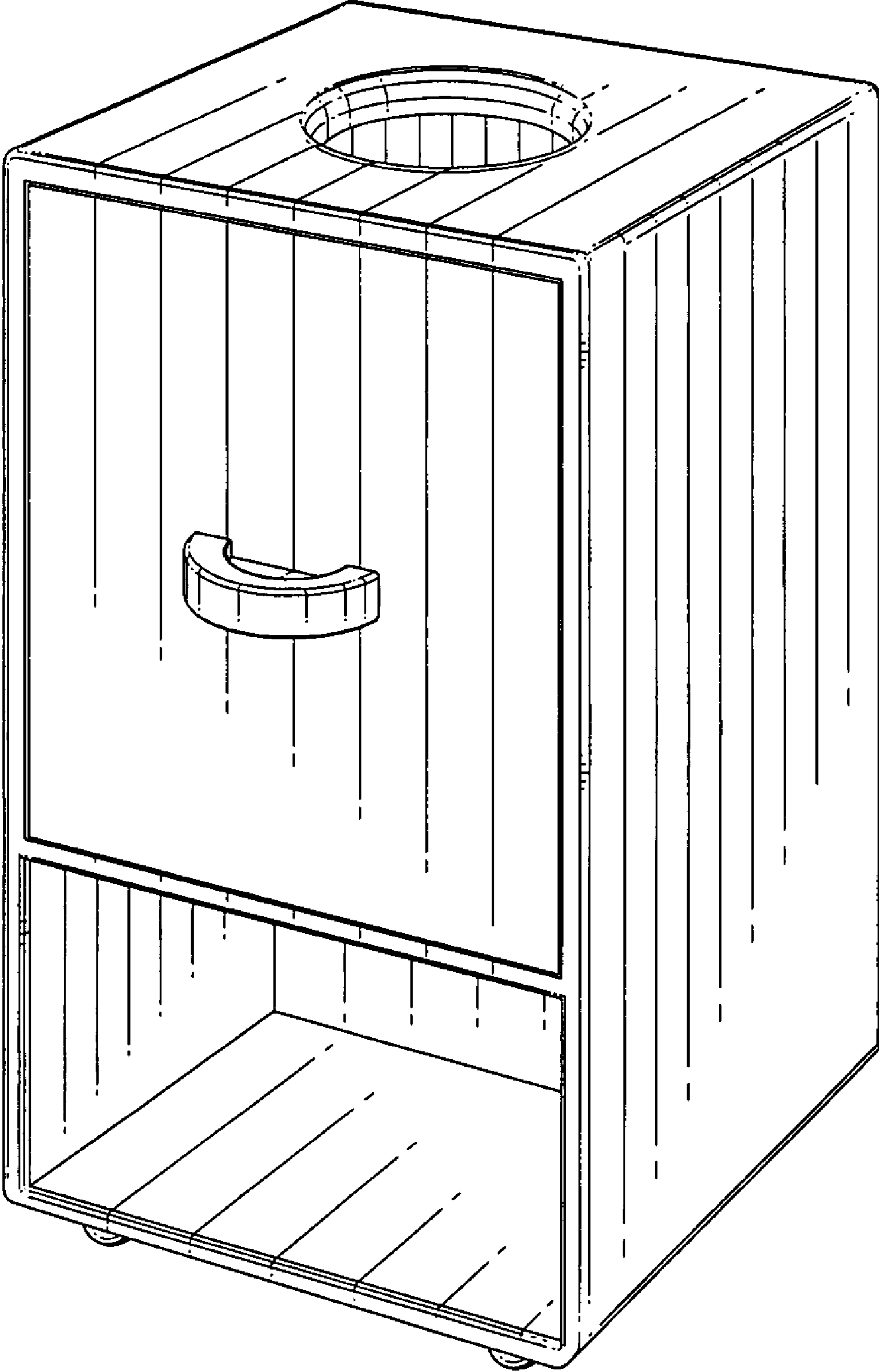
FIG. 6 is a left side elevation view thereof;

FIG. 7 is a right side elevation view thereof; and,

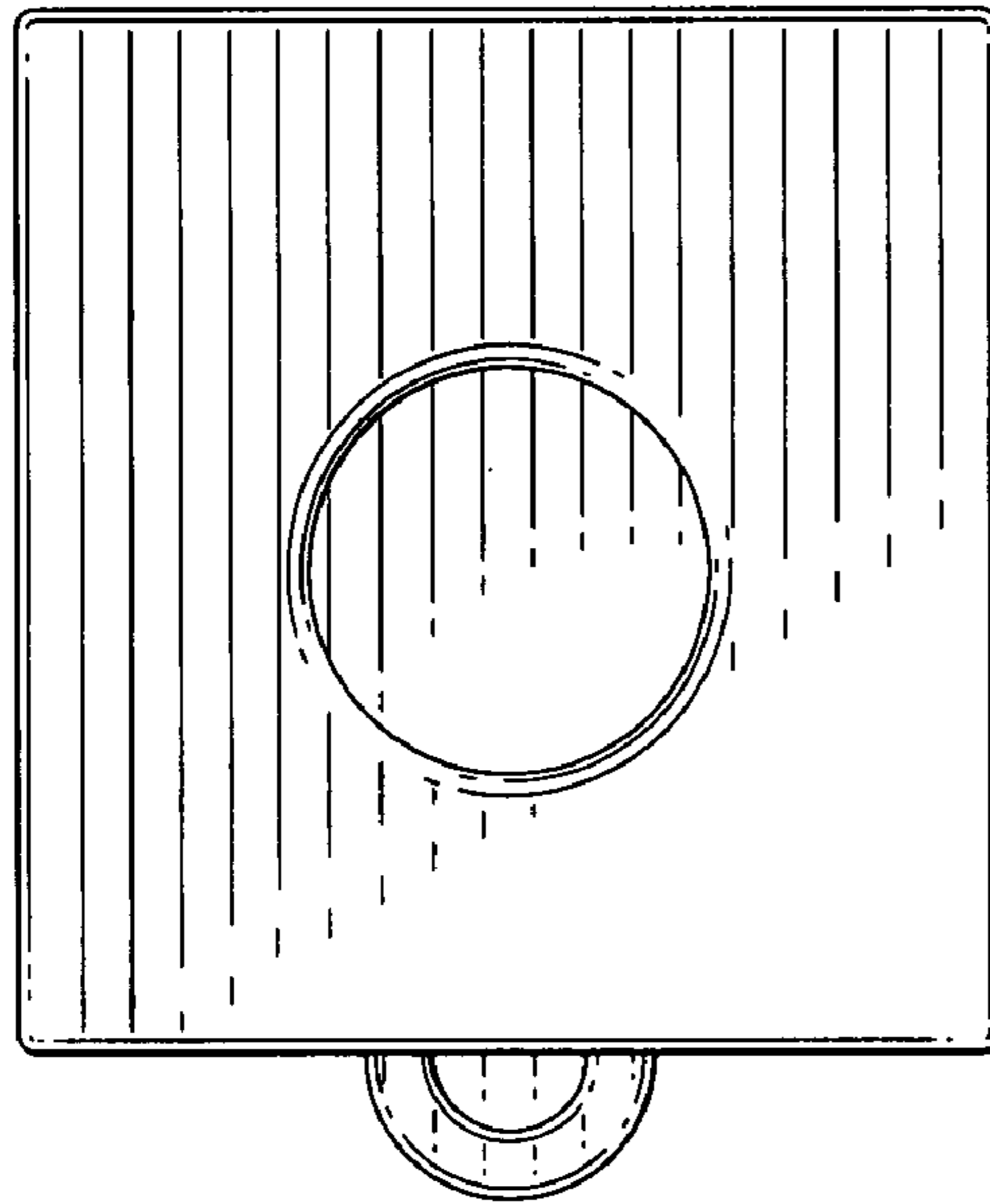
FIG. 8 is a perspective view thereof showing the drawer open.

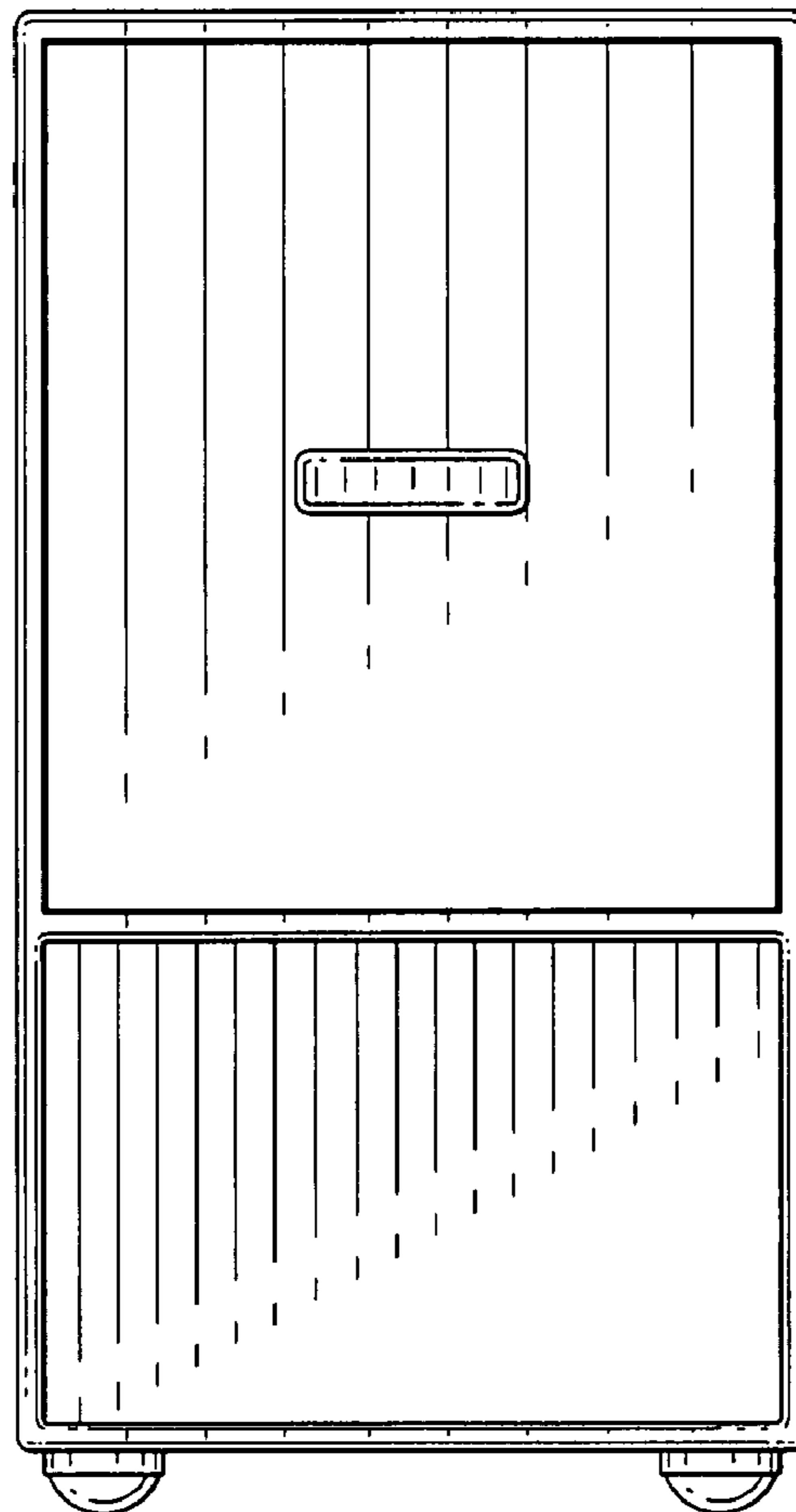




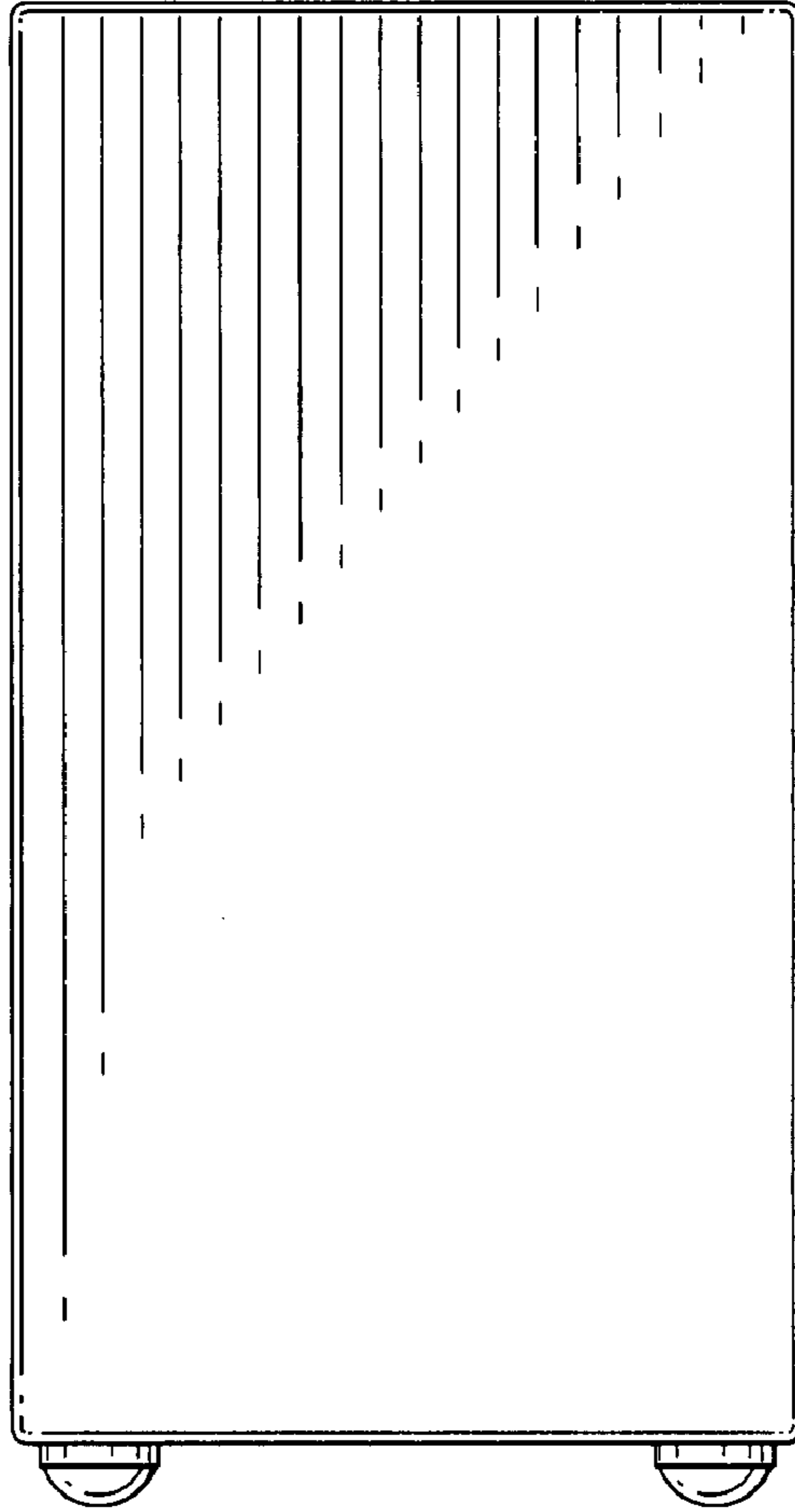

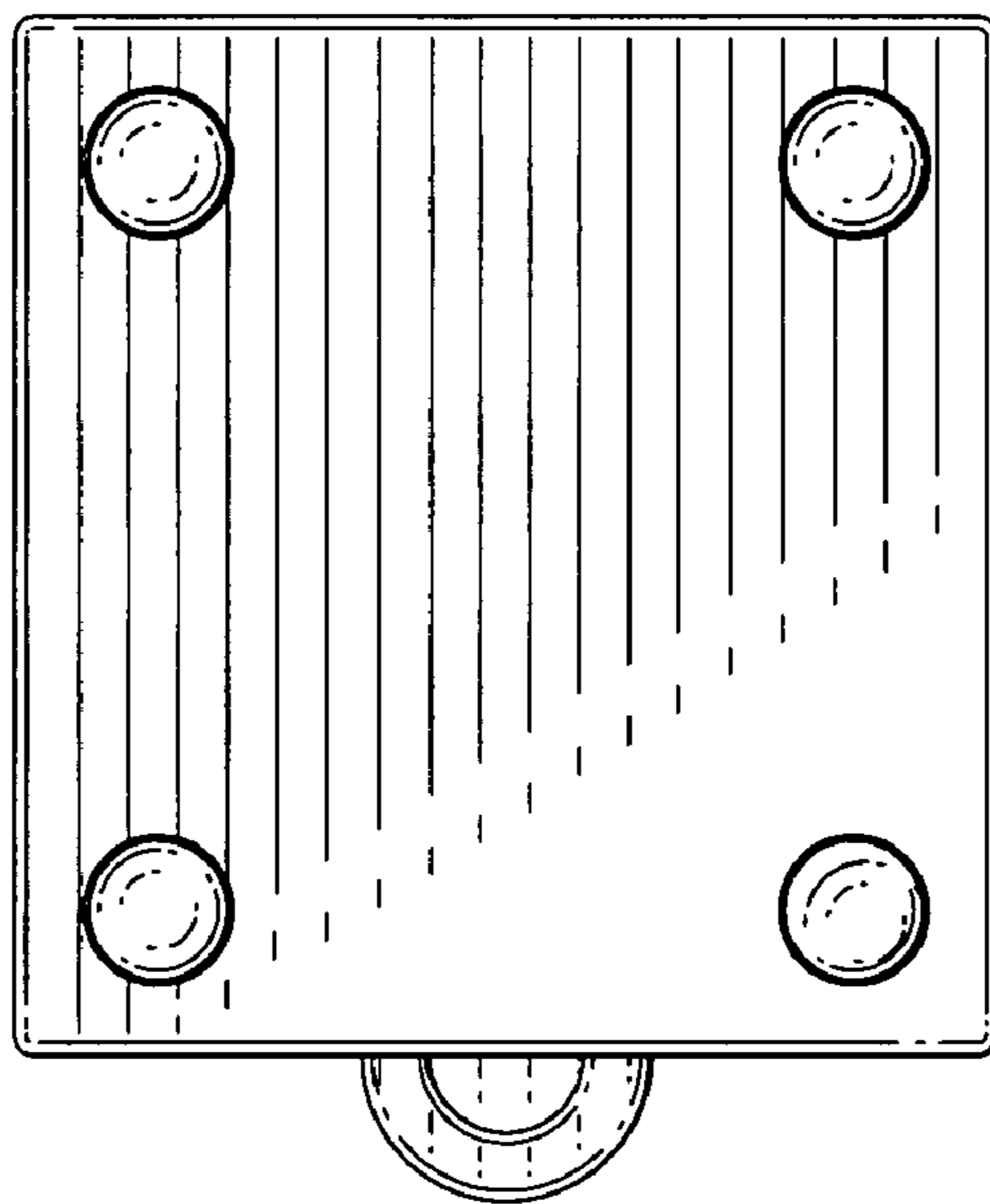

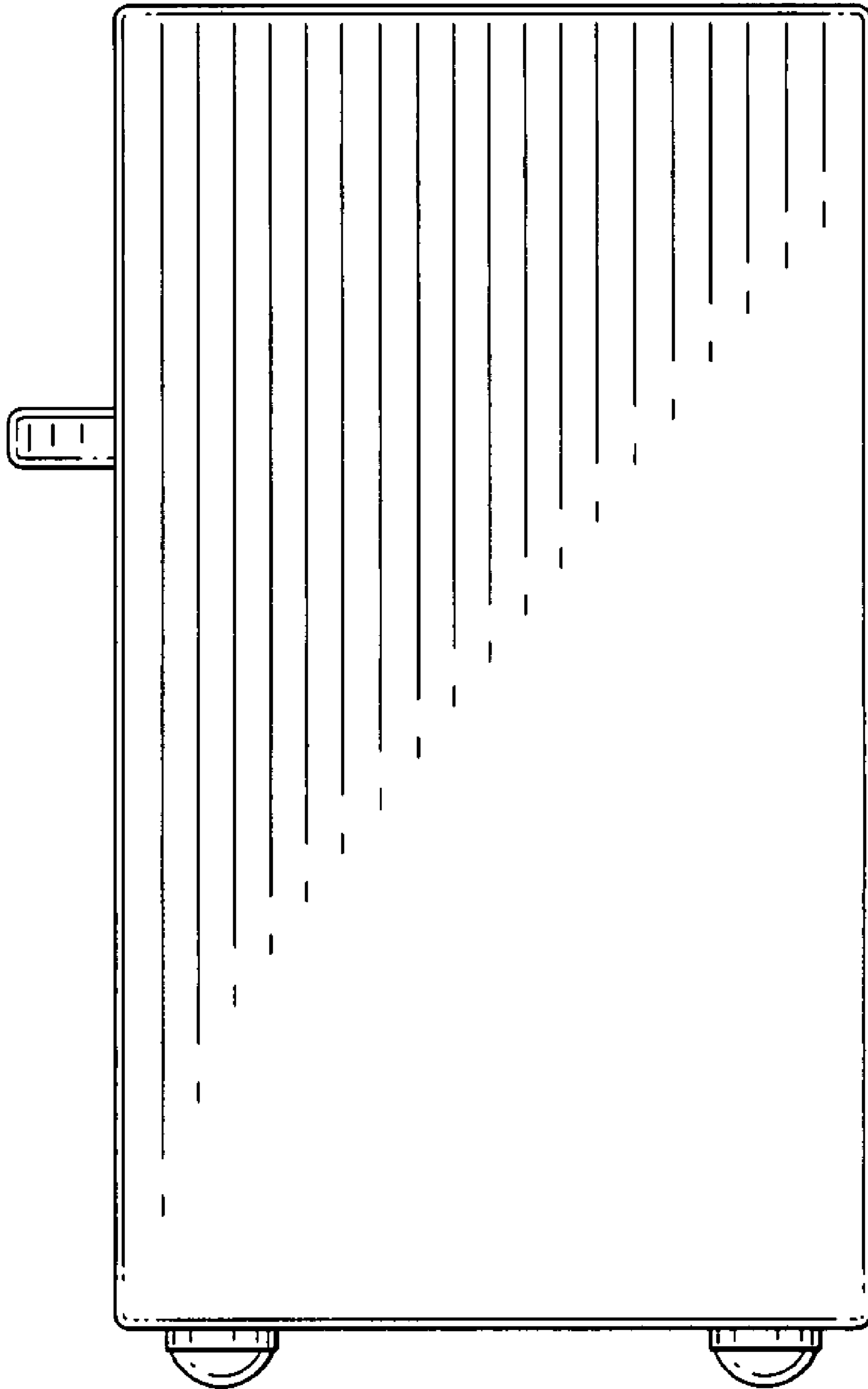

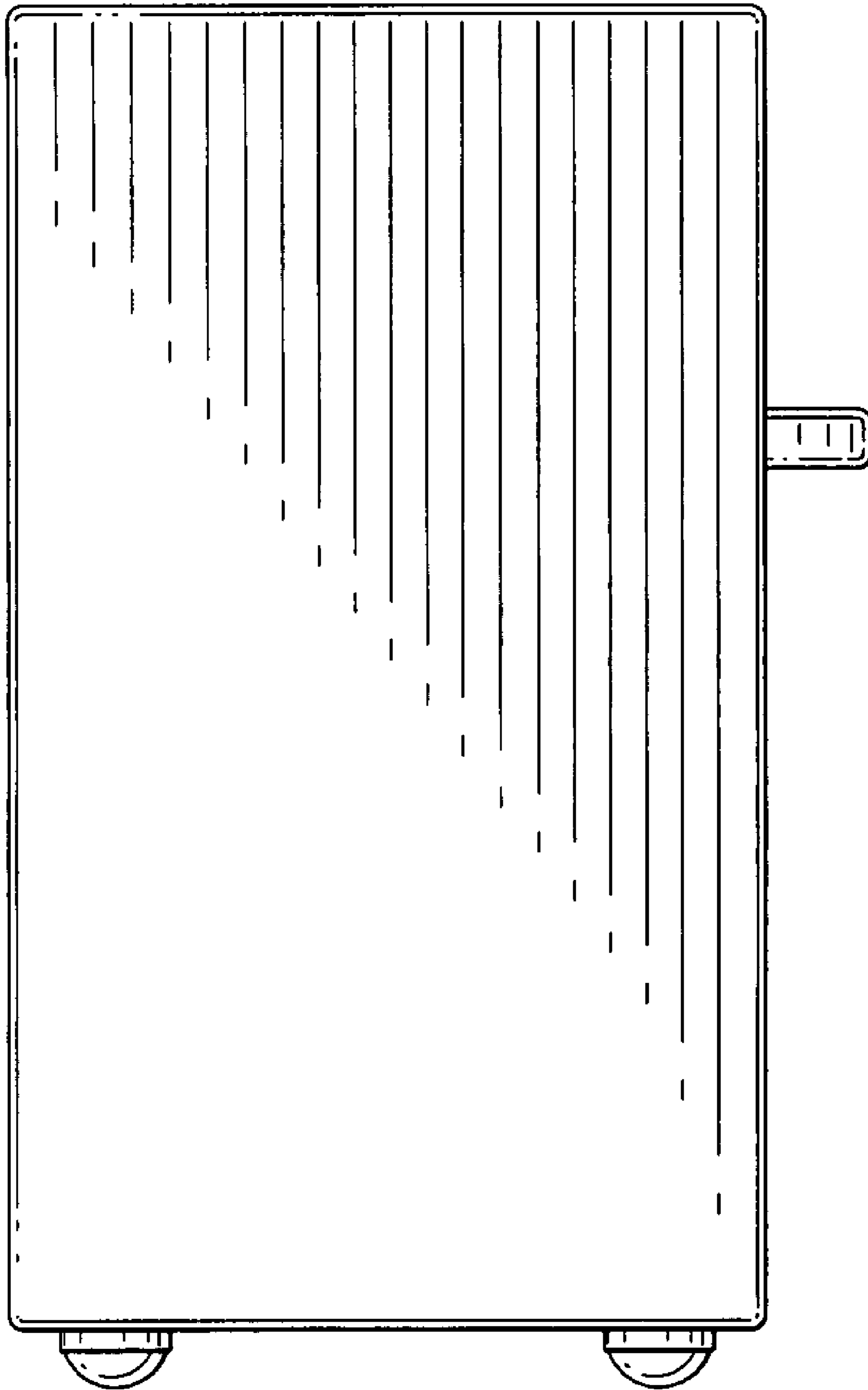

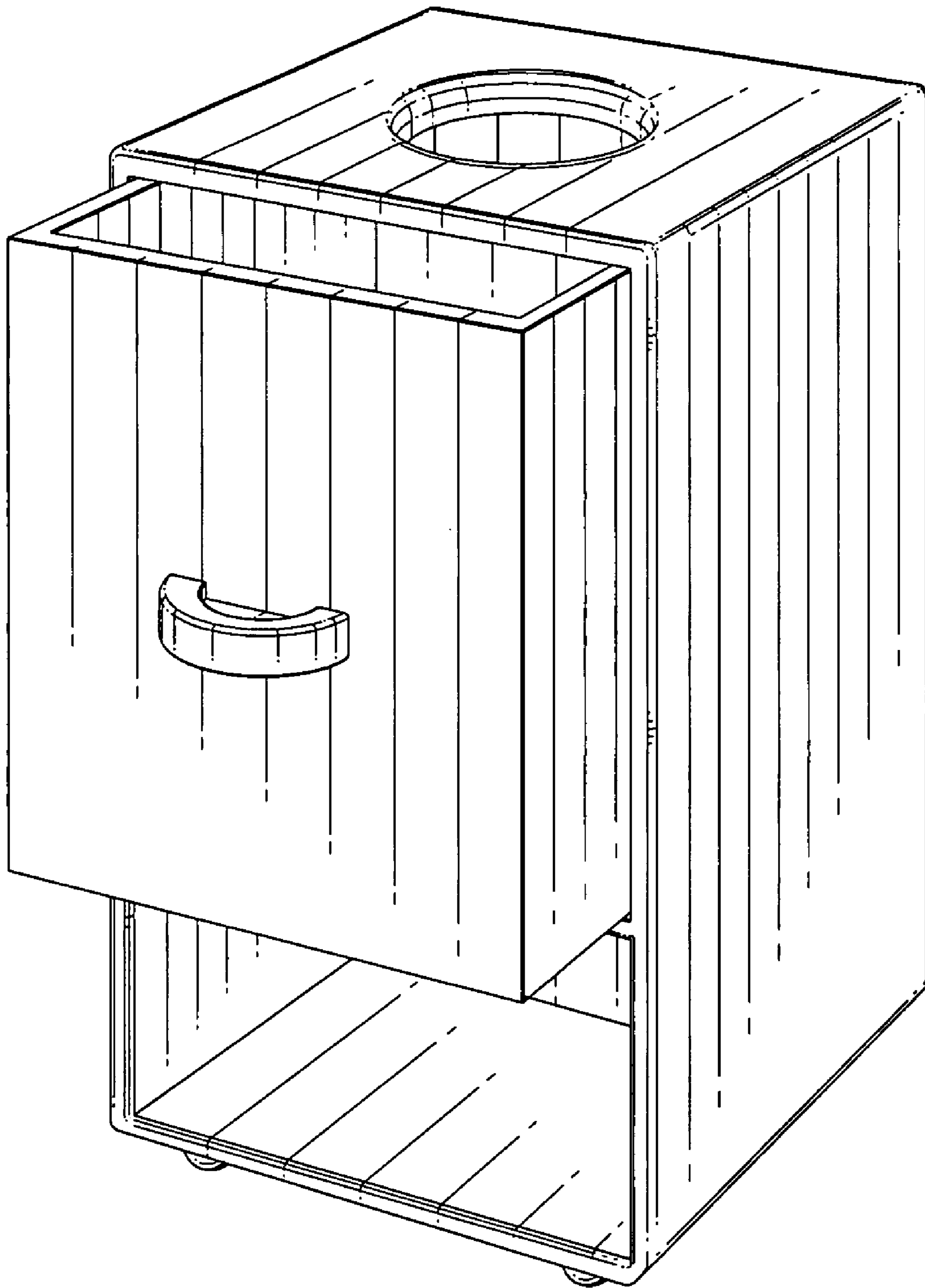
