FIG. 5 is a bottom view of the of the portable electronic device carrier depicted in FIG. 1; and,

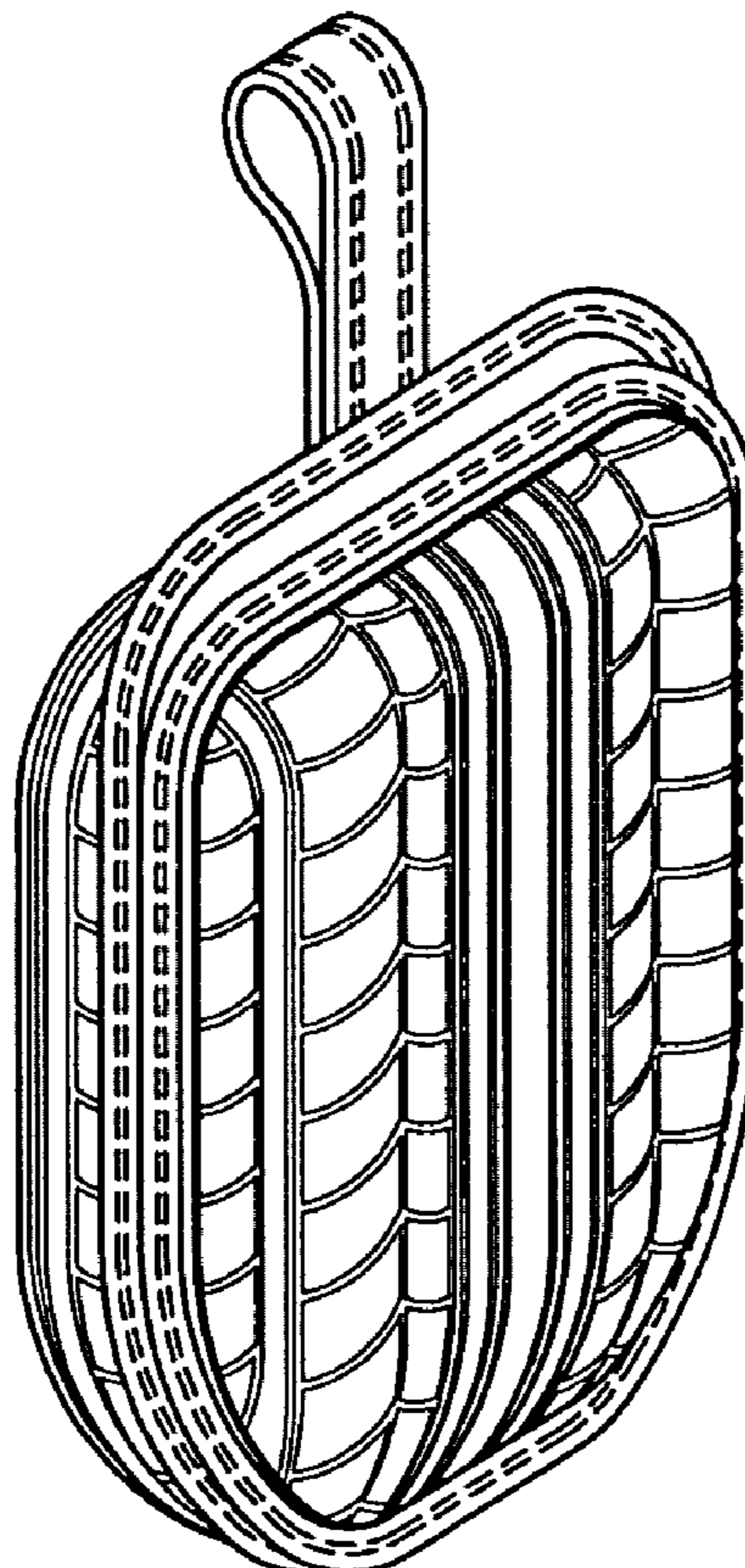
FIG. 6 is a rear view of the portable electronic device carrier depicted in FIG. 1.

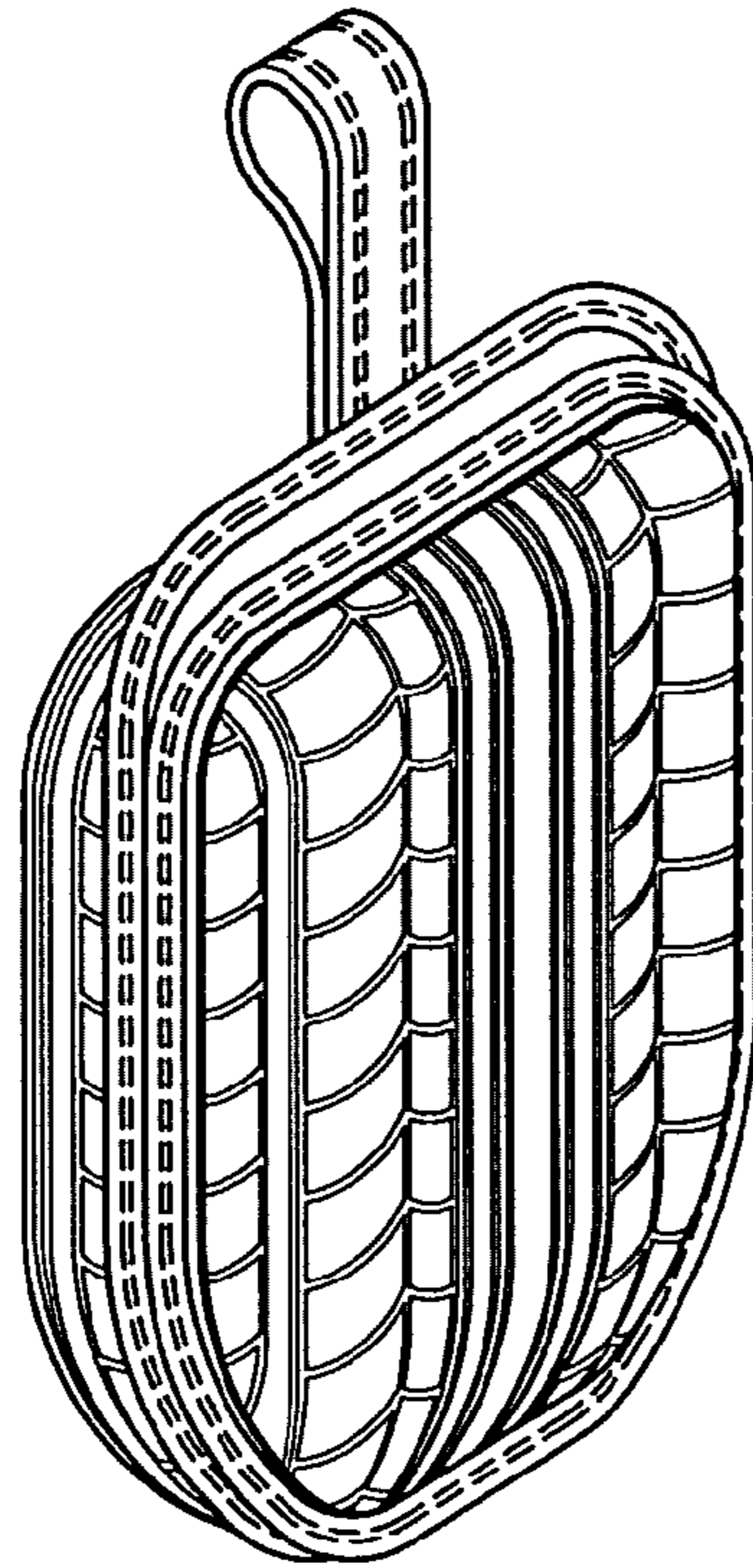

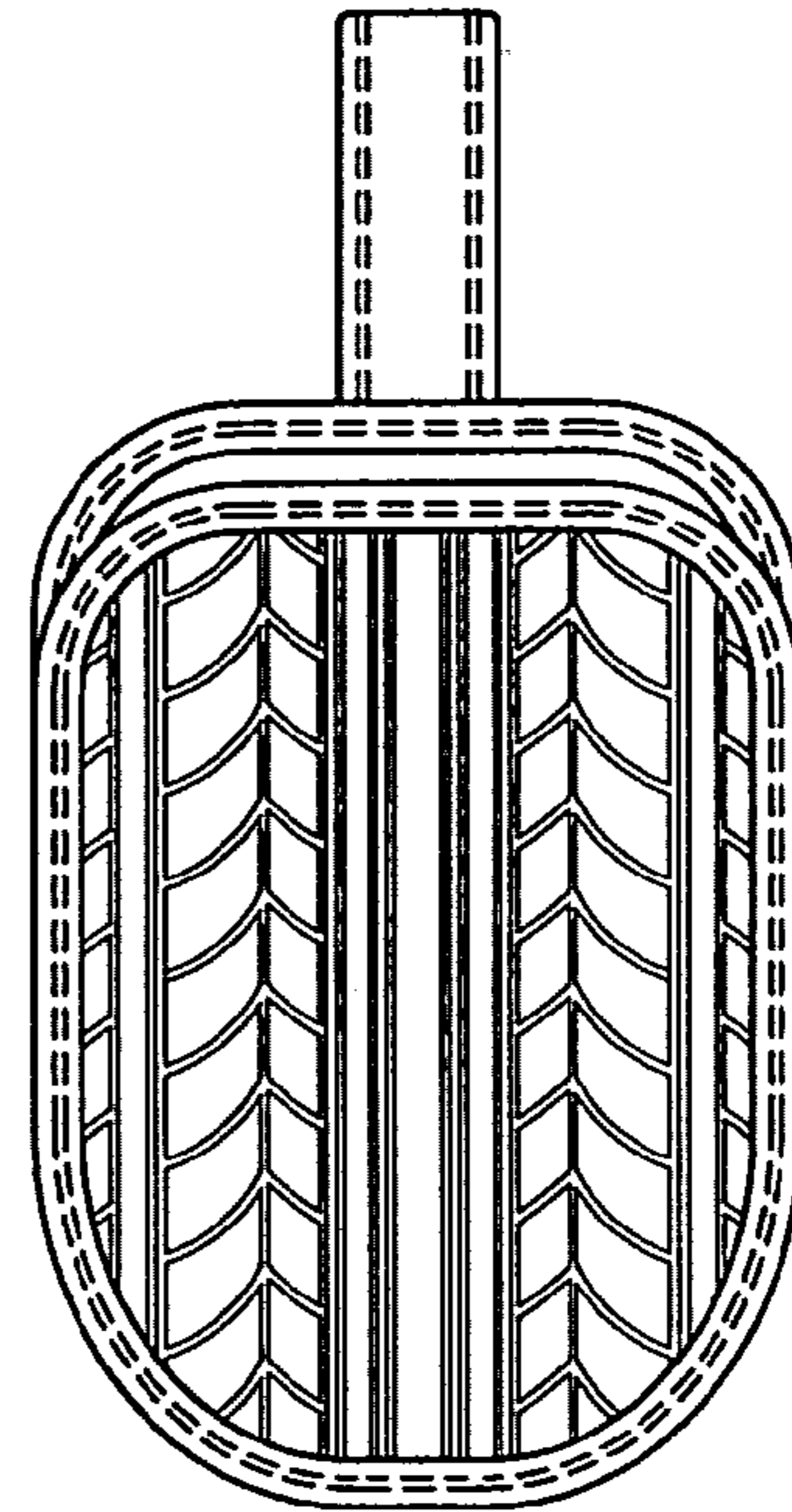

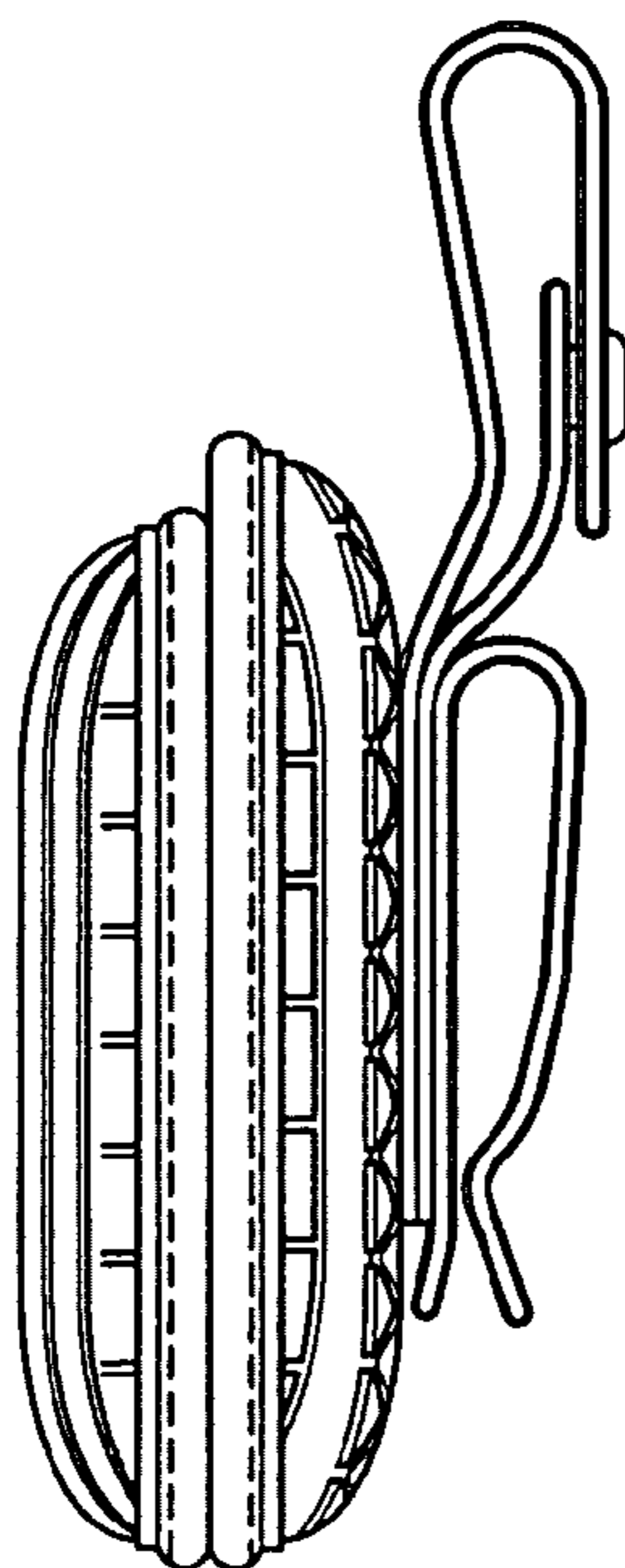

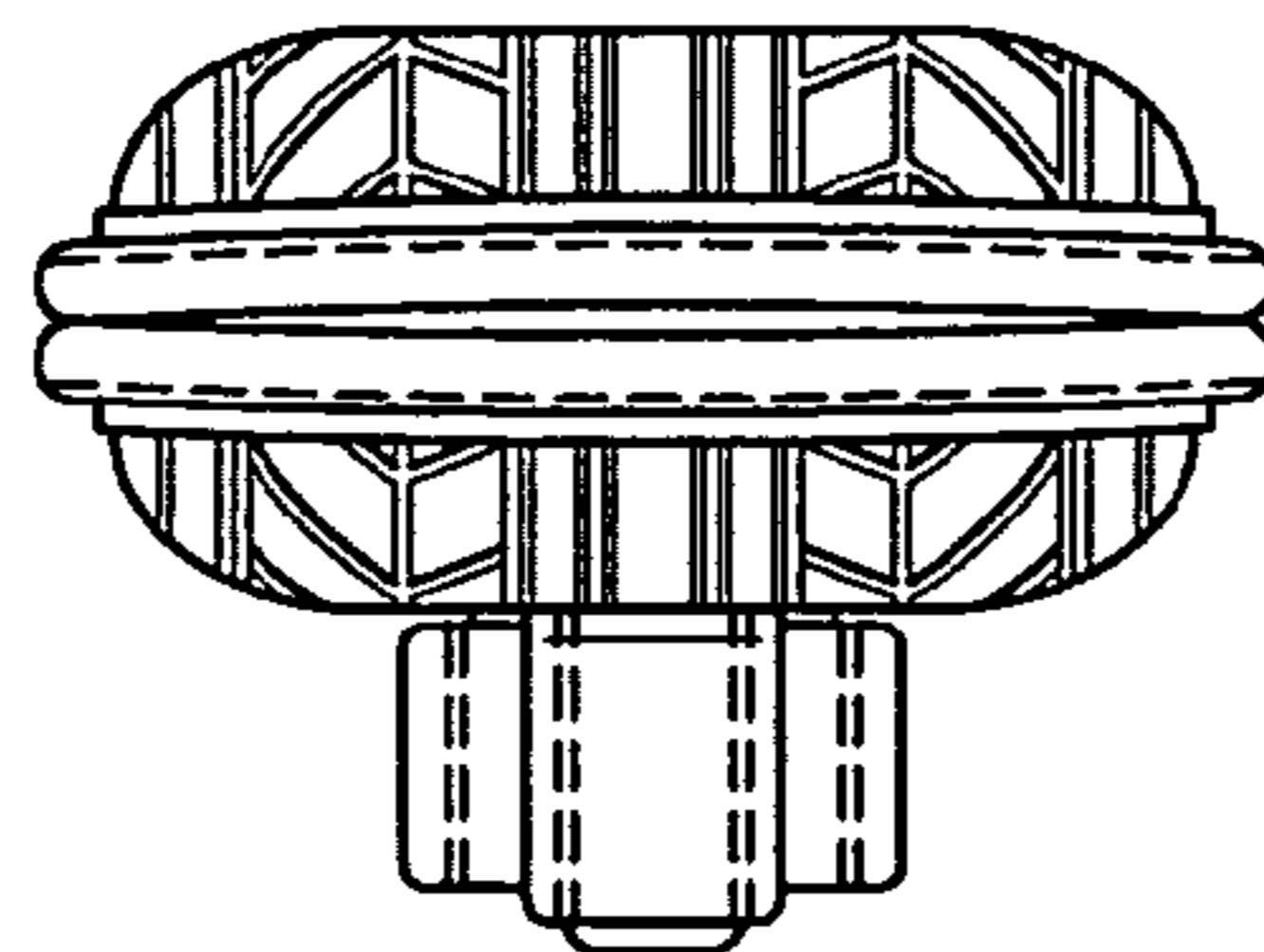

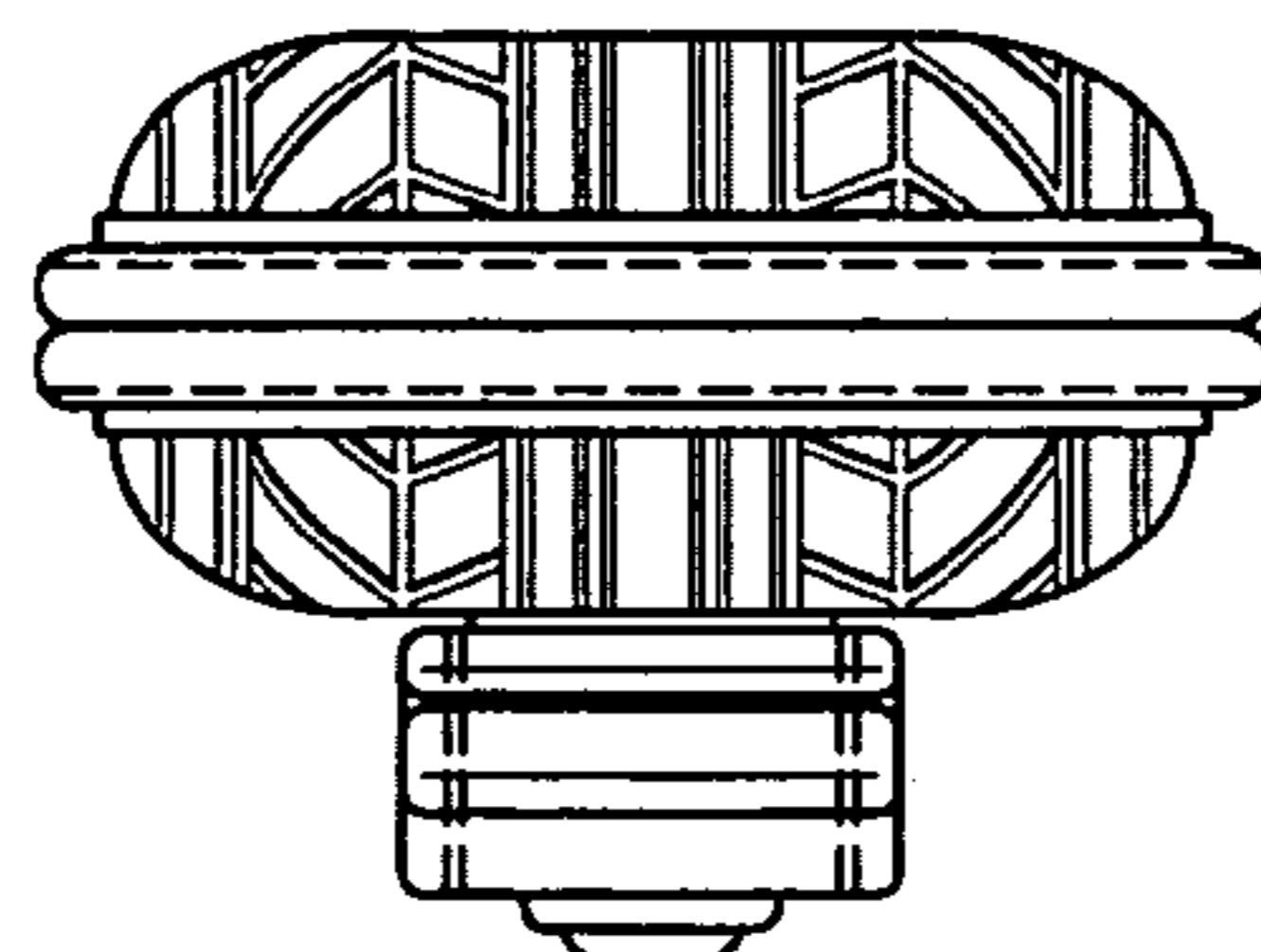

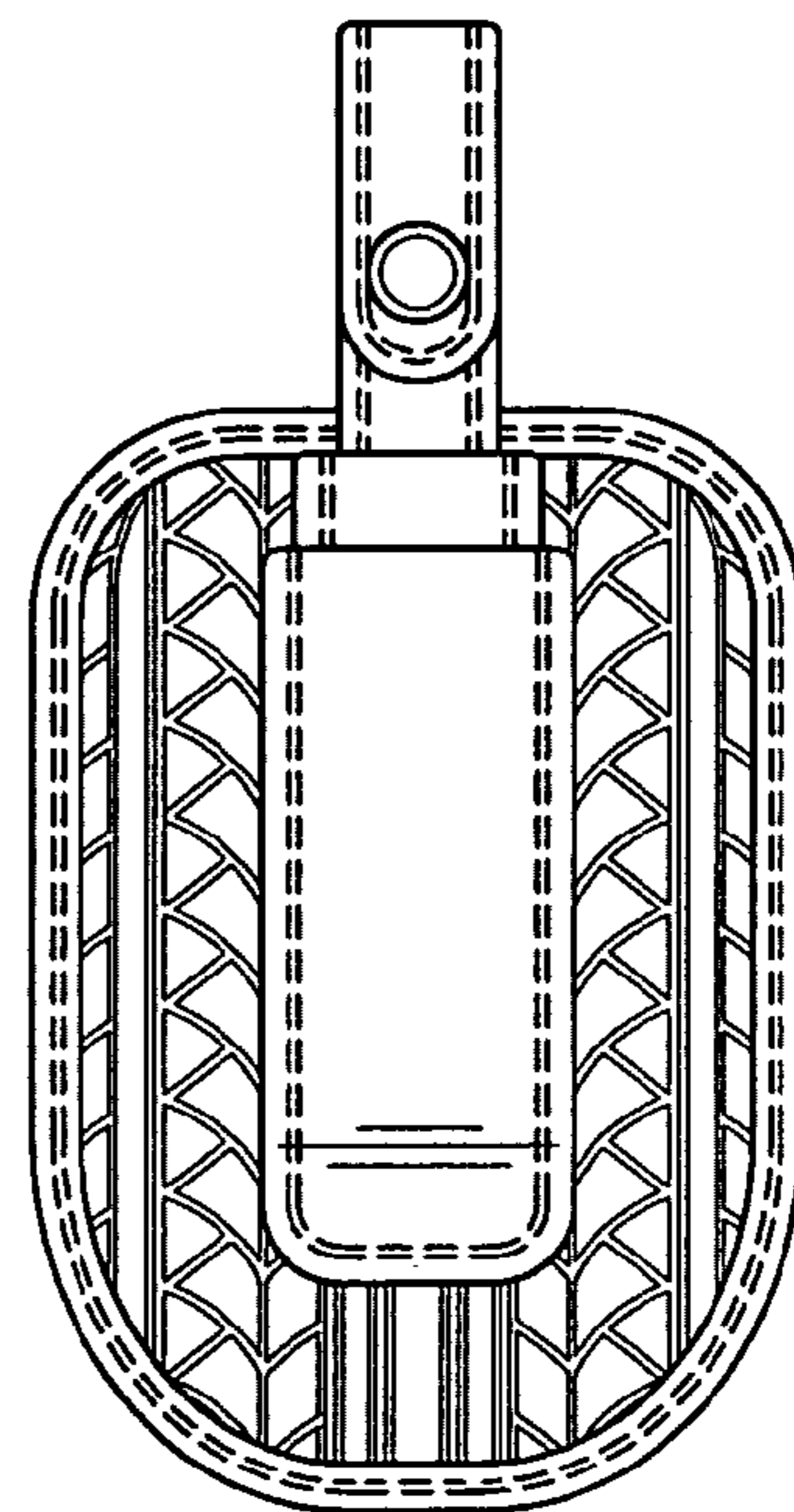
