FIG. 2 is a top plan view thereof;

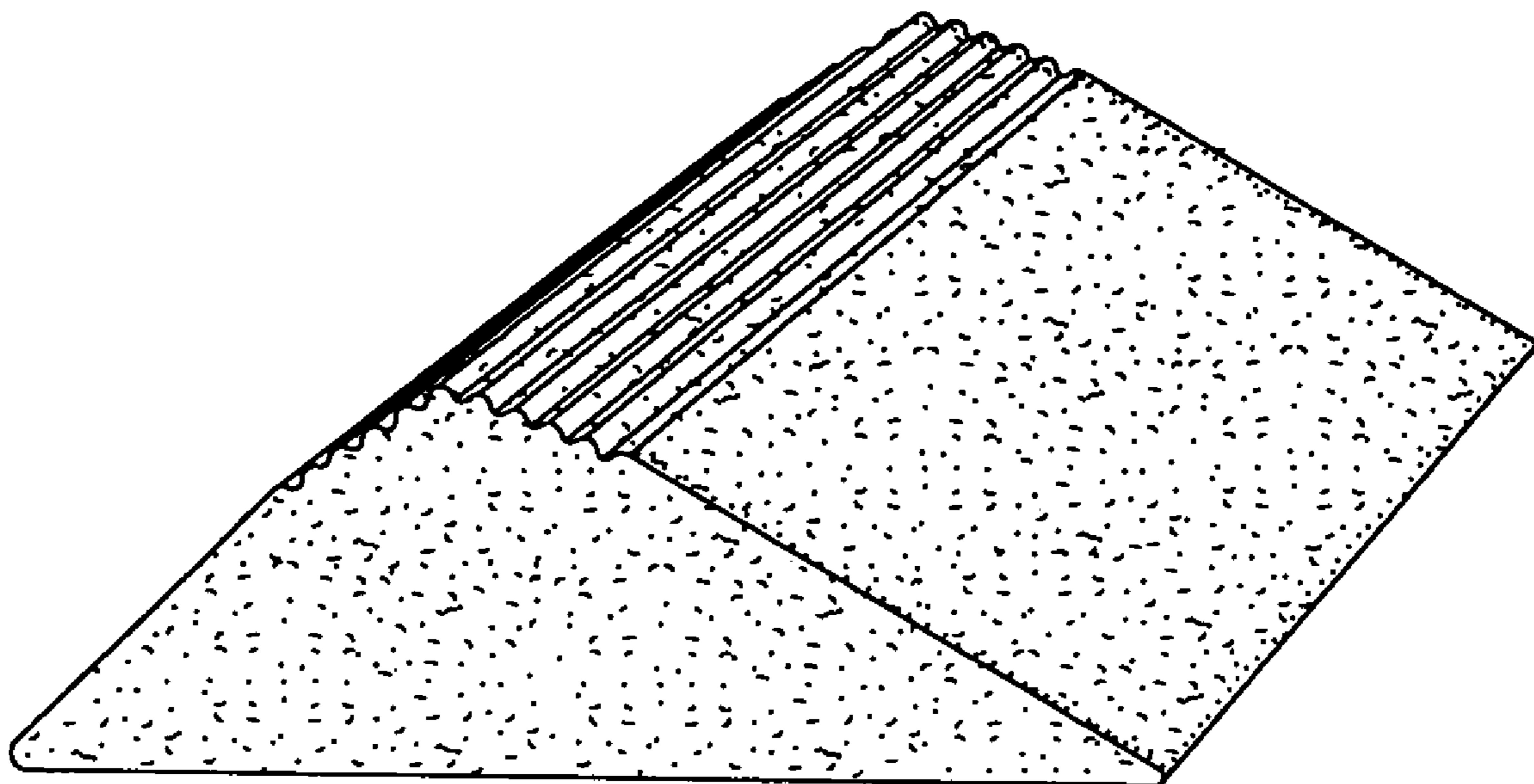
FIG. 3 is a side elevational view thereof with the broken lines depicting solely environmental structure and forming no part of the claimed design;

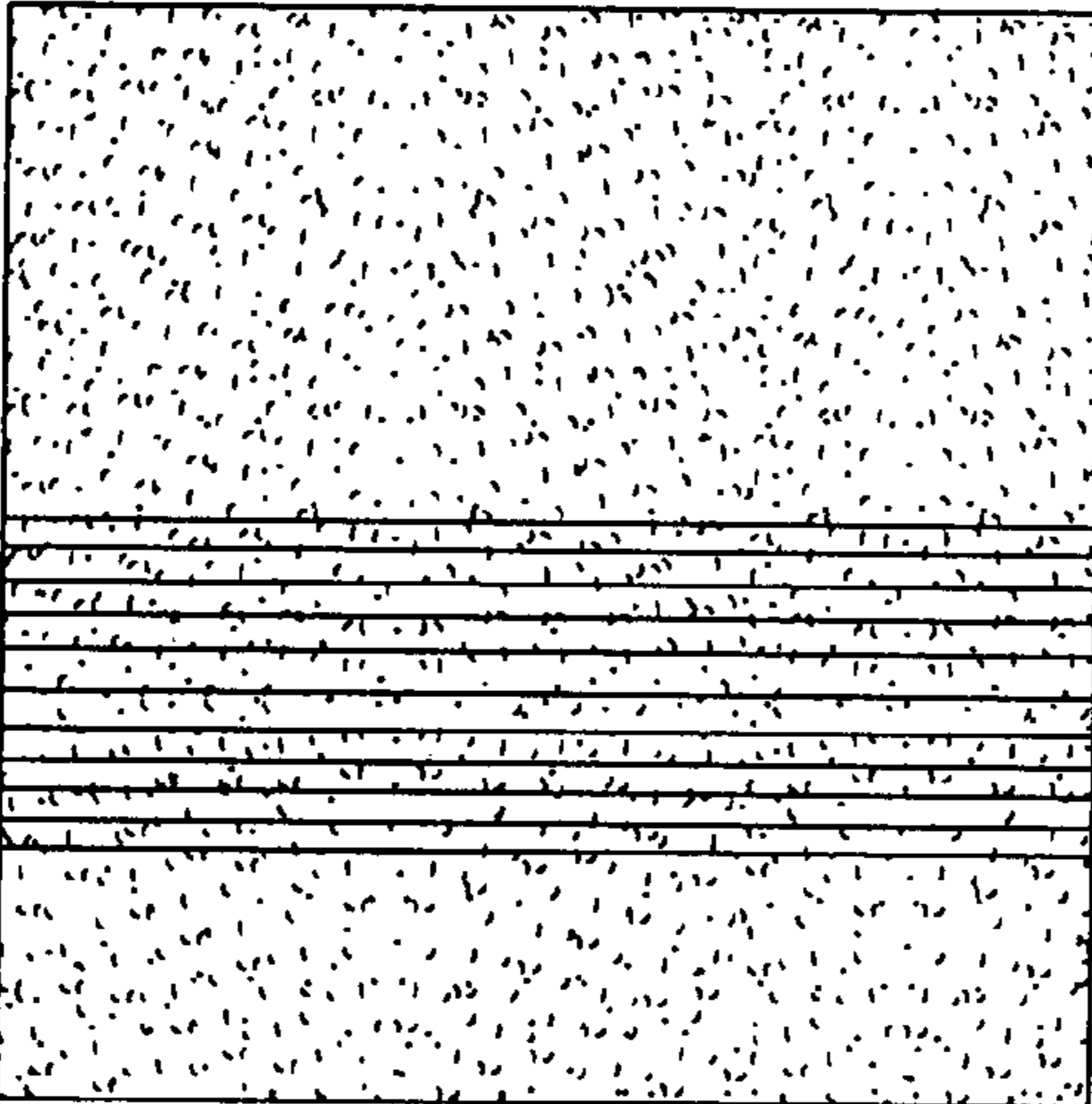

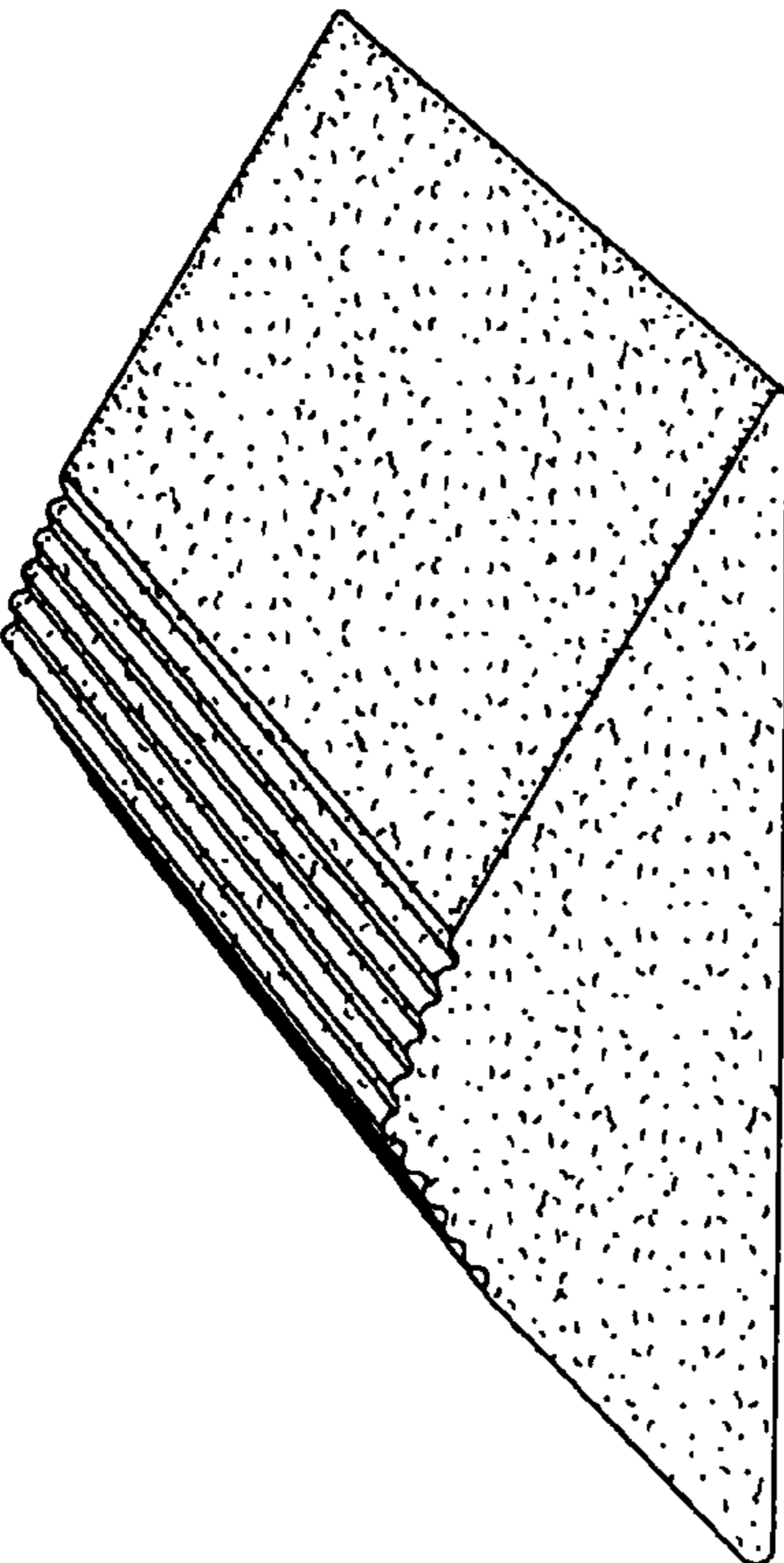

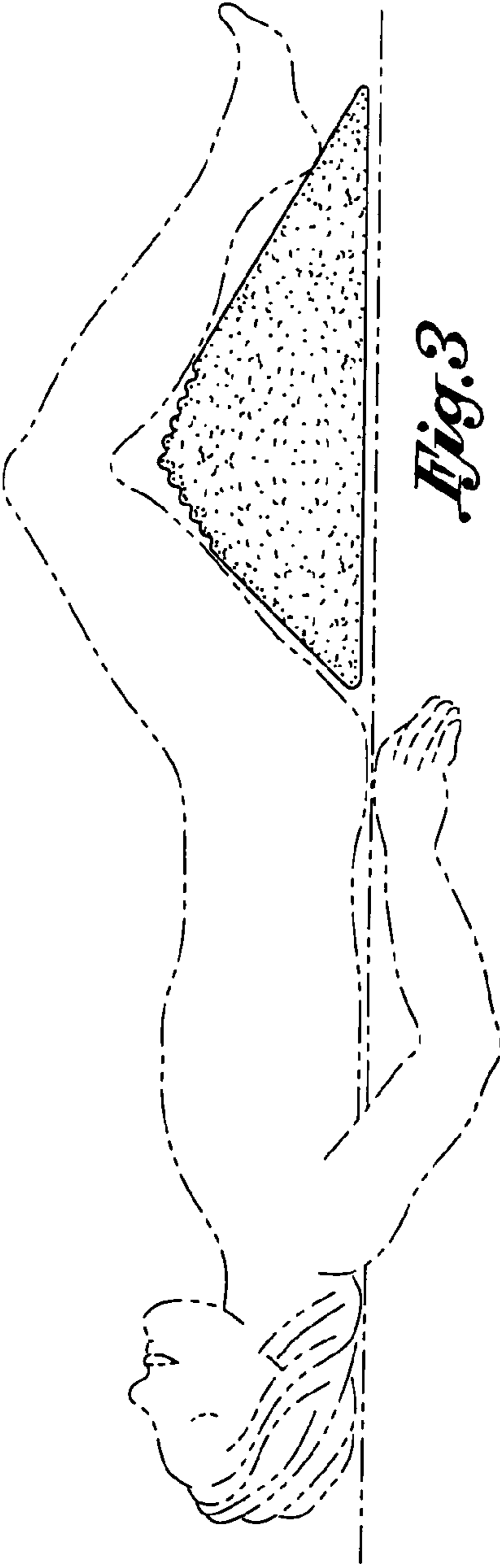

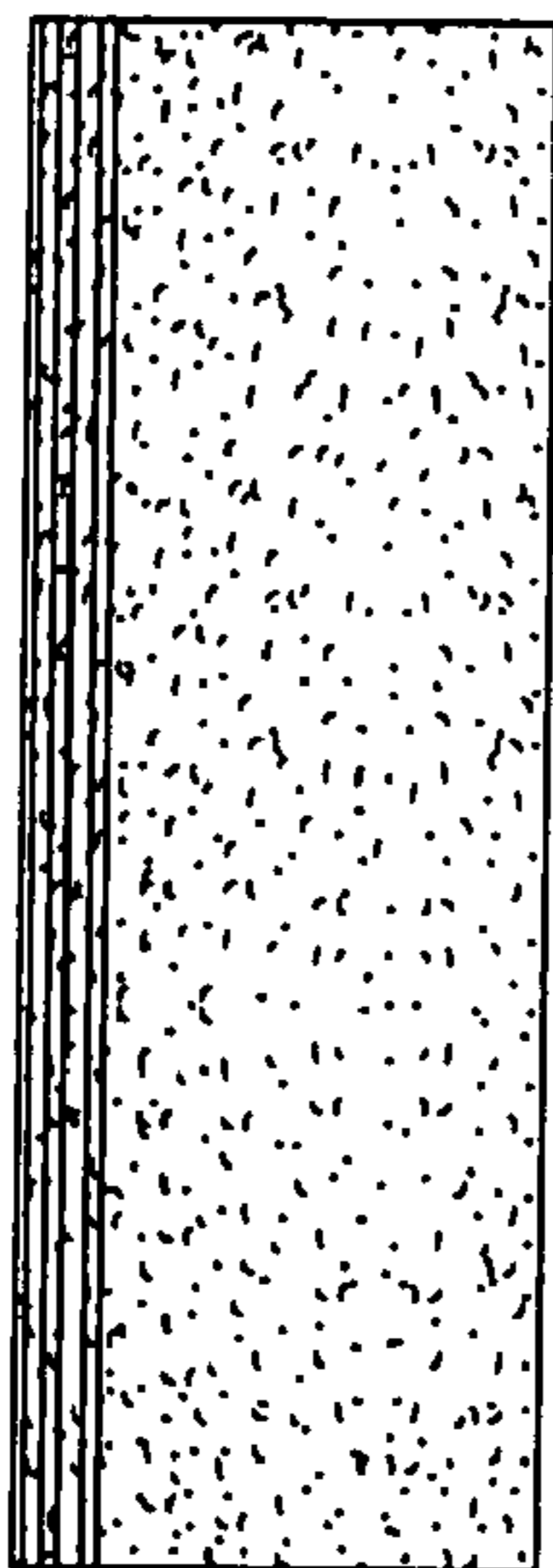

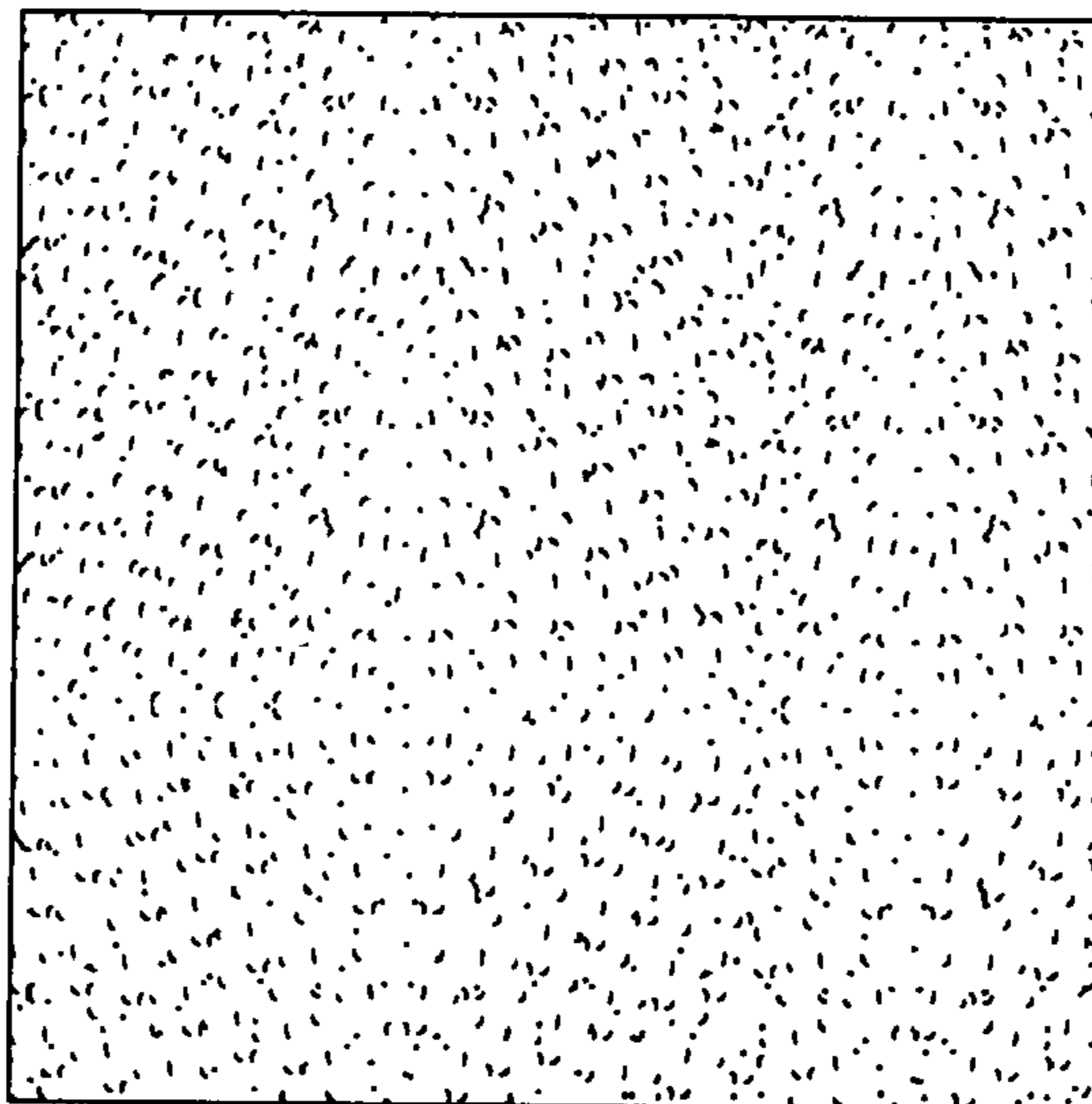

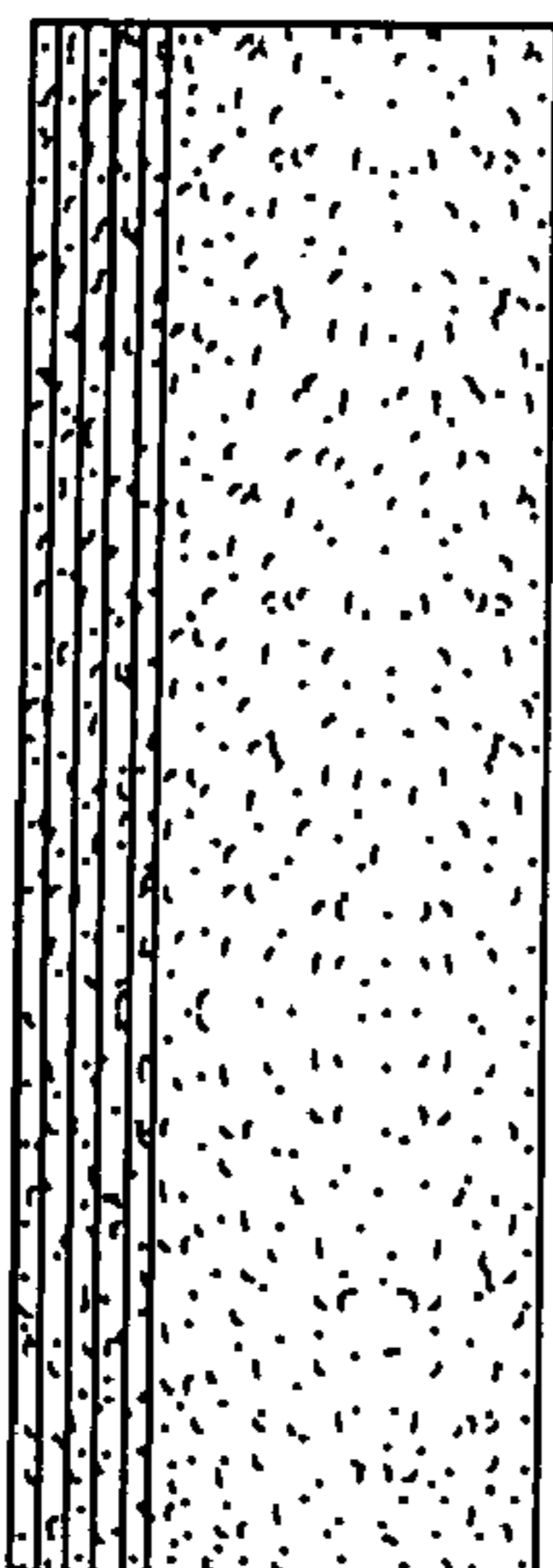
