The broken lines shown in FIG. 8 are for illustrative purposes only and form no part of the claimed design.

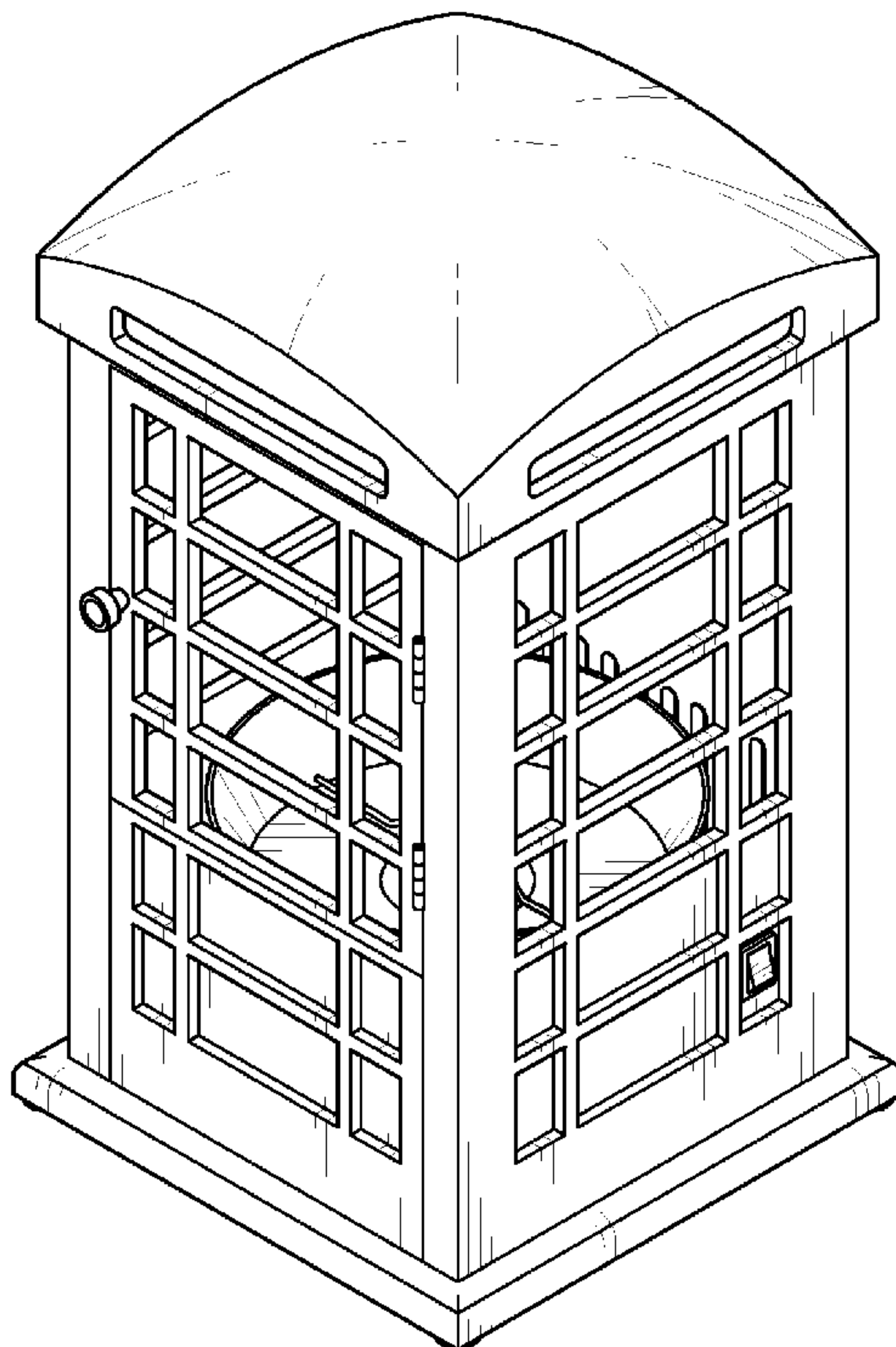

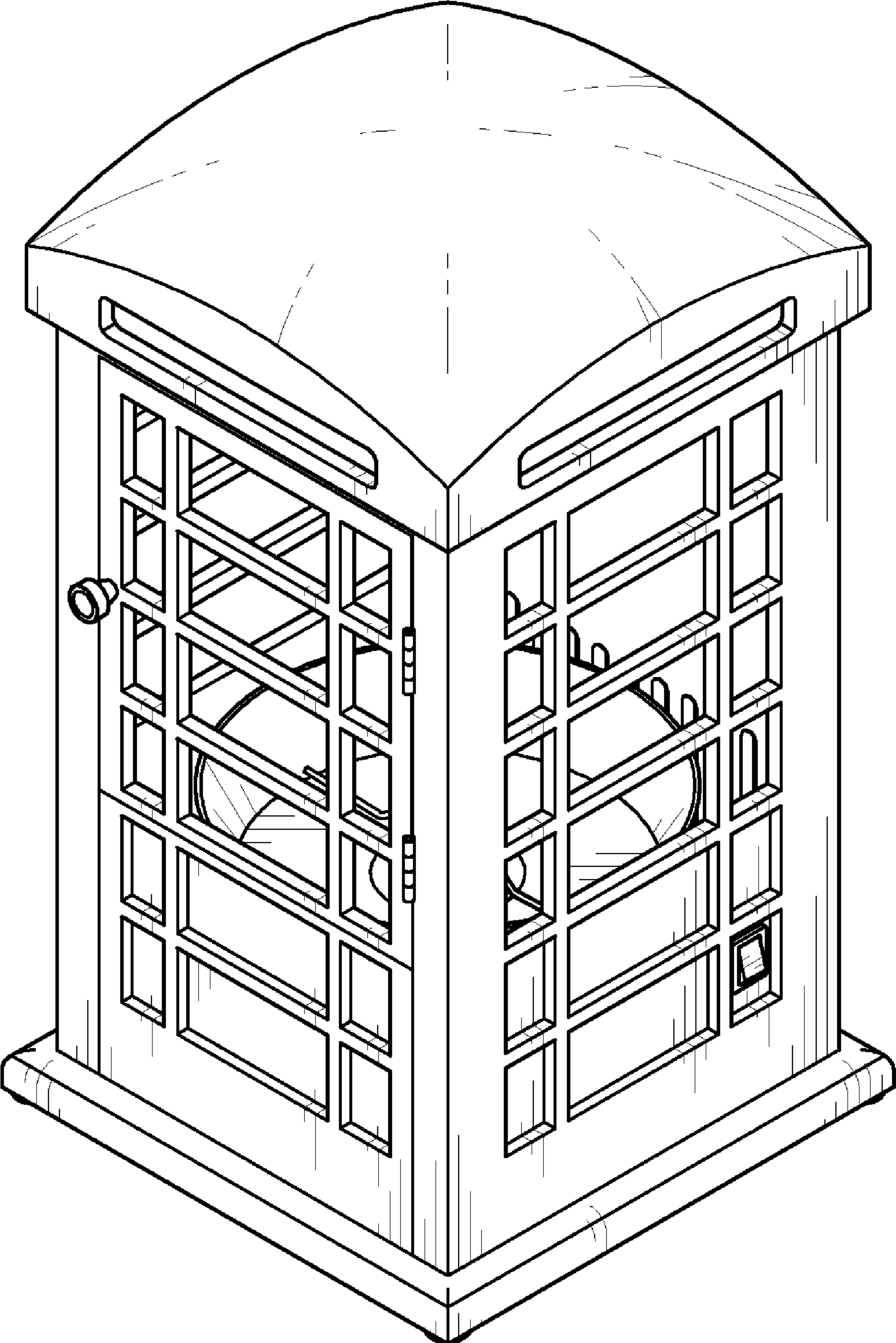

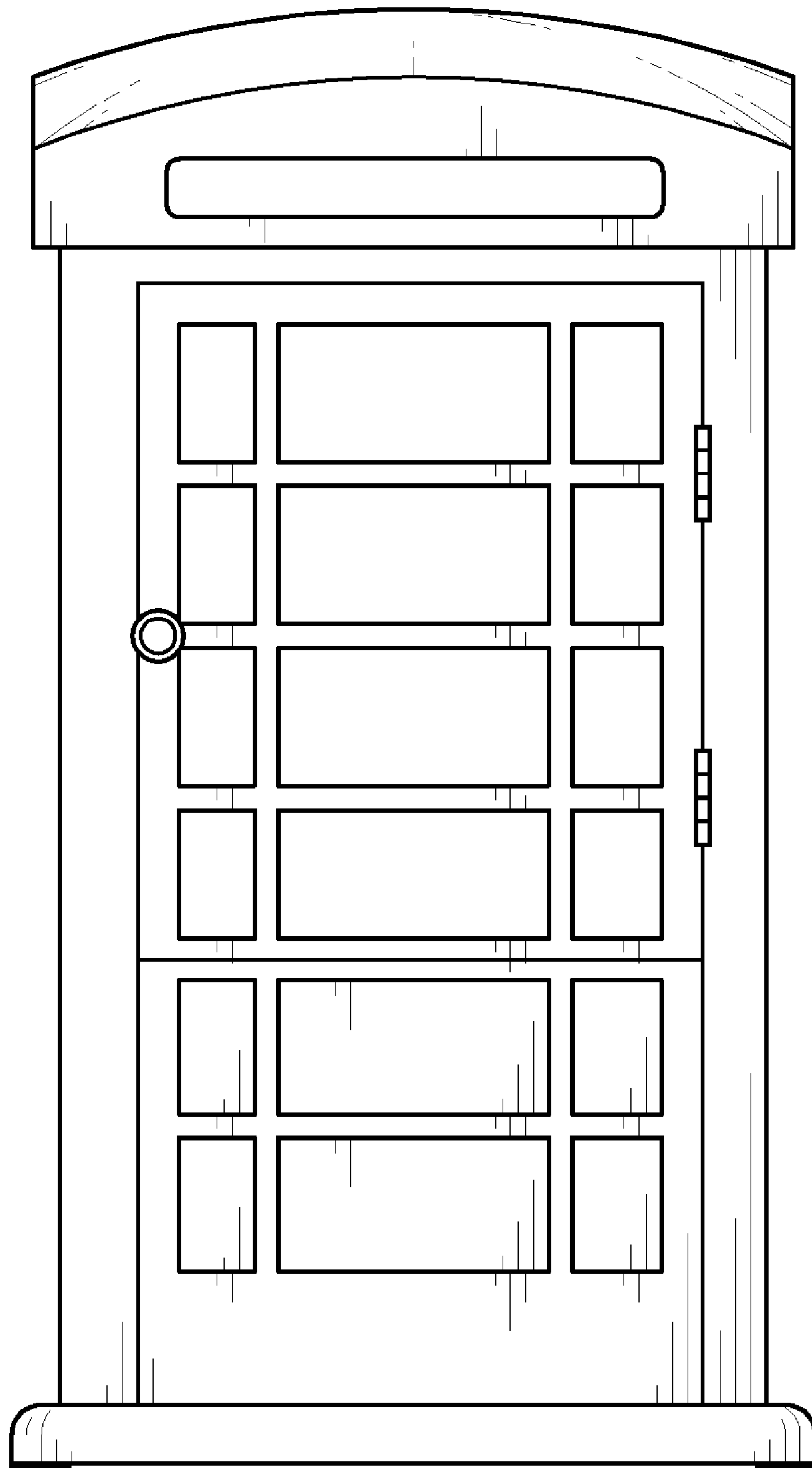

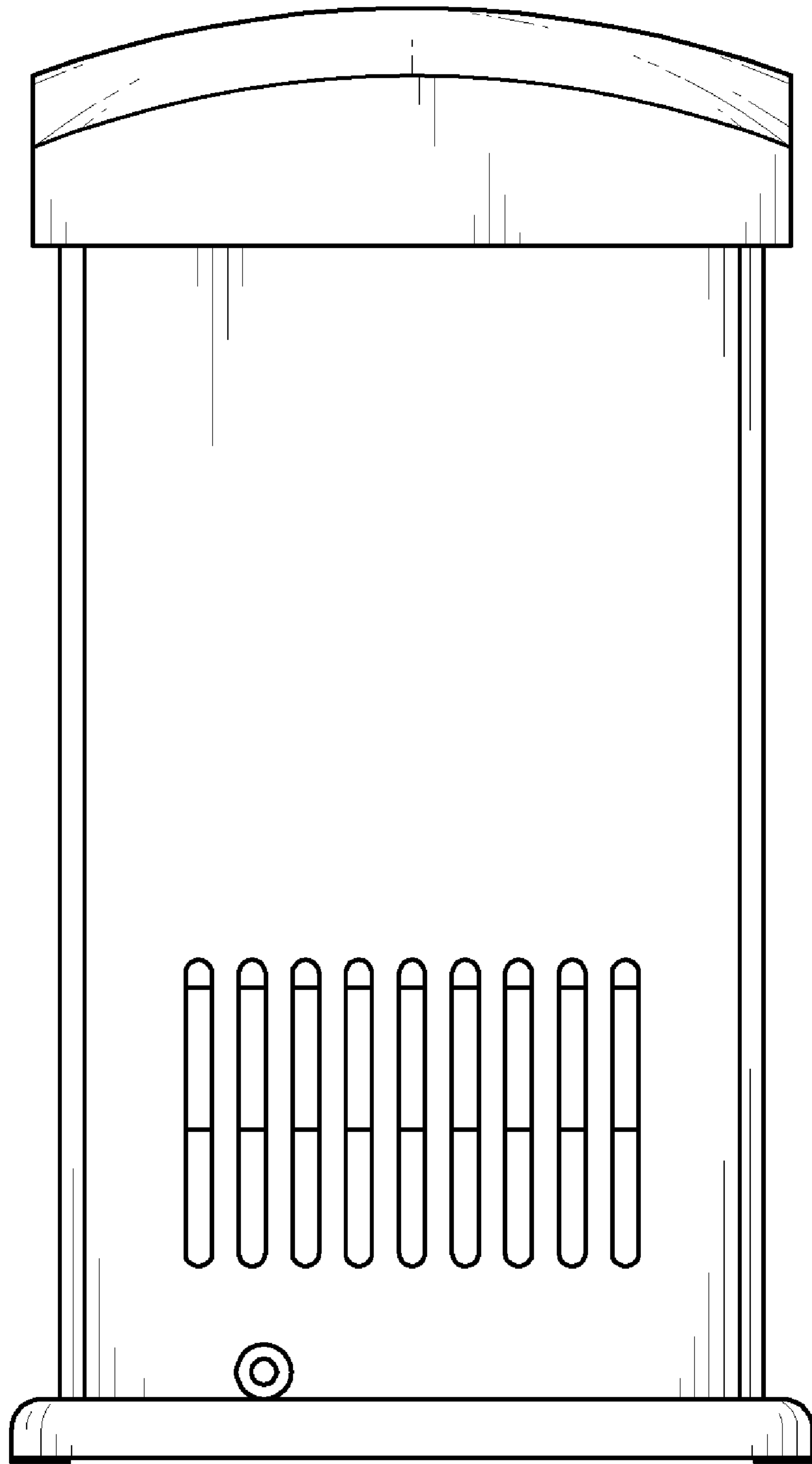

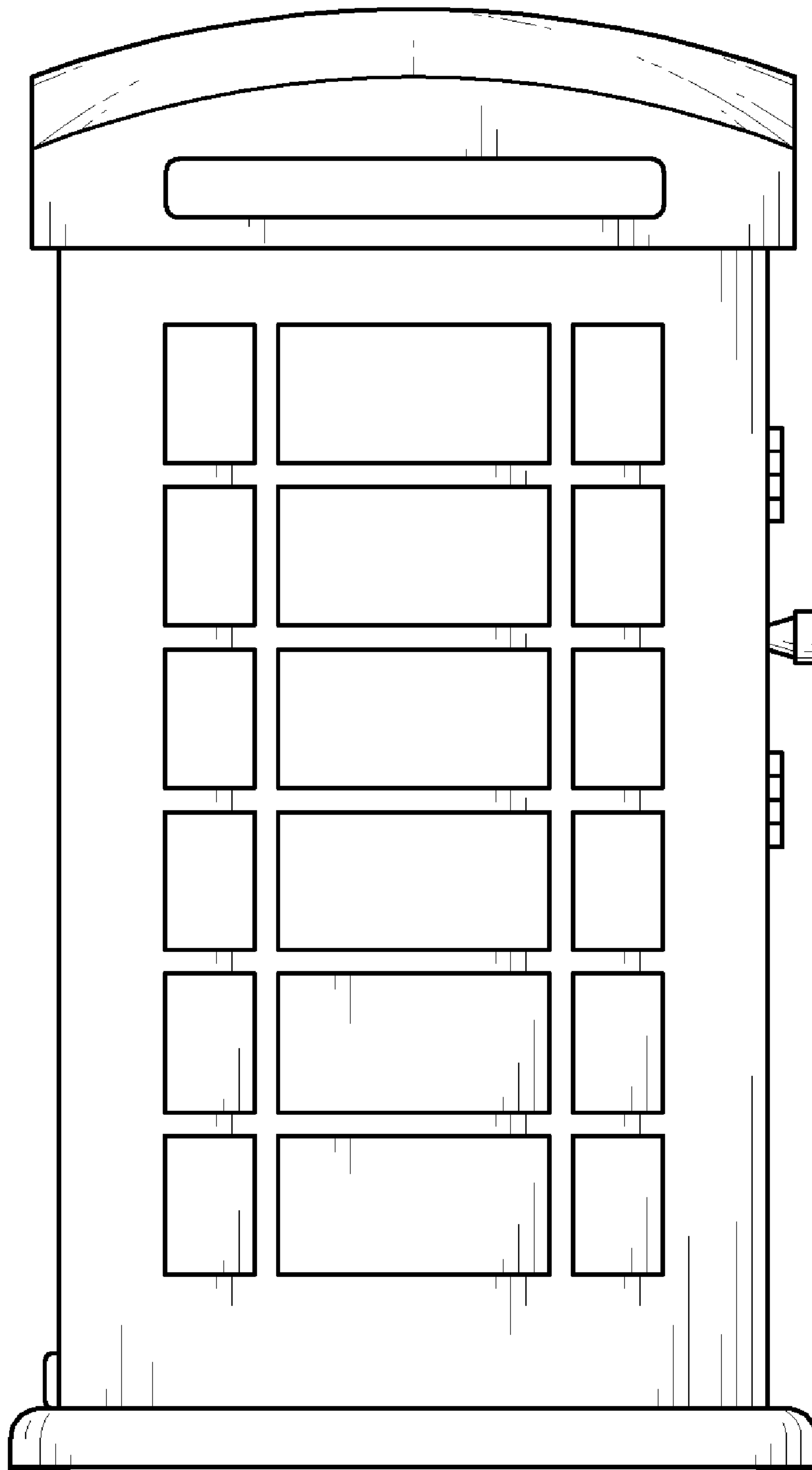

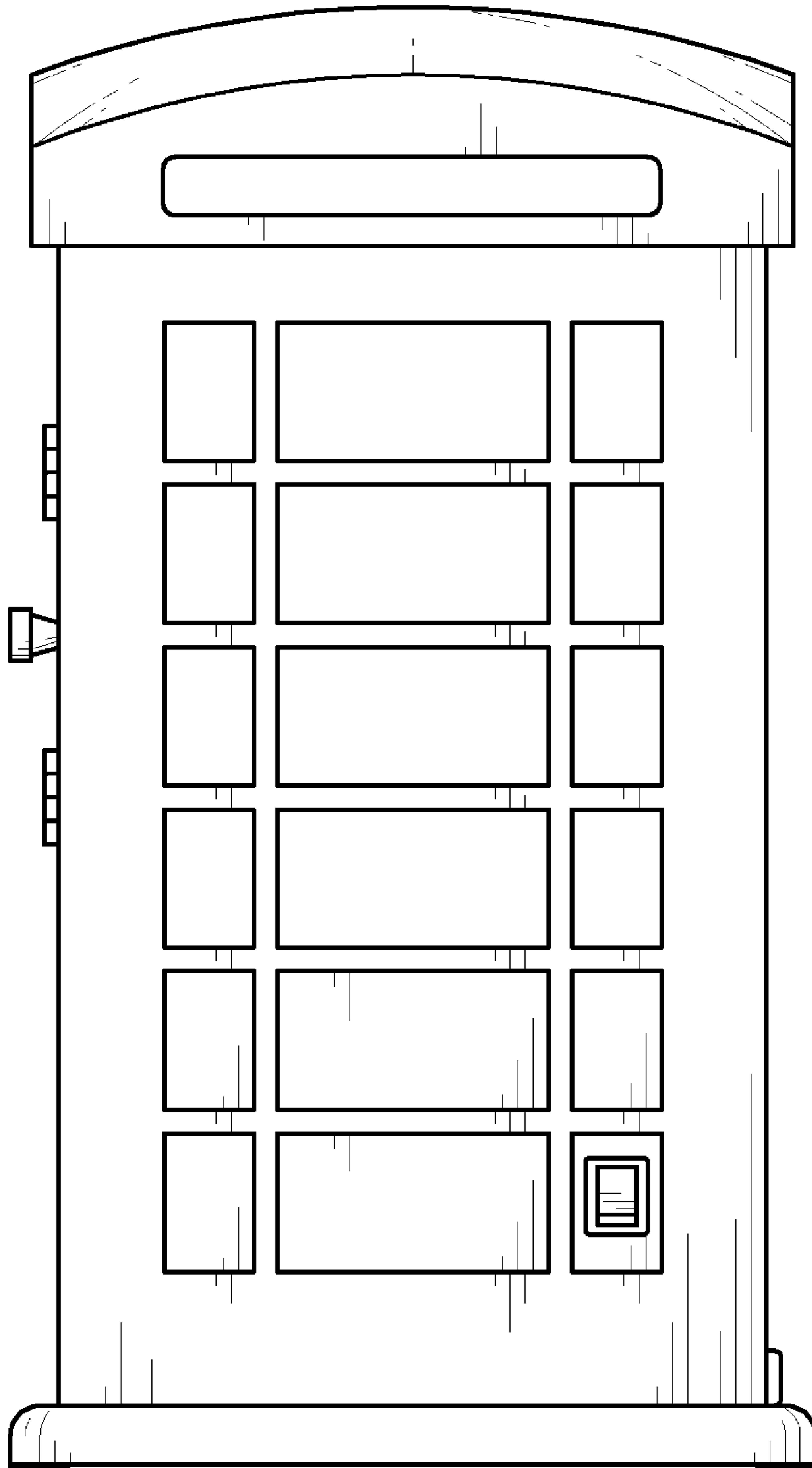

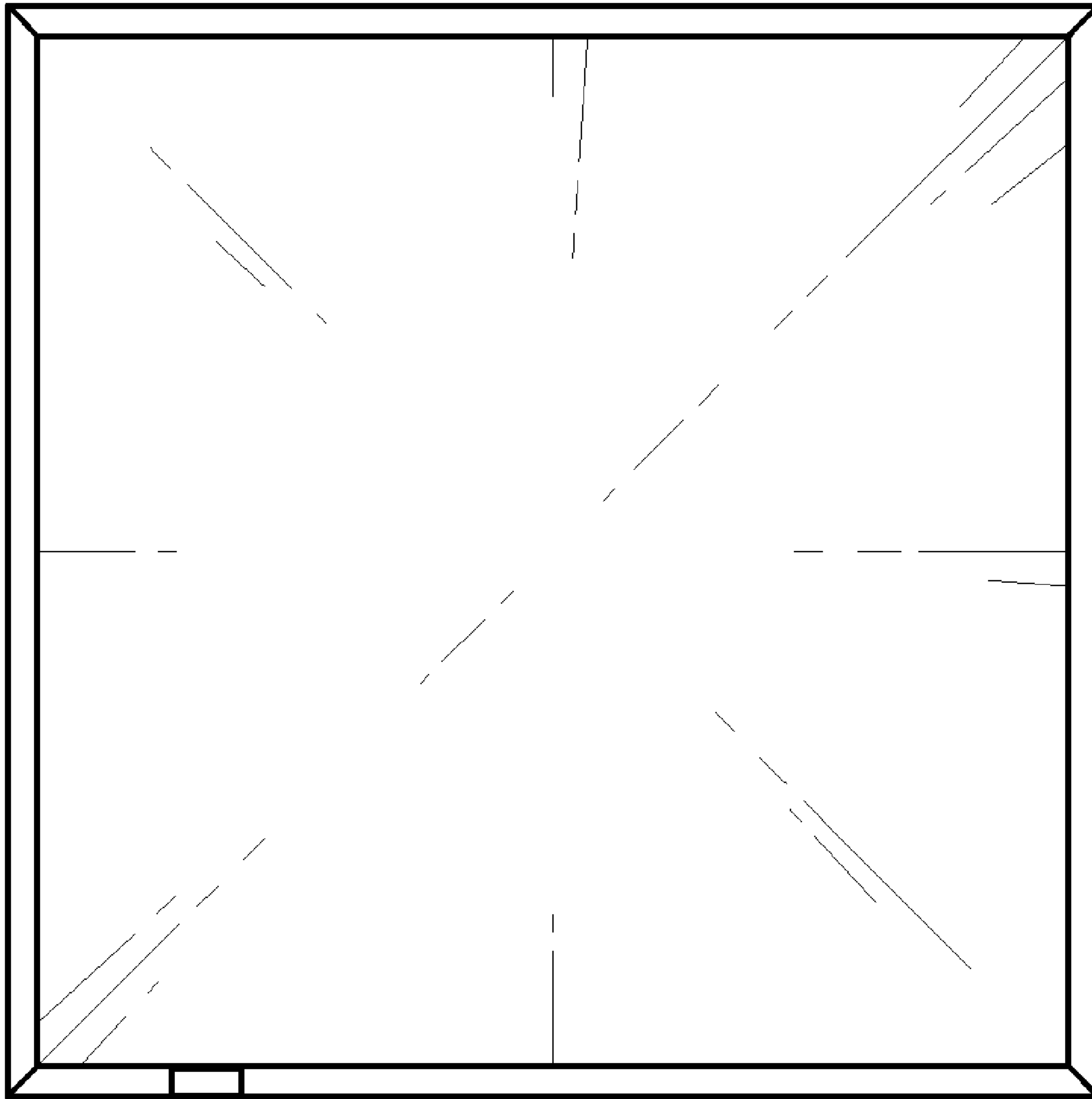

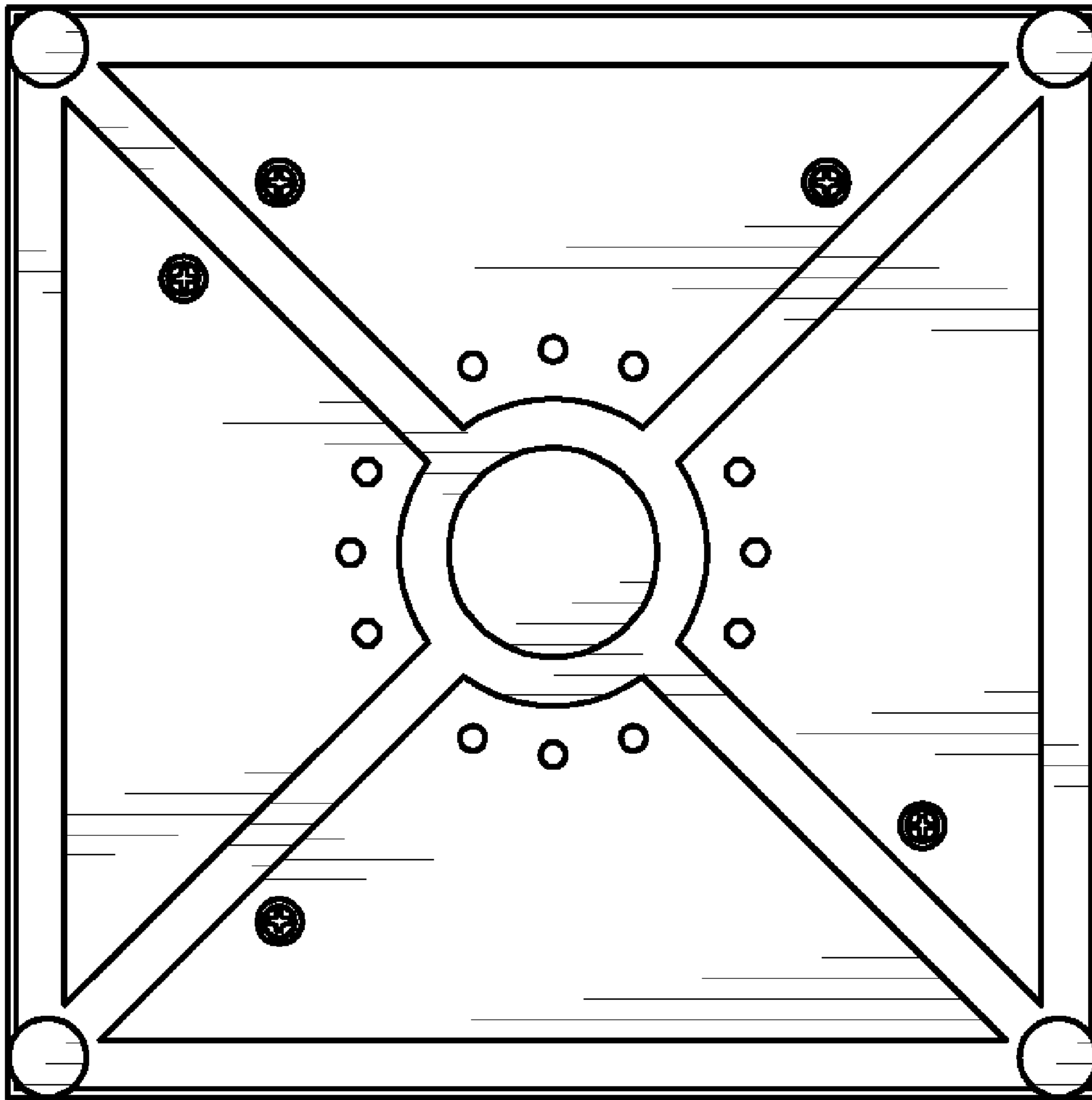

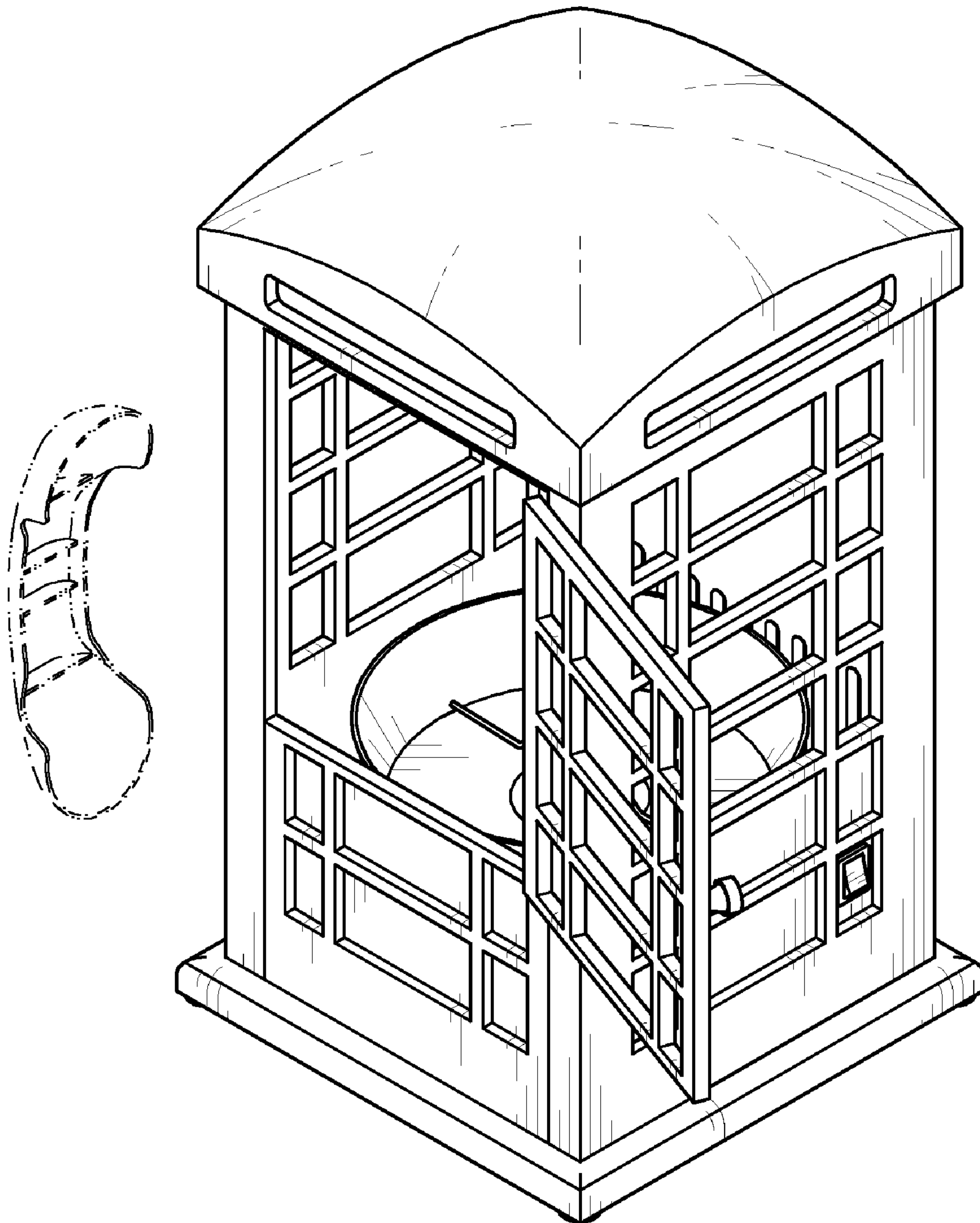
