(57) **CLAIM**

The ornamental design for a rechargeable electric safety knife assembly, as shown and described.

DESCRIPTION

FIG. 1 is a side perspective of the rechargeable electric safety knife assembly showing our new design;

FIG. 2 is a left side elevational view thereof;

FIG. 3 is a top plan view thereof; shown with the rechargeable knife's blades in the left slot of the safety base;

FIG. 4 is a right side elevational view thereof;

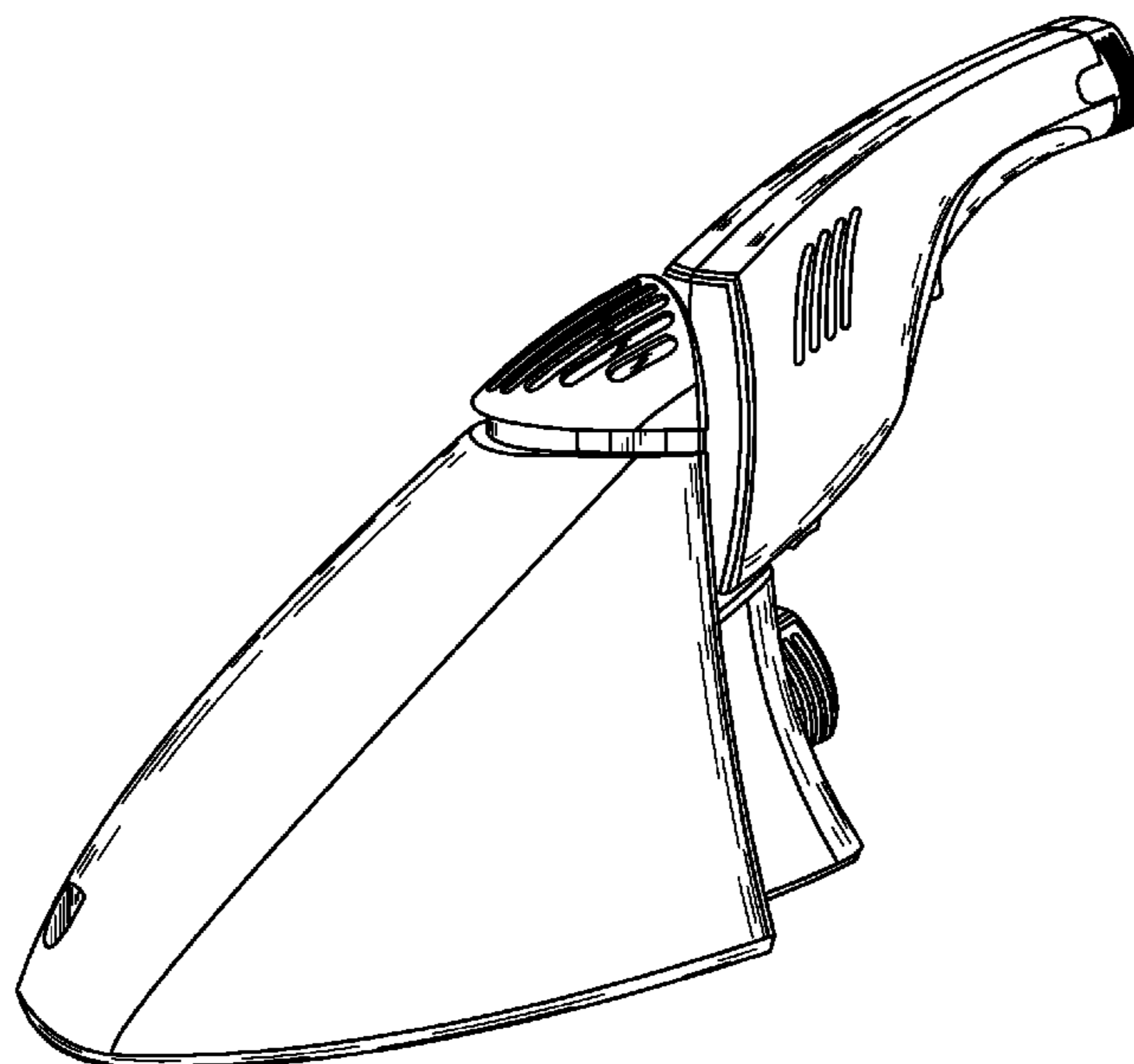
FIG. 5 is a bottom plan view thereof;

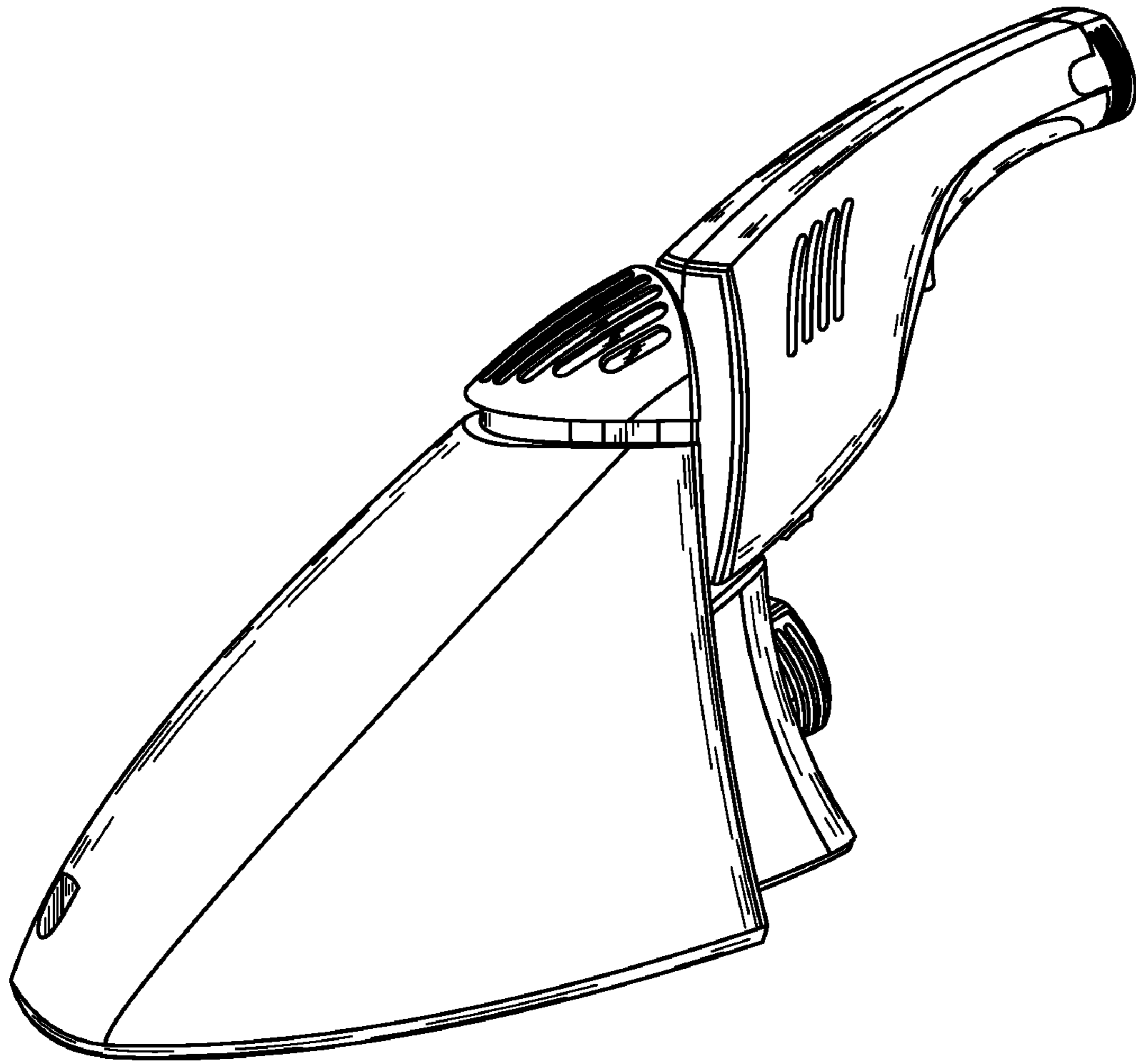

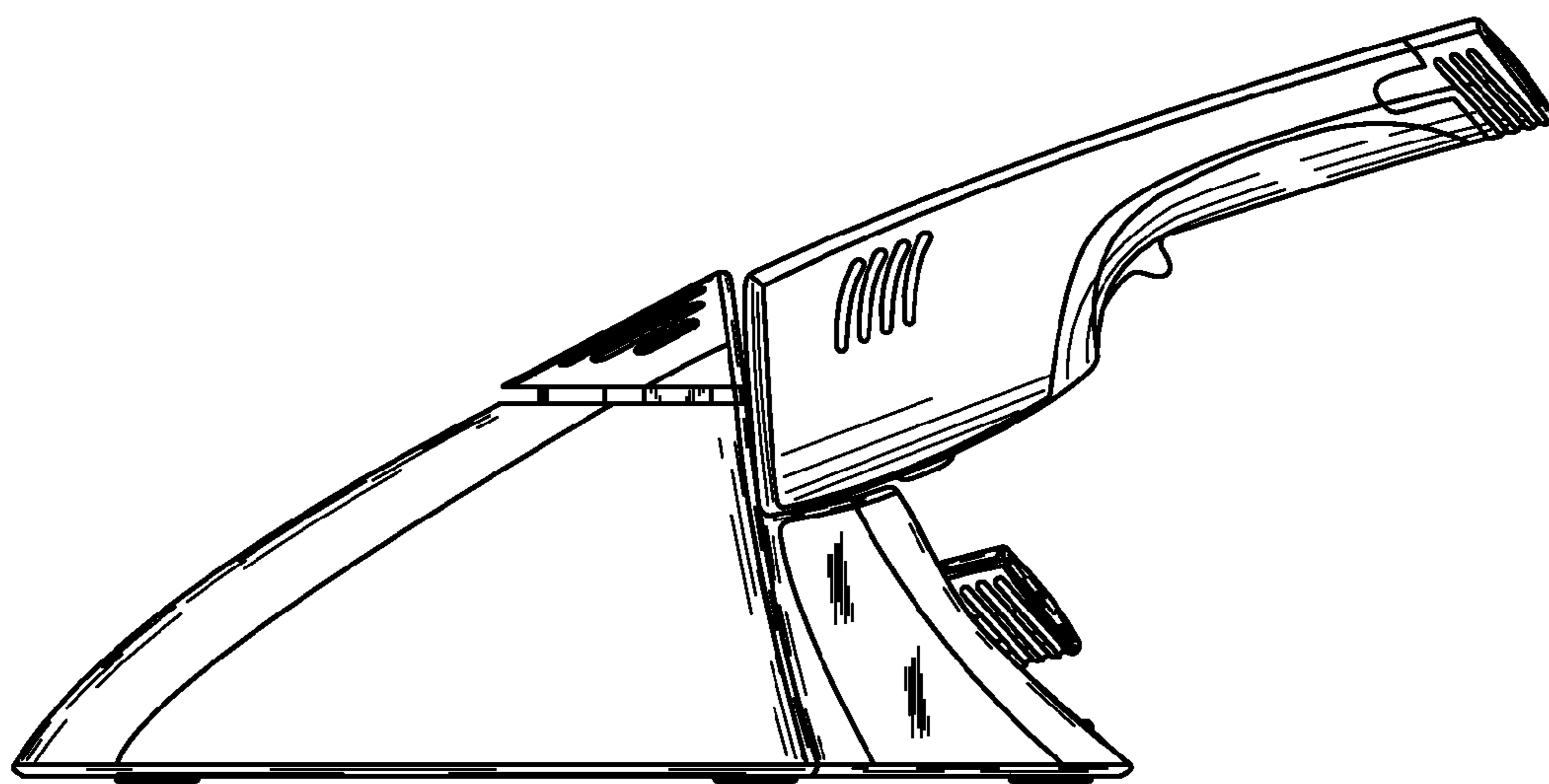

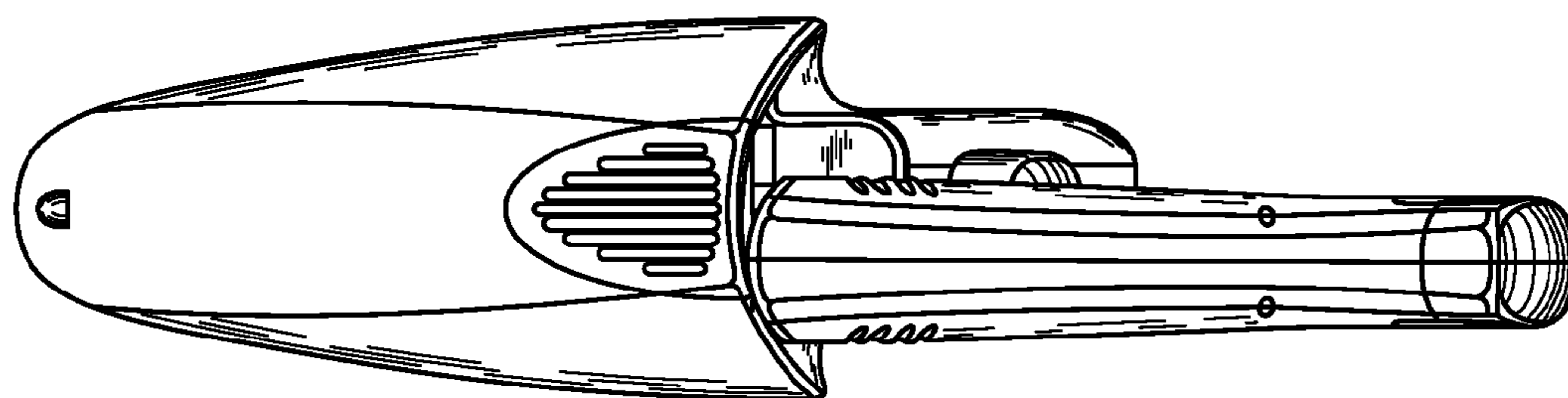

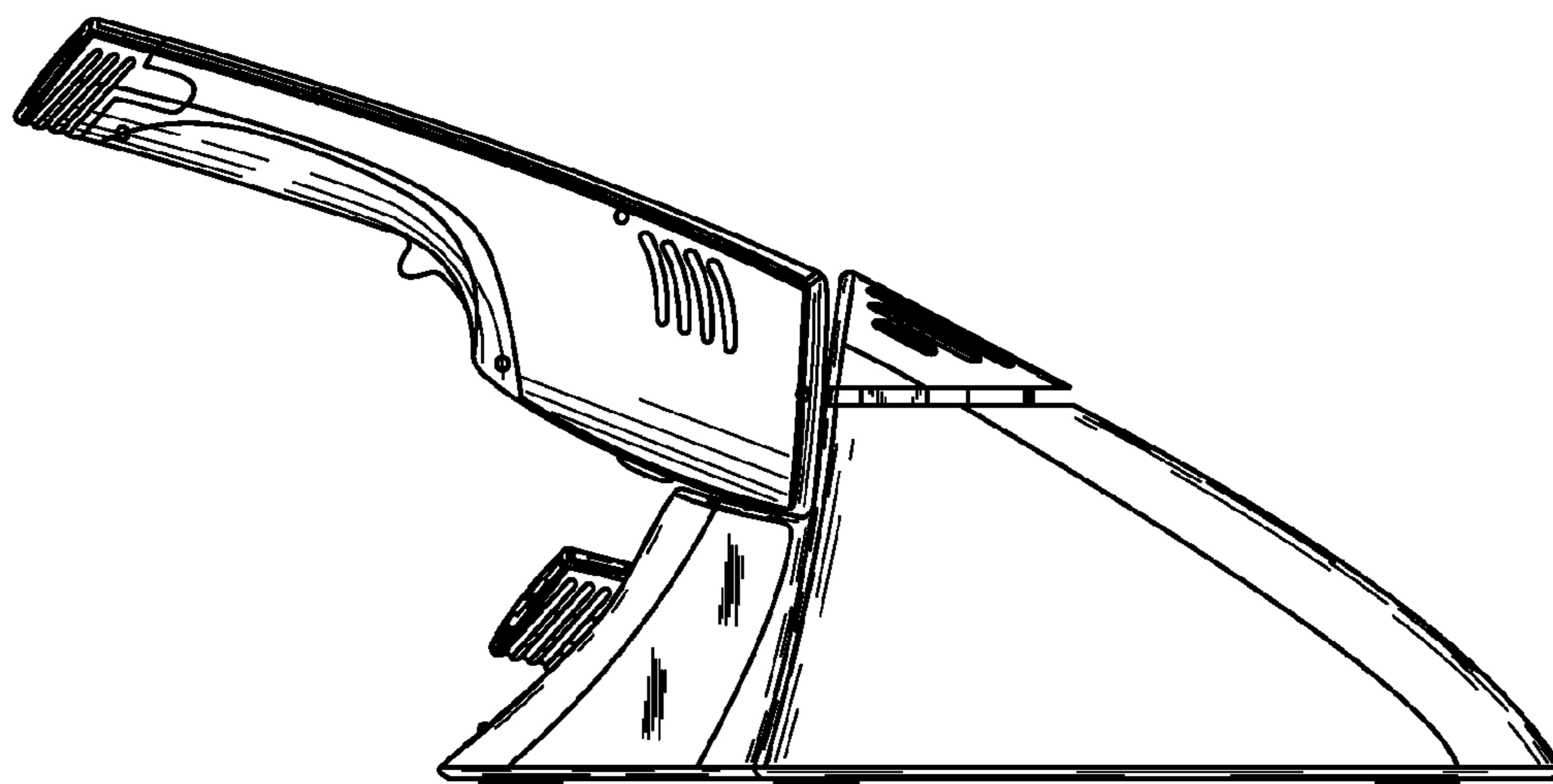

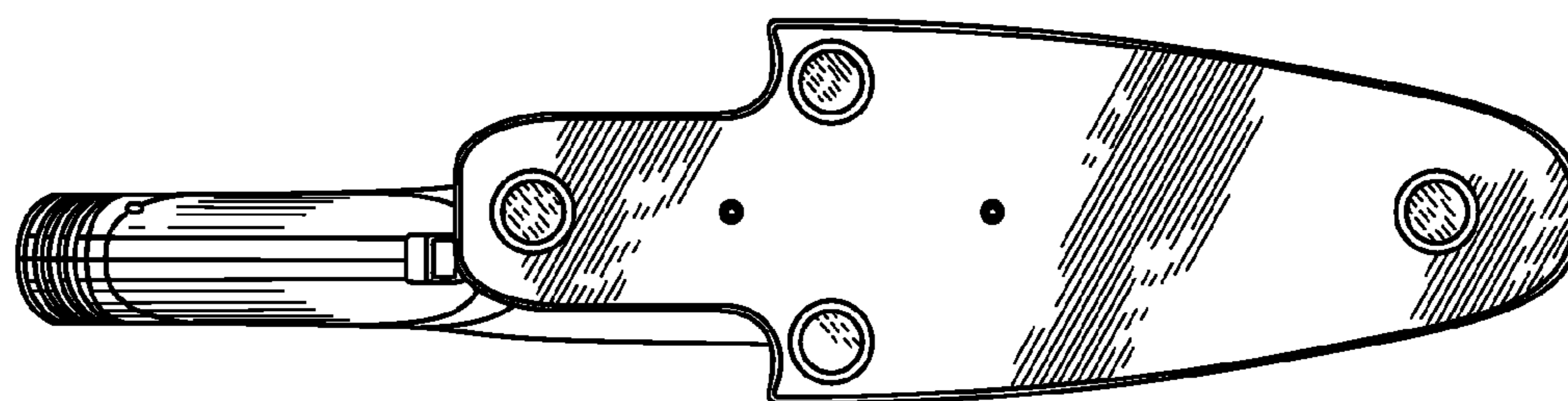

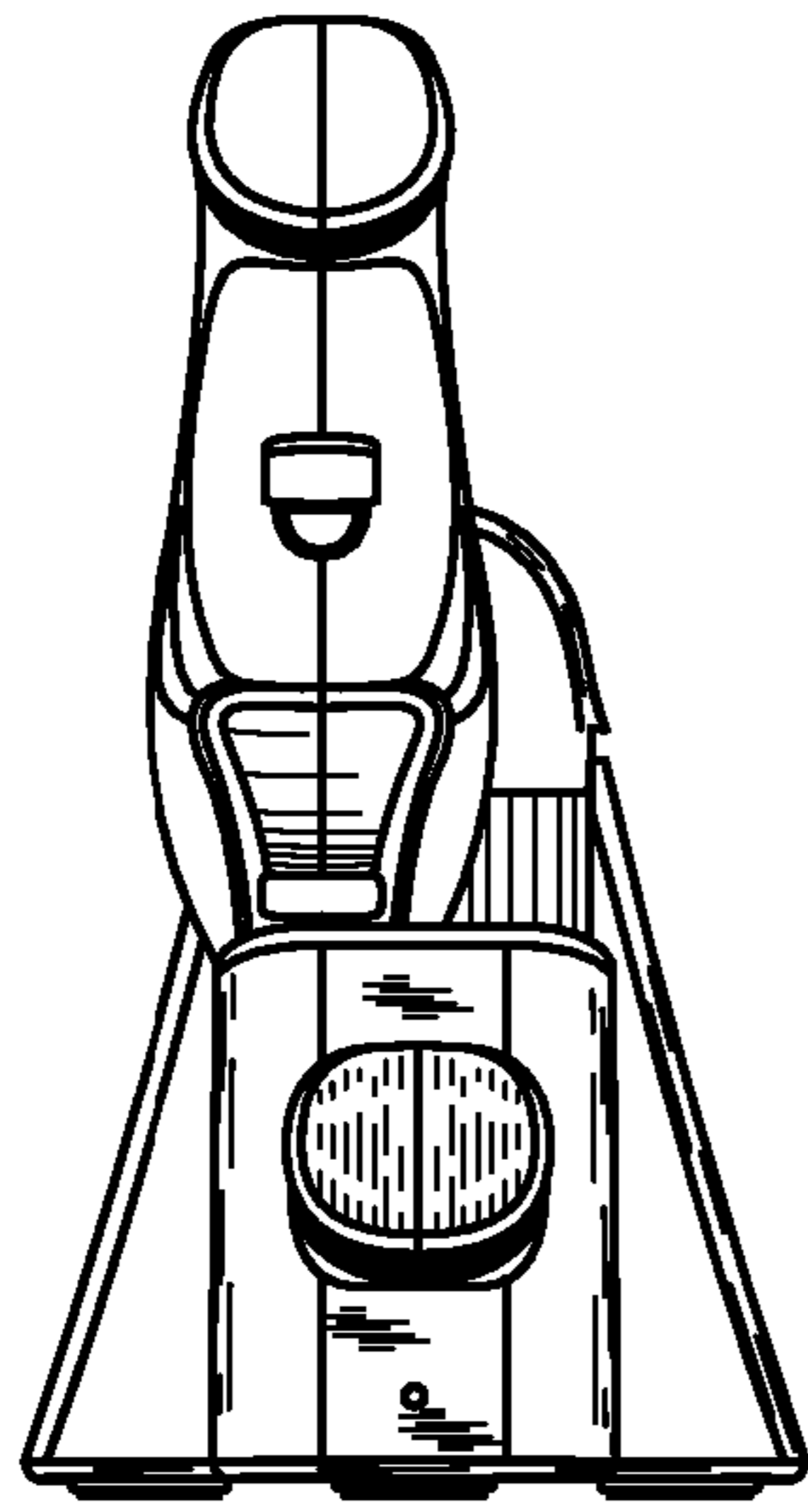

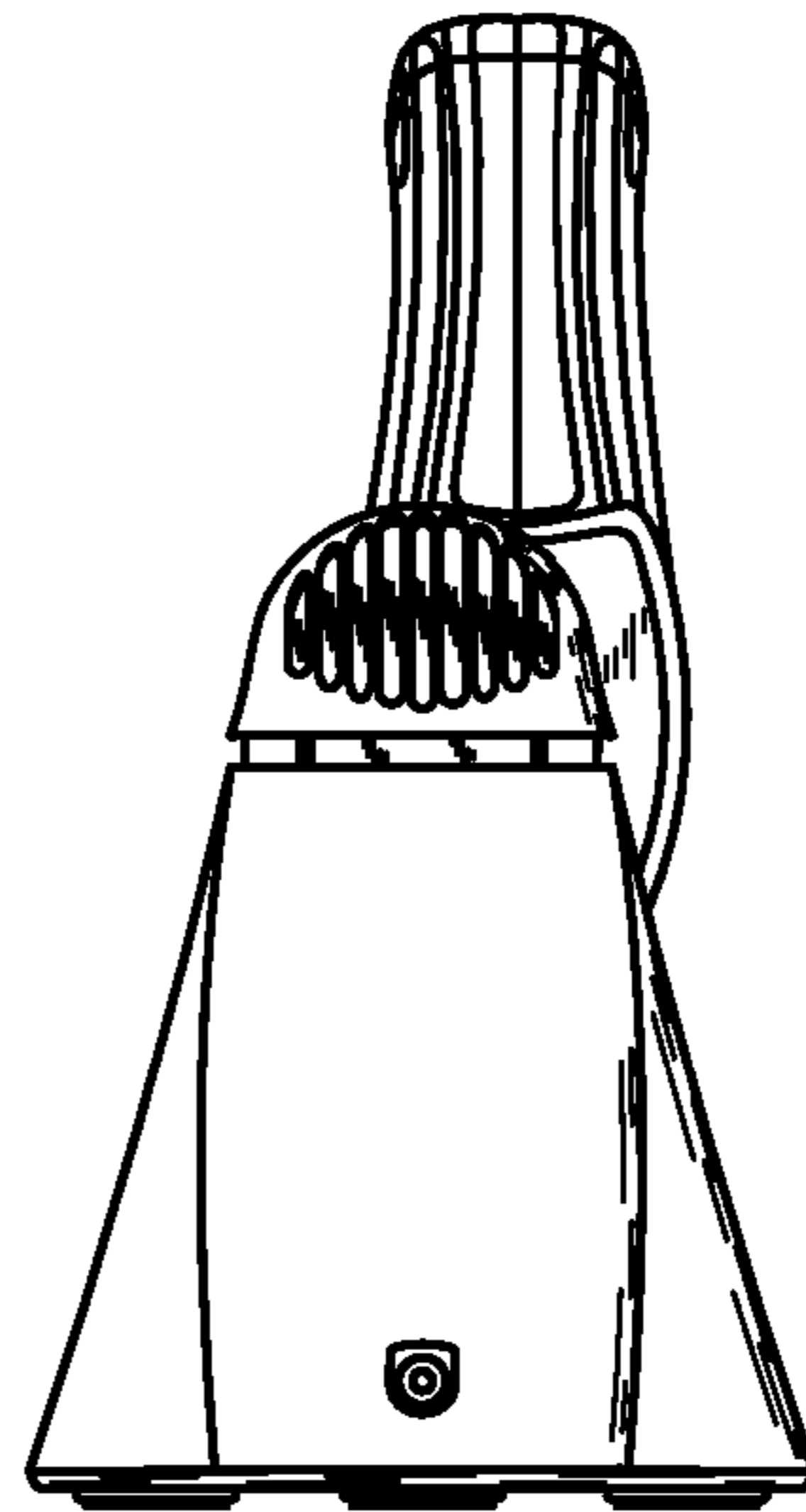

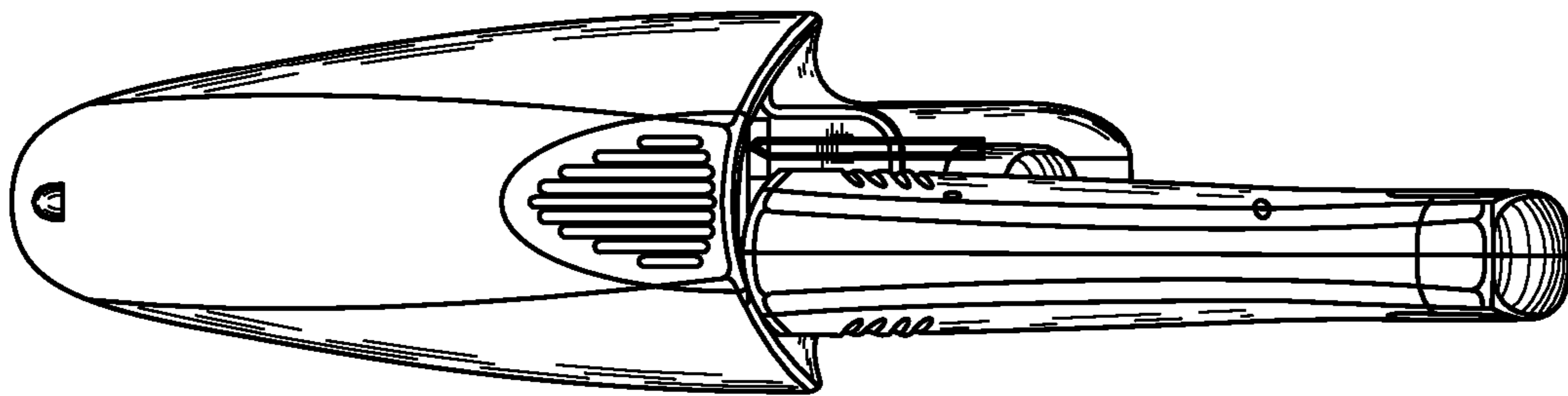
