DESCRIPTION

FIG. 1 is a three dimensional perspective view of a container showing my new design;

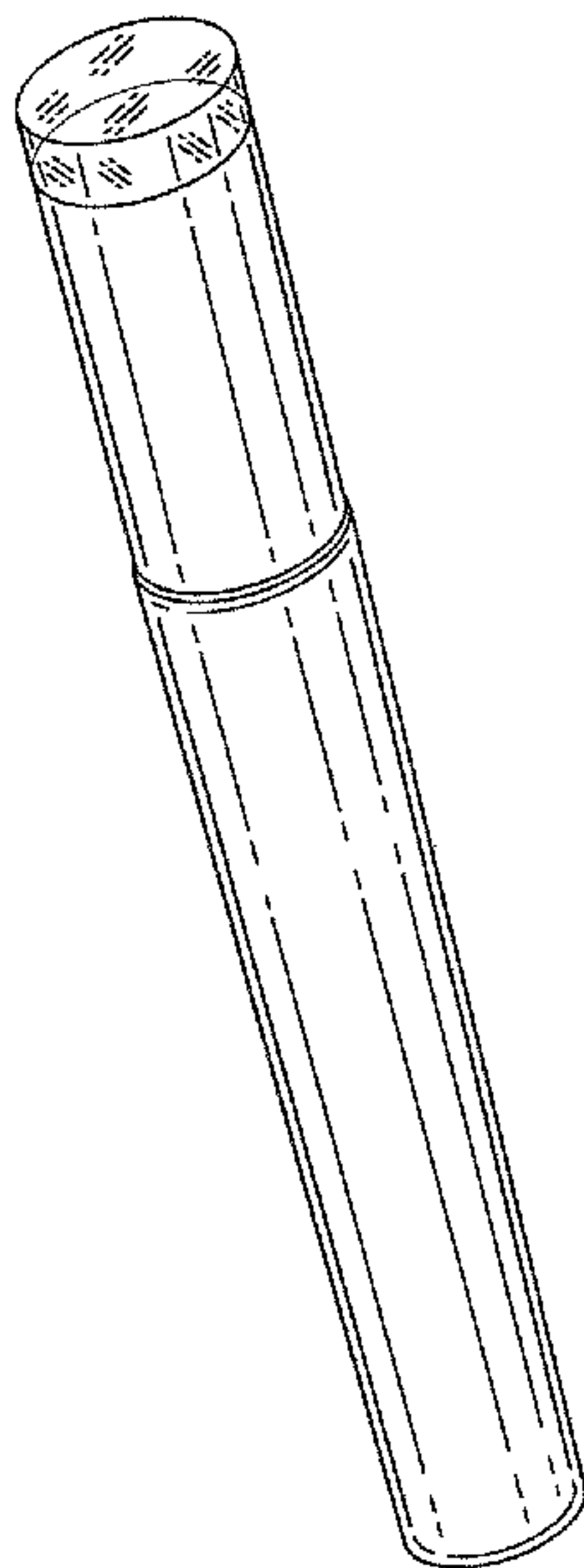
FIG. 2 is a front elevational view thereof;

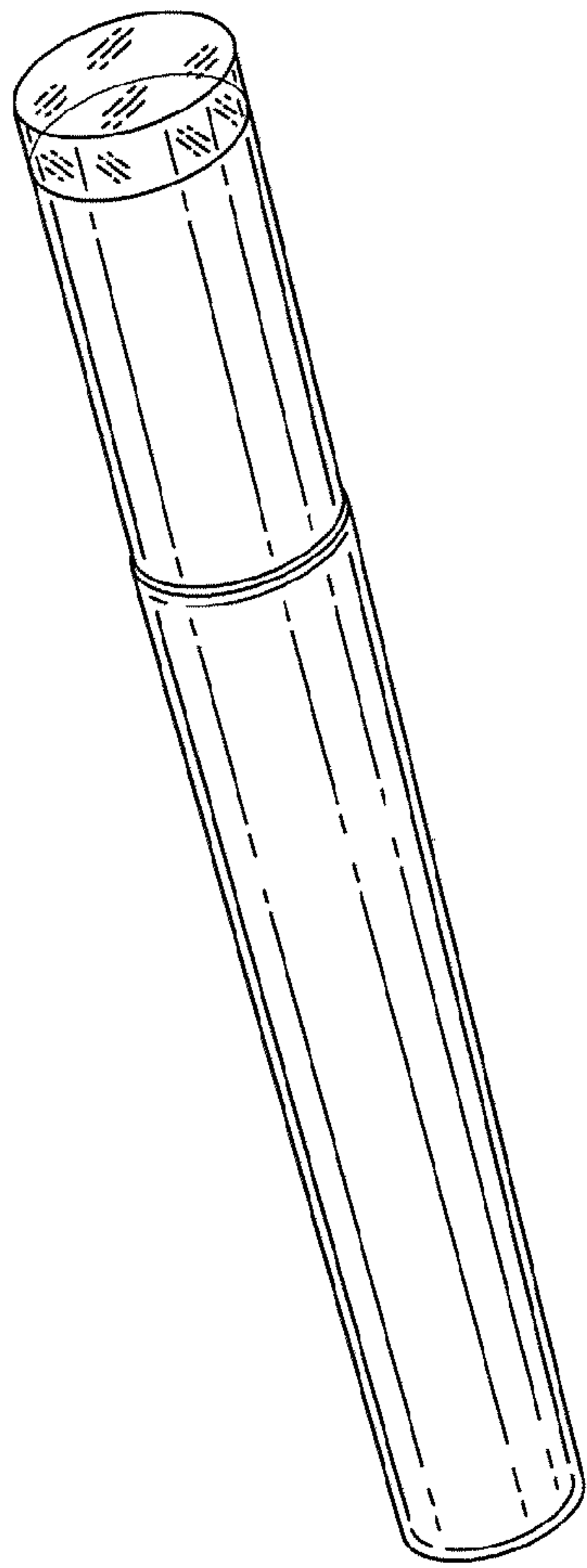

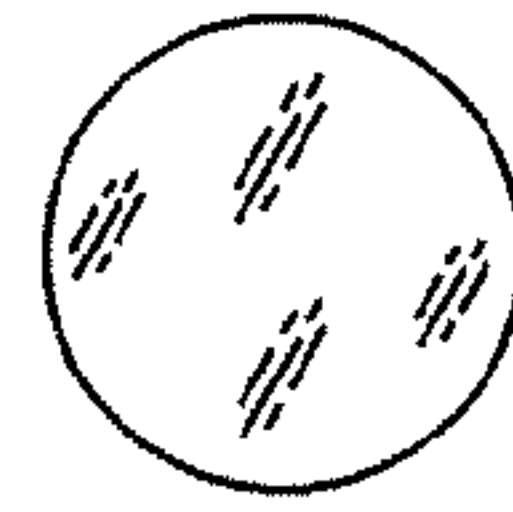

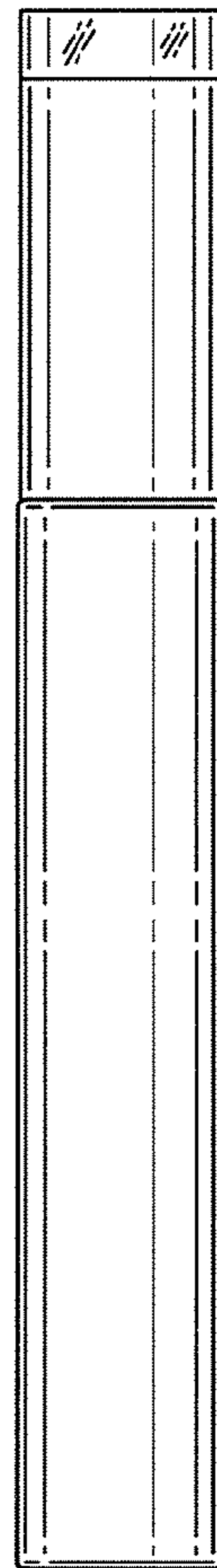

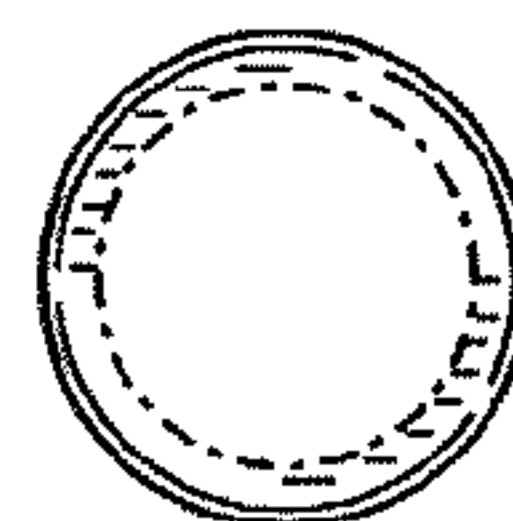
