(57) **CLAIM**

The ornamental design for a pet memory chime, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view for a pet memory chime showing my new design:

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view, the right side elevational view being the mirror image thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a front elevational view of a second embodiment of the pet memory chime; and,

FIG. 8 is a rear elevational view thereof.

In the drawings, the broken line showing of wording on the body of the design depicts environmental subject matter and forms no part of the claim.

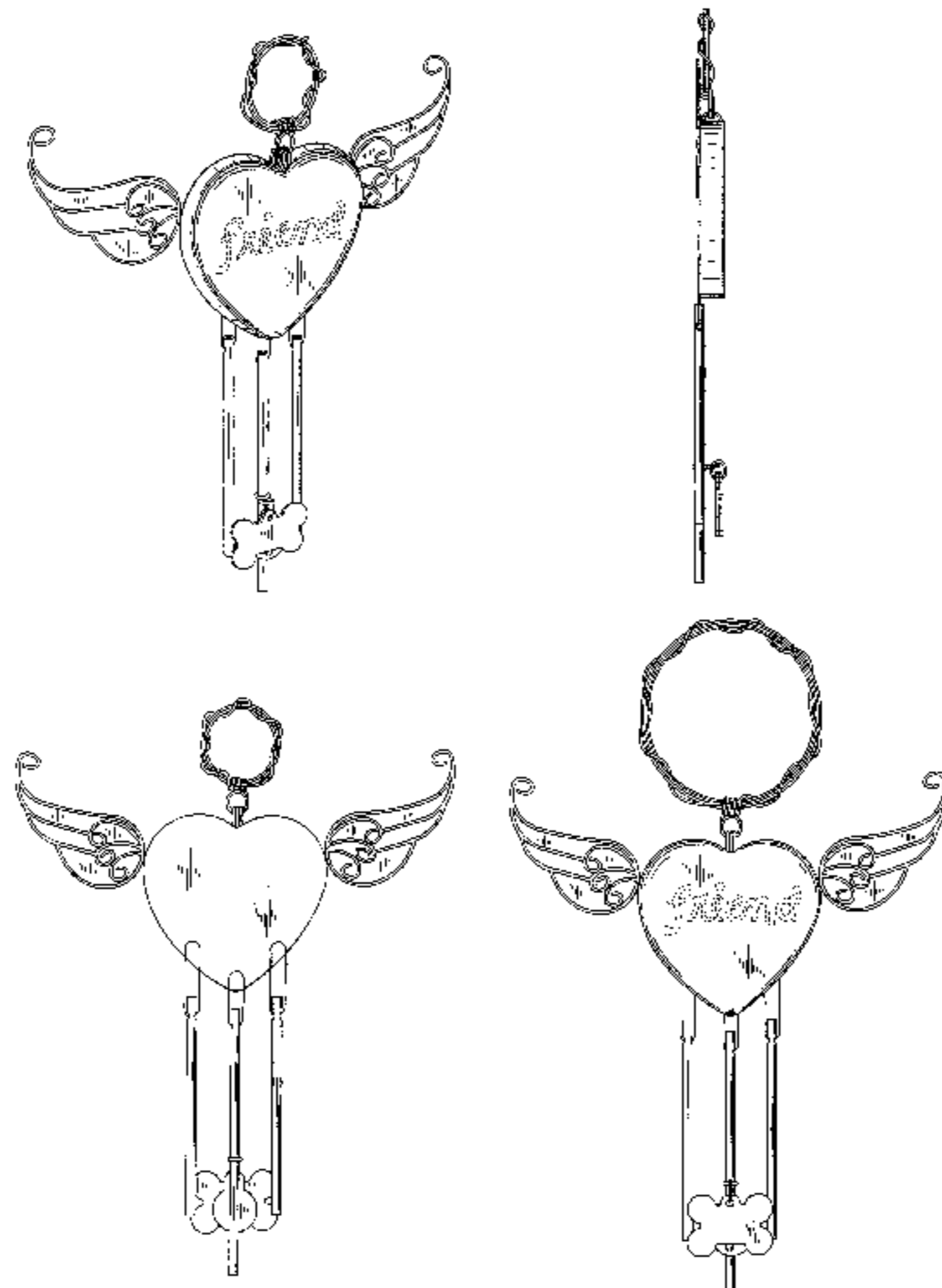

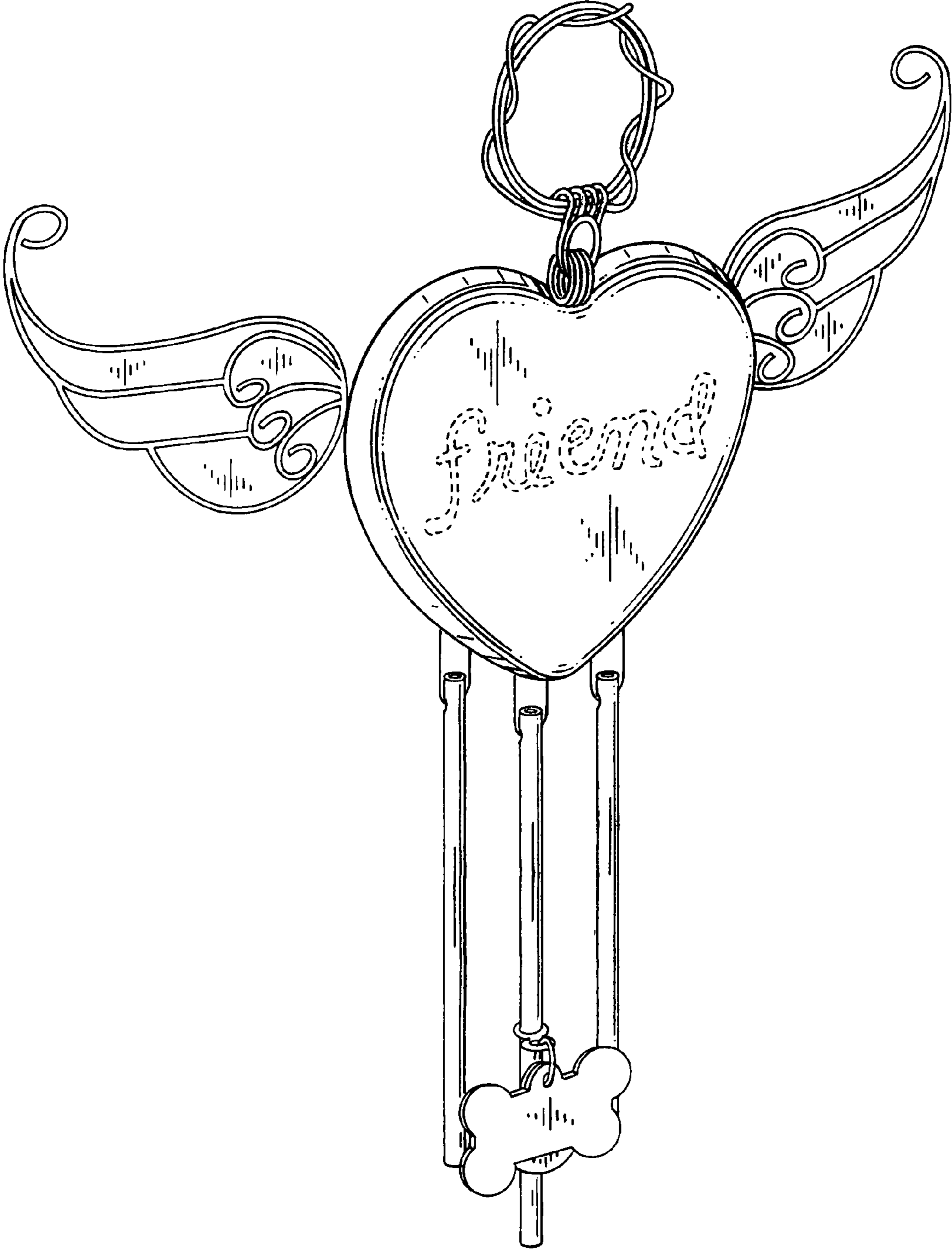

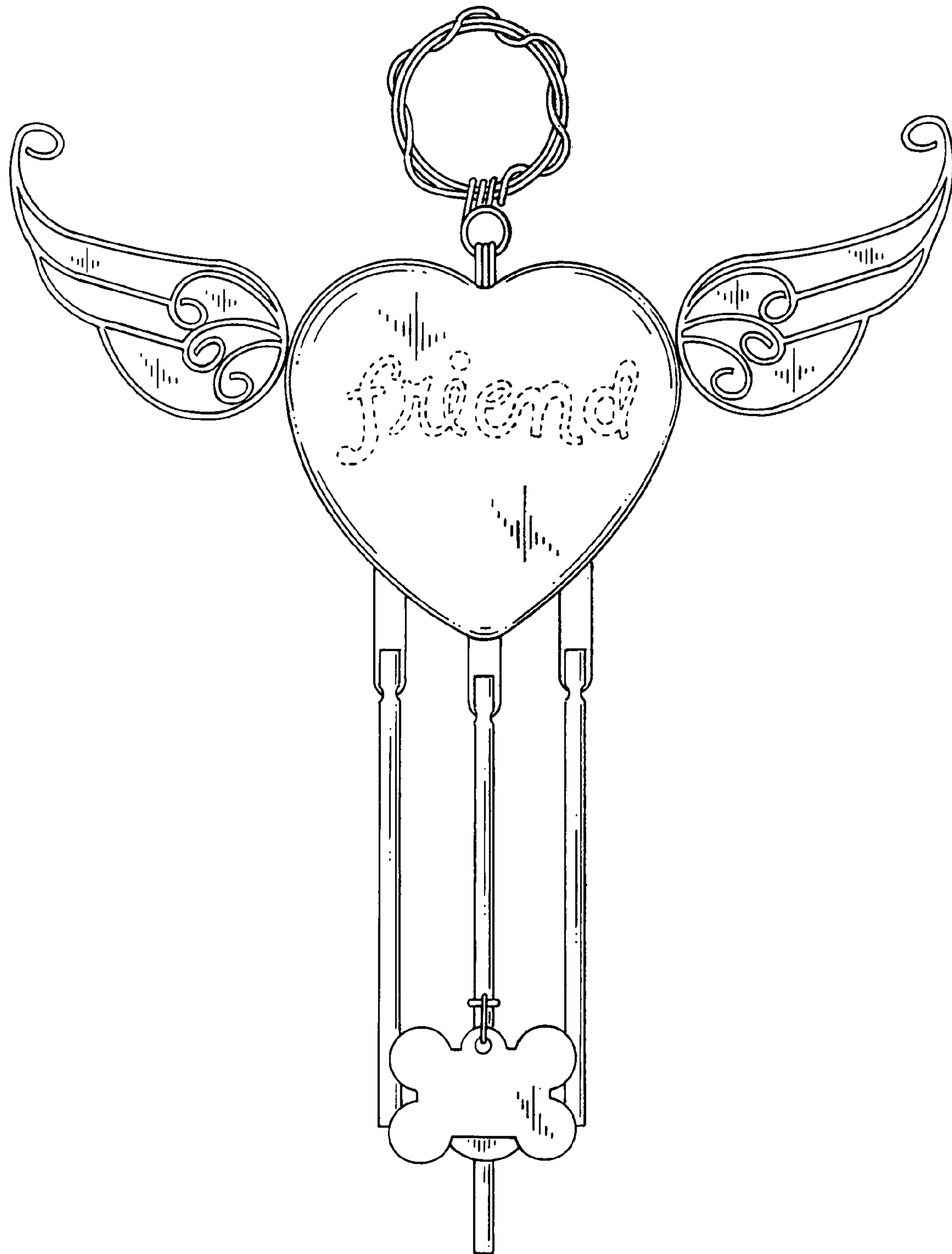

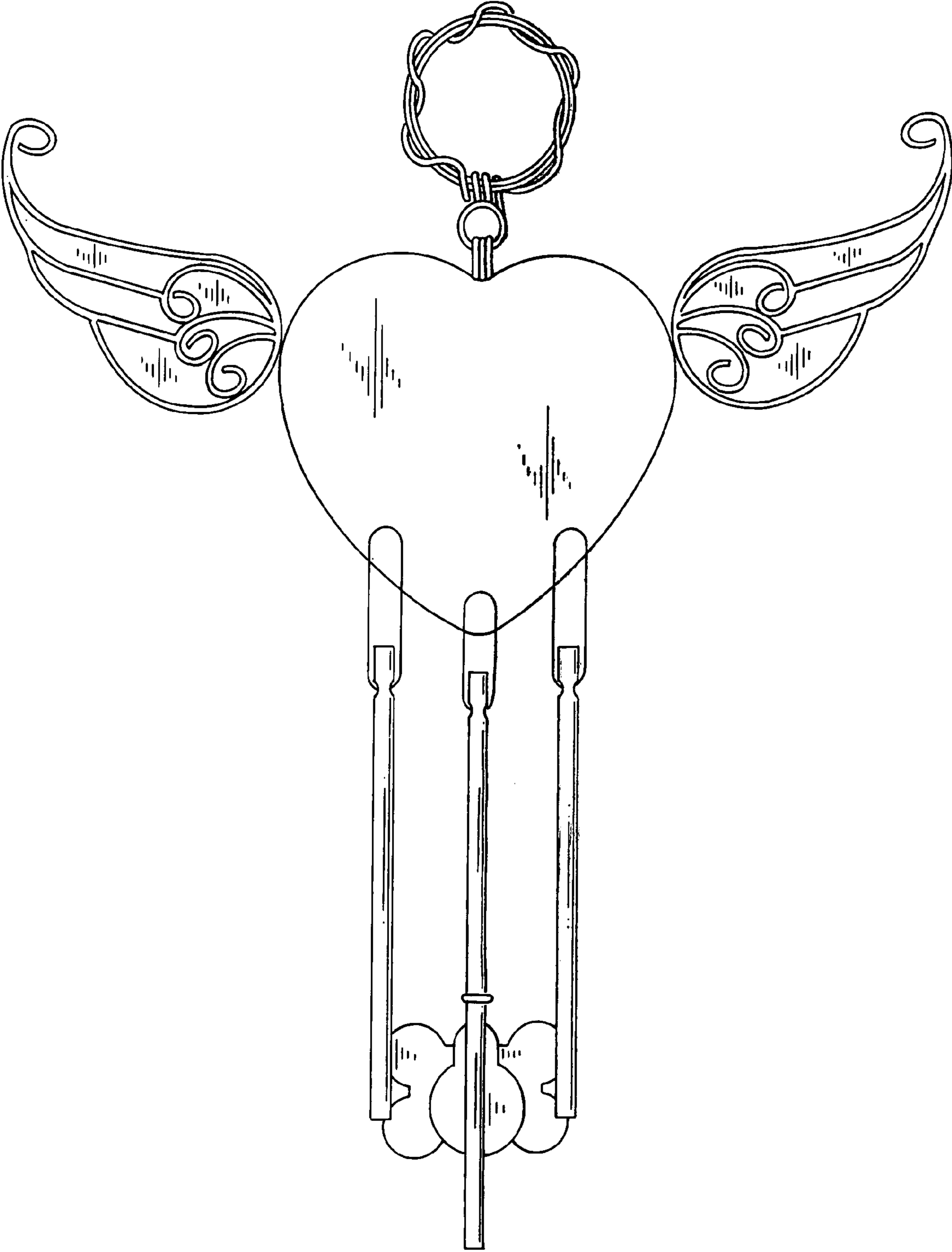

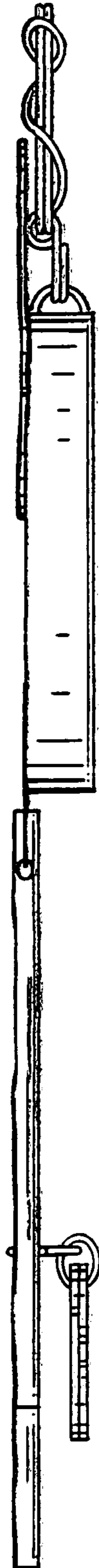

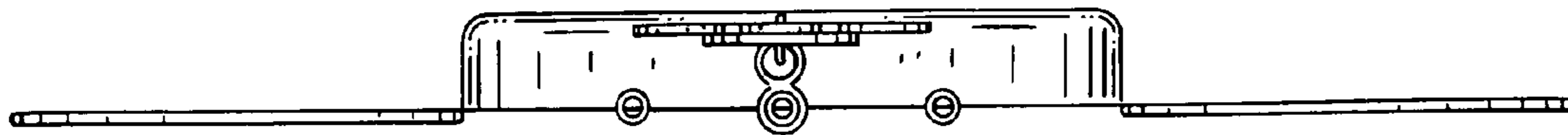

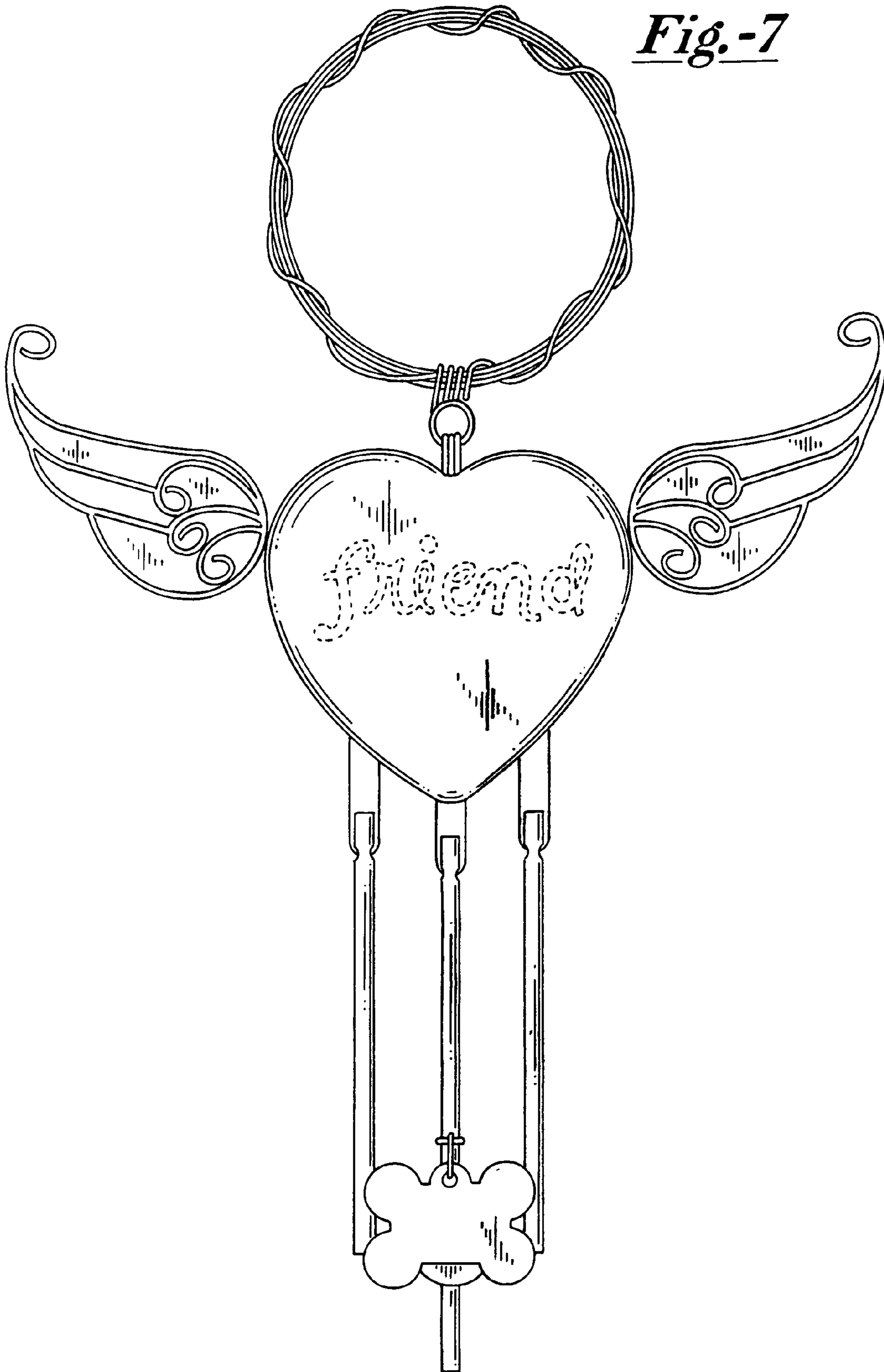
