DESCRIPTION

FIG. 1 is a front elevational view a charm showing my new design;

FIG. 2 is a left side elevational view of FIG.1, the right side view being the same;

FIG. 3 is a top plan view of FIG. 1;

FIG. 4 is a bottom plan view of FIG. 1;

FIG. 5 is a front elevational view of a charm showing a second embodiment of my new design;

FIG. 6 is a left side elevational view of FIG. 5, the right side view being the same;

FIG. 8 is a bottom plan view of FIG. 5;

FIG. 9 is a front elevational view of a charm showing a third embodiment of my new design;

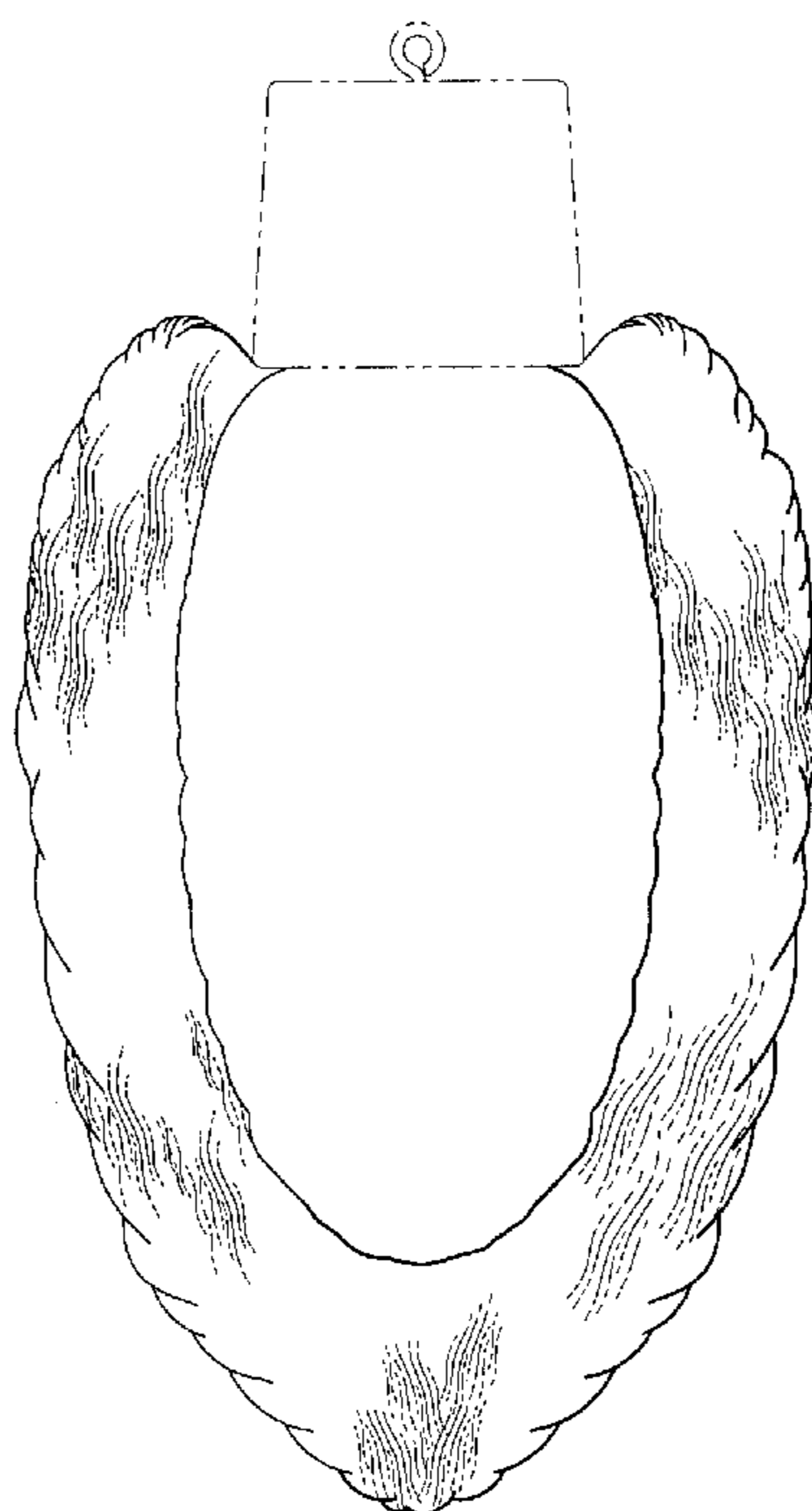
FIG. 10 is a left side elevational view of FIG. 9, the right side view being the same;

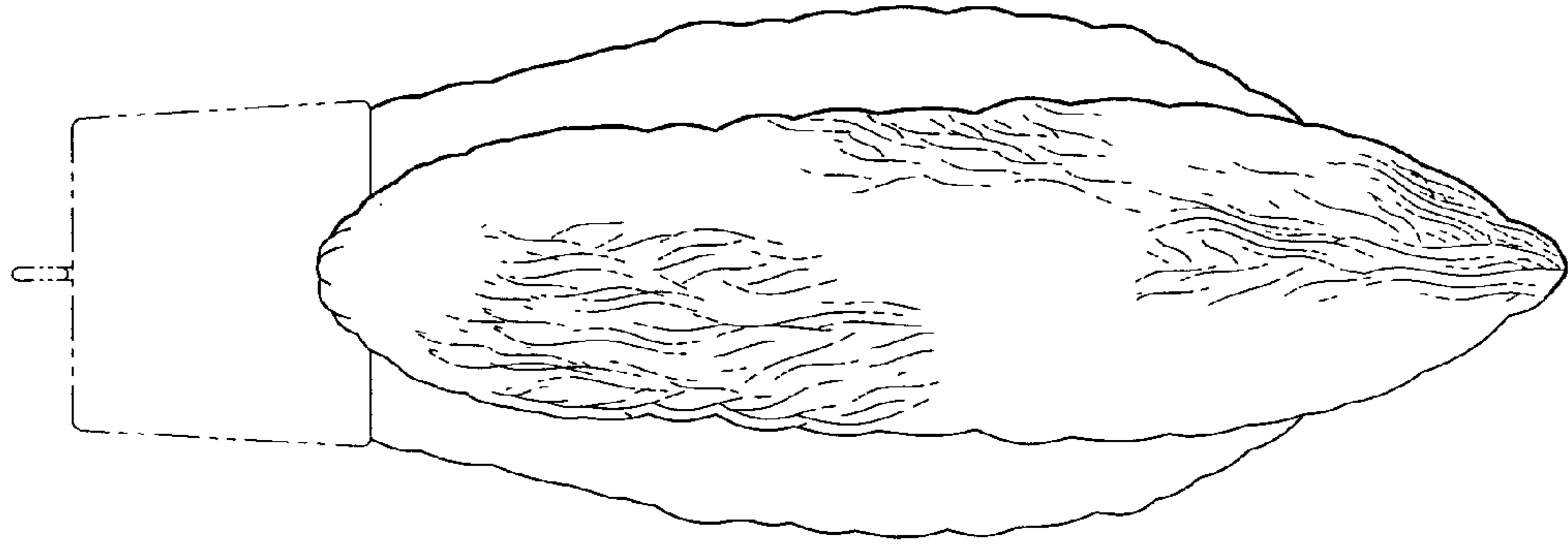

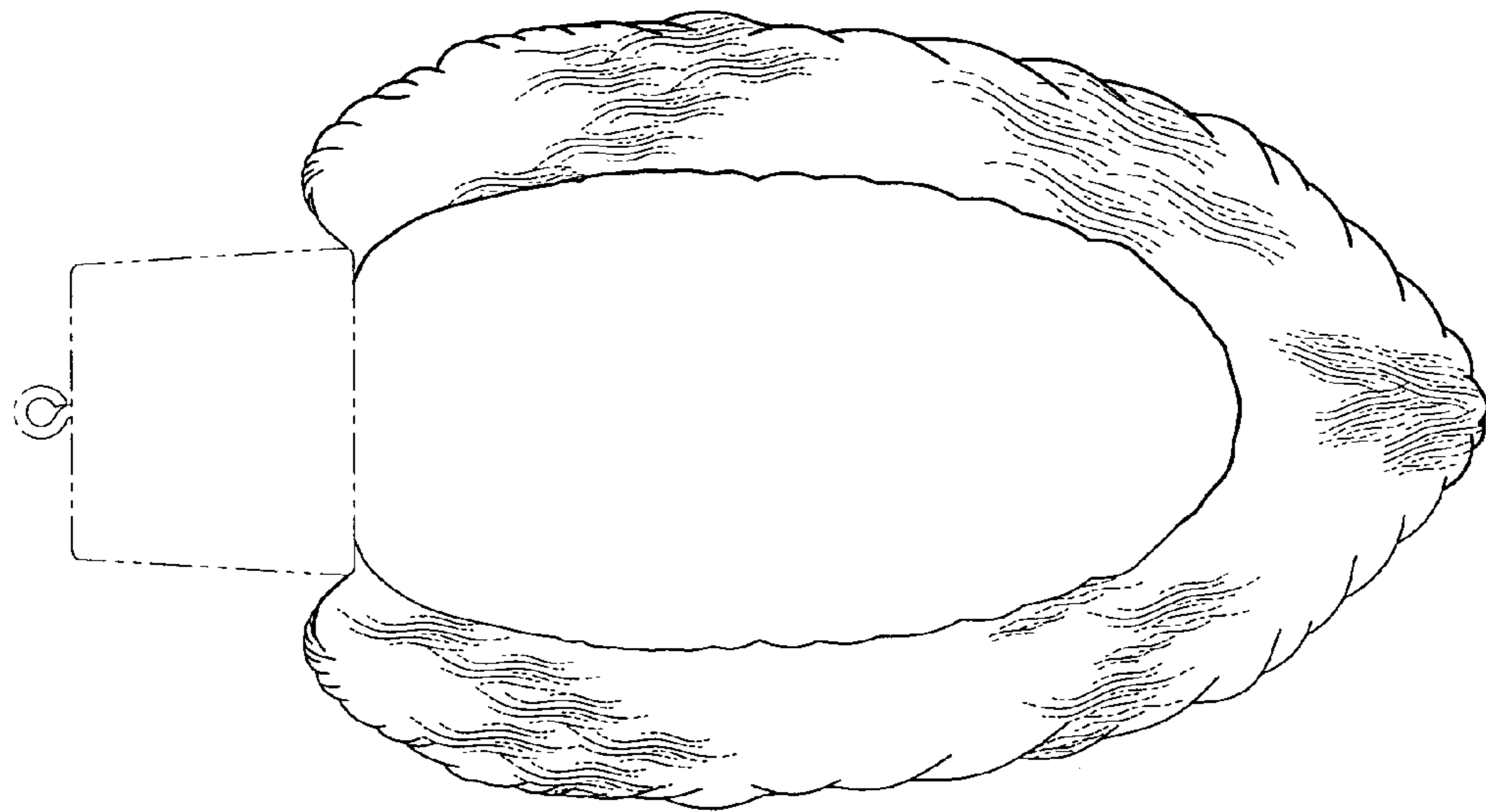

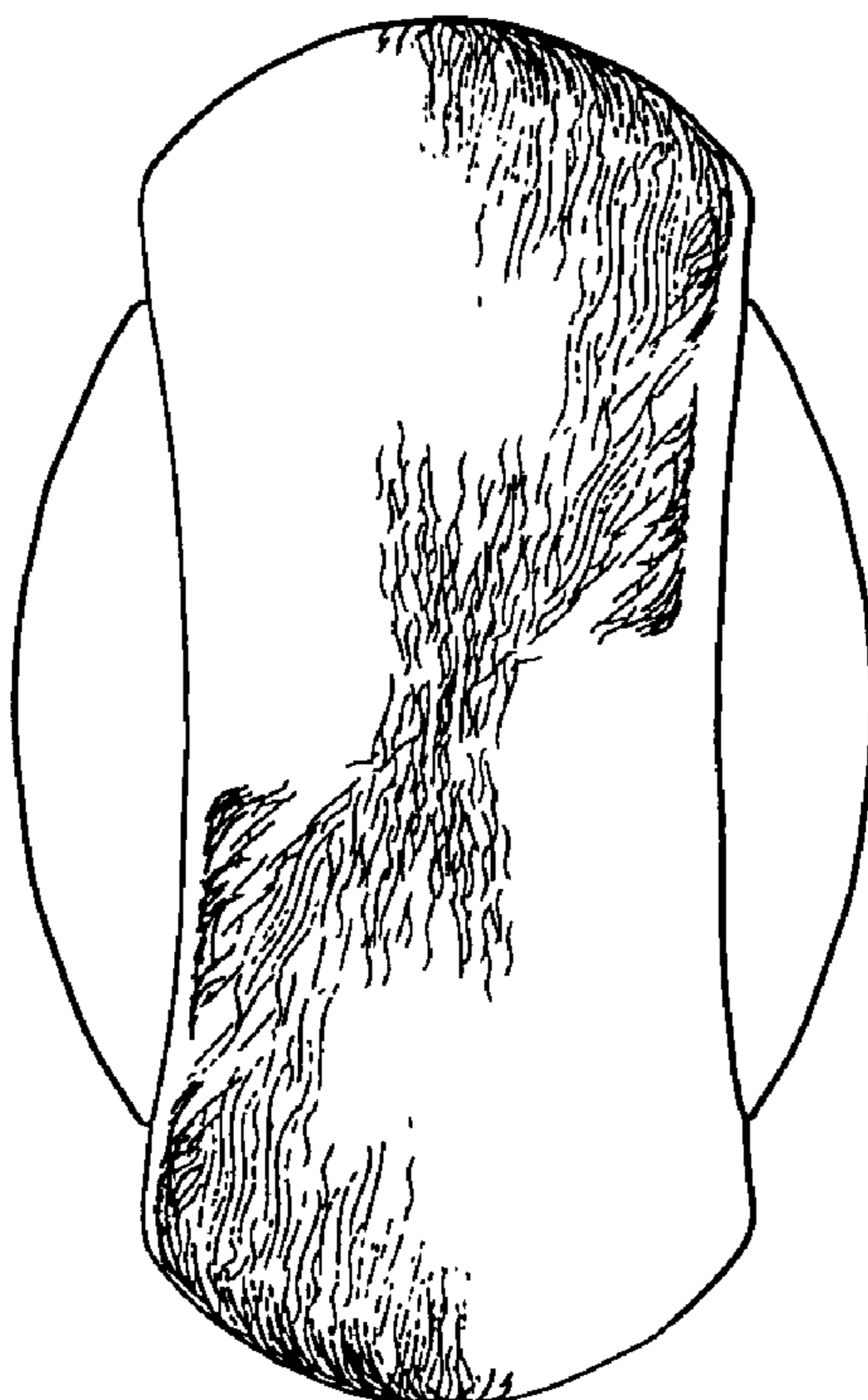
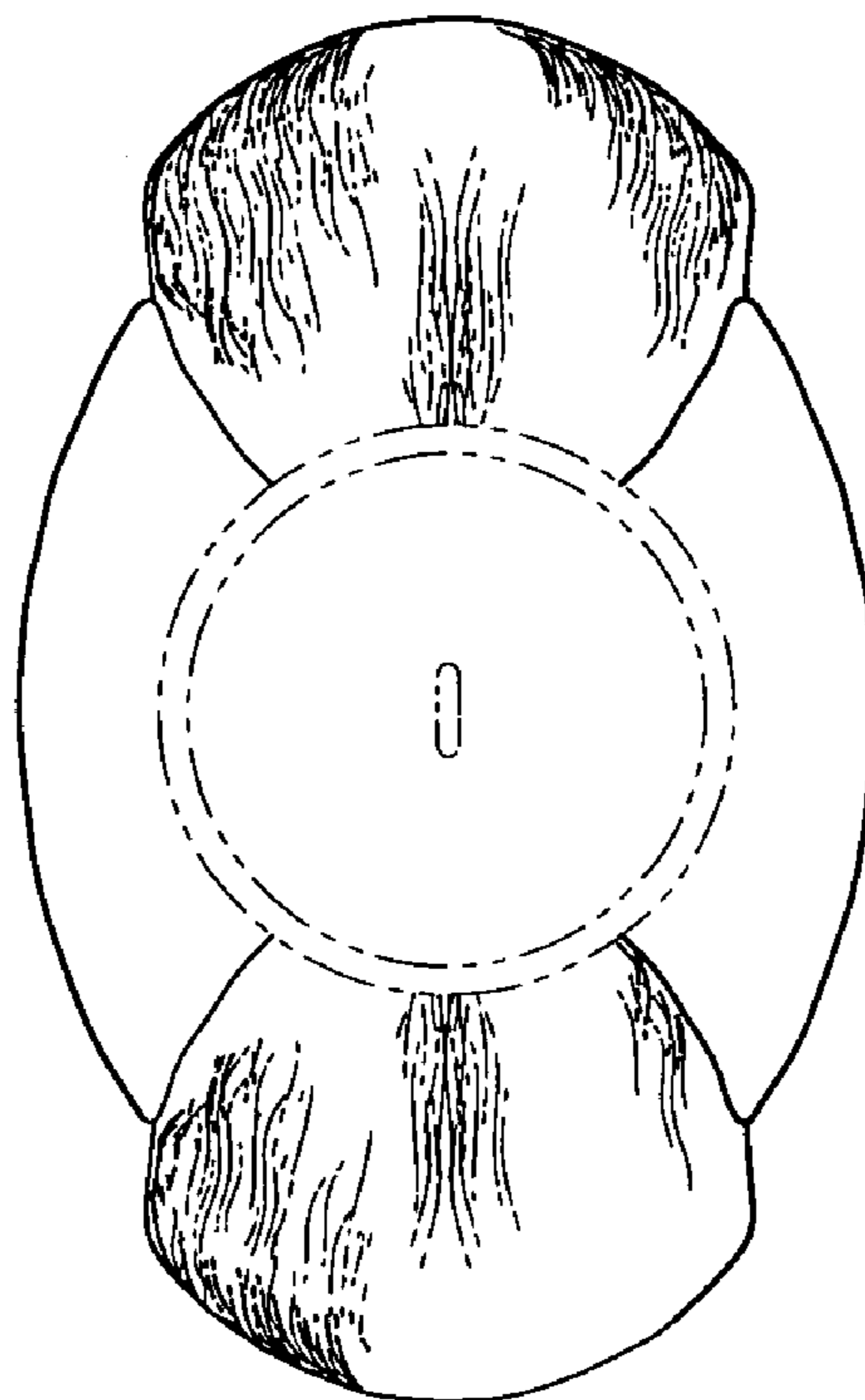

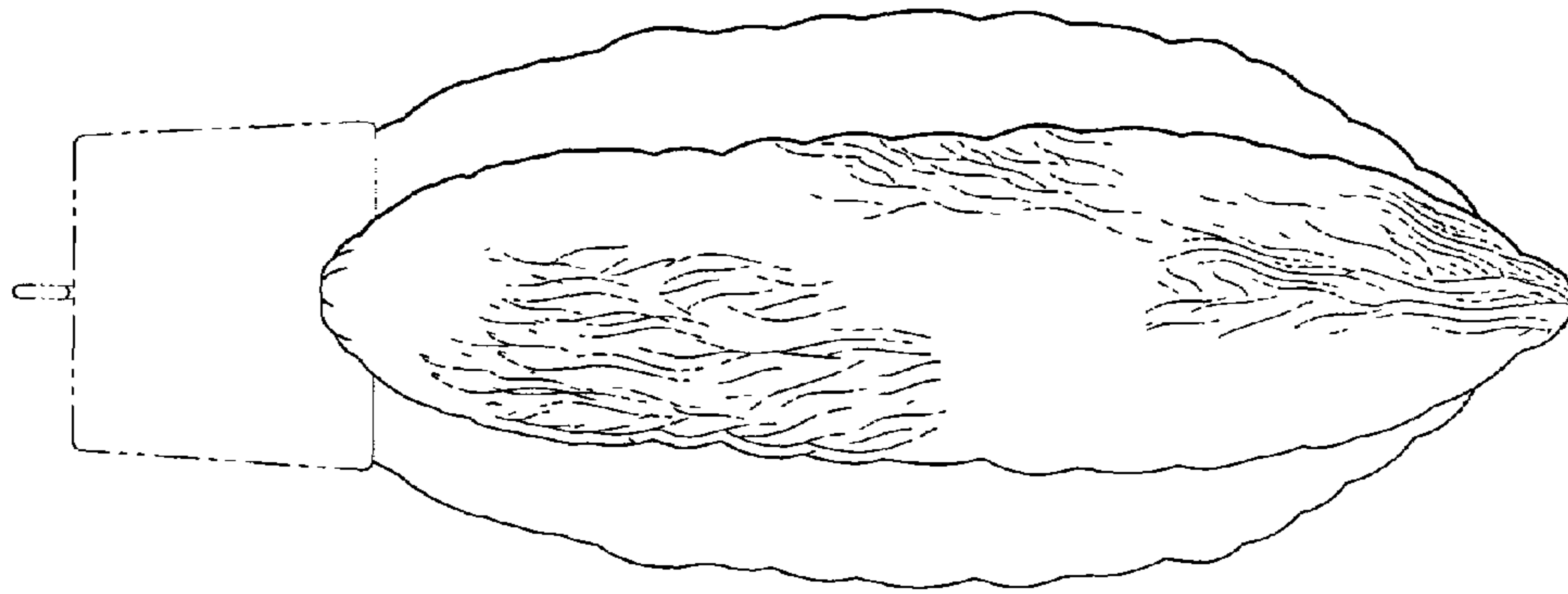

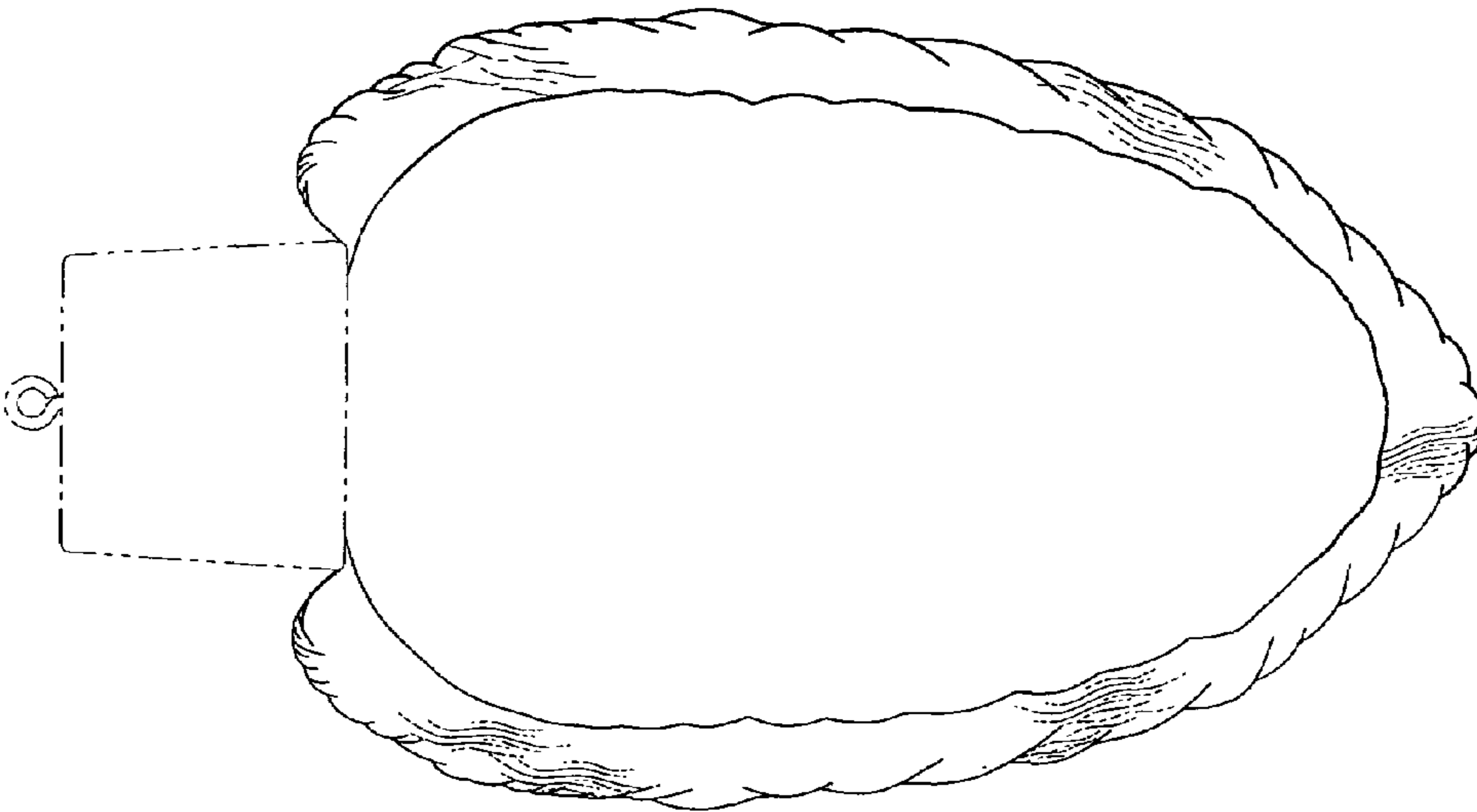

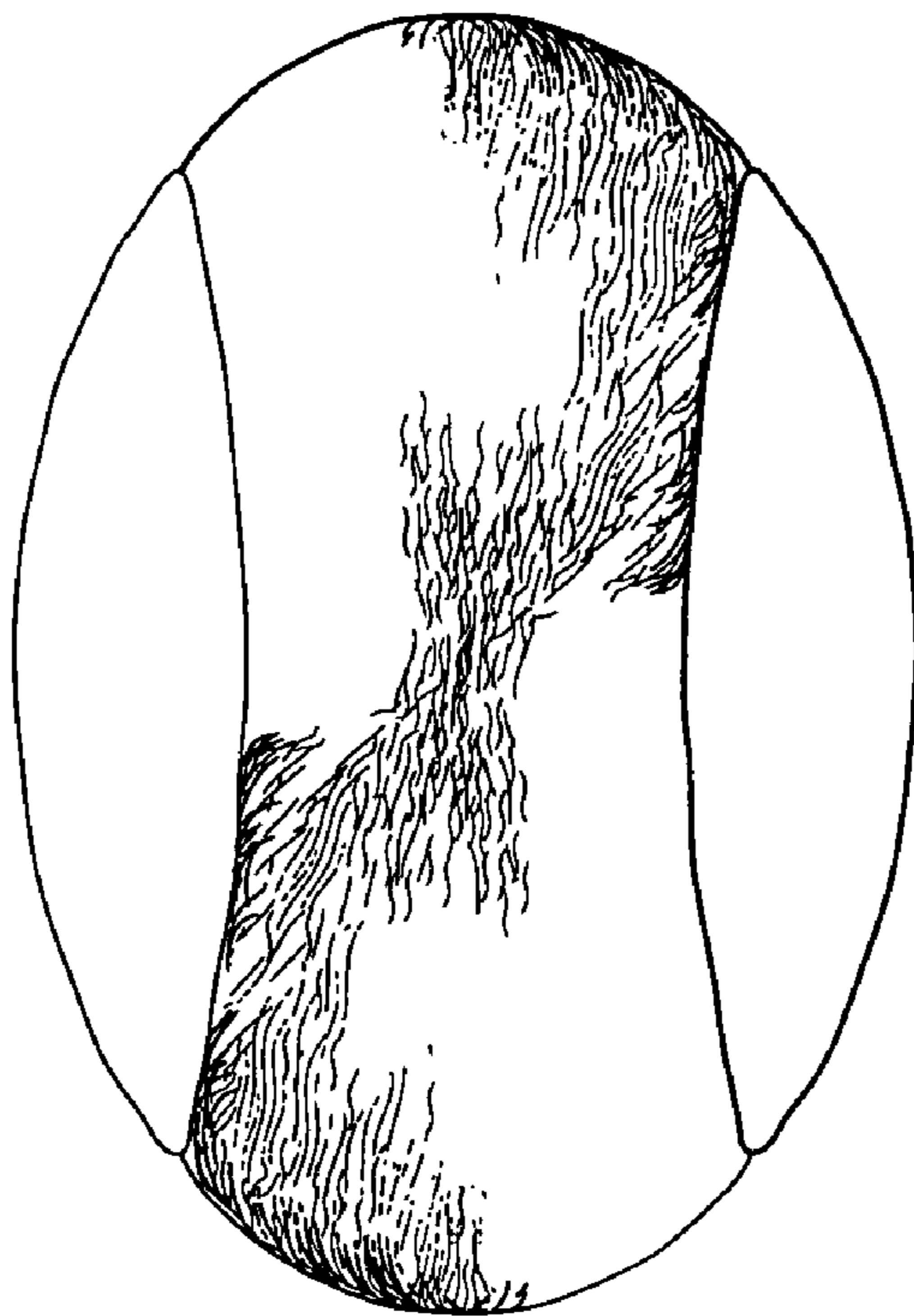
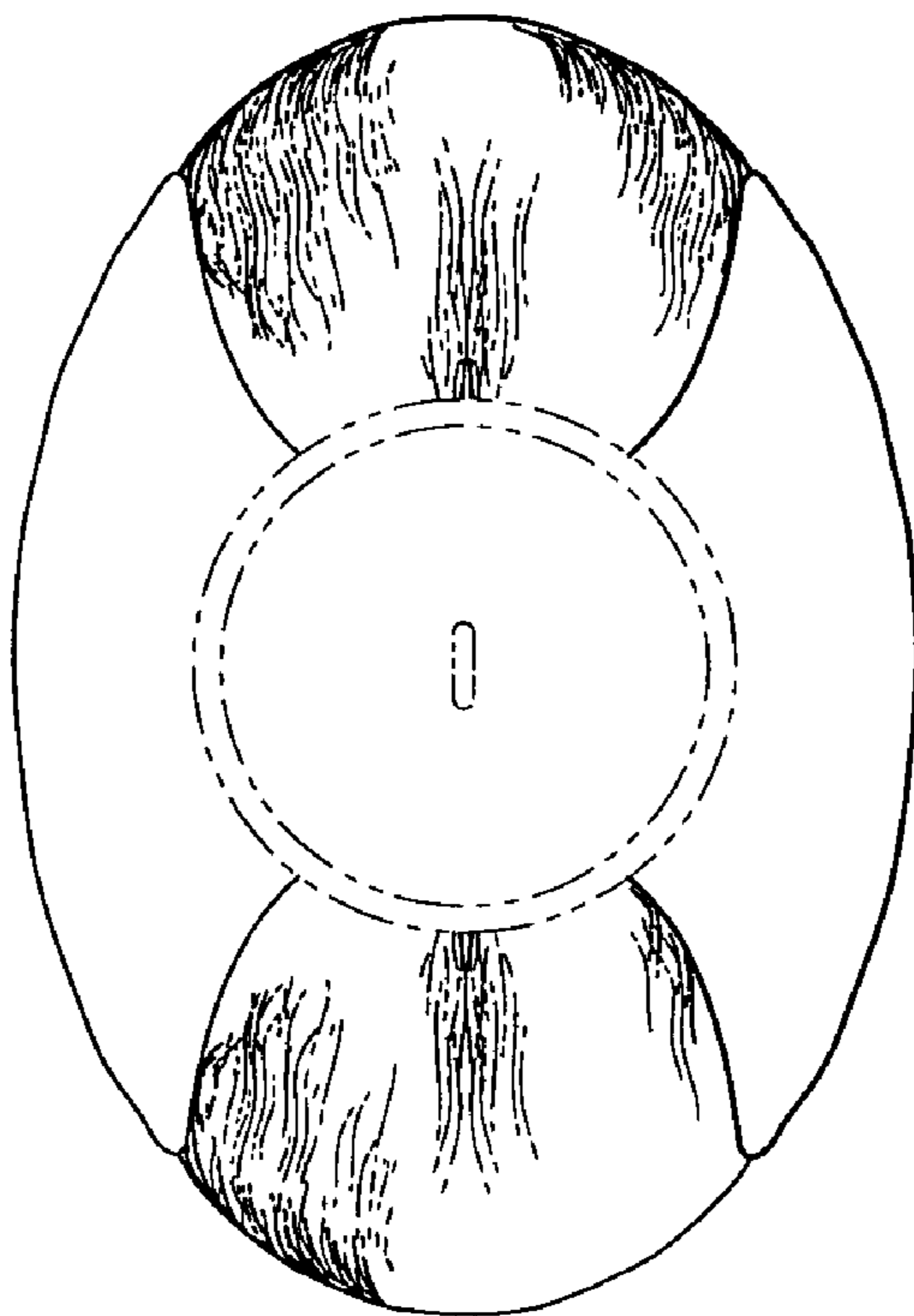

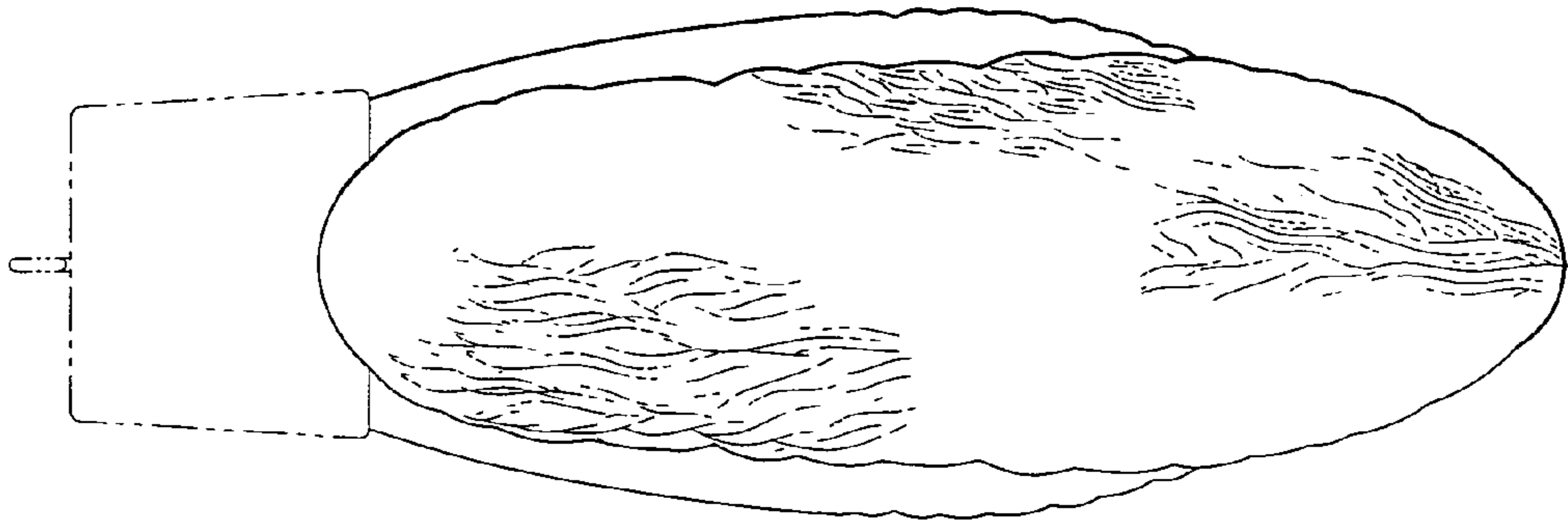

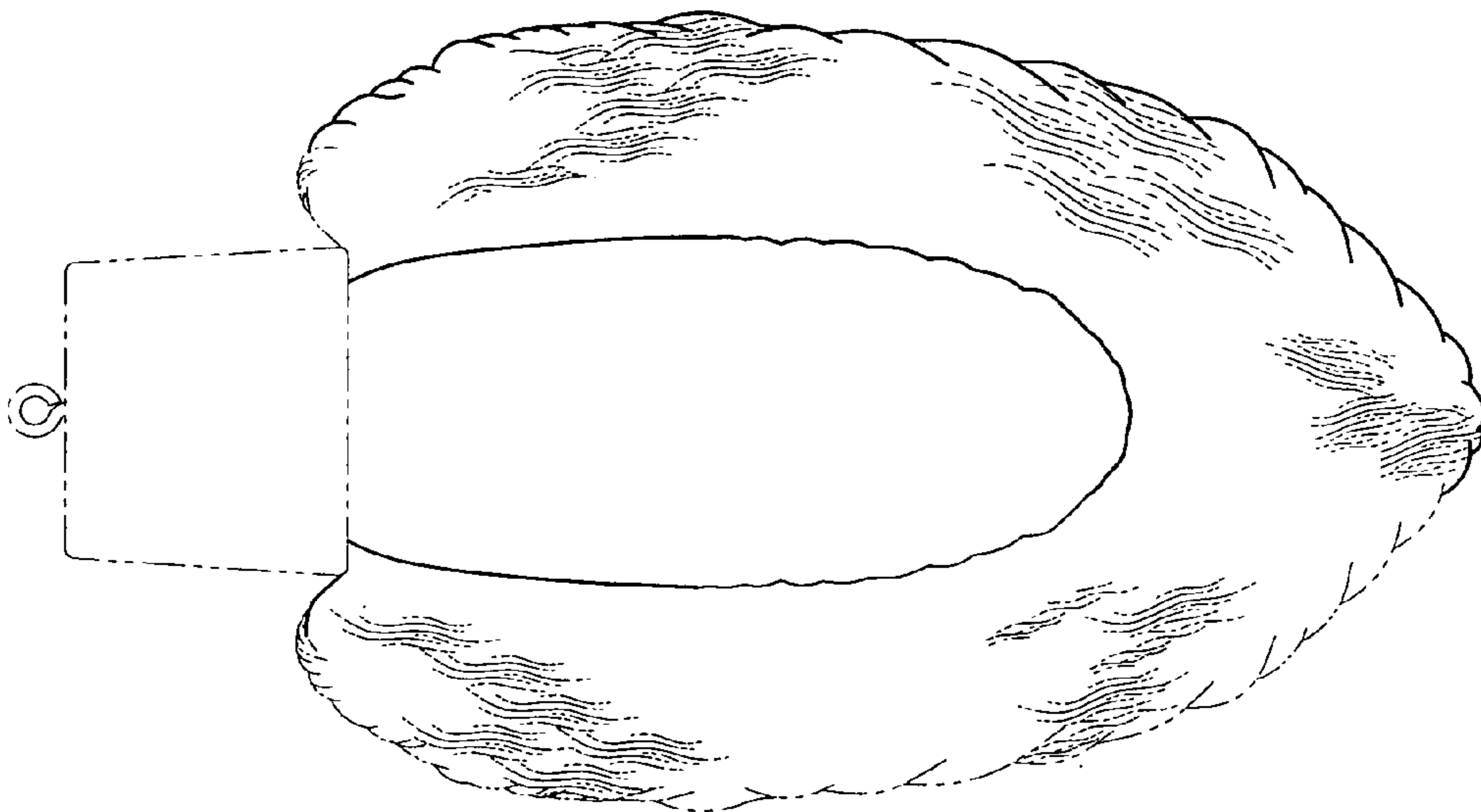

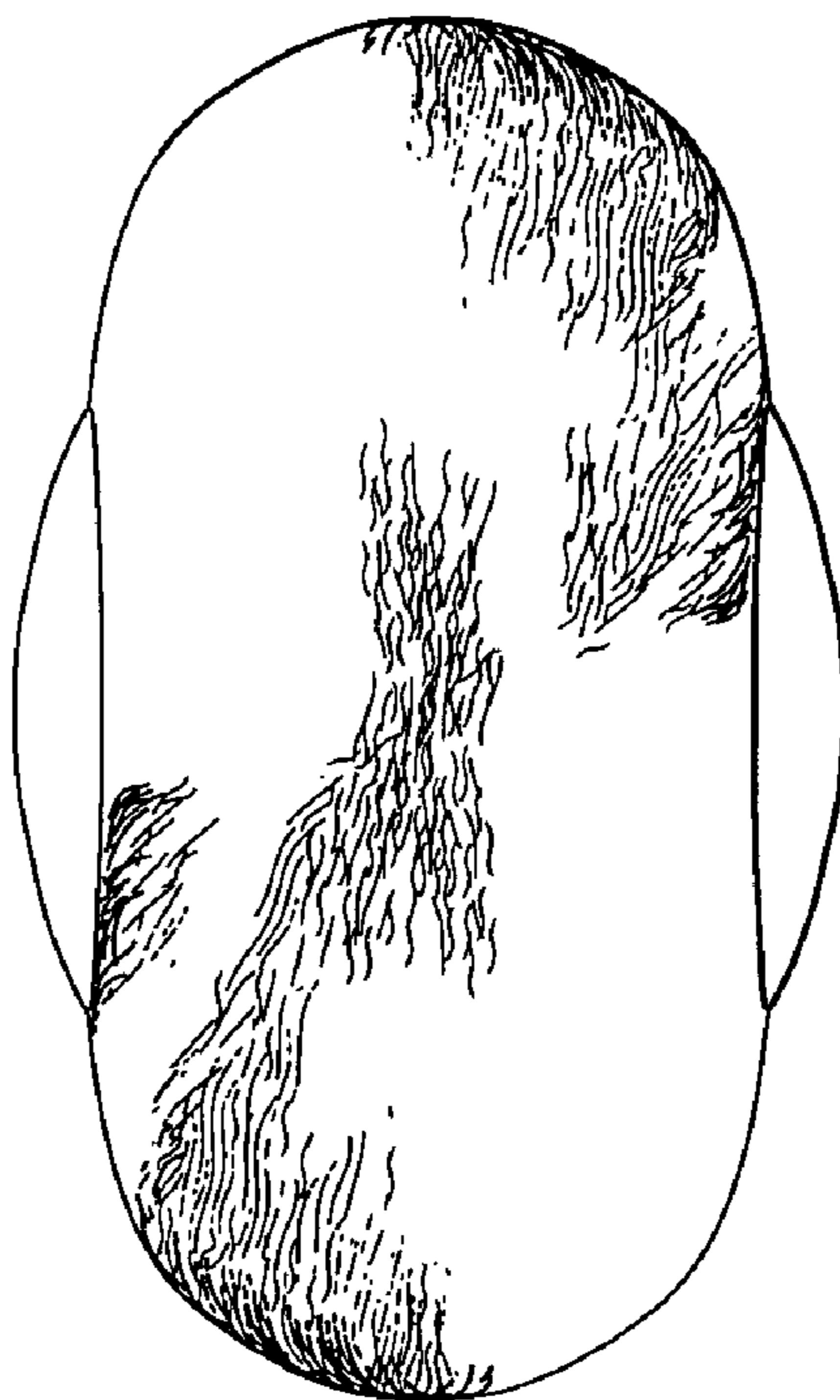
