(57) **CLAIM**

The ornamental design for a tire, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the tire of the design, it being understood that the pattern of the tread repeats uniformly throughout the circumference of the tread;

FIG. 2 is a front side view front thereof, the rear, top and bottom sides being identical thereto; and,

FIG. 3 is a right side view thereof, the left side being identical thereto.

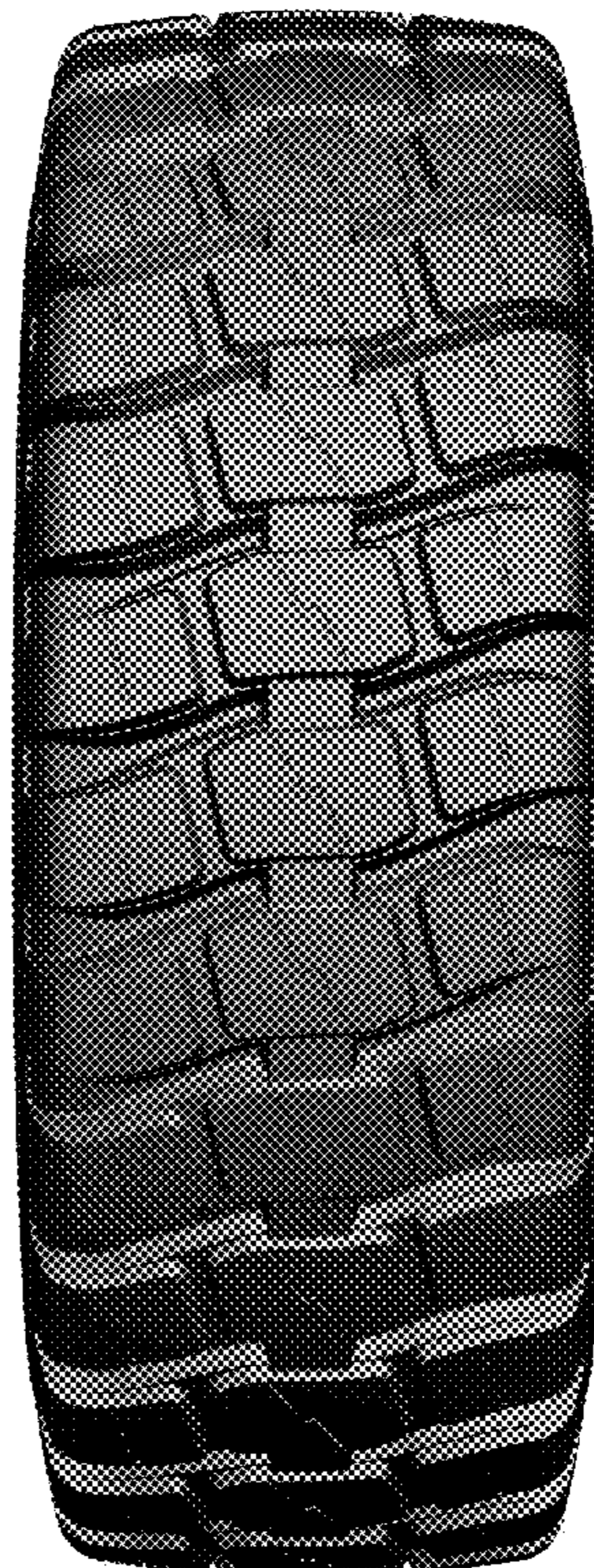

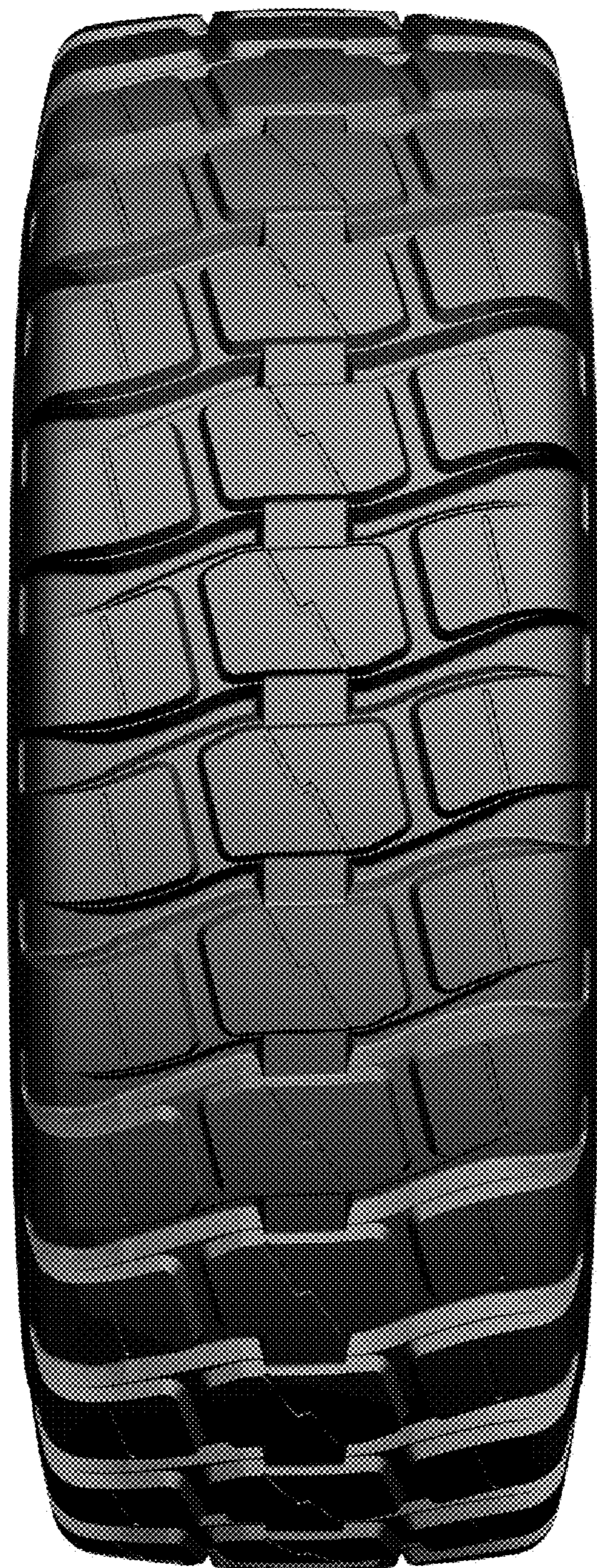
