Crawler track link assembly, as shown and described.

DESCRIPTION

FIG. 4 is a side elevational view taken from right to left thereof;

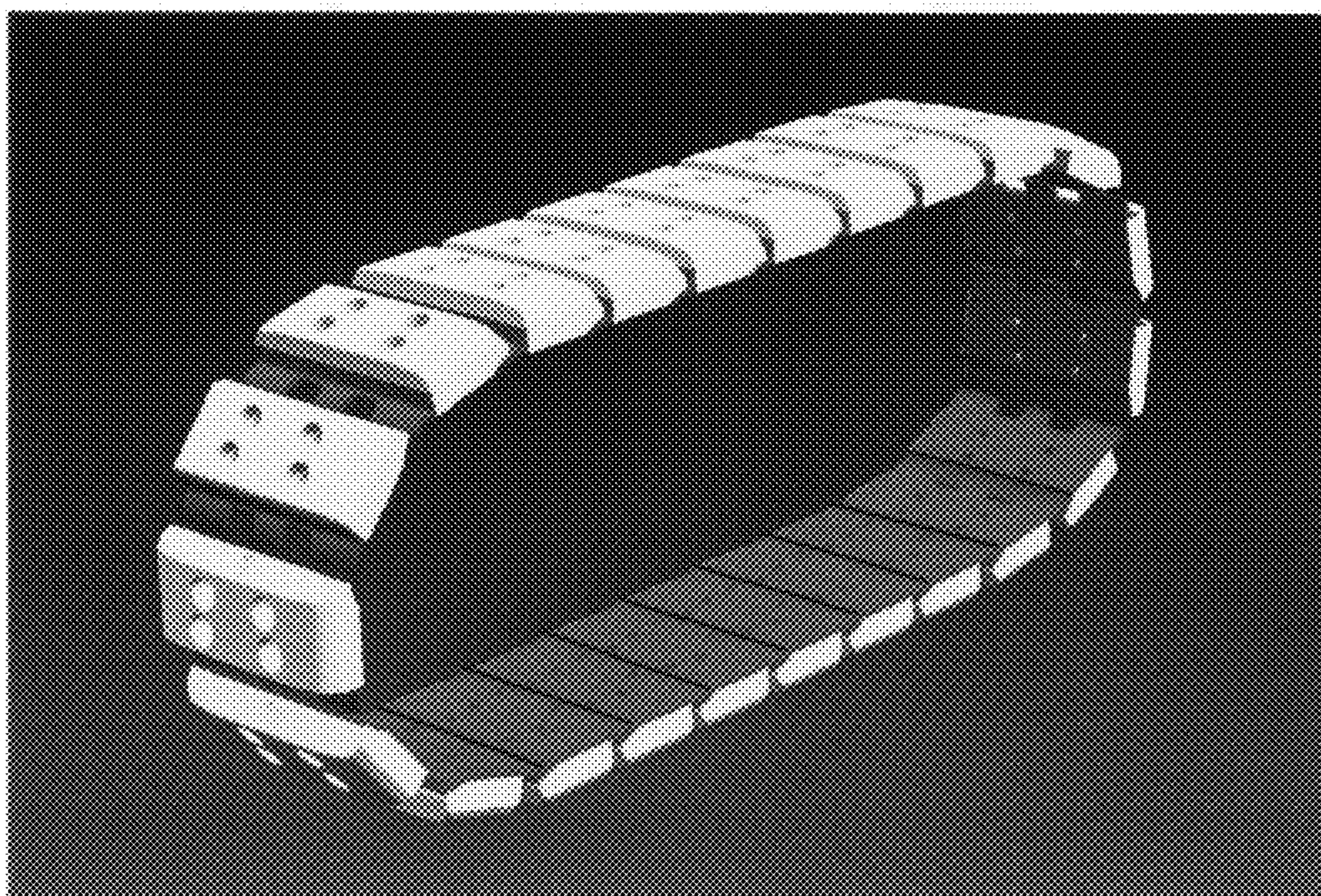
FIG. 5 is a top plan view thereof;

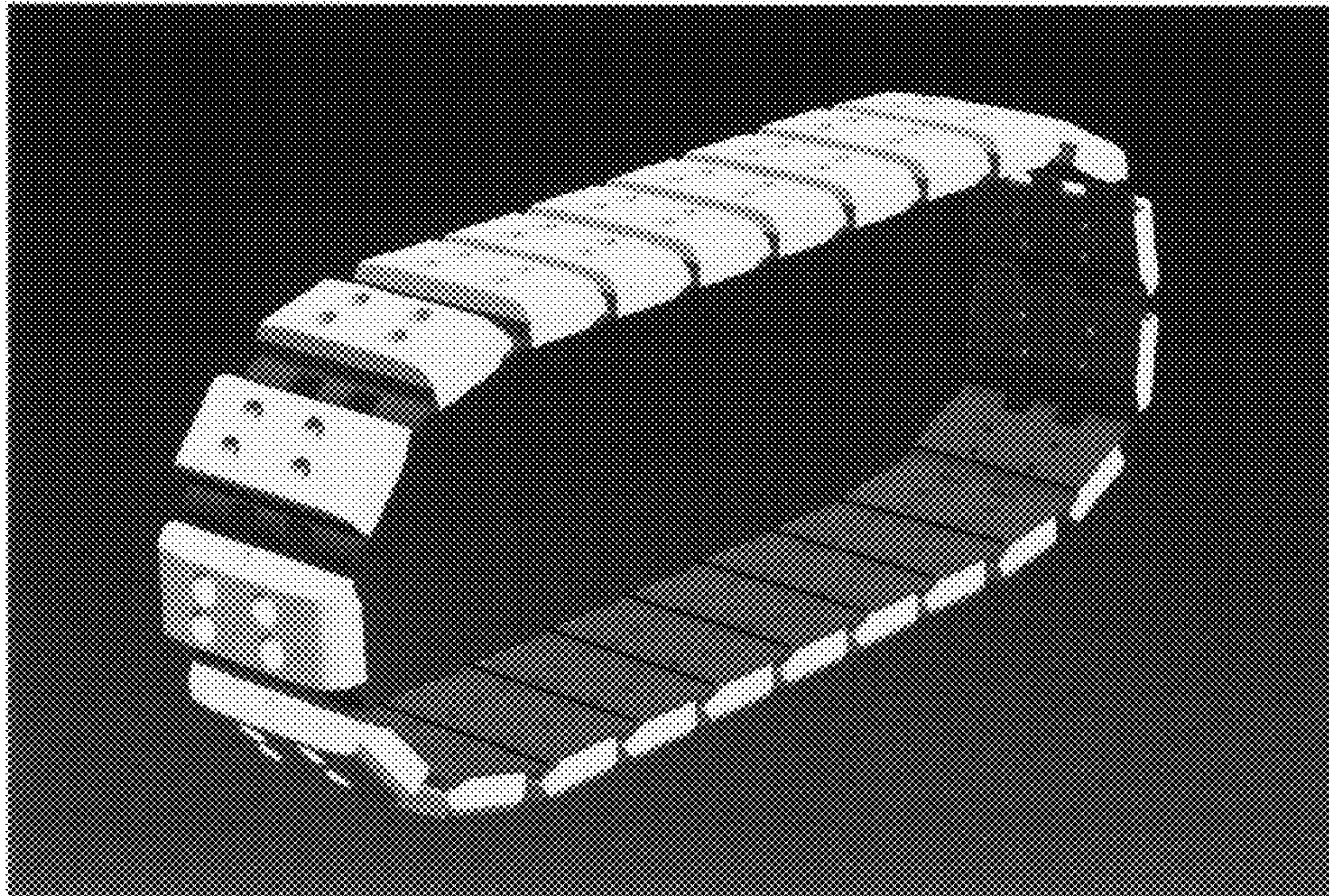

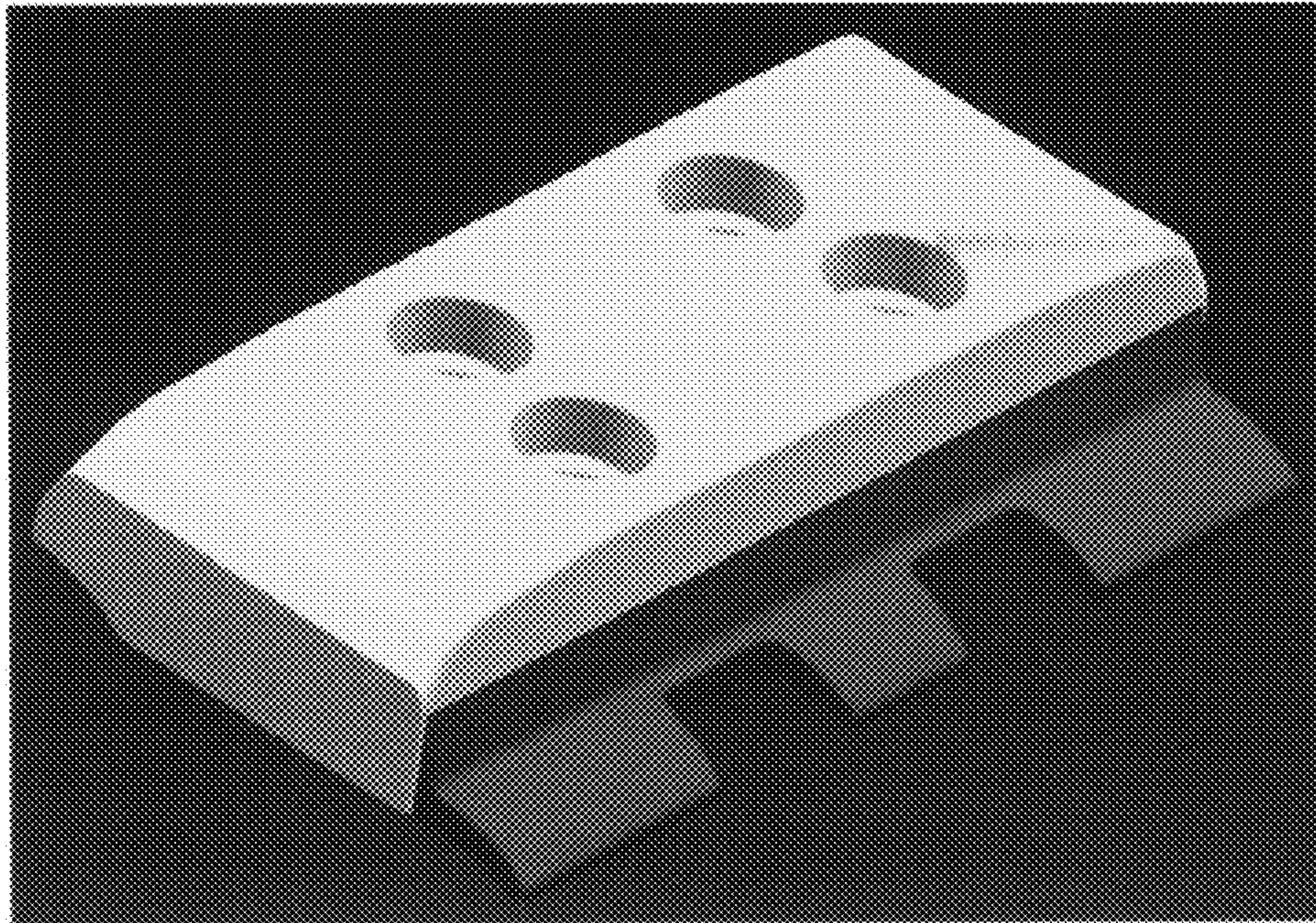

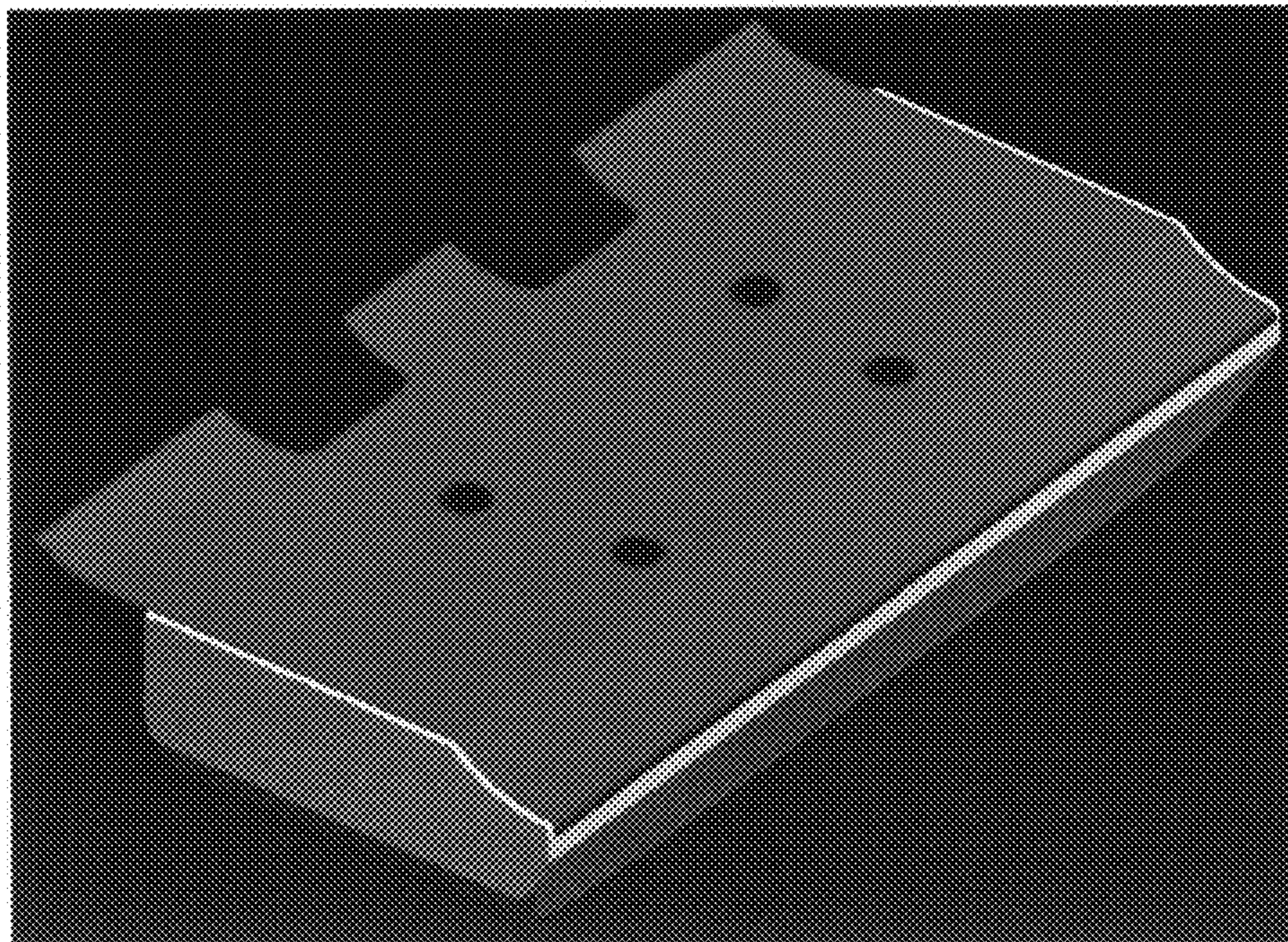

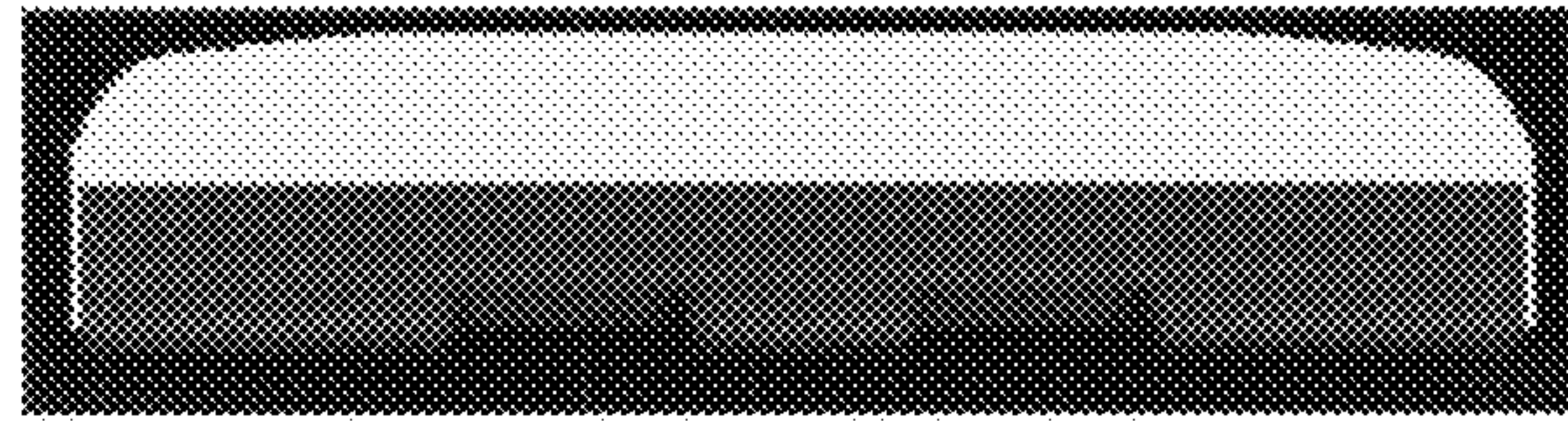

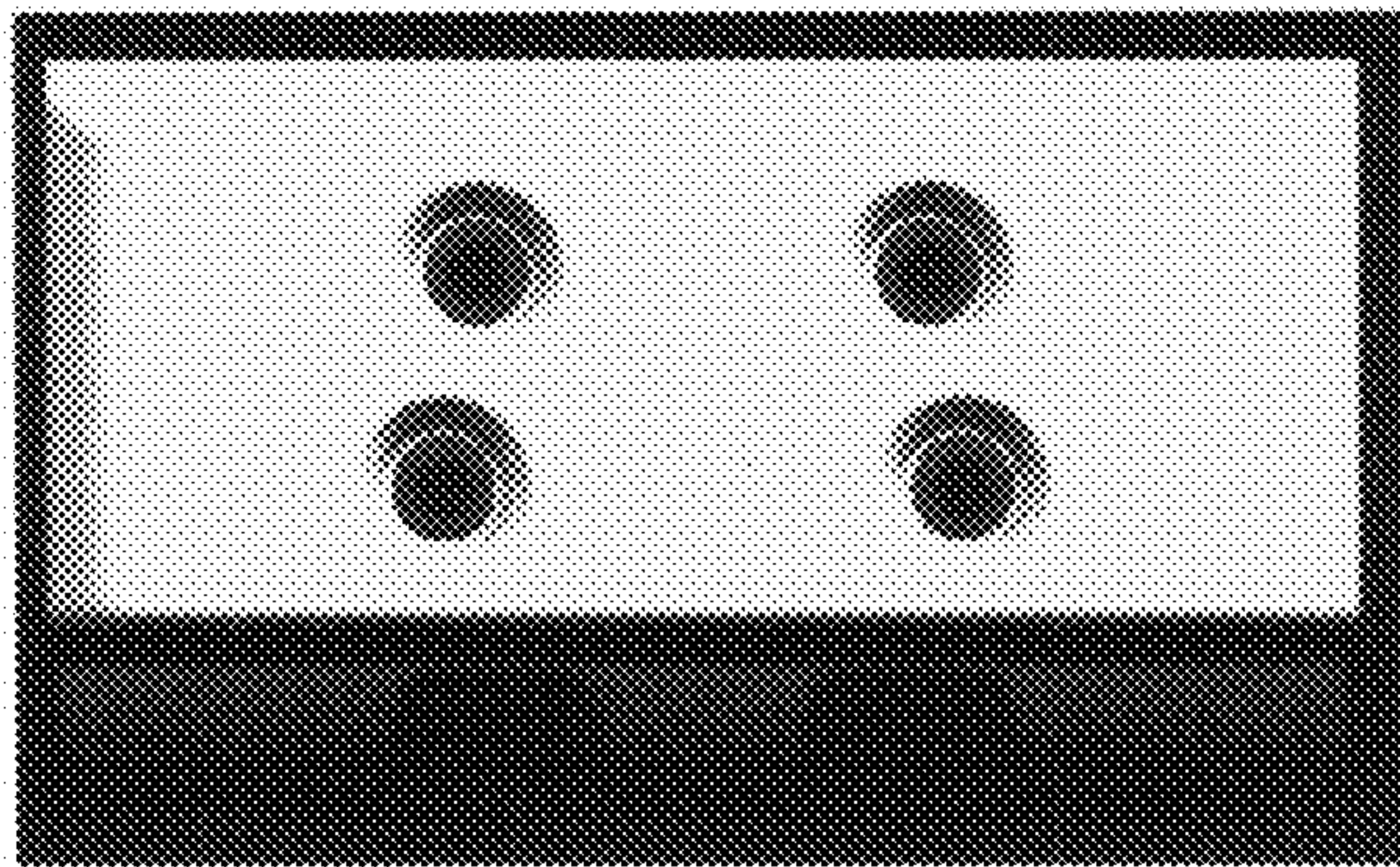

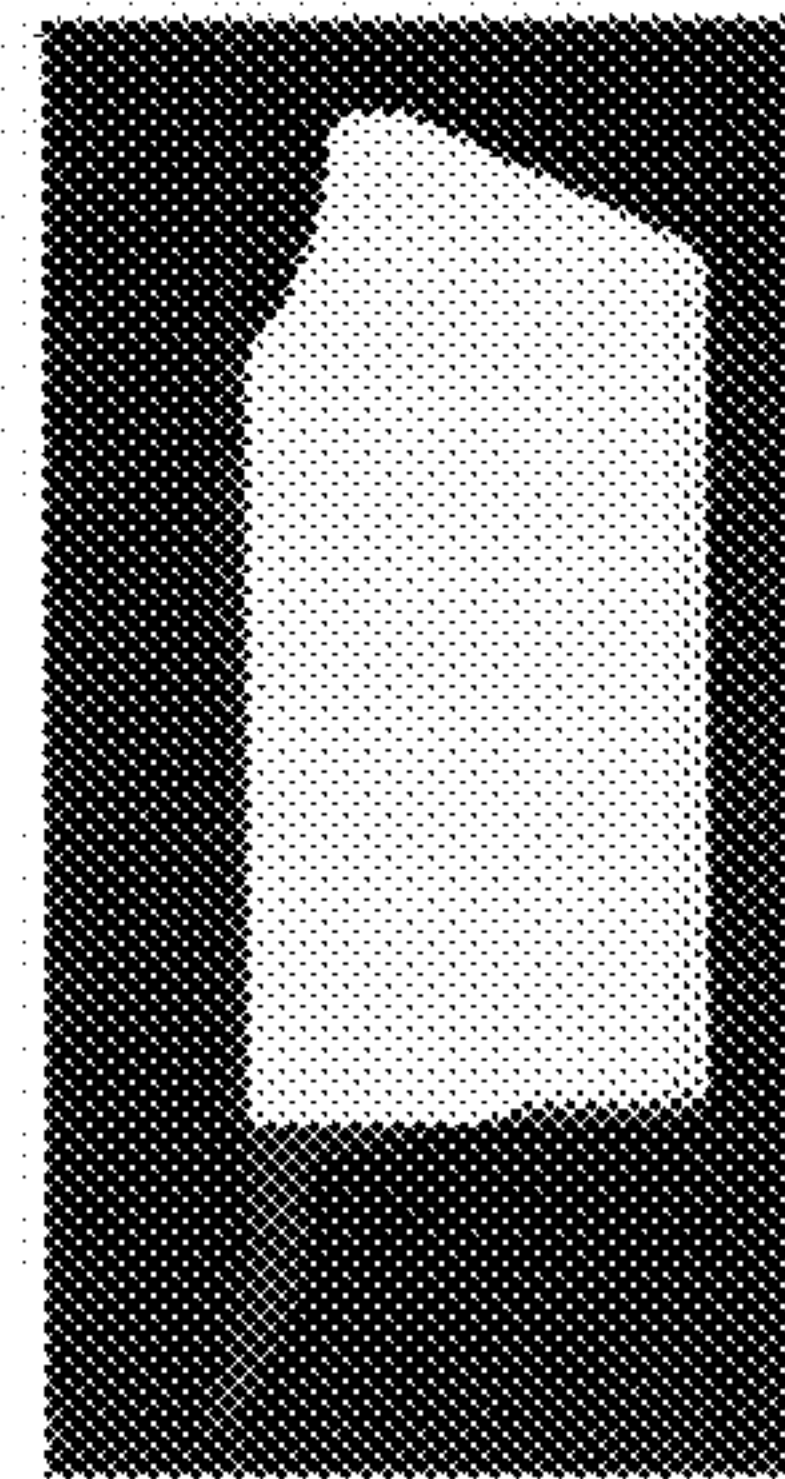

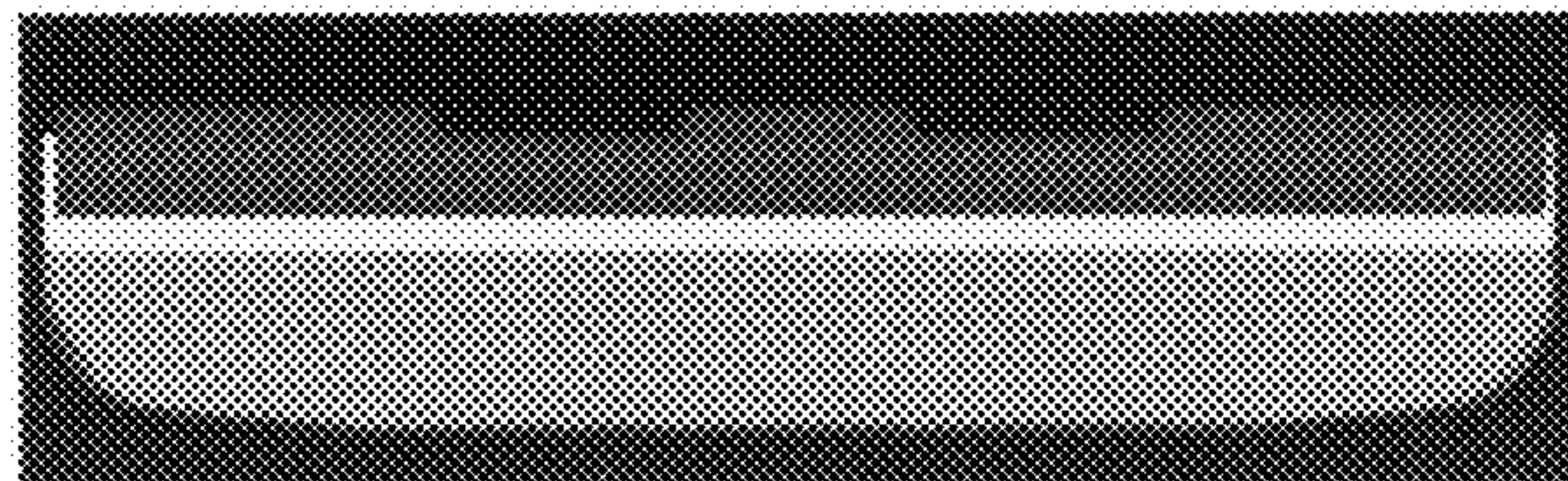

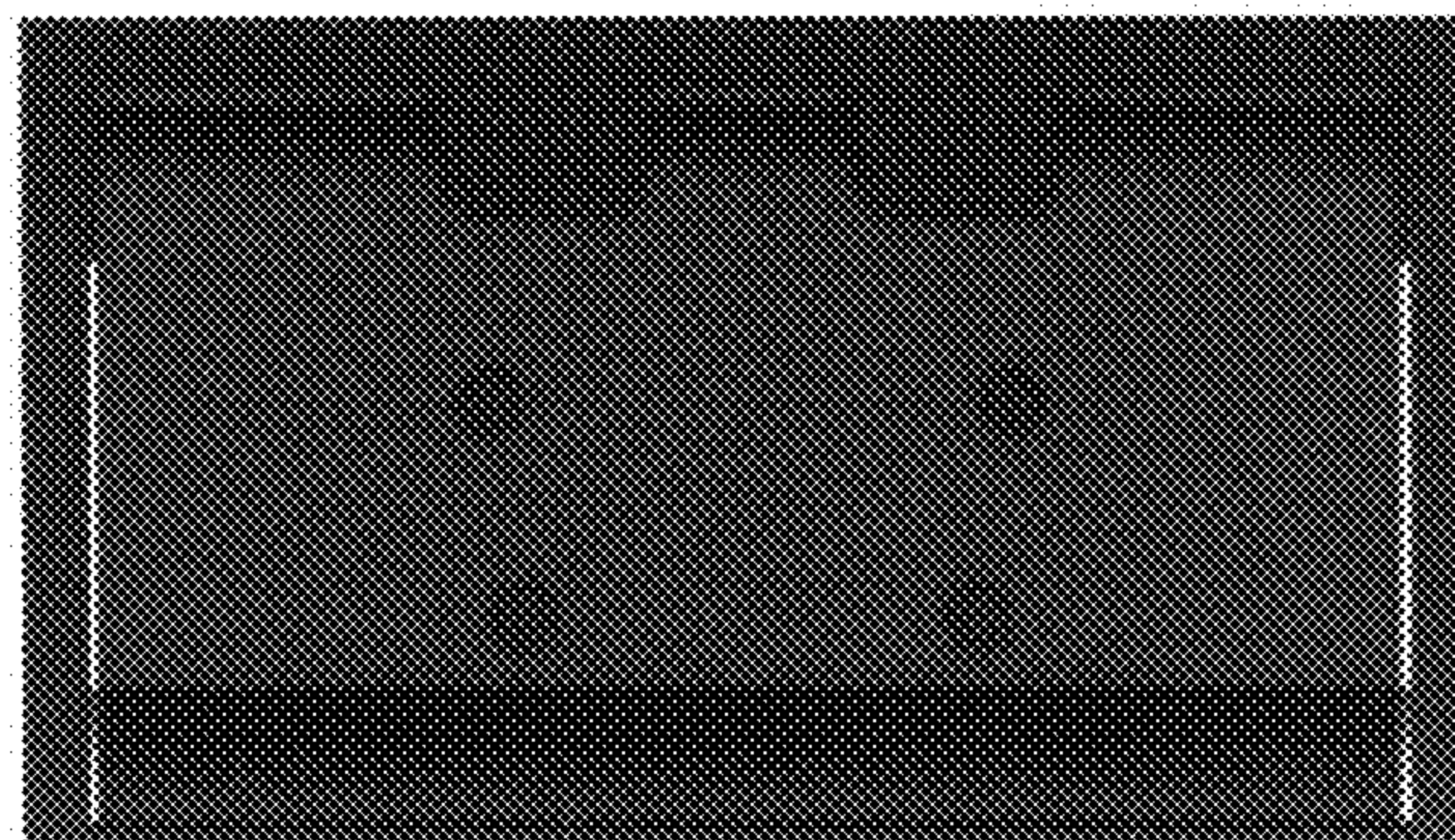
