**DESCRIPTION**

FIG. 5 is an enlarged rear elevation view thereof;

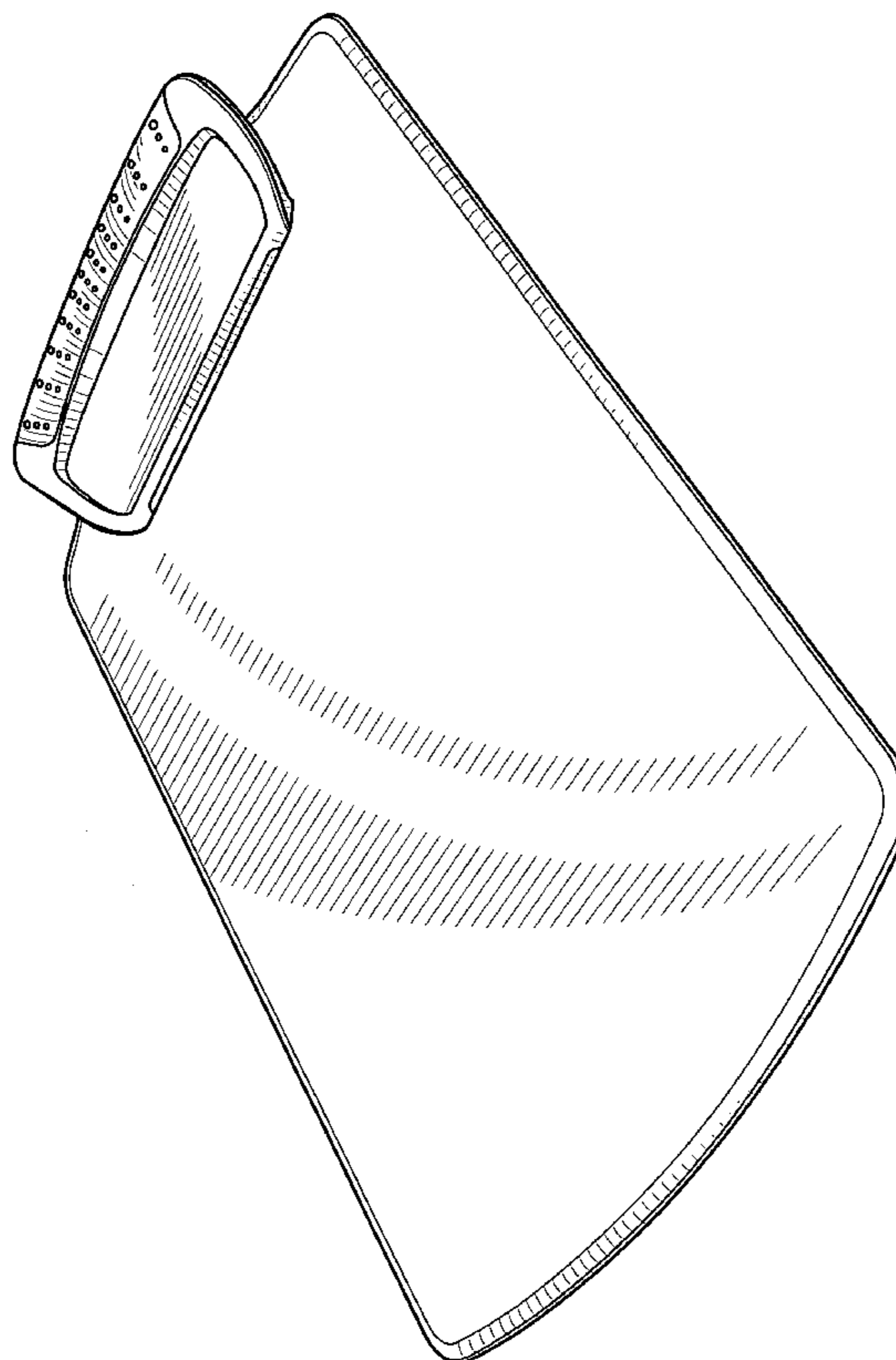
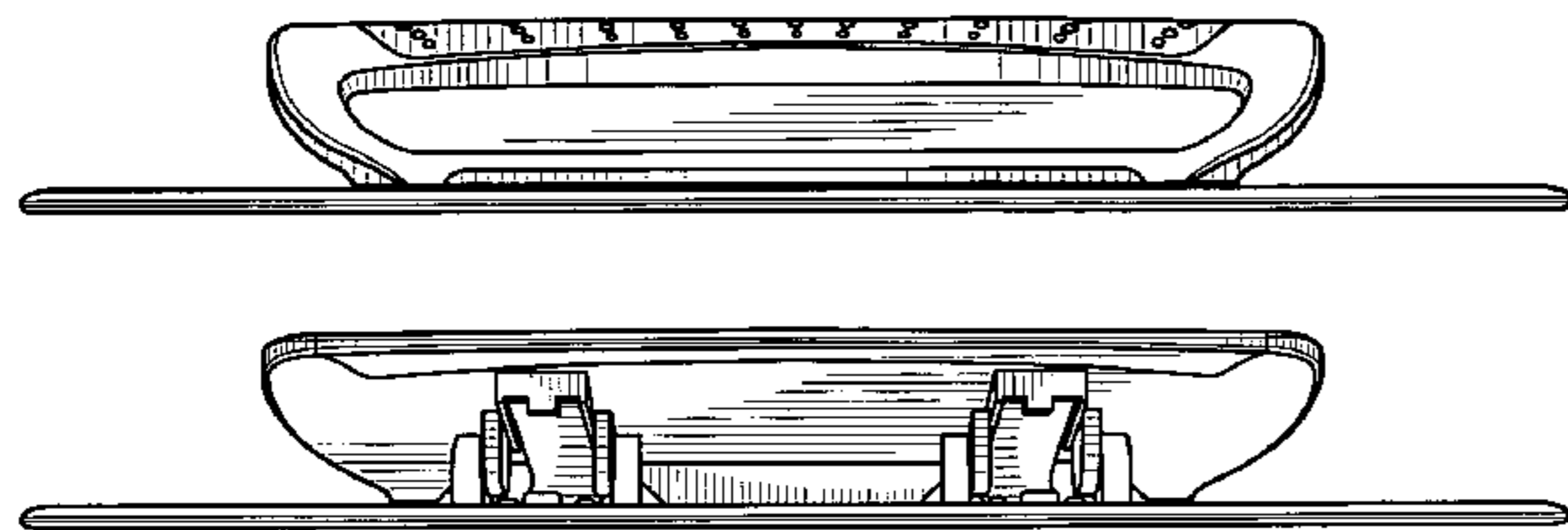
FIG. 6 is a front top right isometric view thereof;

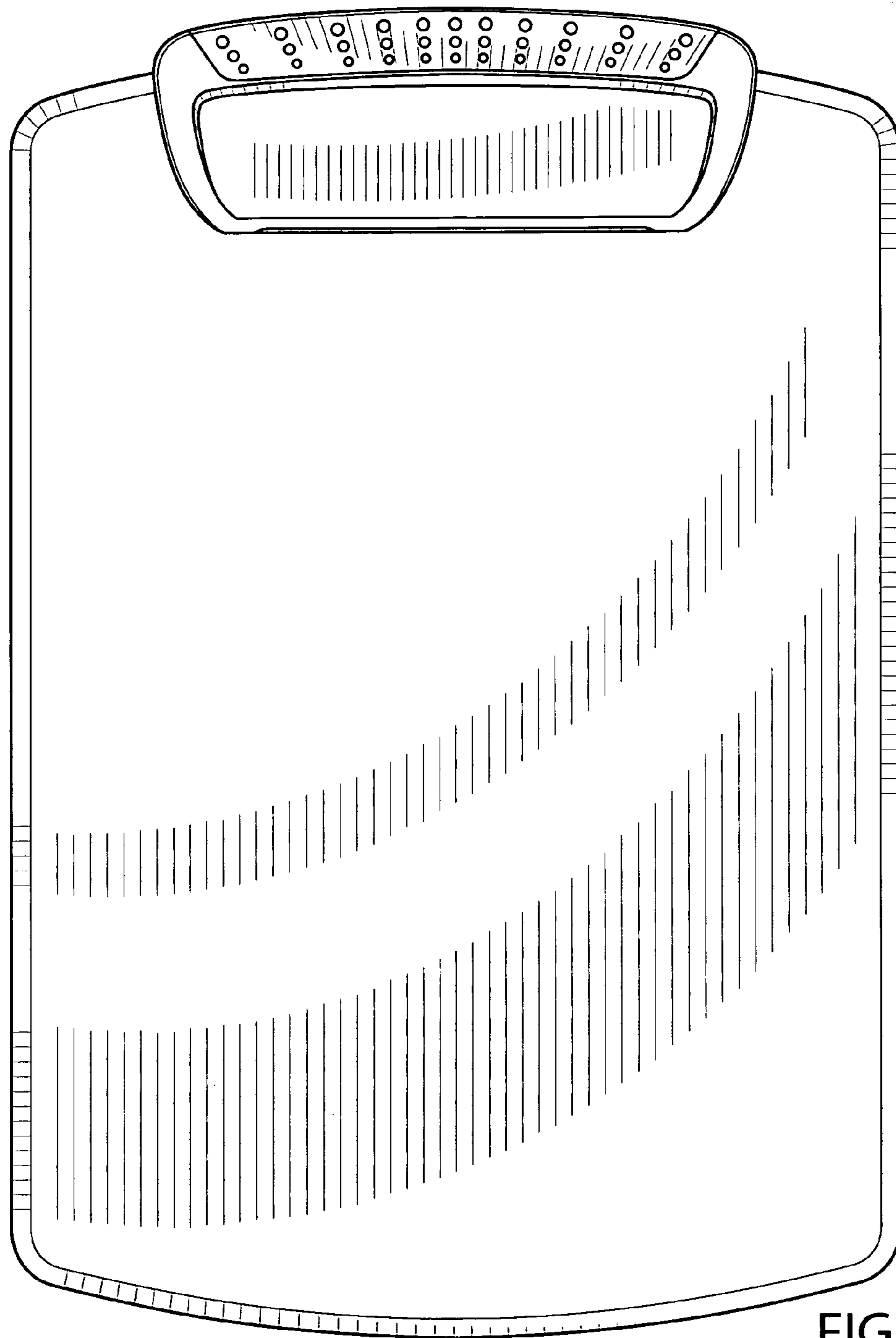

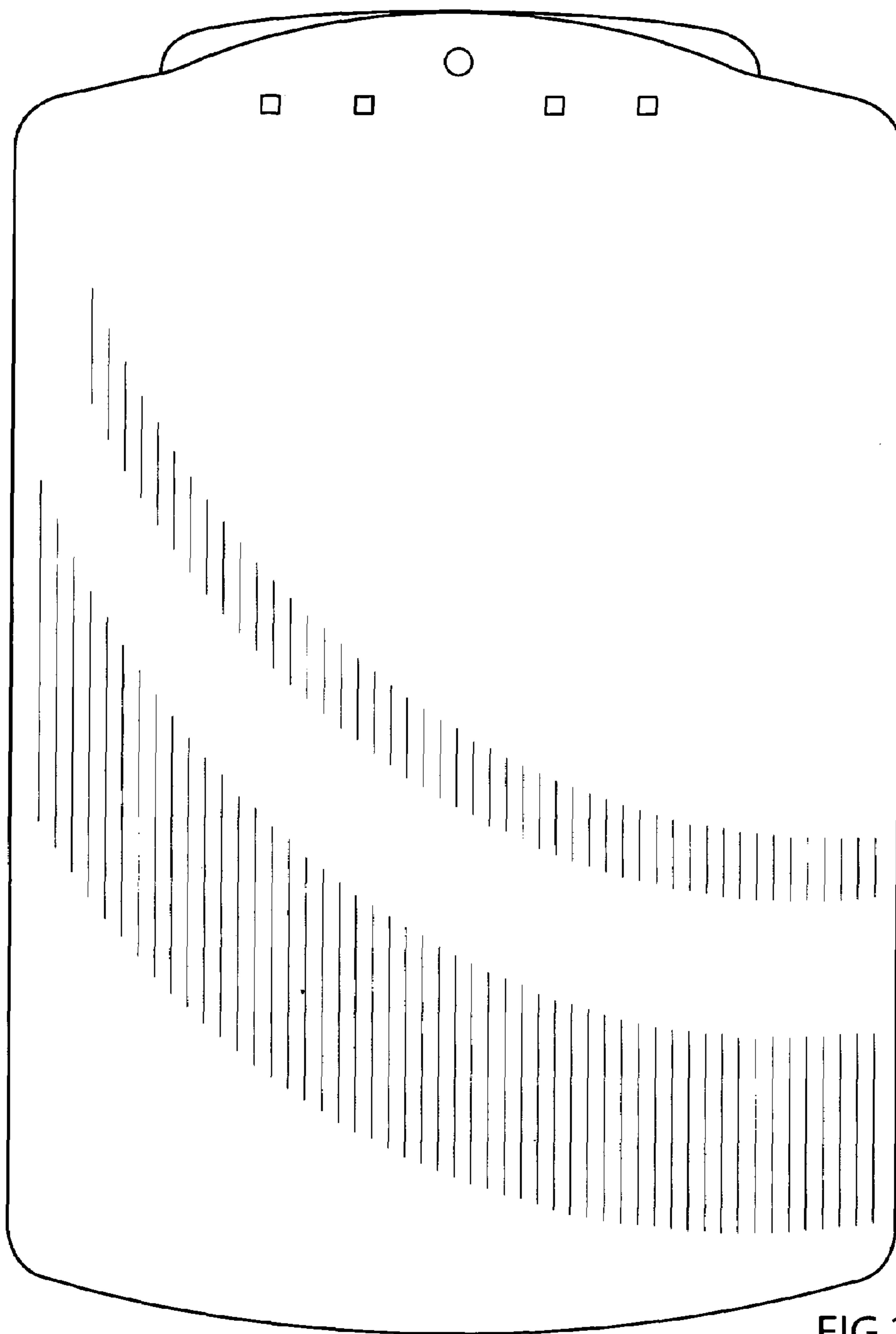

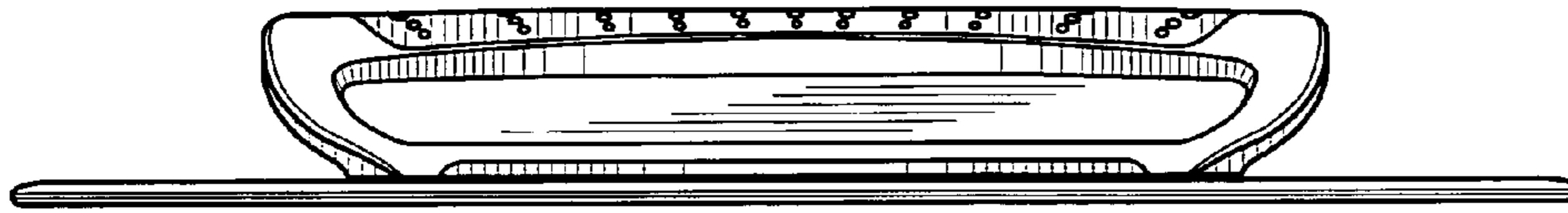

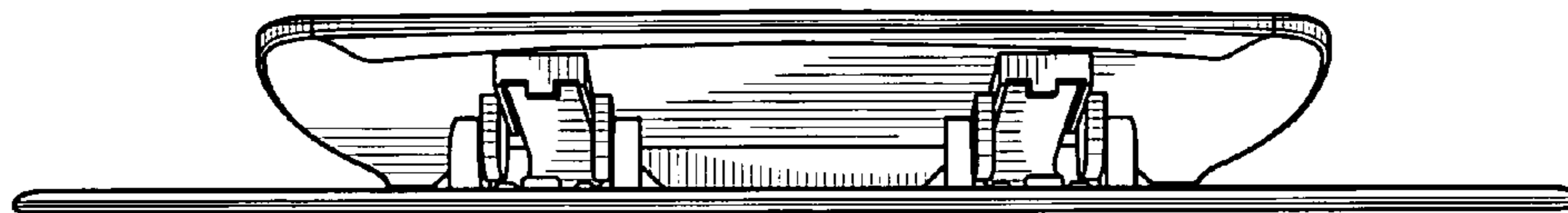

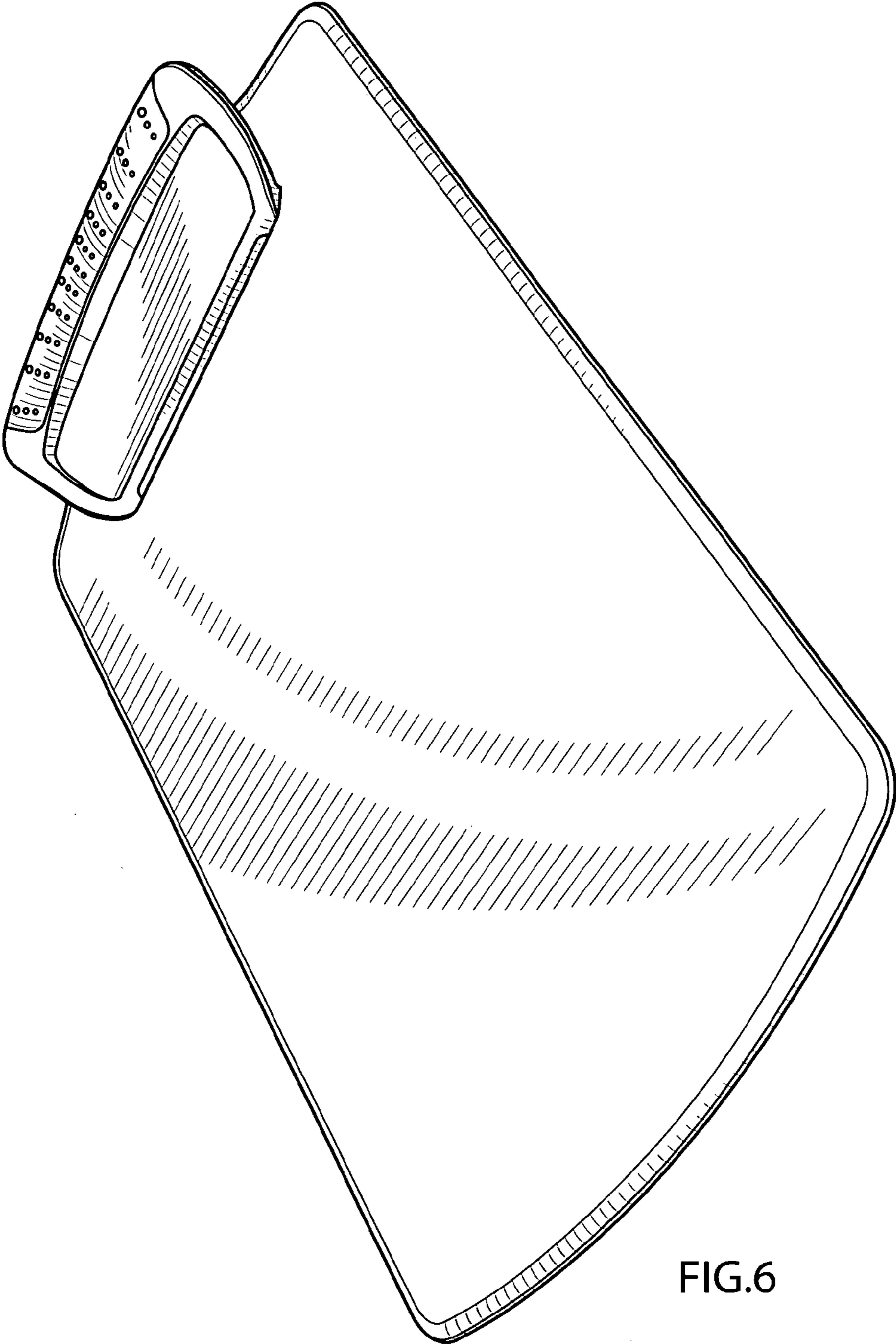

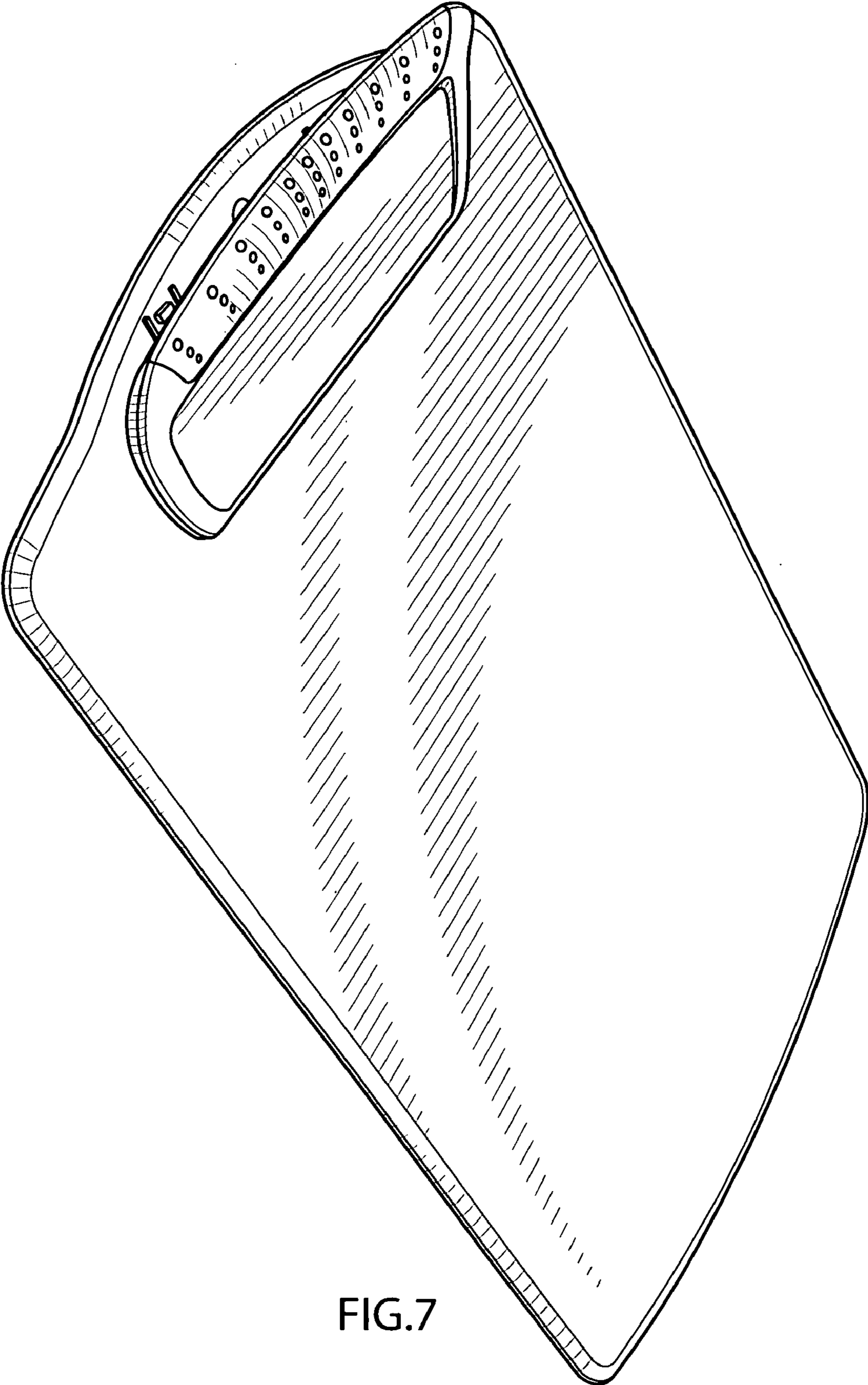

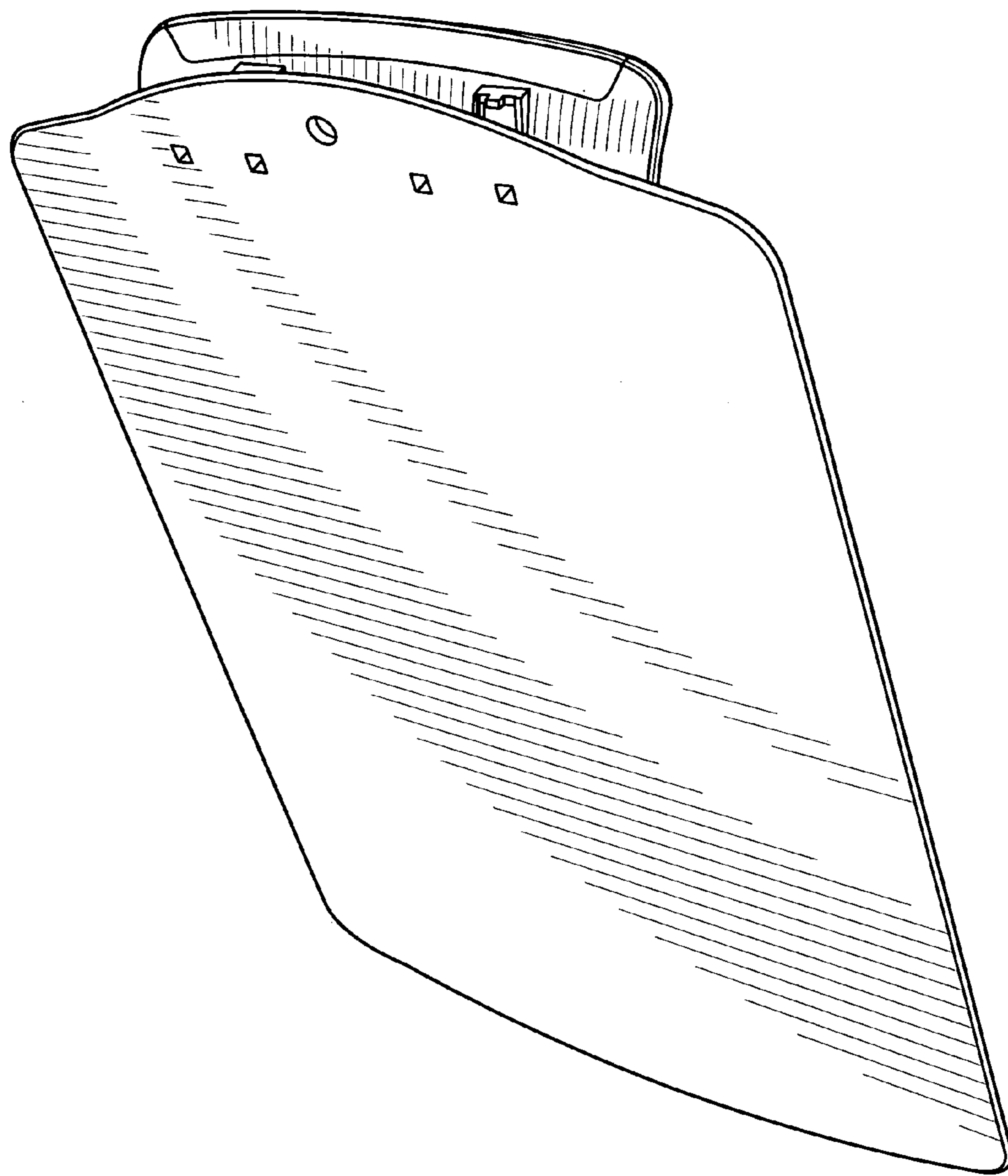
