(57) **CLAIM**

The ornamental design for a head for golf club, as shown and
described.

DESCRIPTION

FIG. 1 is a first perspective view of a head for golf club;
FIG. 2 is a second perspective view thereof;
FIG. 3 is a plan view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a front elevational view thereof;
FIG. 6 is a side elevational view thereof; and,
FIG. 7 is an inverted opposite side elevational view of FIG. 6.
The portion shown by broken lines is for illustrative purposes
only and forms no part of the claimed design. The dashed
lines show a borderline between the claimed design and other
portion.

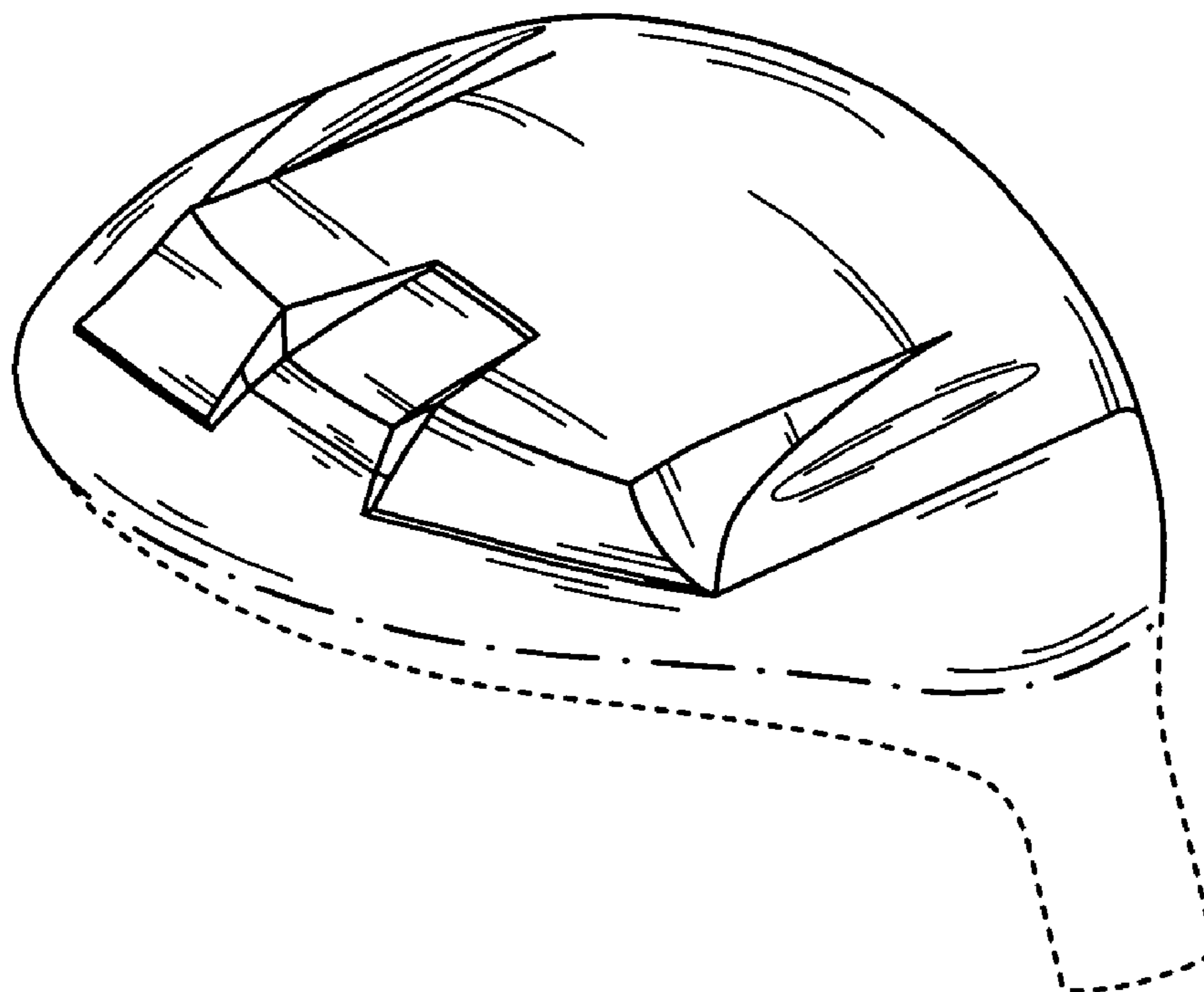

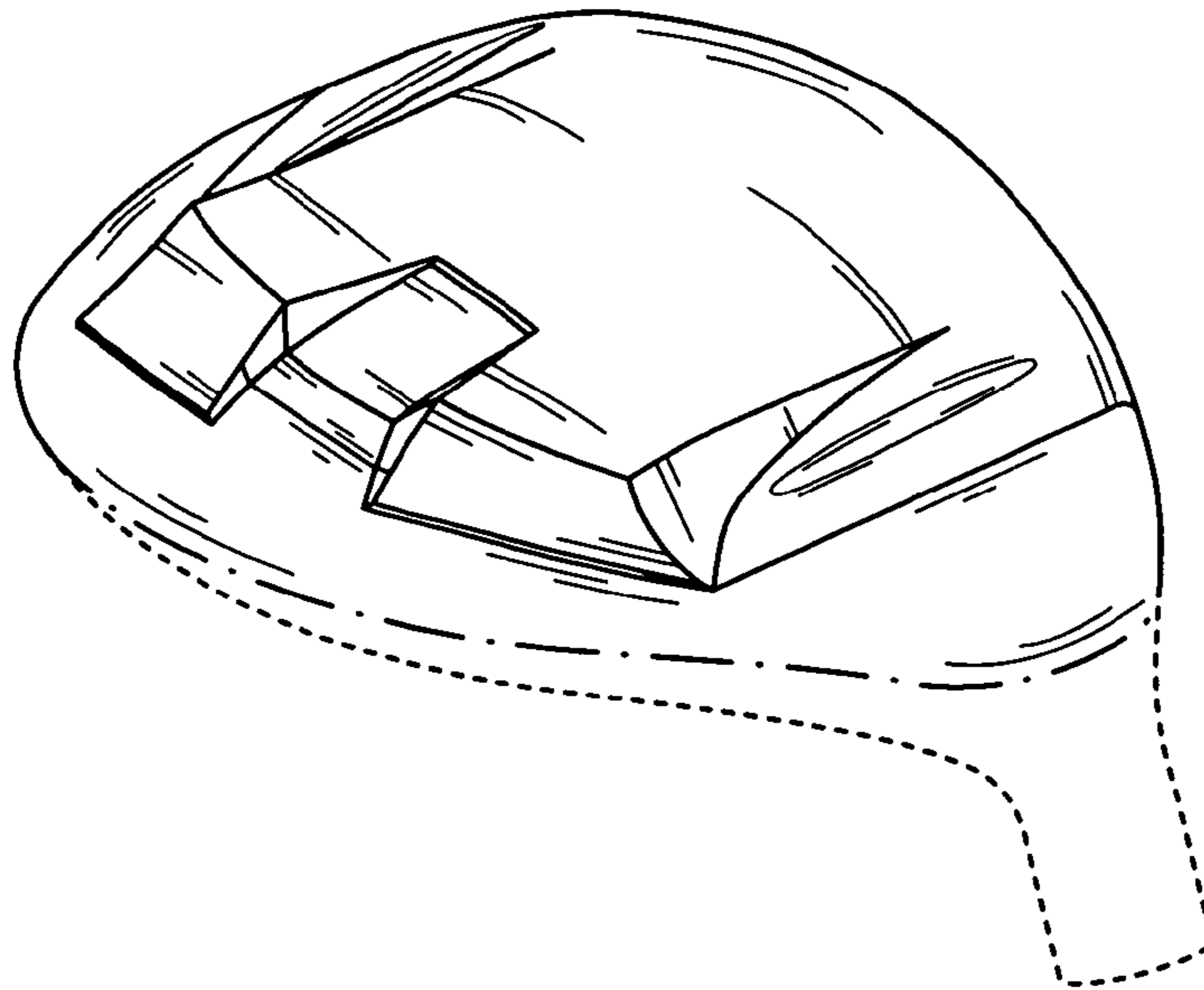

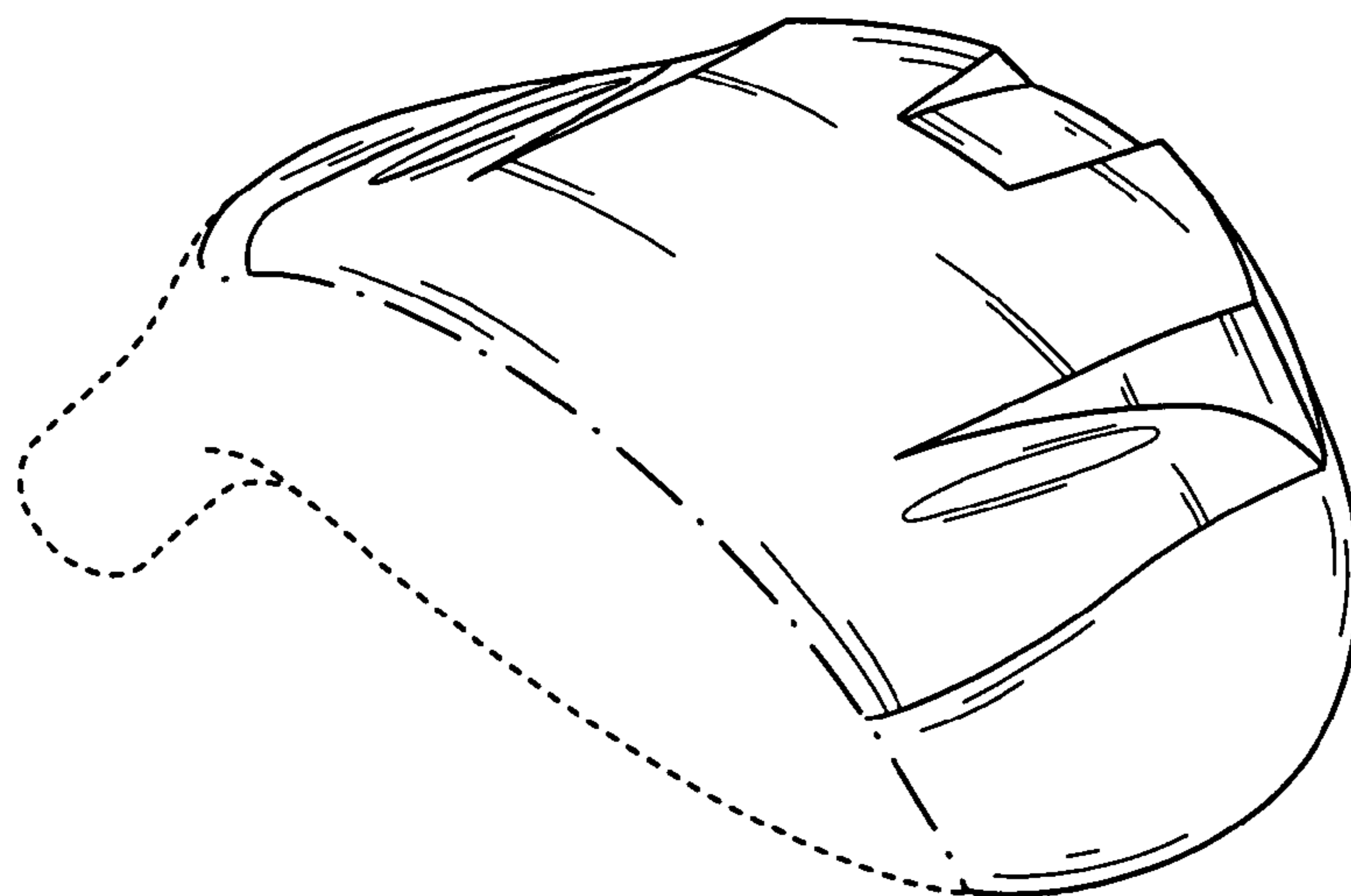

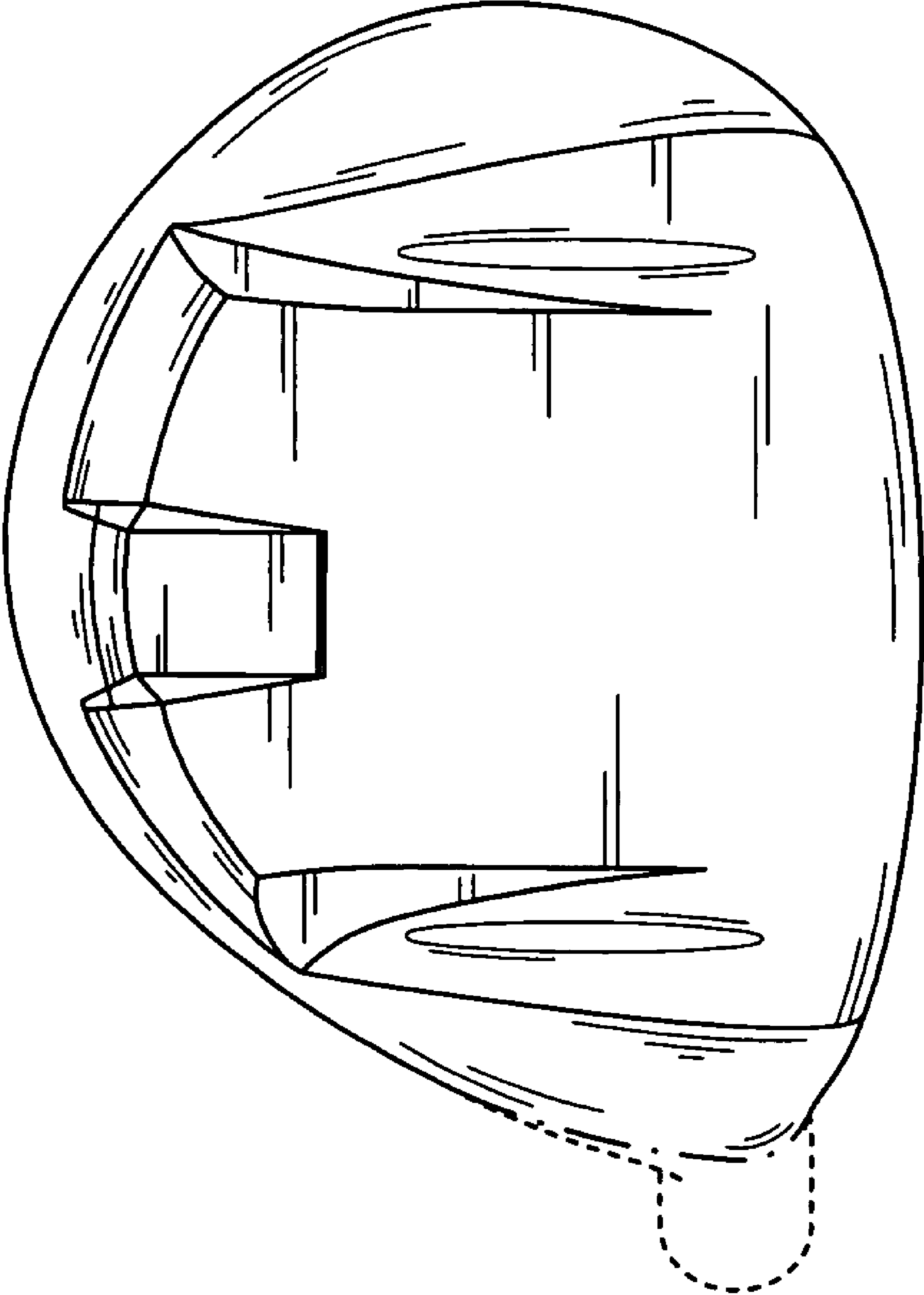

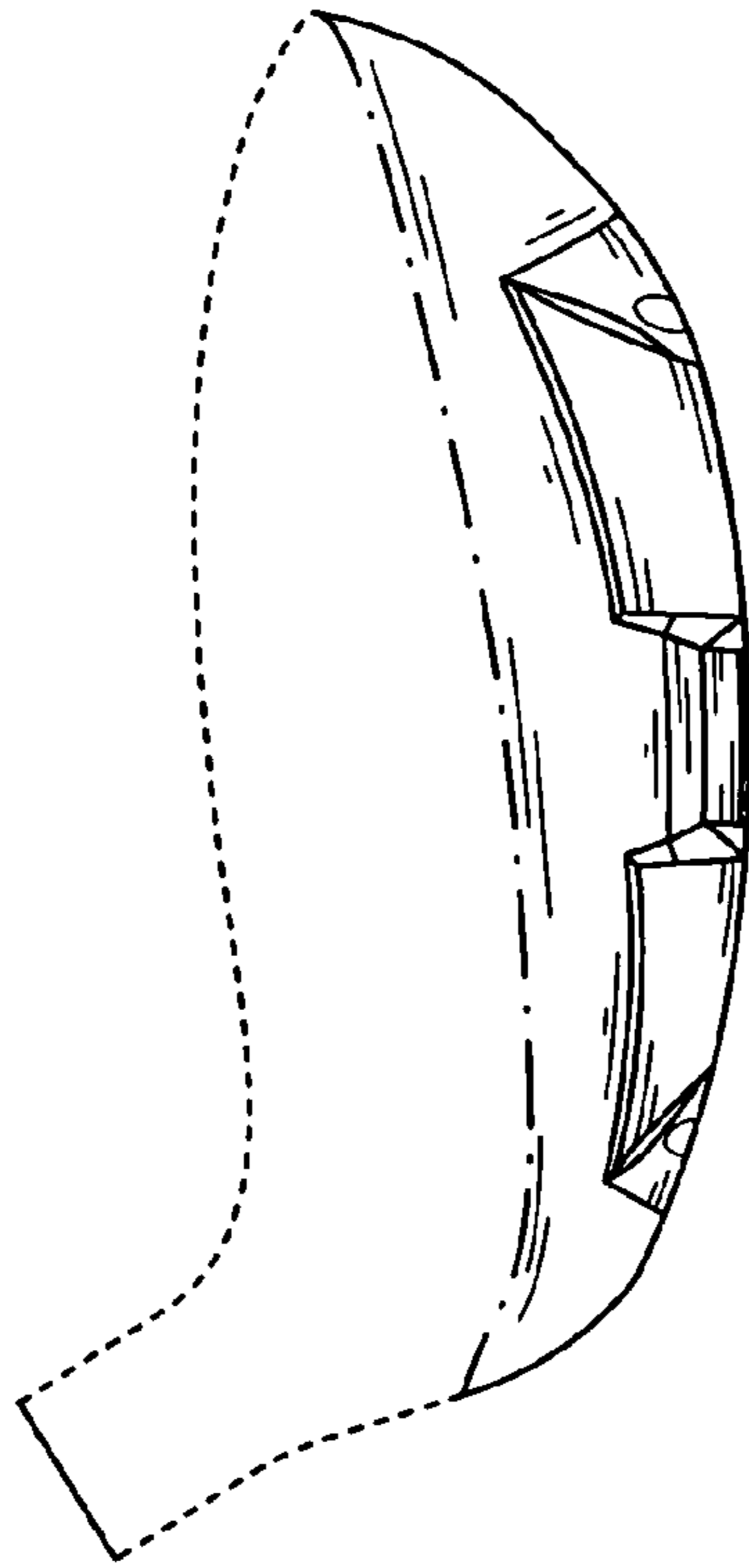

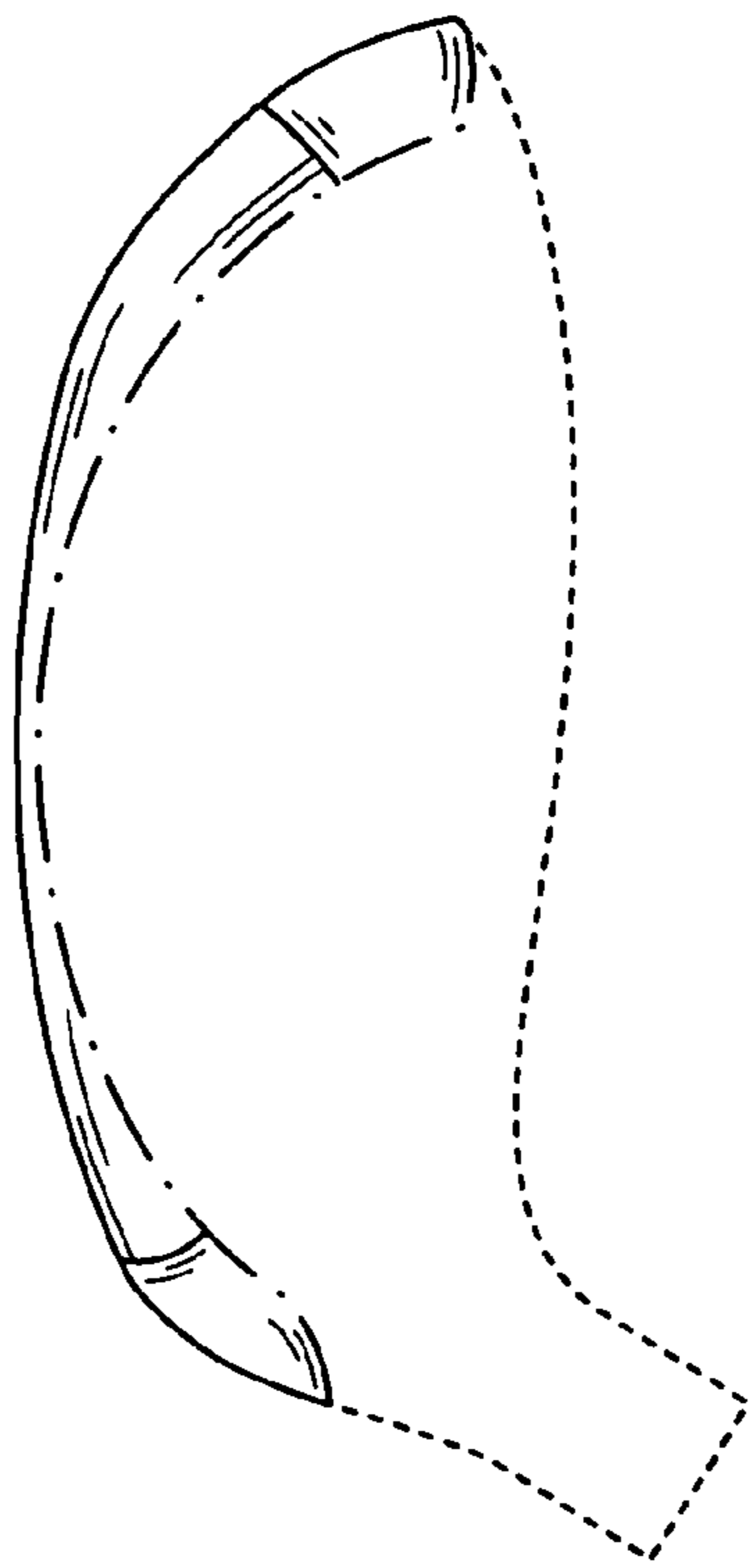

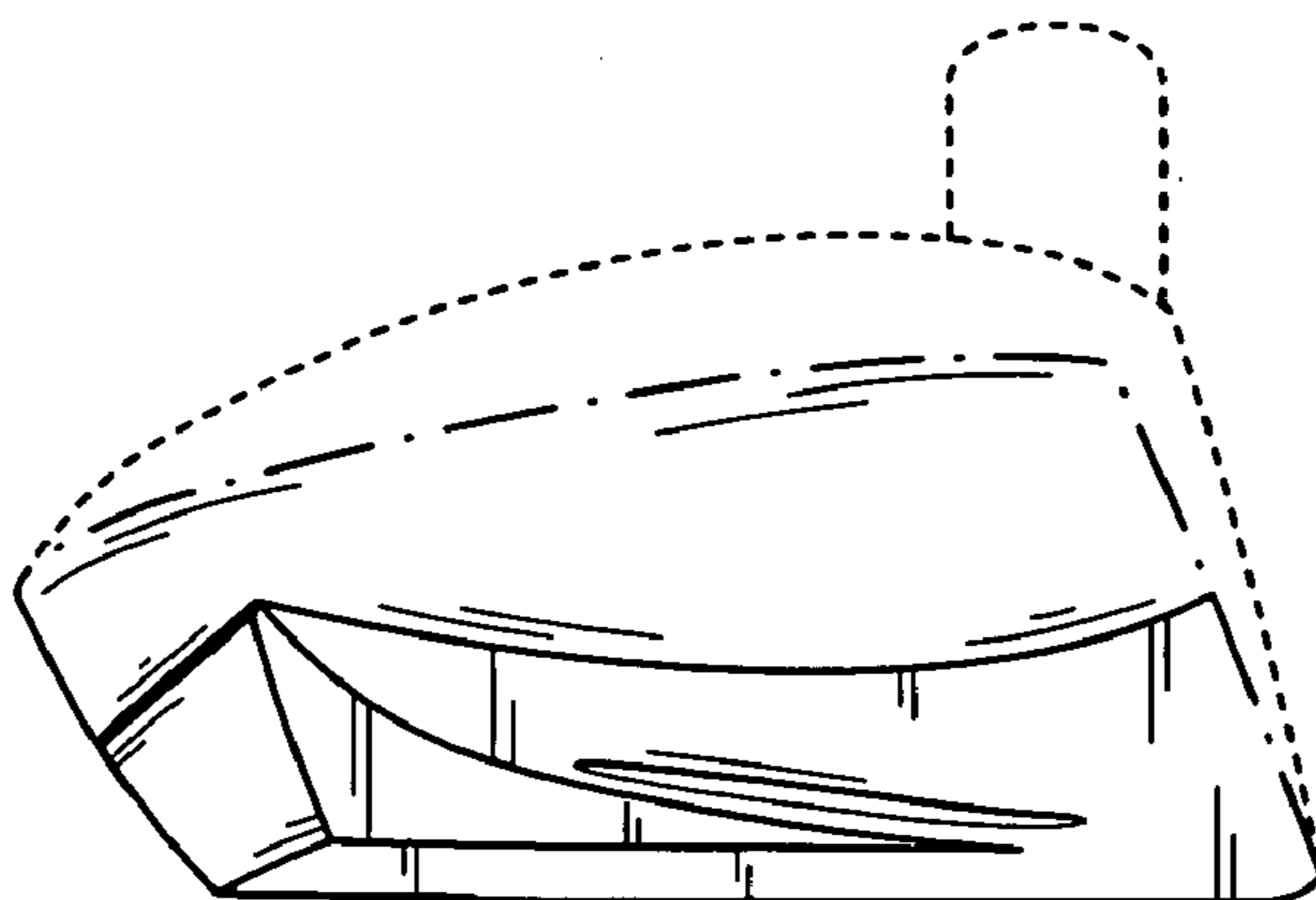
