I claim the ornamental design for a shoe sole, as shown and described in the drawings.

DESCRIPTION

FIG. 1 is a right side, front and top perspective view of a shoe sole in accordance with the new design;

FIG. 2 is a left side and top perspective view thereof;

FIG. 3 is a right side and top perspective view thereof;

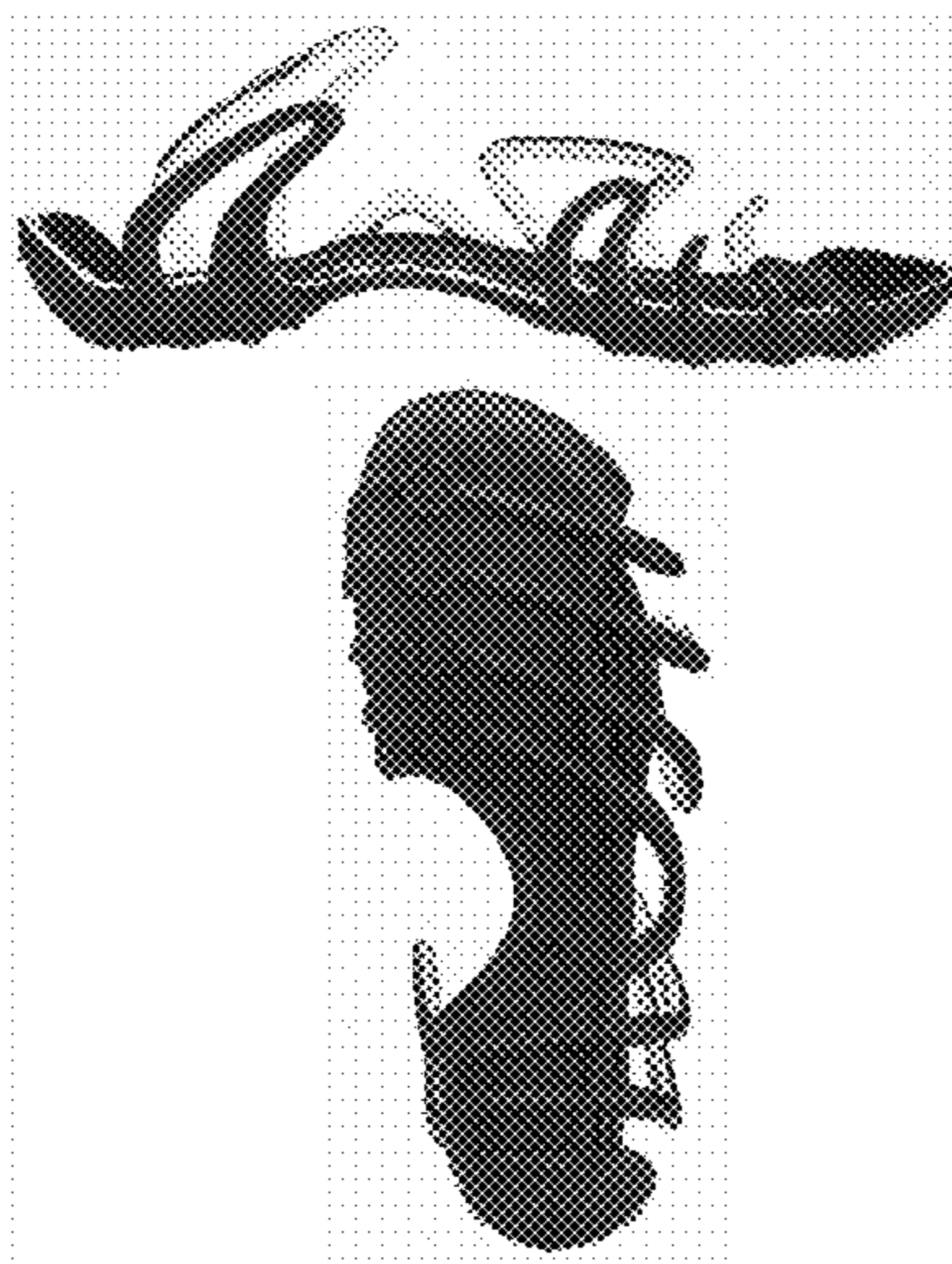
FIG. 4 is a front and top perspective view thereof;

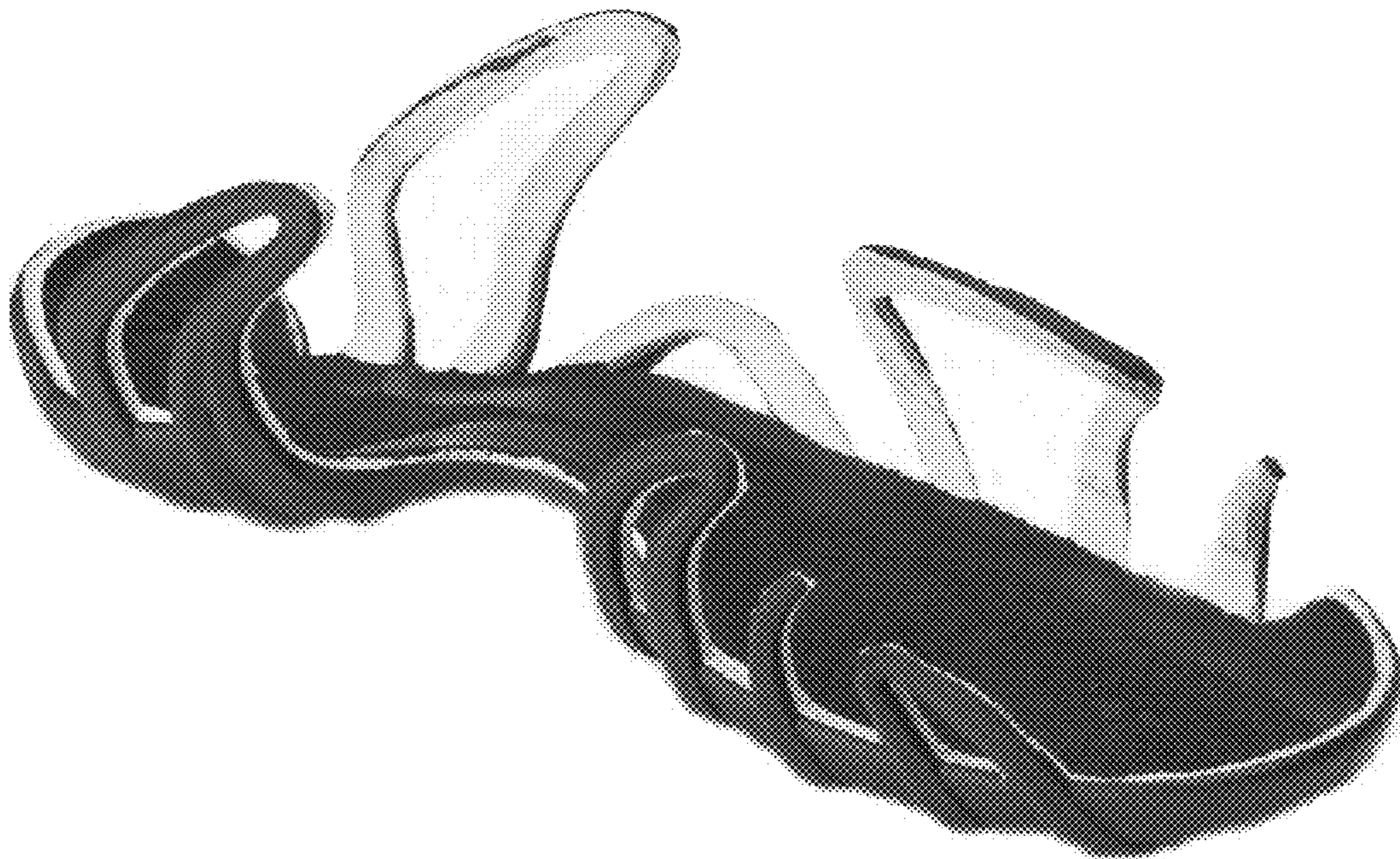

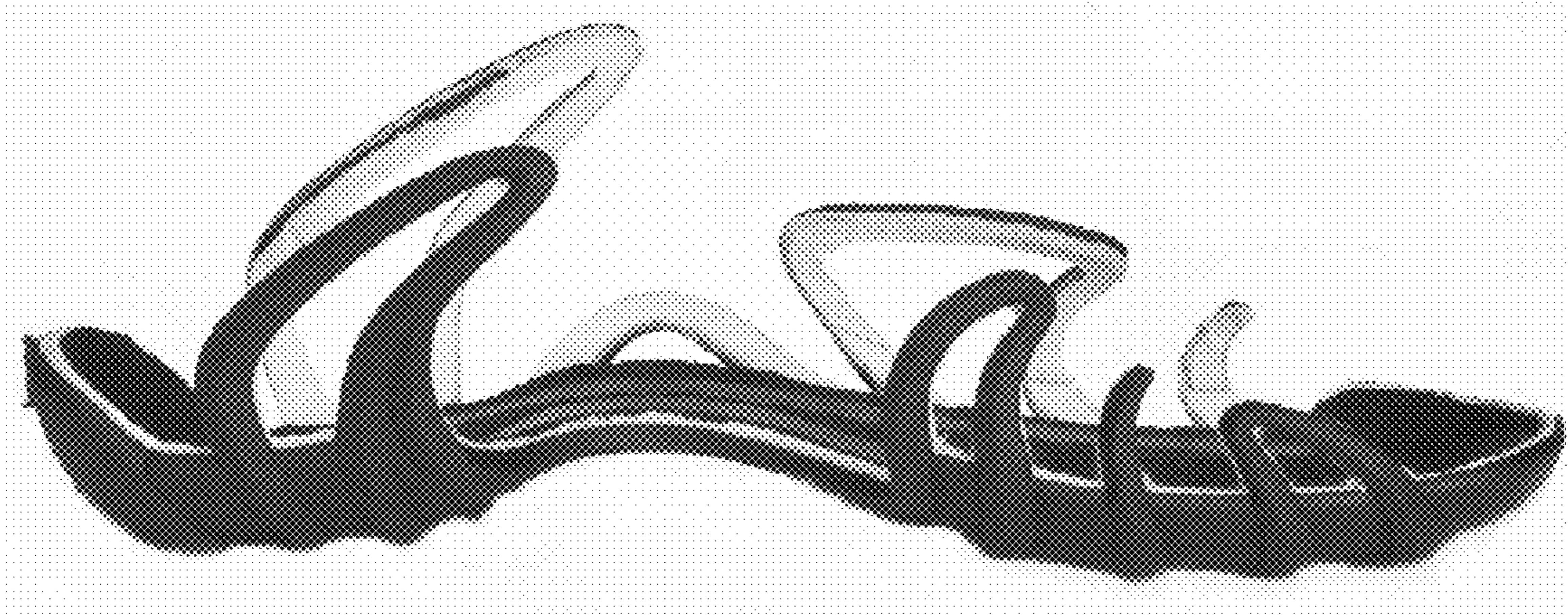

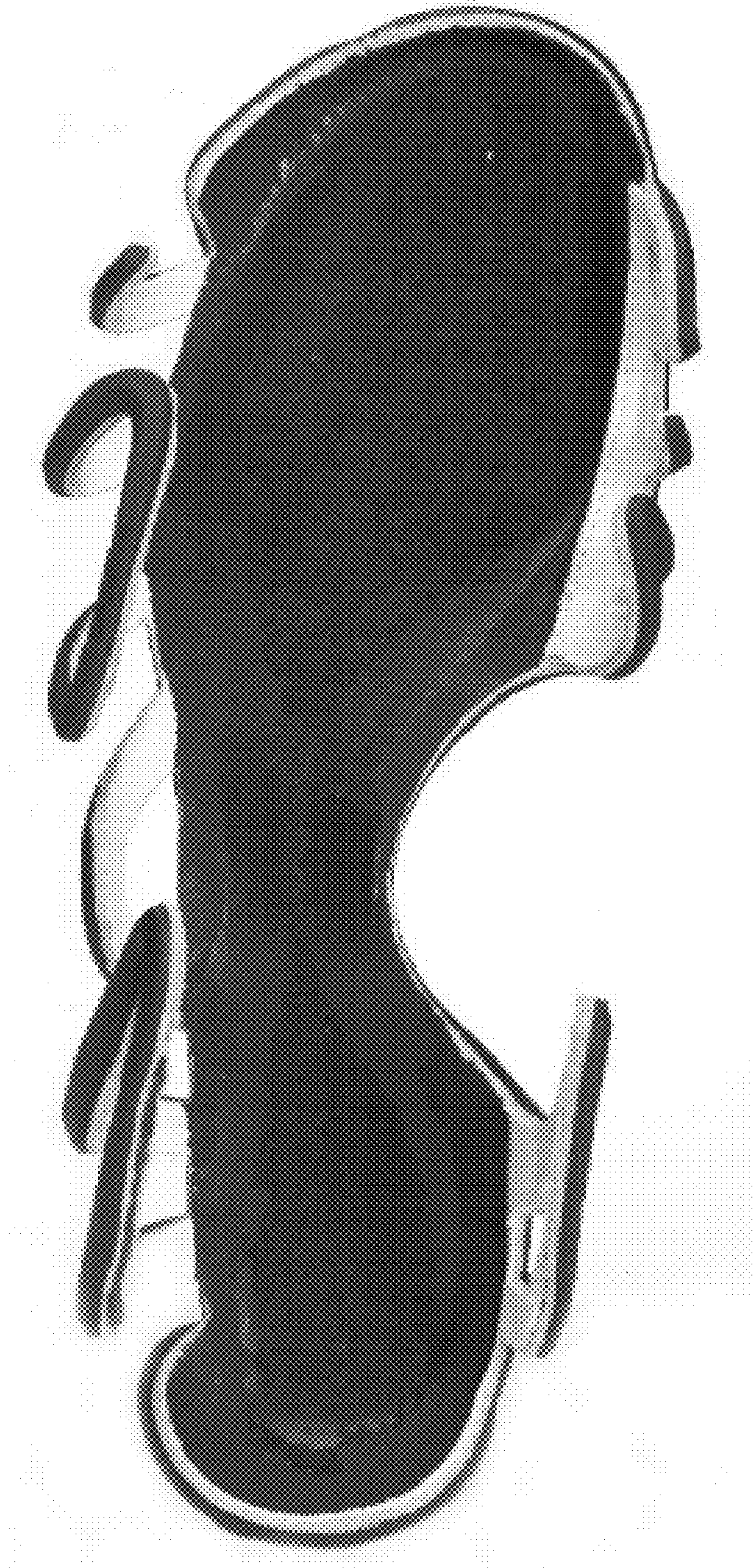

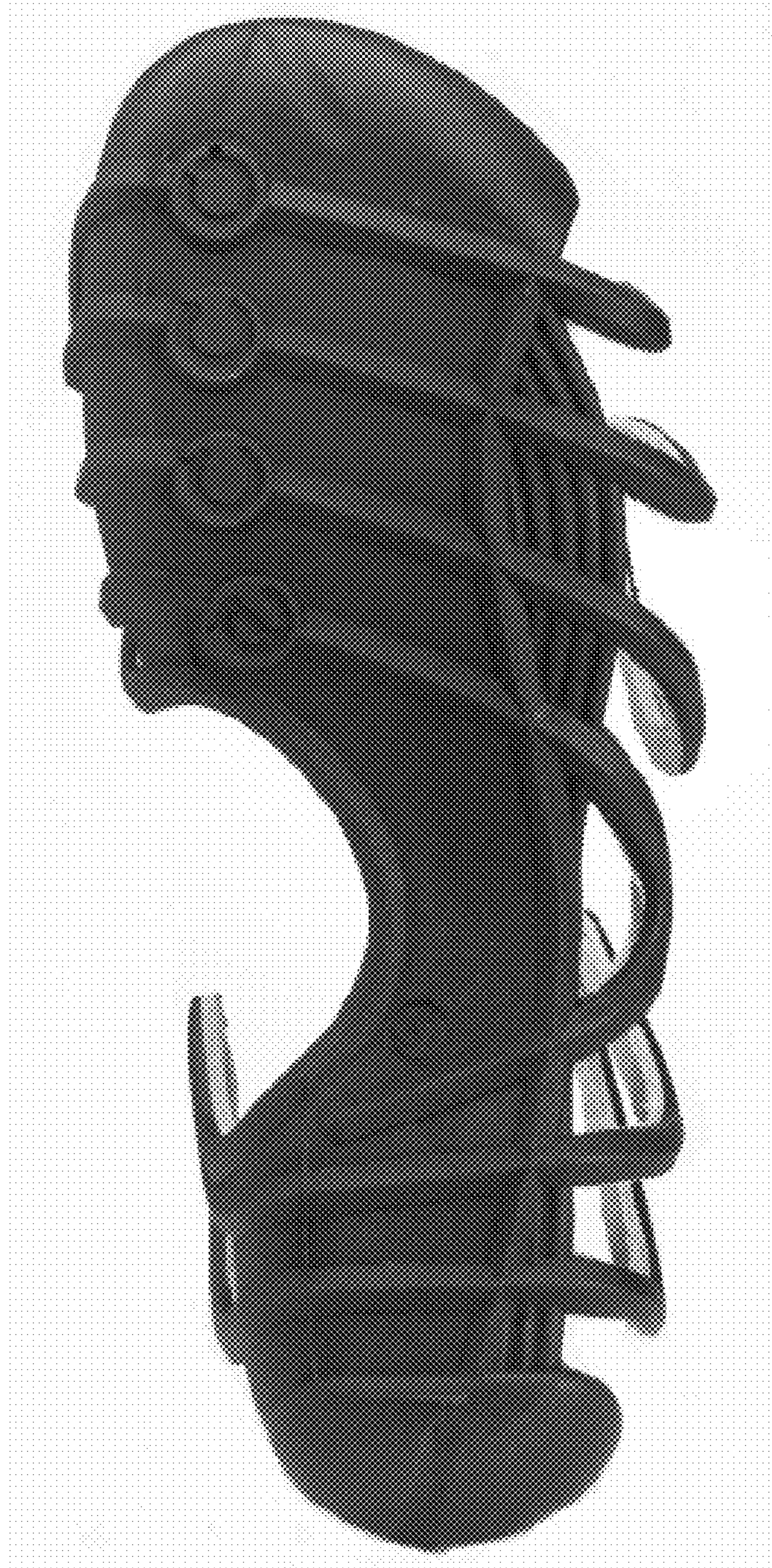
