FIG. 3 is a rear elevational view of the design of FIG. 1;

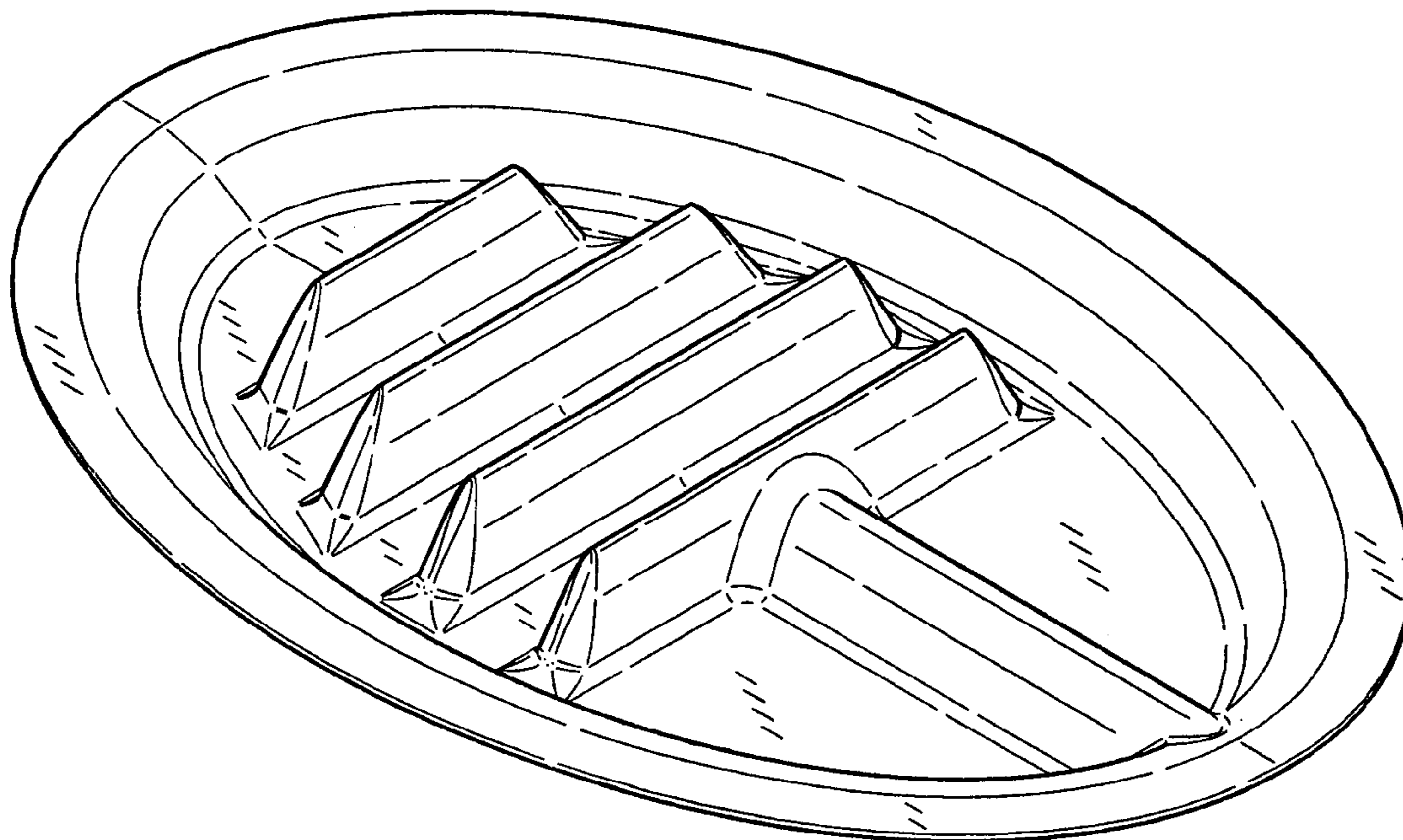
FIG. 4 is a left side elevational view of the design of FIG. 1;

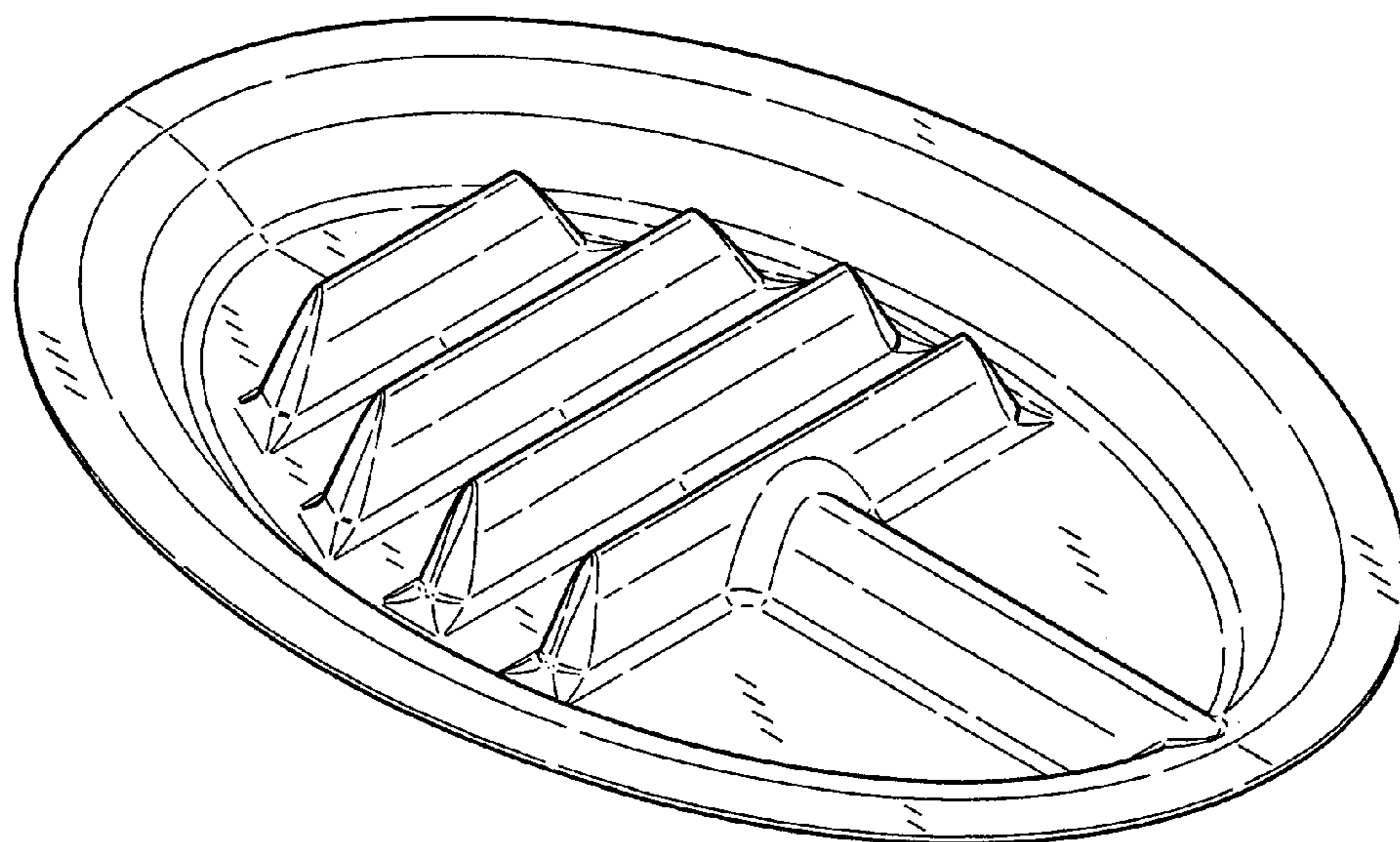

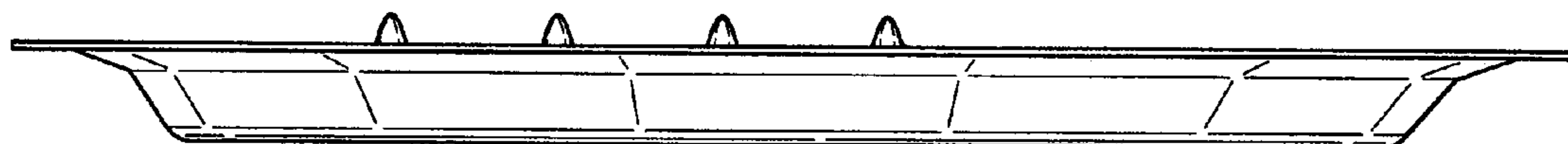

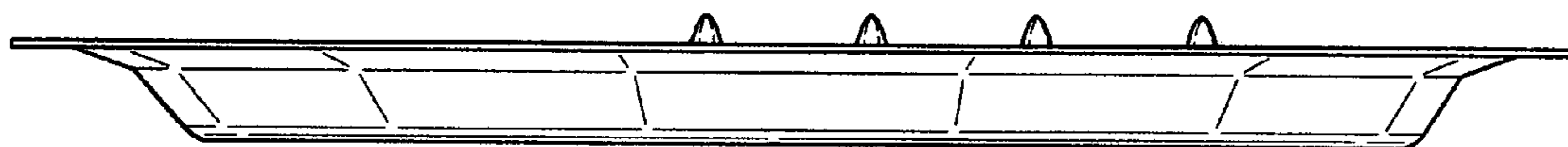

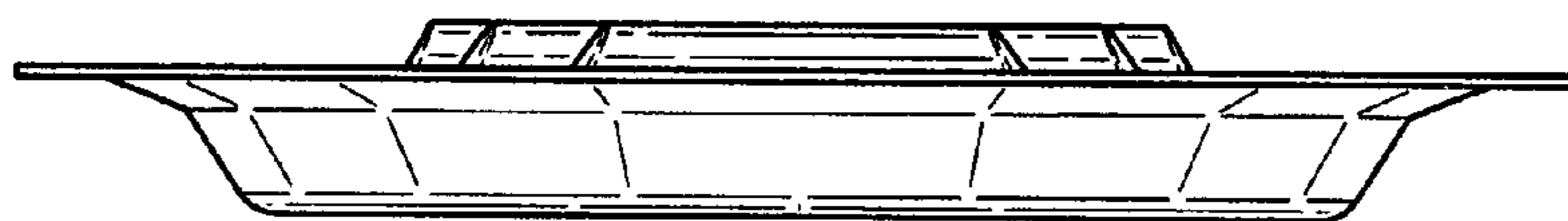

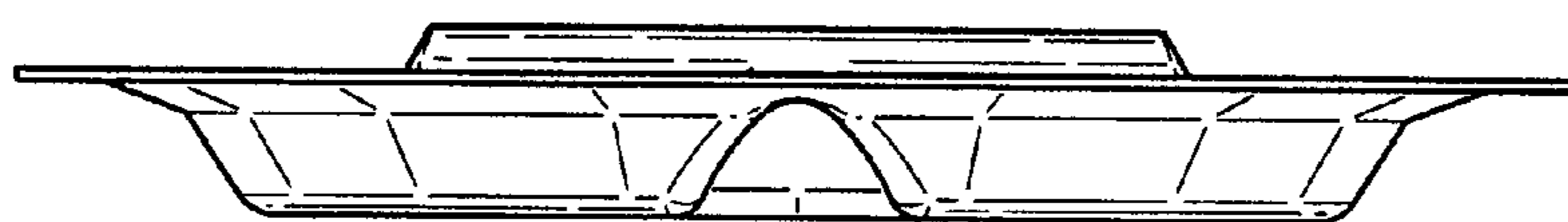

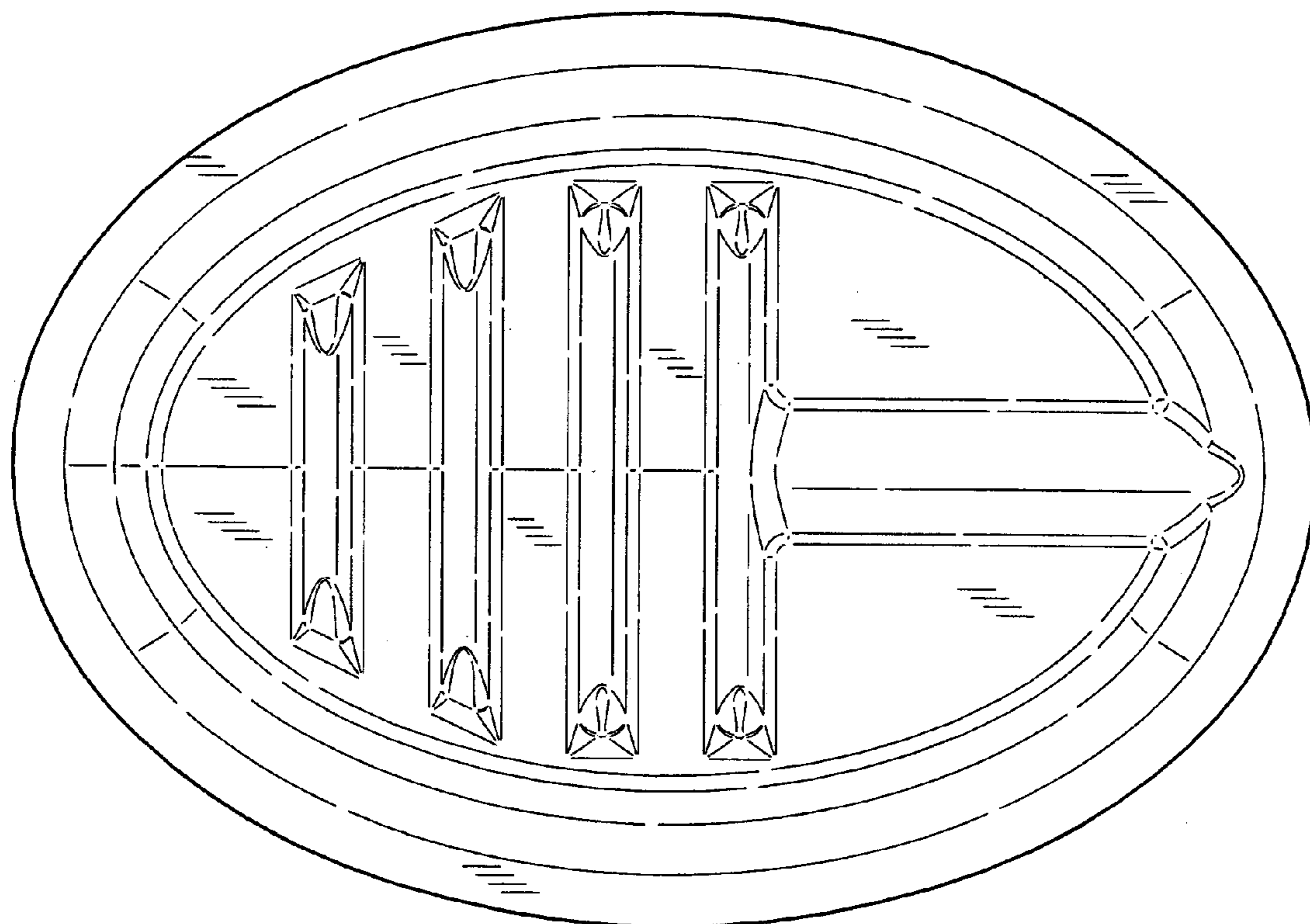

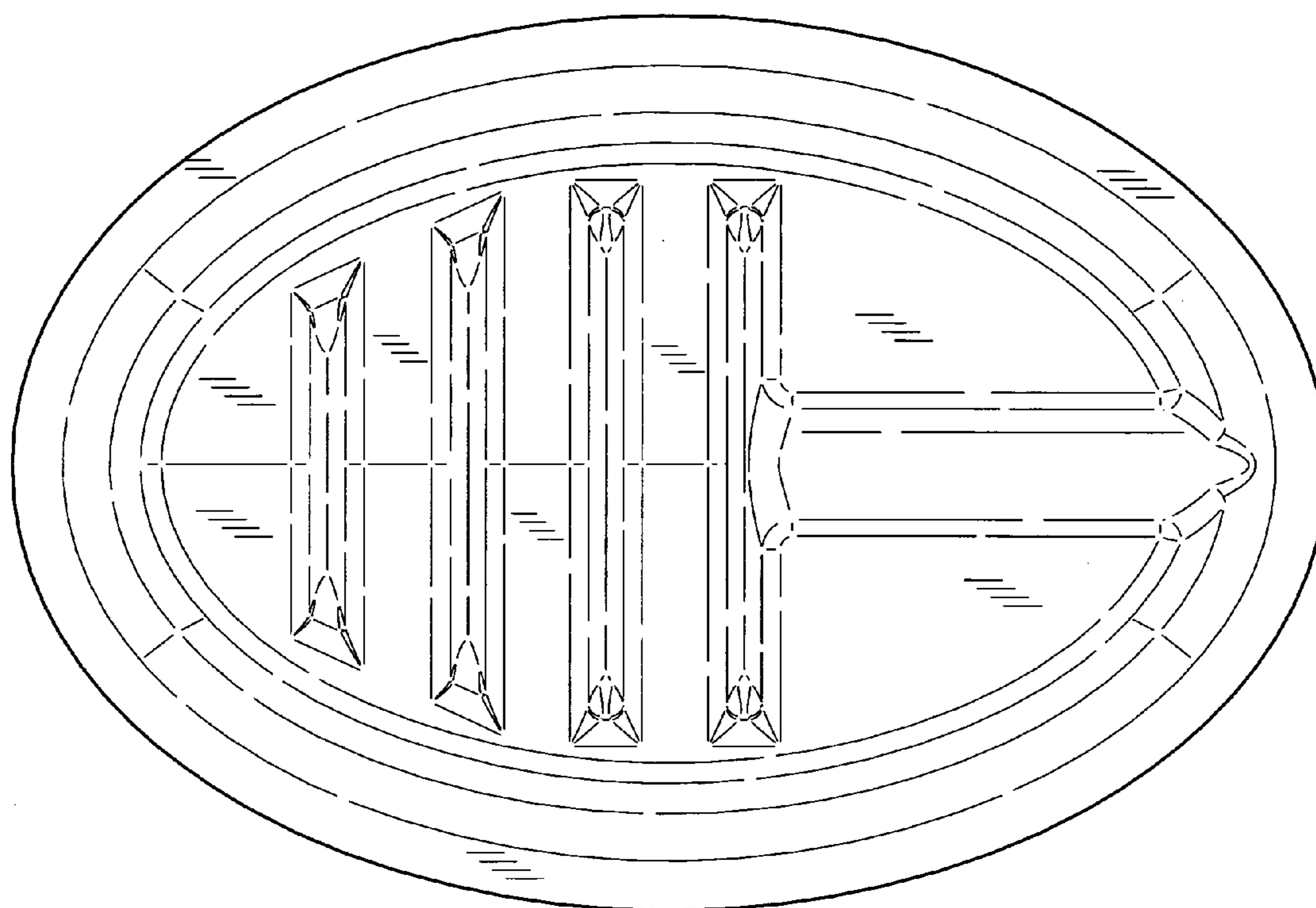
