FIG. 14 is a bottom view of the embodiment of FIG. 8.

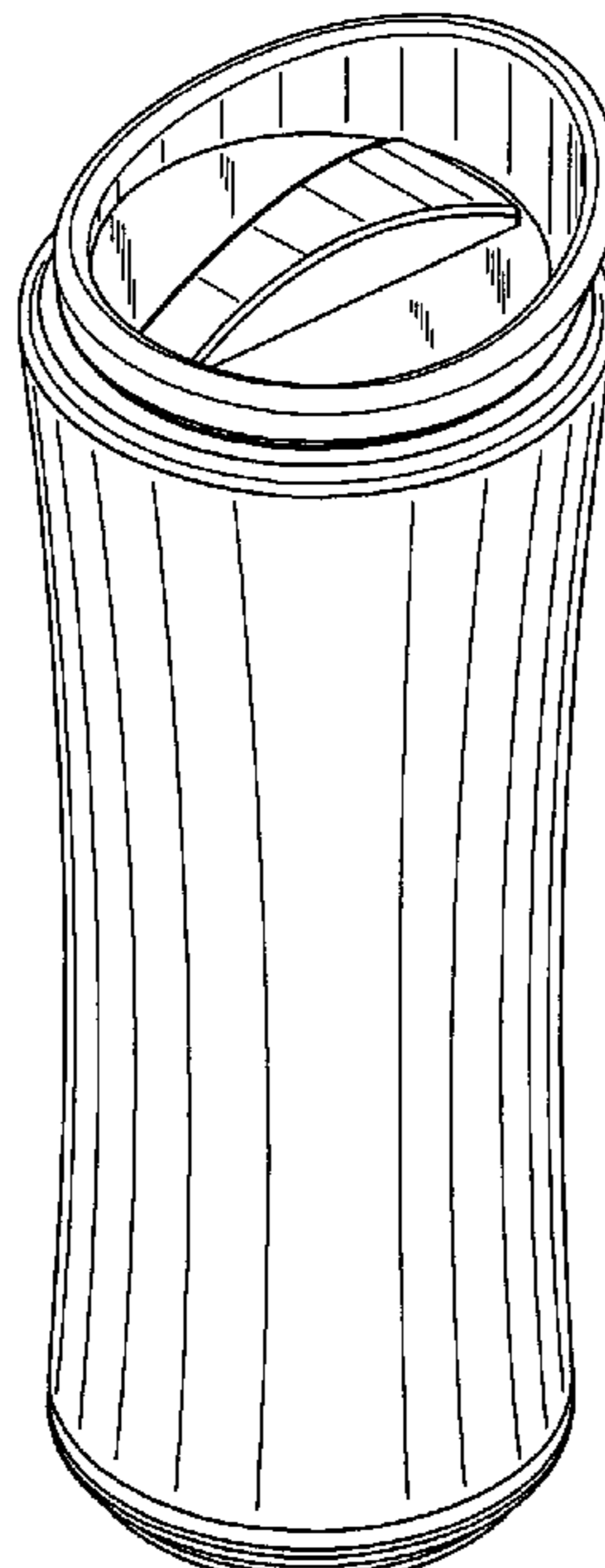

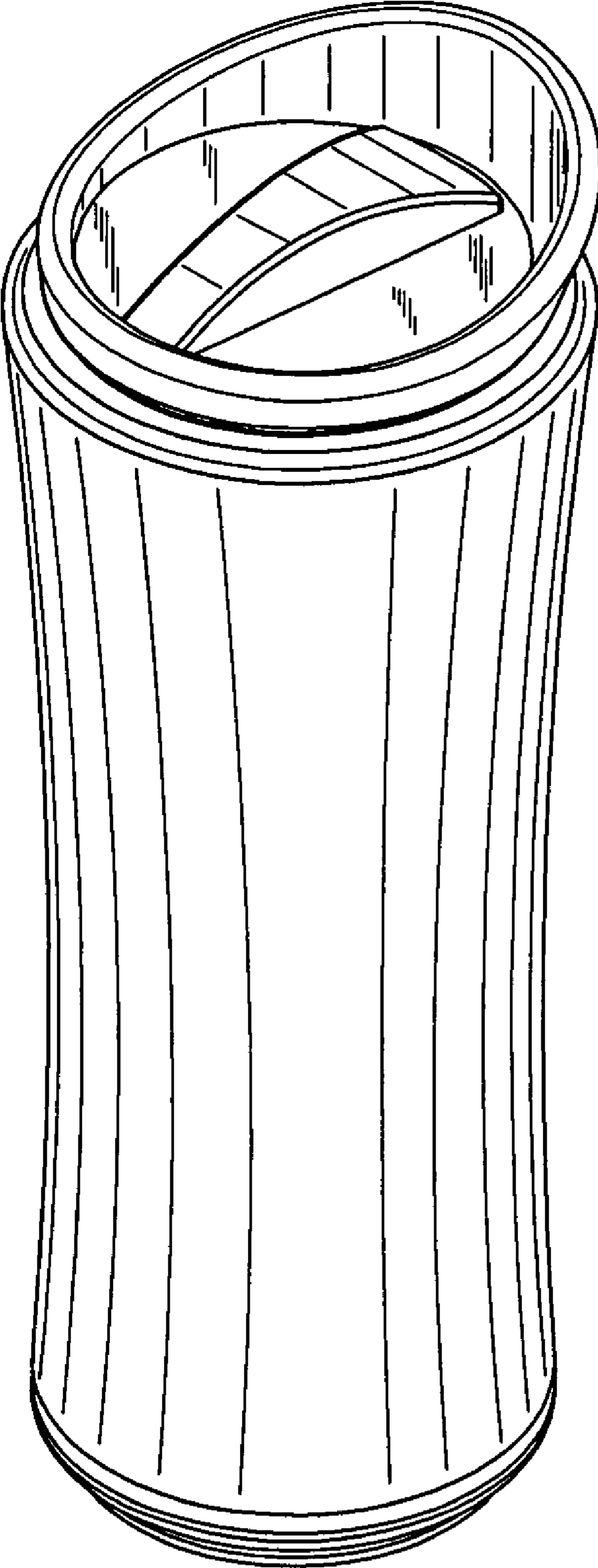

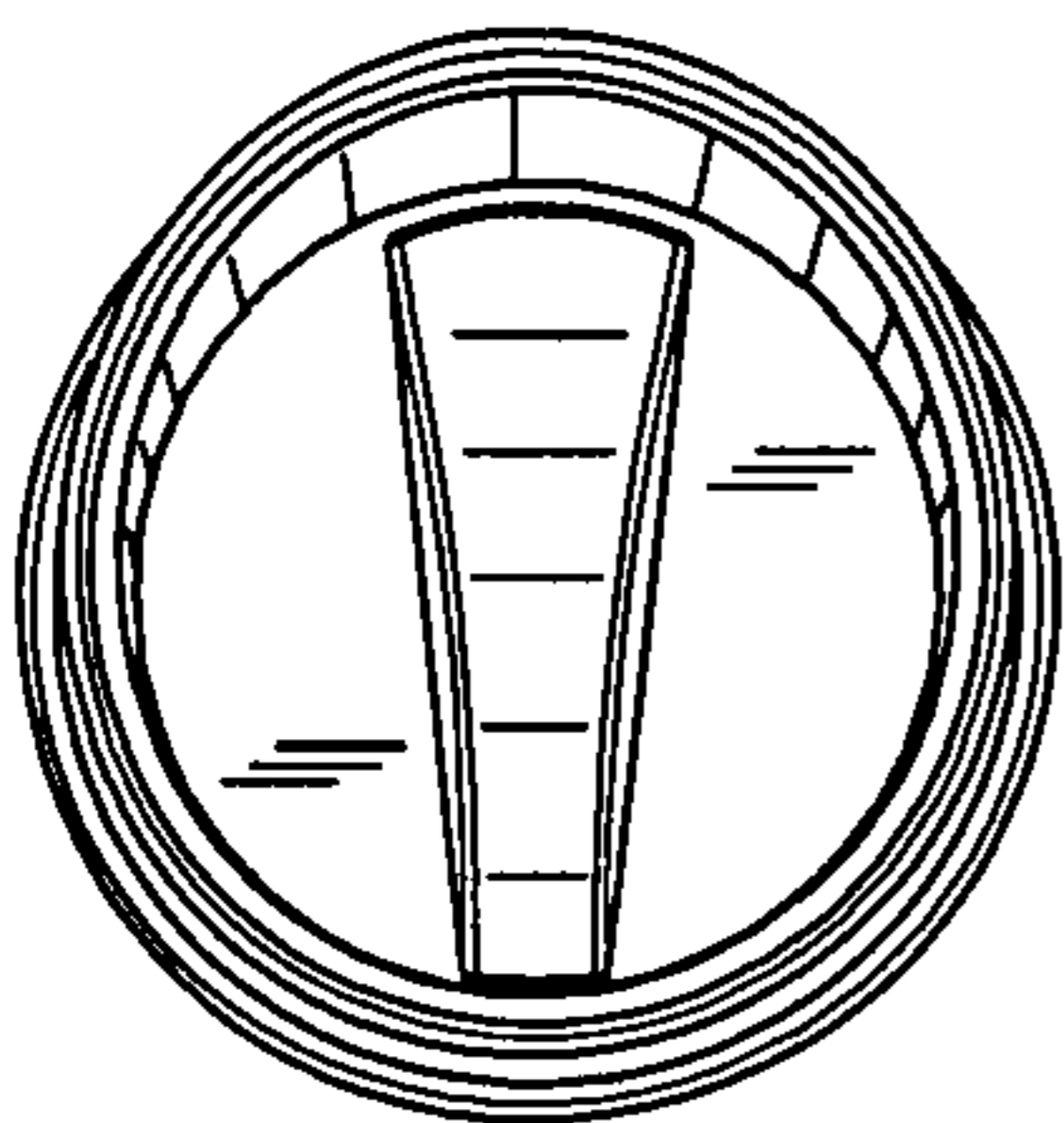

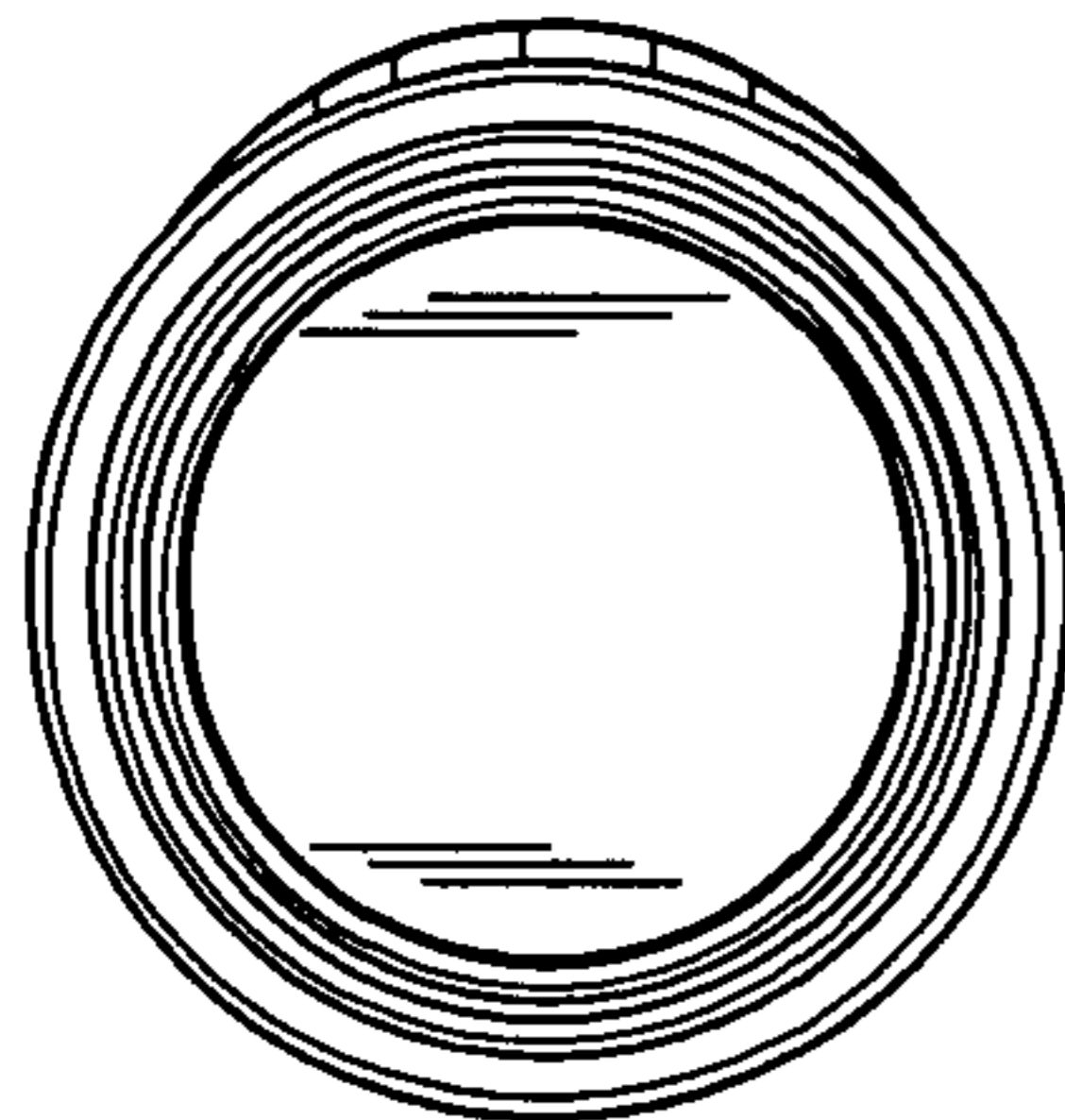

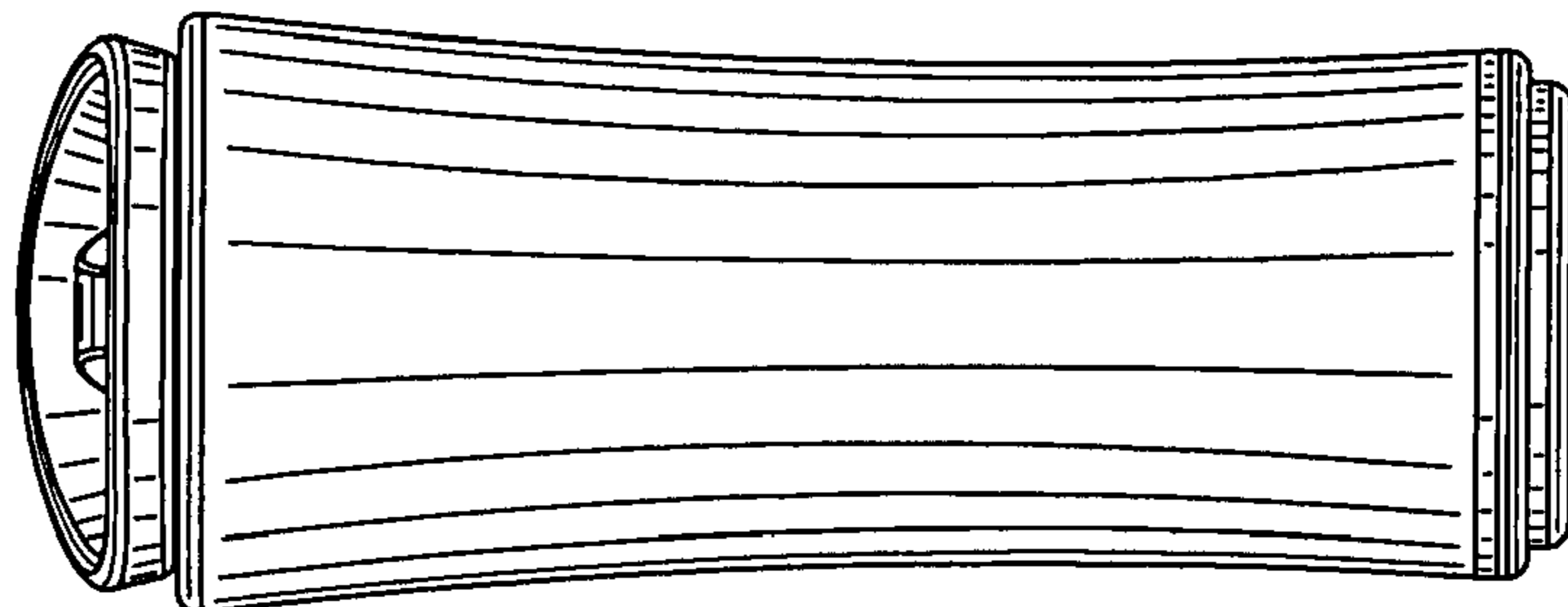

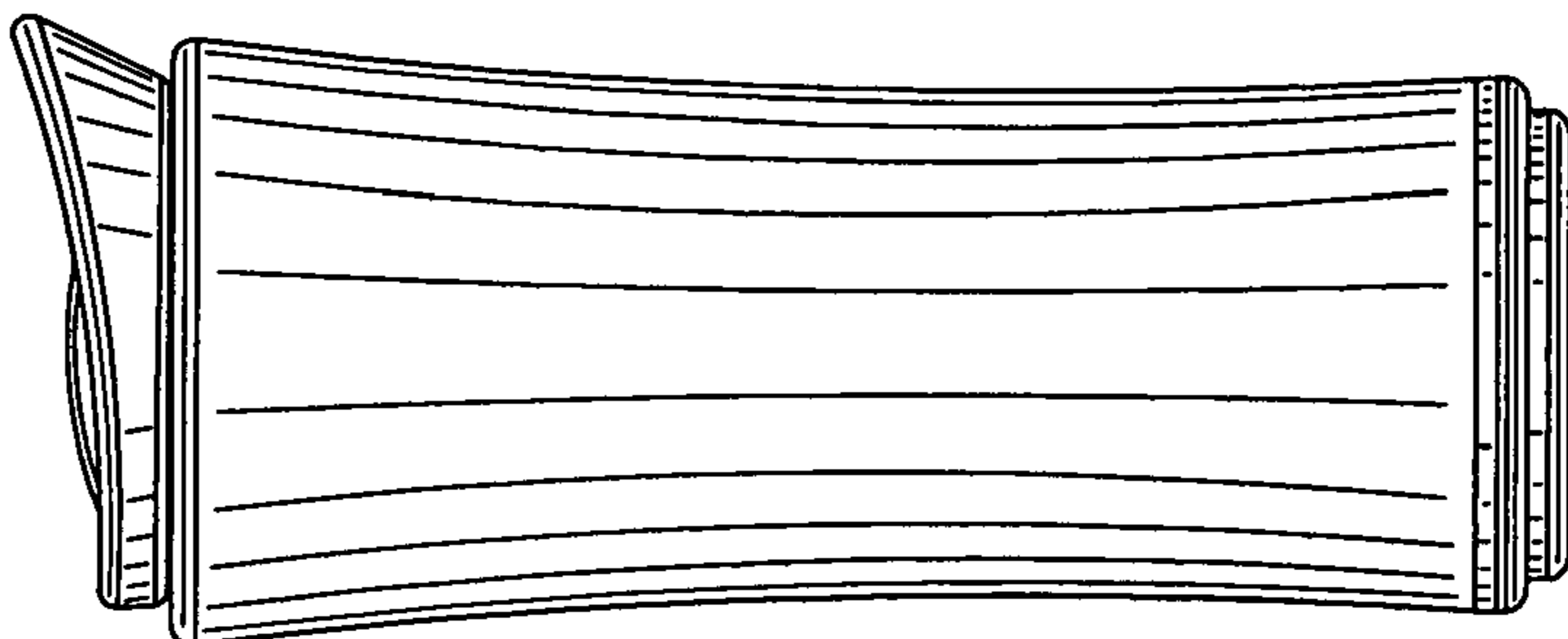

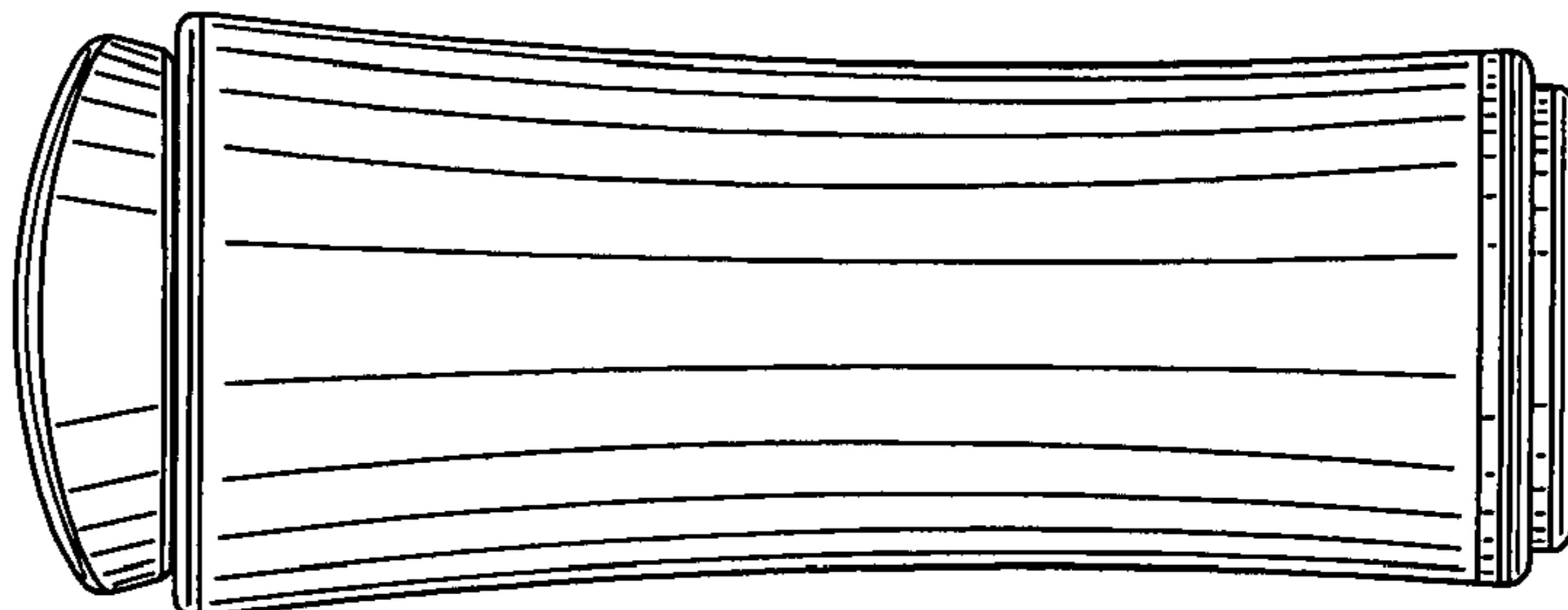

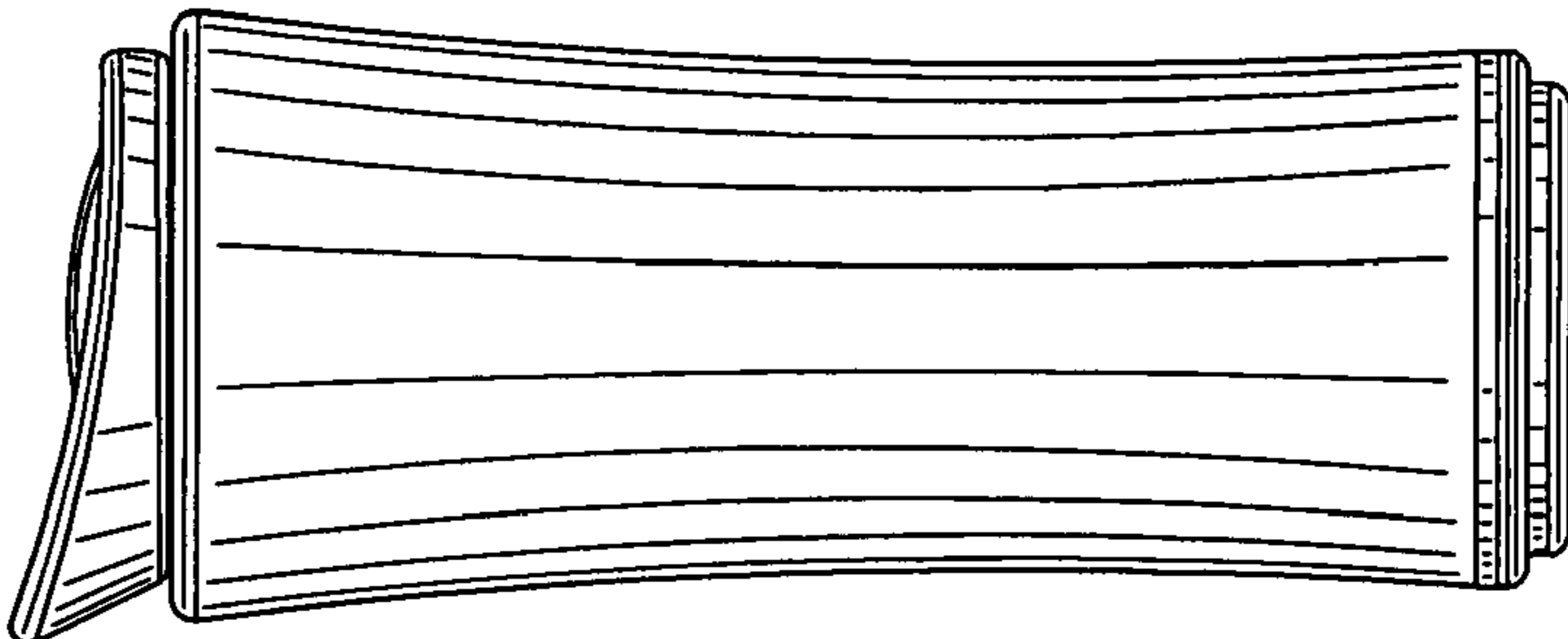

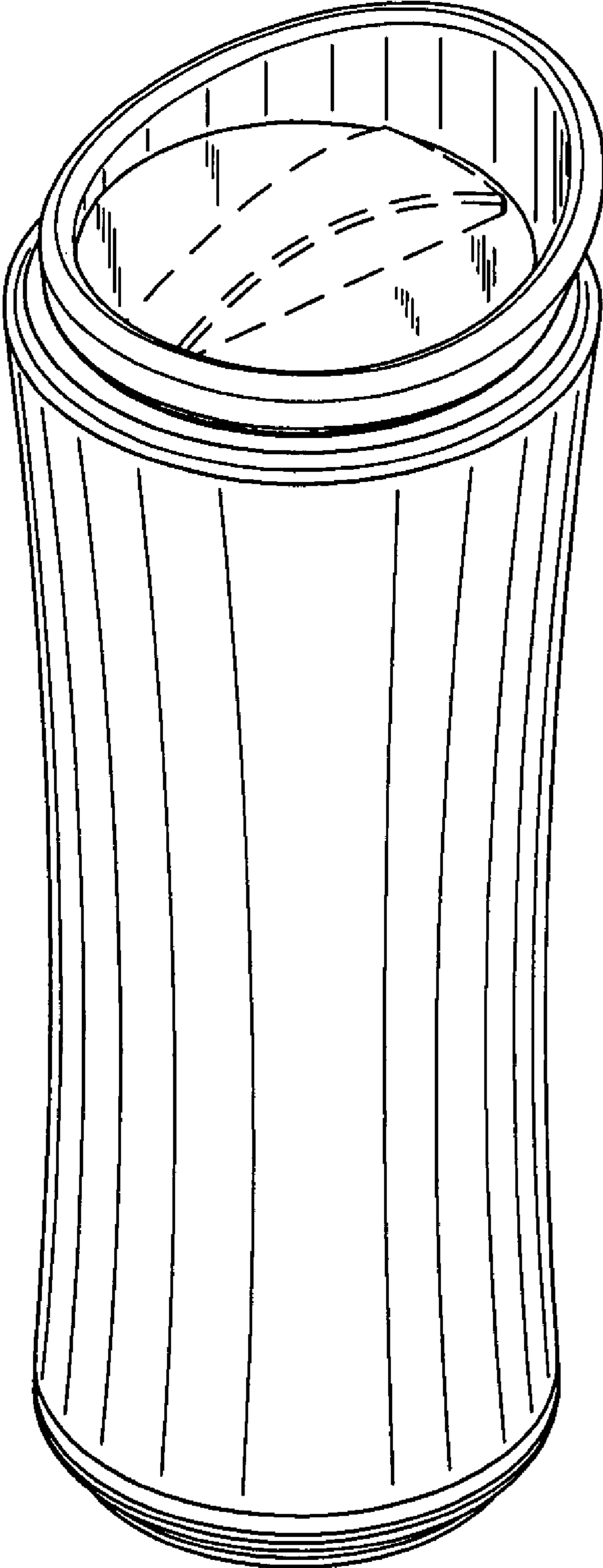

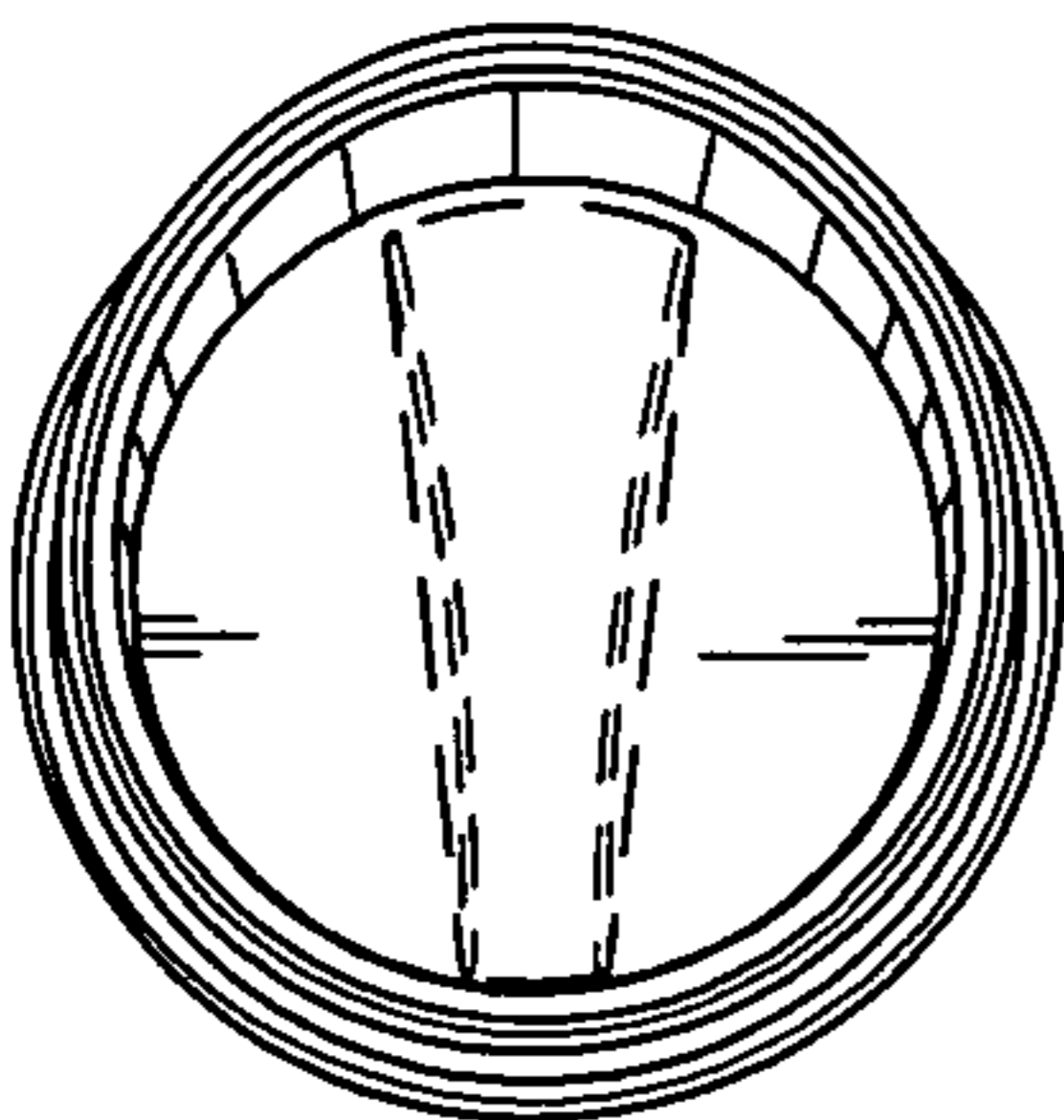

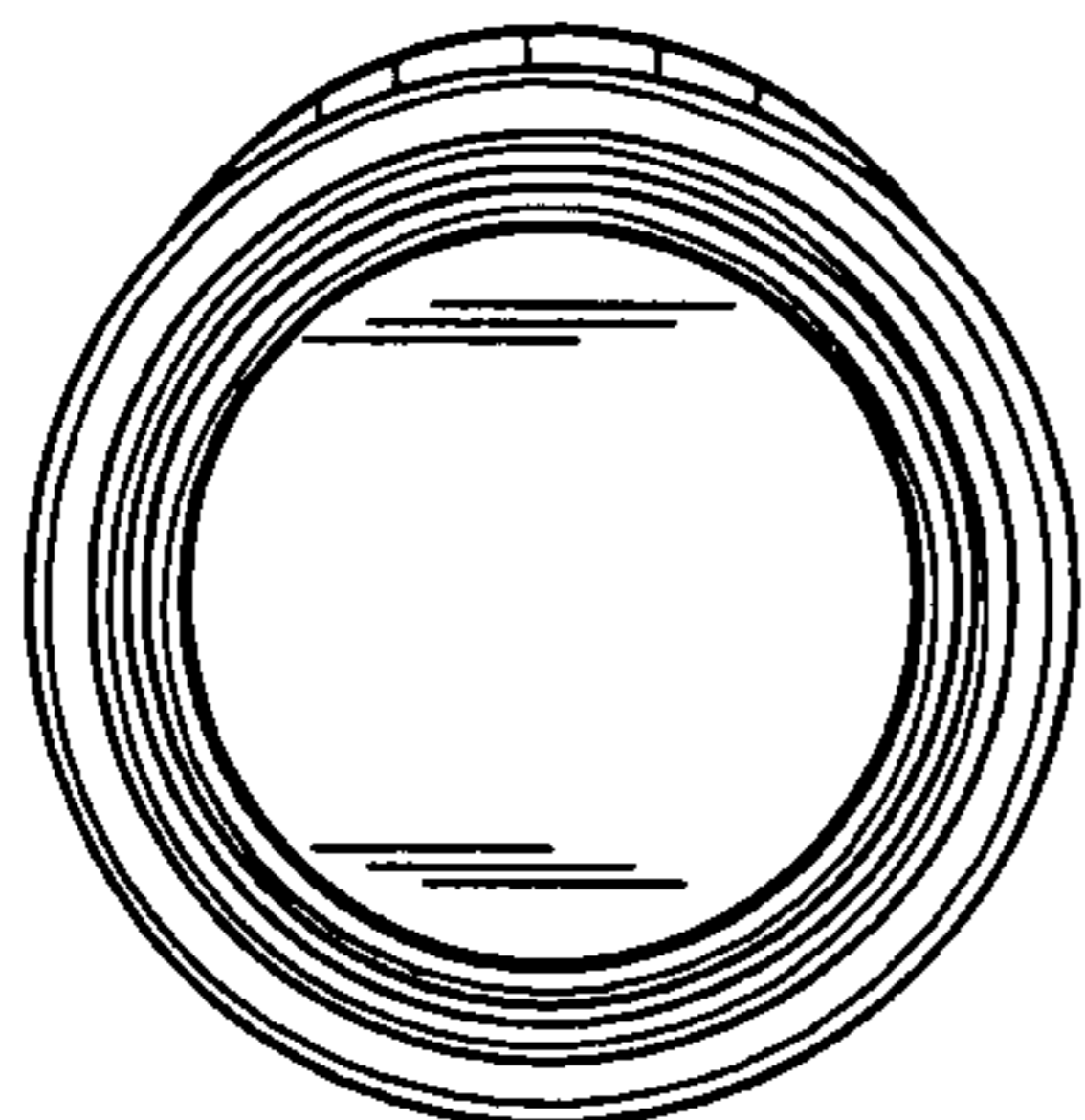

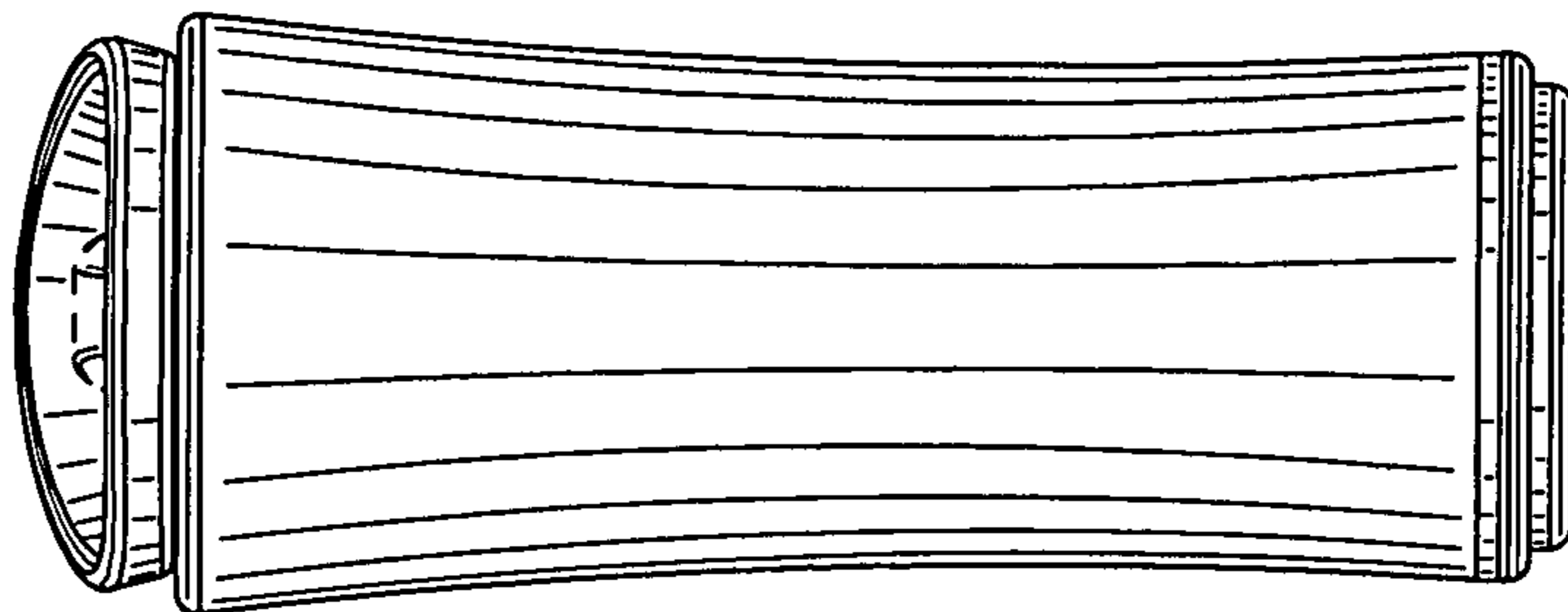

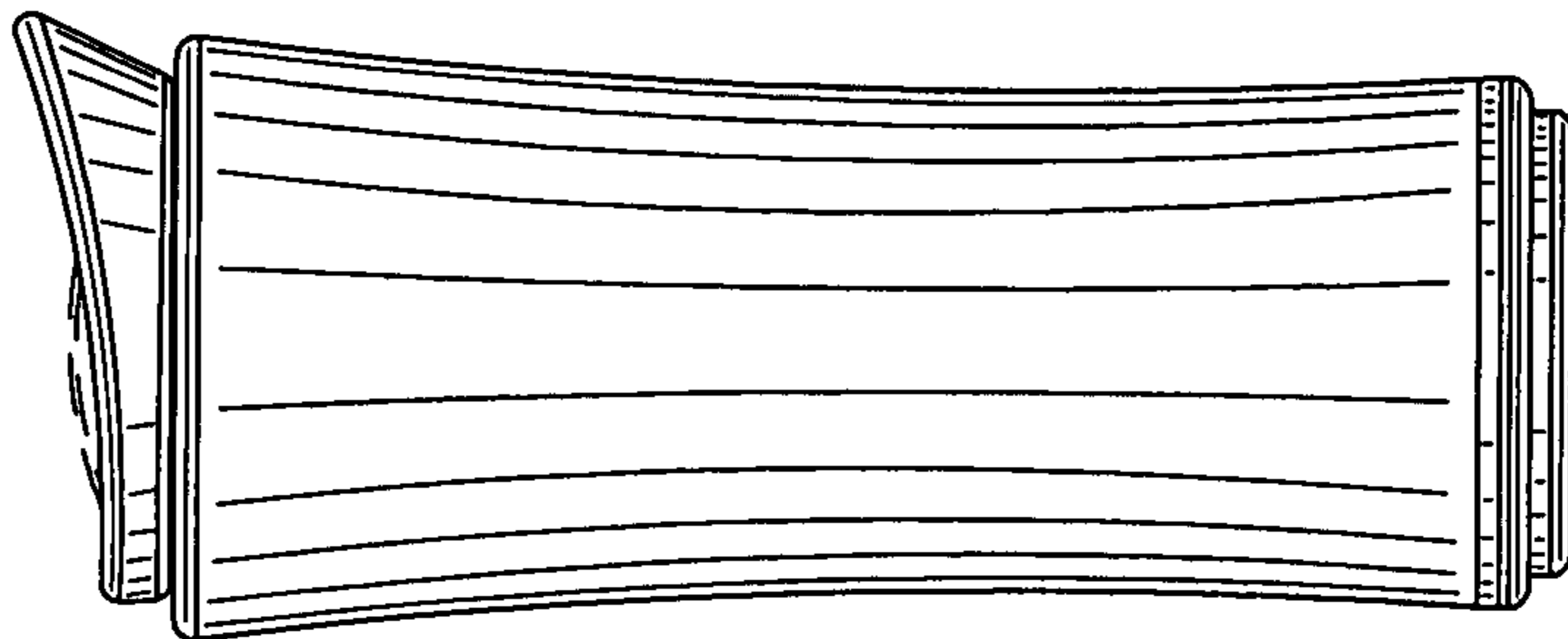

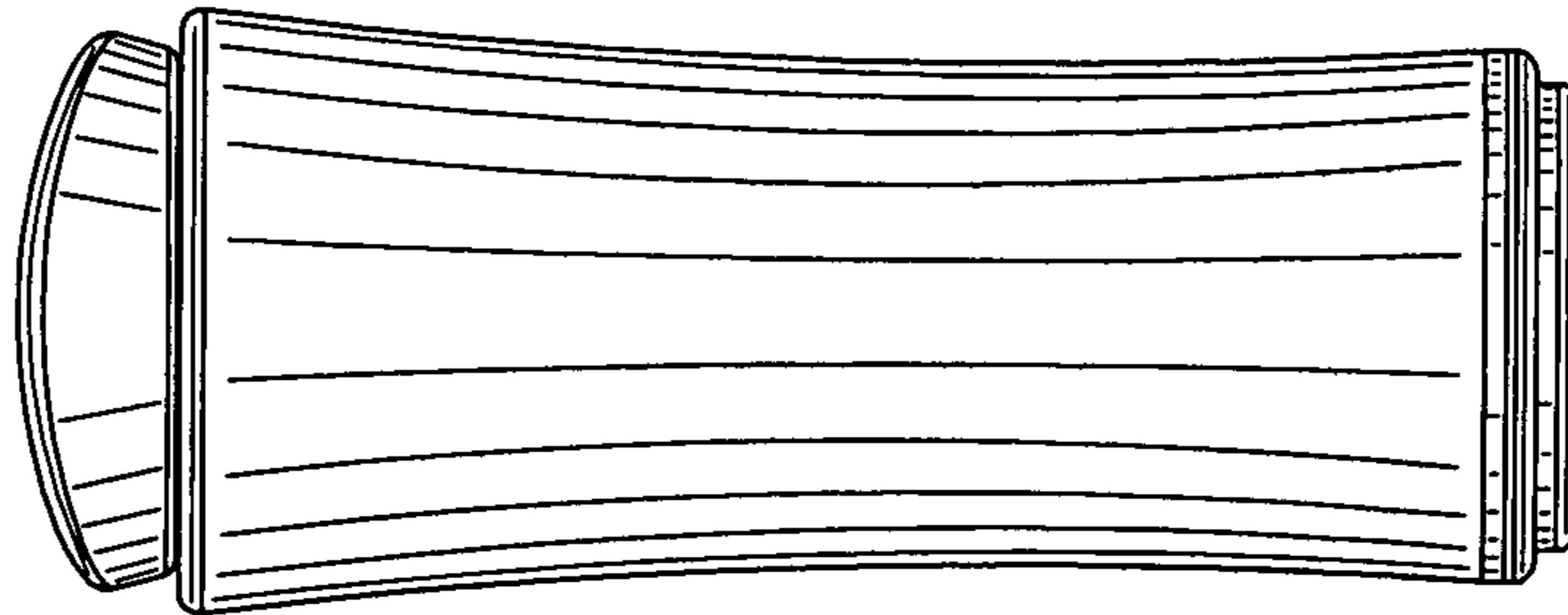

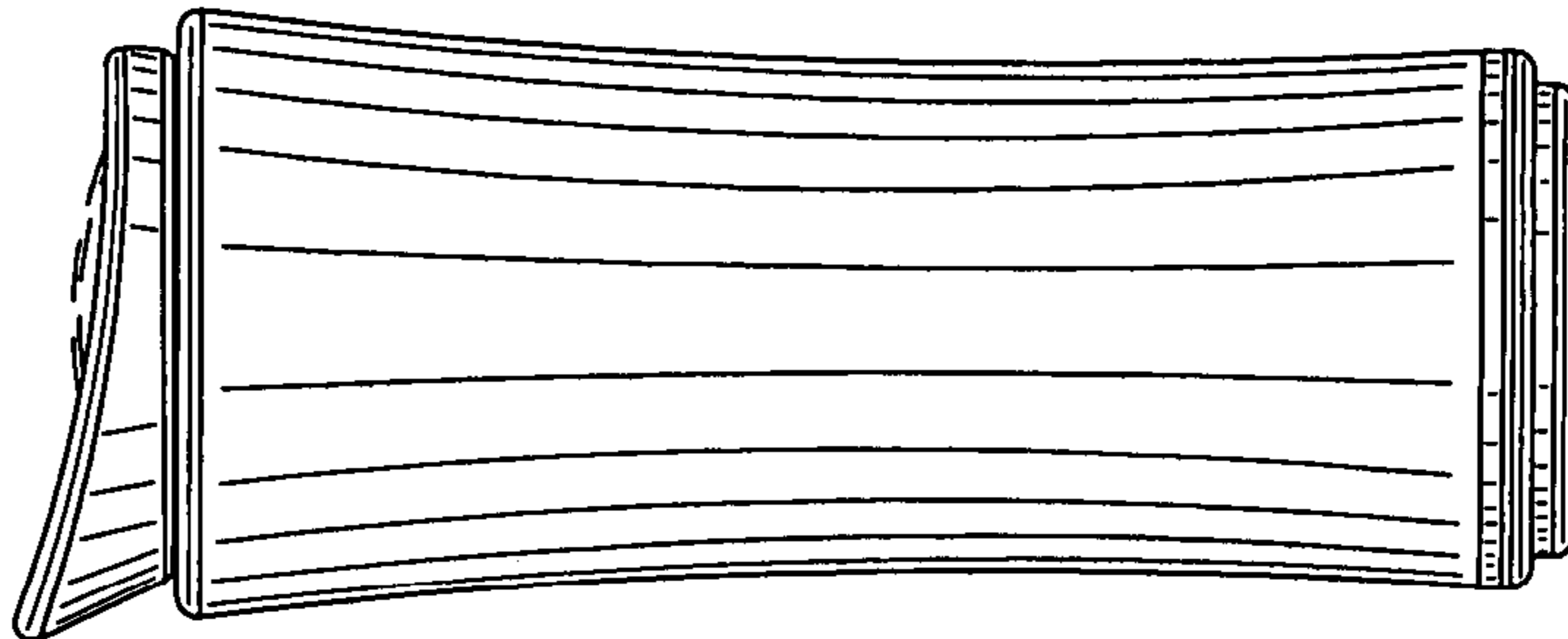
