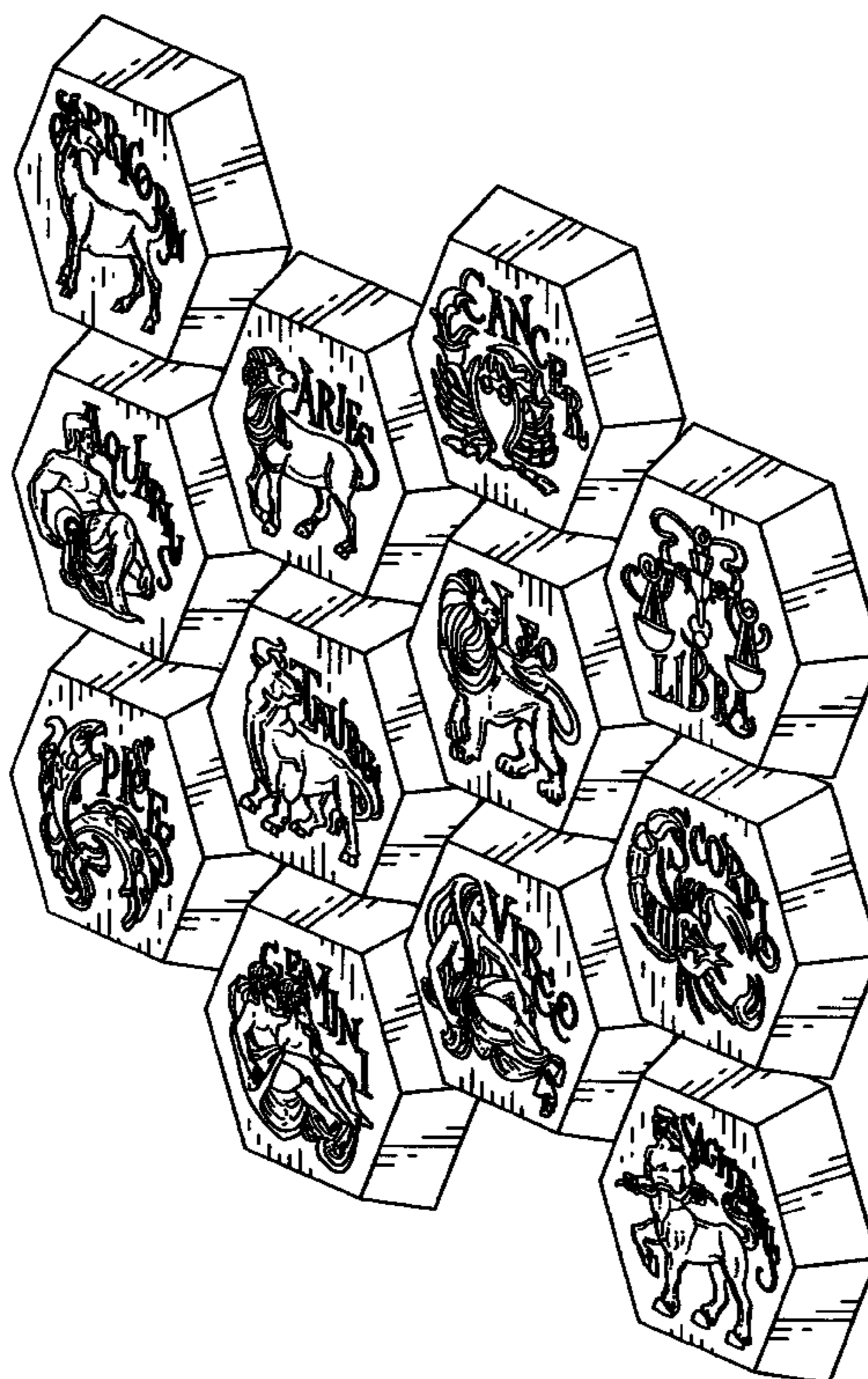
FIG. 5 is an end view of FIG. 2 as seen from the left side thereof;

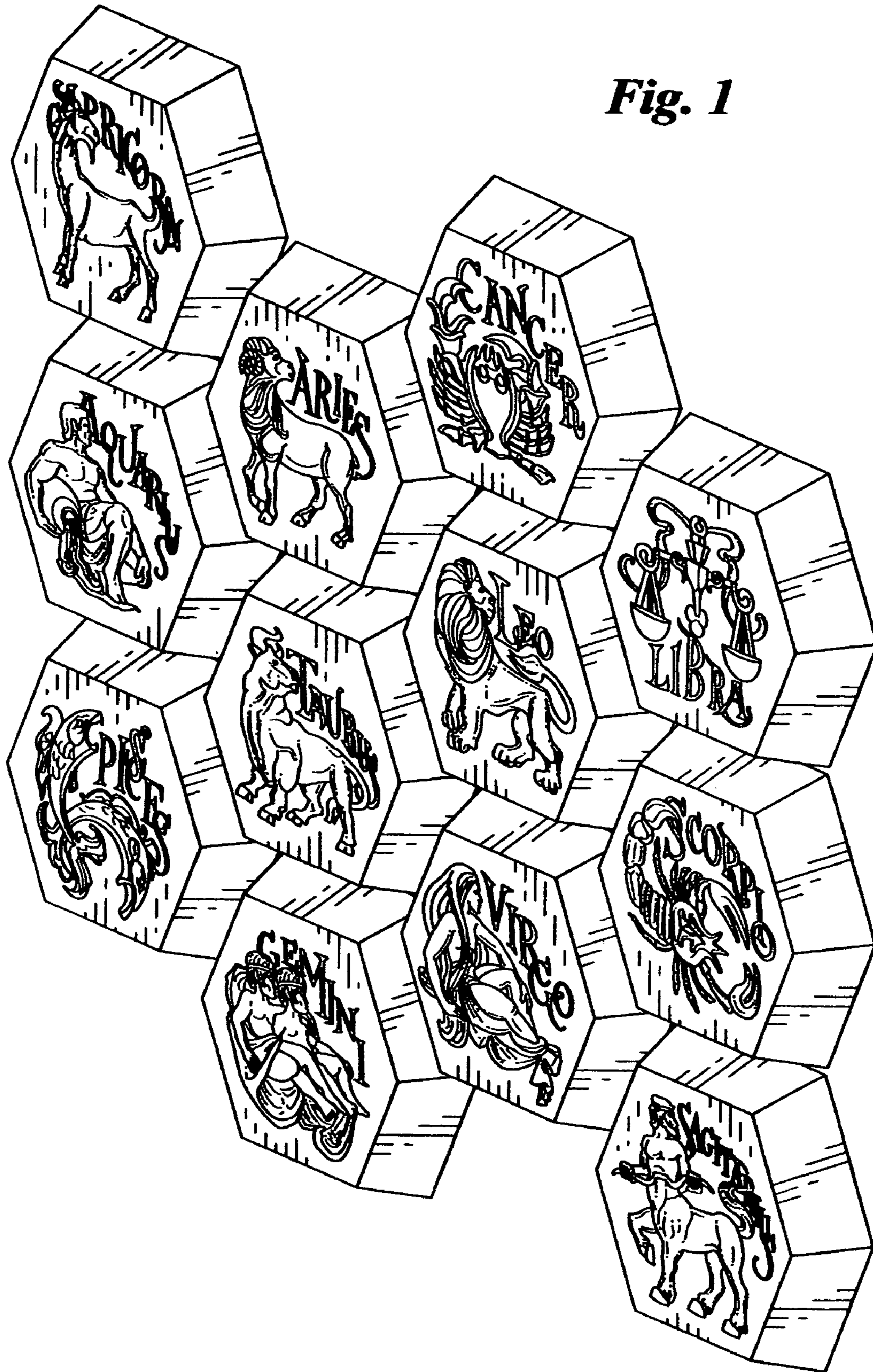
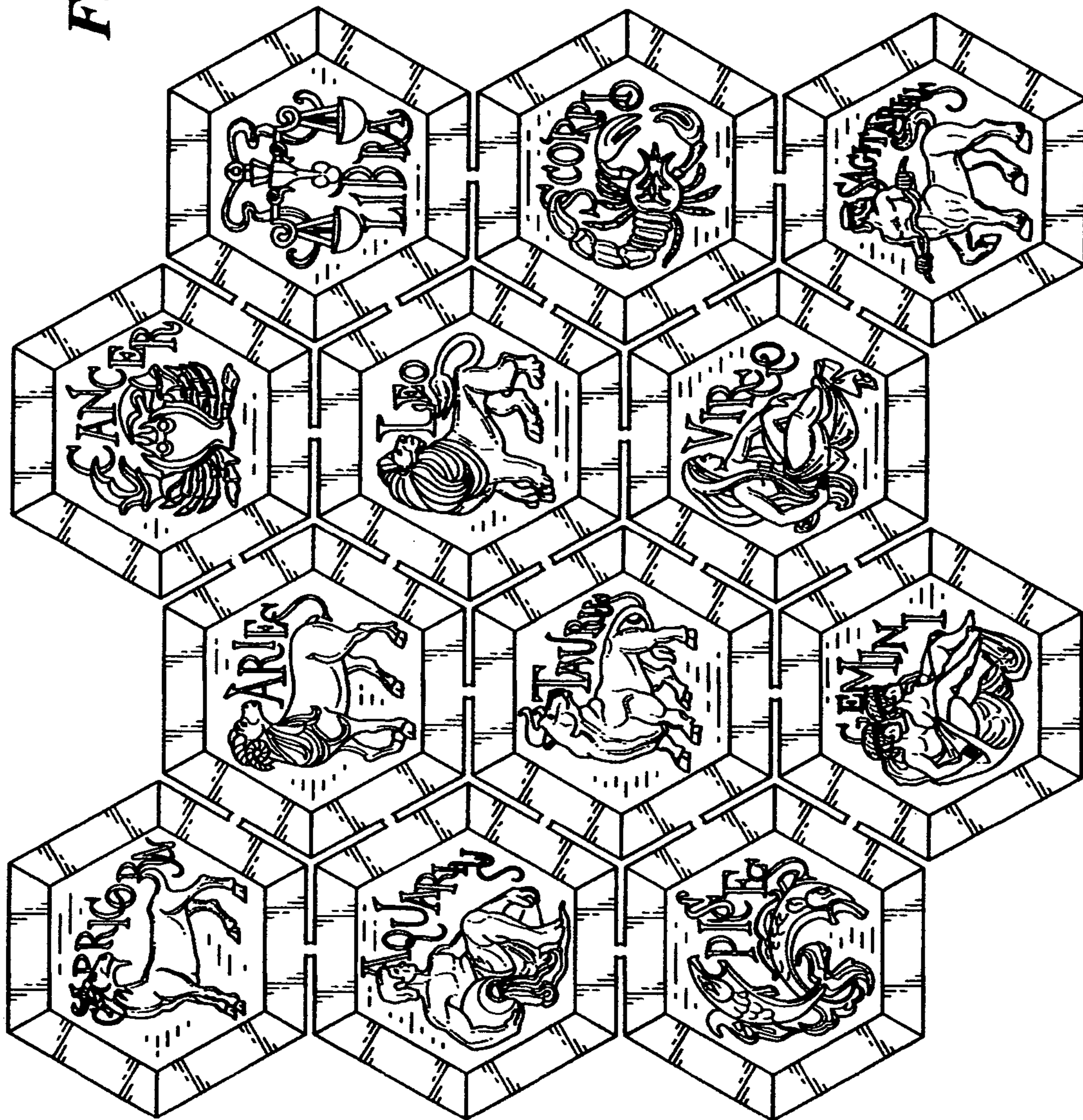

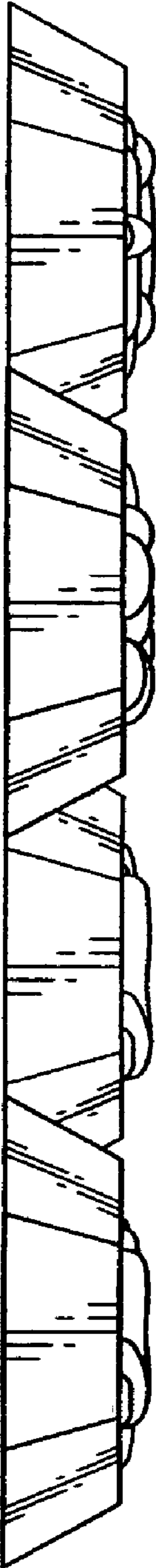

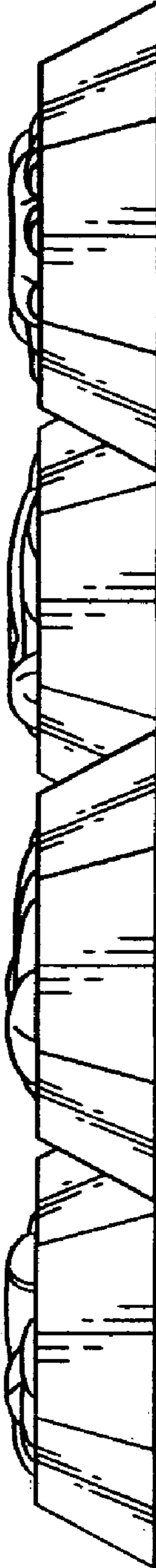

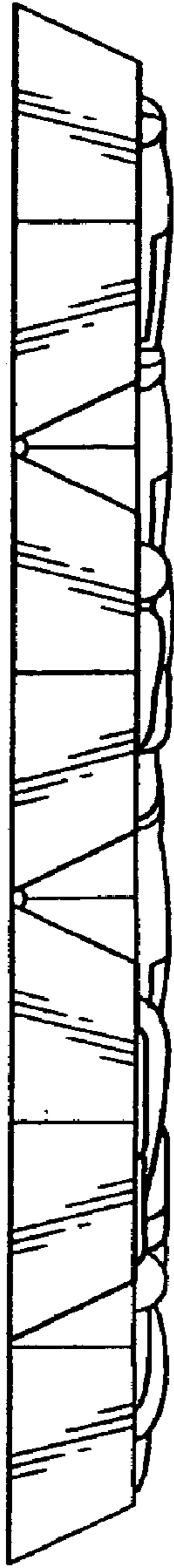

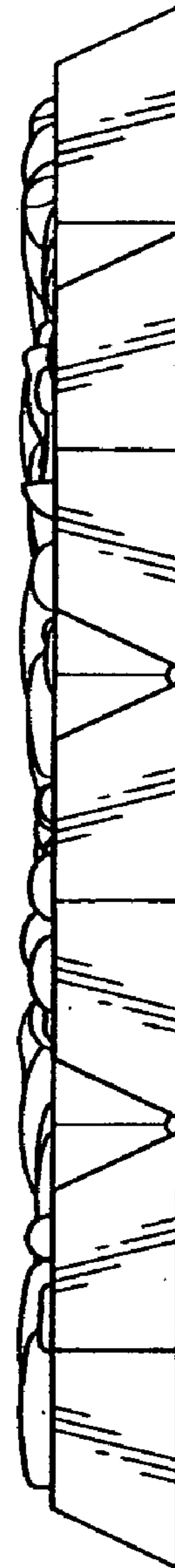

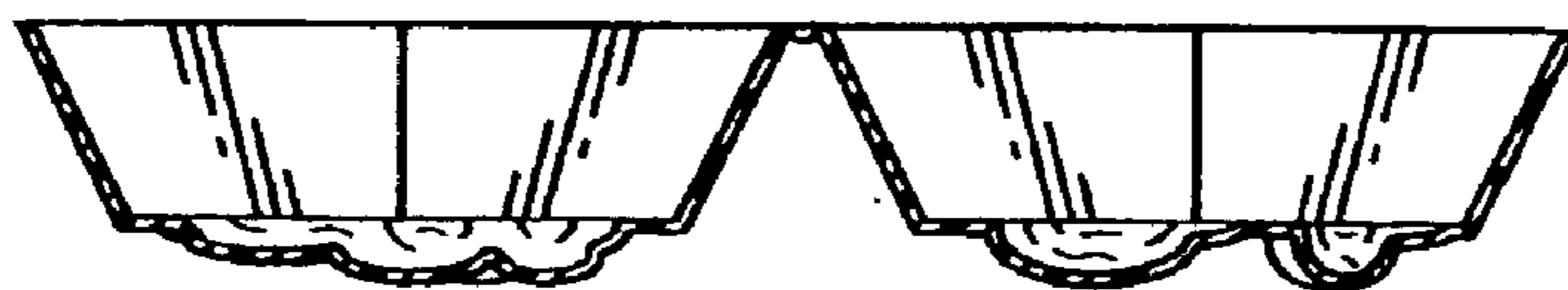

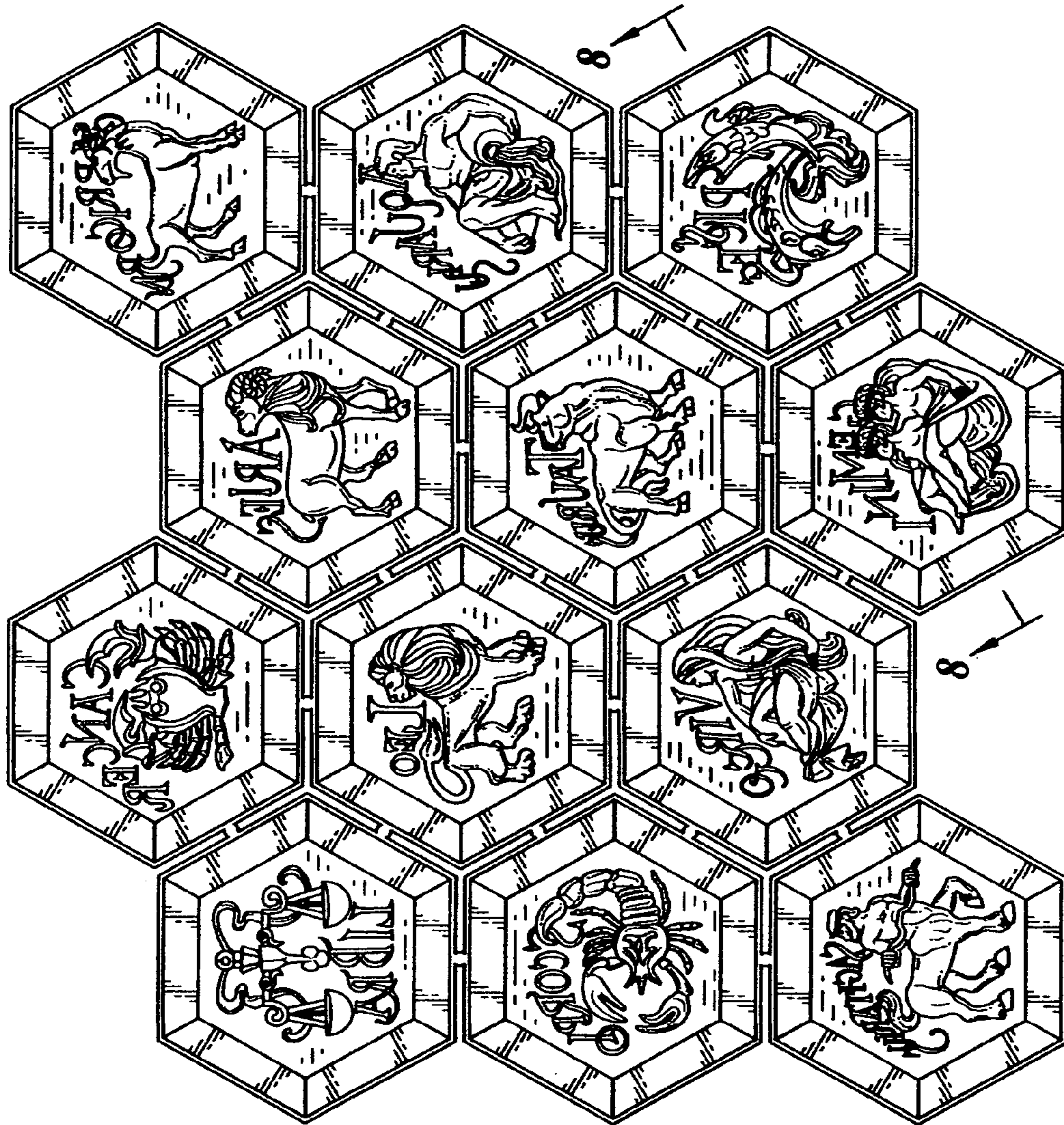
