dispenser in accordance with our design;

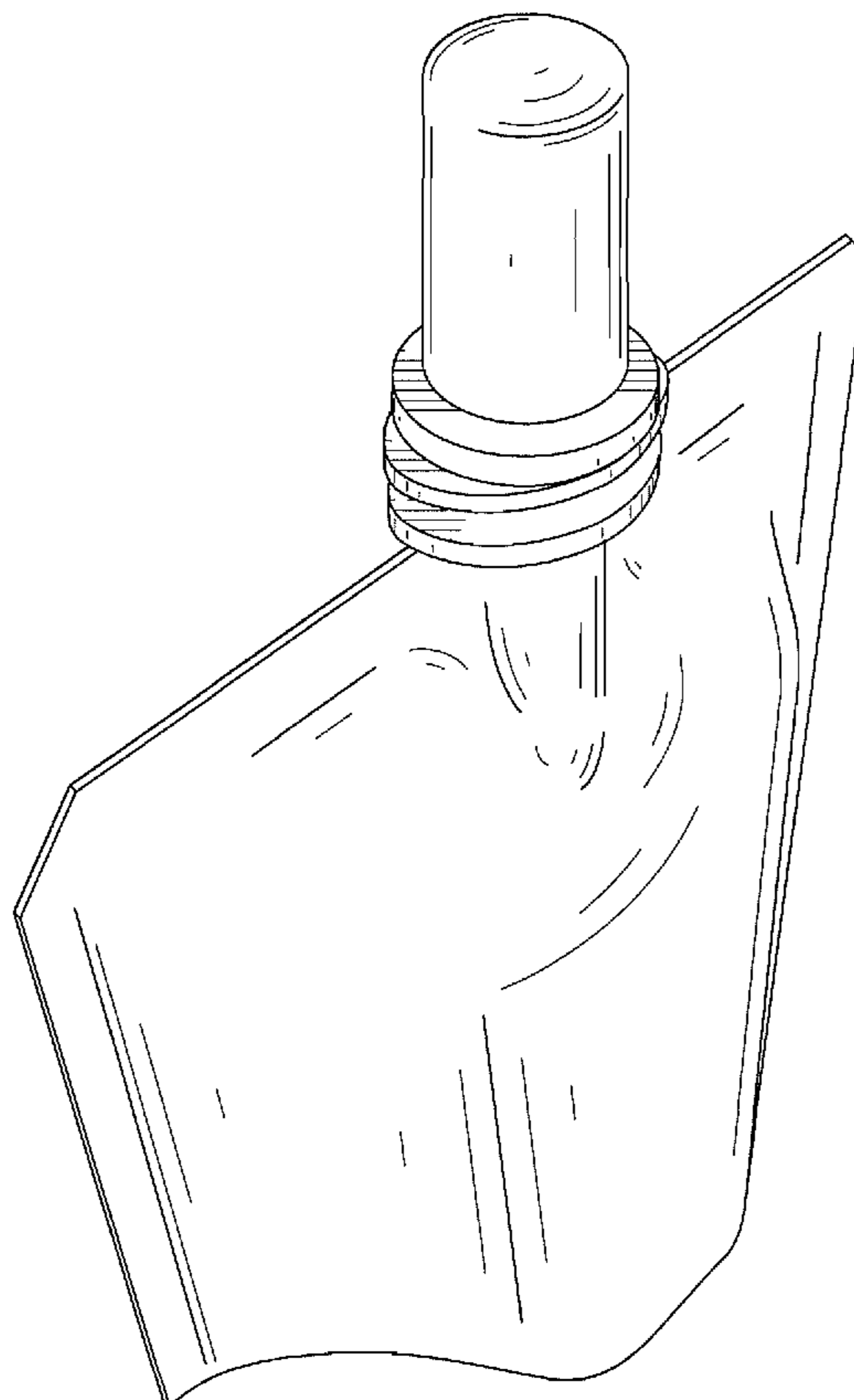
FIG. 2 is a front elevational view thereof, the rear elevational

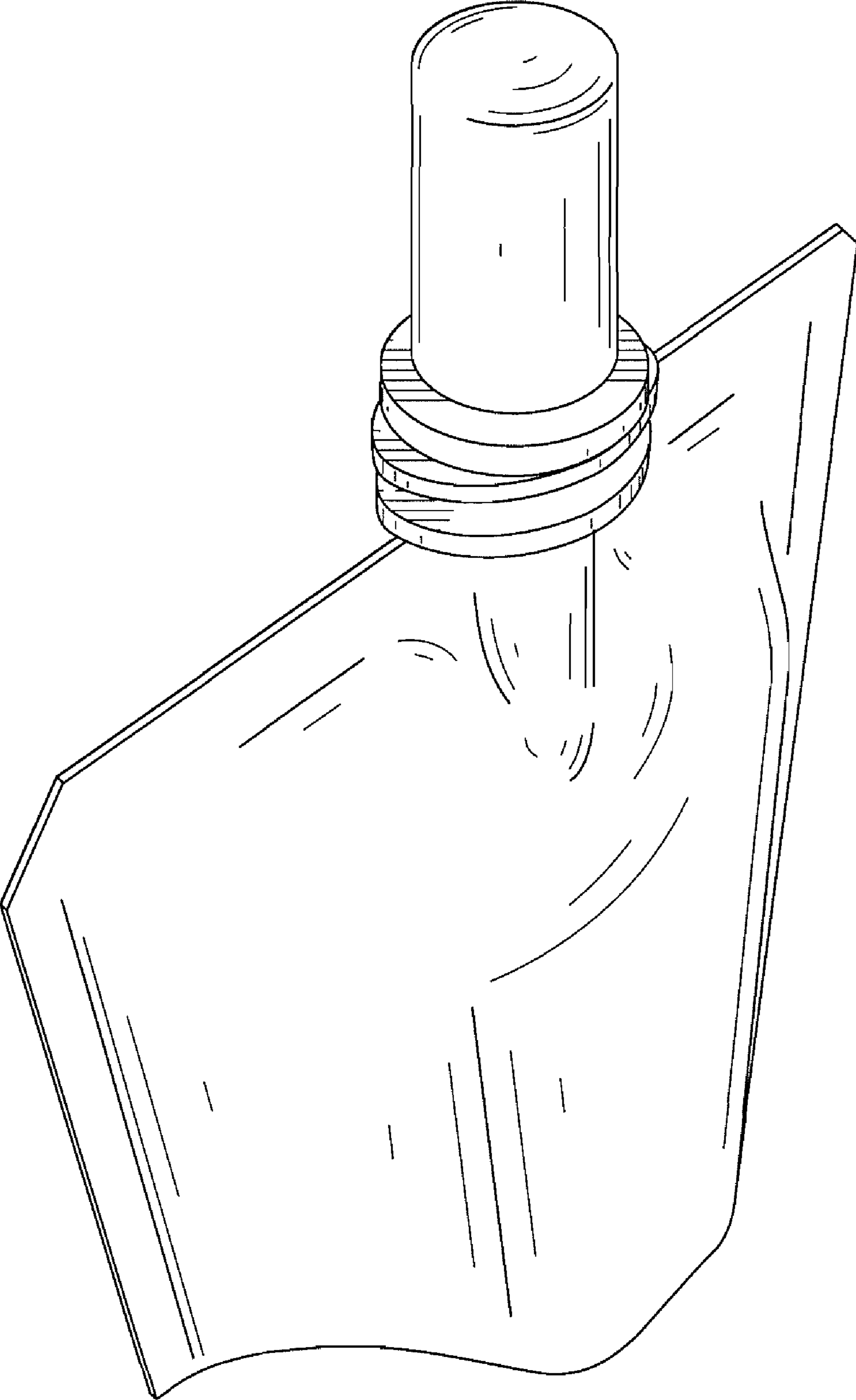

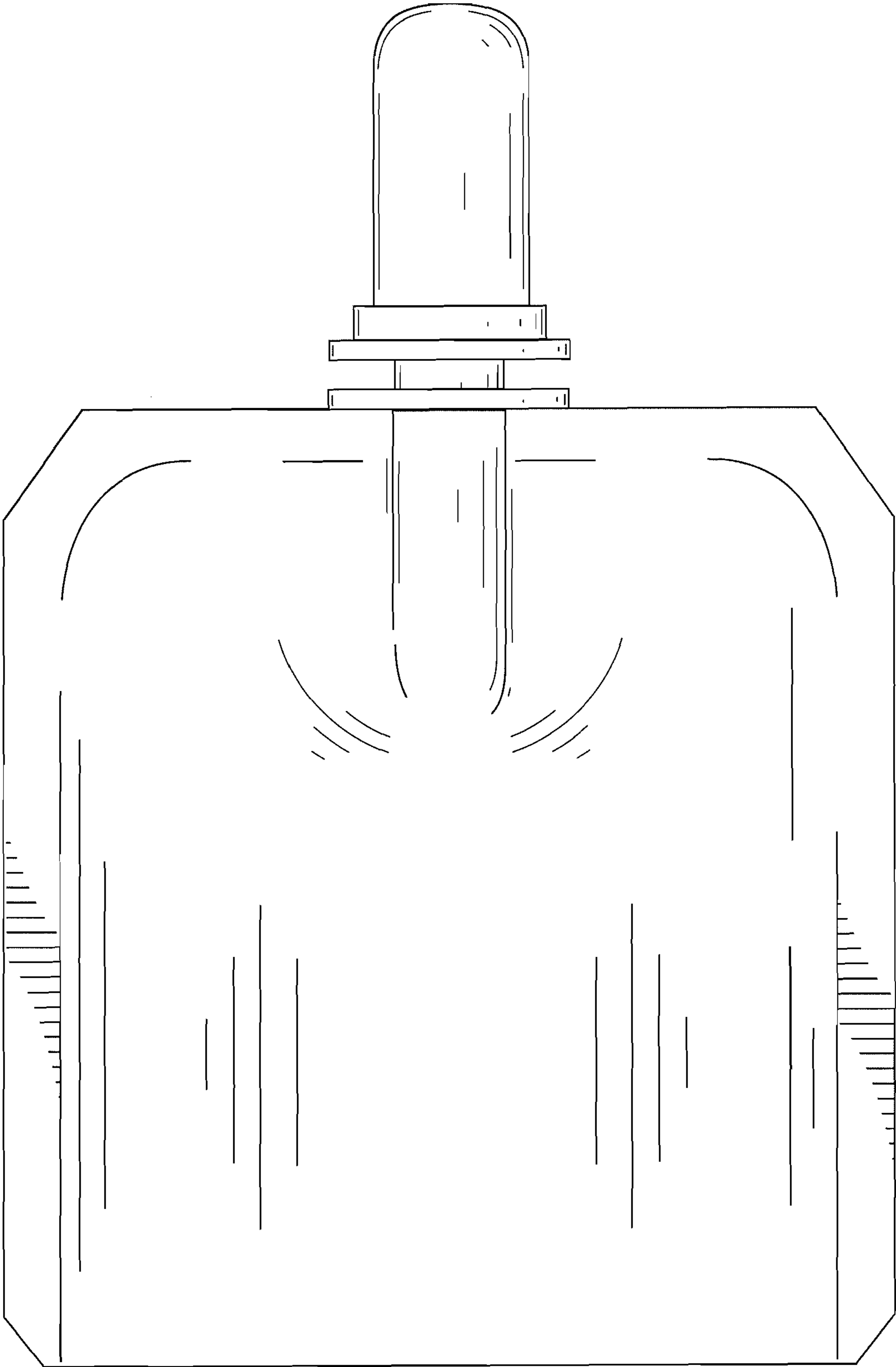

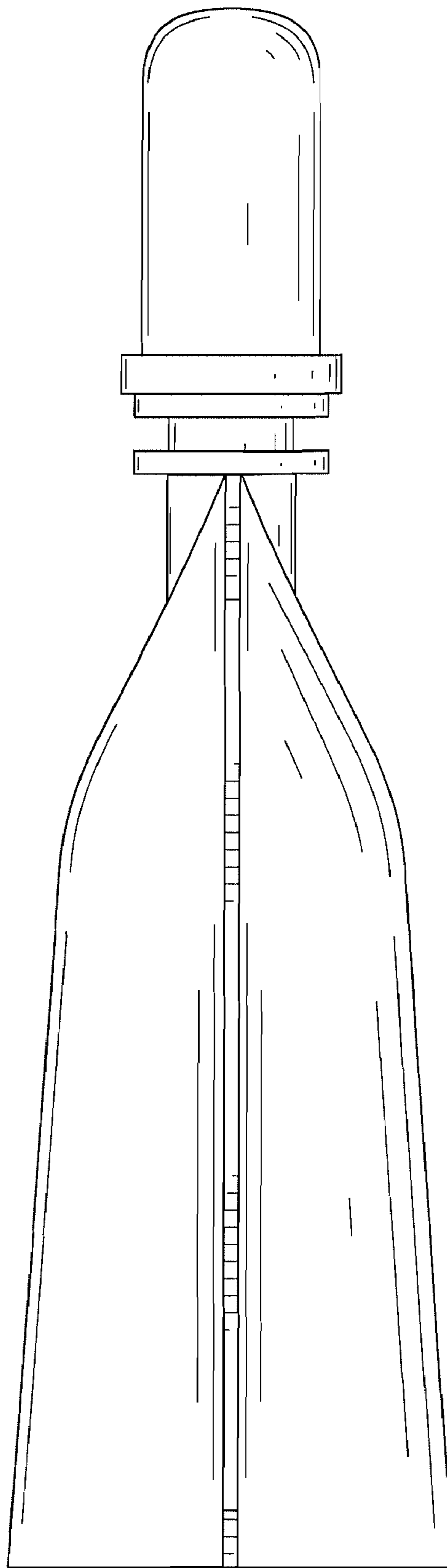

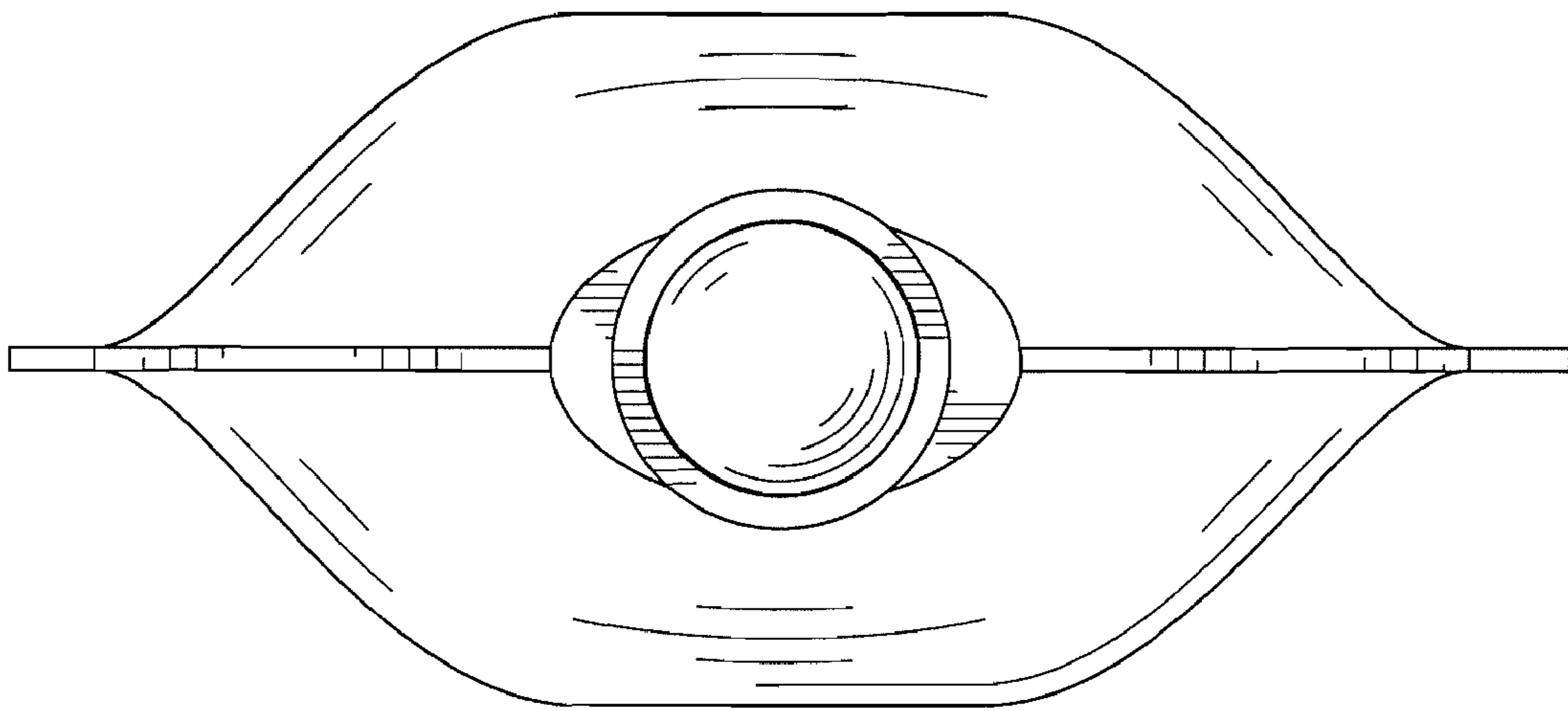

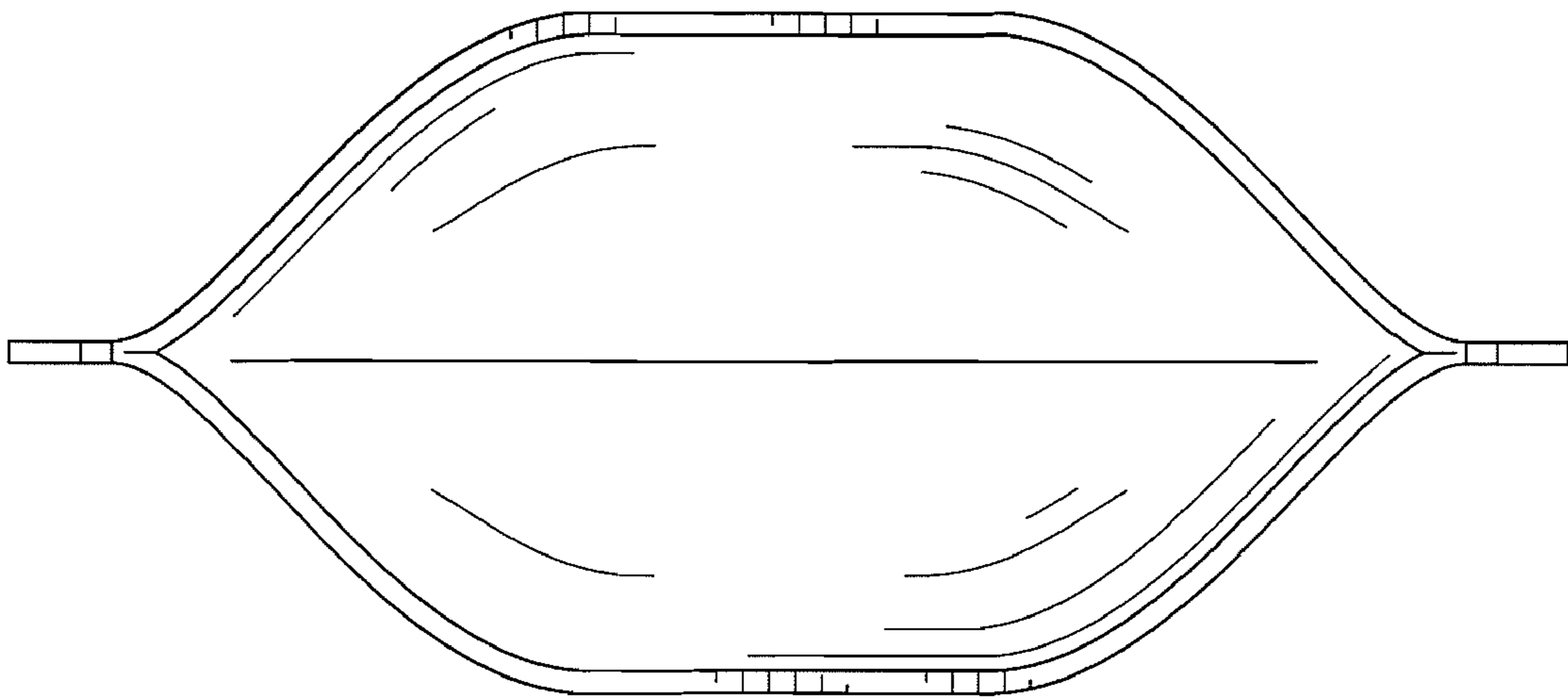
