(57) **CLAIM**

The ornamental design for a combined watch and bracelet, as shown and described.

DESCRIPTION

FIG. 1 is a top view of my new combined watch and bracelet design;

FIG. 2 is a bottom view thereof;

FIG. 3 is a top and right side perspective view thereof;

FIG. 4 is a top and left side perspective view of the combined watch and bracelet shown with a portion of the watch being separated from a remaining portion;

FIG. 5 is a top and right side perspective view of the combined watch and bracelet shown with first and second portions of the watch being separated from the remaining portion;

FIG. 6 is a side view as seen from the right side of FIG. 1;

FIG. 7 is a side view as seen from the left side of FIG. 1;

FIG. 8 is a rear end view thereof; and,

FIG. 9 is a front end view thereof.

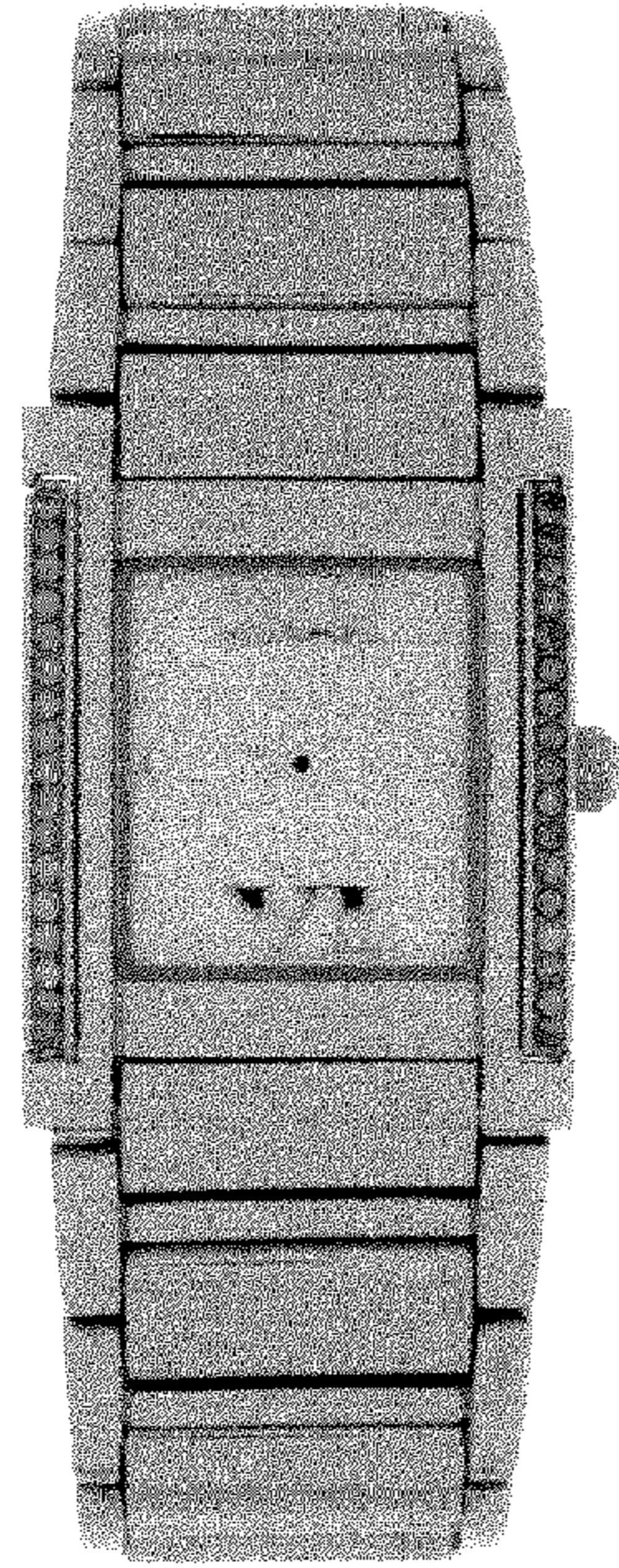

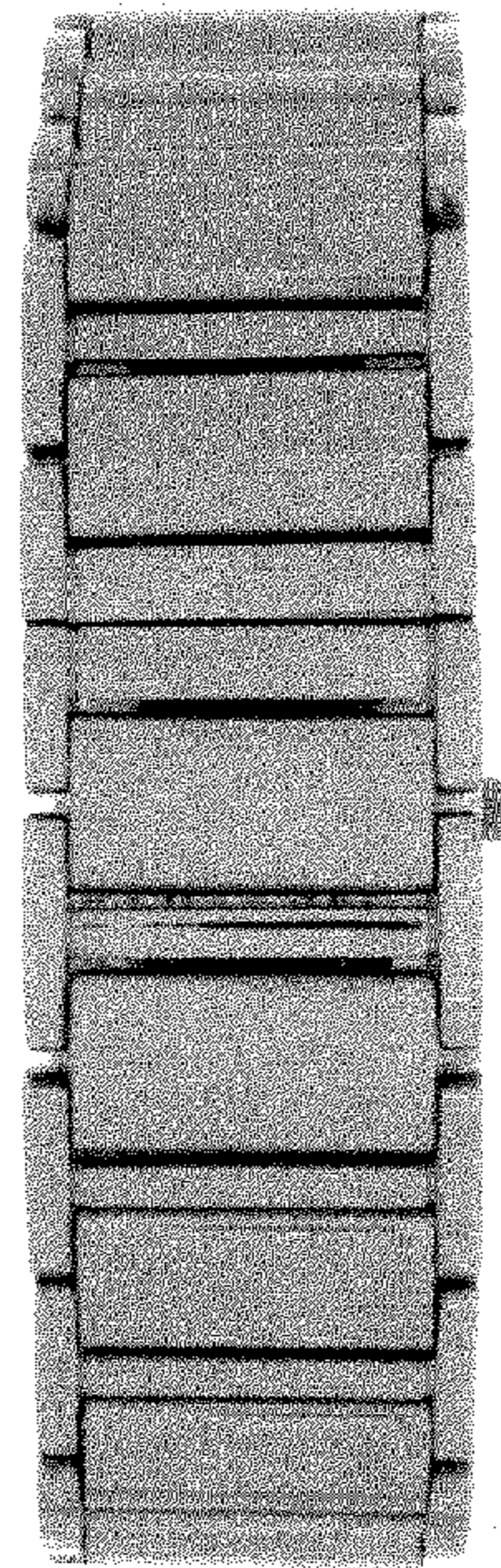

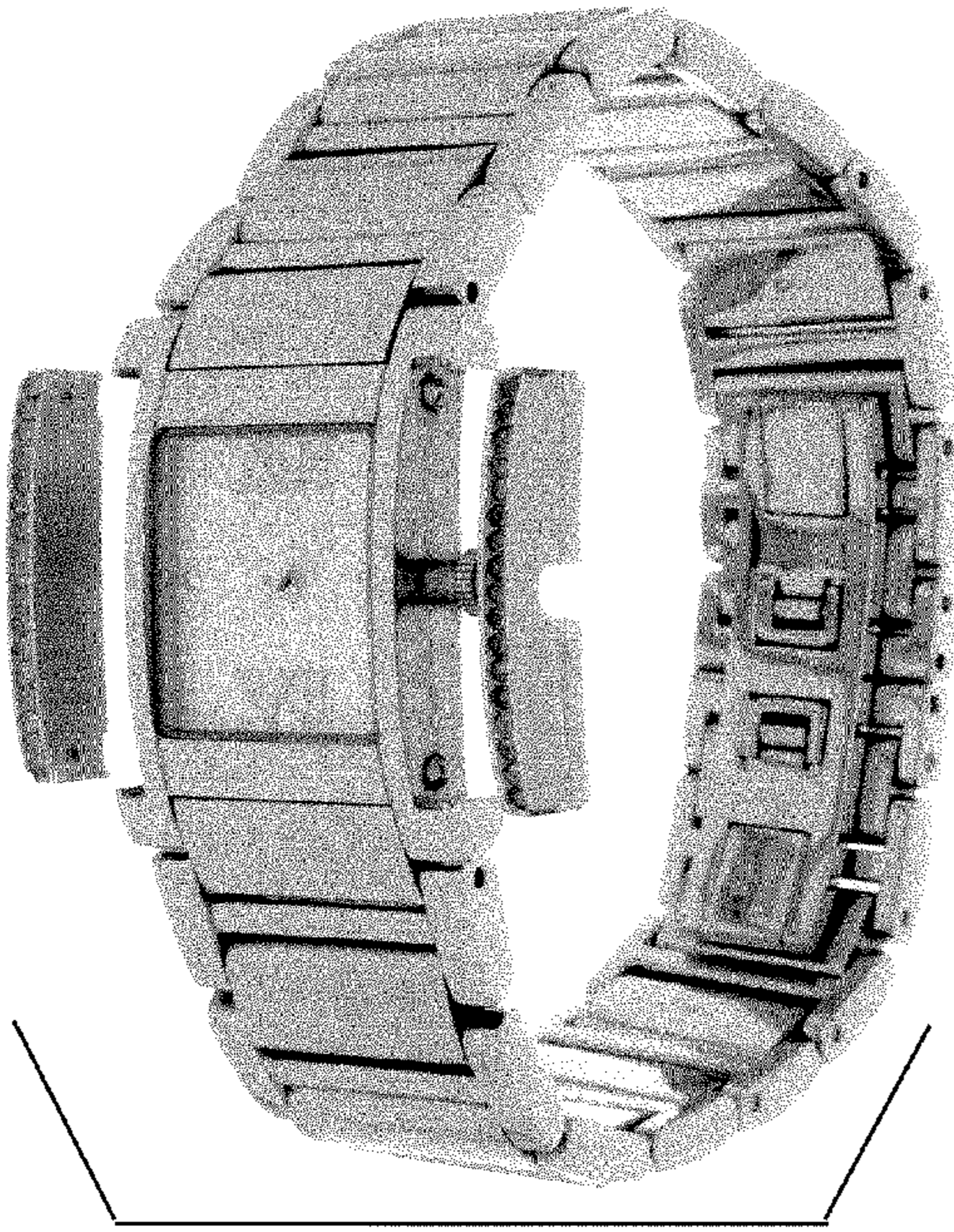

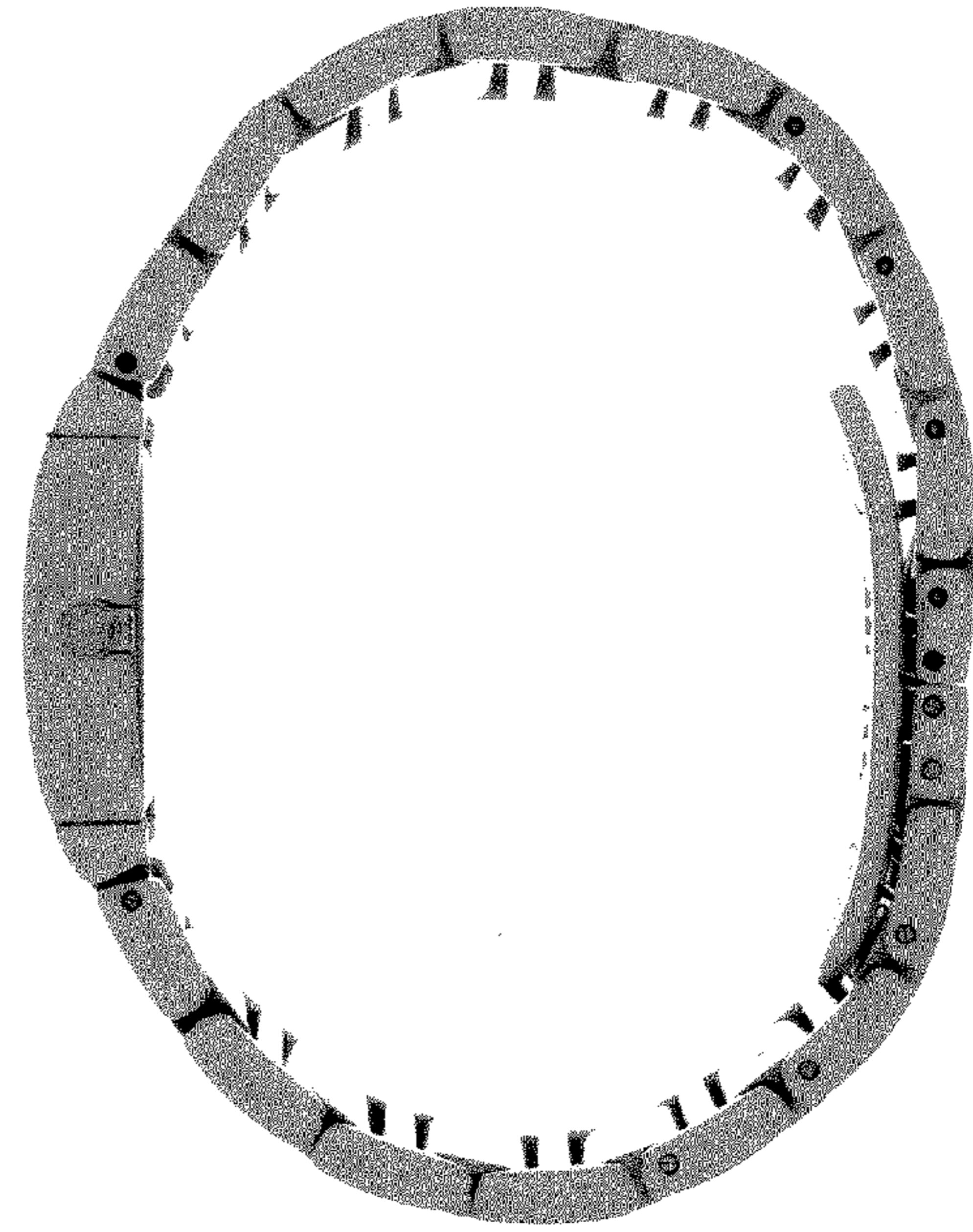

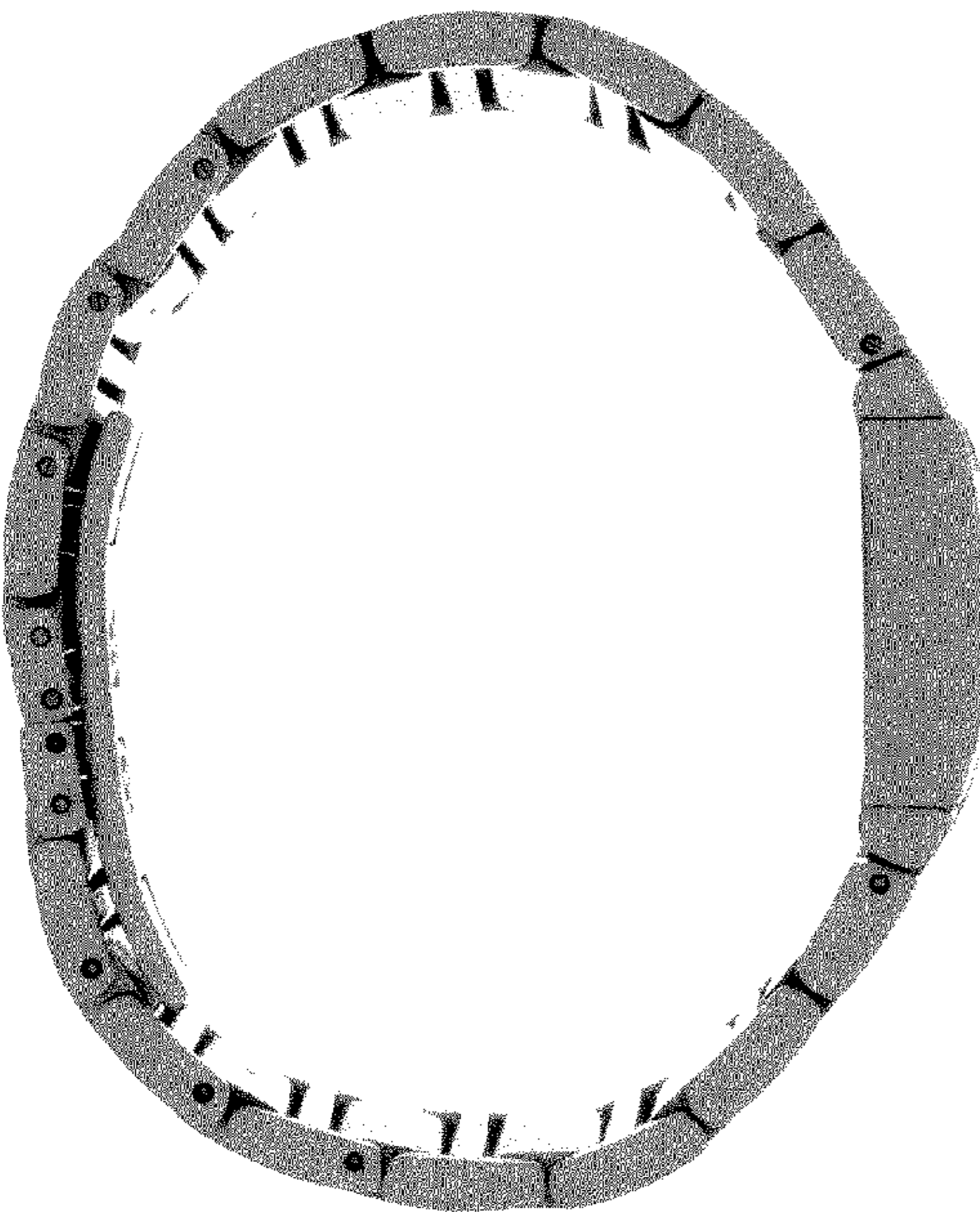

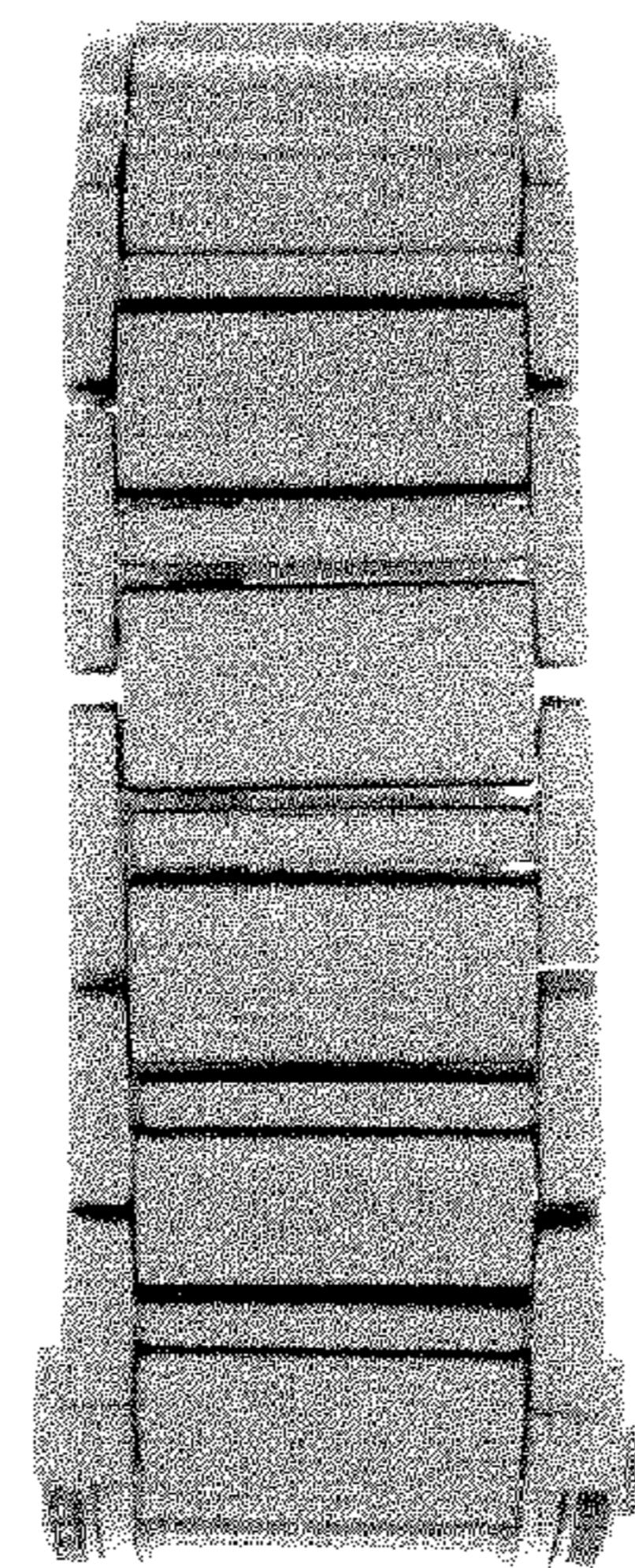

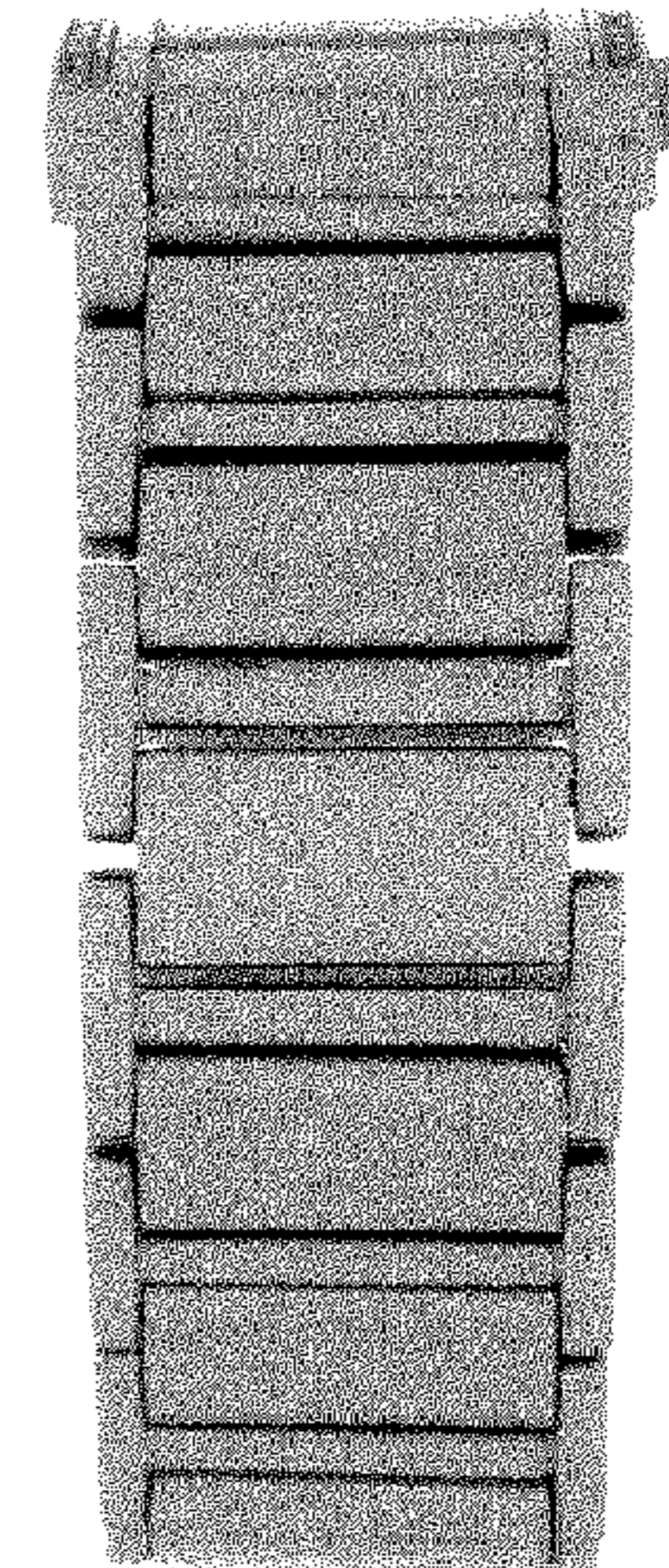
