The ornamental design for a clothing jewelry, as shown and described.

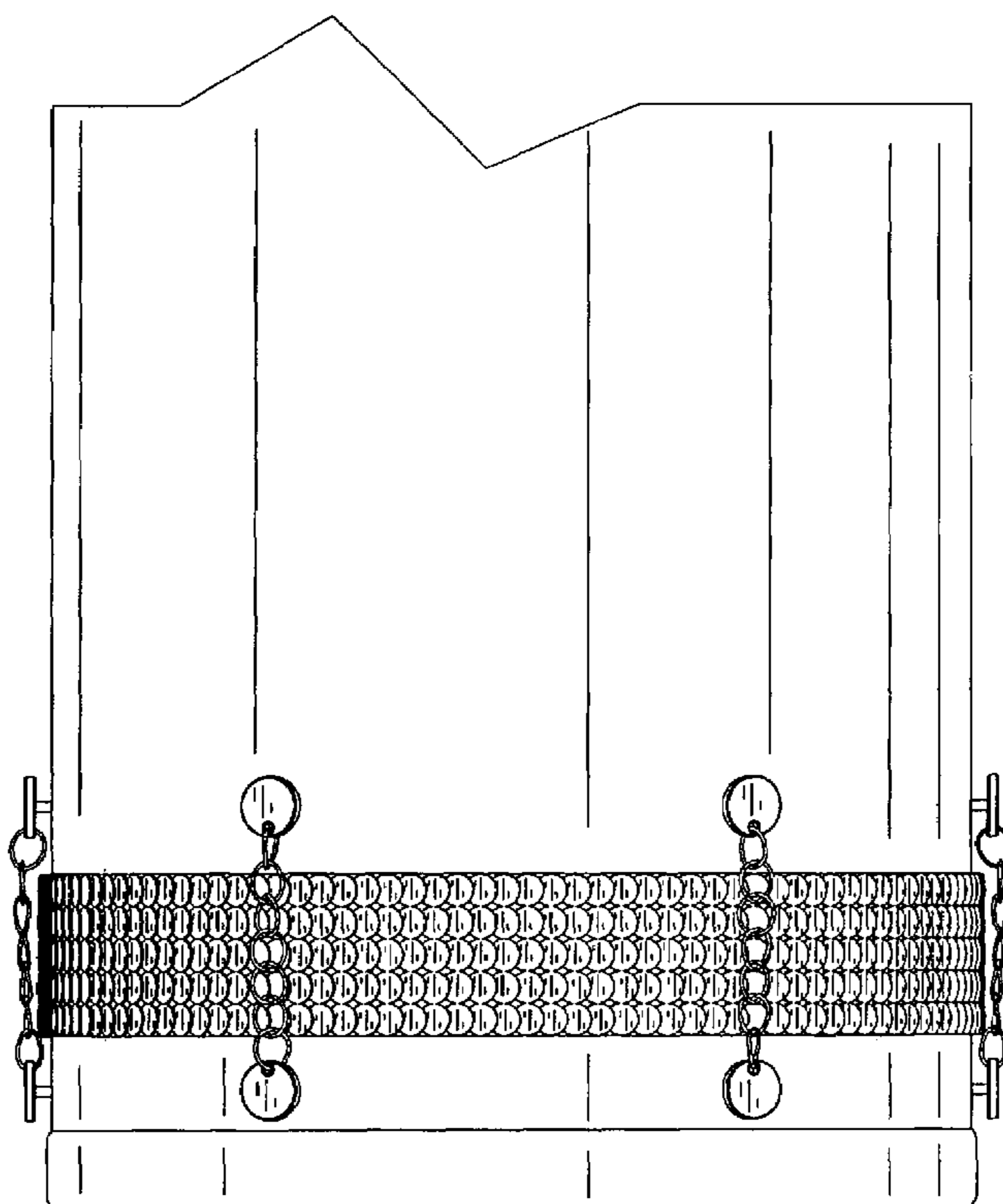
DESCRIPTION

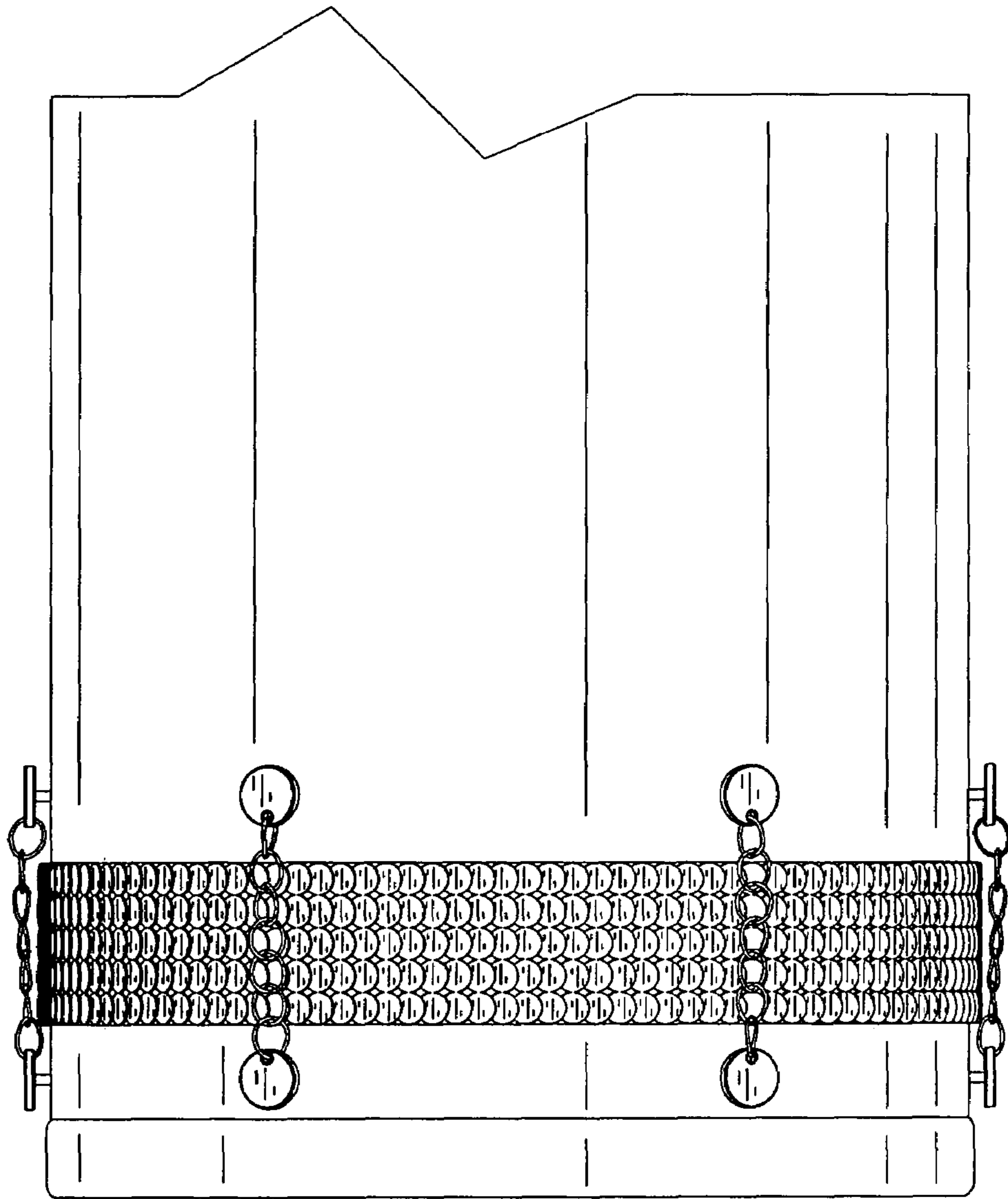

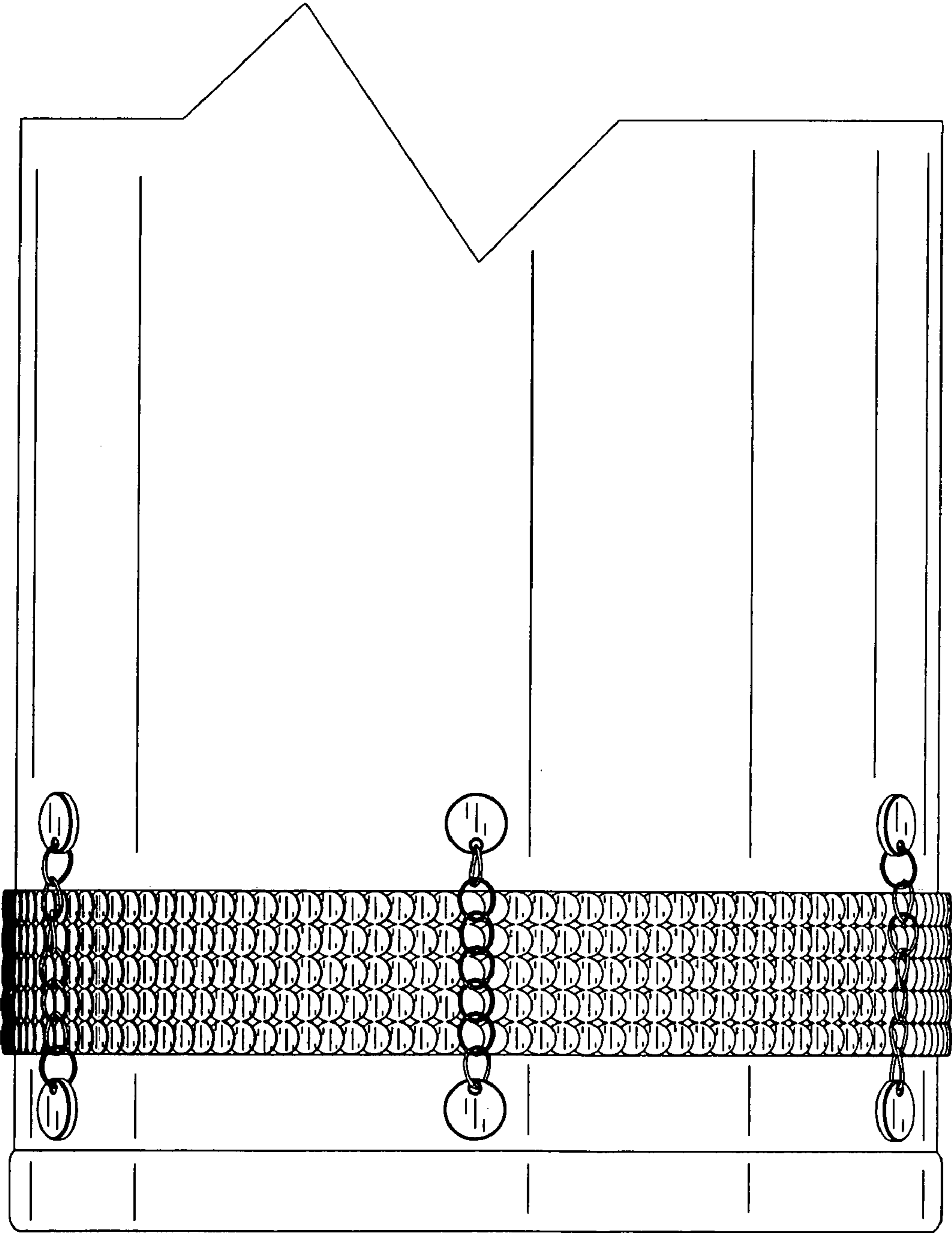

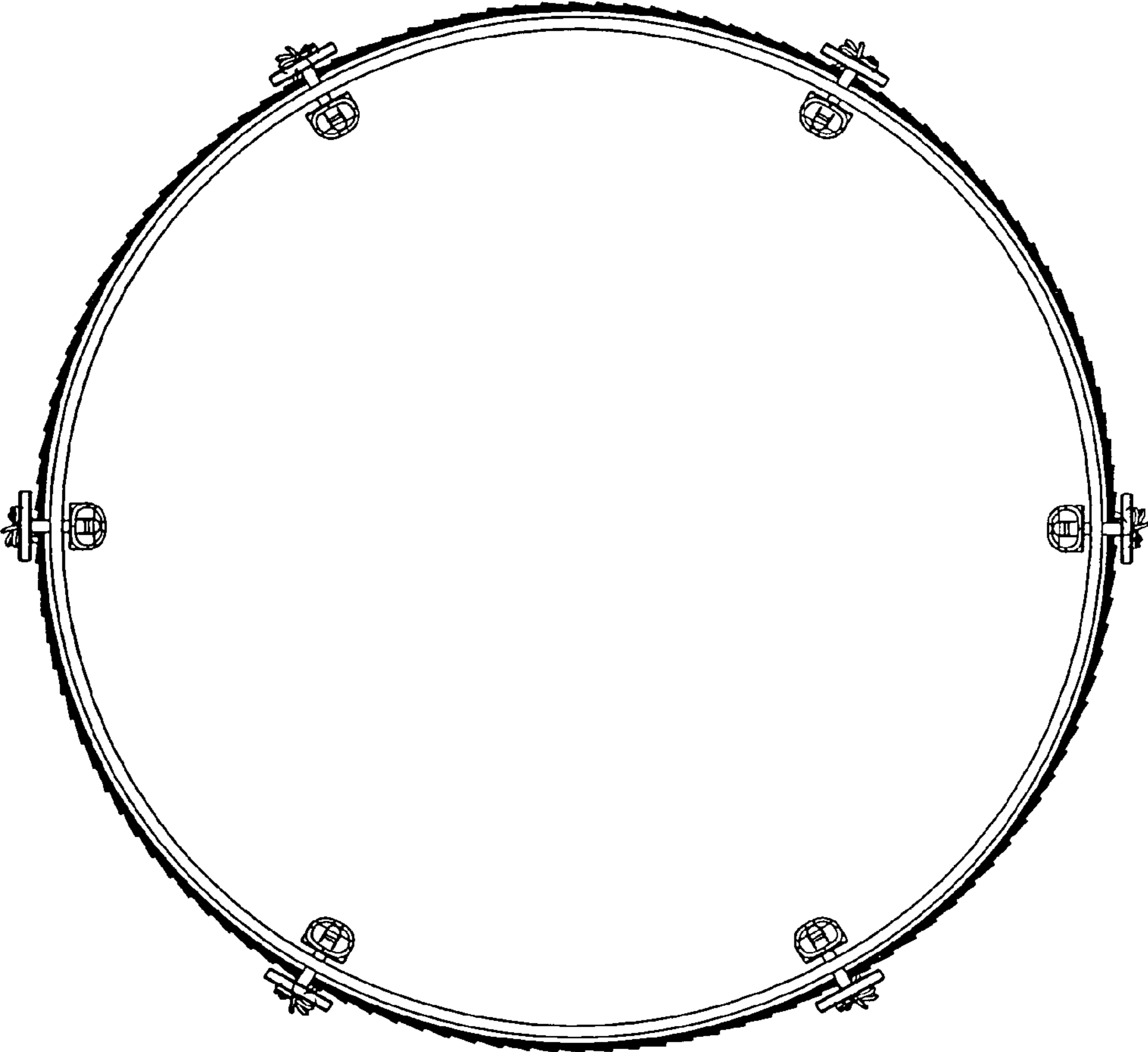
