(57) **CLAIM**

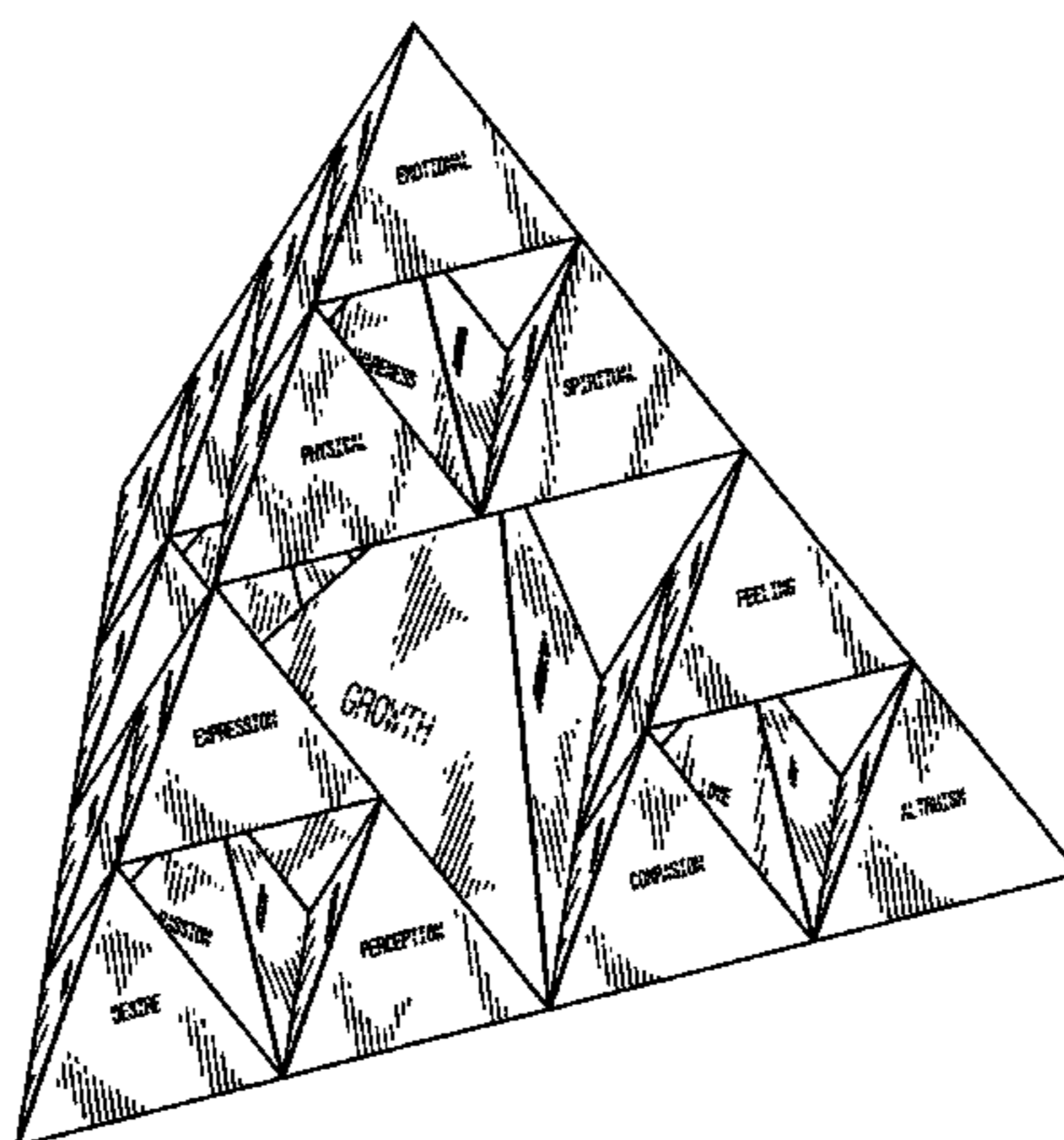
The ornamental design for an inscribed pyramid ornaments,
