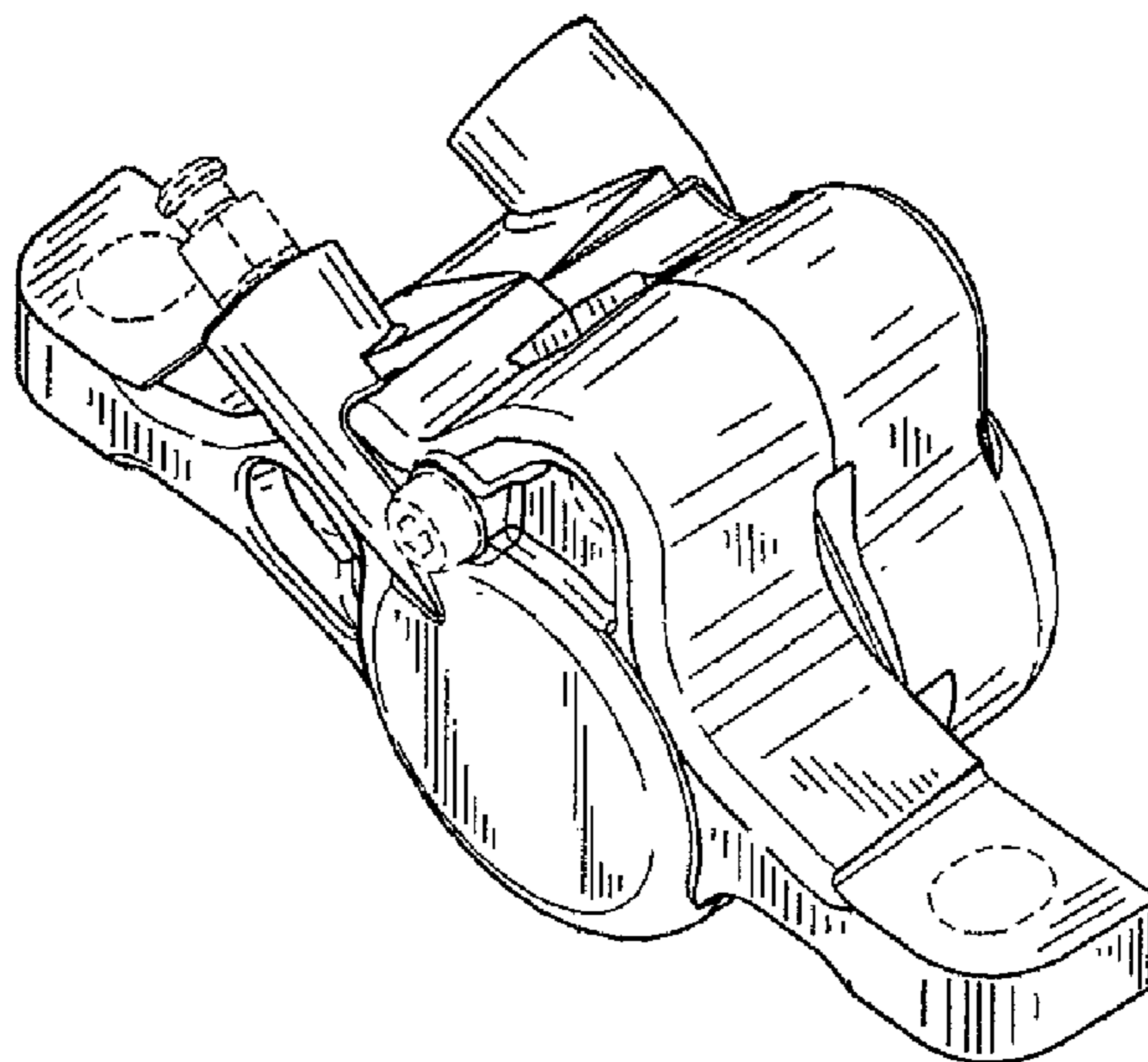

FIG. 1 is a perspective view of the design;  
FIG. 2 is a side elevational view of FIG. 1;  
FIG. 3 is a side elevational view of the opposite side of FIG. 2, rotated clockwise 180 degrees from the position shown in FIG. 2;  
FIG. 4 is a top view of FIG. 1;  
FIG. 5 is a bottom view of FIG. 1;  
FIG. 6 is a front view of FIG. 1; and,  
FIG. 7 is a rear view of FIG. 1.  
The broken lines showing portions of the bicycle brake form no part of the claimed design.

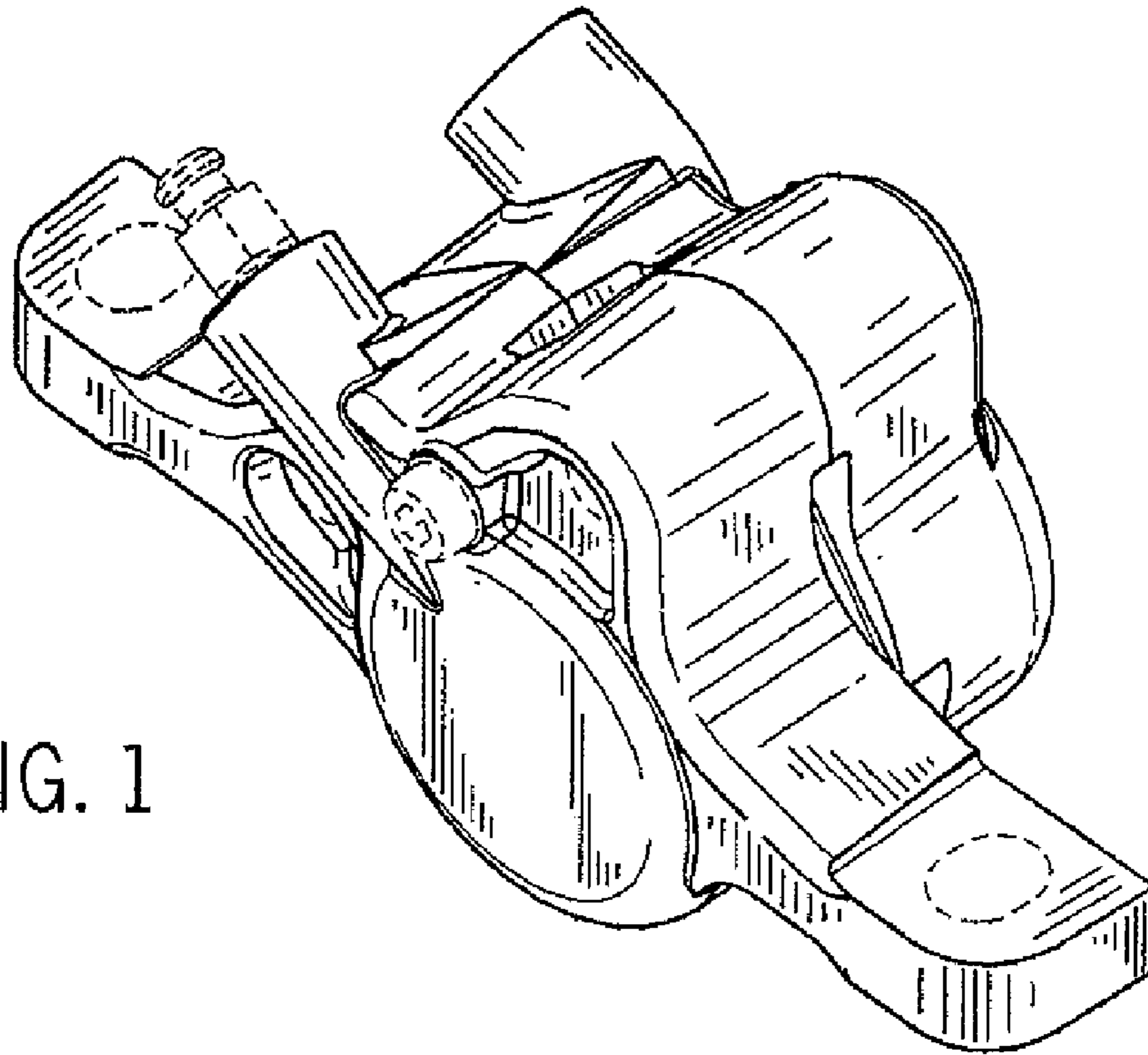

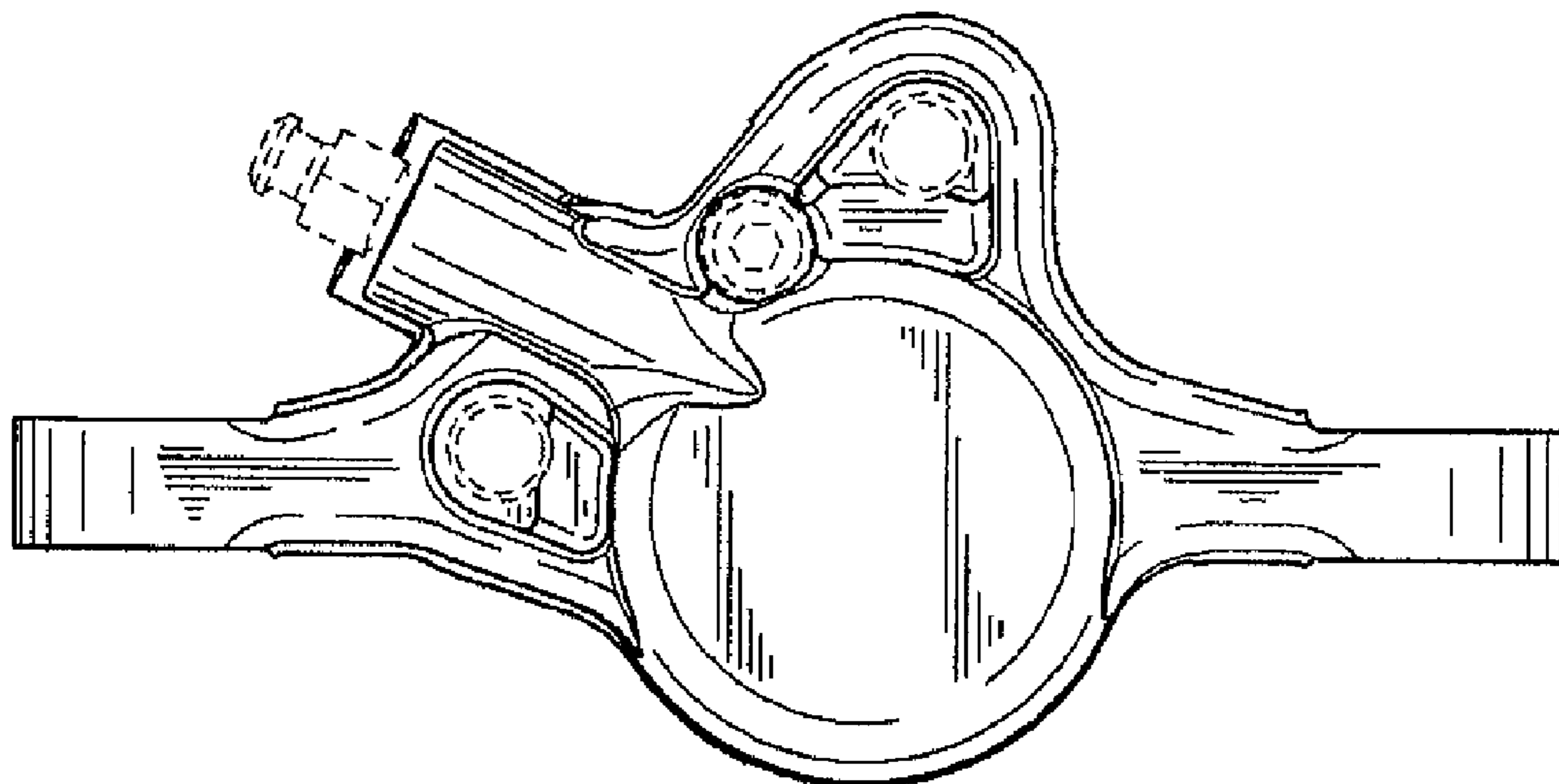

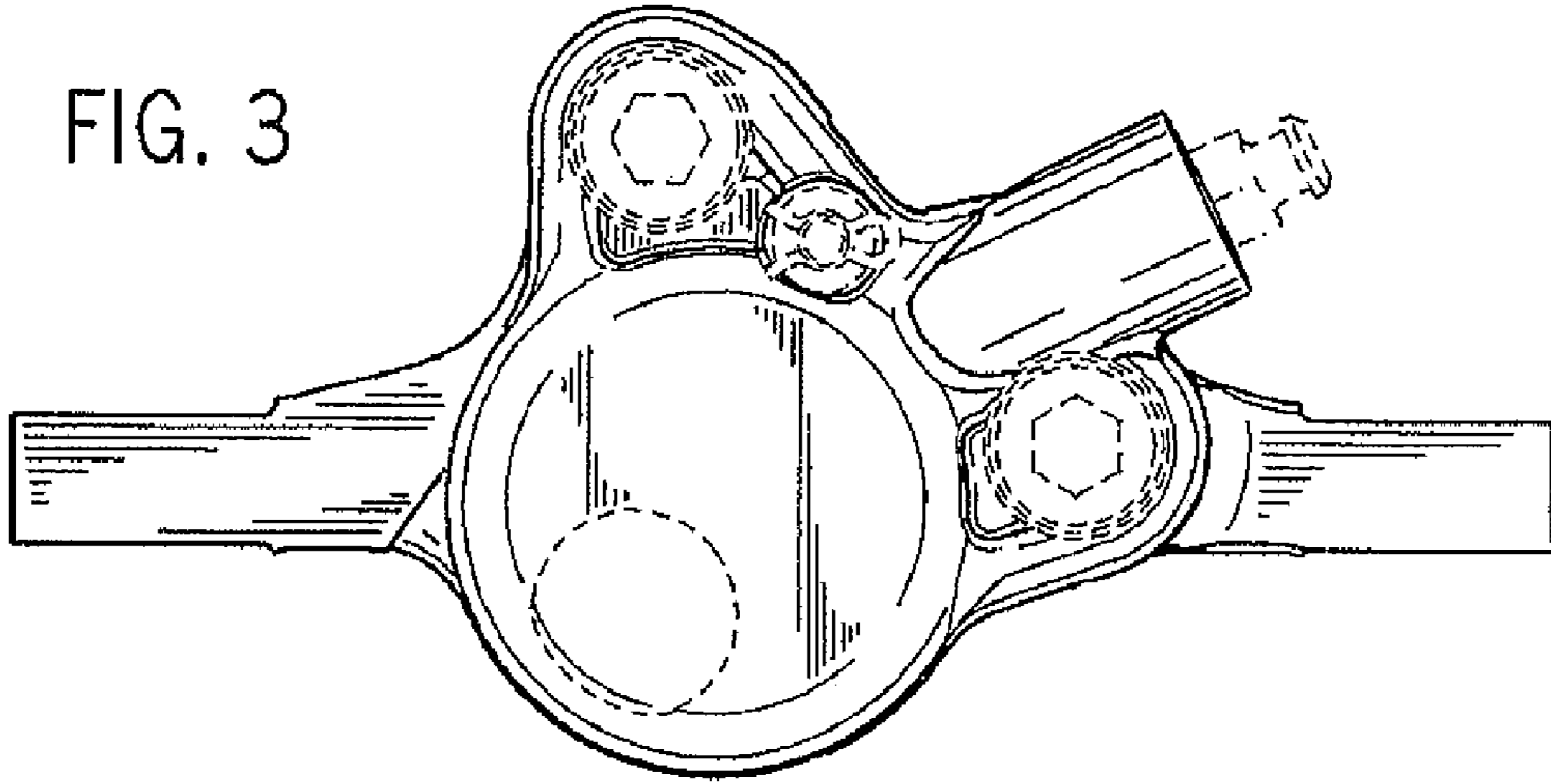

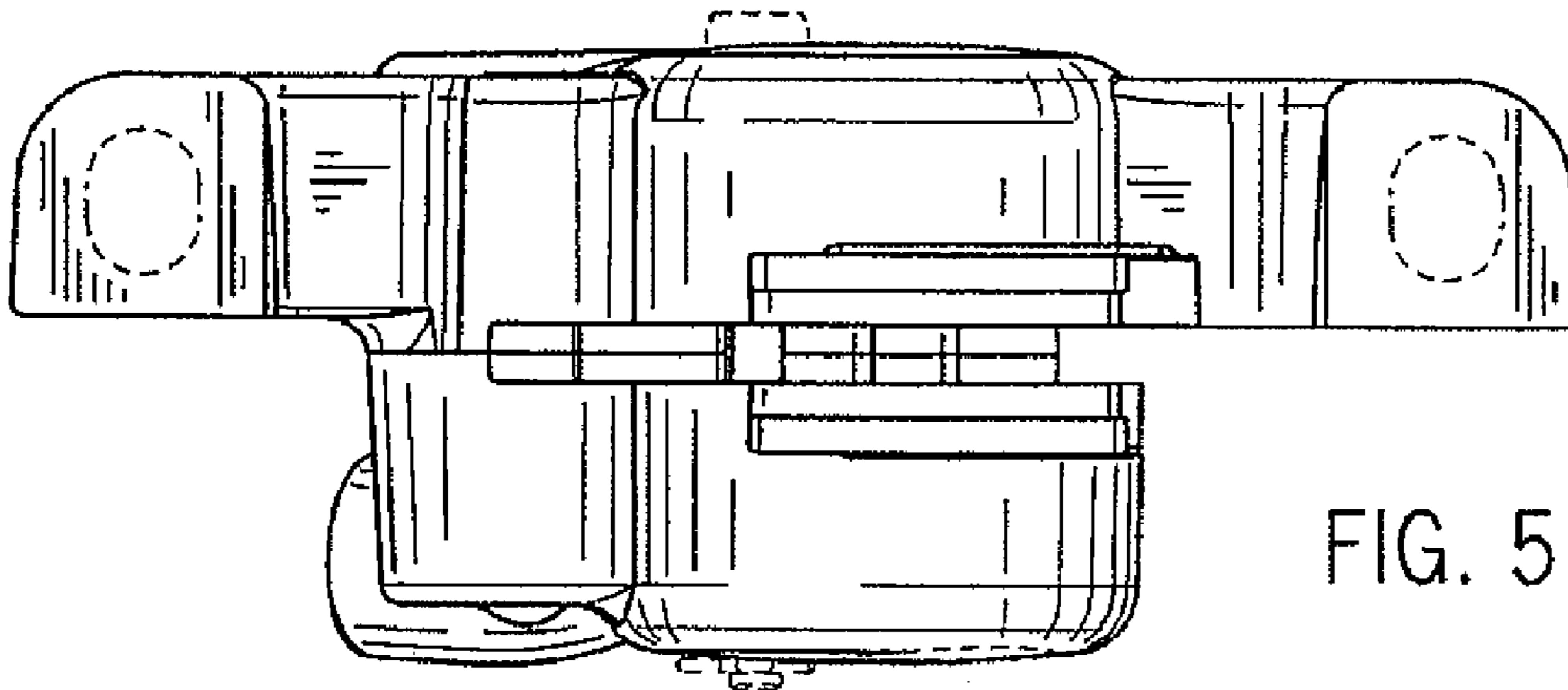
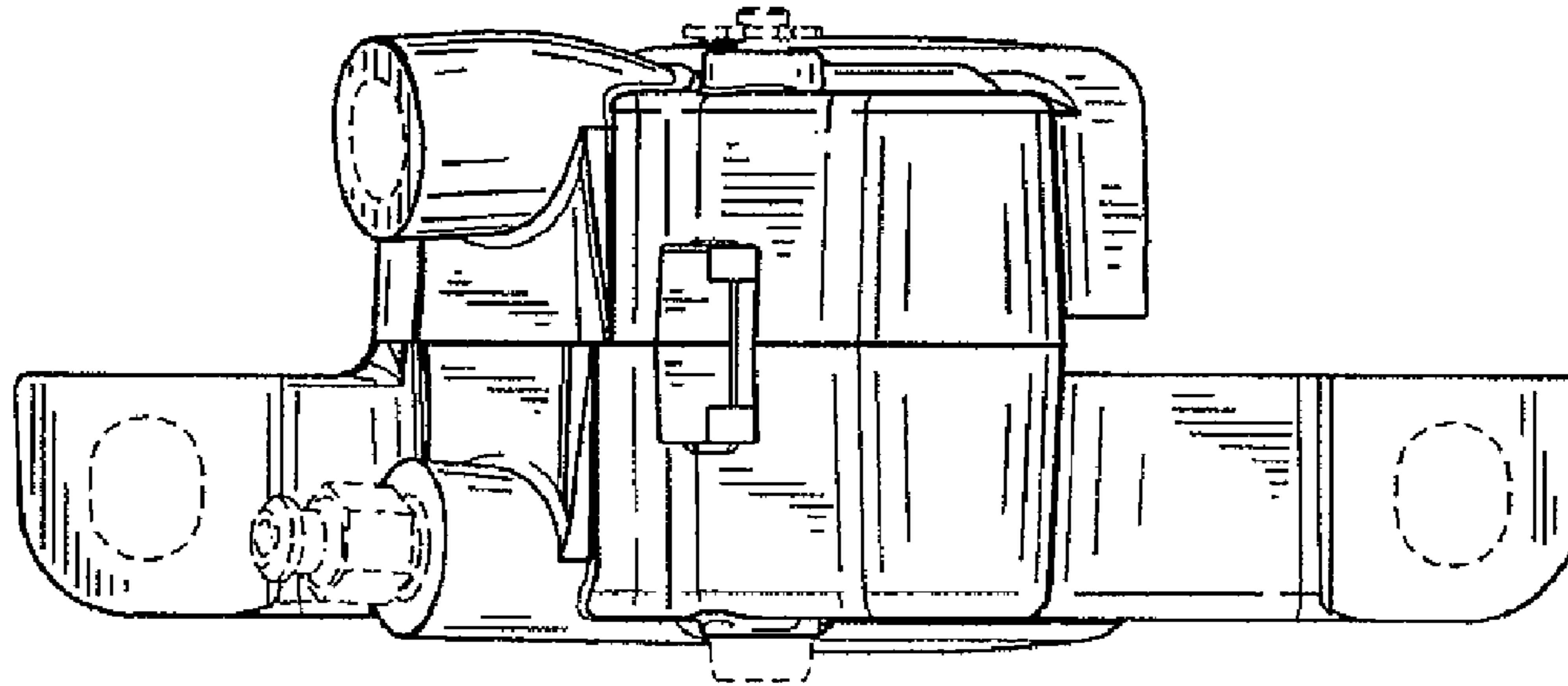

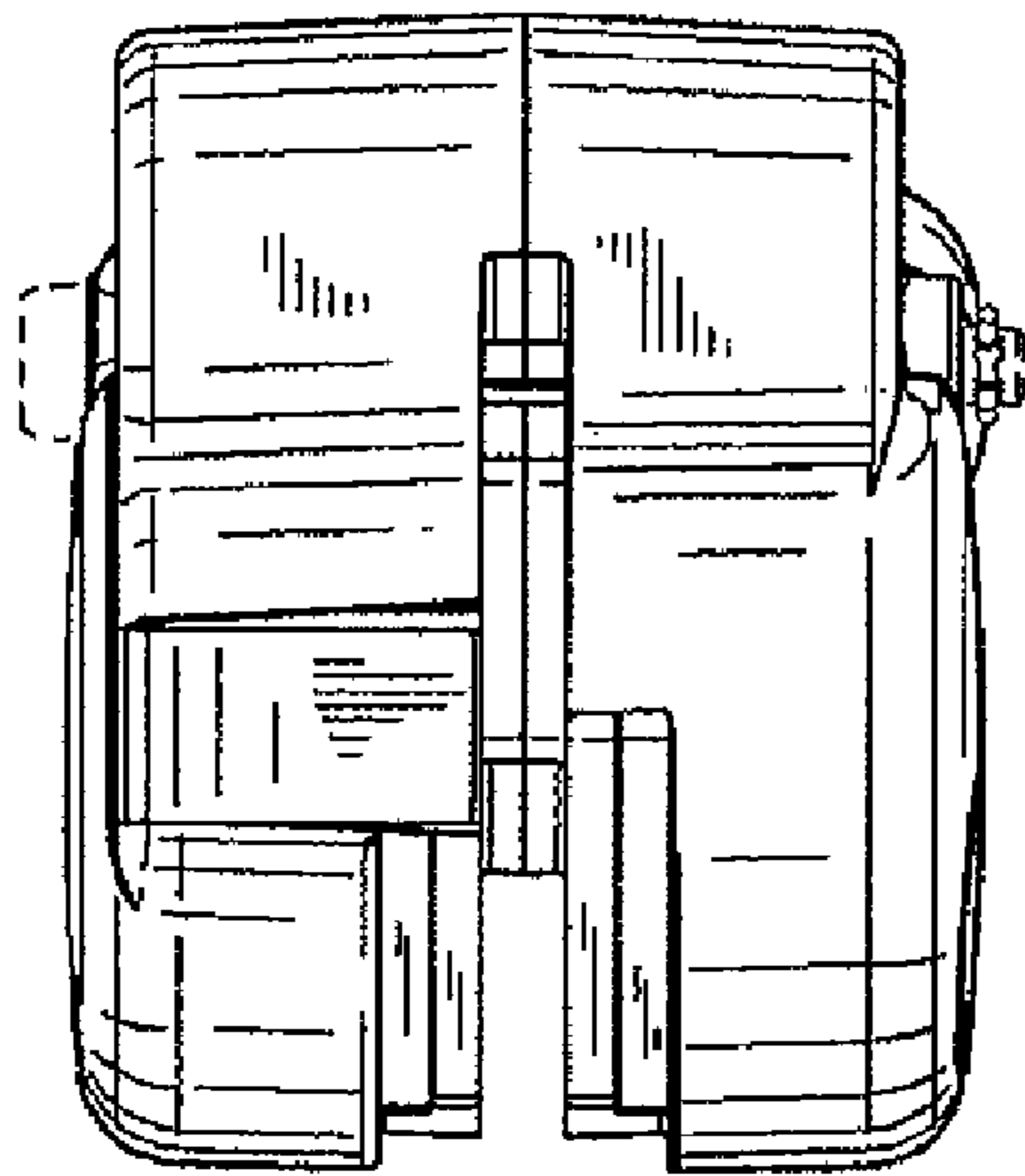

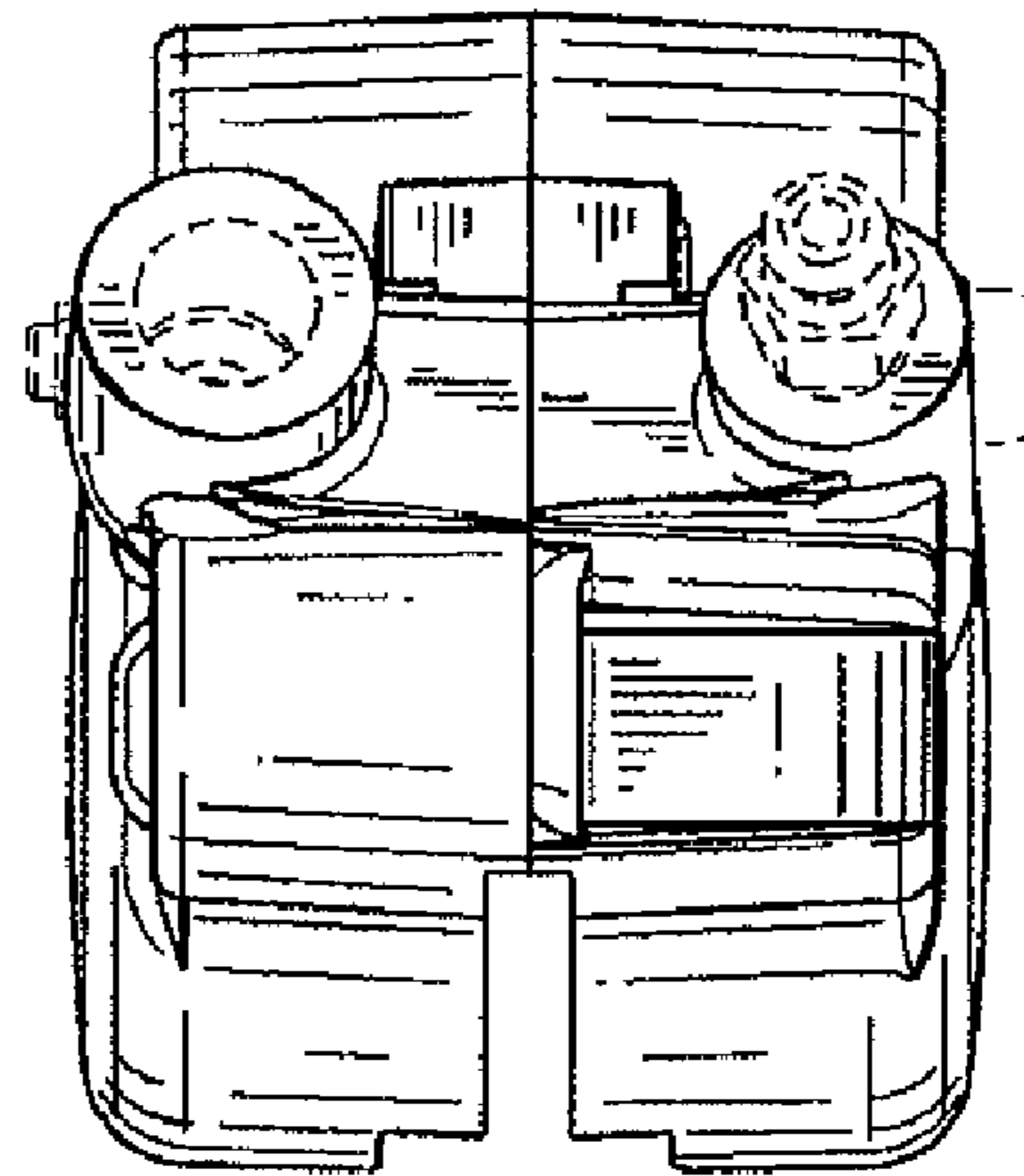
