DESCRIPTION

FIG. 7 is a front view thereof;

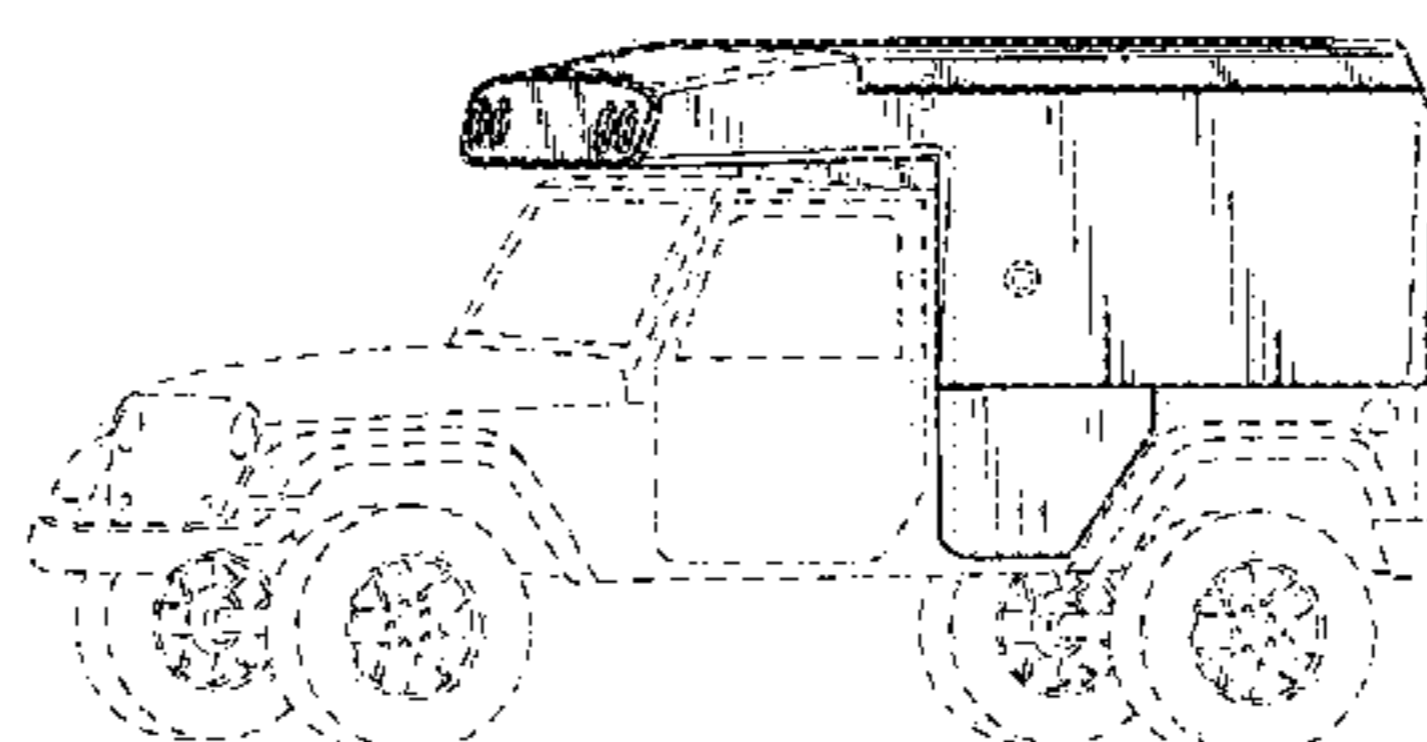
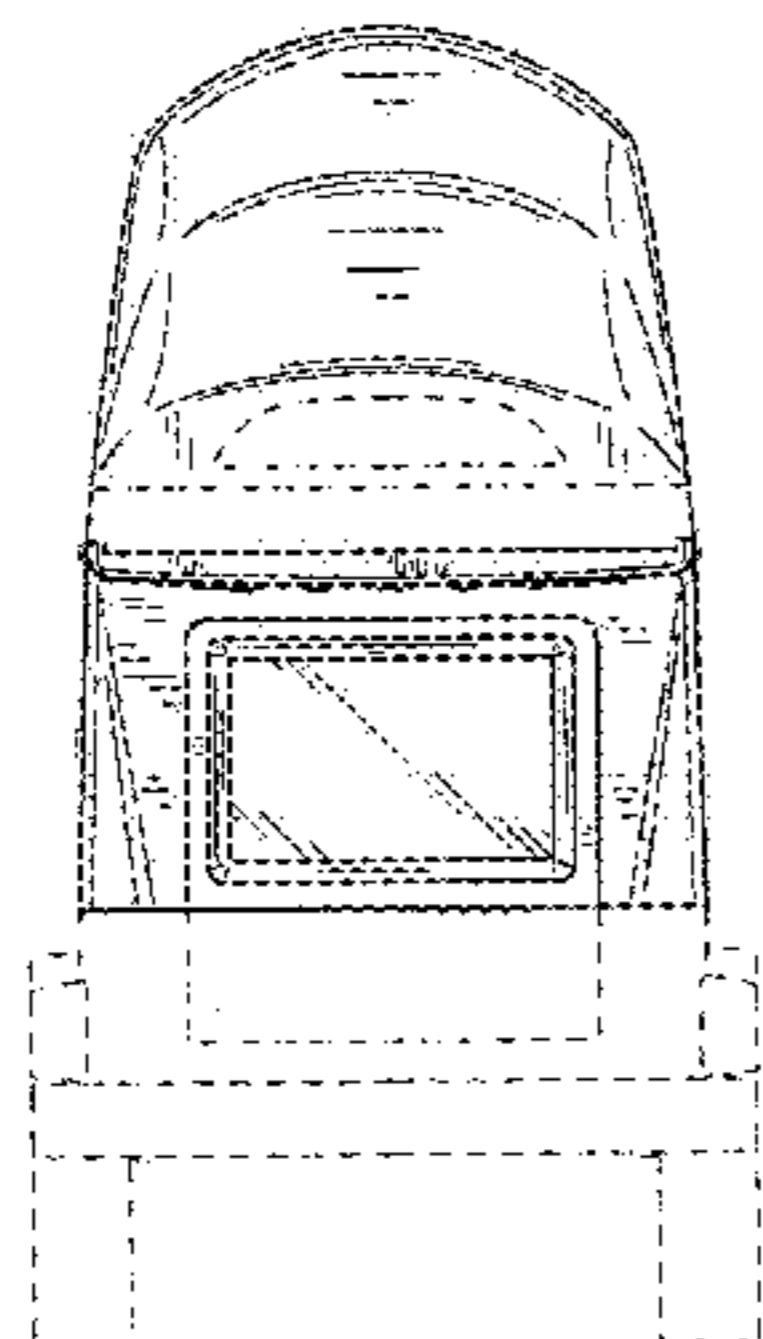
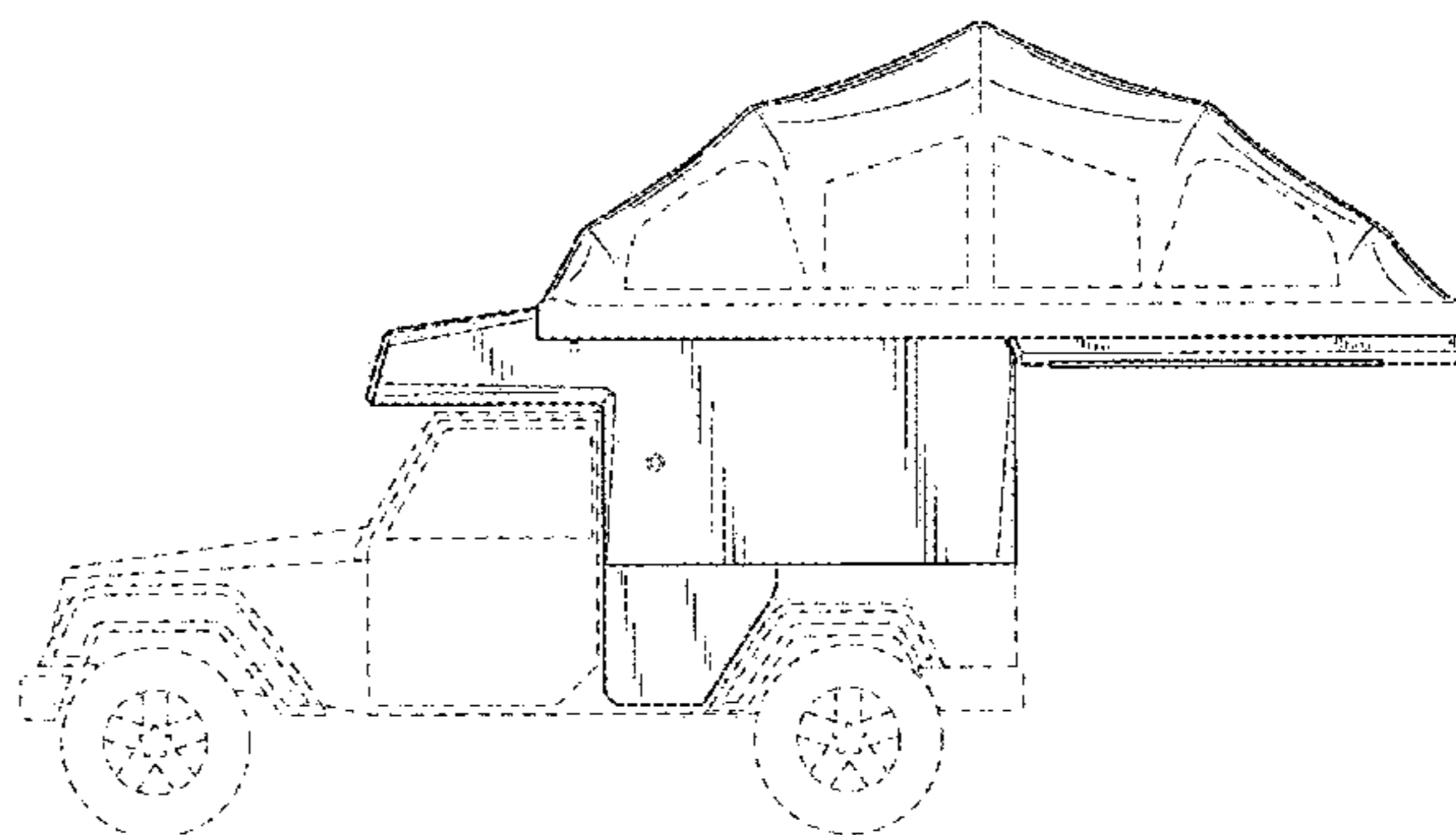
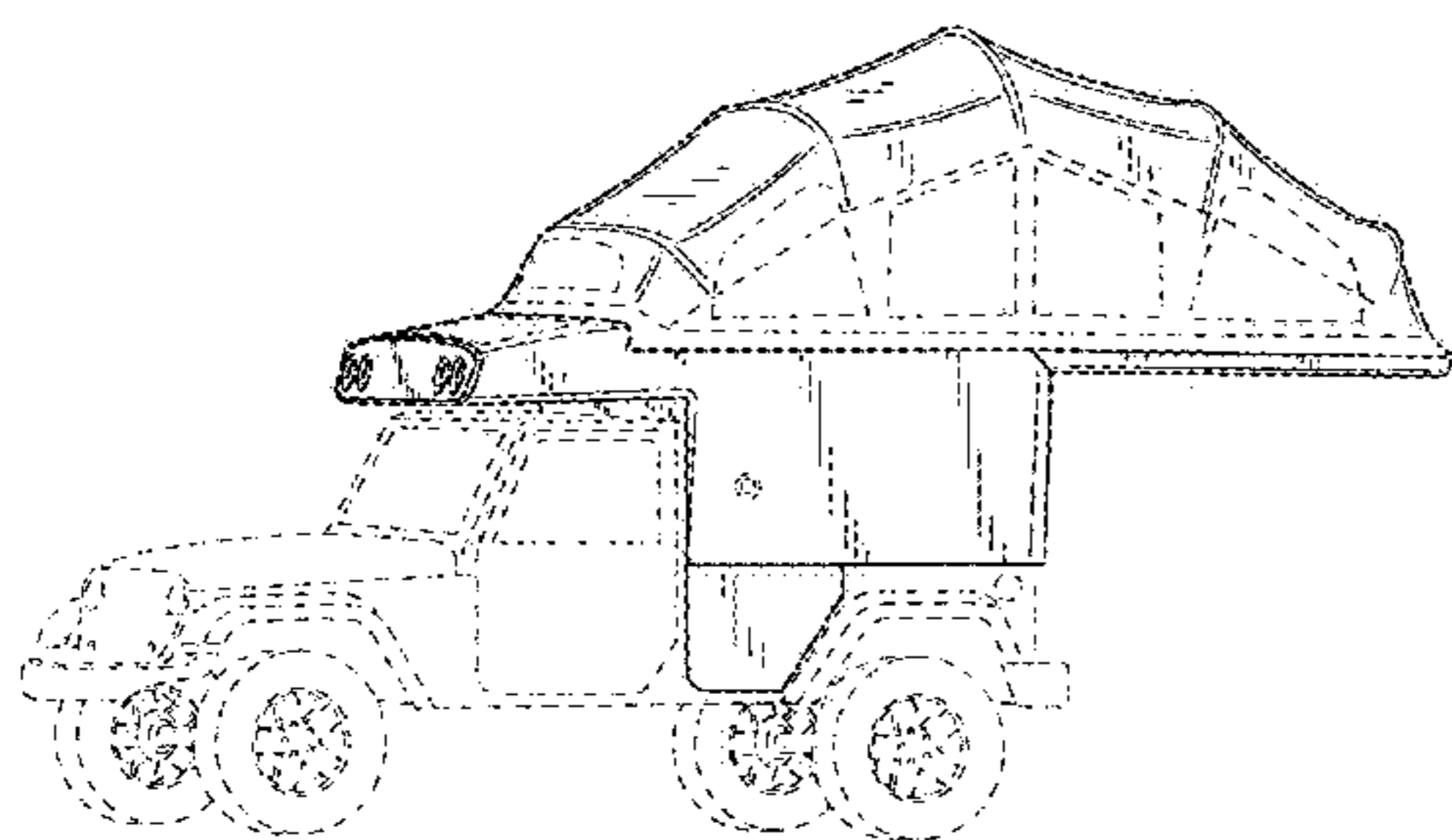
FIG. 8 is a back view thereof;

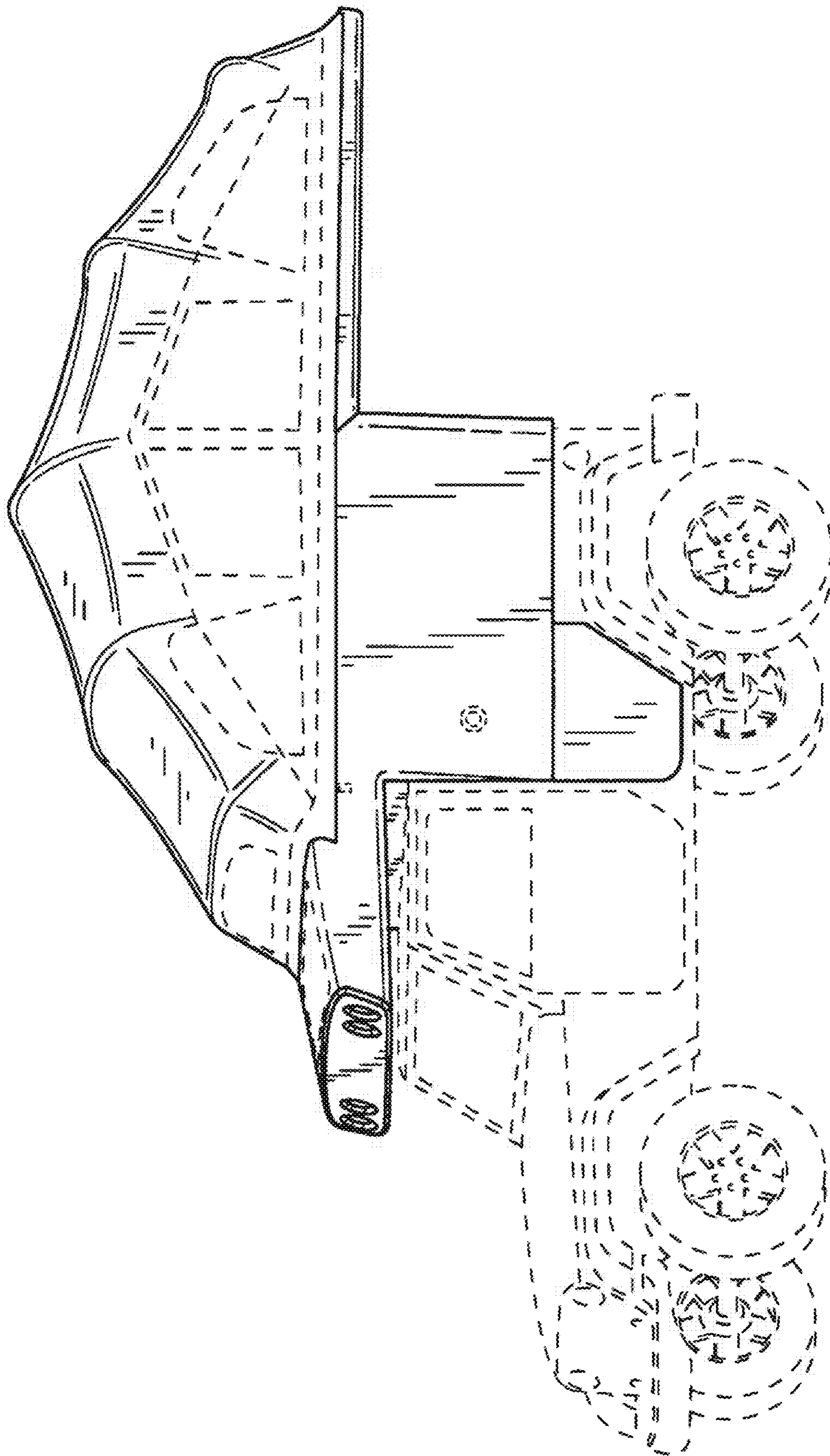

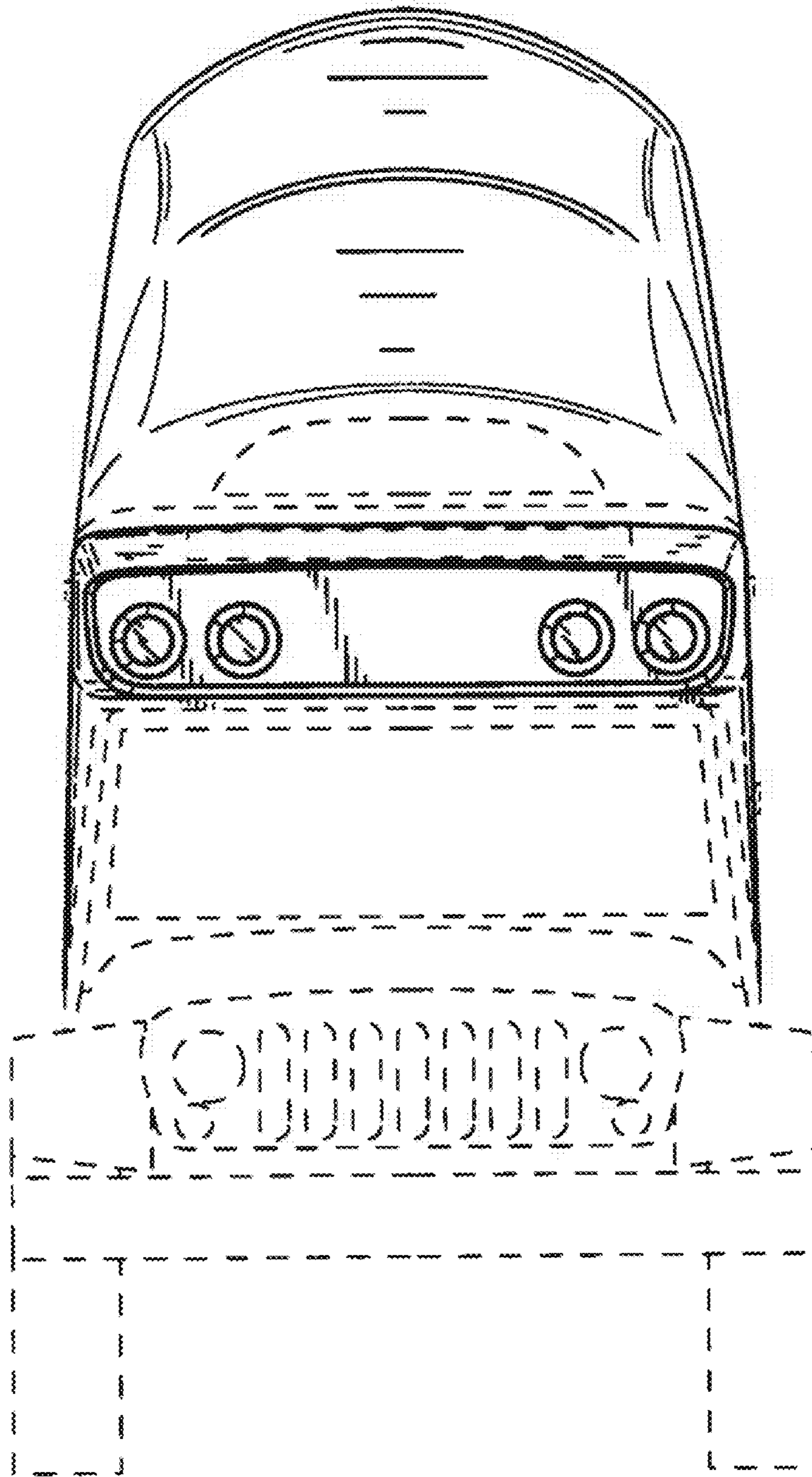

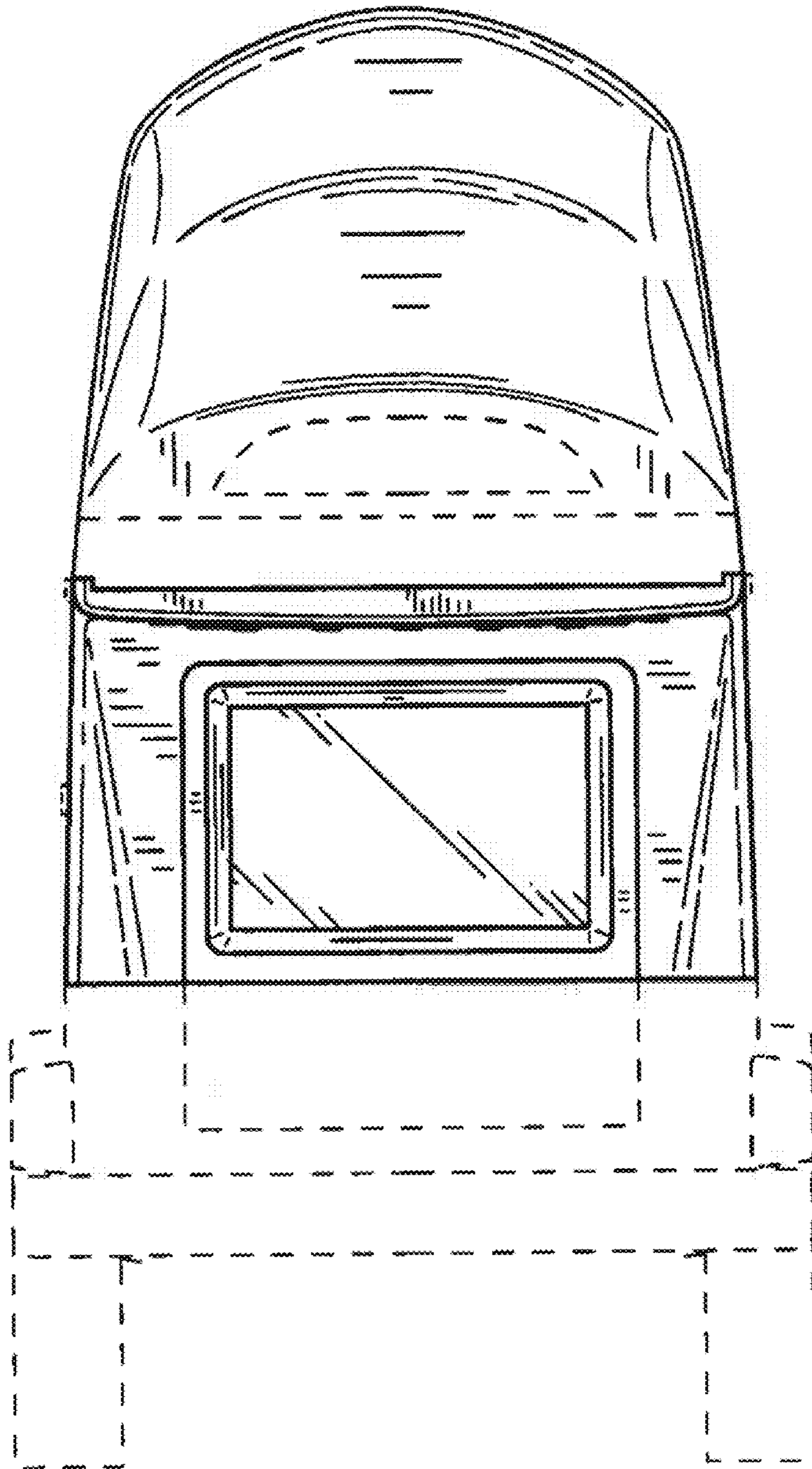

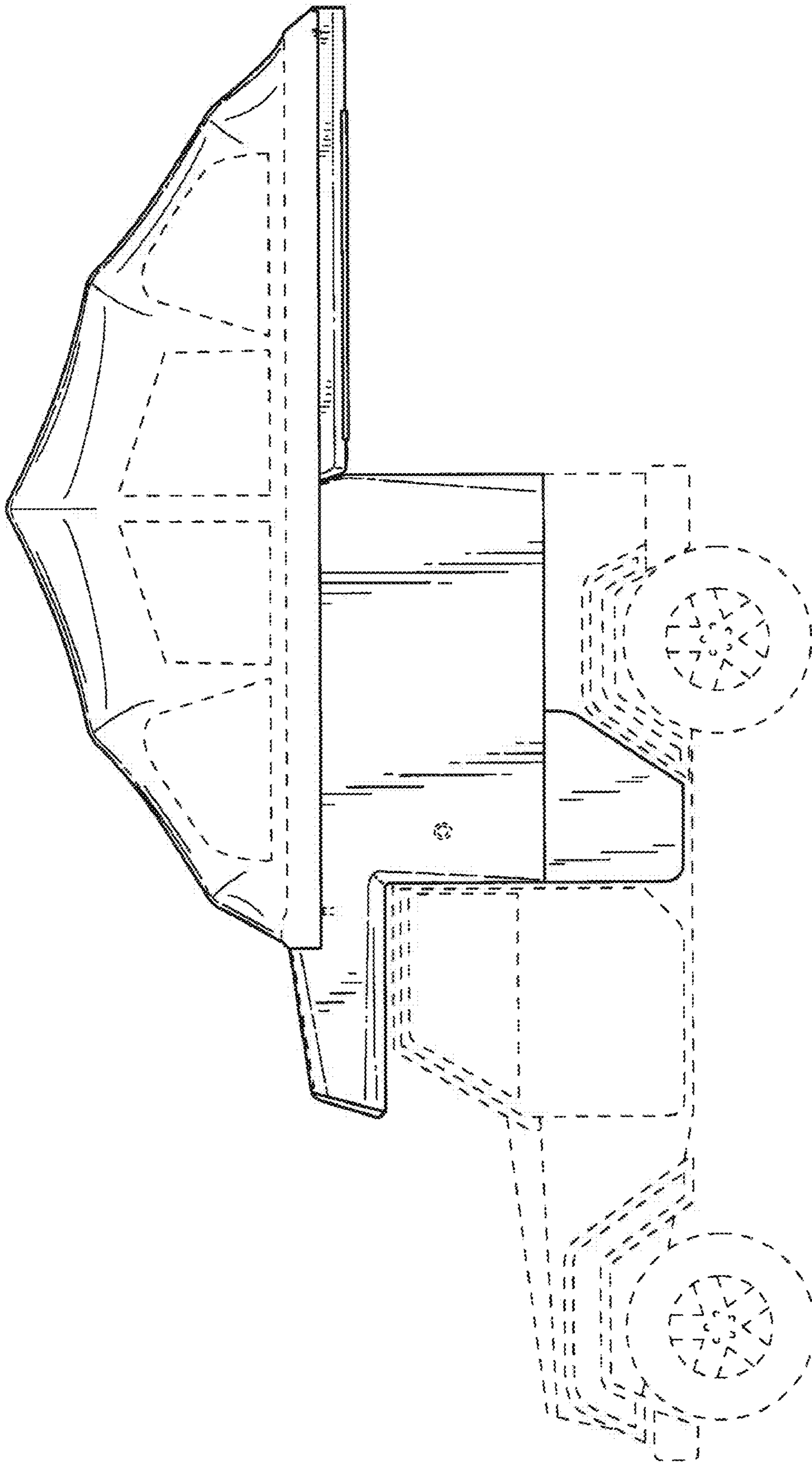

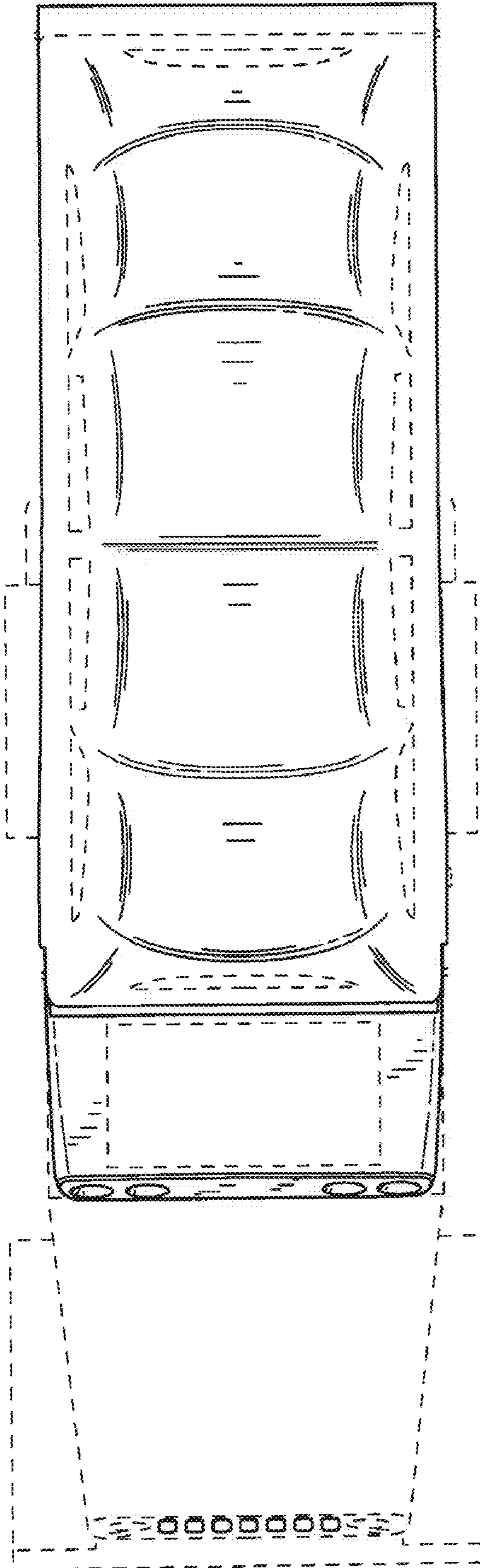

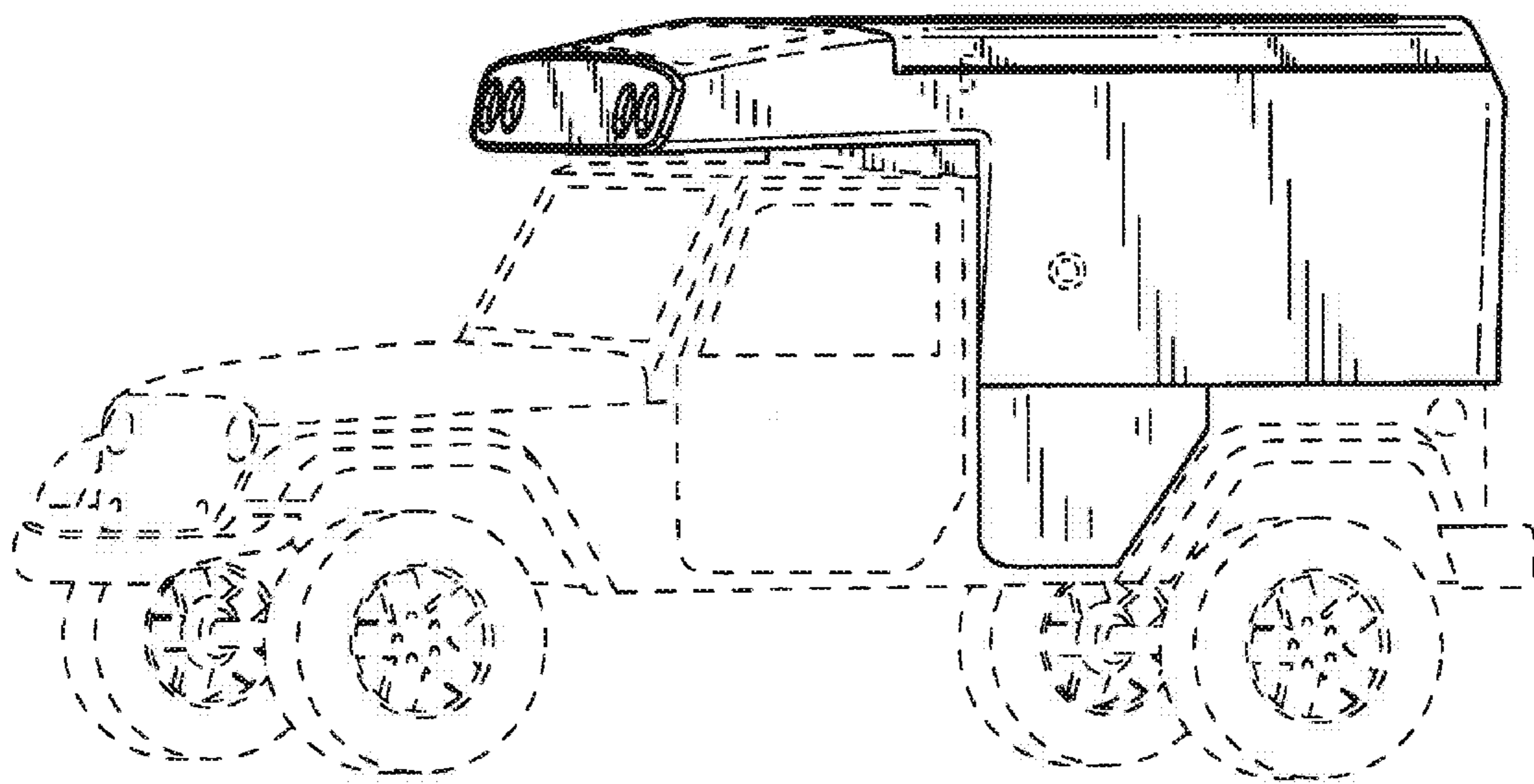

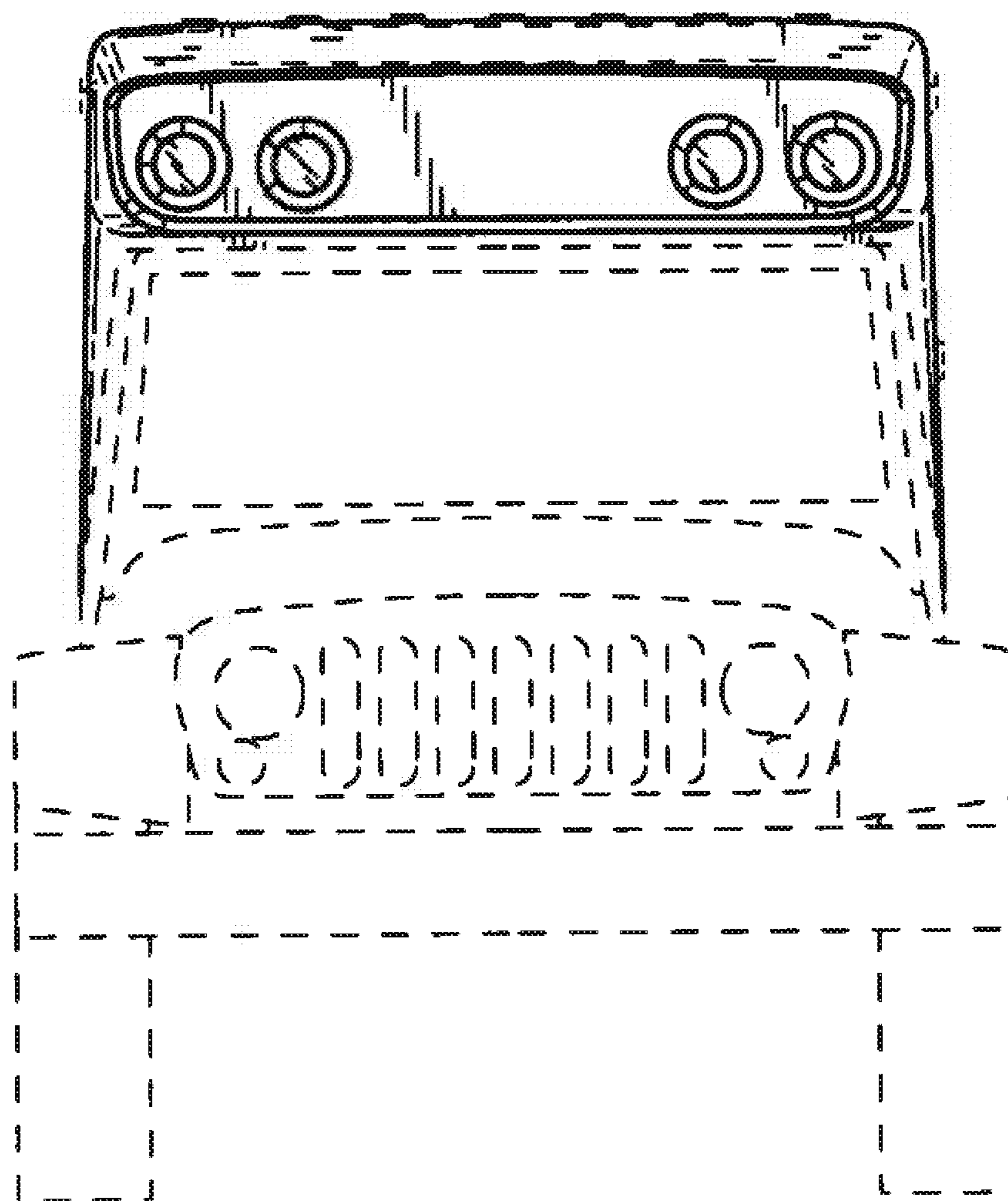

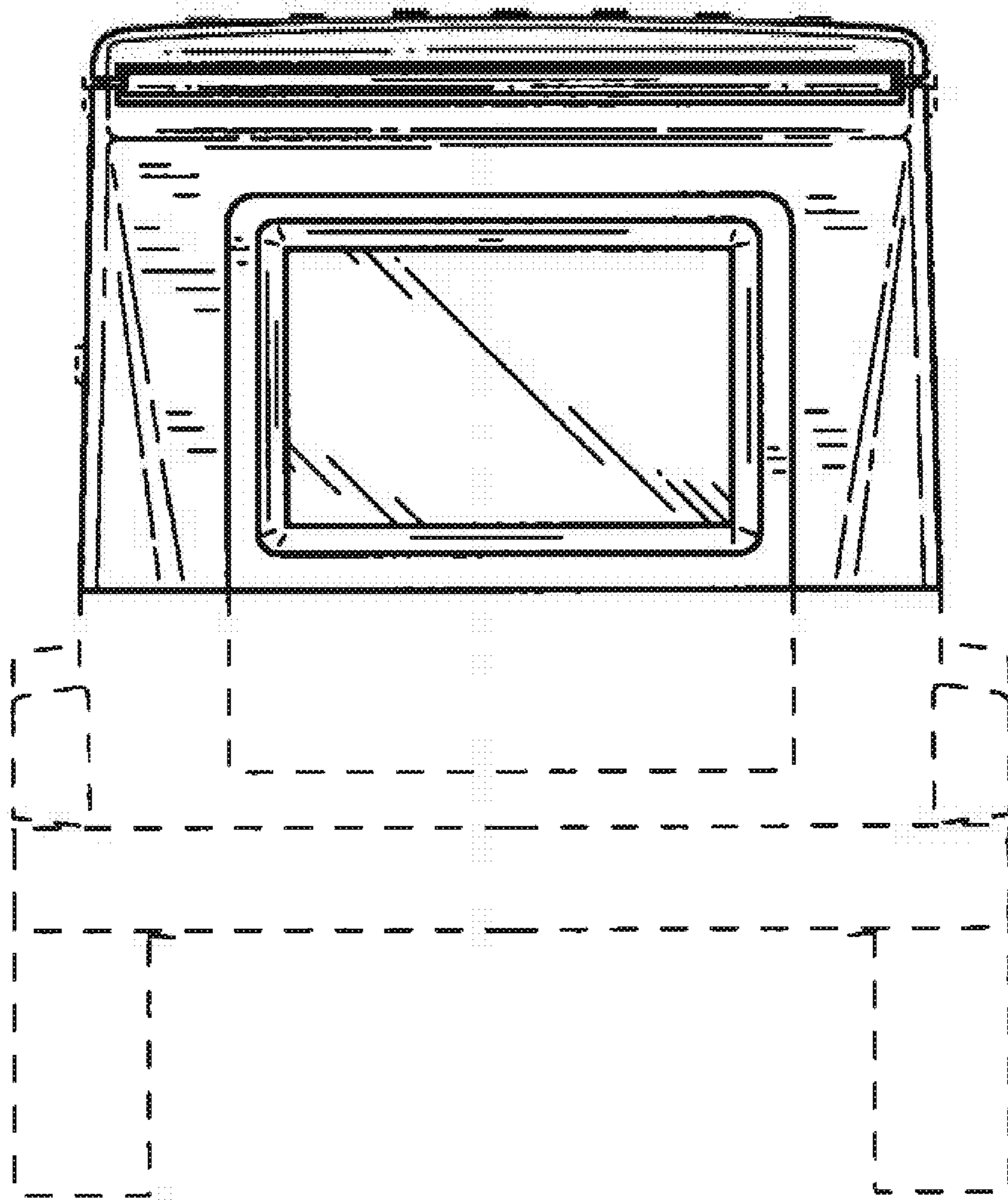

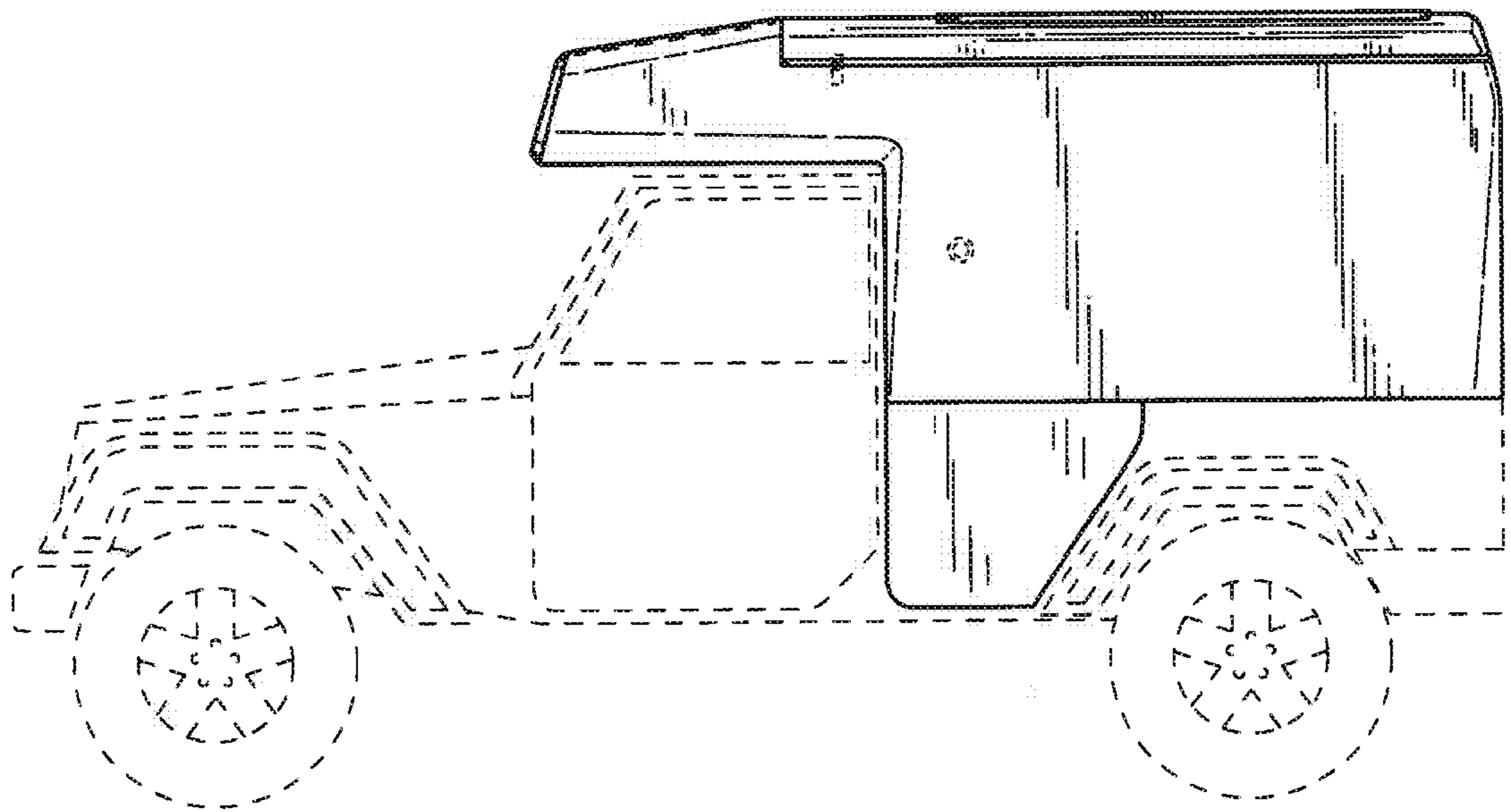

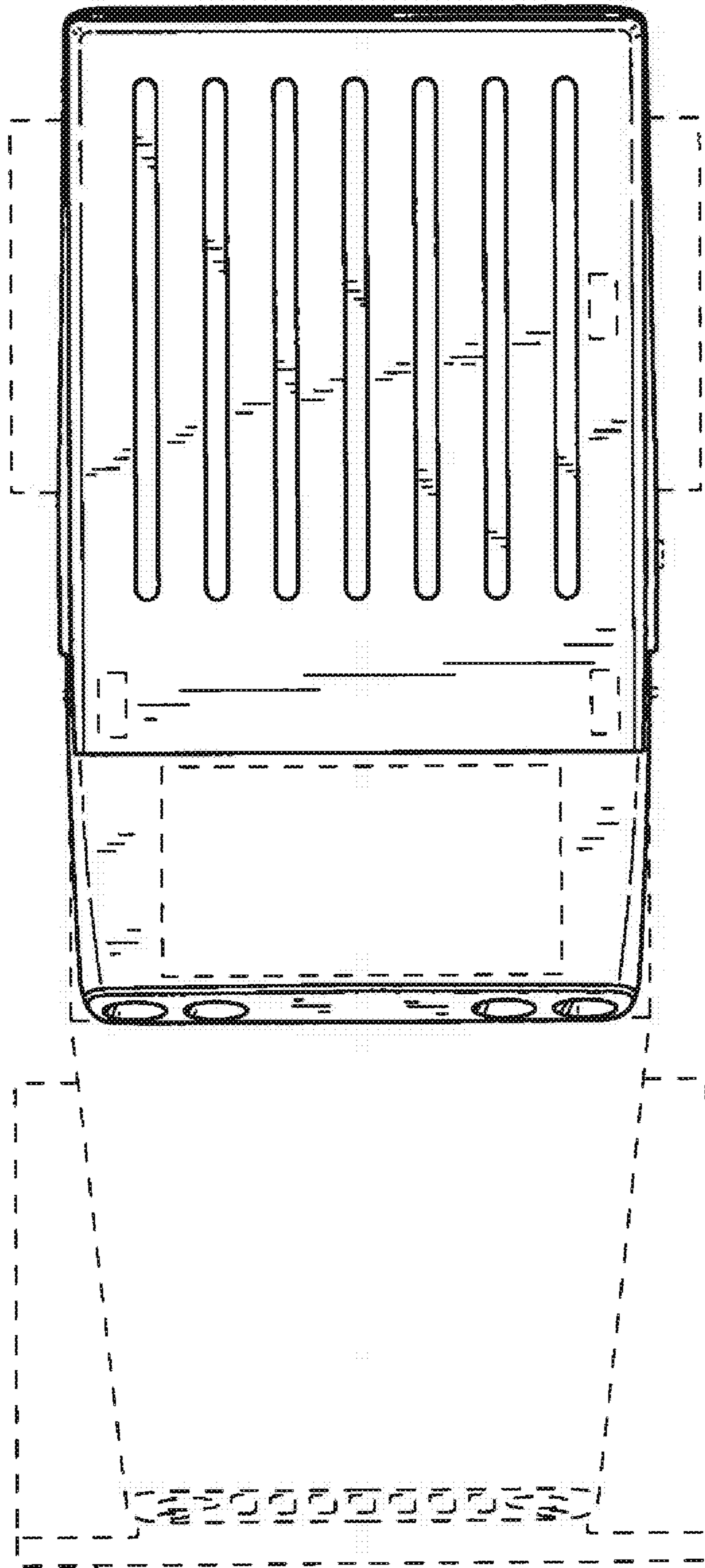
