(57) **CLAIM**

The ornamental design for a combination cellular telephone dialer and media player, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a combination cellular telephone dialer and media player according to our new design;

FIG. 2 is a rear perspective view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a top view thereof;

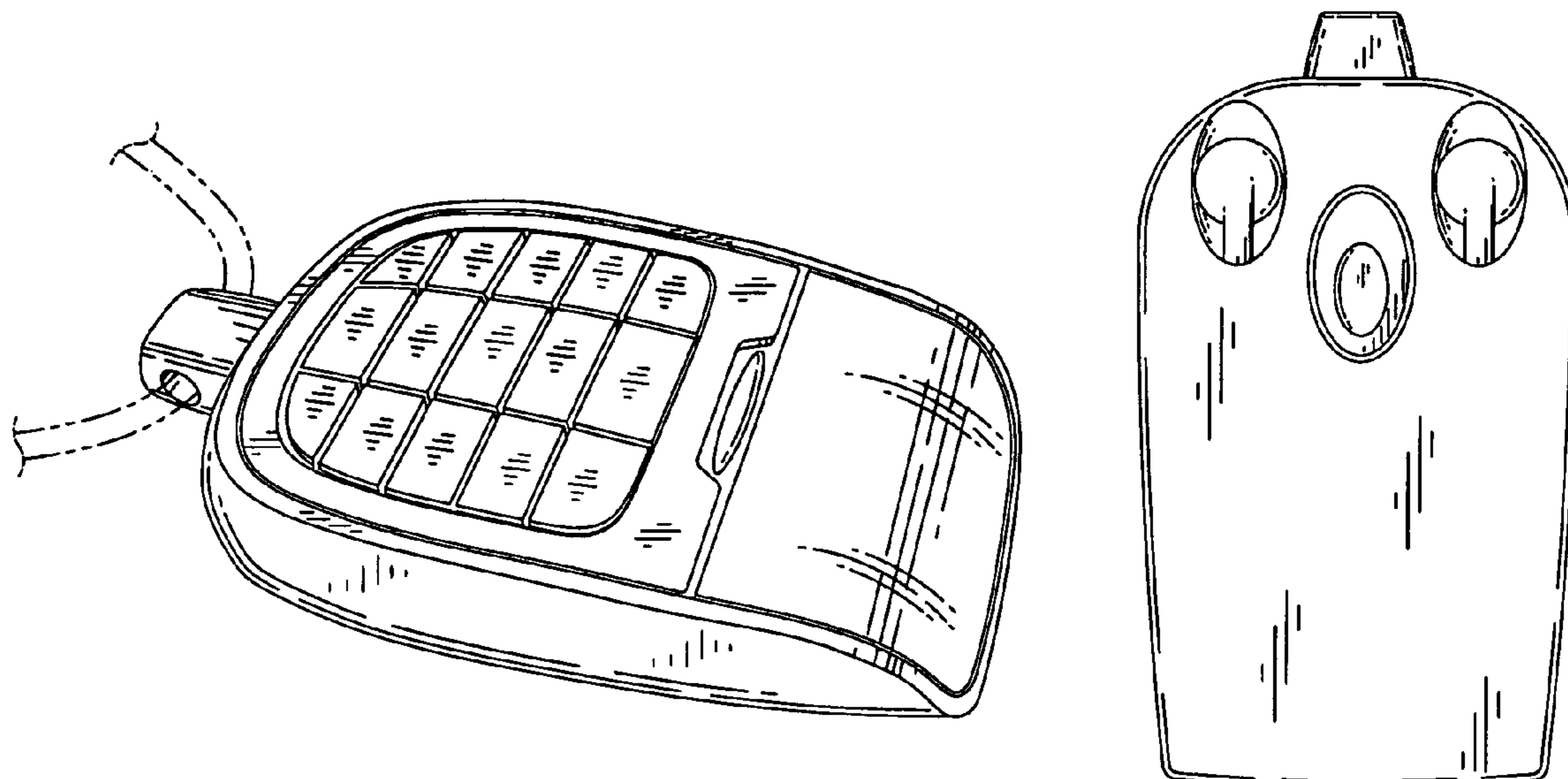
FIG. 6 is a front elevational view thereof;

FIG. 5 is a side elevational view thereof, taken from the left of FIG. 6;

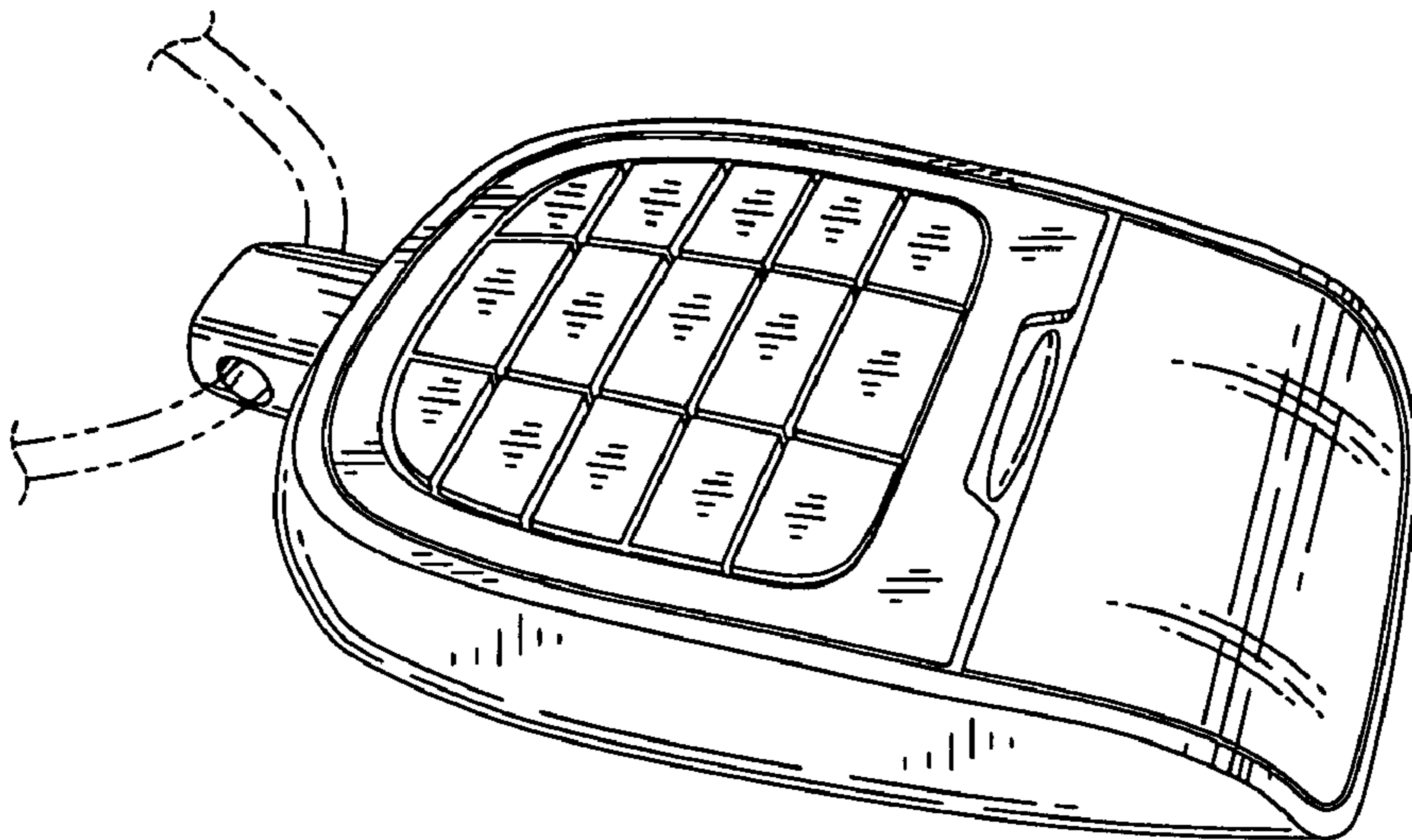

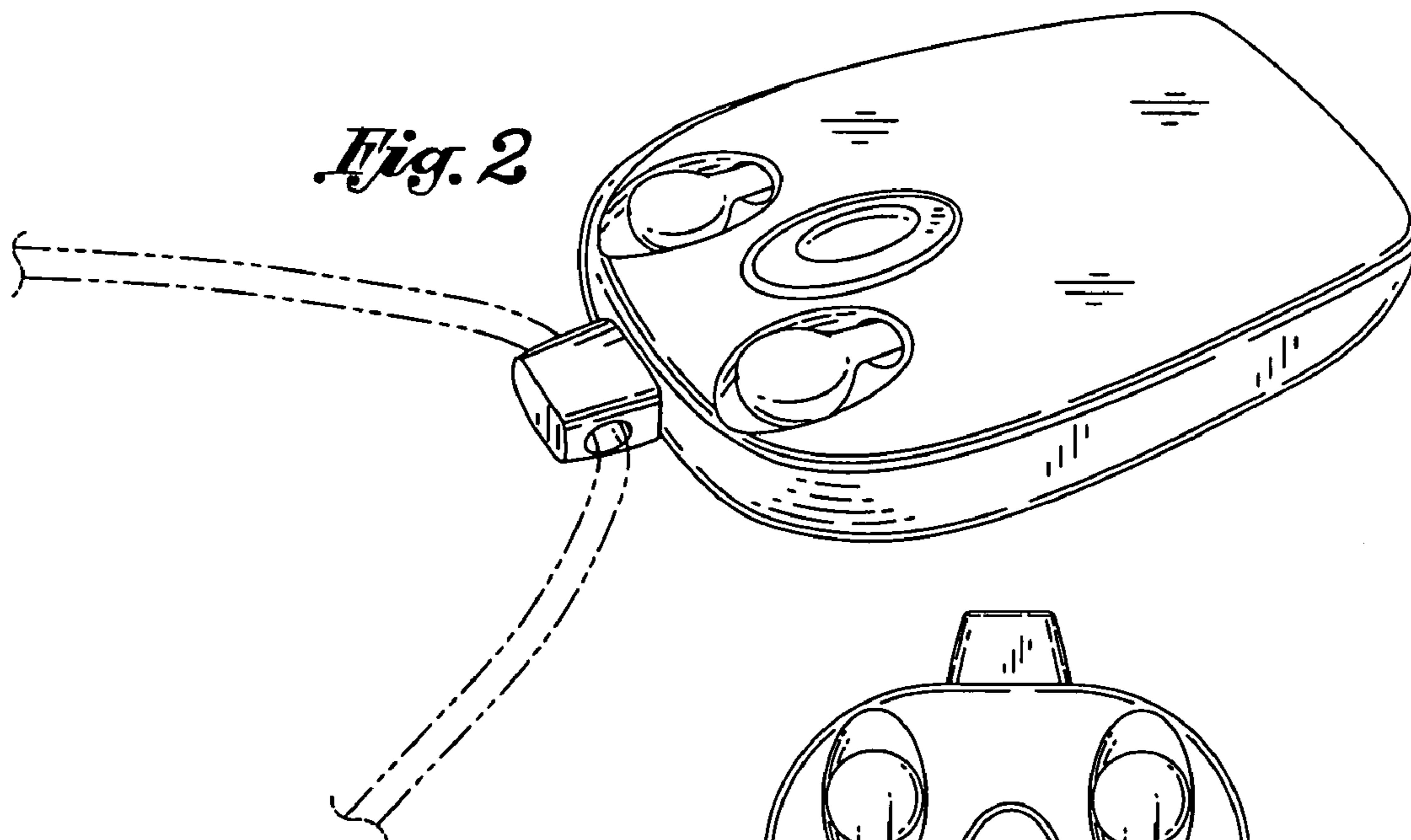

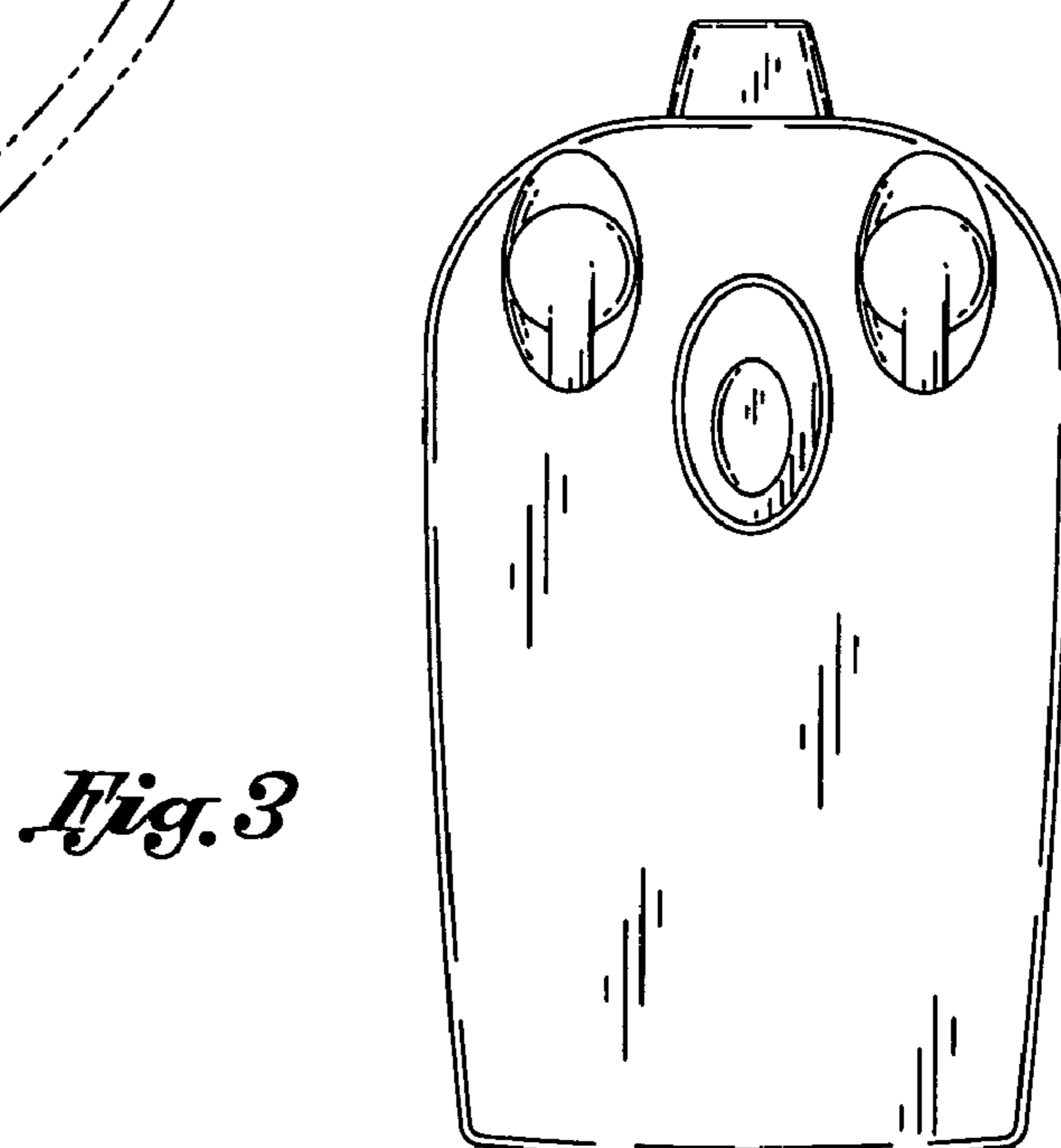

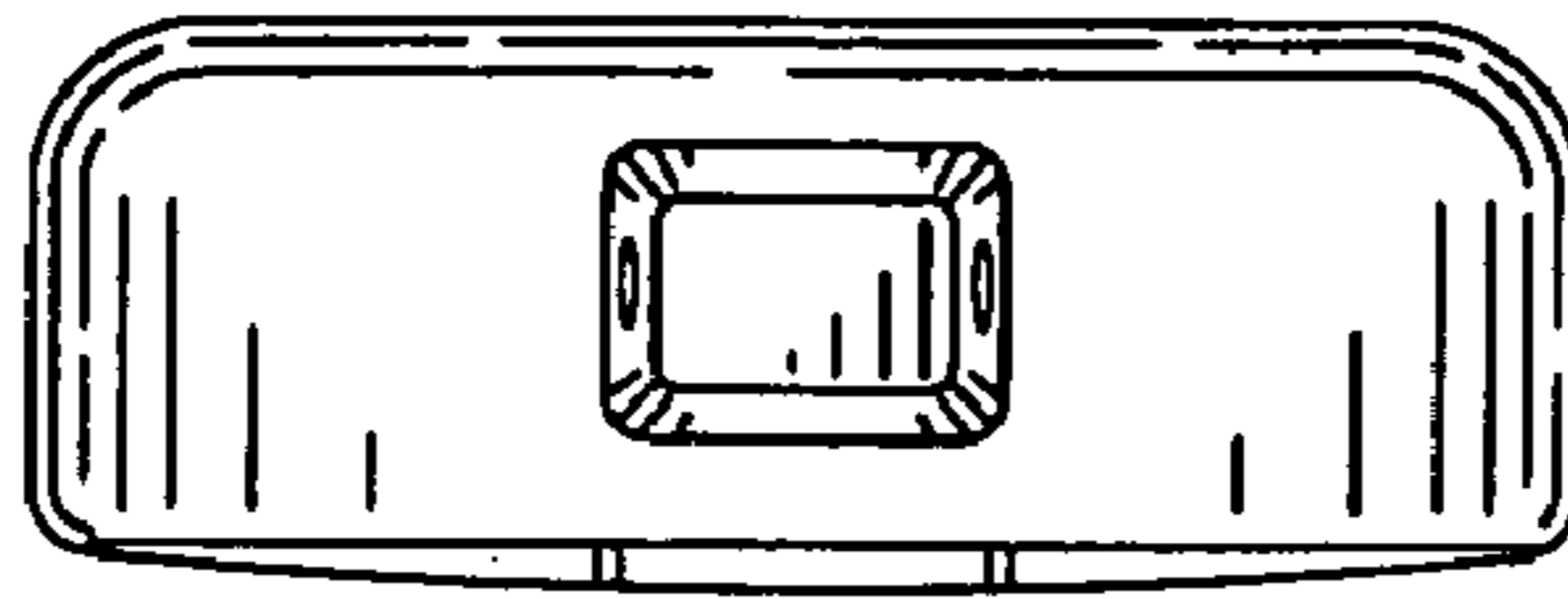

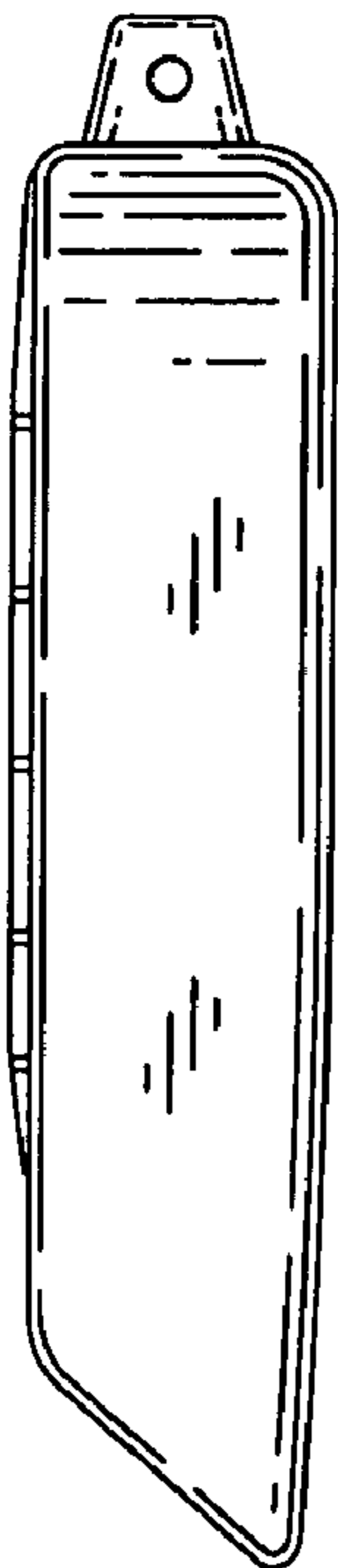

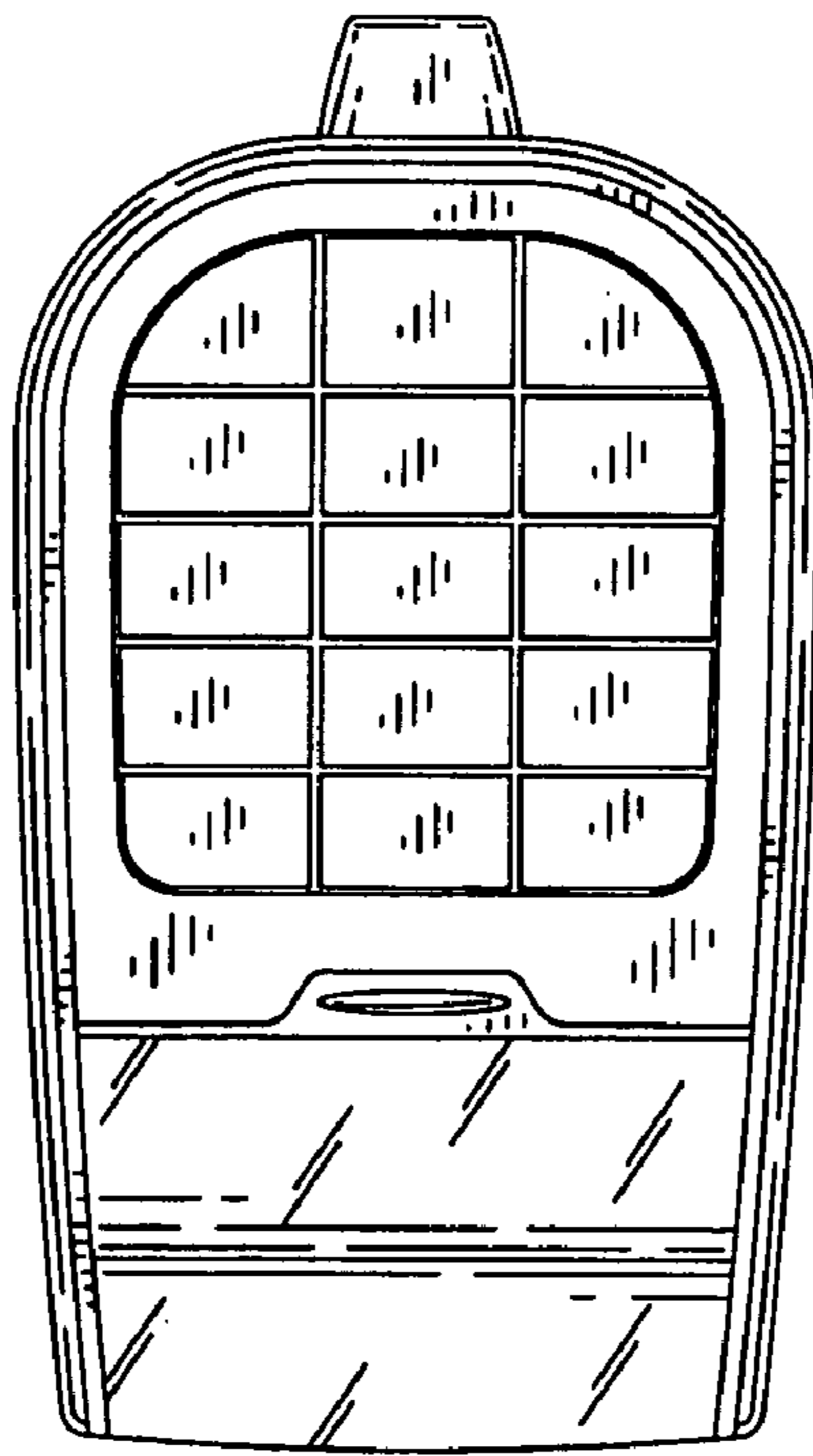

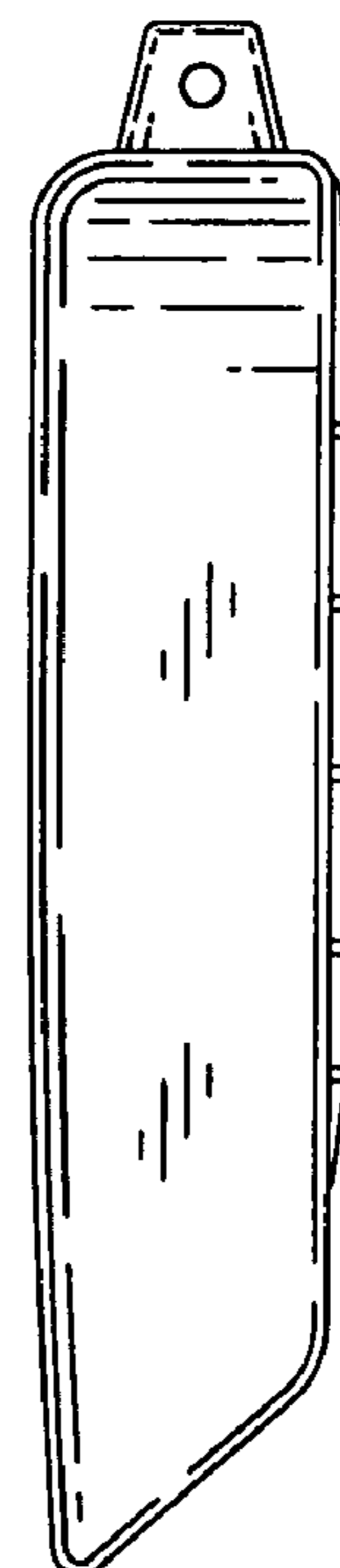

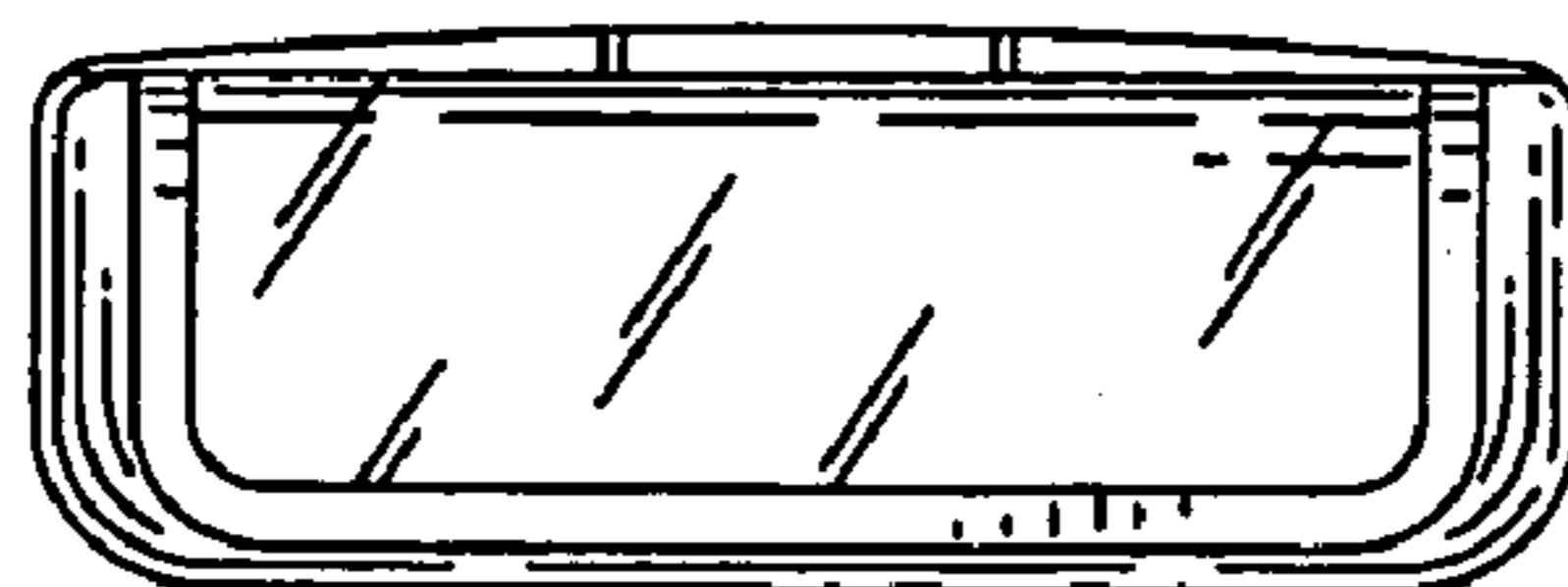
