I claim the ornamental design for a personal computer, as shown and described.

**DESCRIPTION**

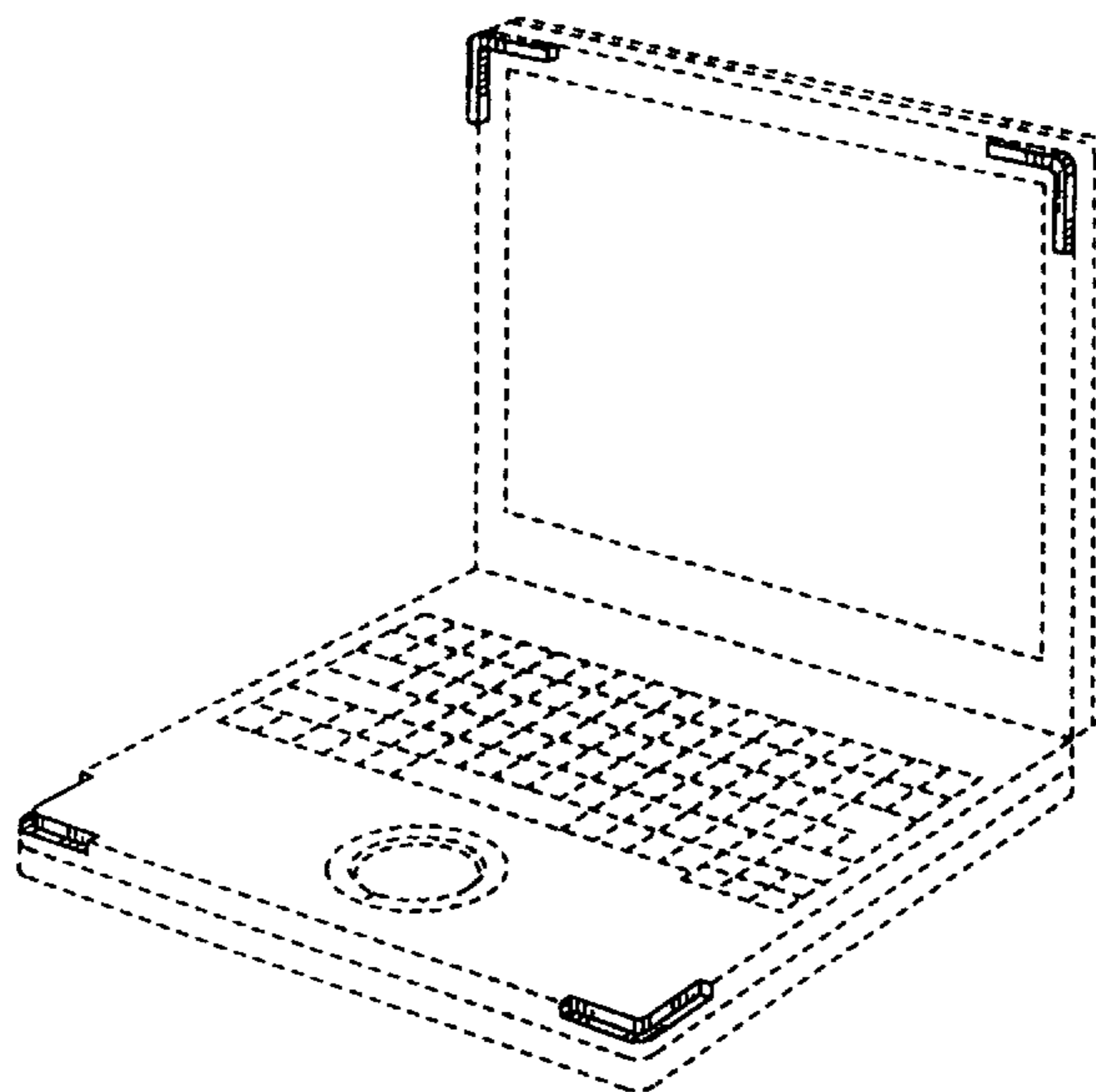

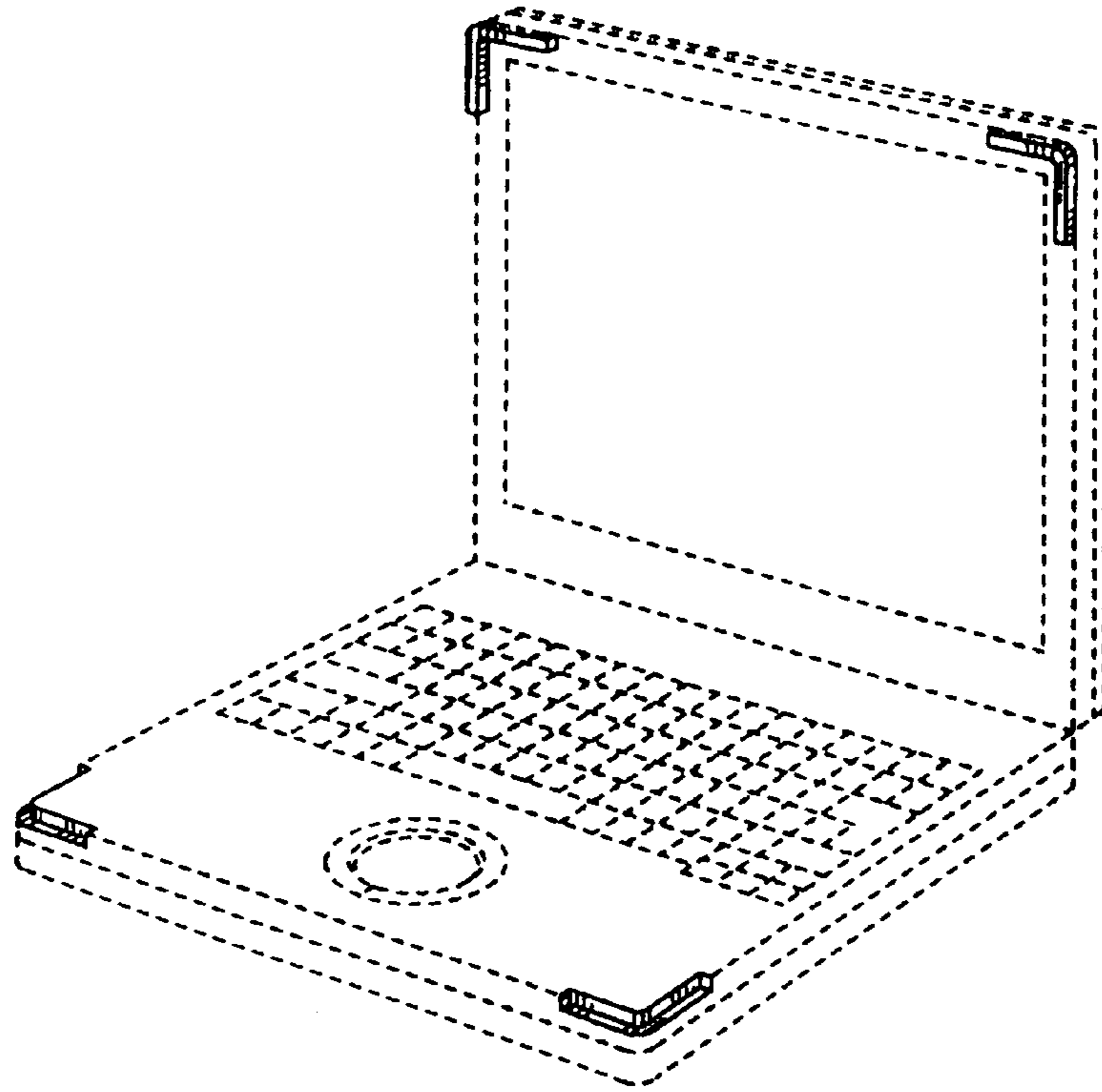

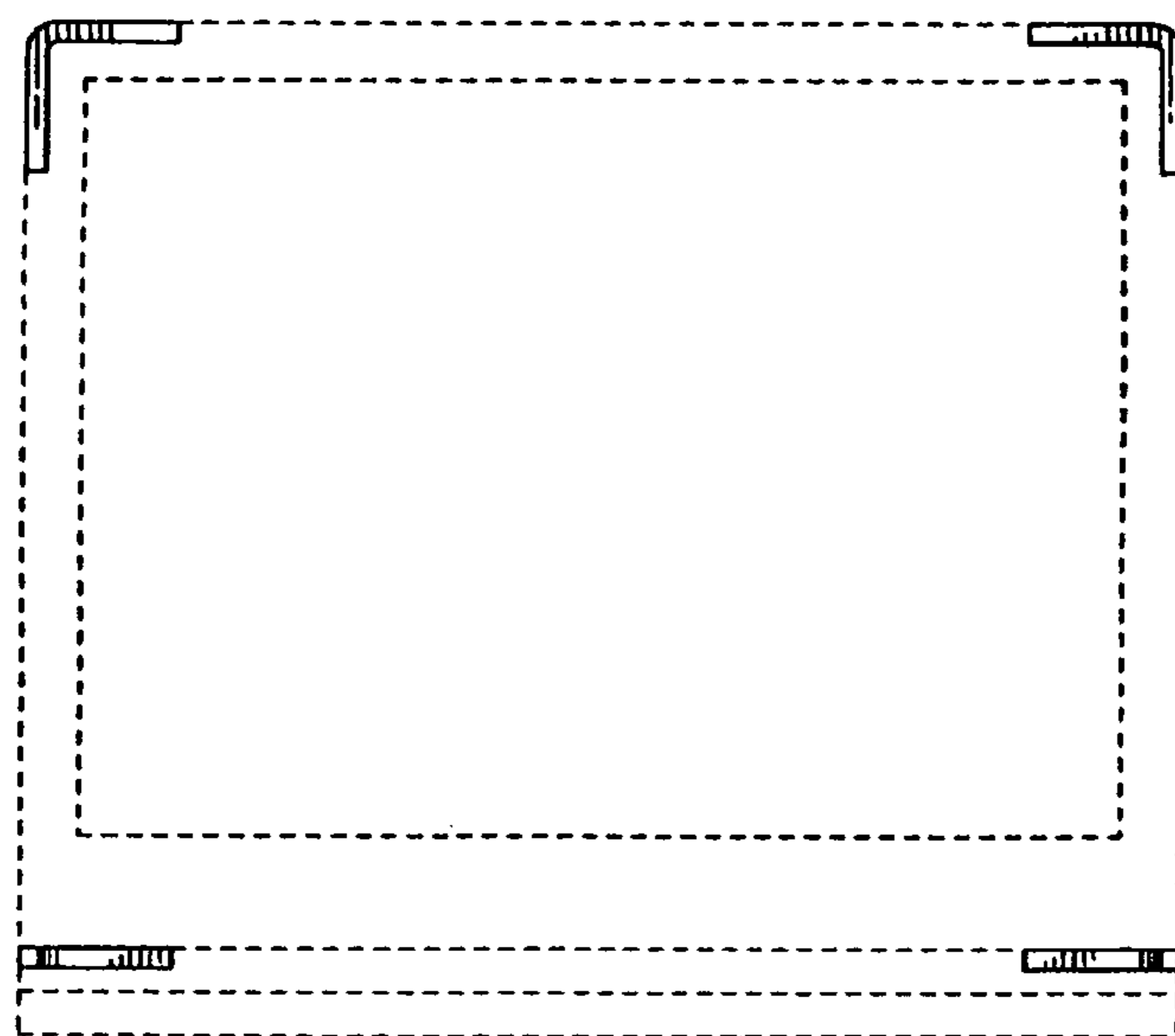

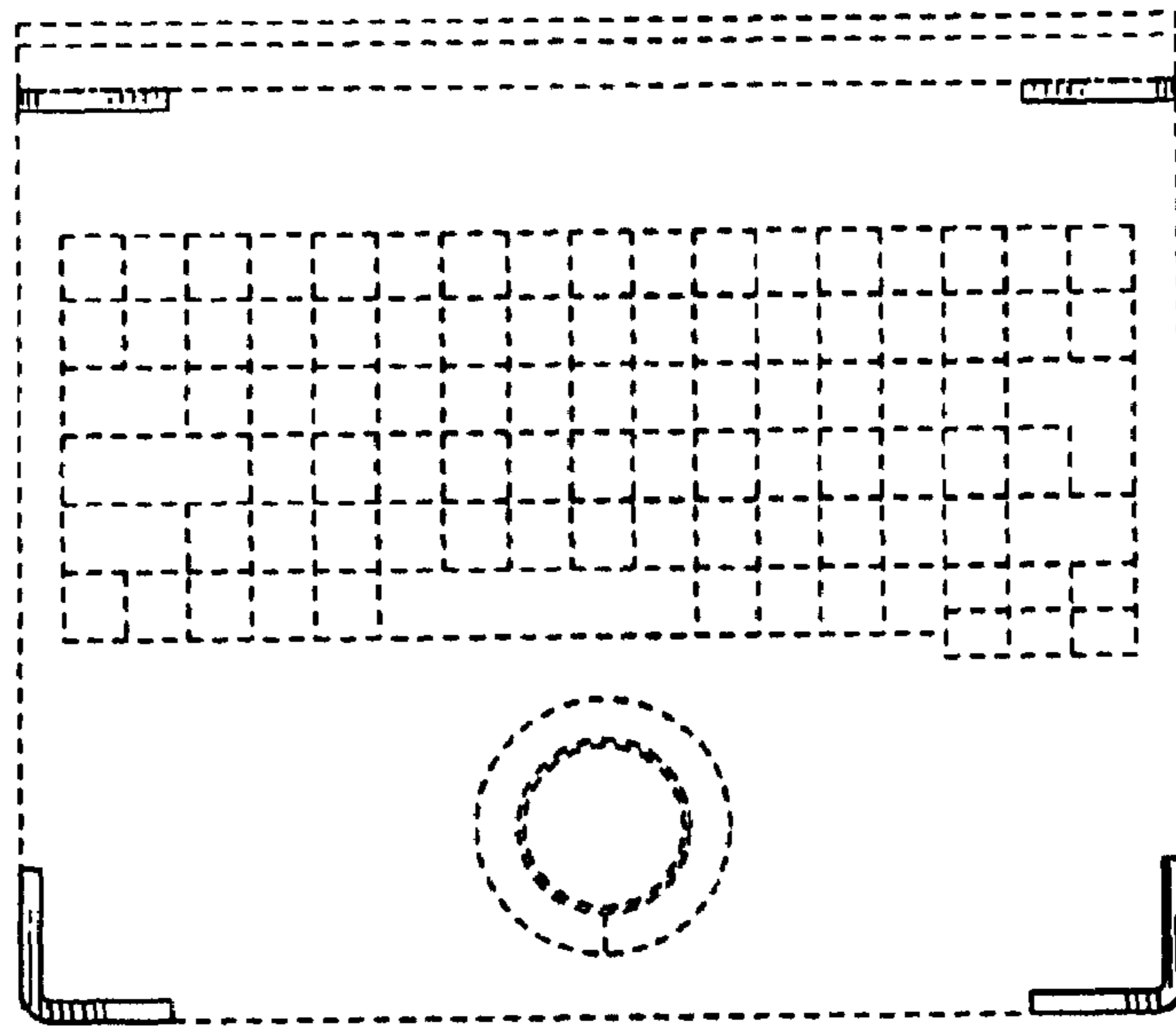

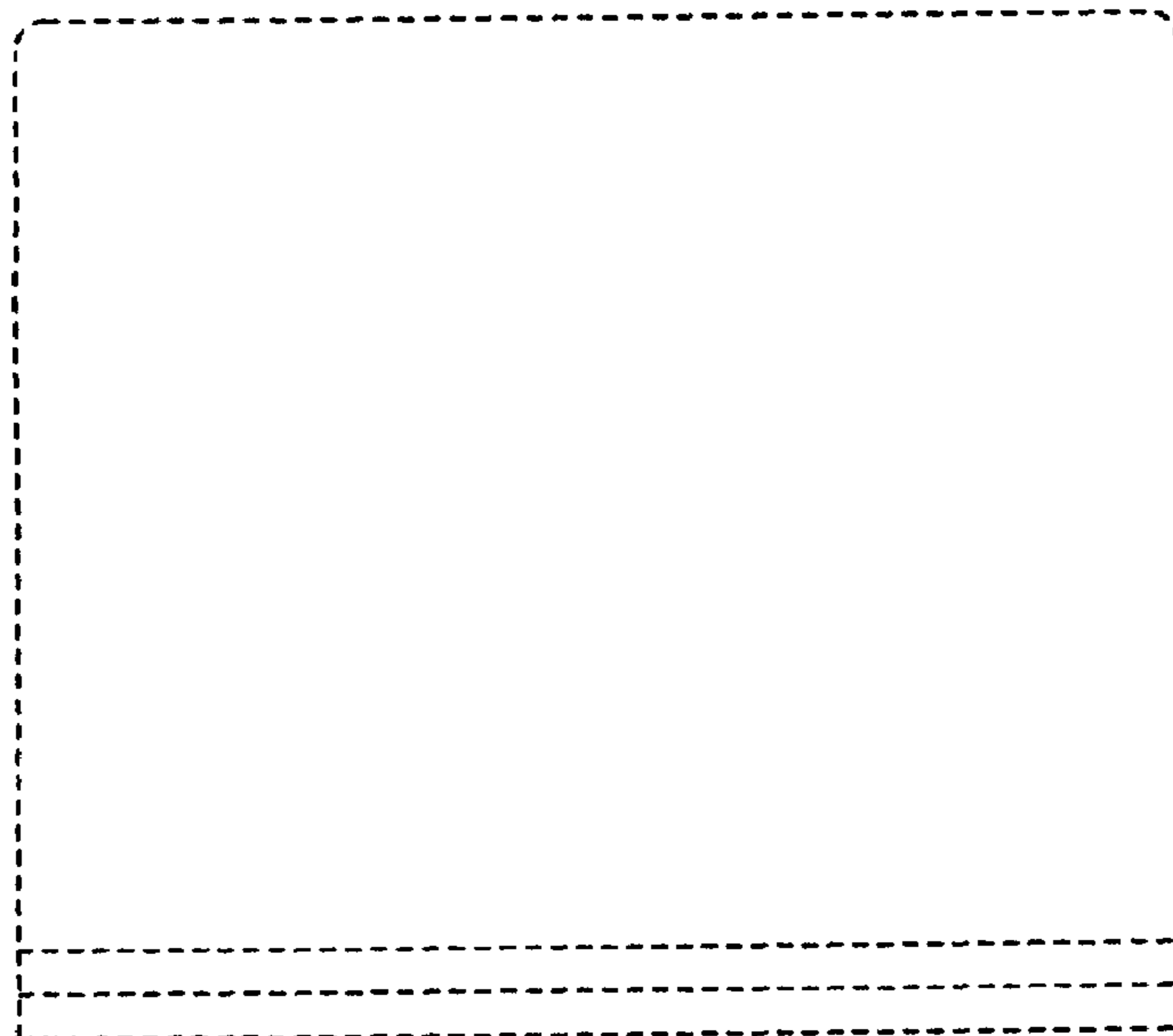

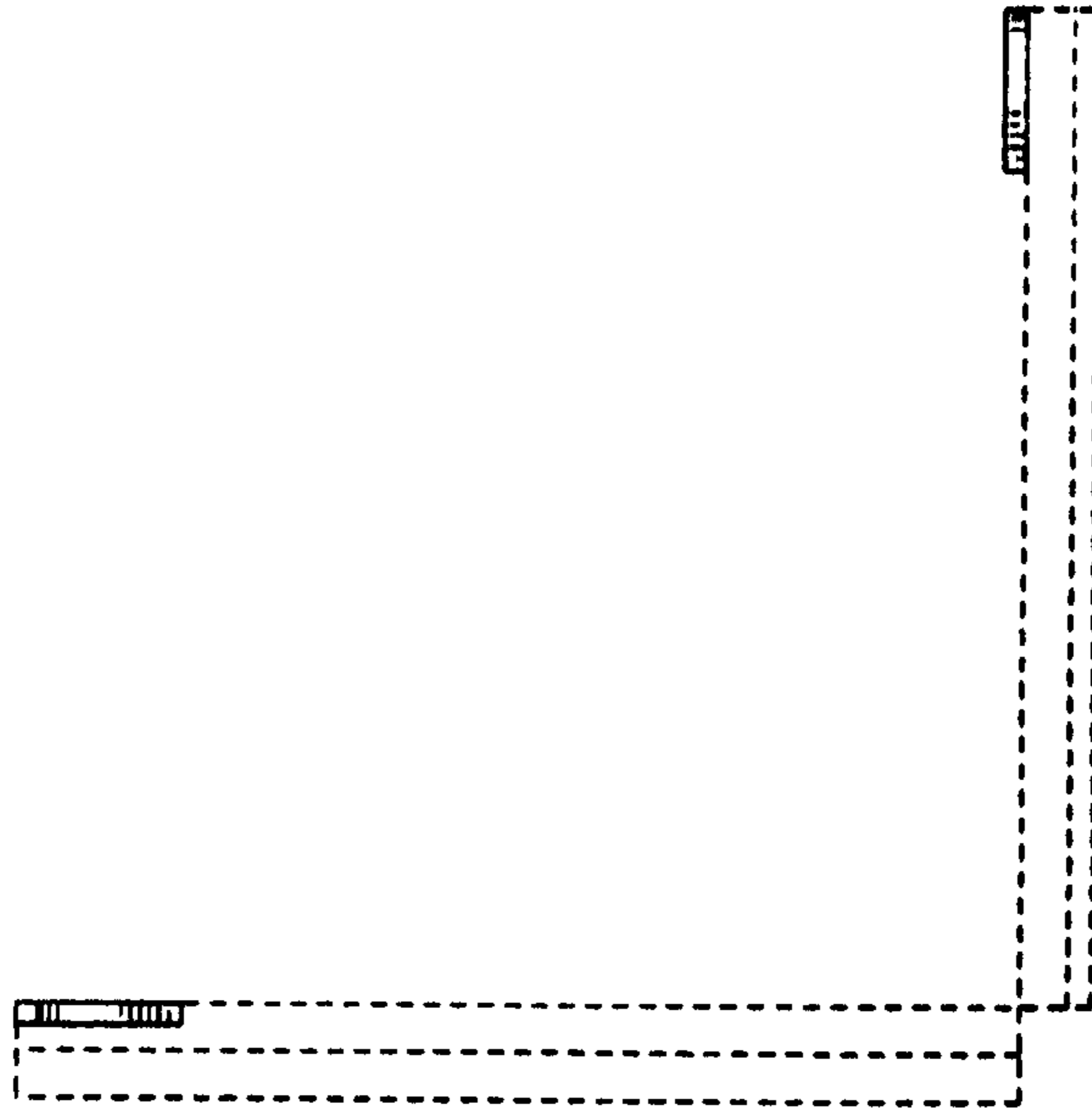

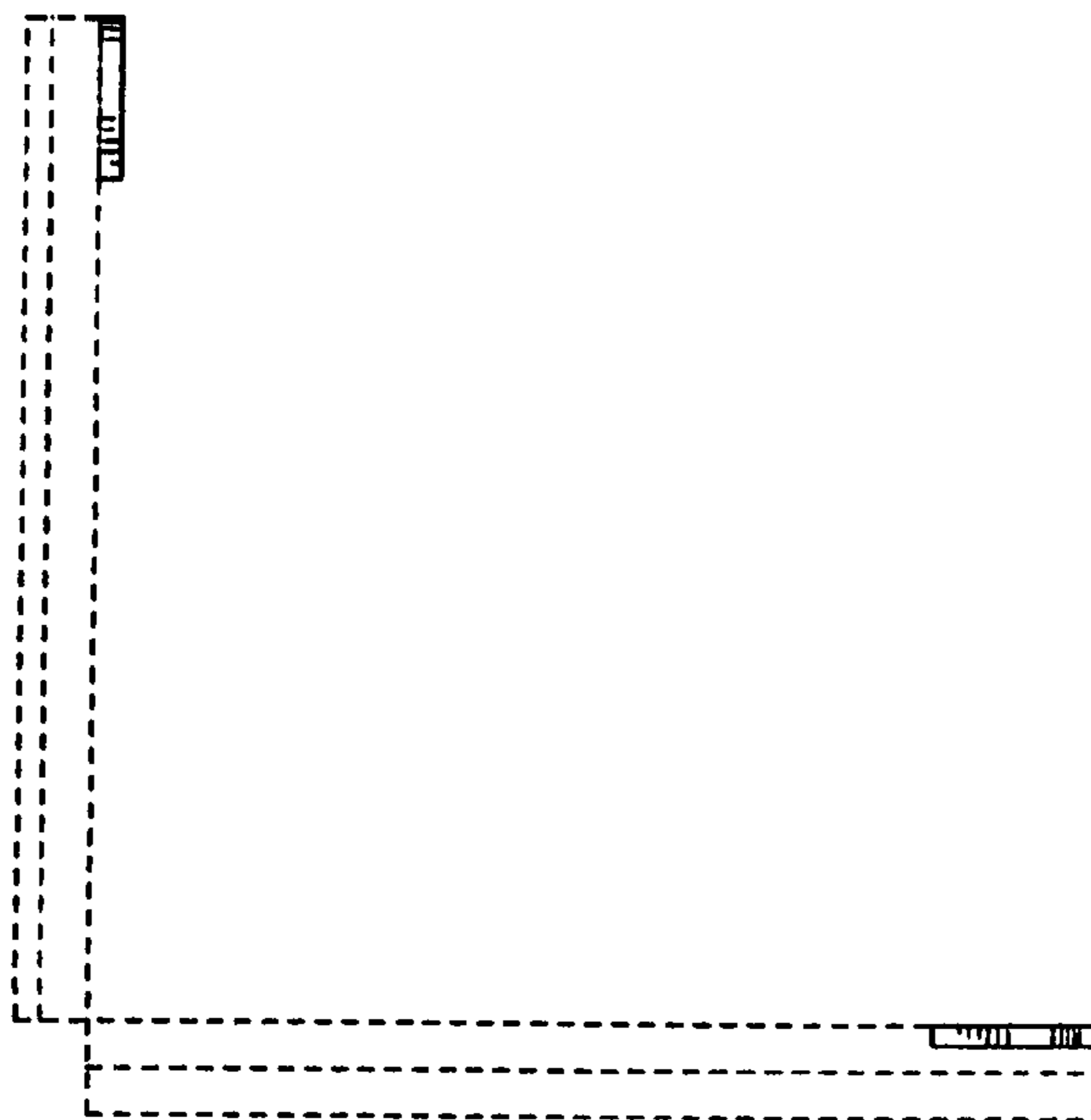

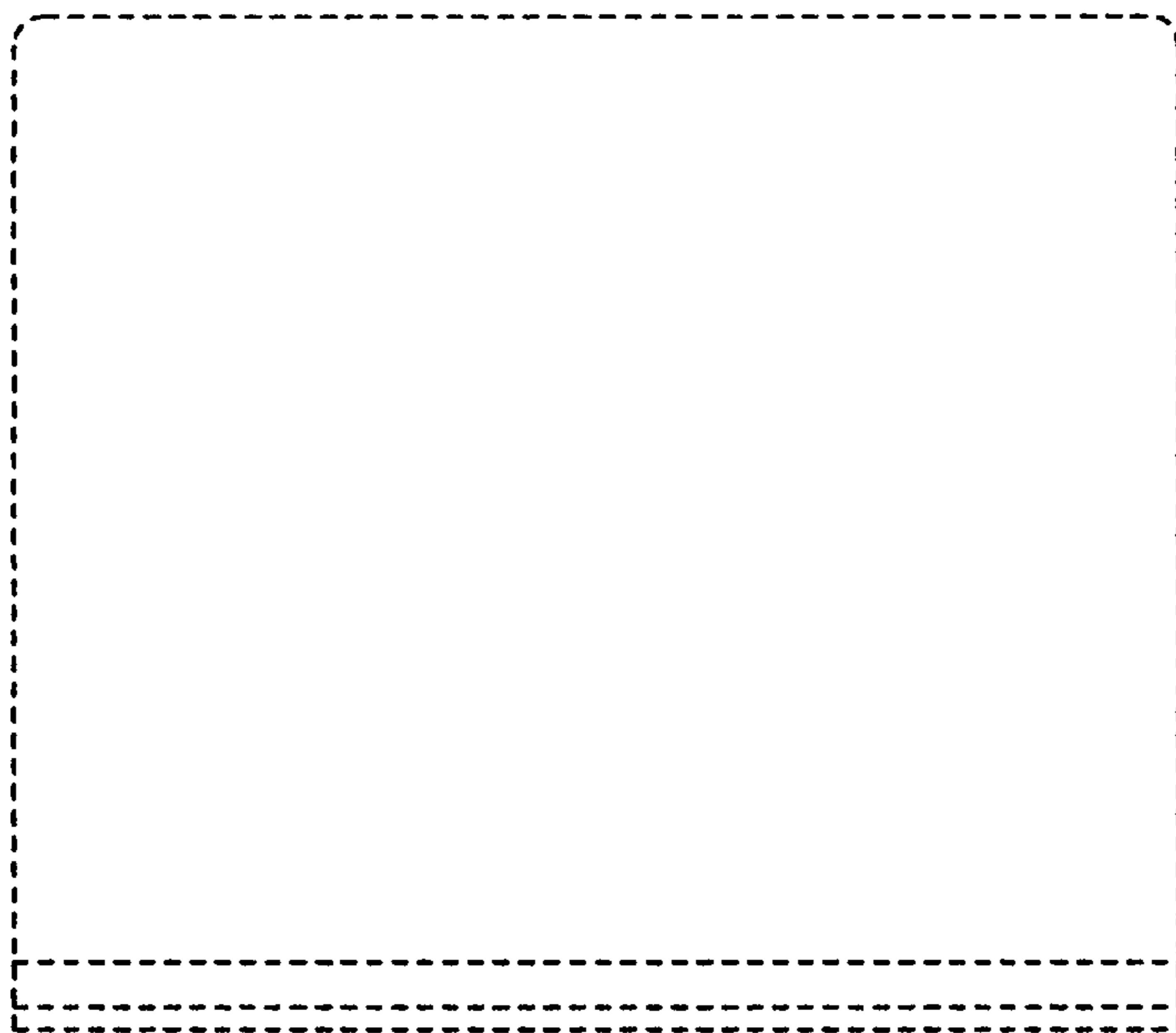
