FIG. 1 is a first embodiment of a projector screen with an image projected by a projector;

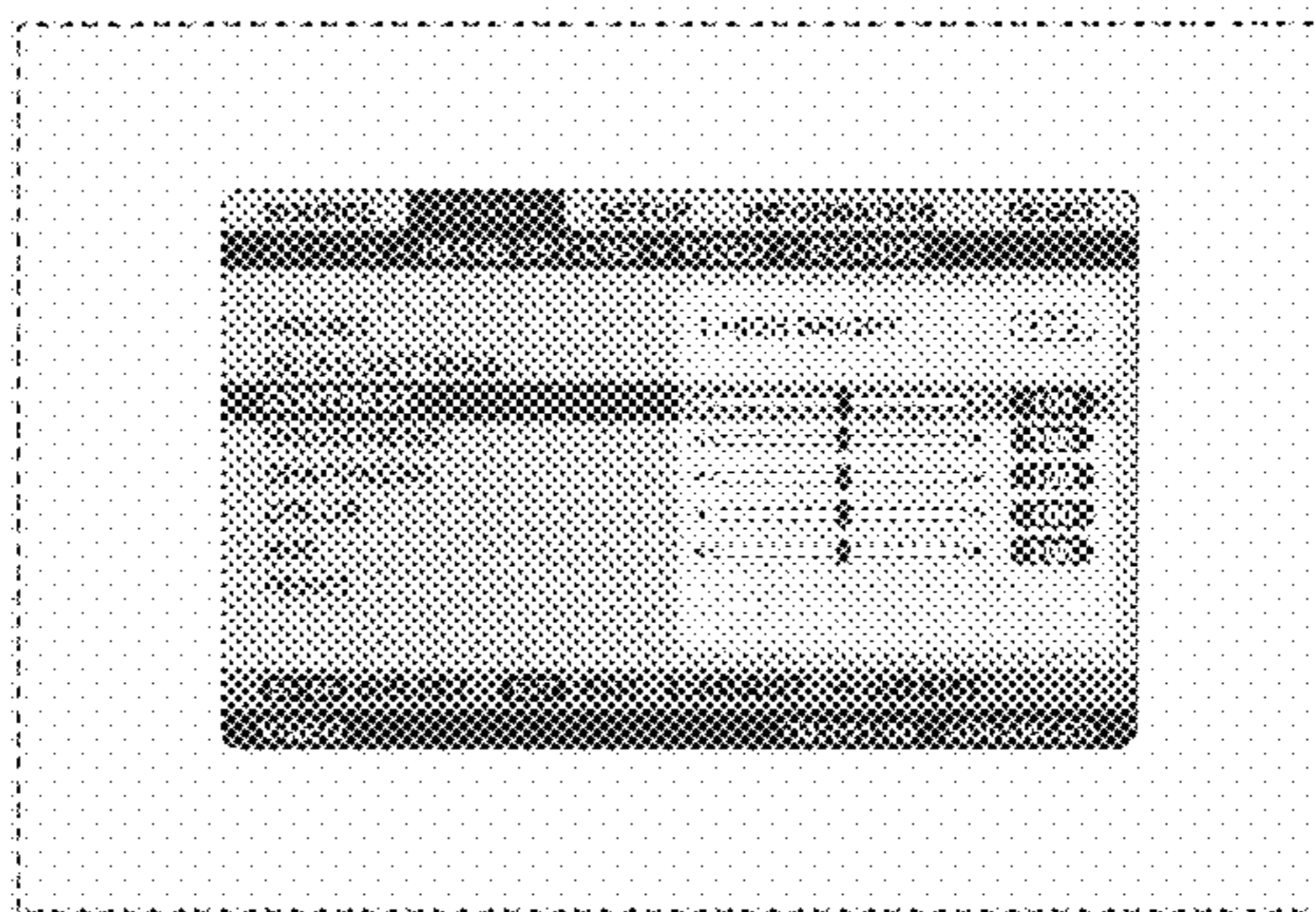
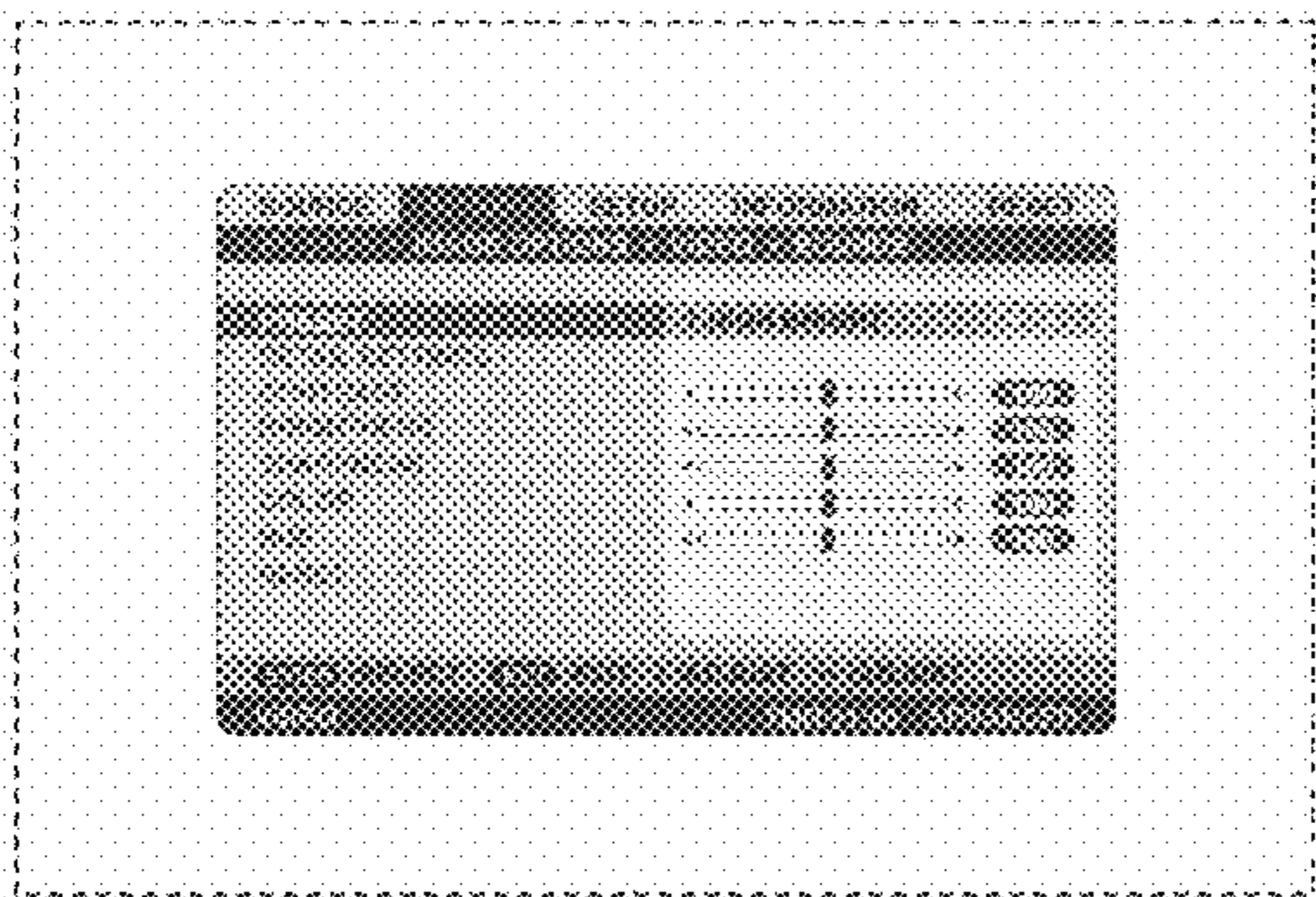
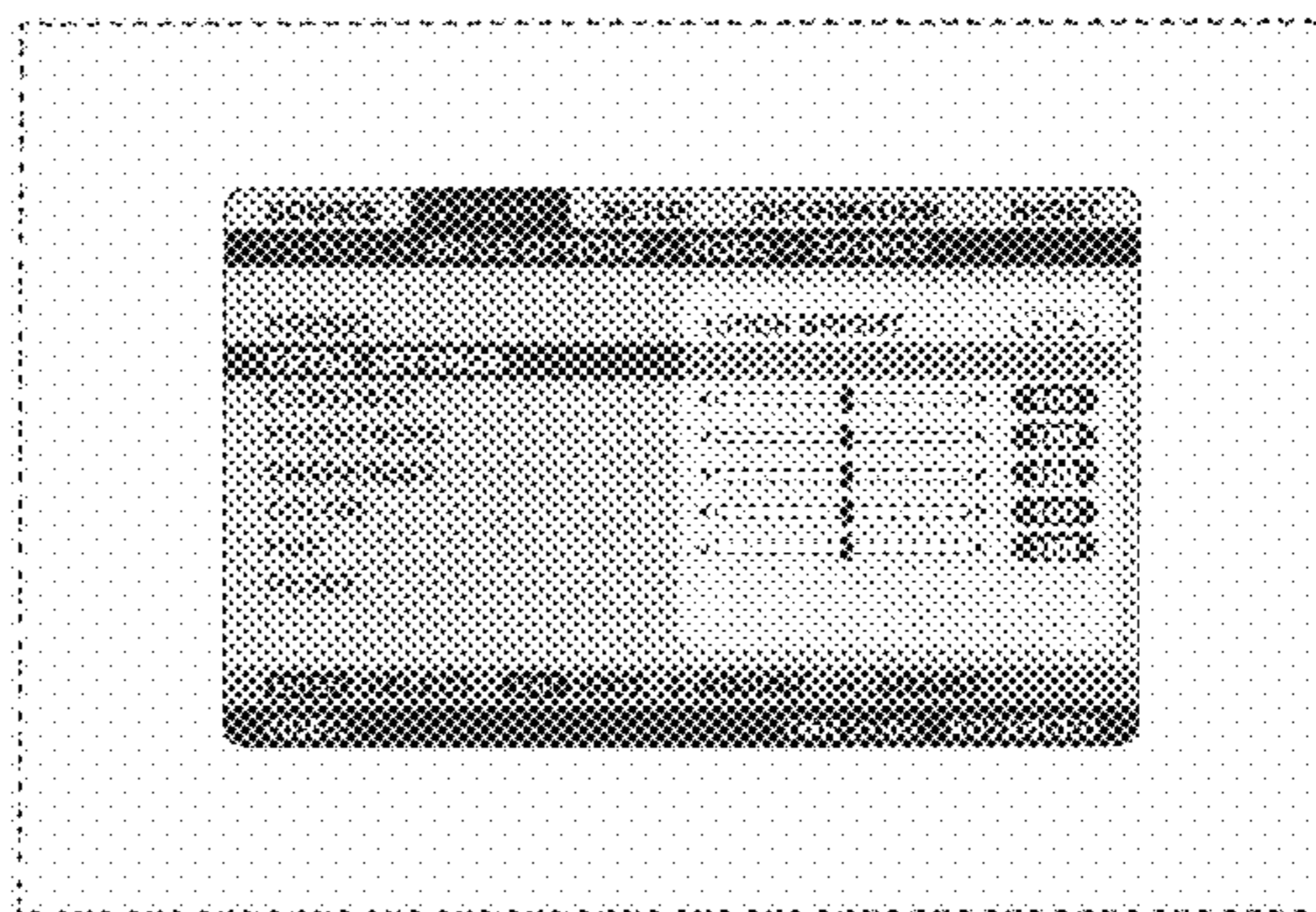
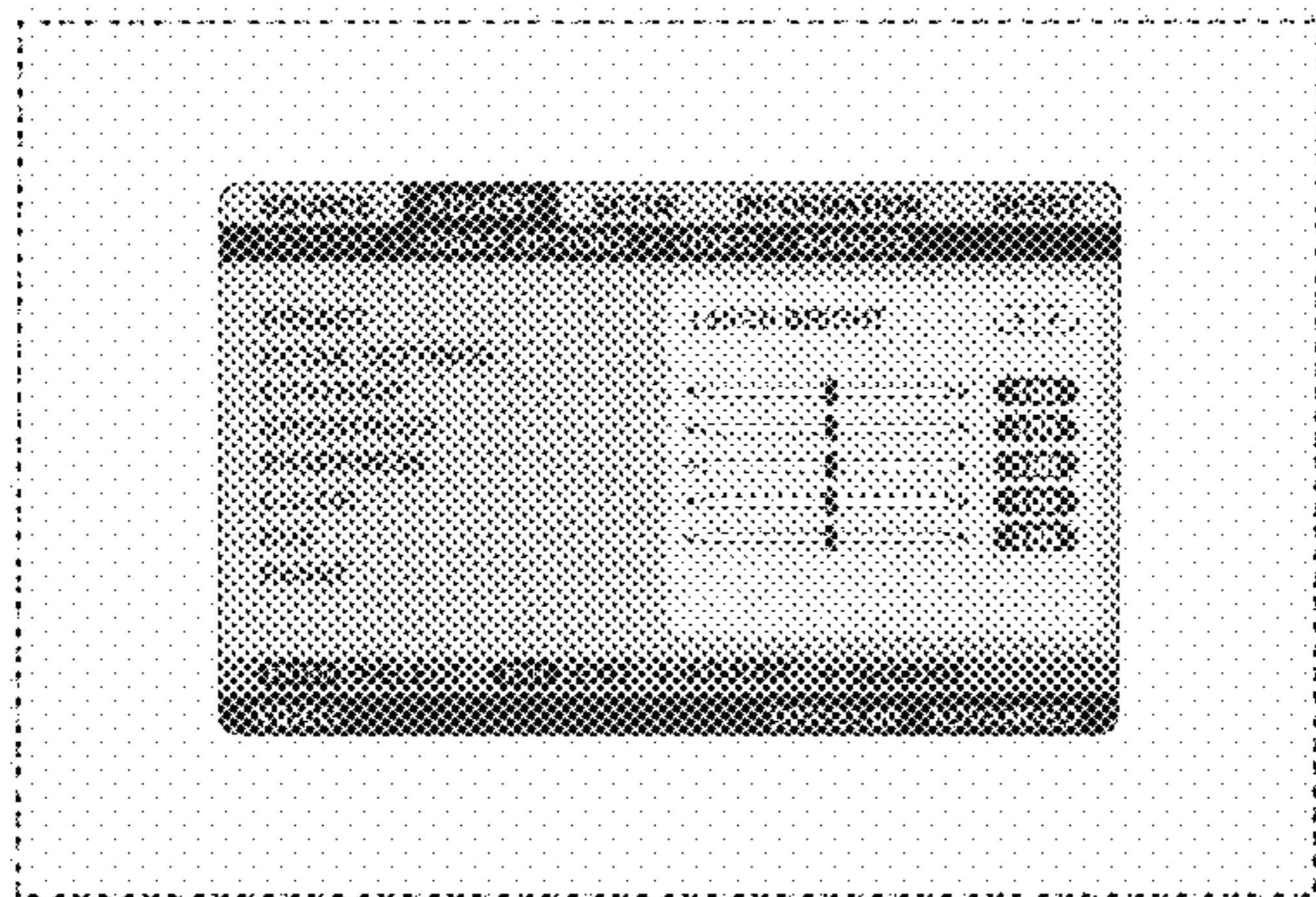
FIG. 2 is a second embodiment of a projector screen with an image projected by a projector;

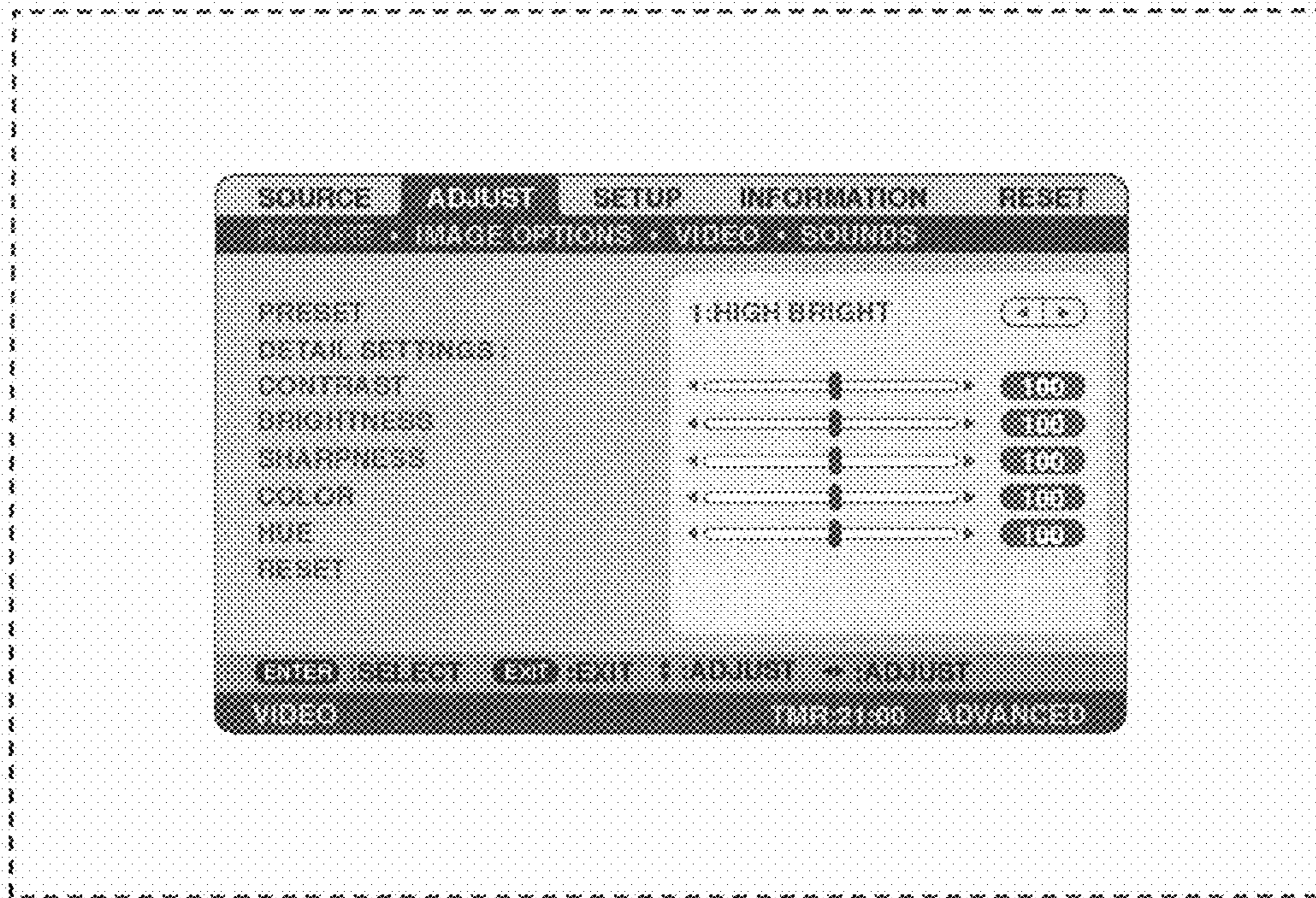

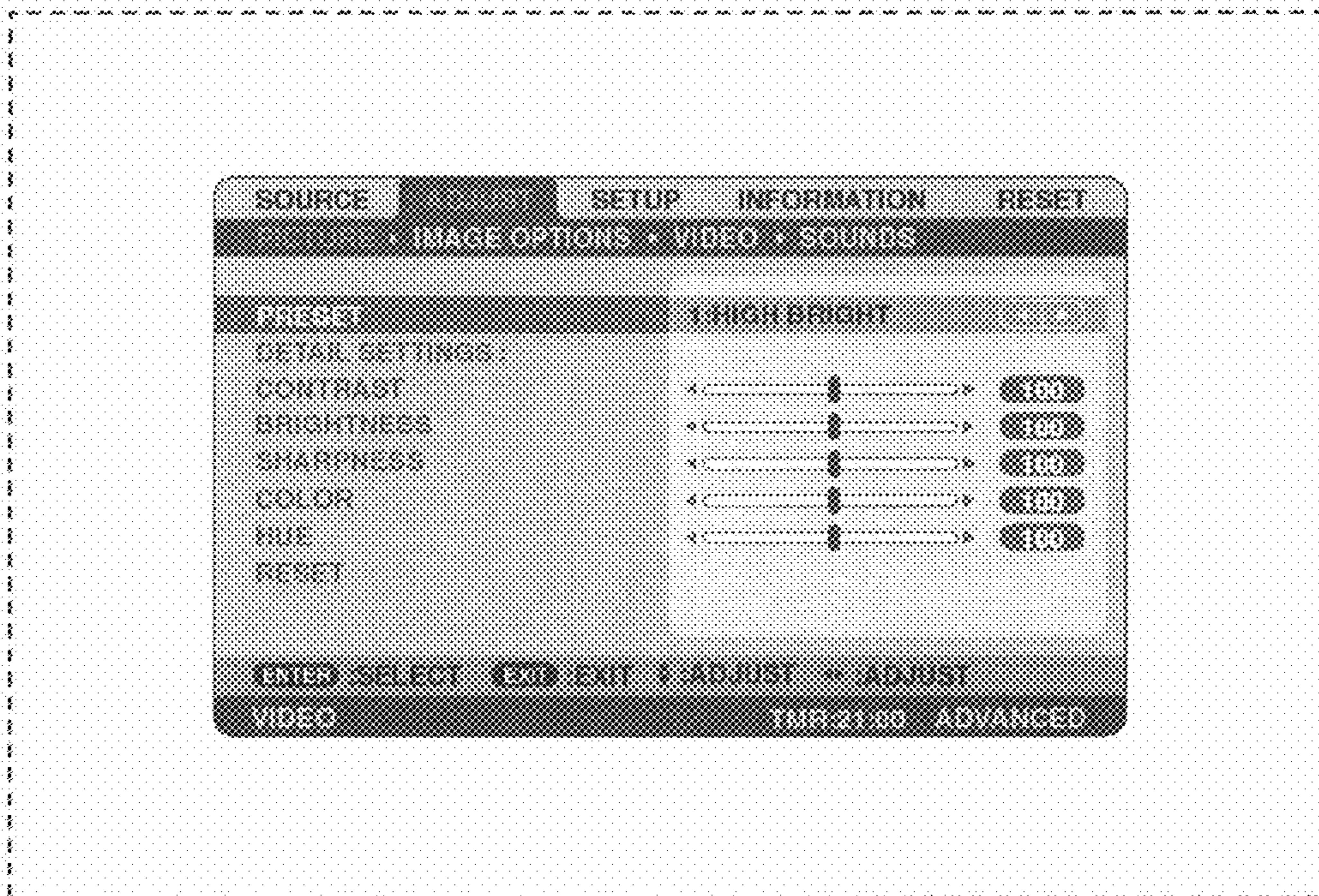

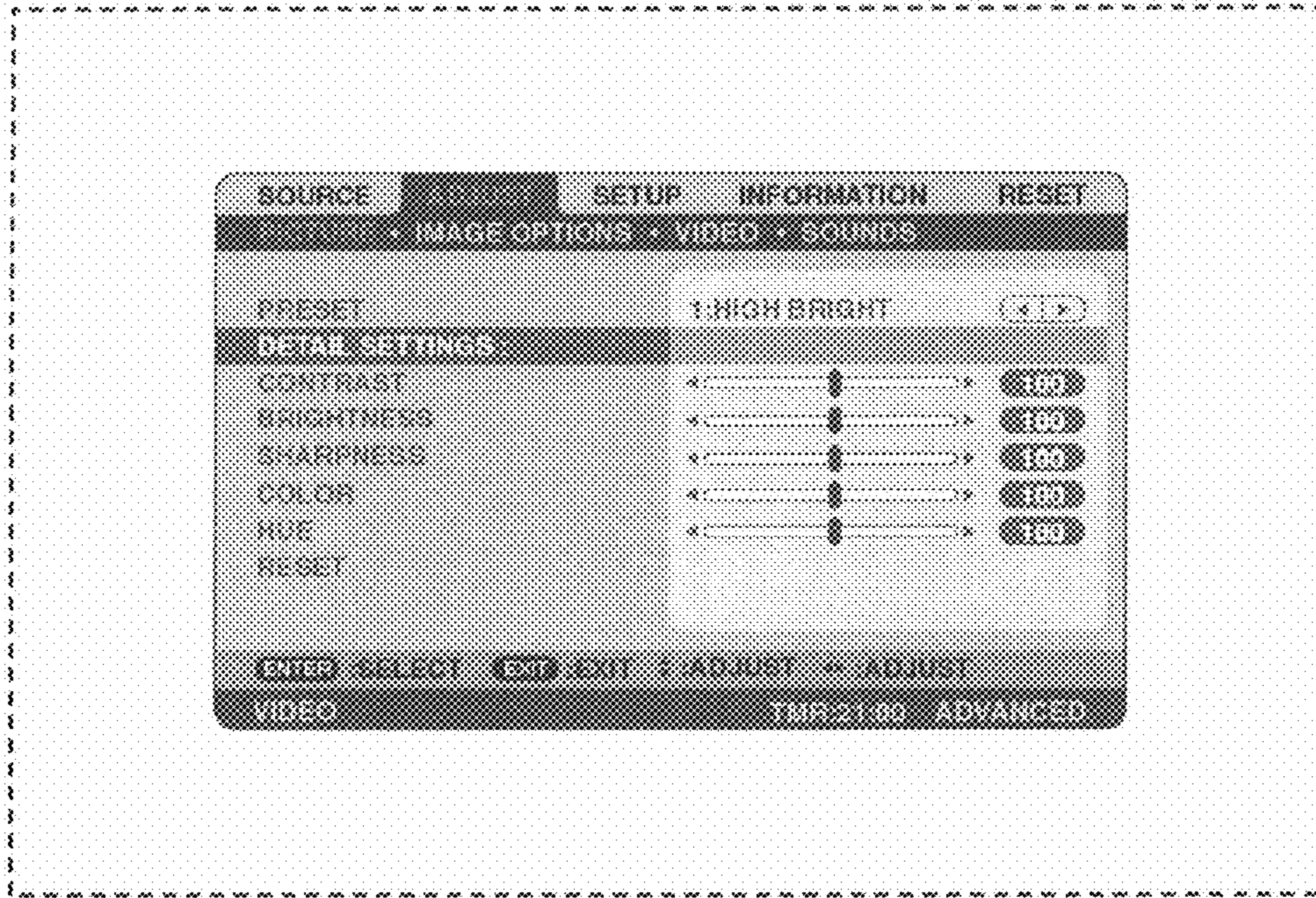

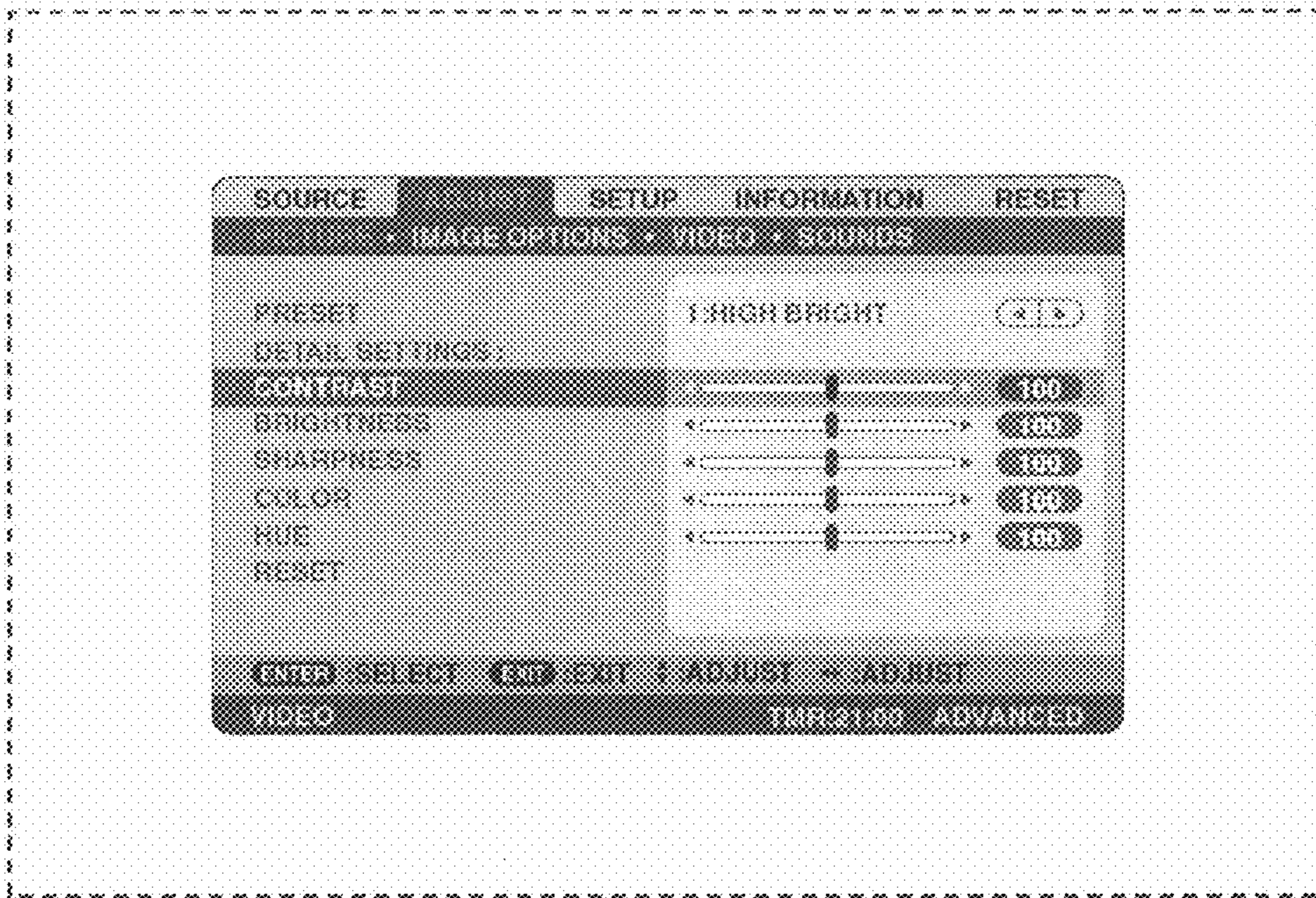
