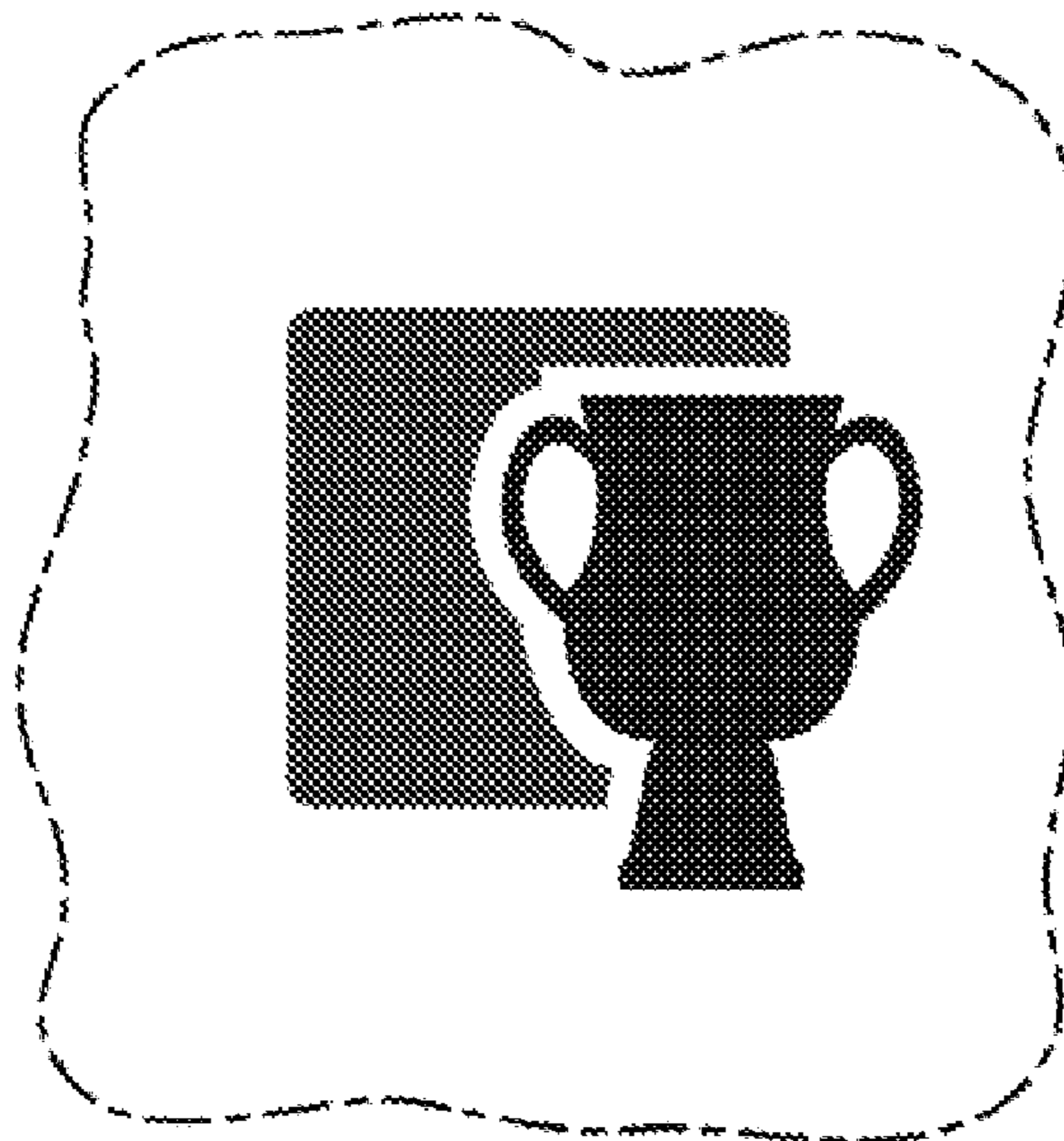

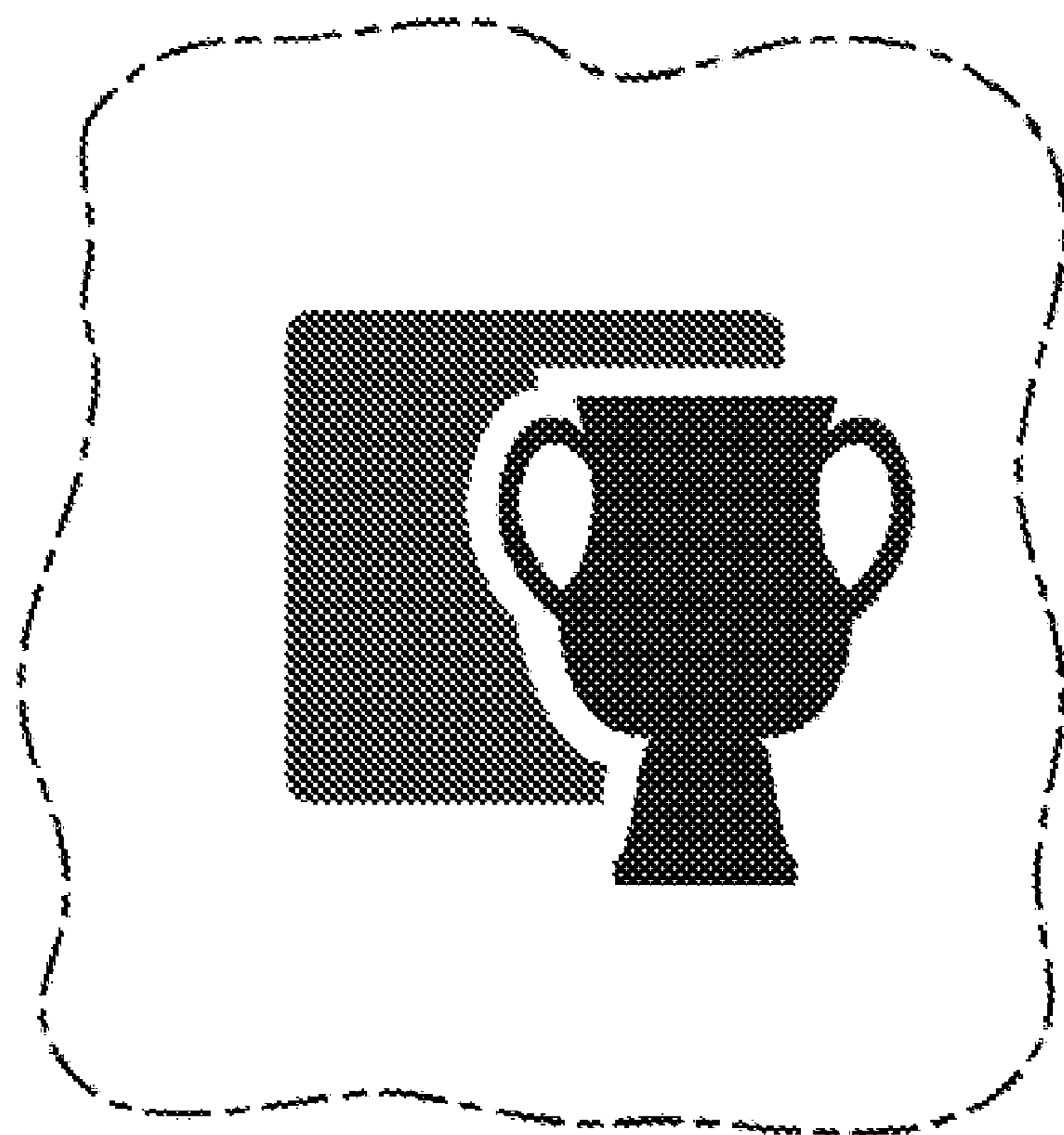
**DESCRIPTION**

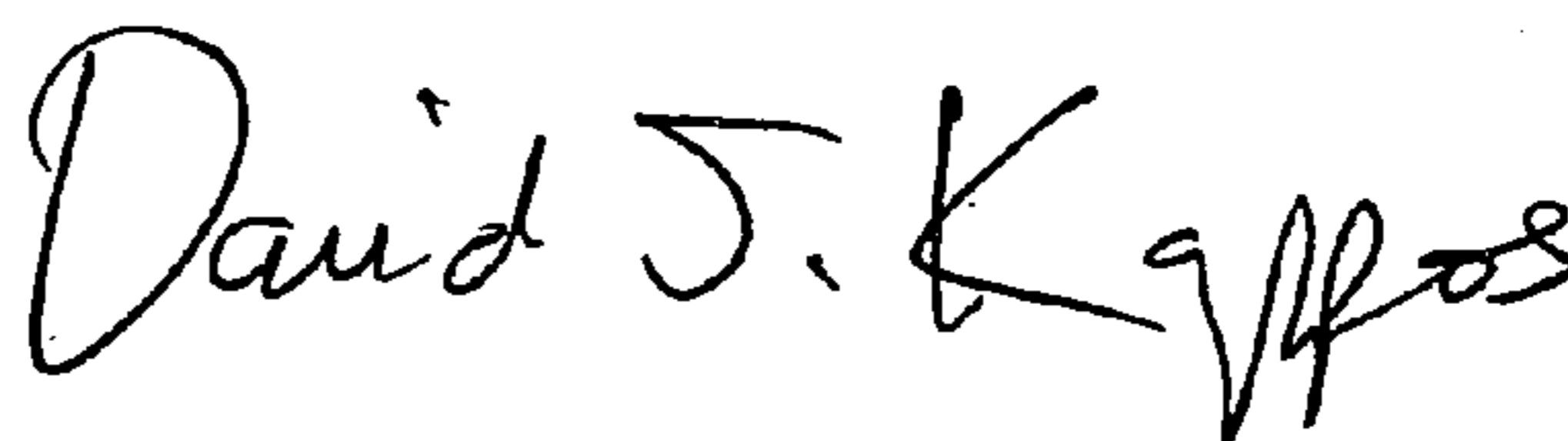

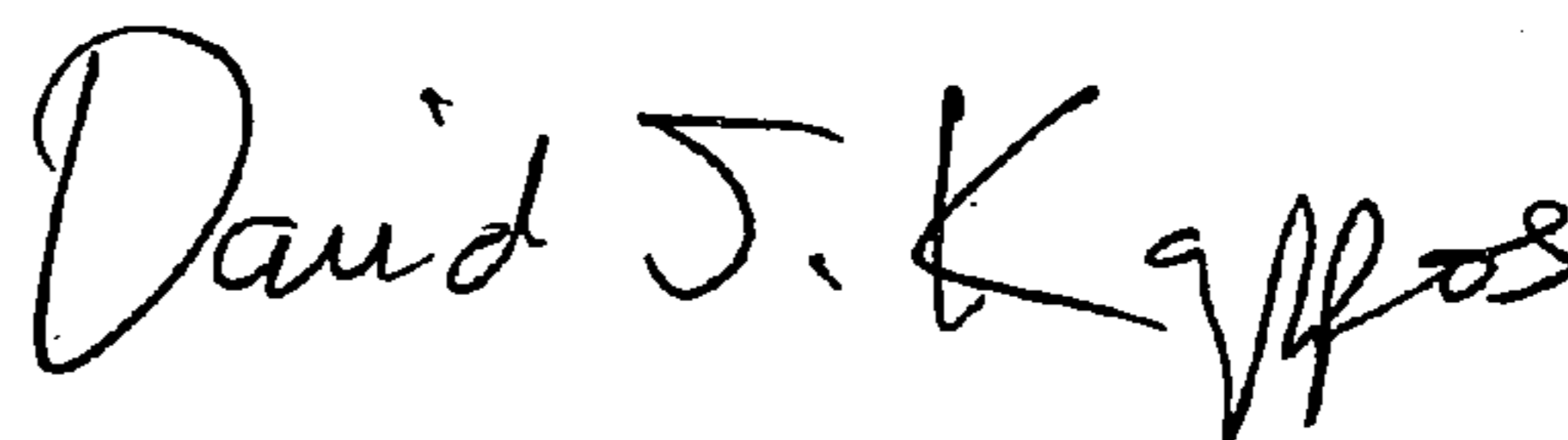
