FIG. 4 is a right-side view thereof, shown at a reduced scale;

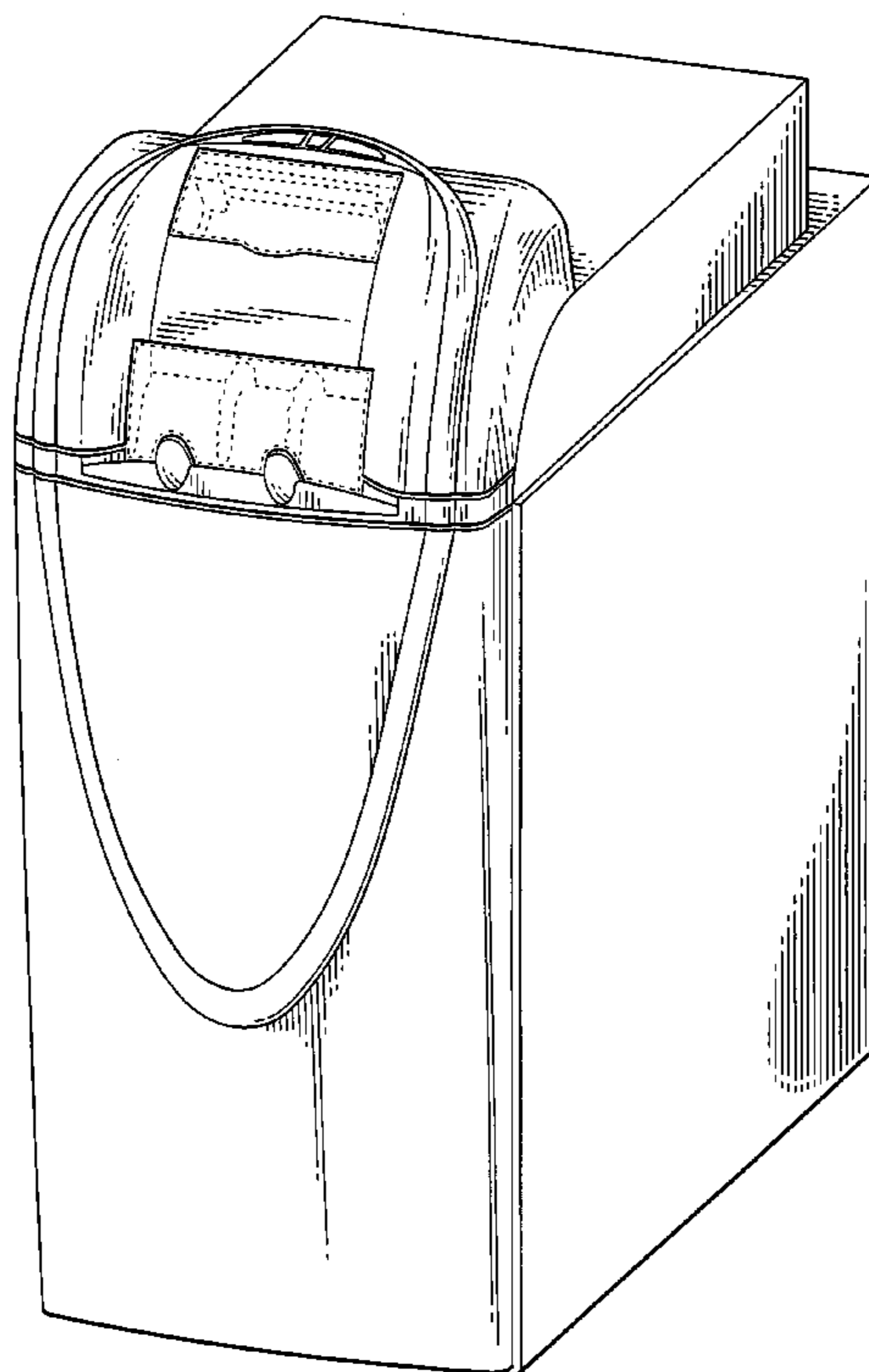
FIG. 5 is a left-side view thereof, shown at a reduced scale;

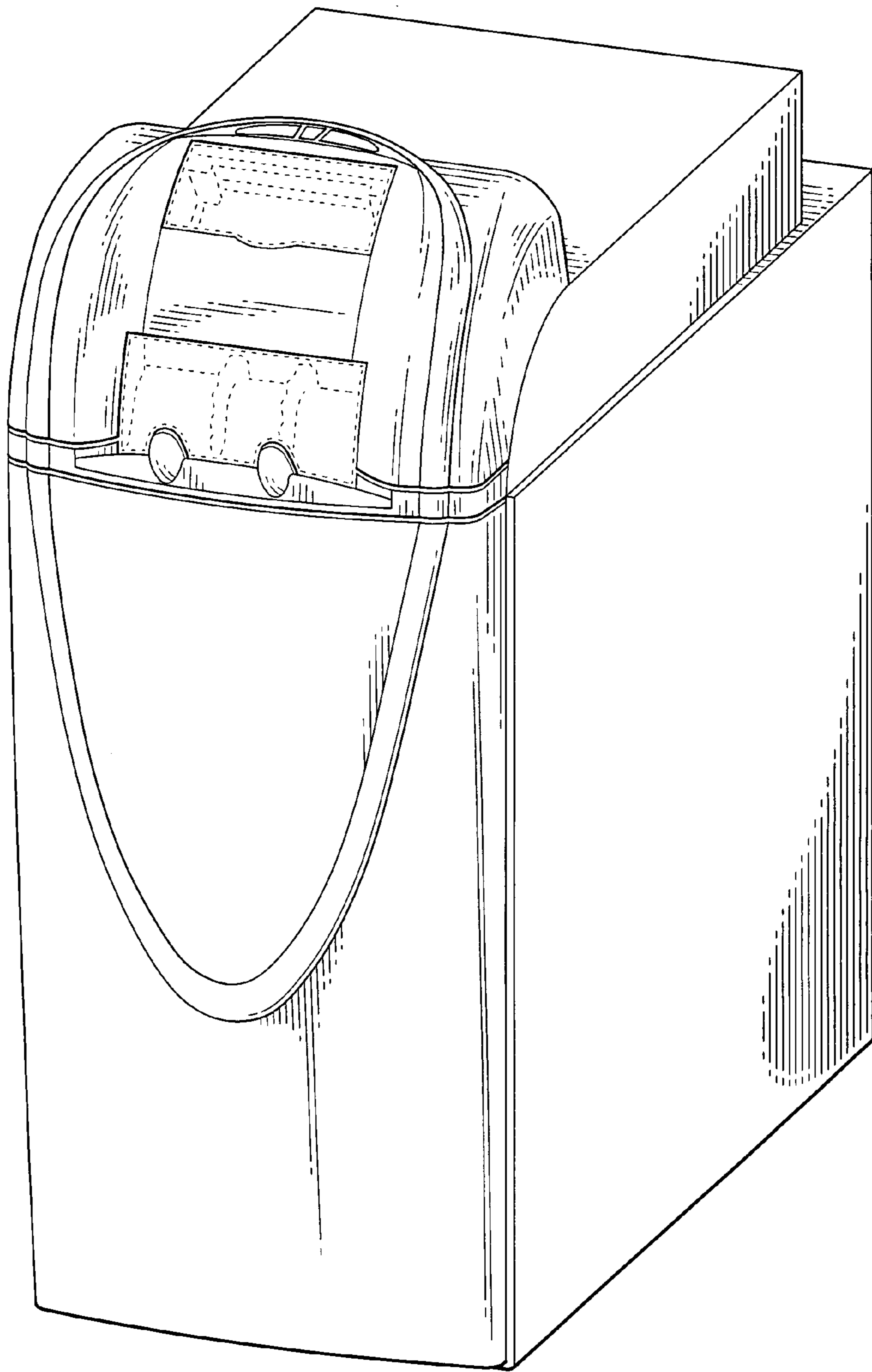

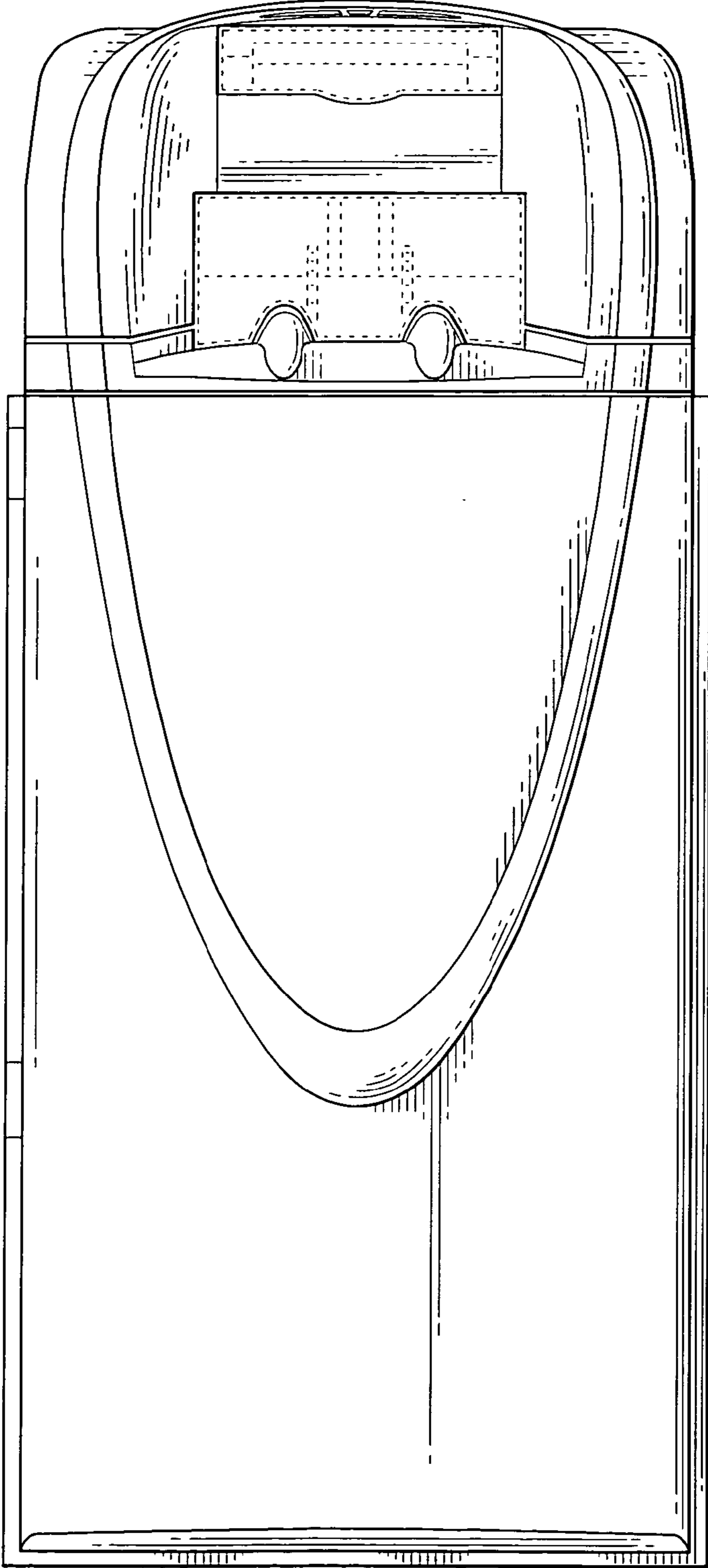

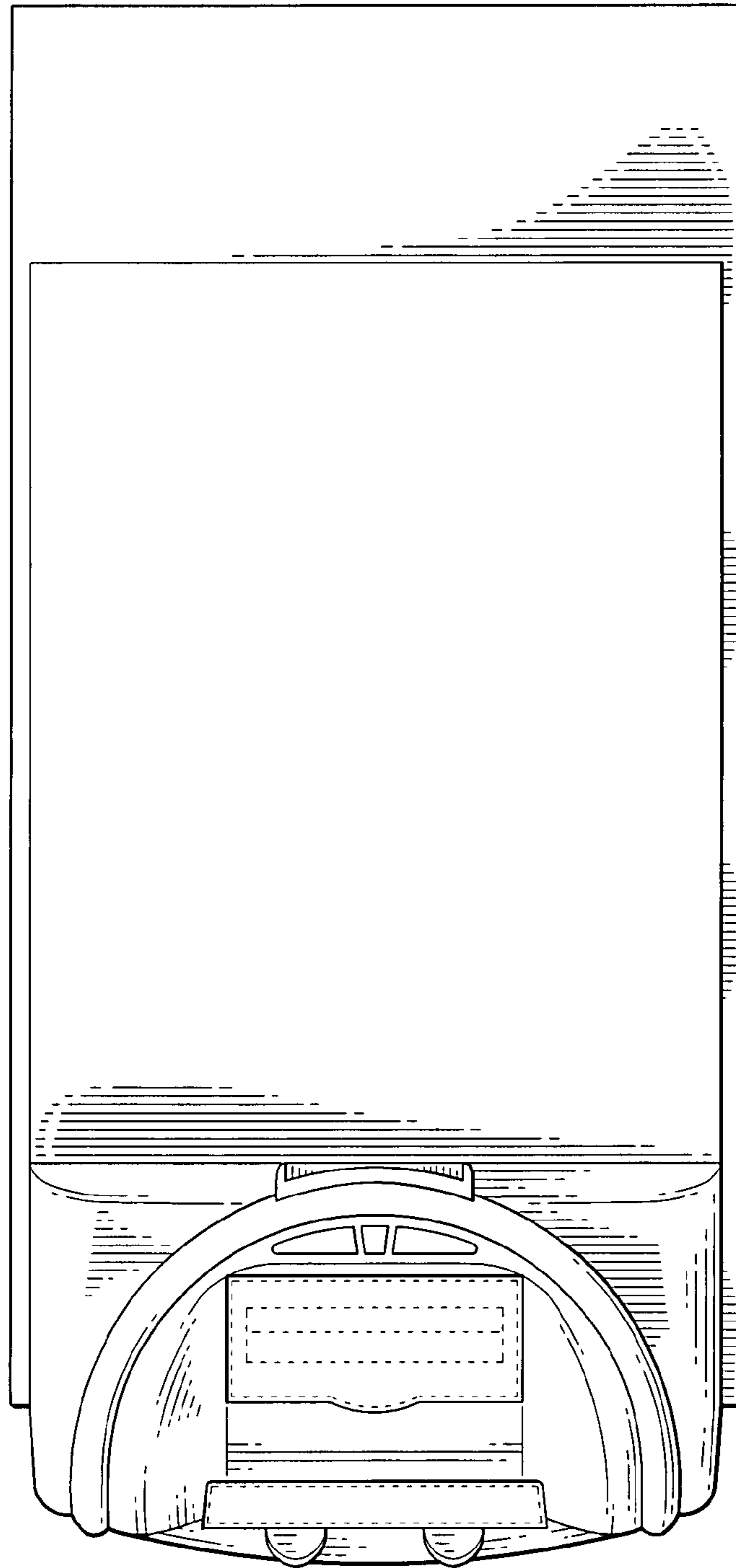

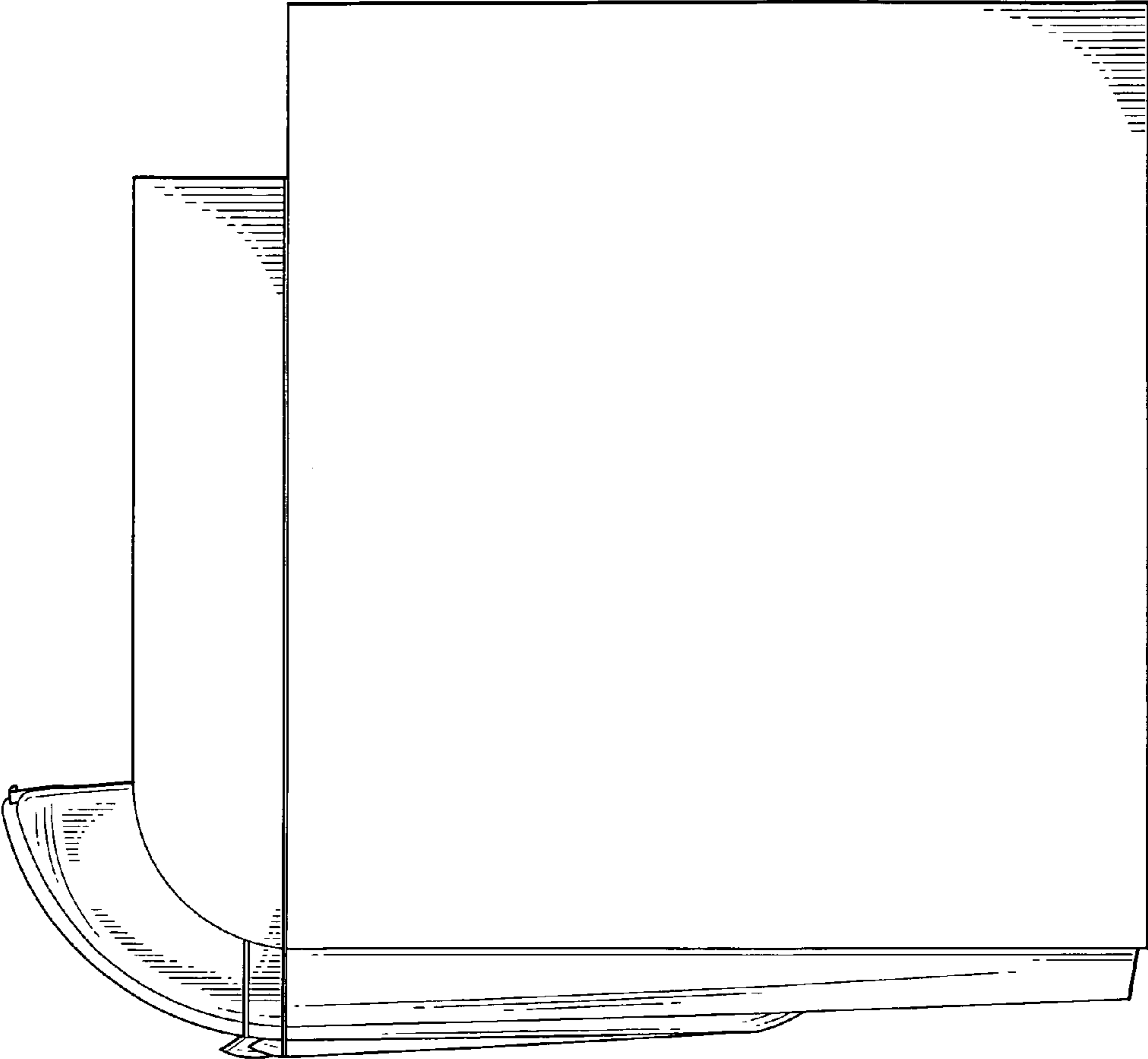

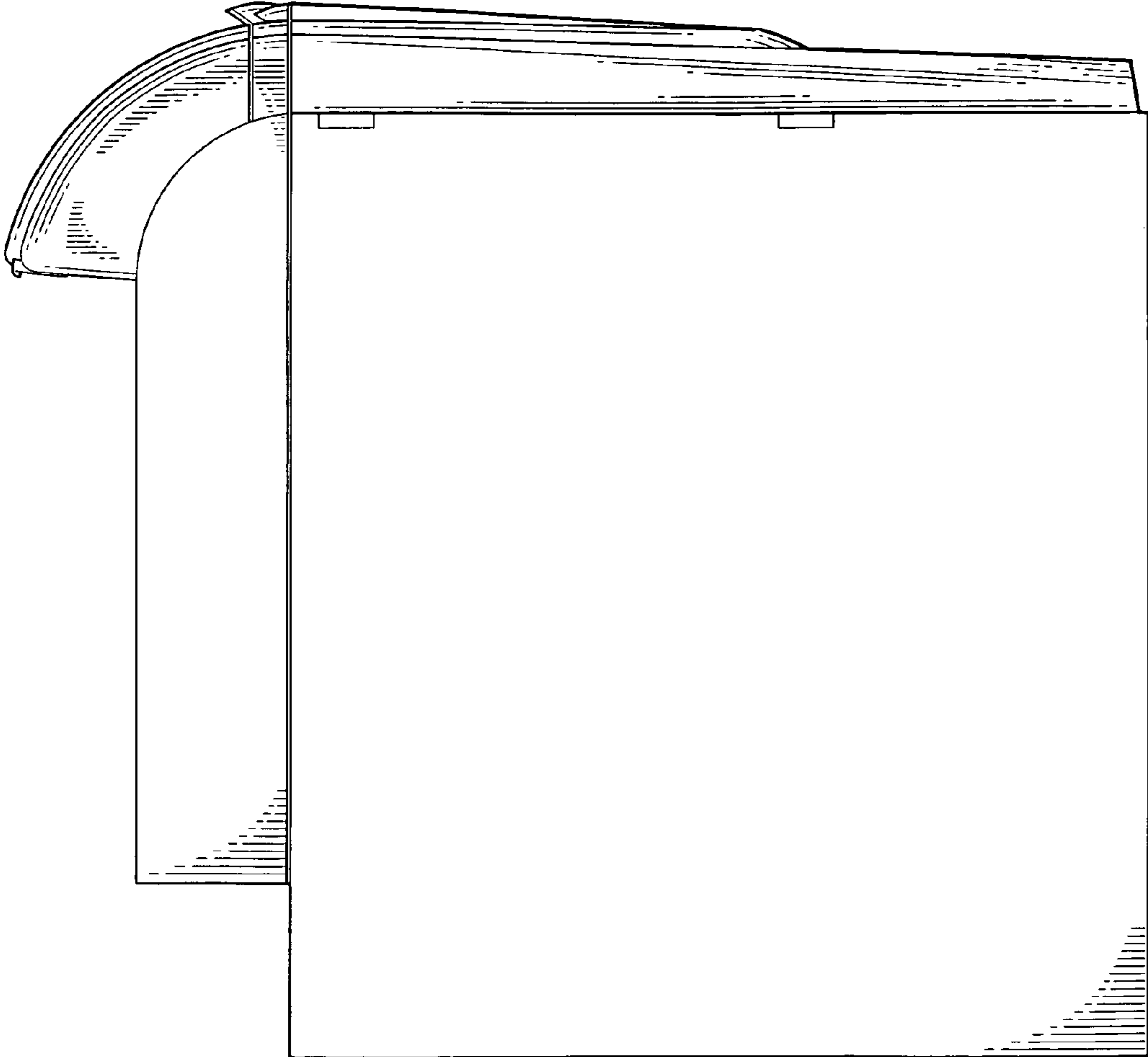

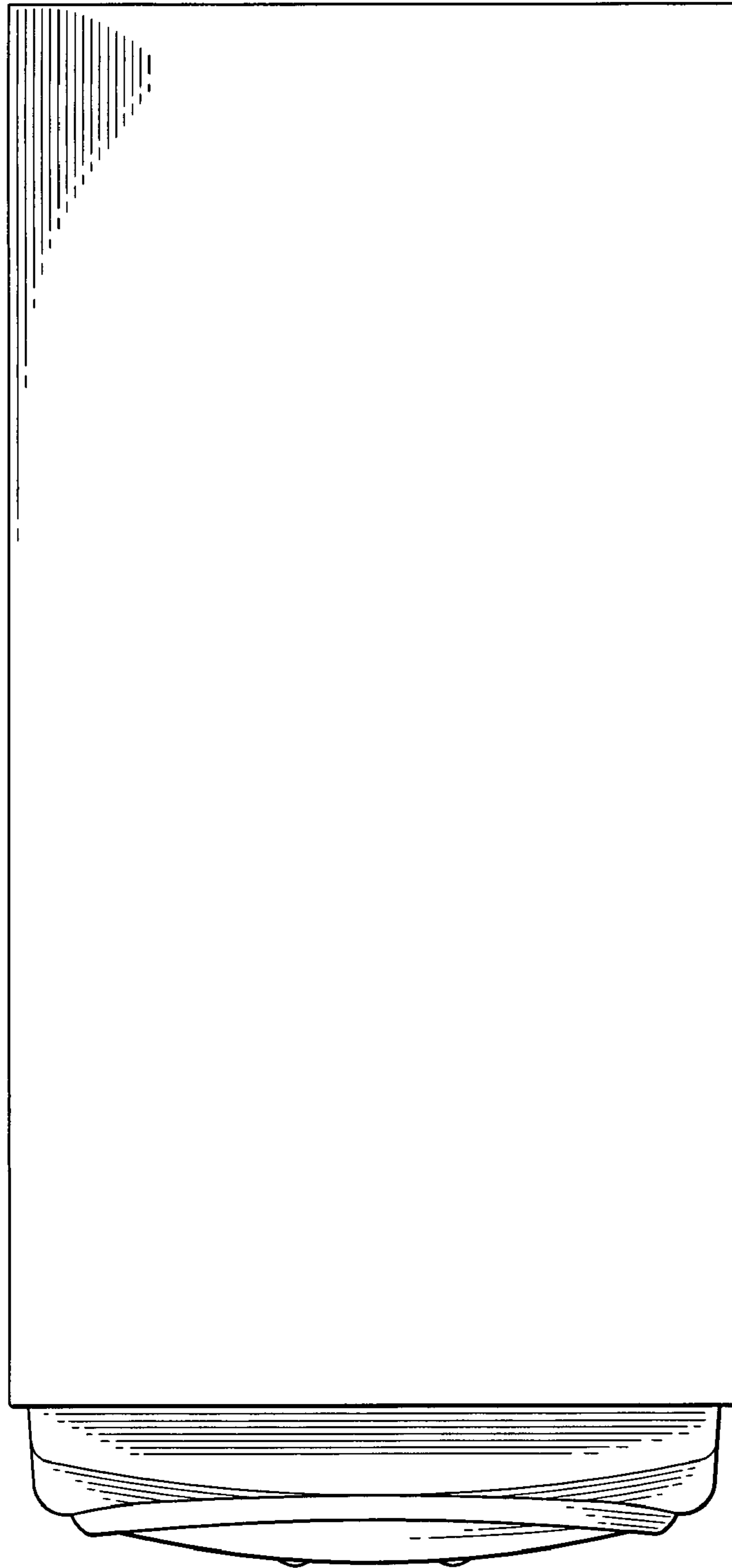

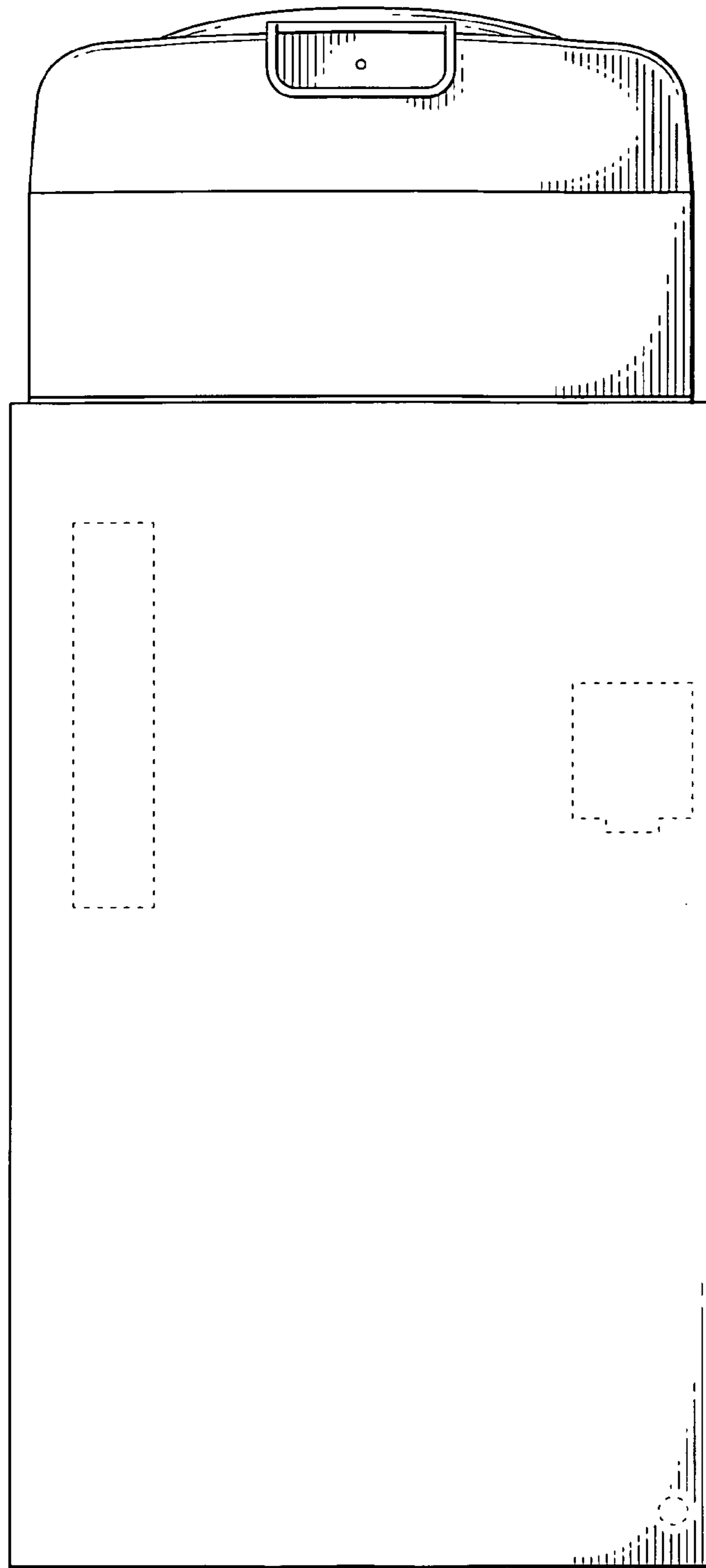
