DESCRIPTION

FIG. 3 is a left side elevation view of the FIG. 1 printer;

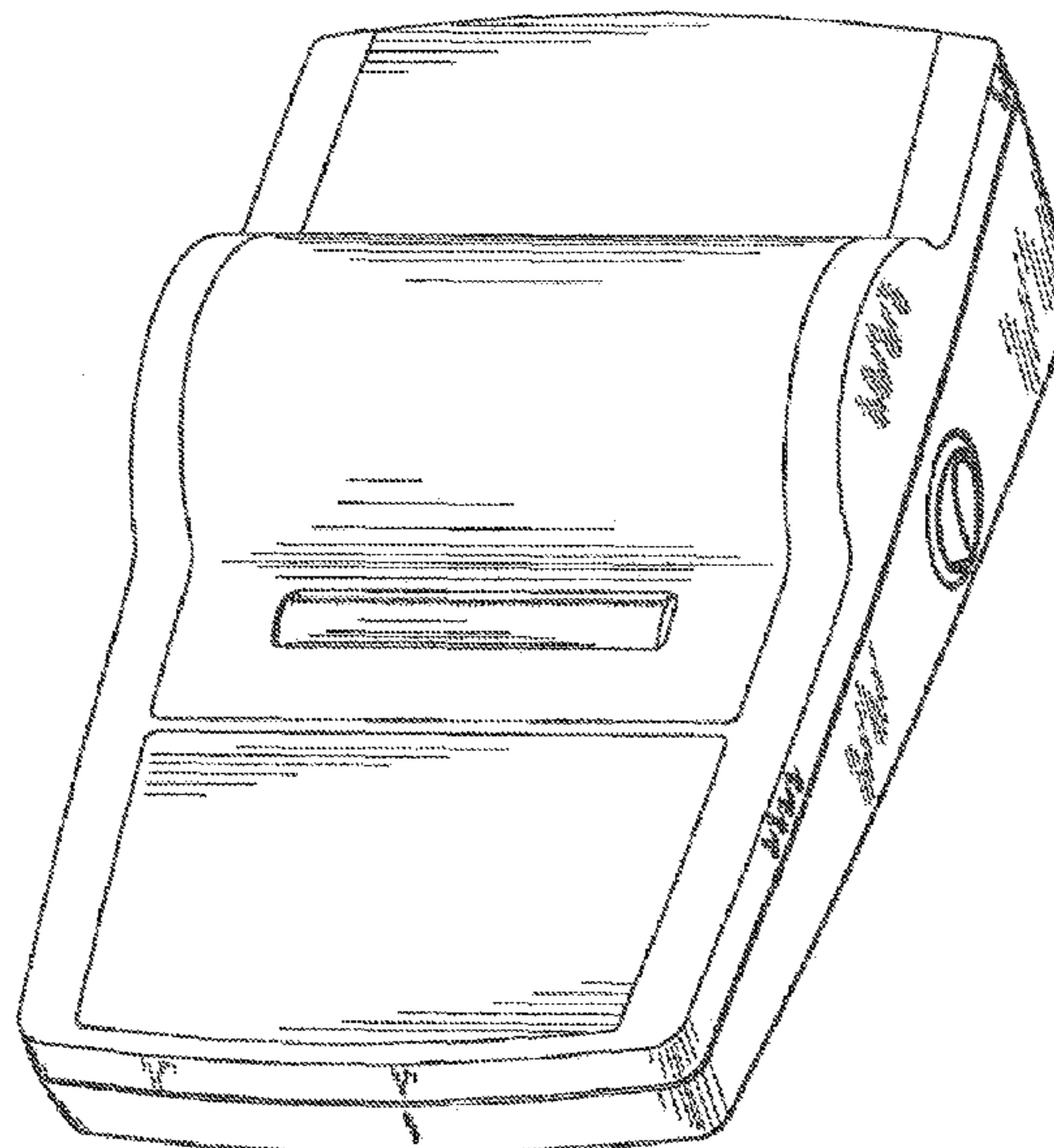
FIG. 4 is a front elevation view of the FIG. 1 printer;

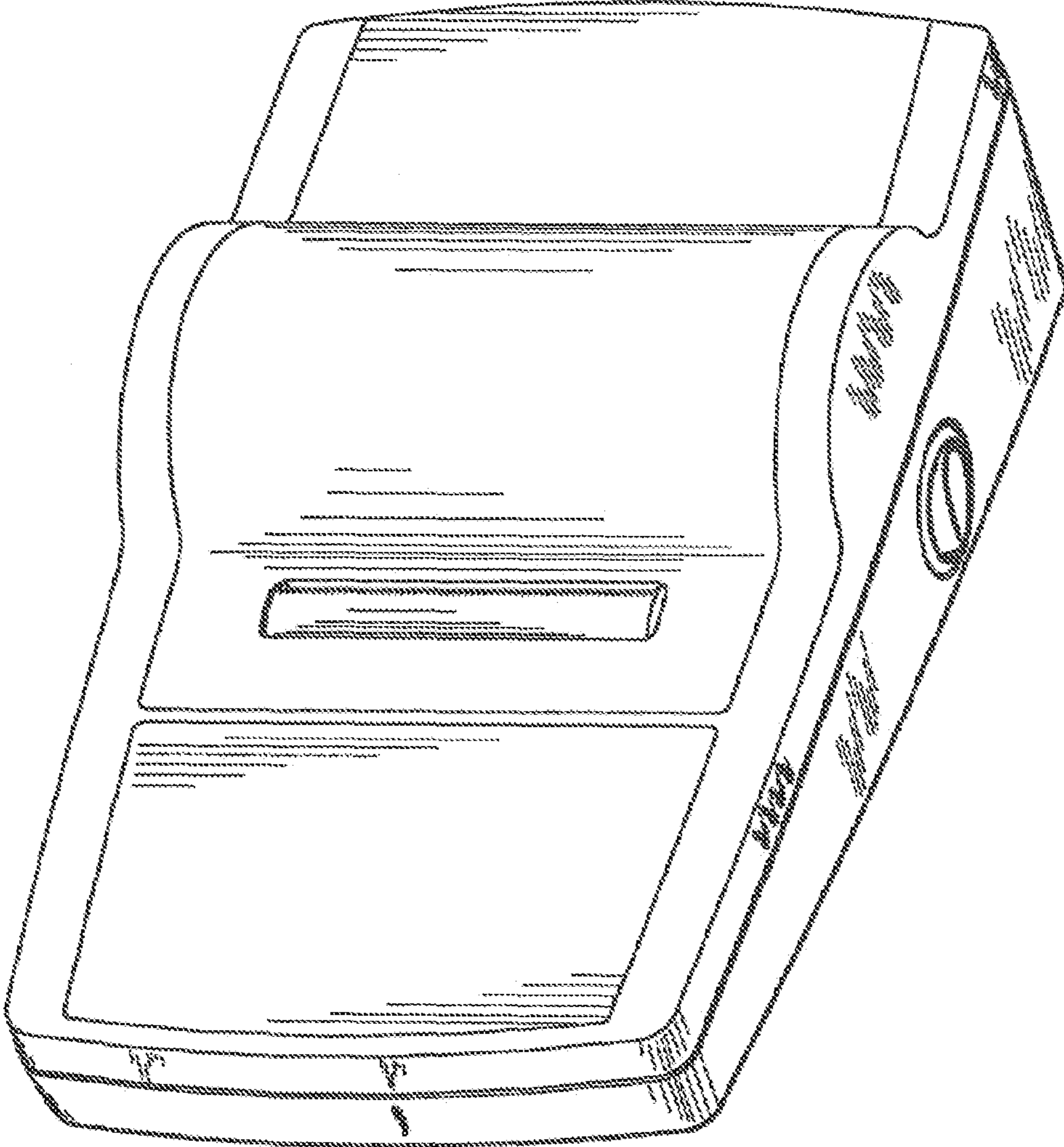

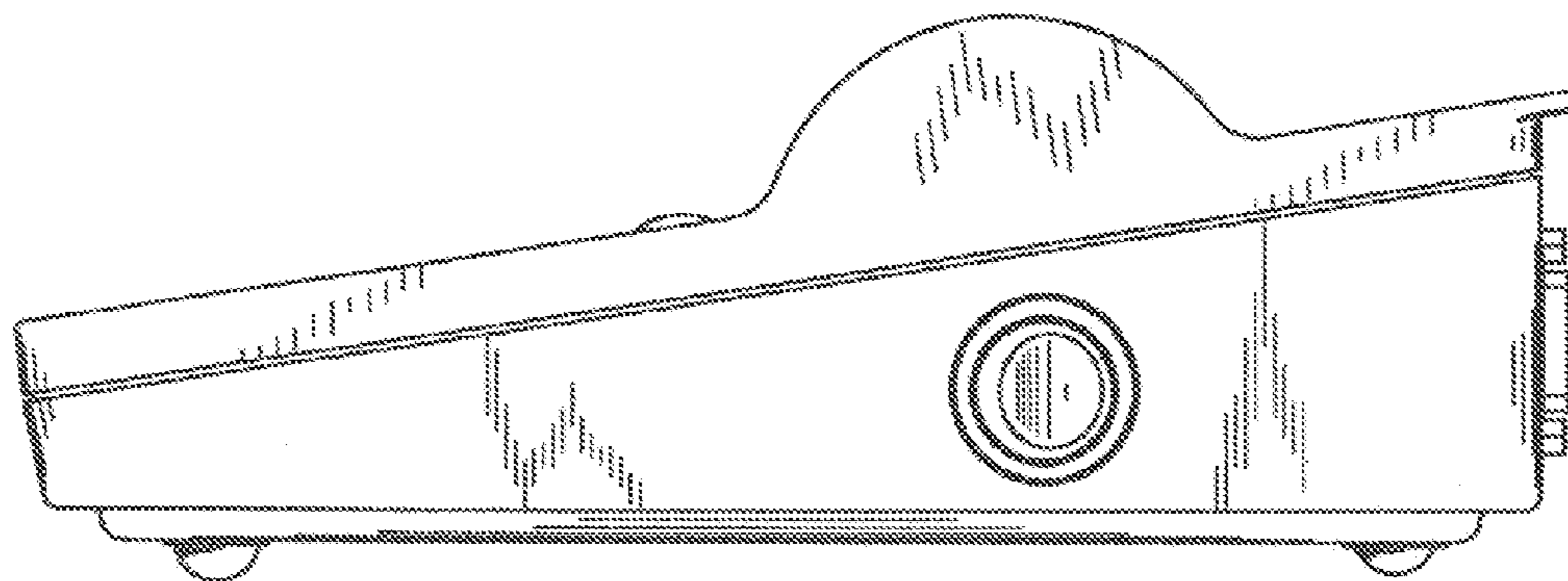
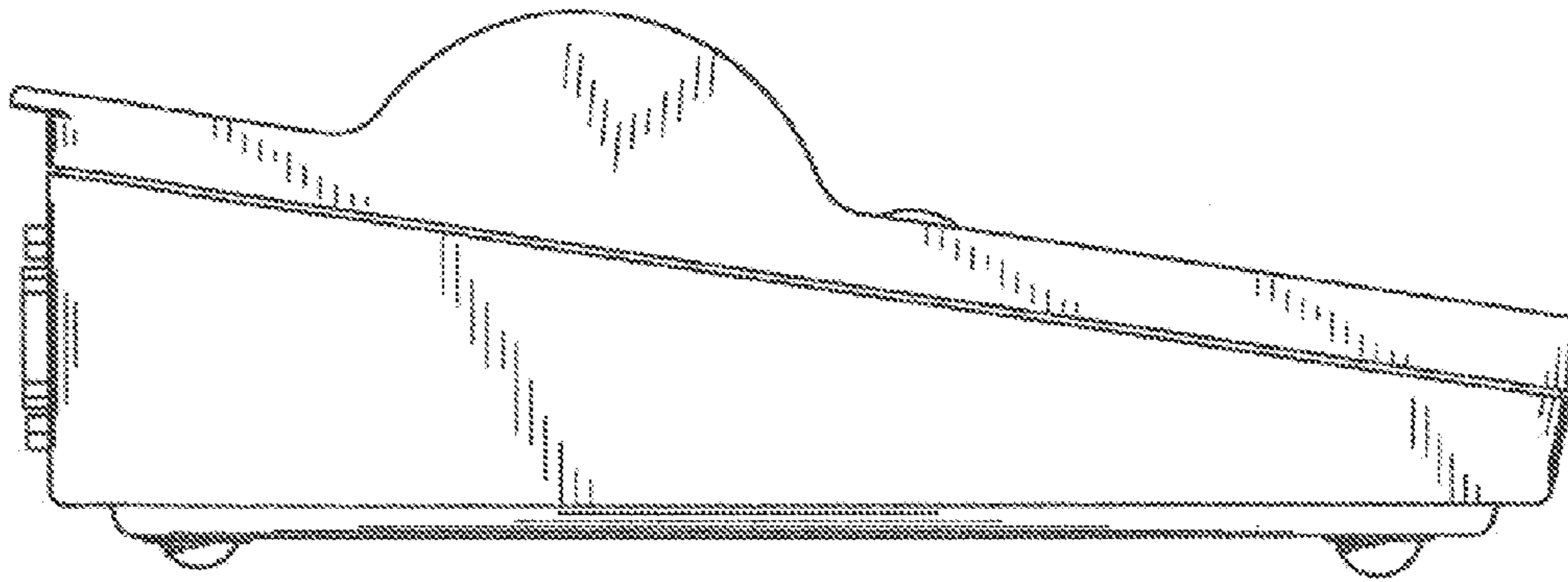

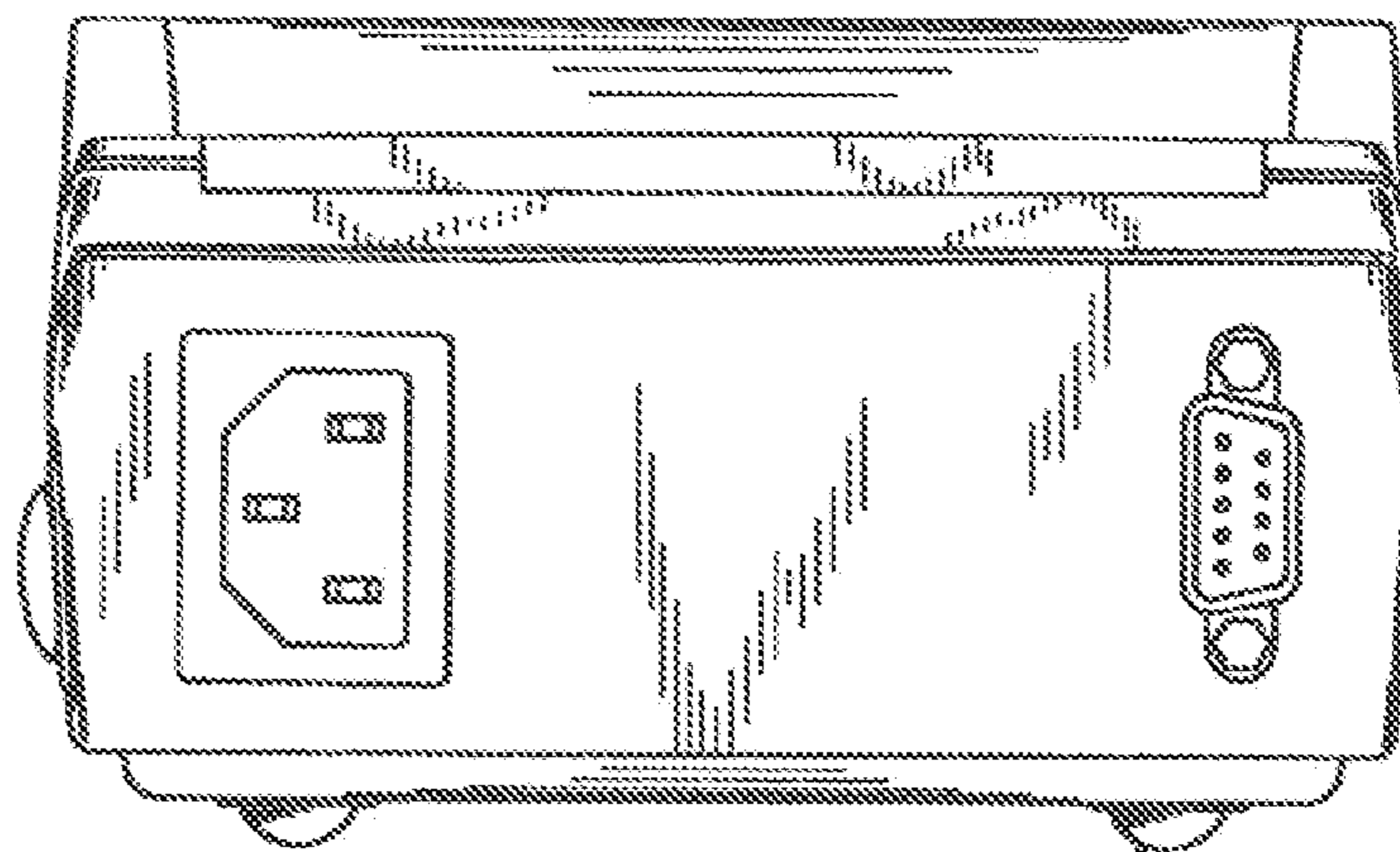
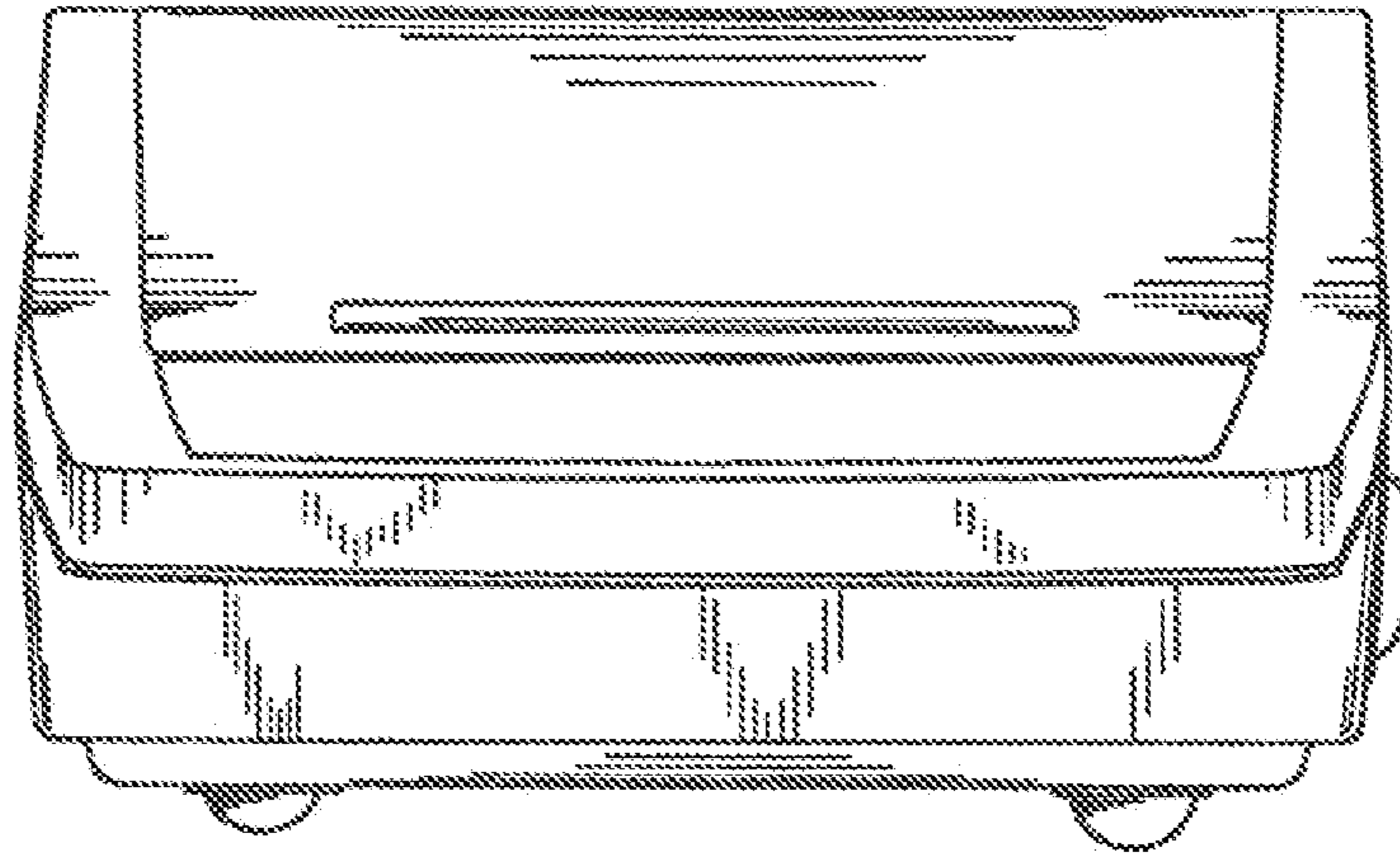

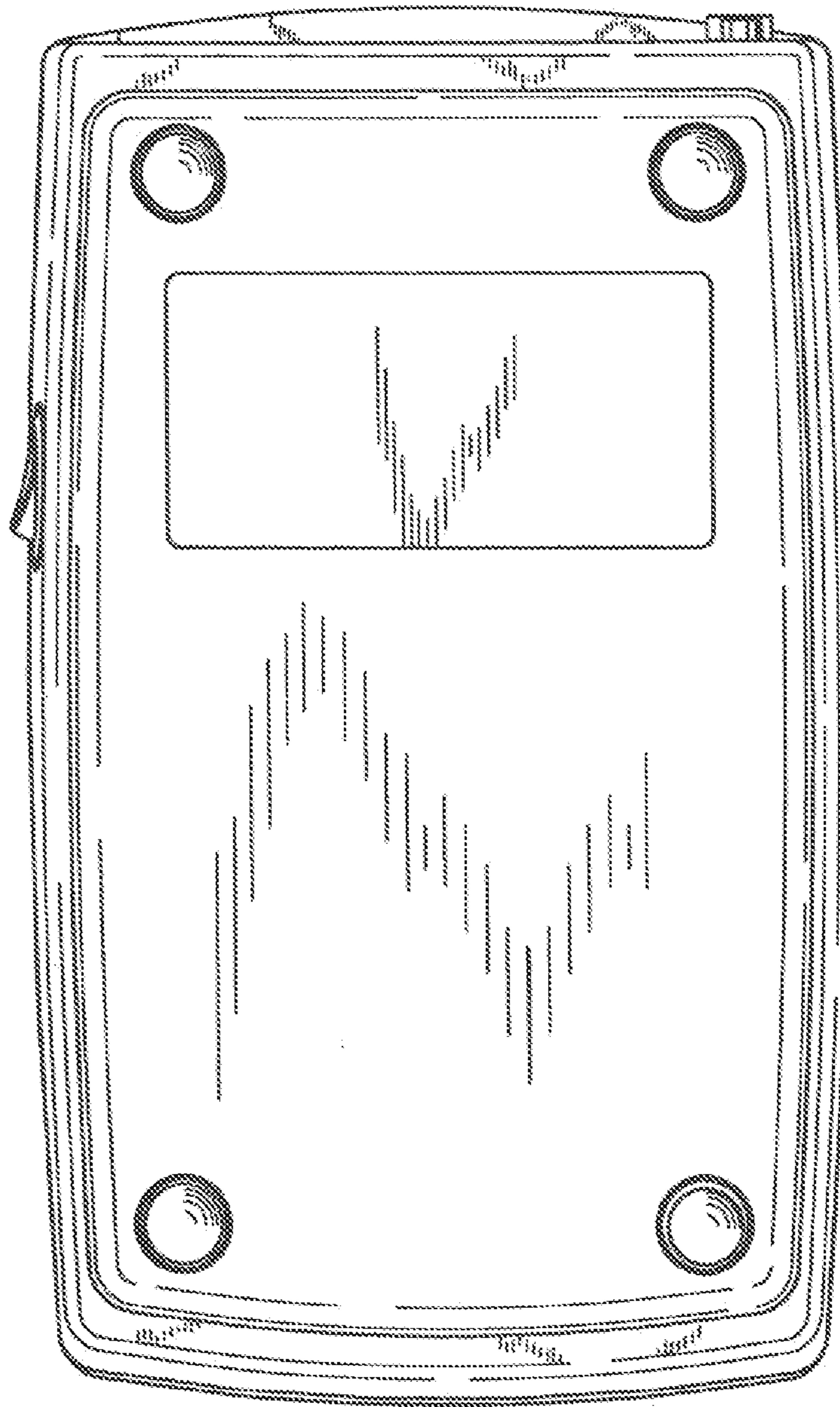
