FIG. 2 is a front view of a page thereof;

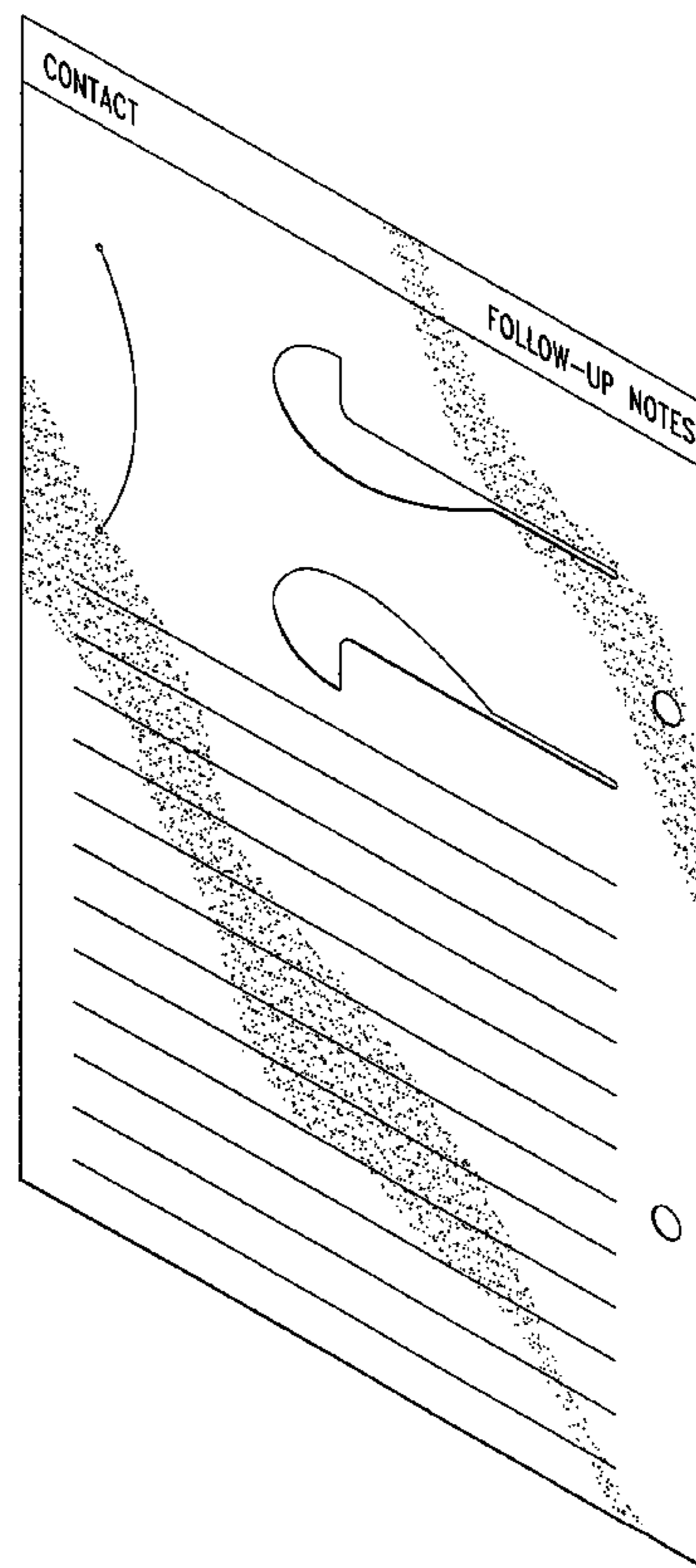
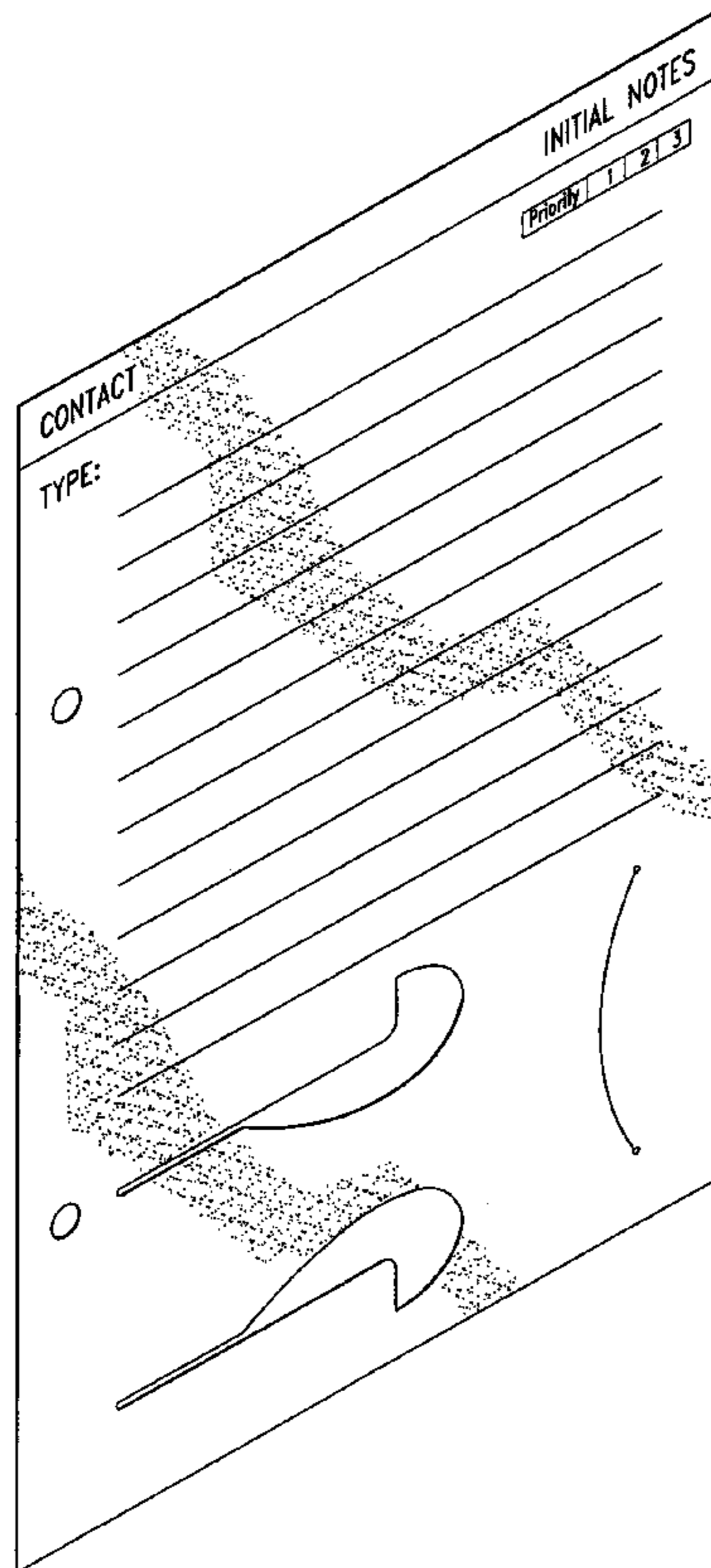
FIG. 3 is a back view thereof;

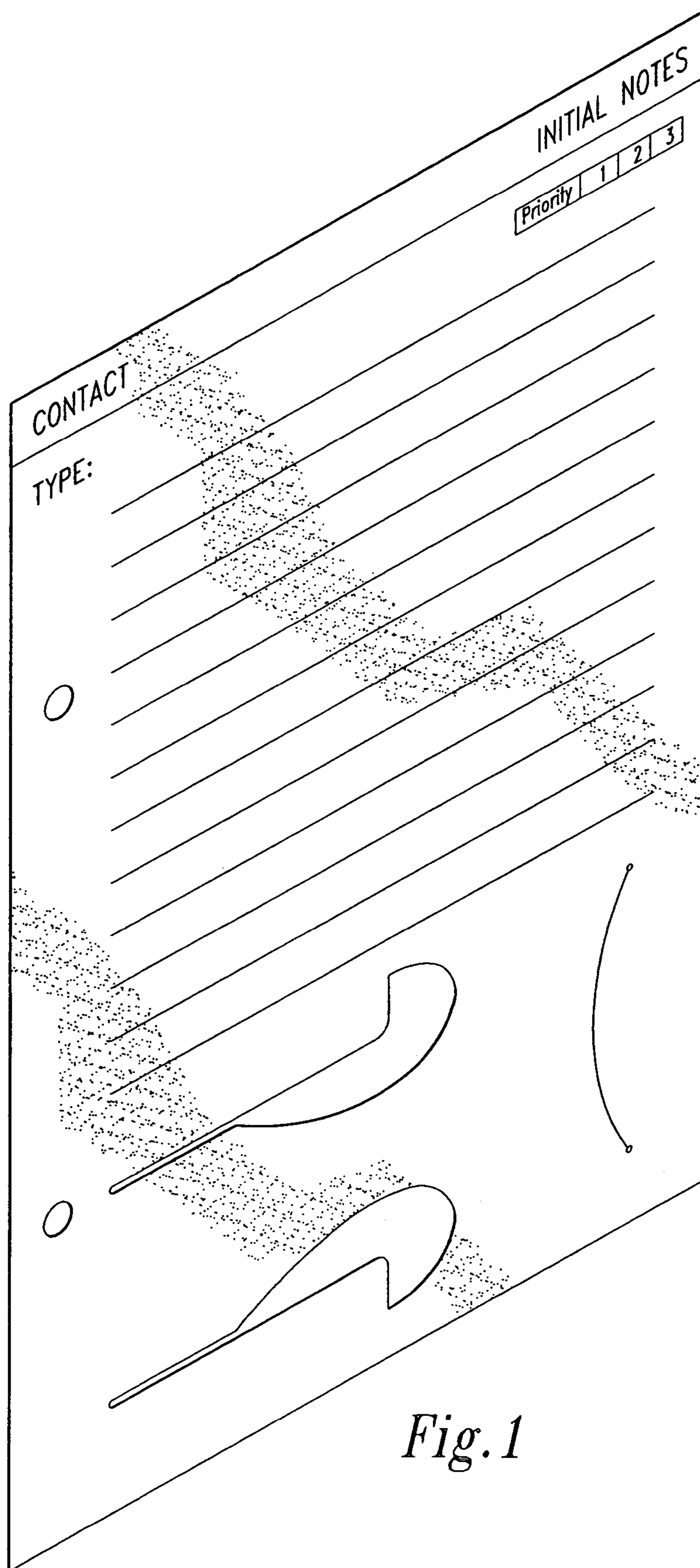






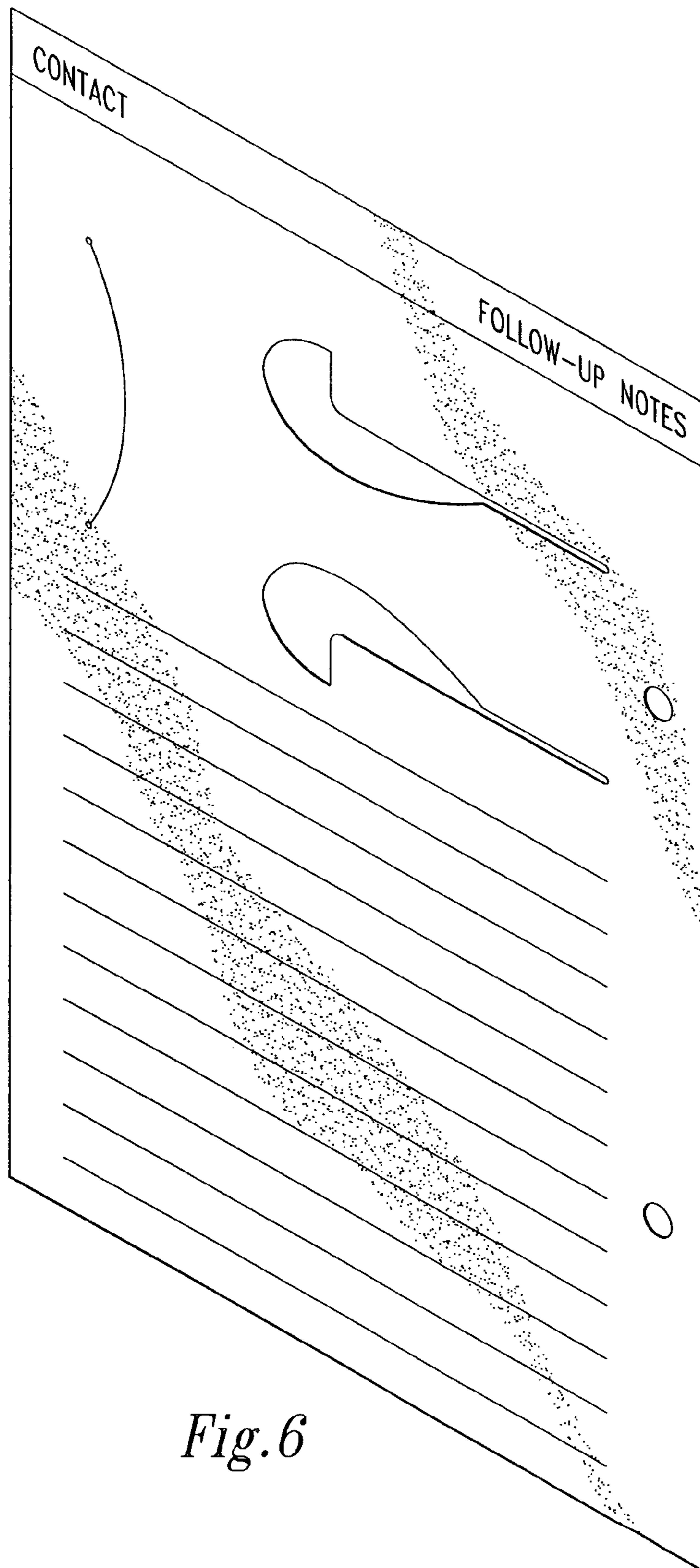
