**DESCRIPTION**

FIG. 4 is an enlarged front elevation view thereof;

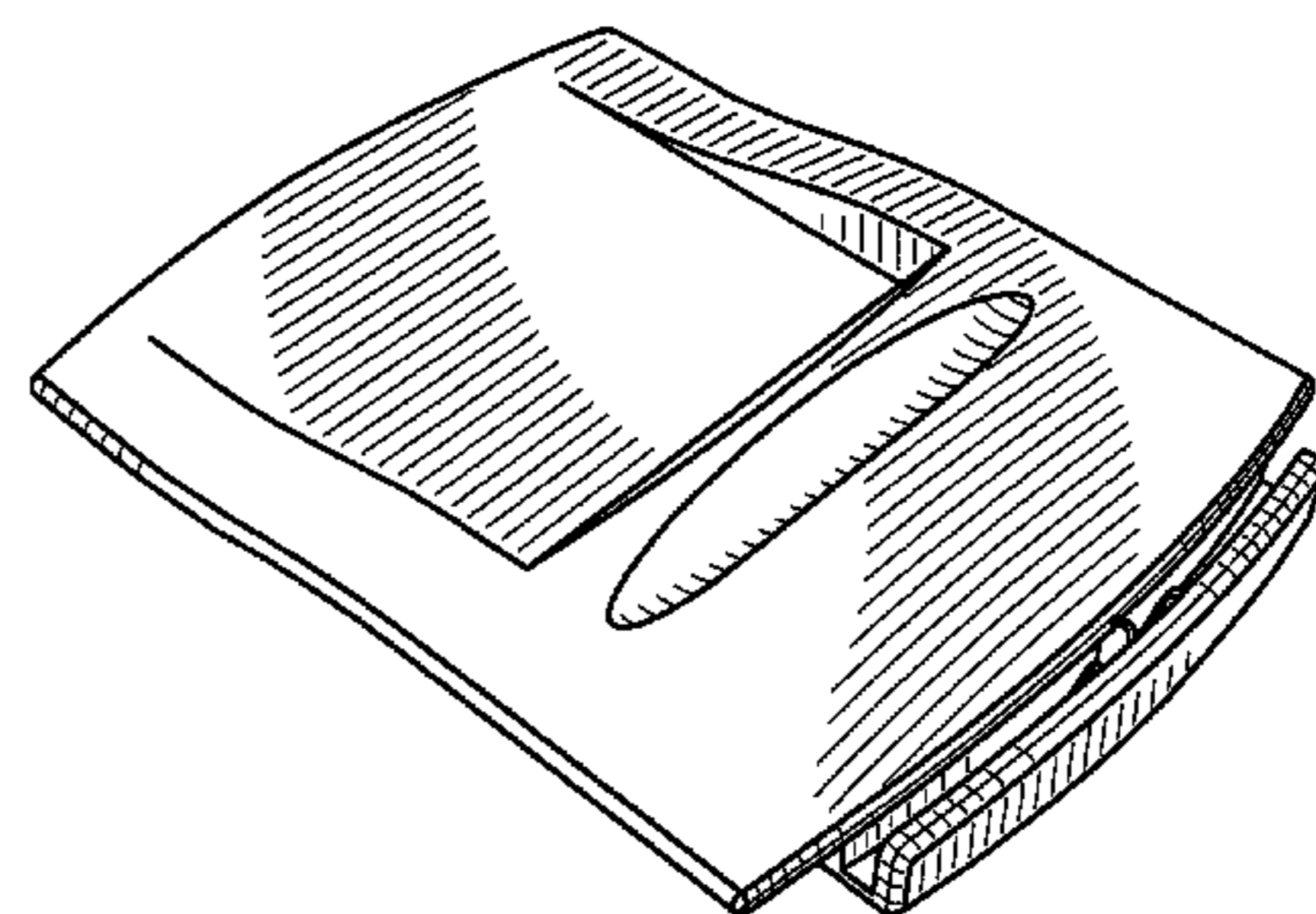
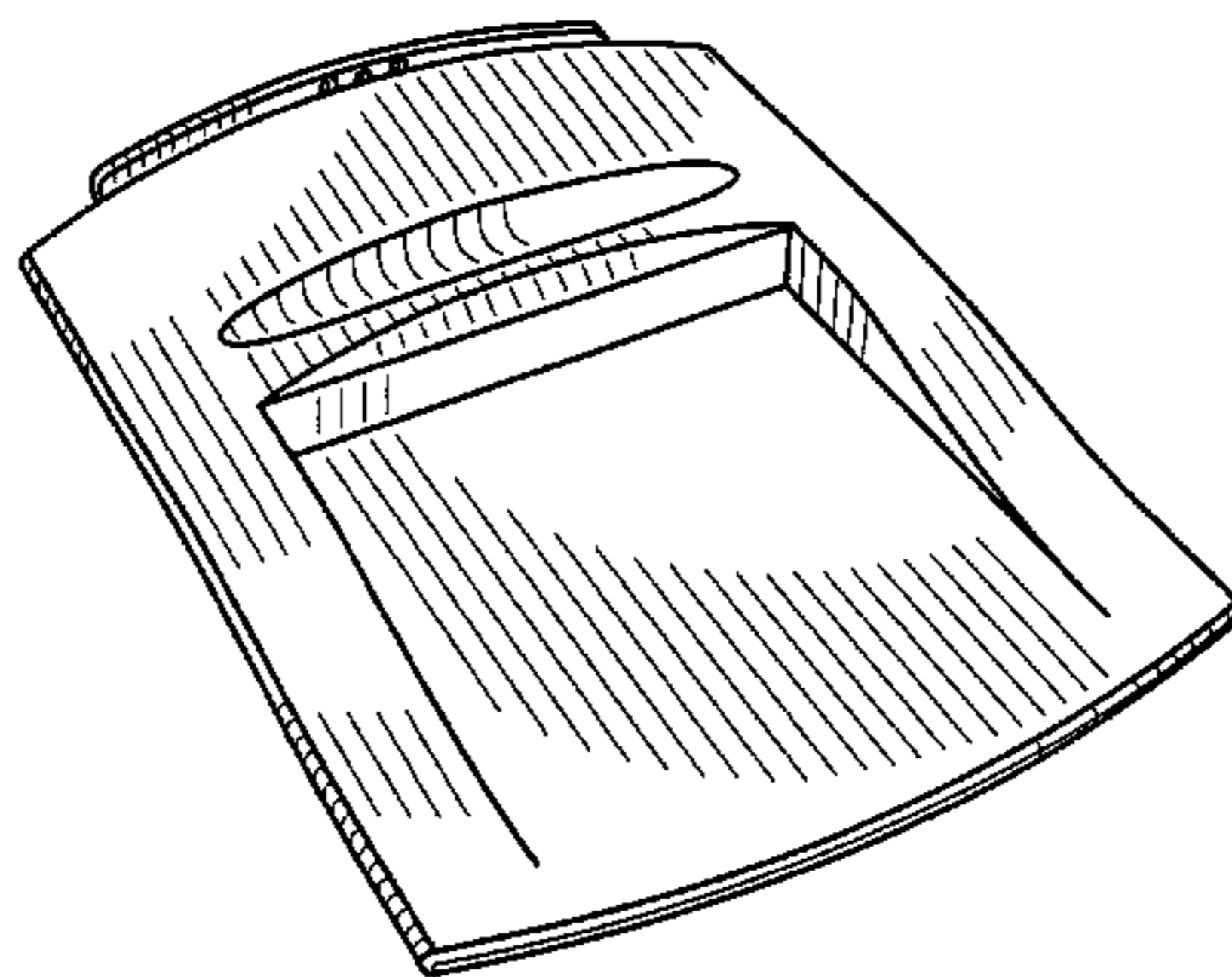
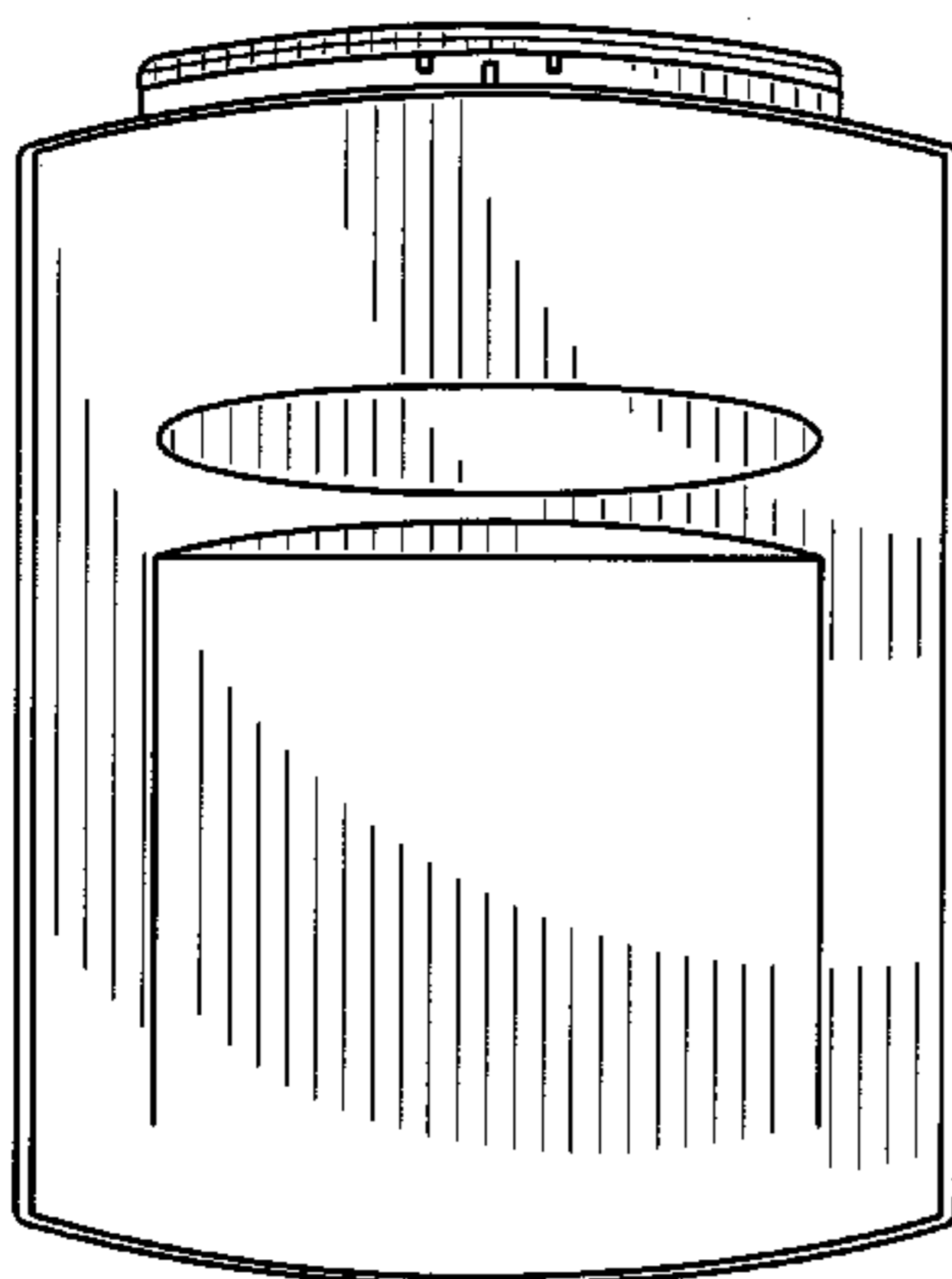
FIG. 5 is a bottom plan view thereof;

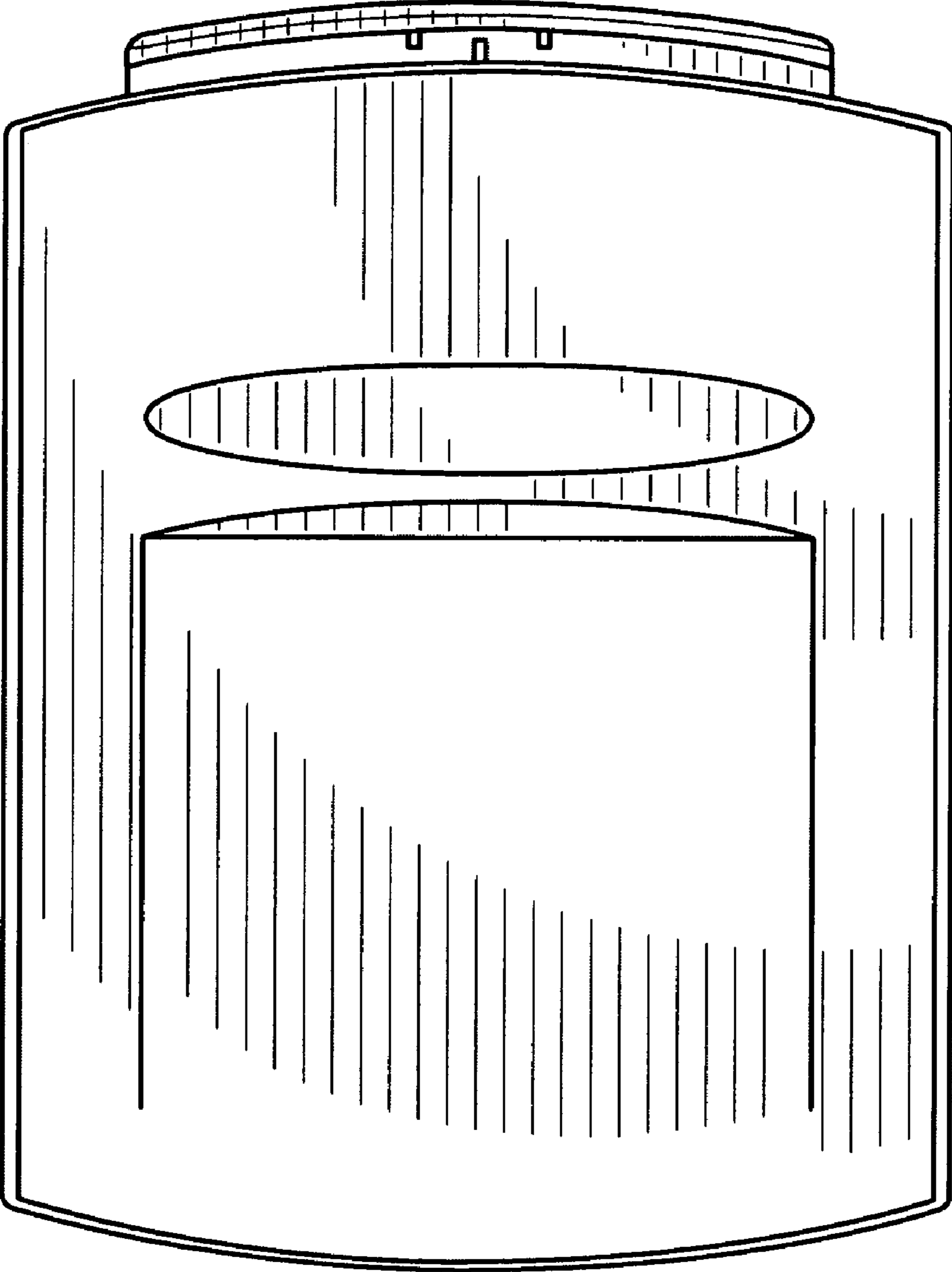

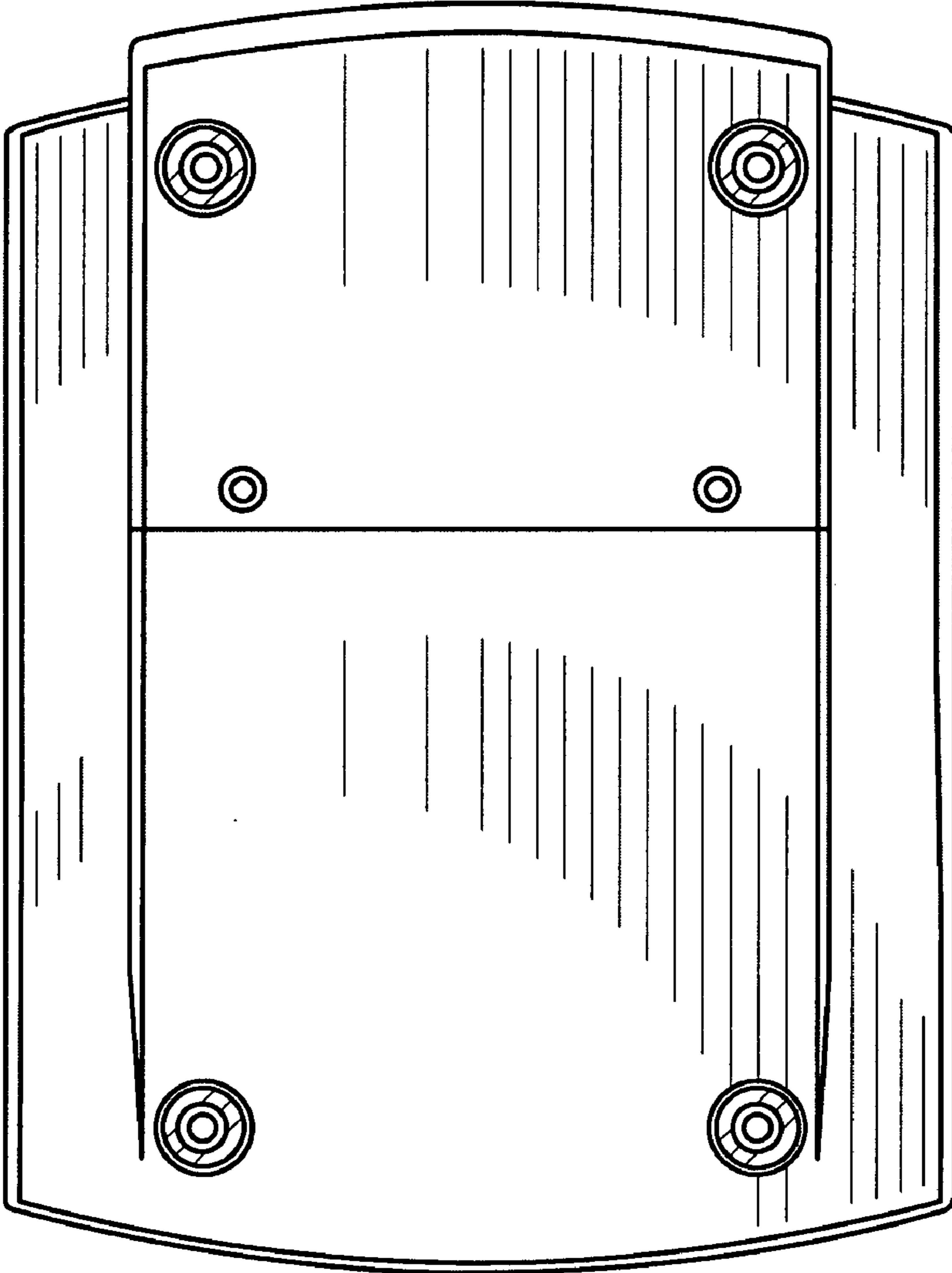

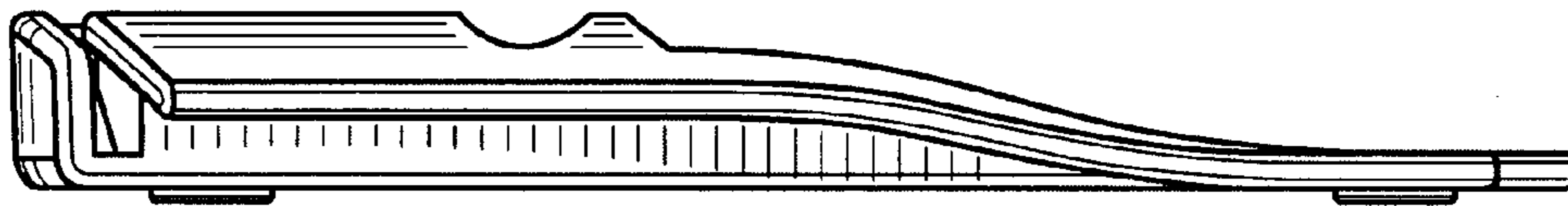

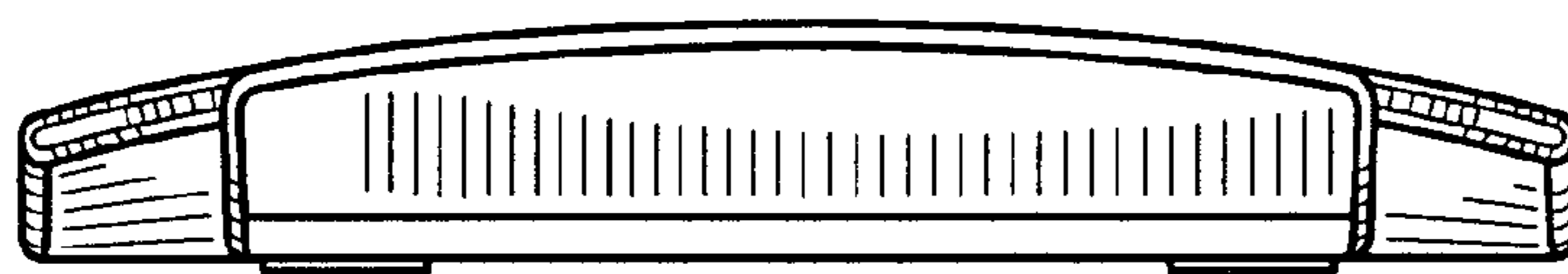

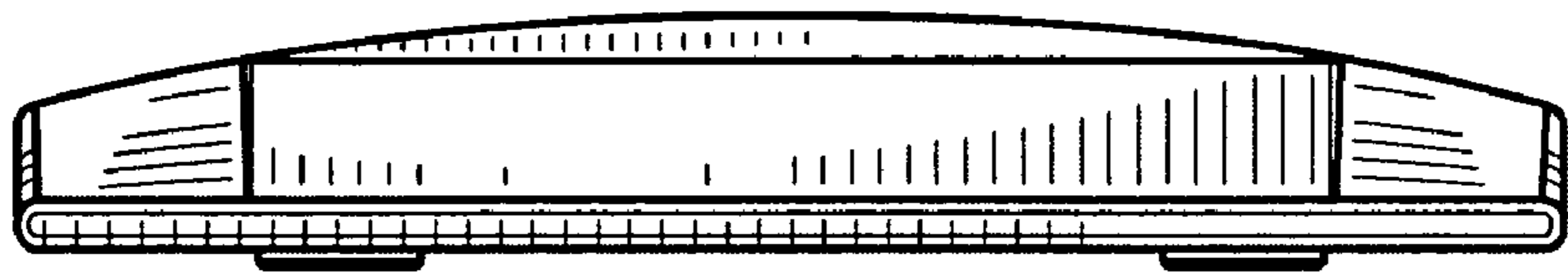

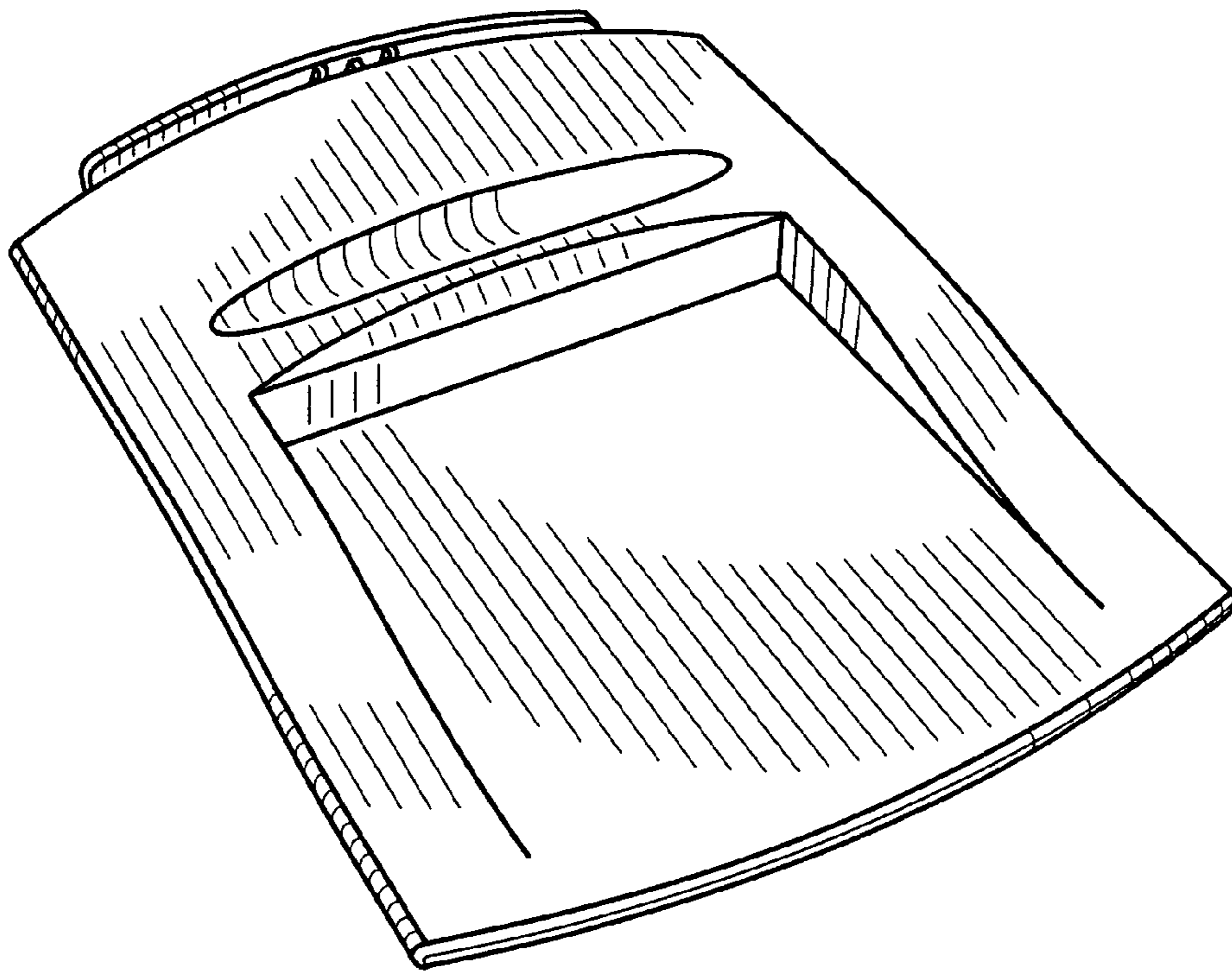

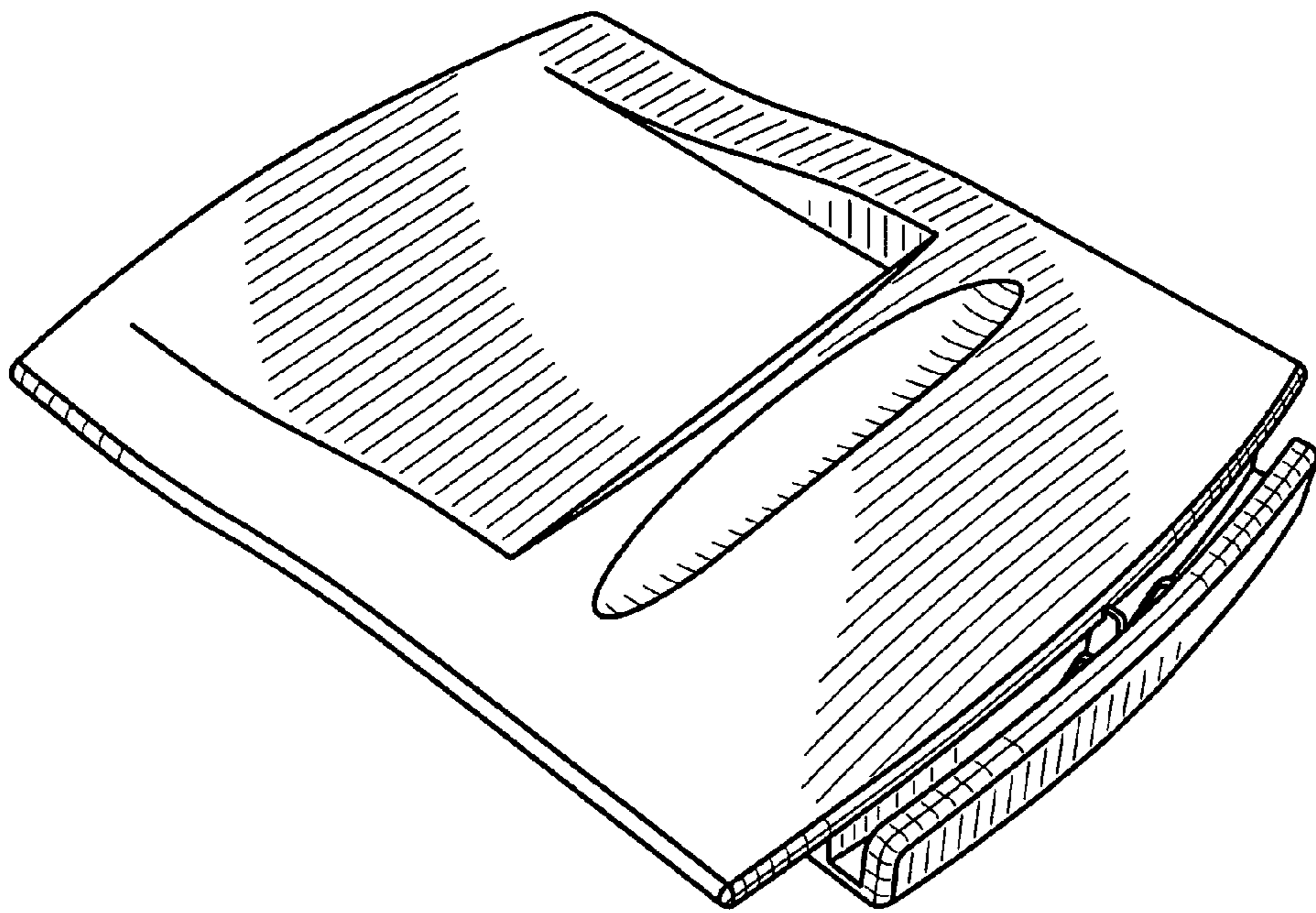
