FIG. 5 is a left-hand side view of the ice skate blade guard;

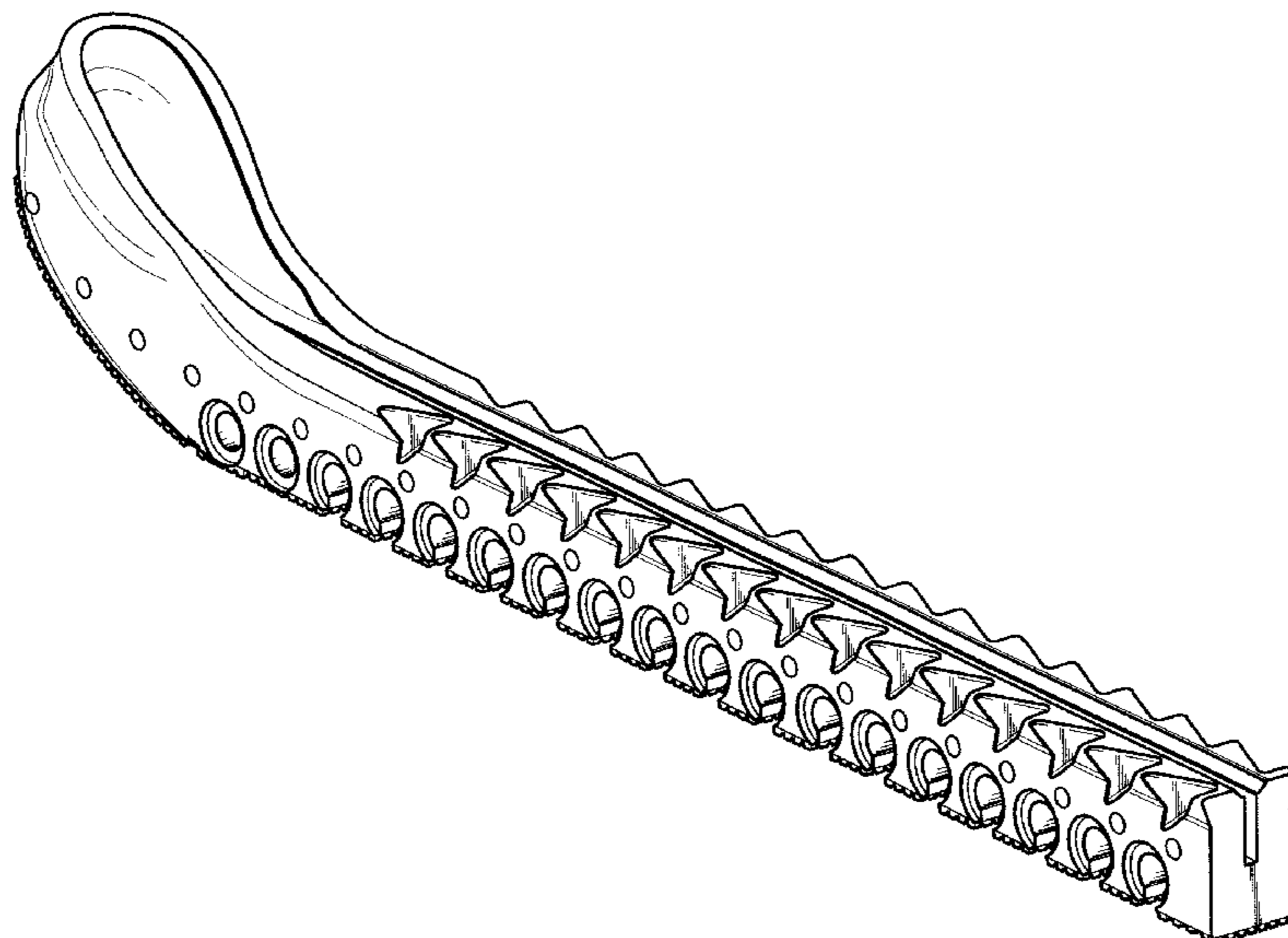
FIG. 6 is a right-hand view of the ice skate blade guard;

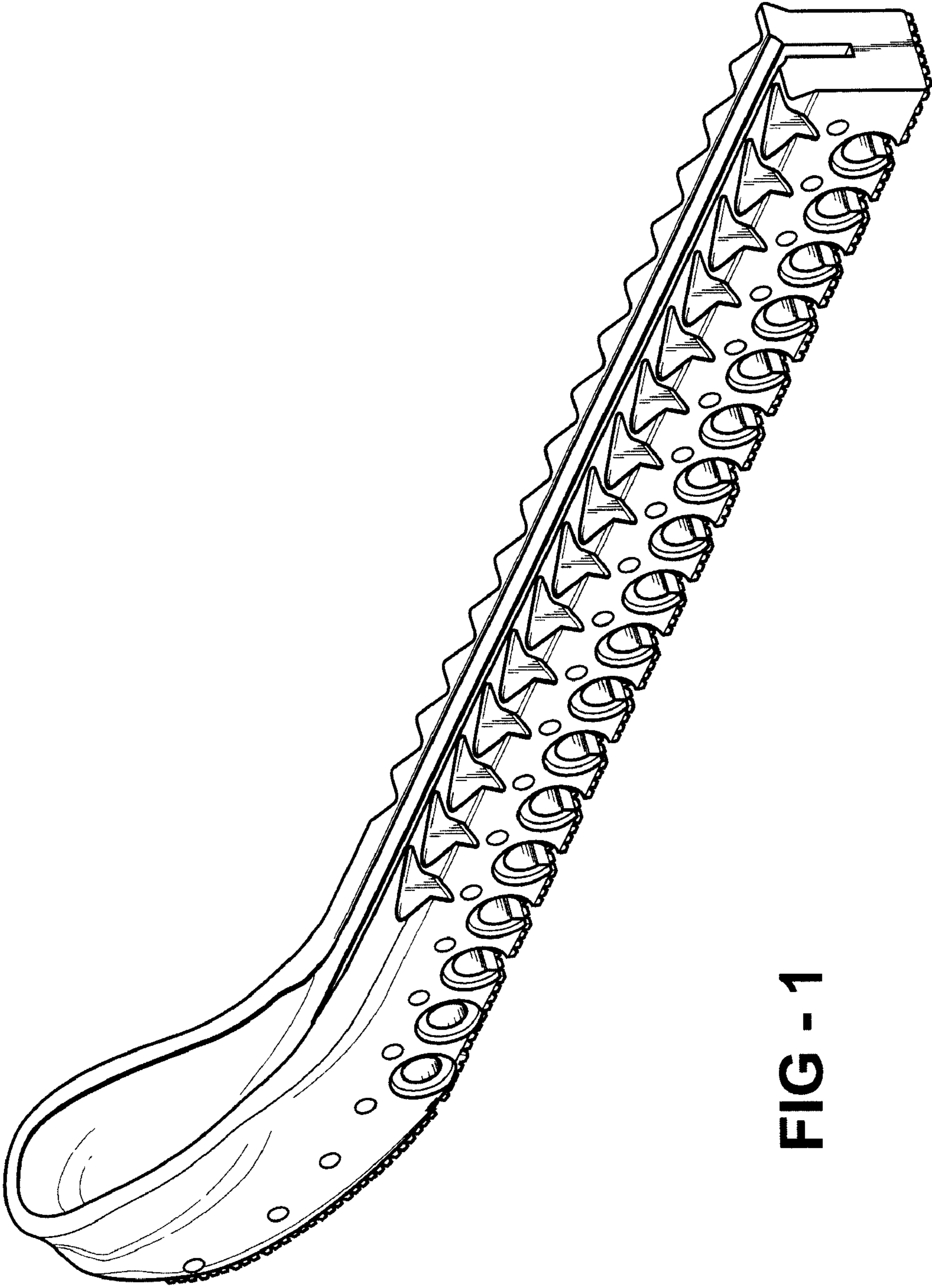

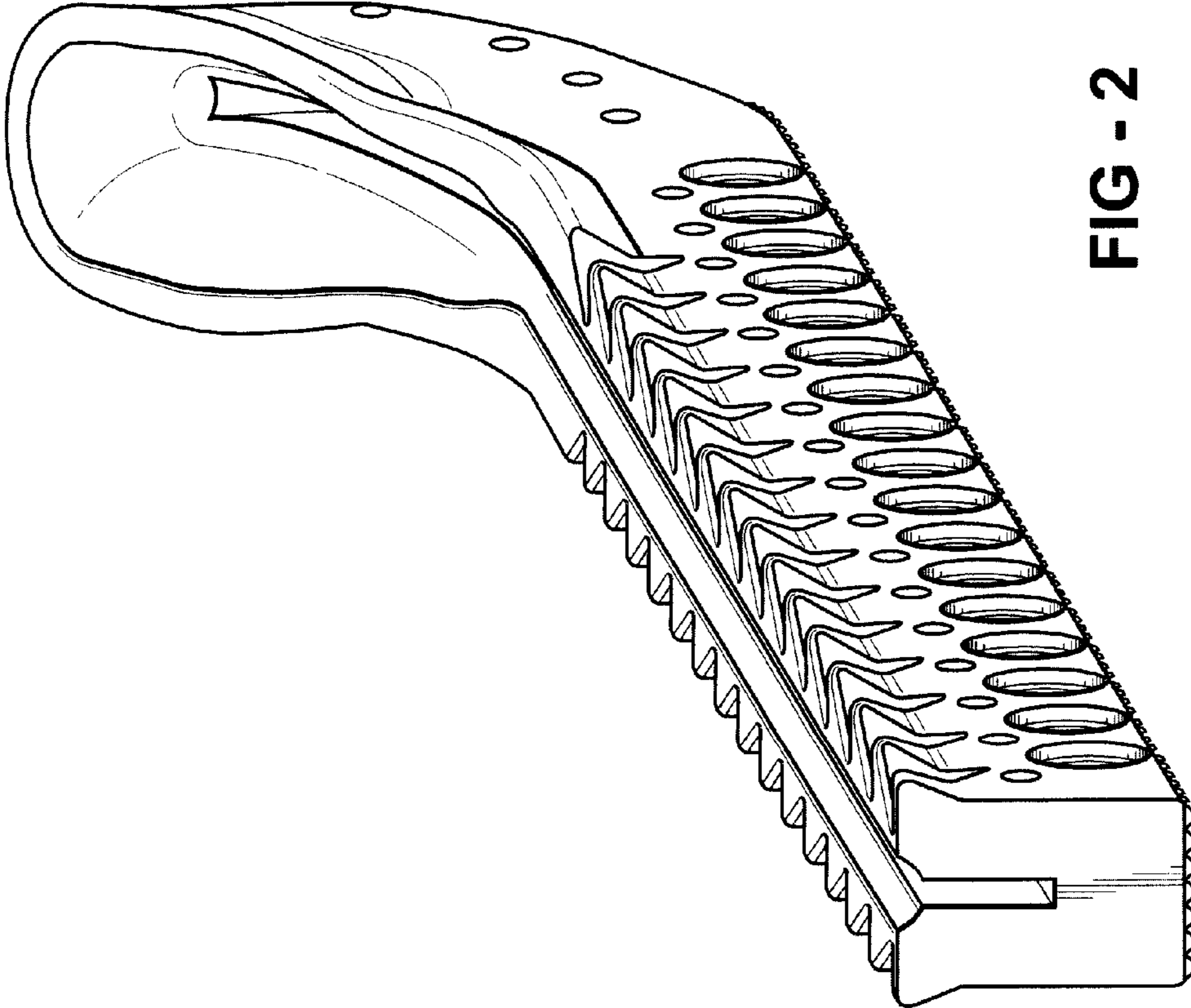

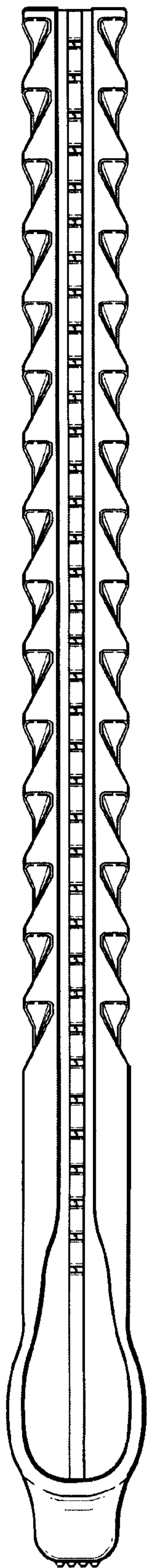

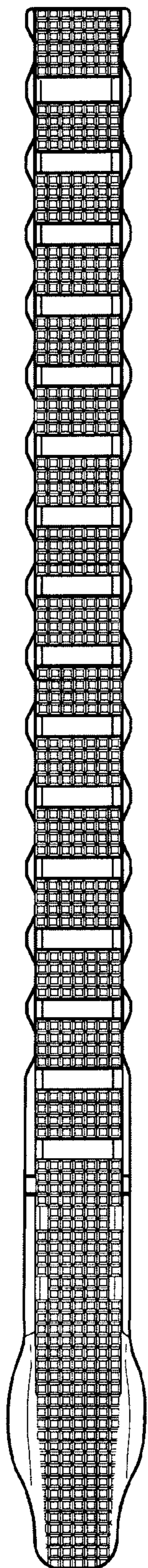

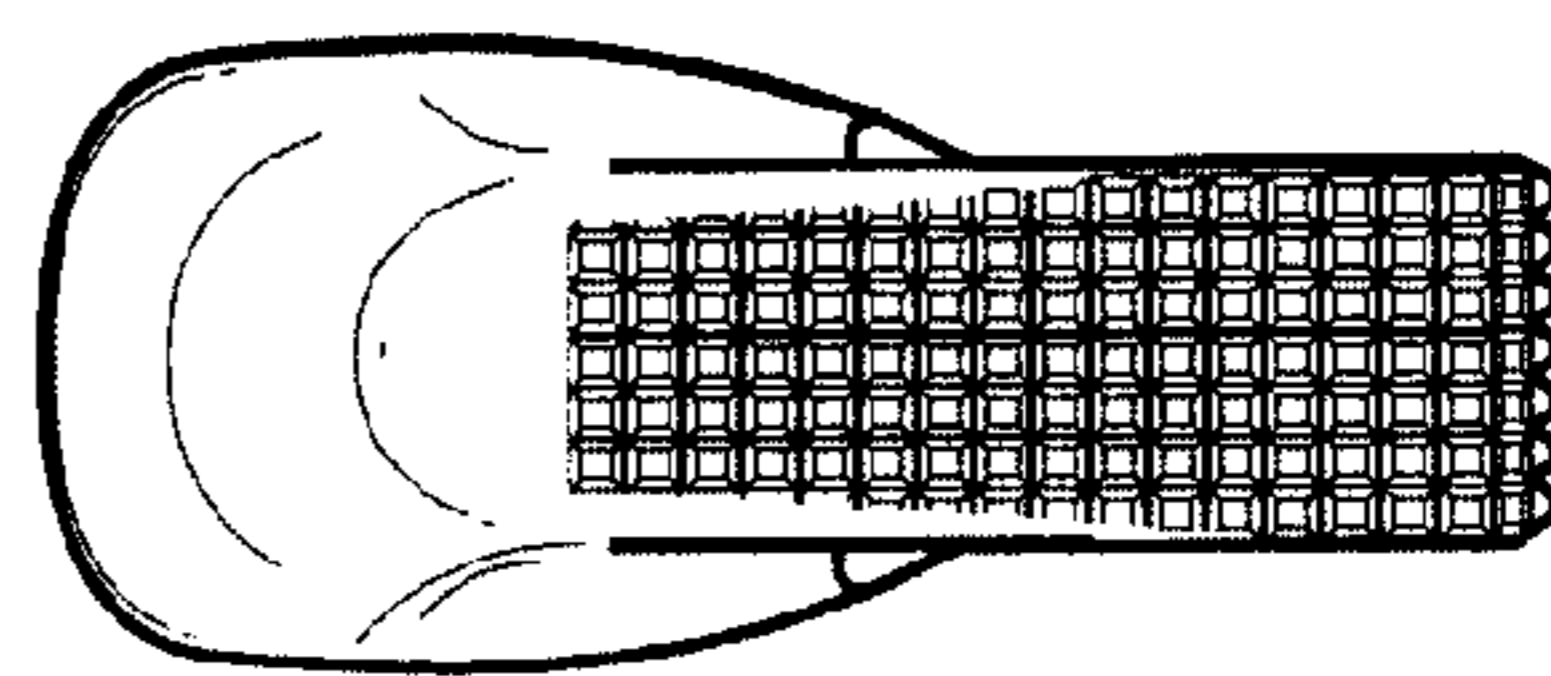

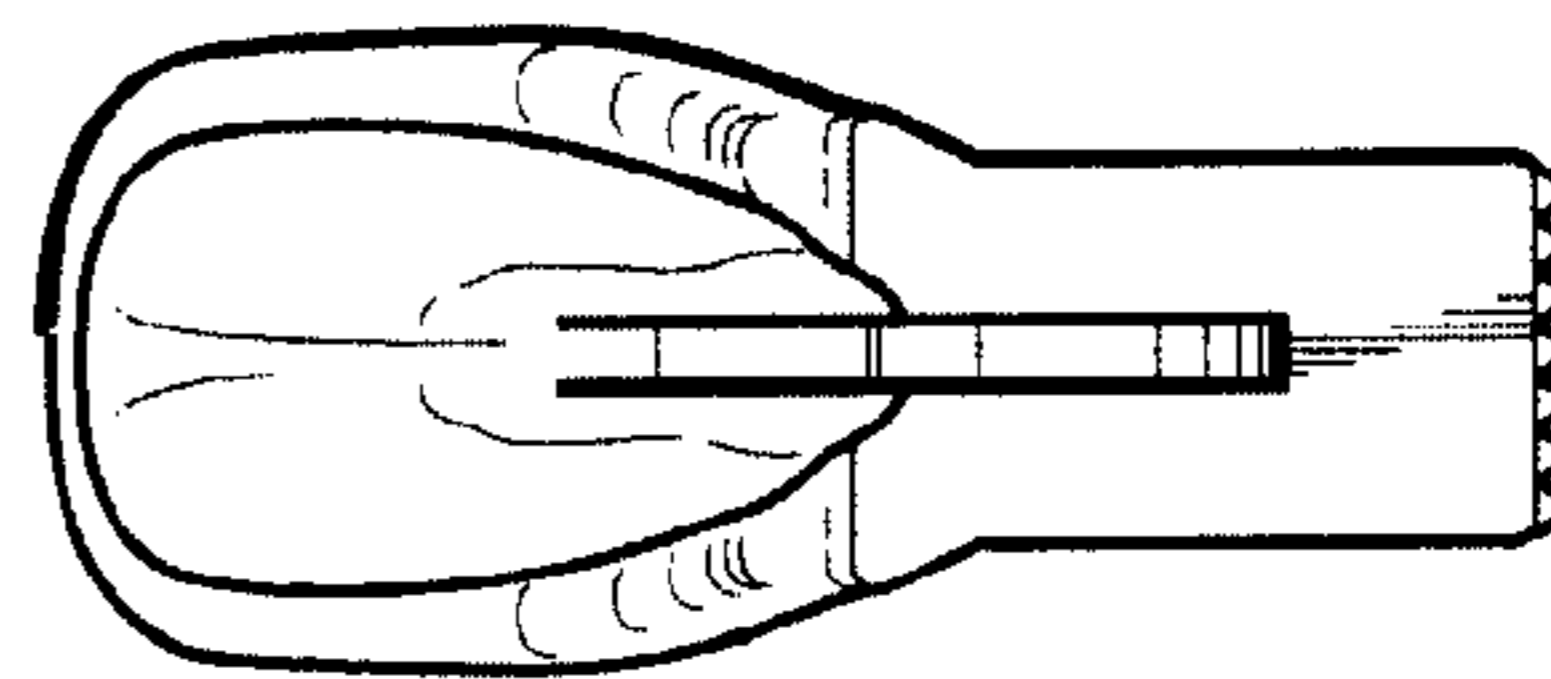

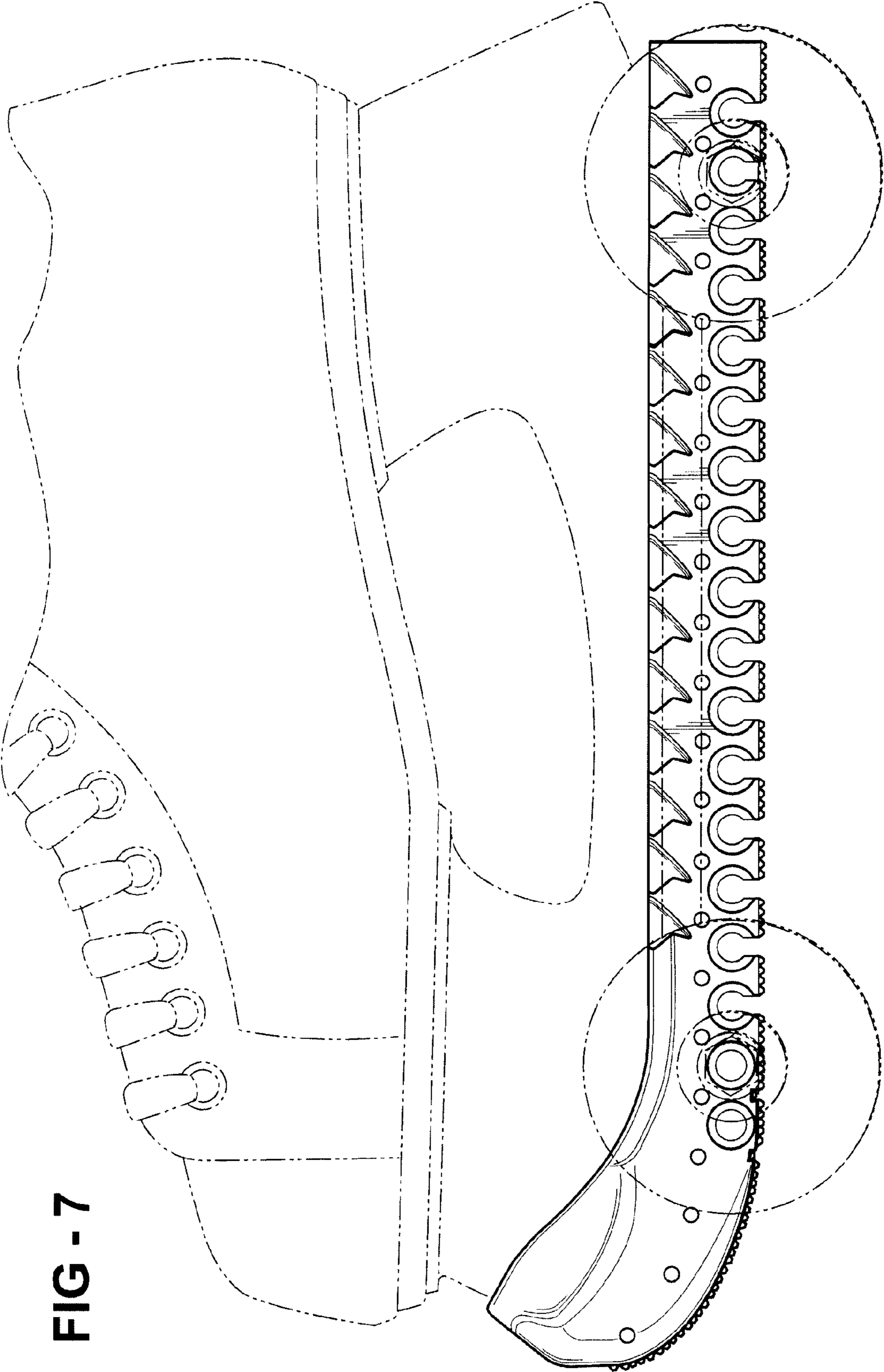
