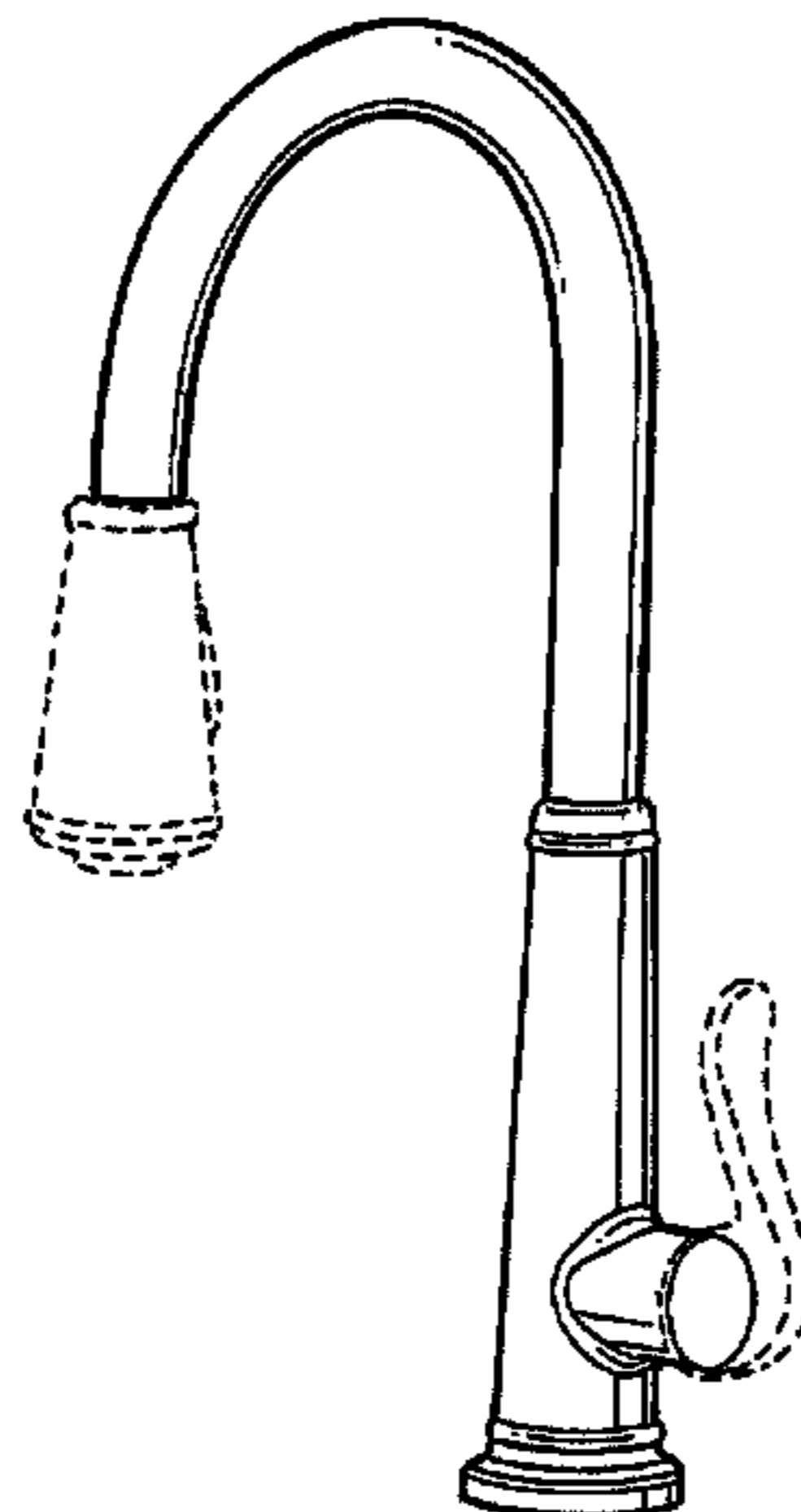
The ornamental design for a faucet body, as shown and described.

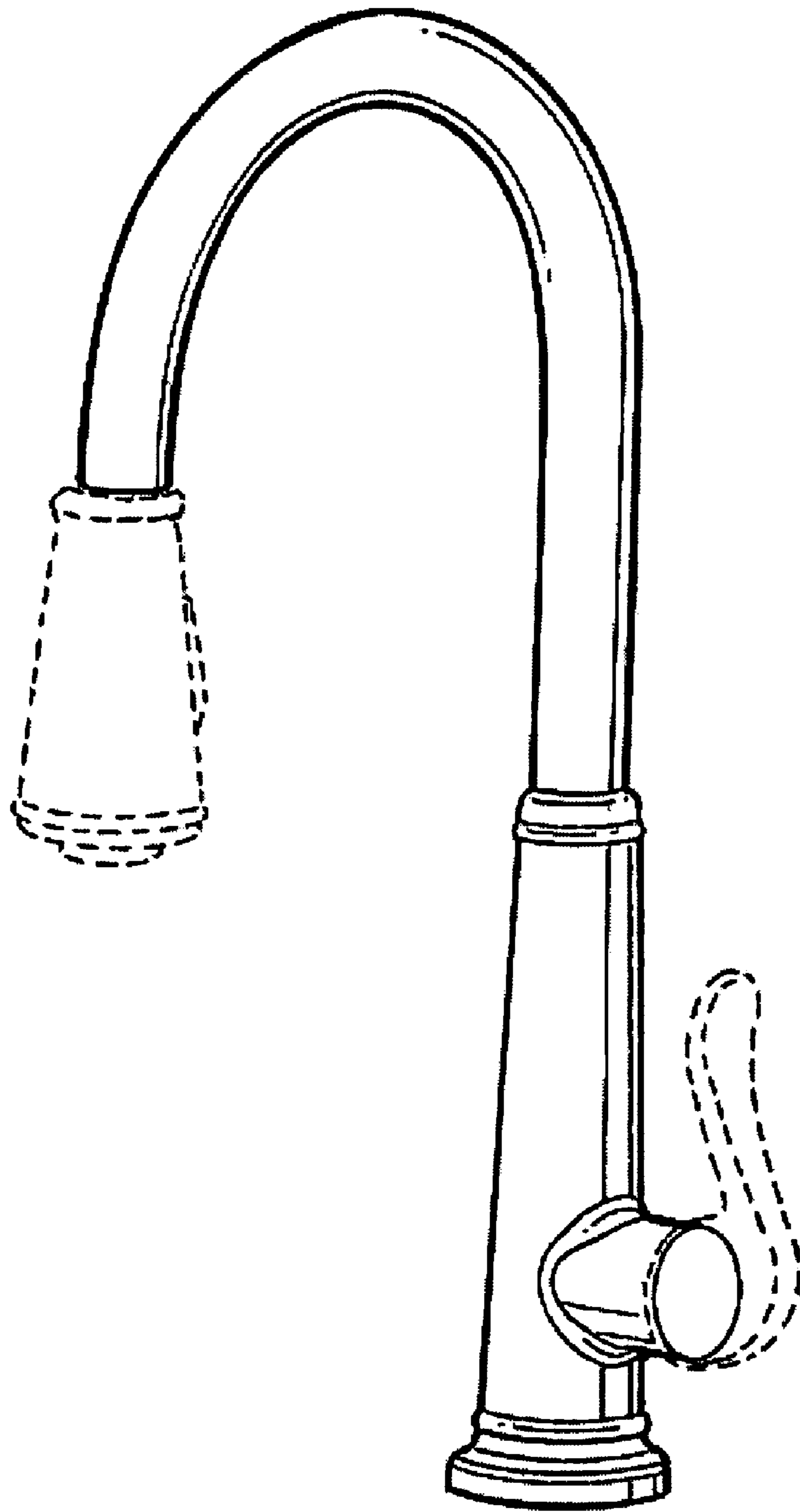

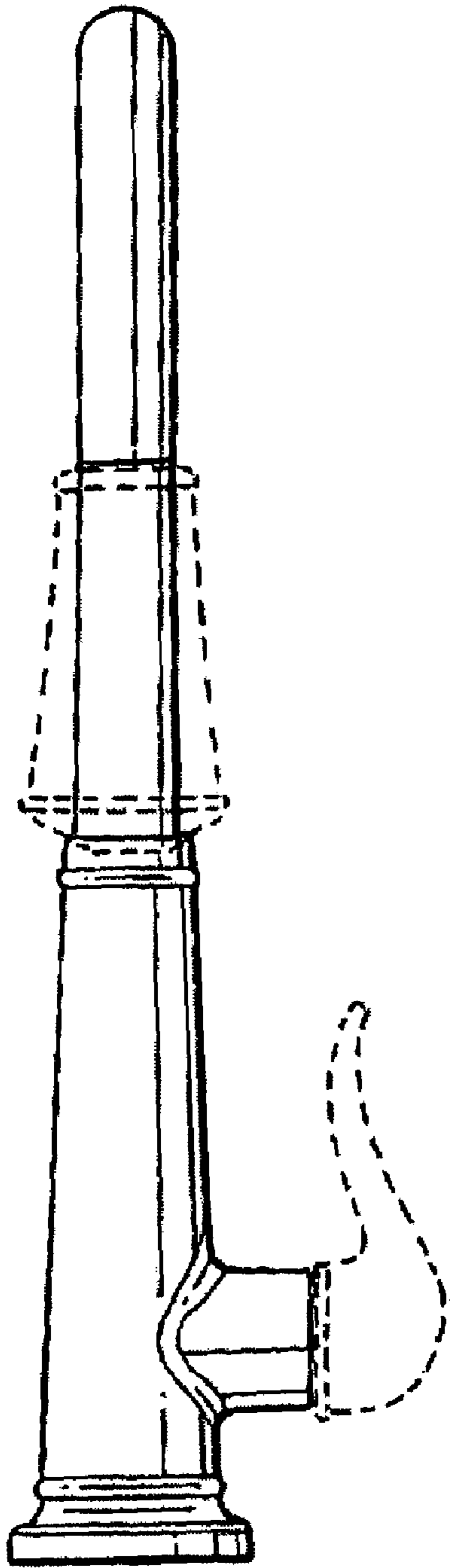

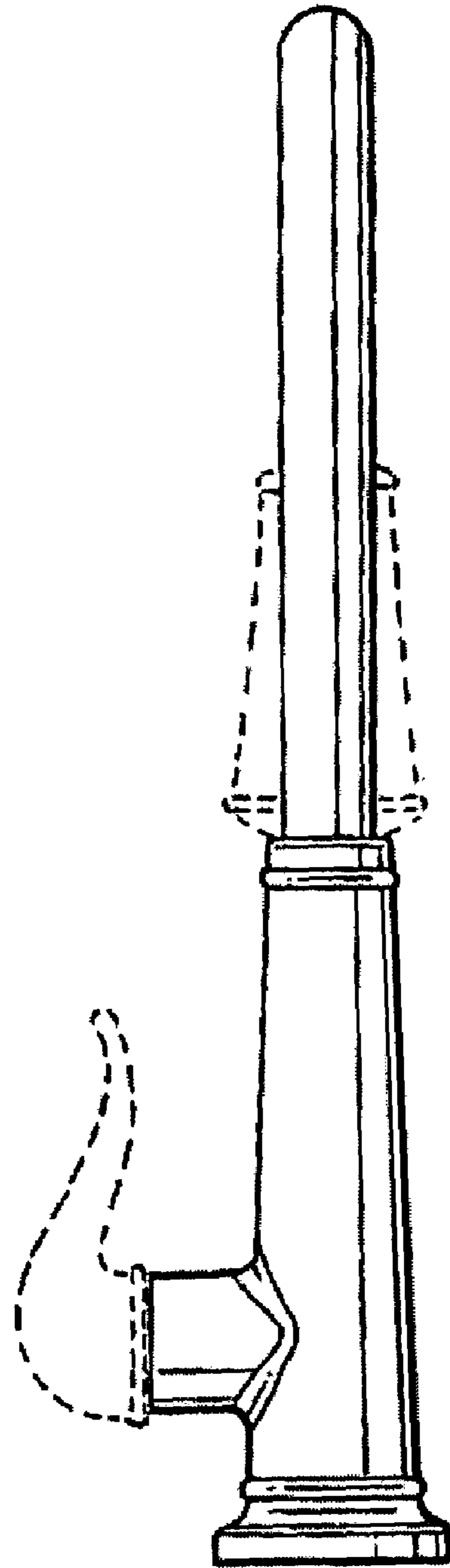

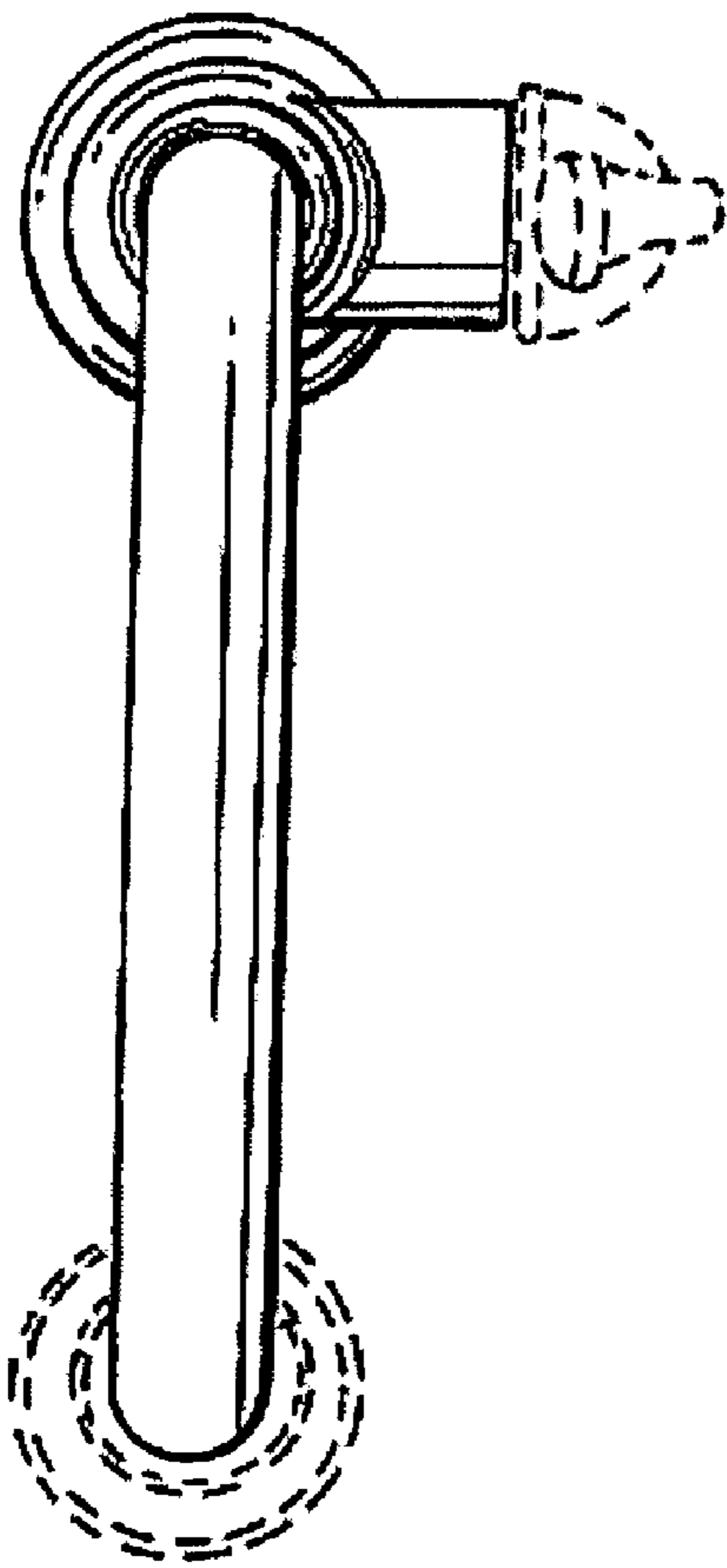

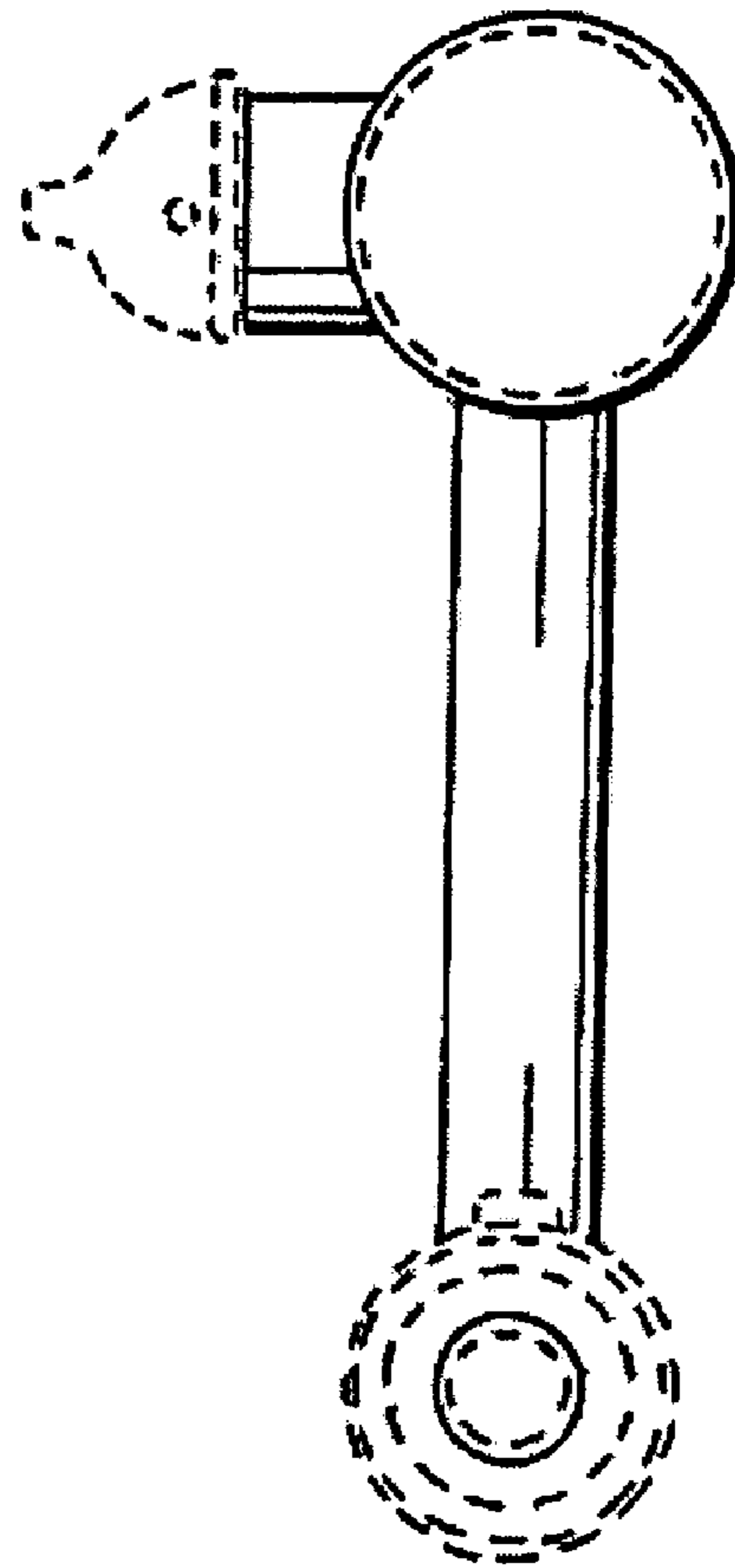

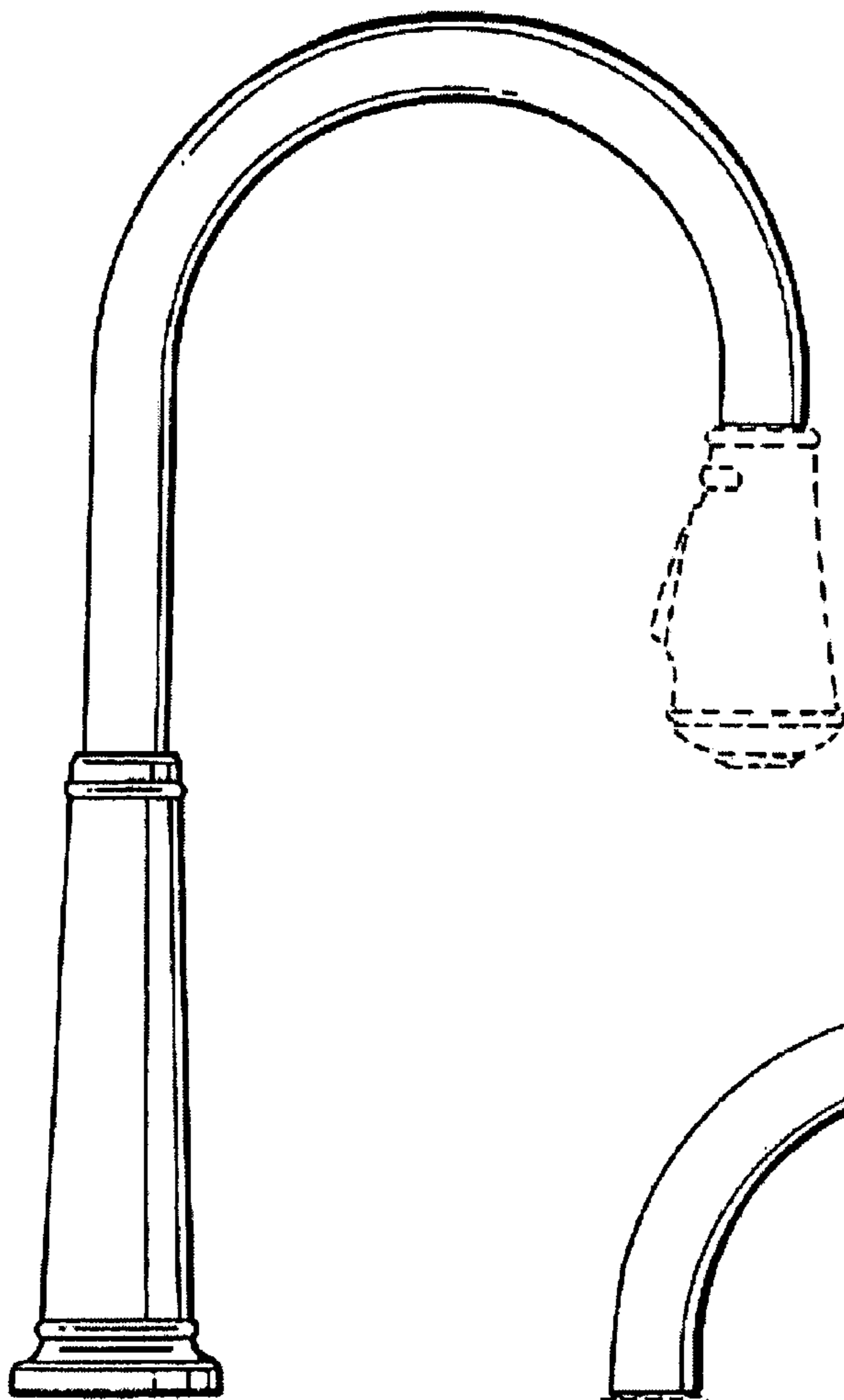

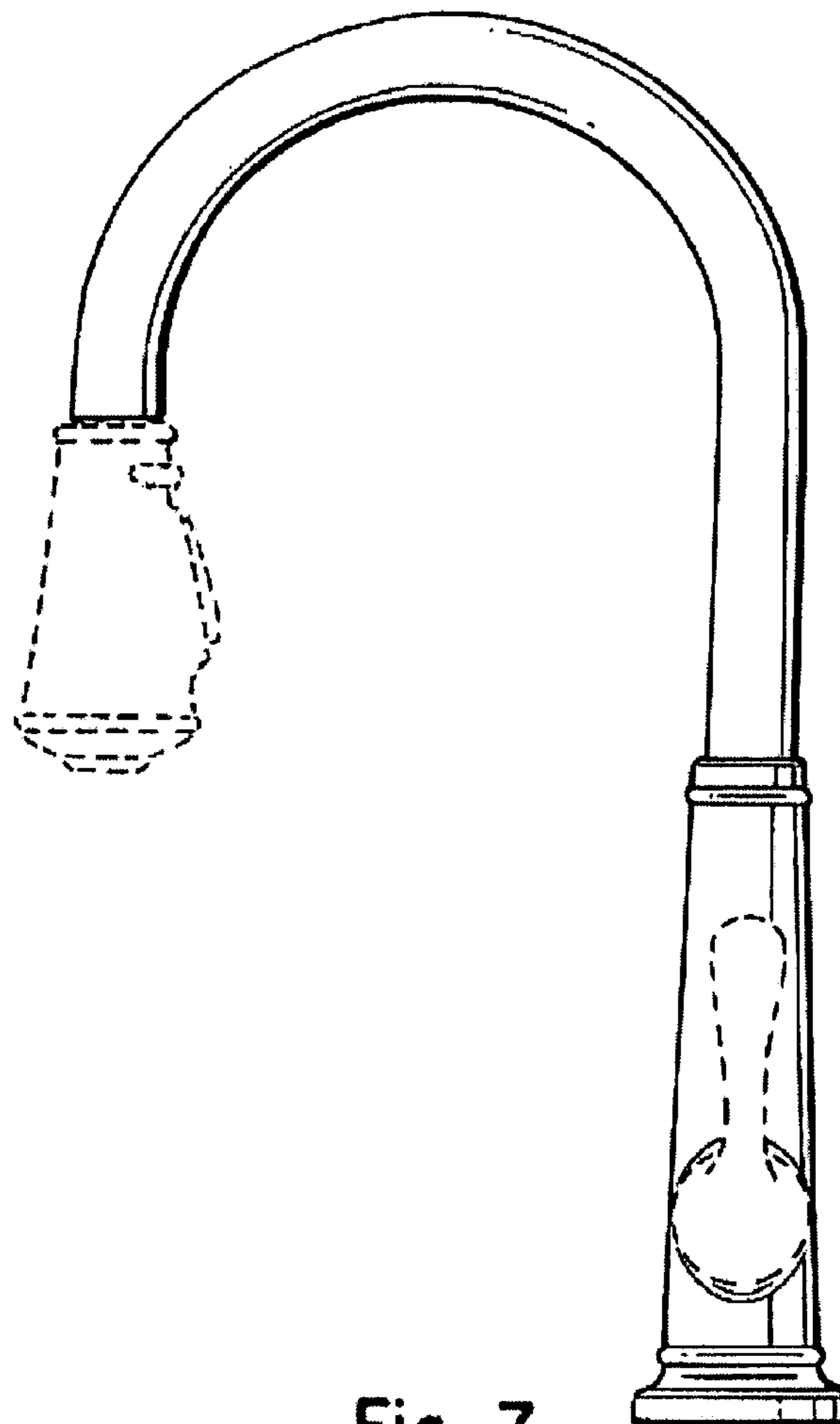
