(57) **CLAIM**

The ornamental design for a ceiling fan hanger, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of a ceiling fan hanger in accordance with my design shown in use;

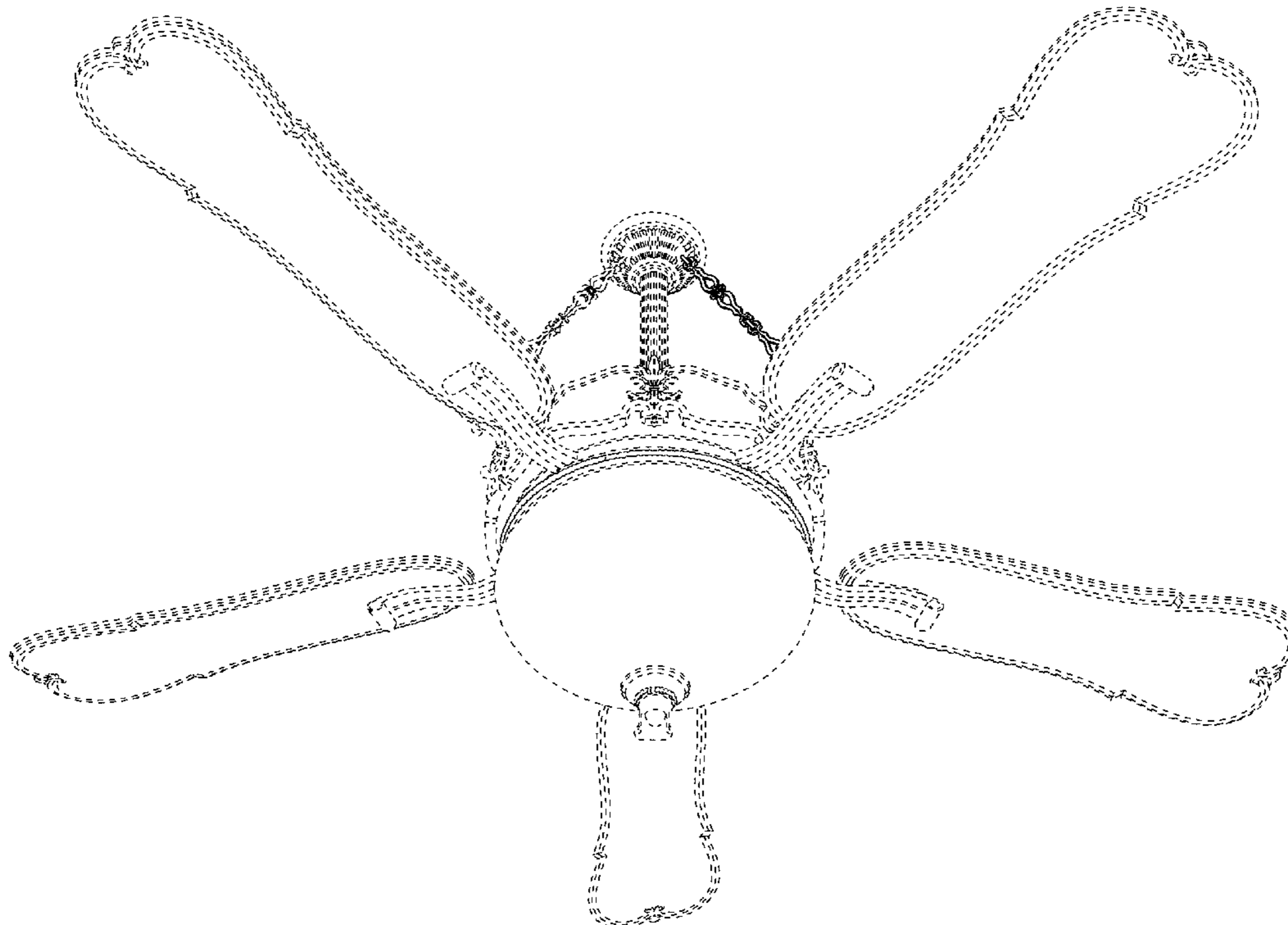
FIG. 2 is an enlarged perspective view of the ceiling fan hanger in accordance with my design;

FIG. 3 is an enlarged front plan view of the ceiling fan hanger in accordance with my design, the opposite view being a mirror image of that shown; and,

FIG. 4 is an enlarged side elevation view of the ceiling fan hanger in accordance with my design, the opposite view being a mirror image of that shown.

The broken line showing of the canopy, support rod, ceiling fan hanger, ceiling fan blades, blade irons, ceiling fan housing and light fixture is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

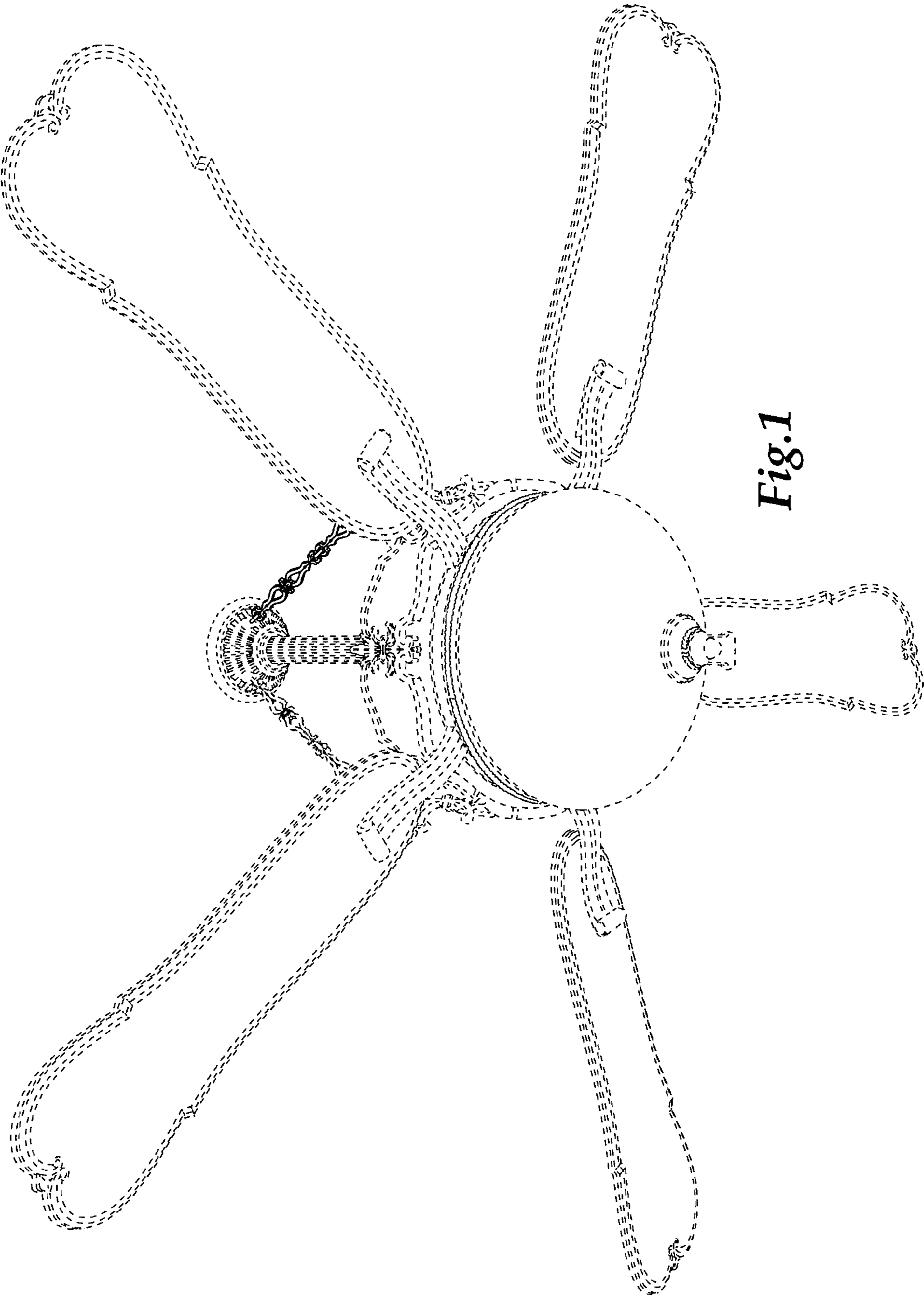

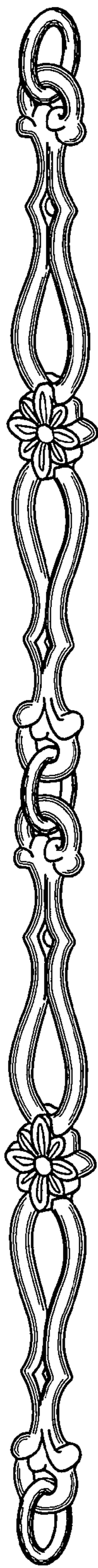

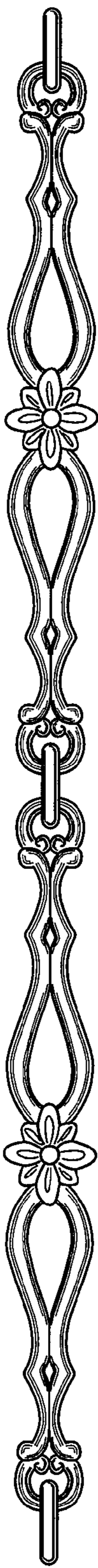

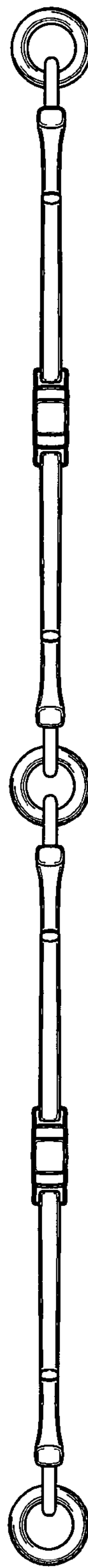
