FIG. 3 is a bottom plan view of the multi-well plate of FIG. 1;

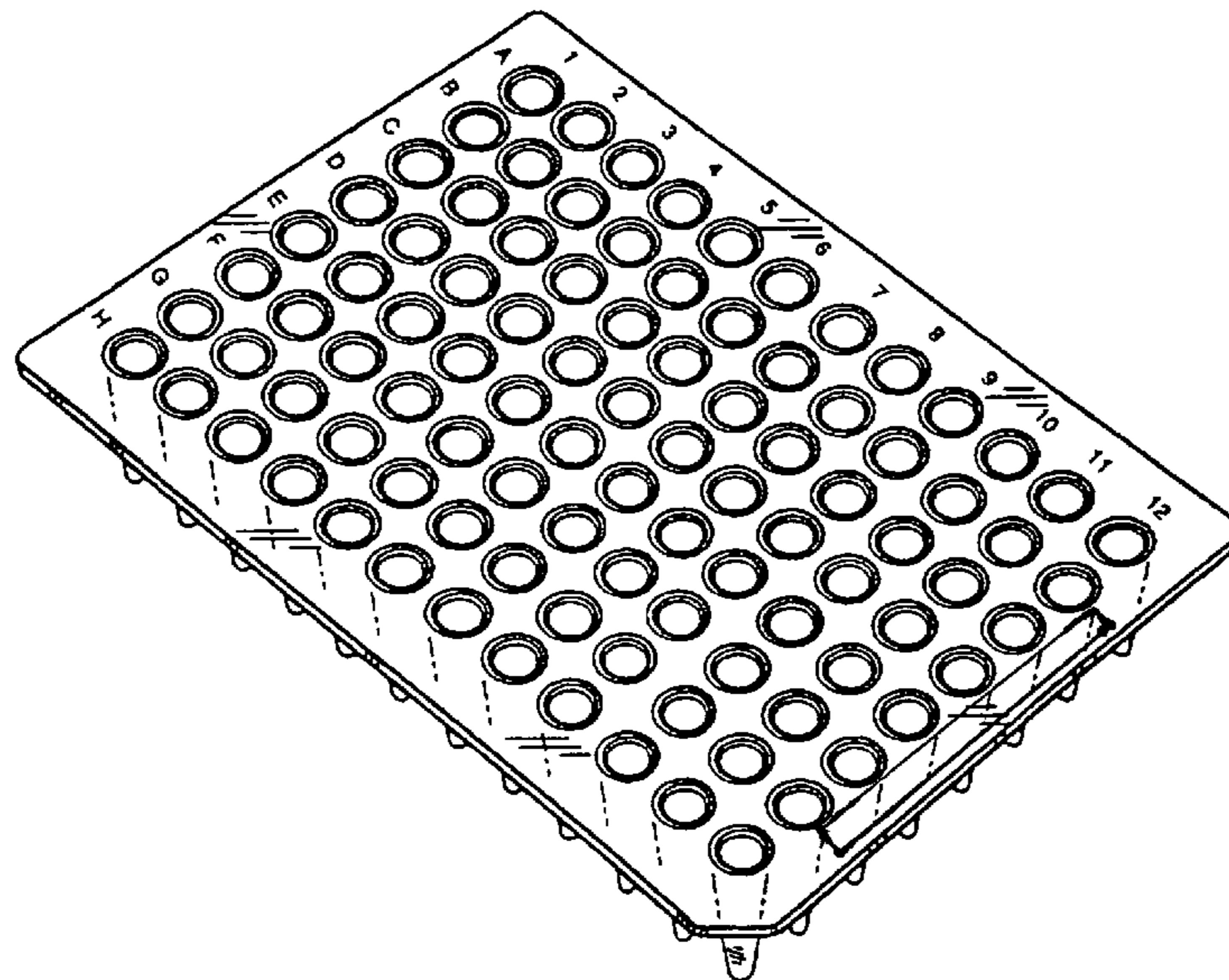
FIG. 4 is a front elevational view of the multi-well plate of FIG. 1;

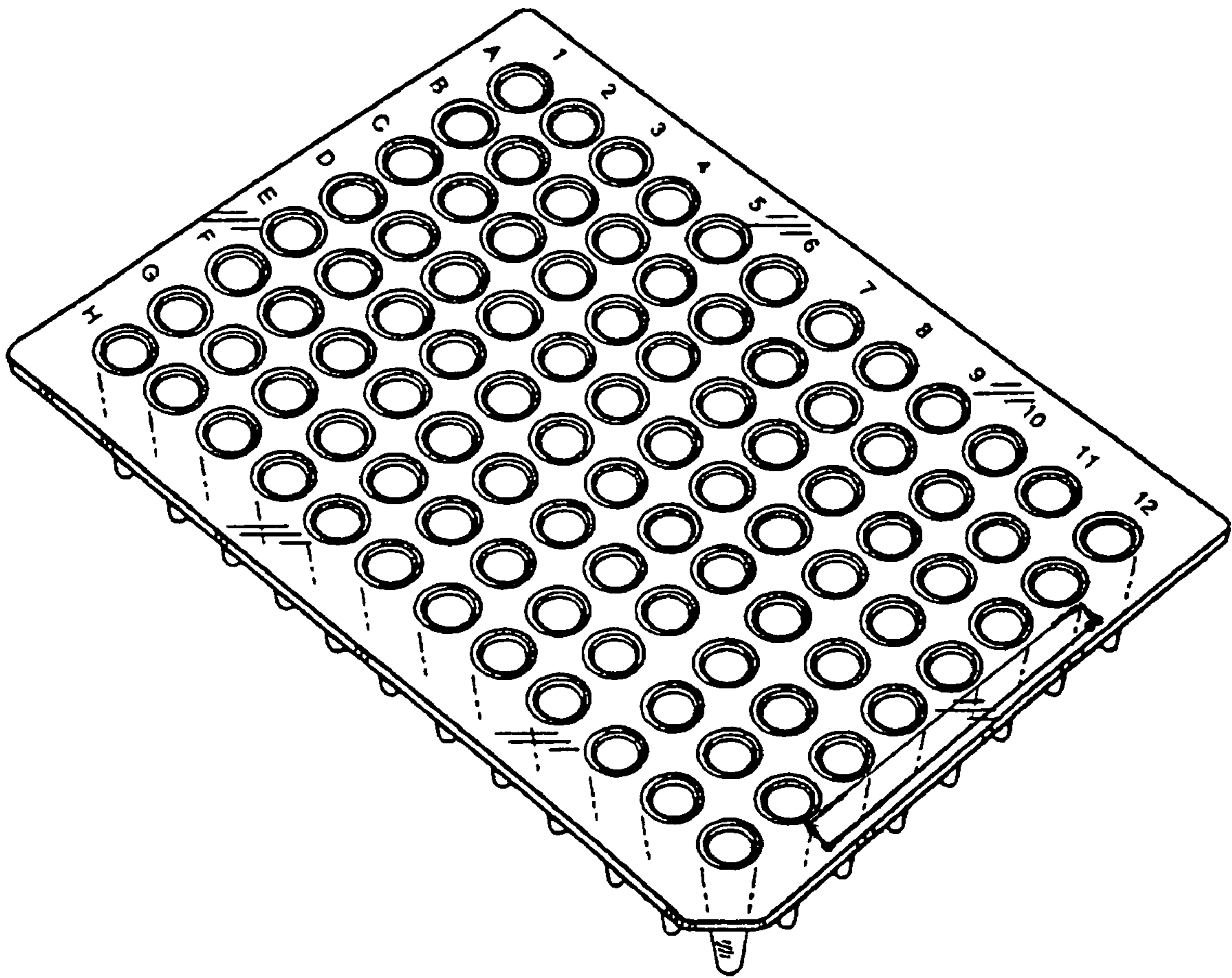

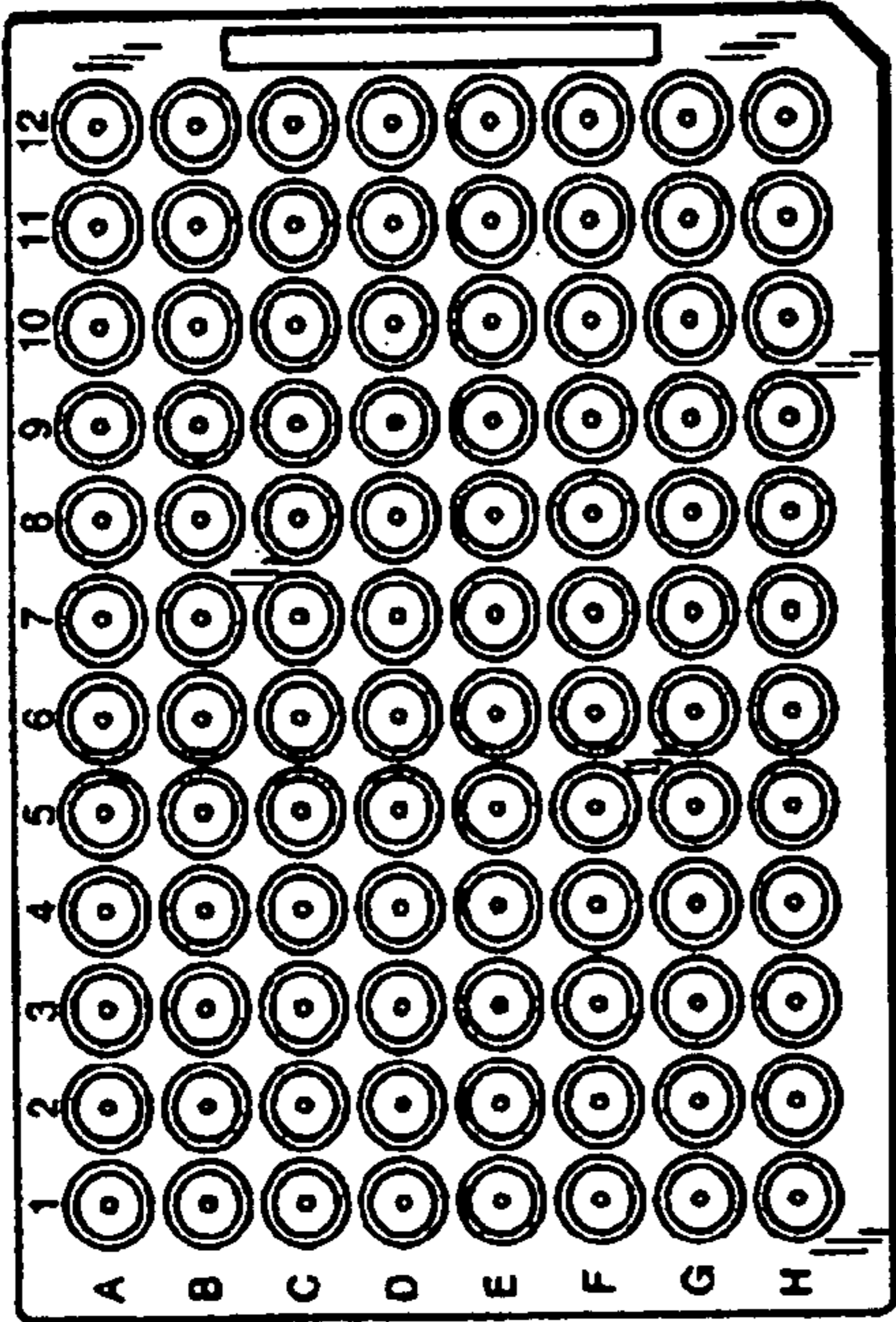

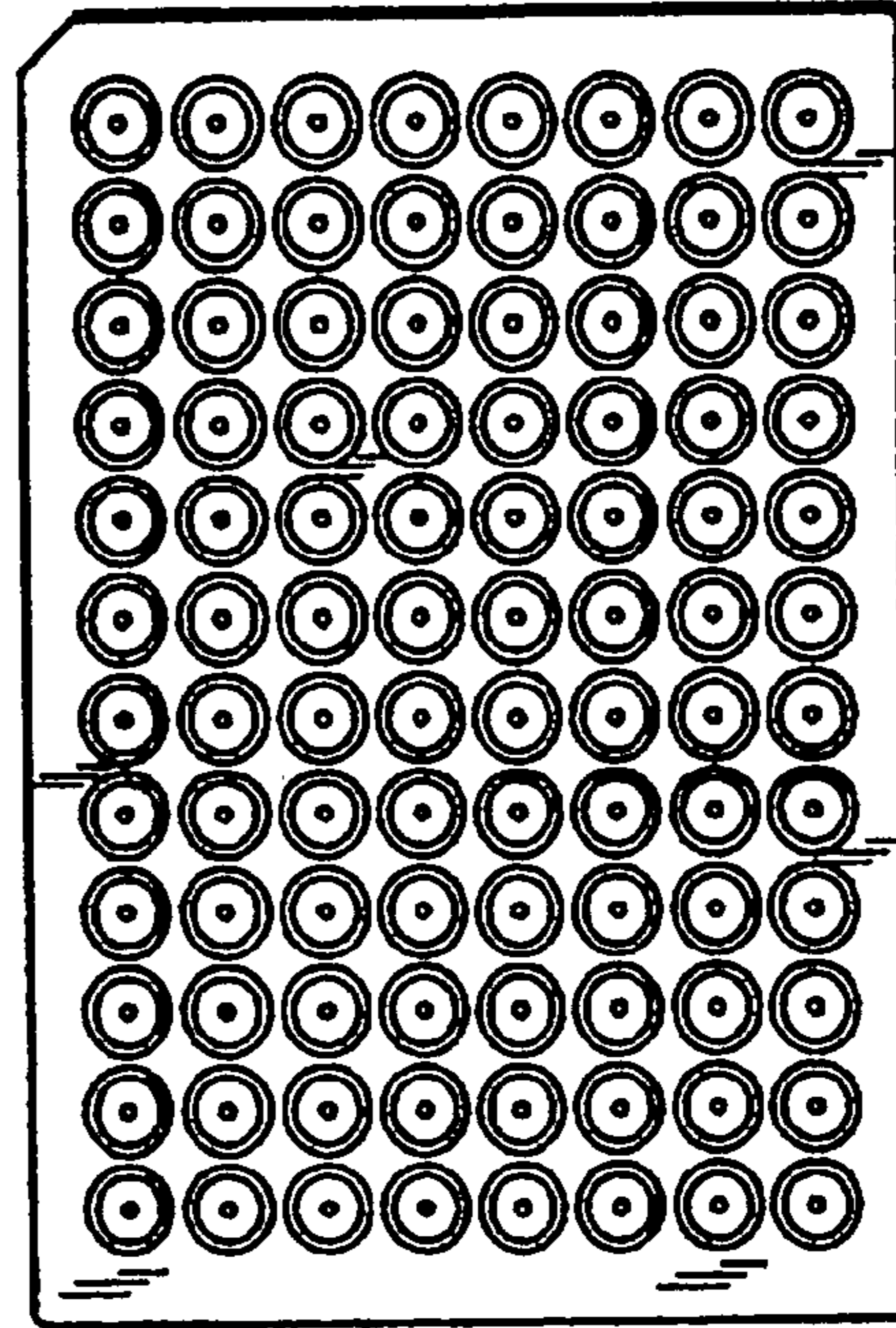

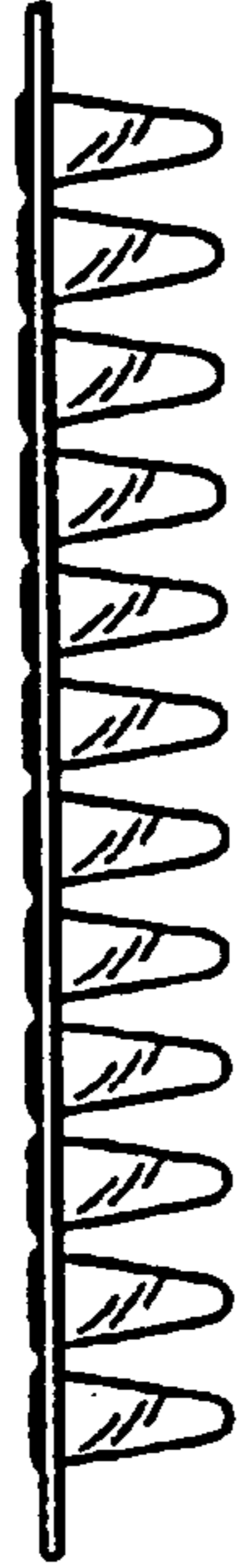

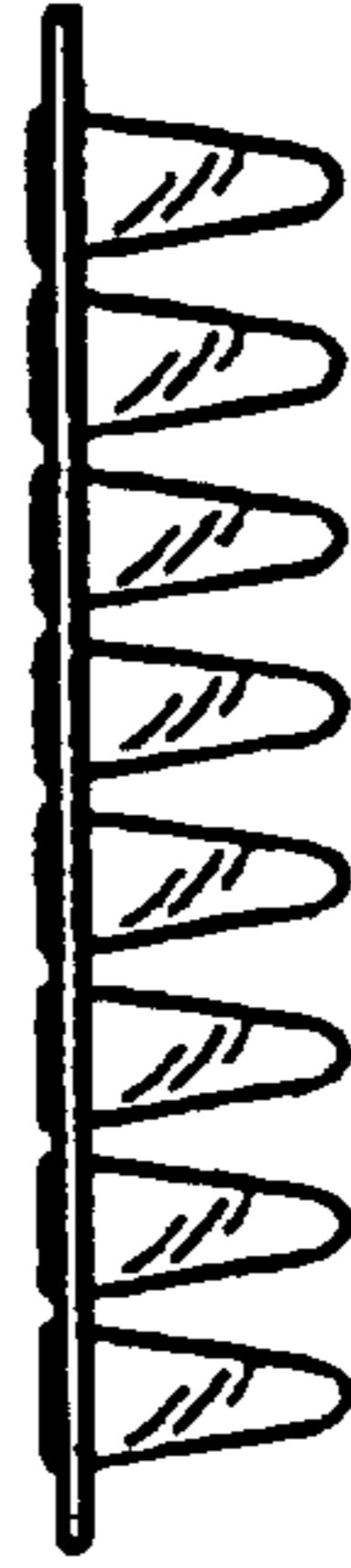
