The ornamental design for a handle mount portion of drywall duster base, as shown and described.

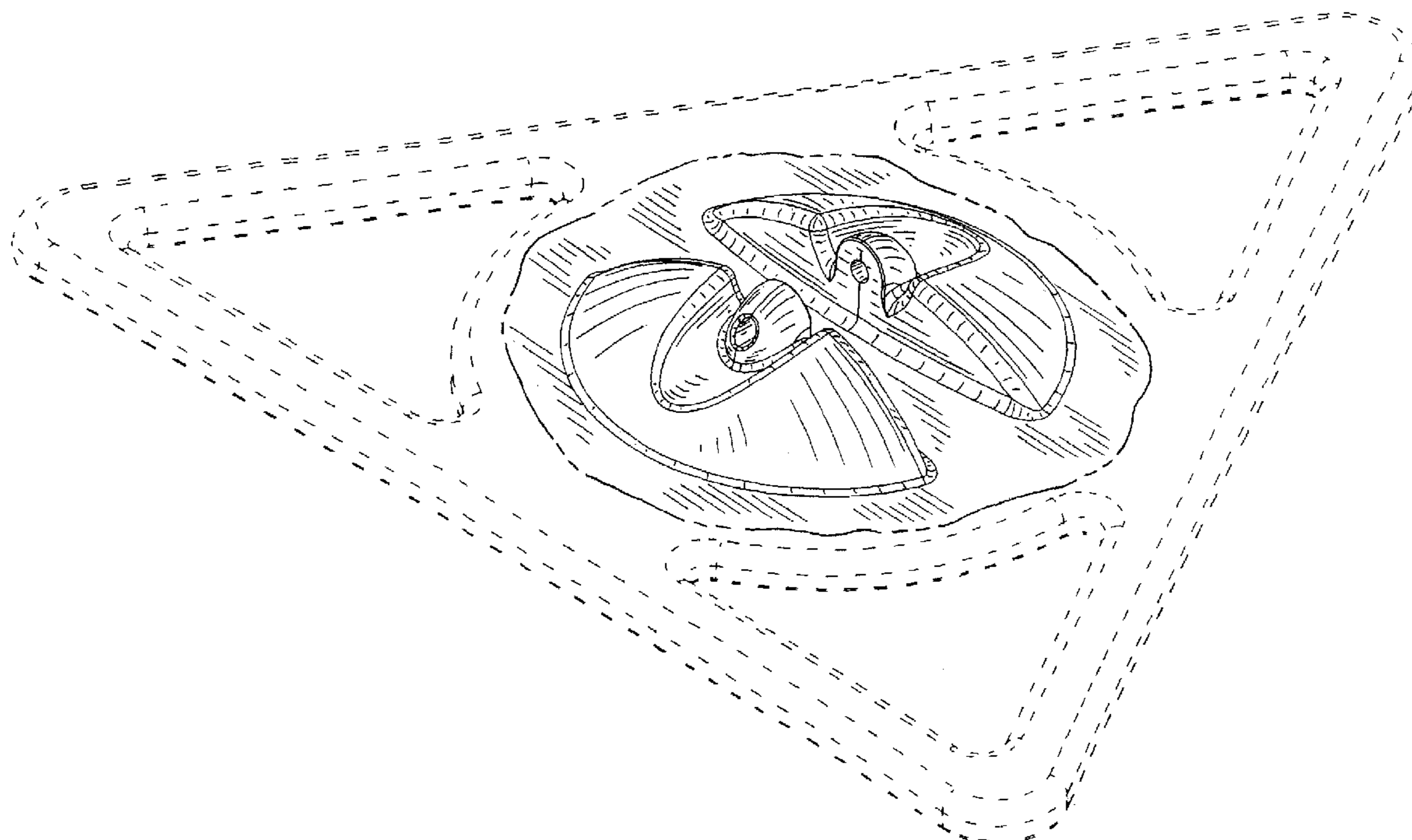
DESCRIPTION

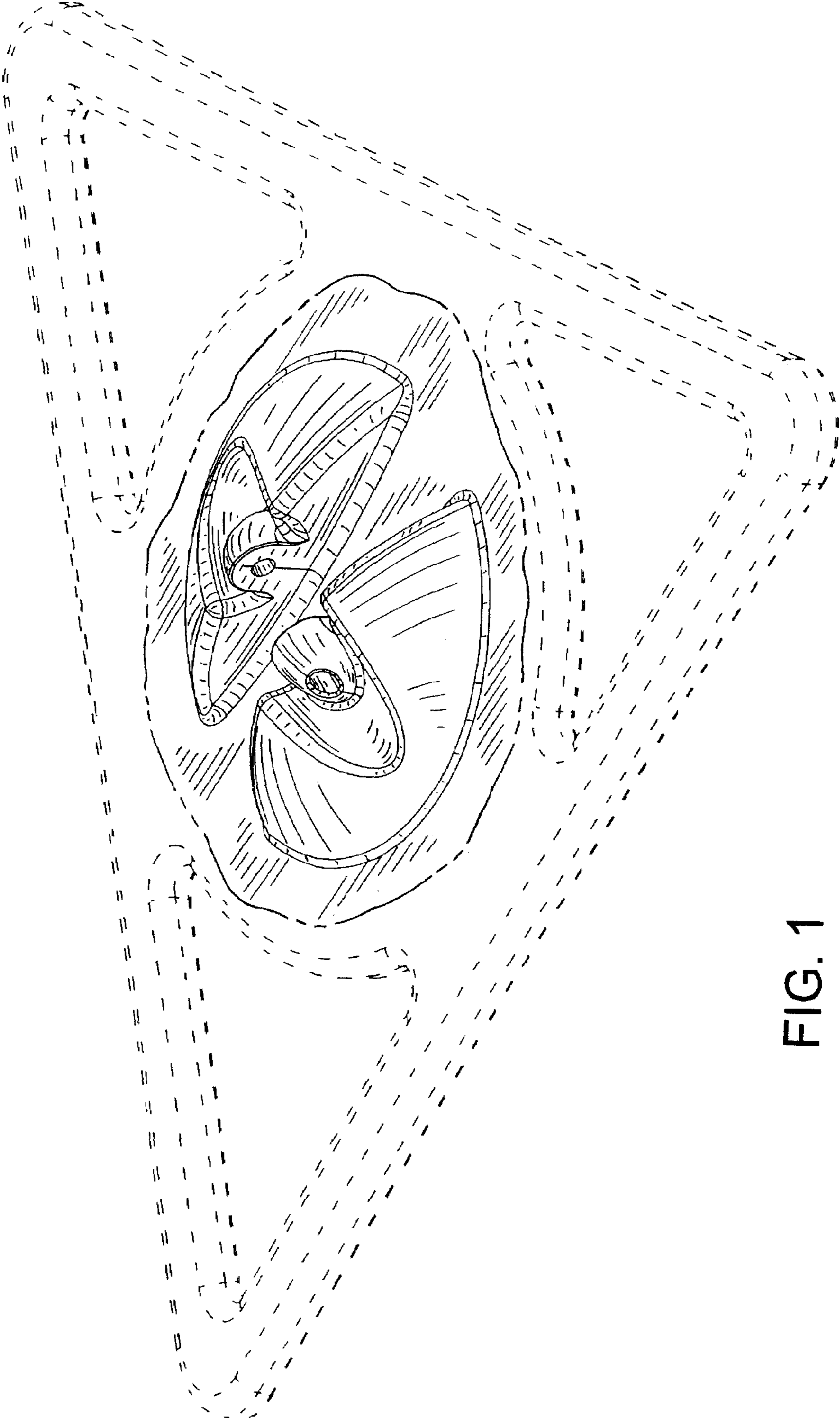

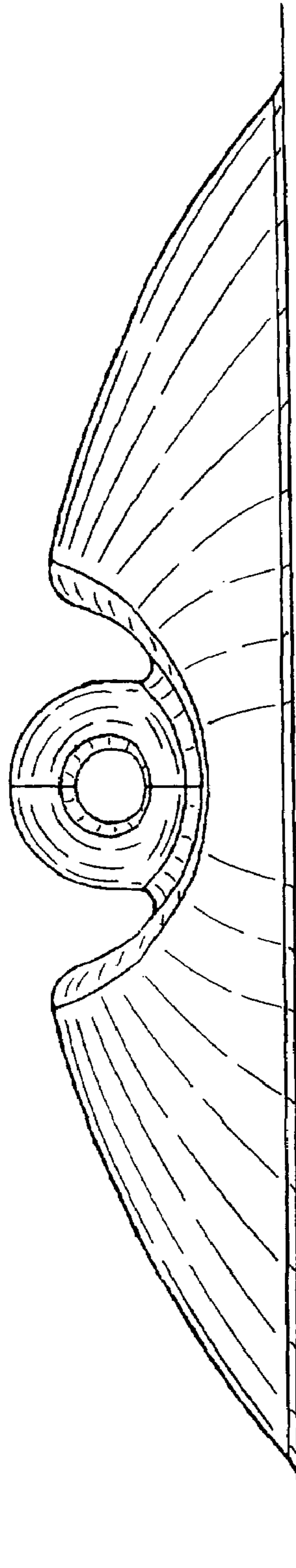
