**DESCRIPTION**

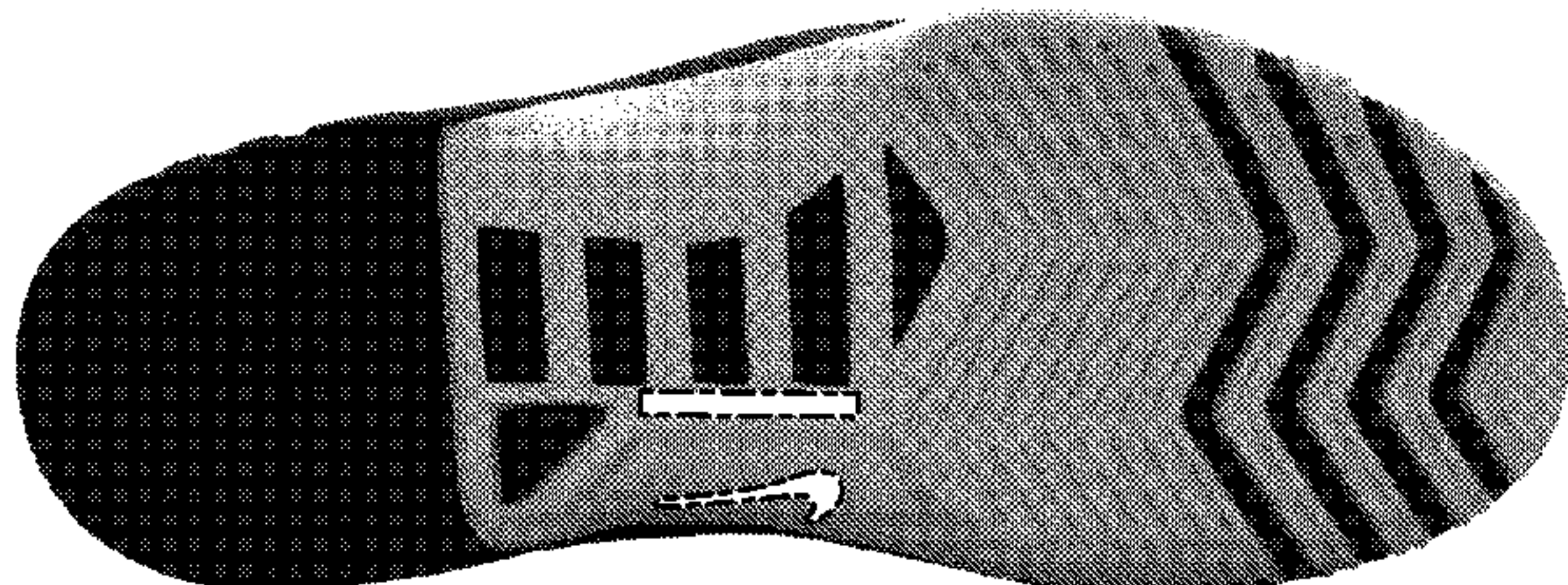
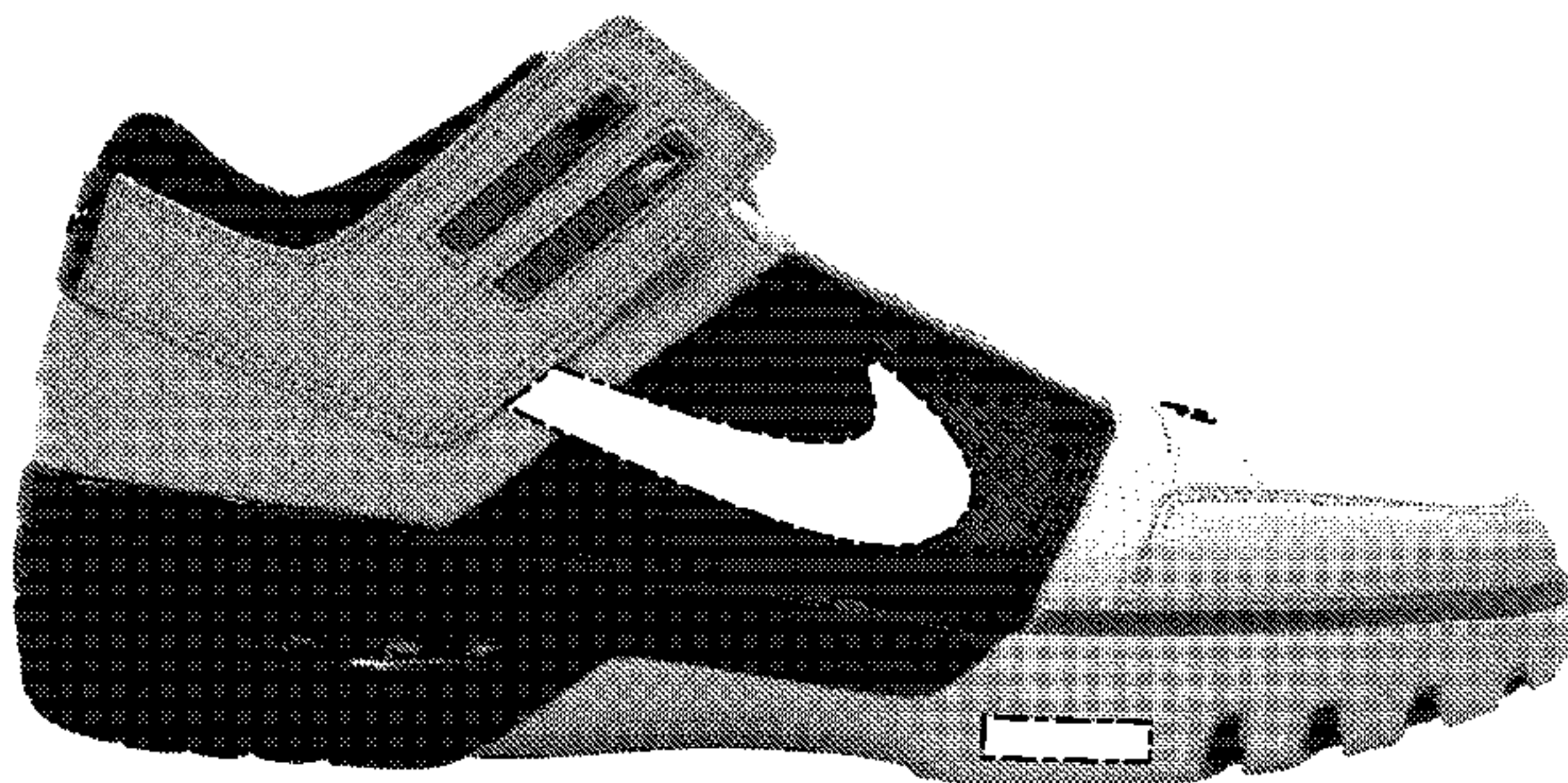

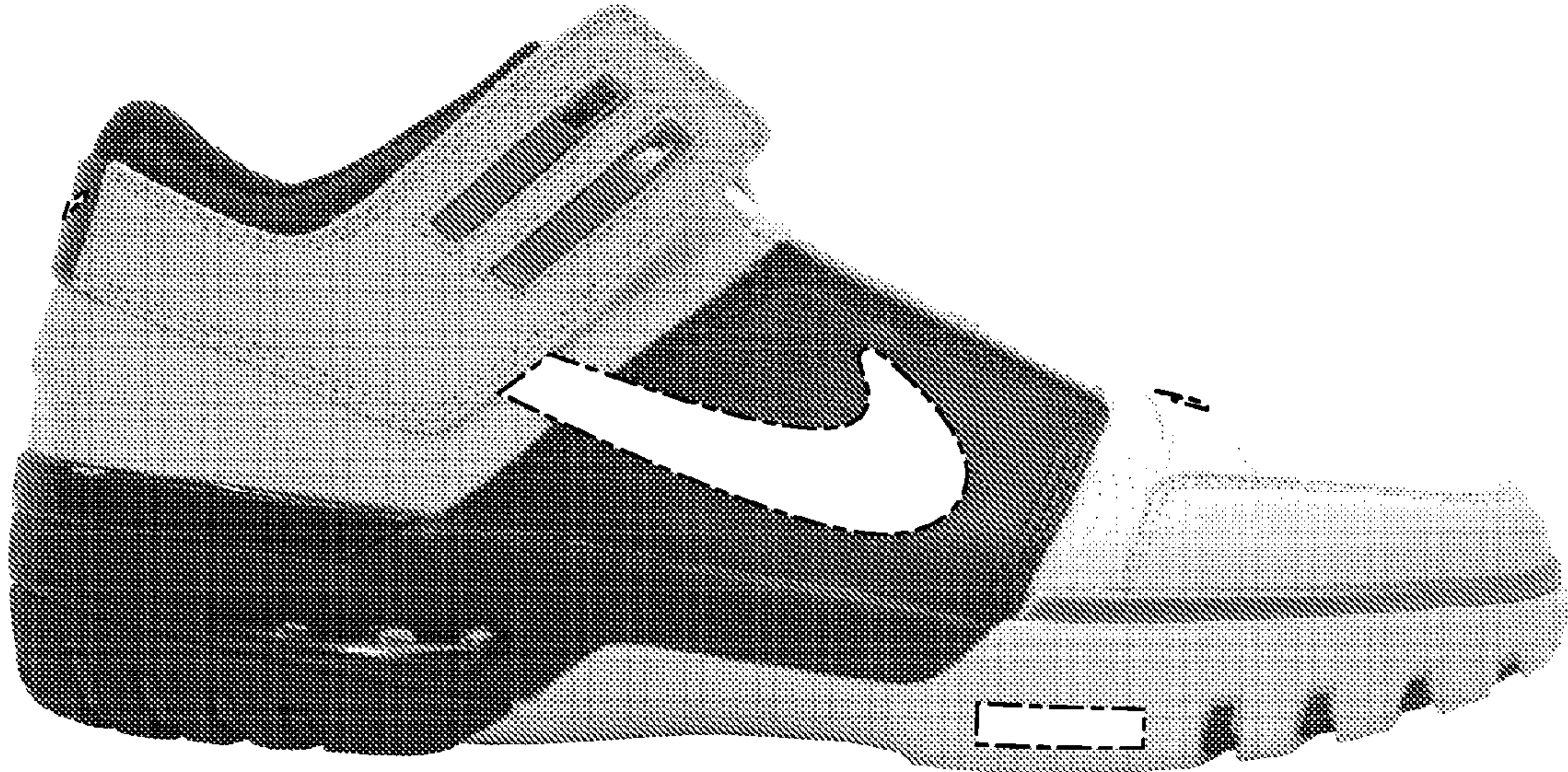

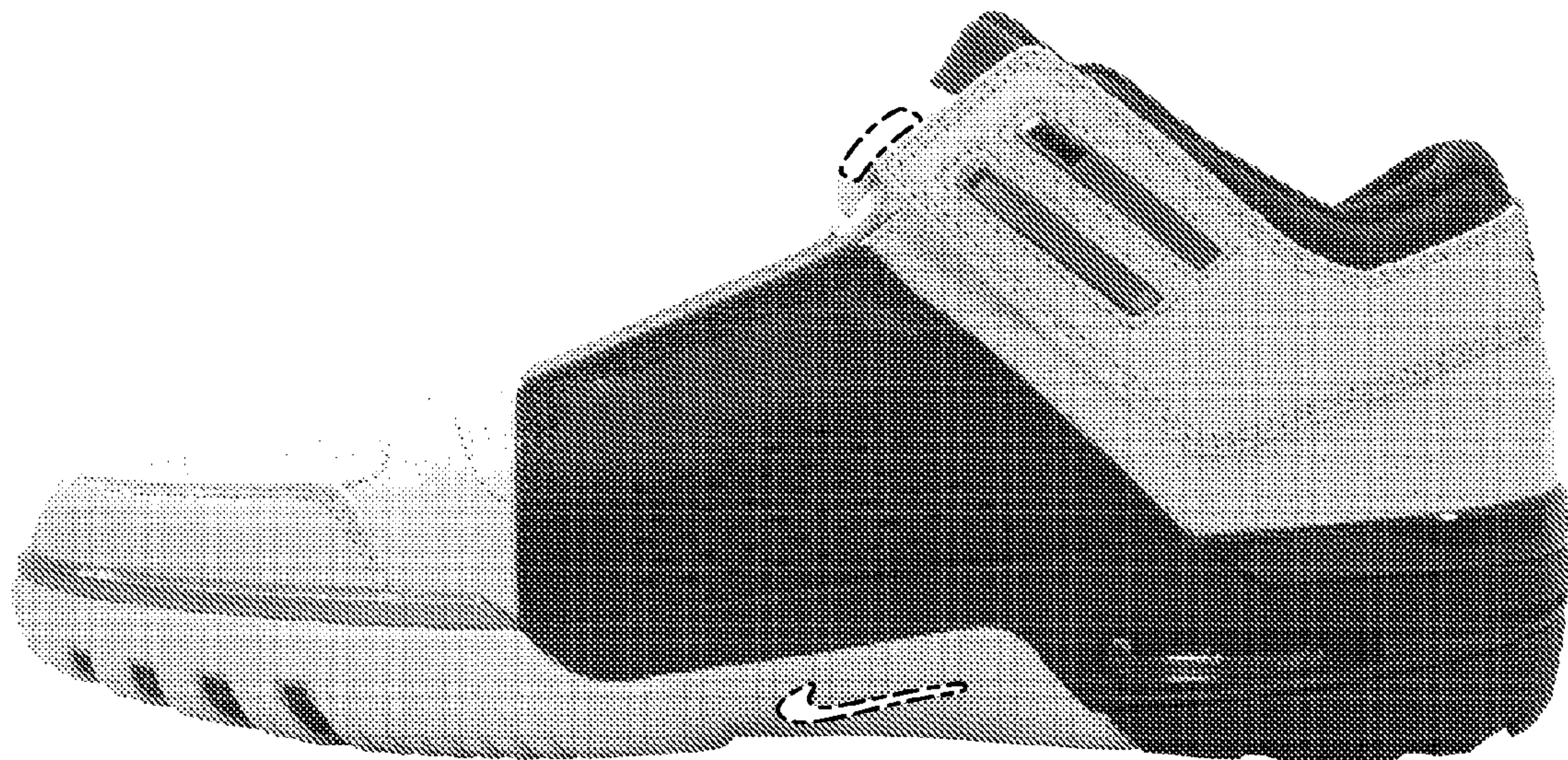

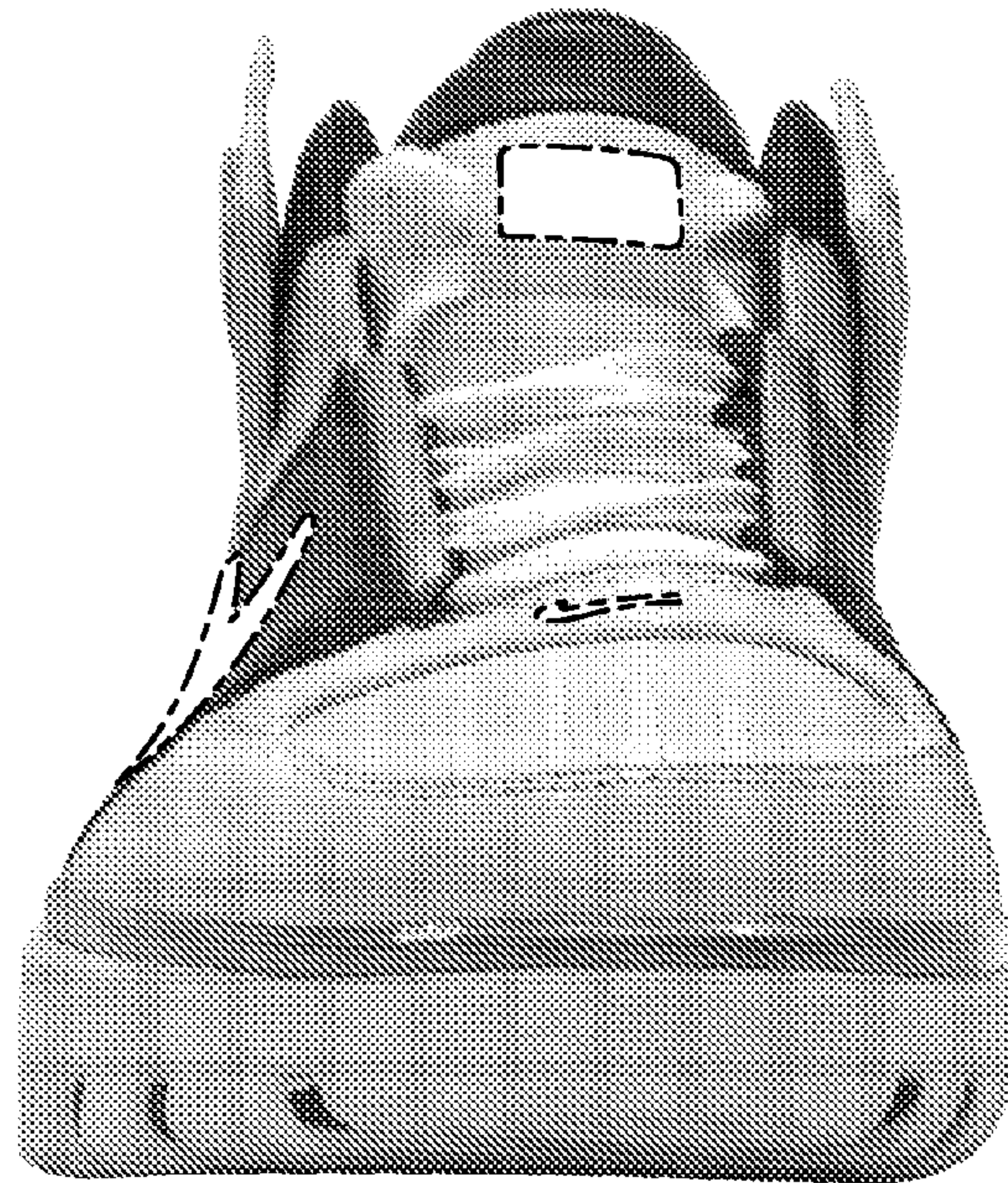

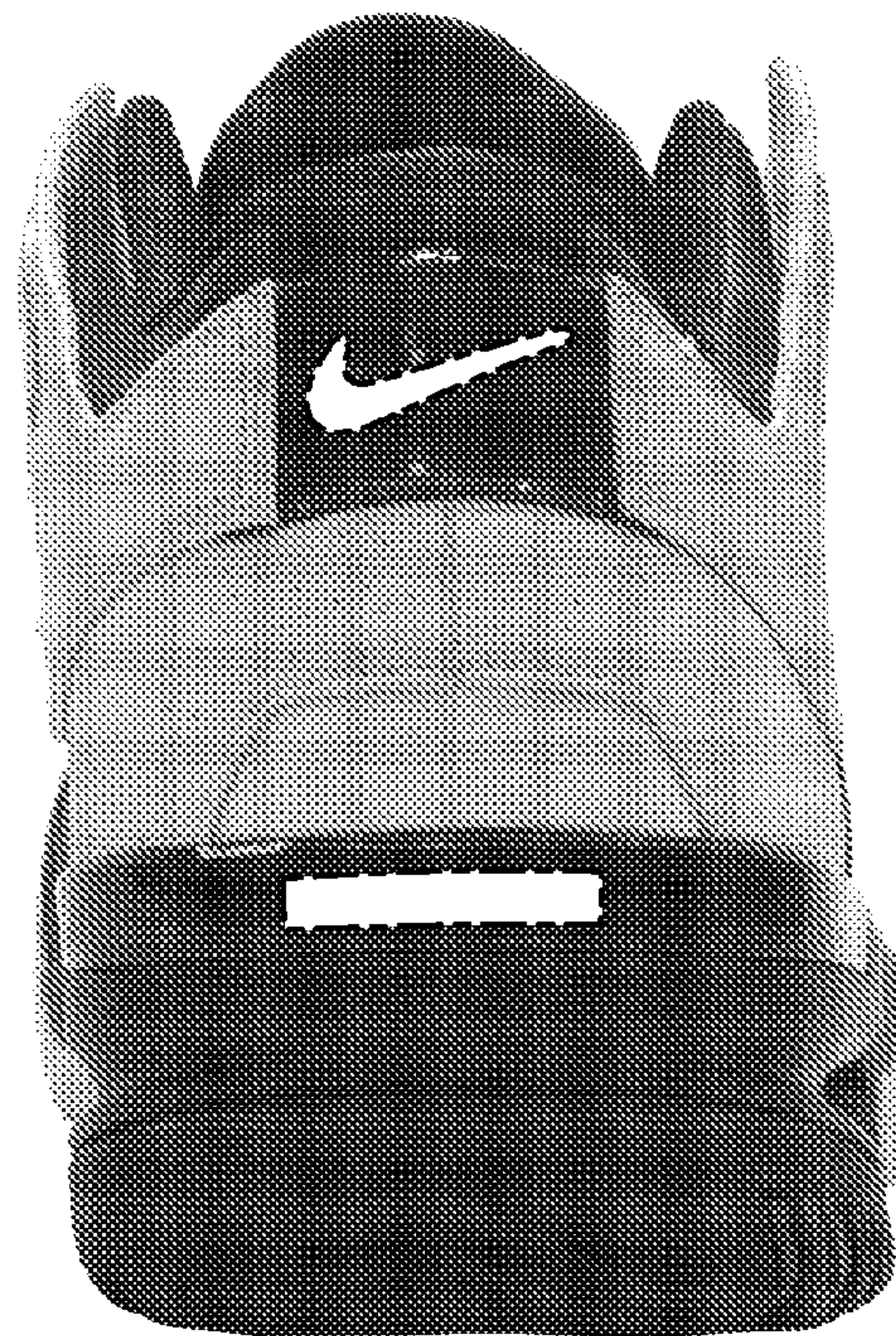

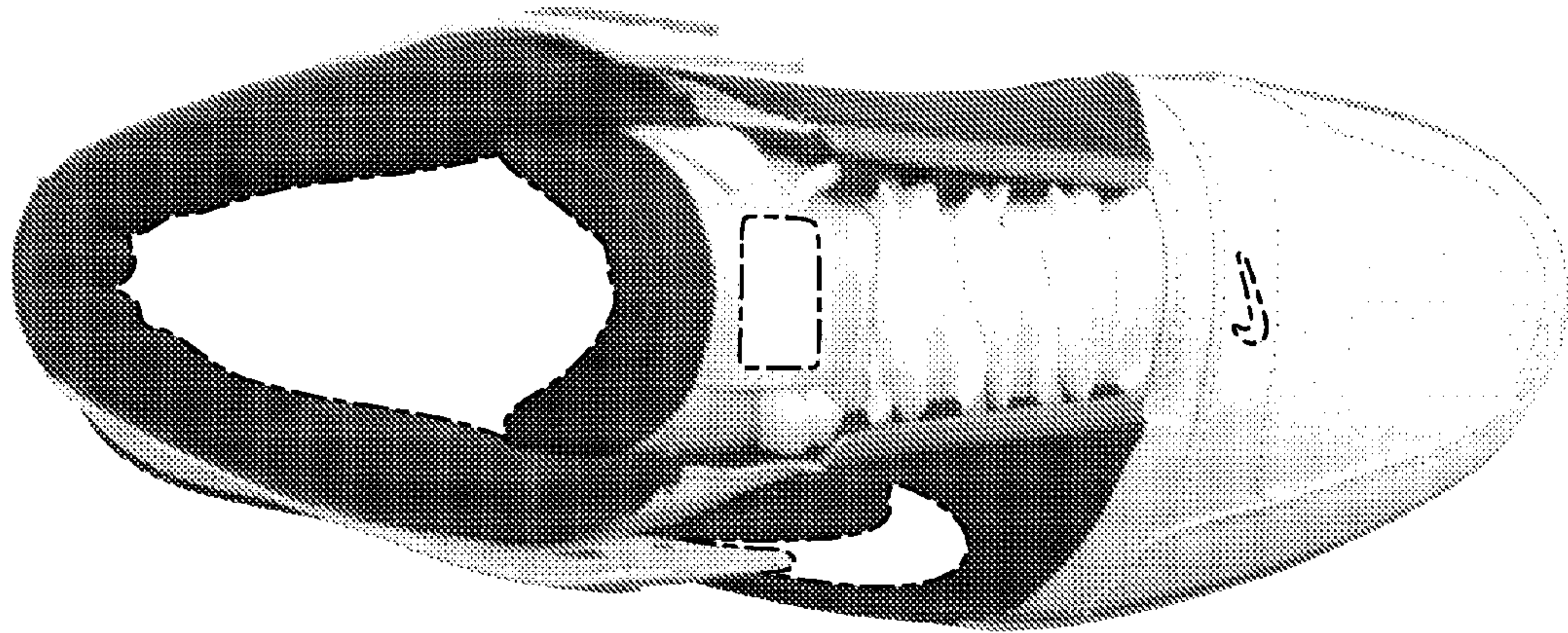

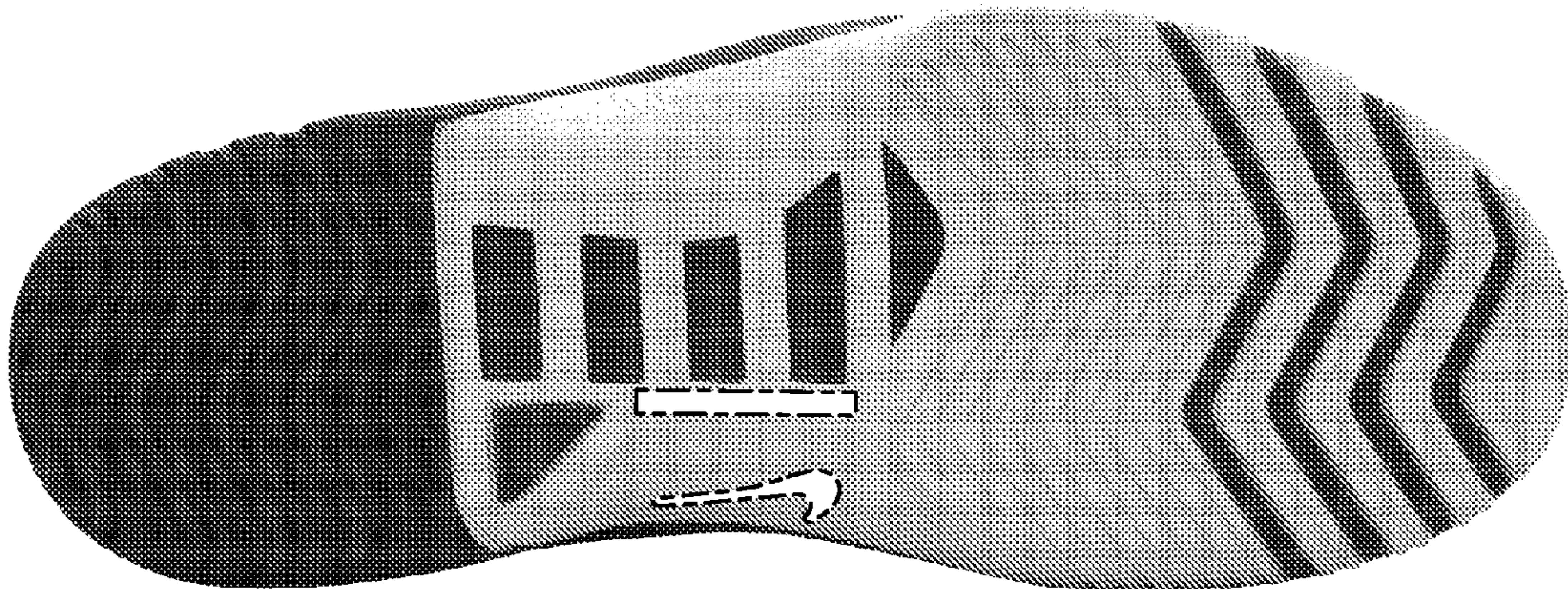
