FIG. 18 is a top perspective view of FIG. 13.

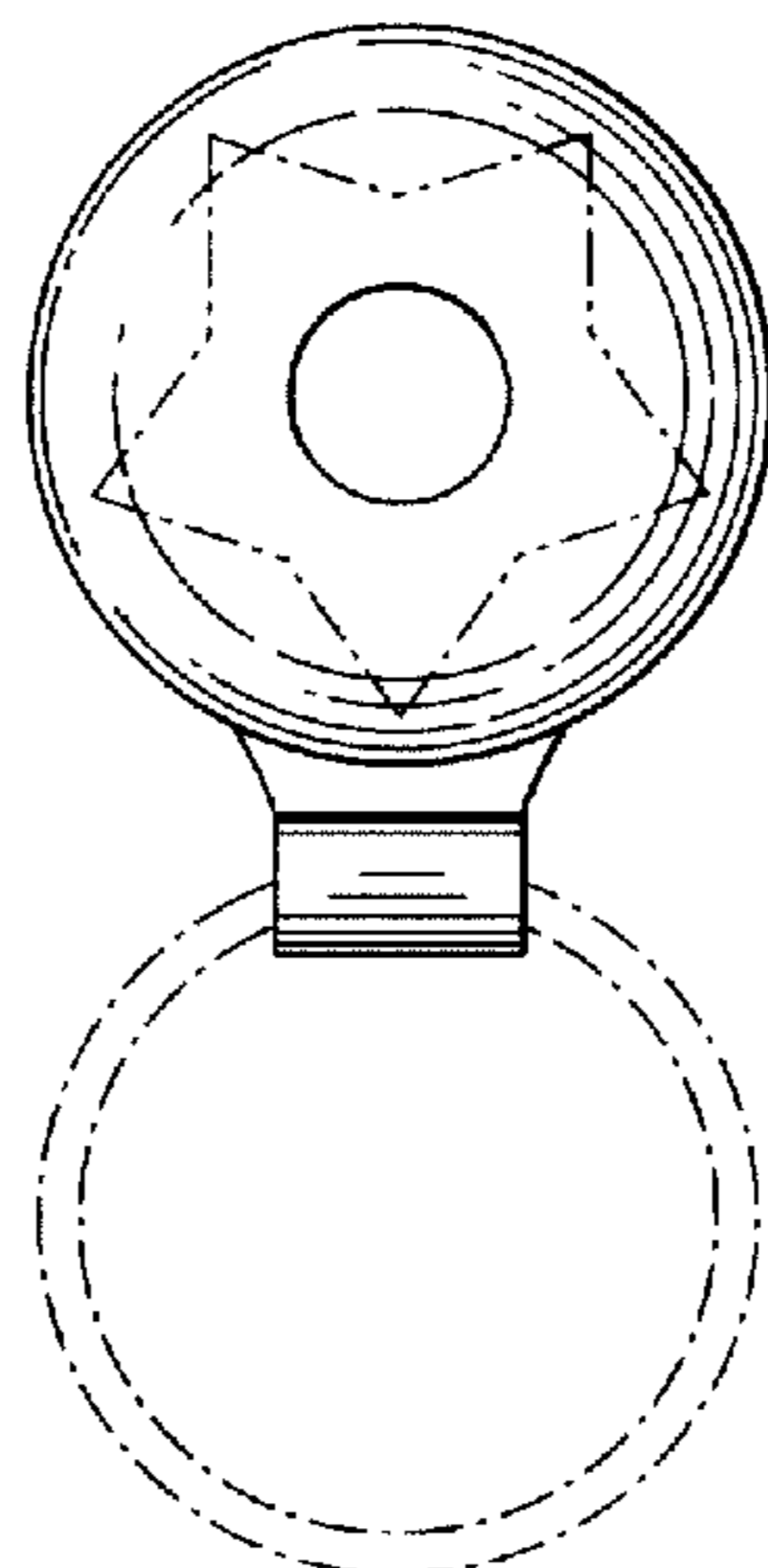

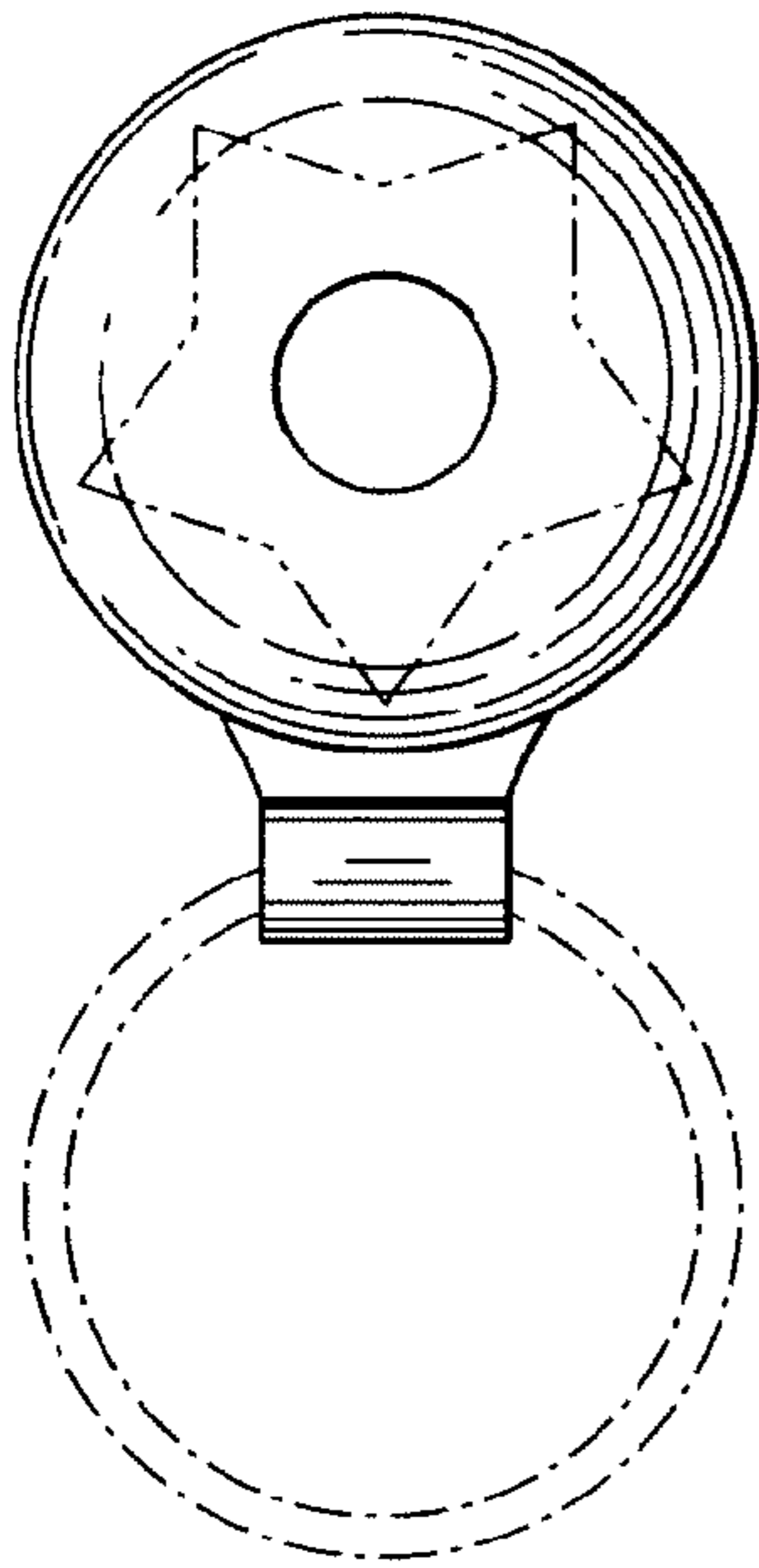

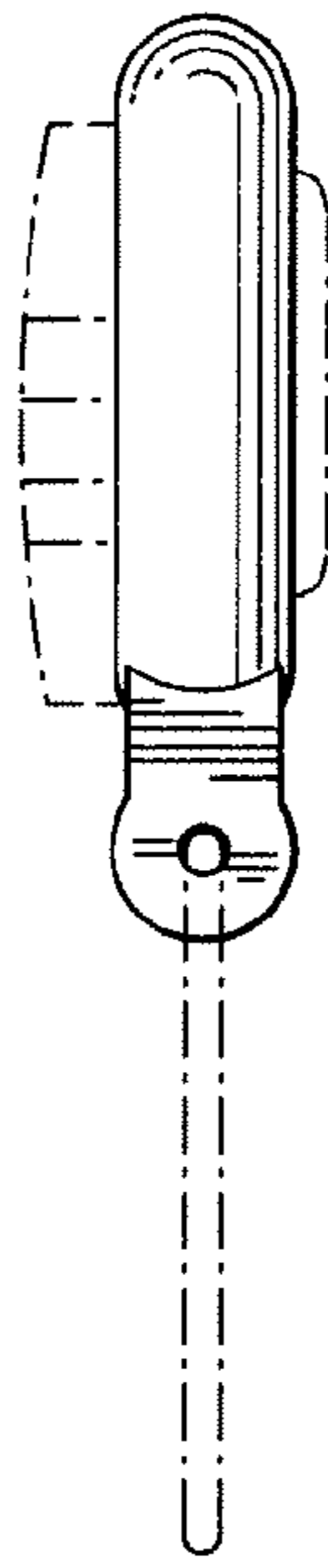

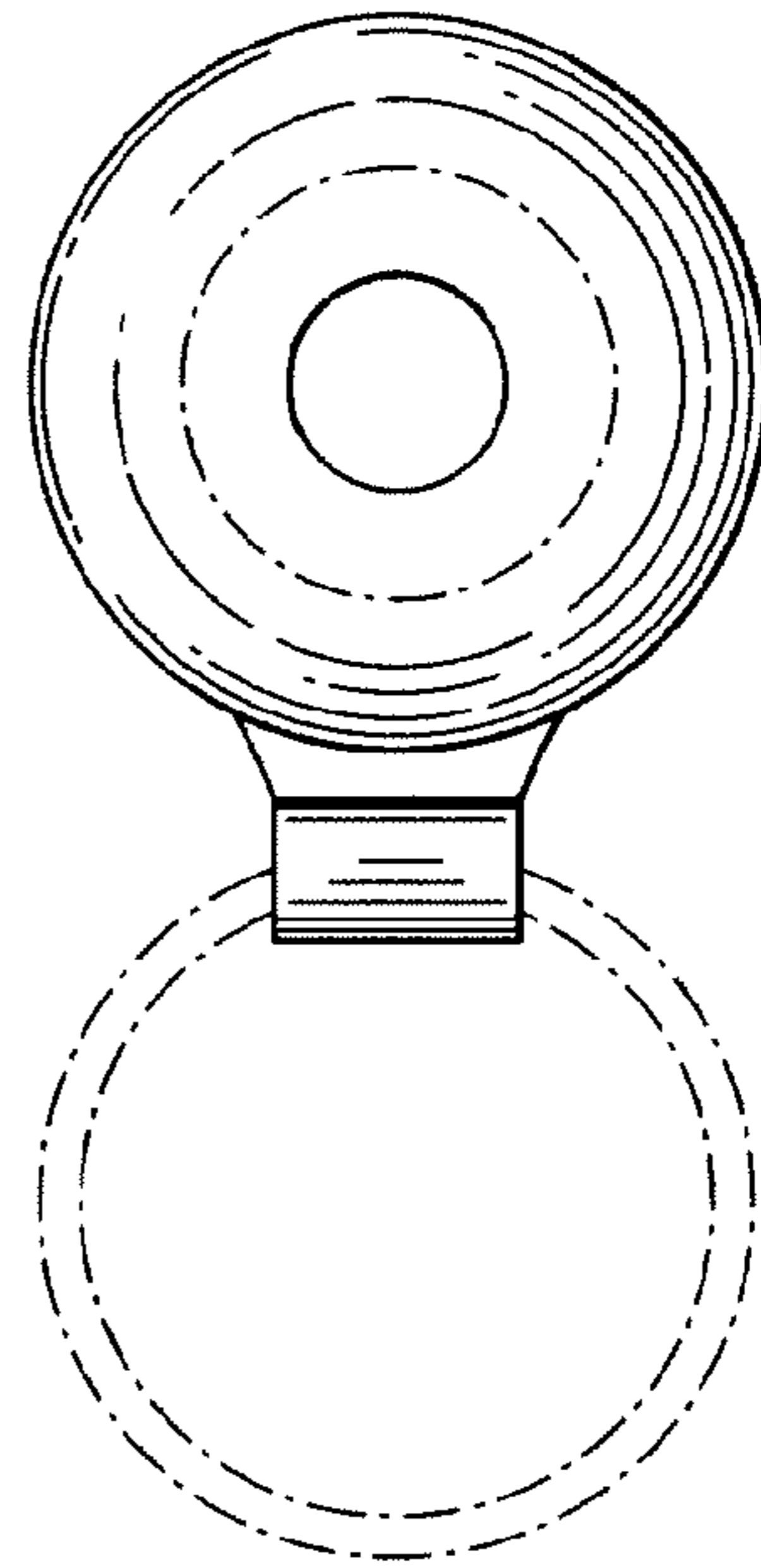

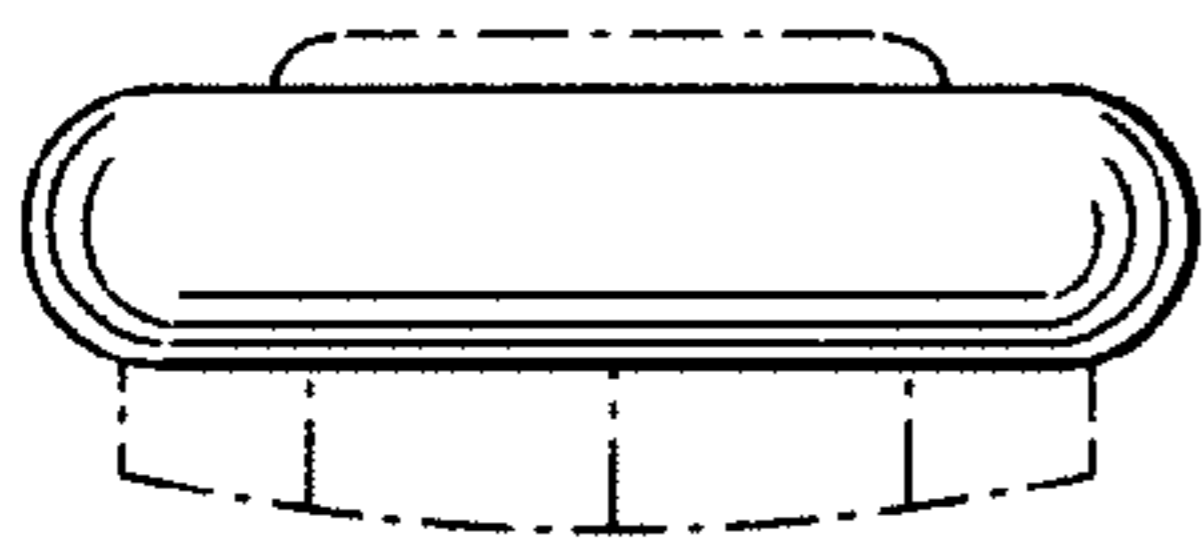

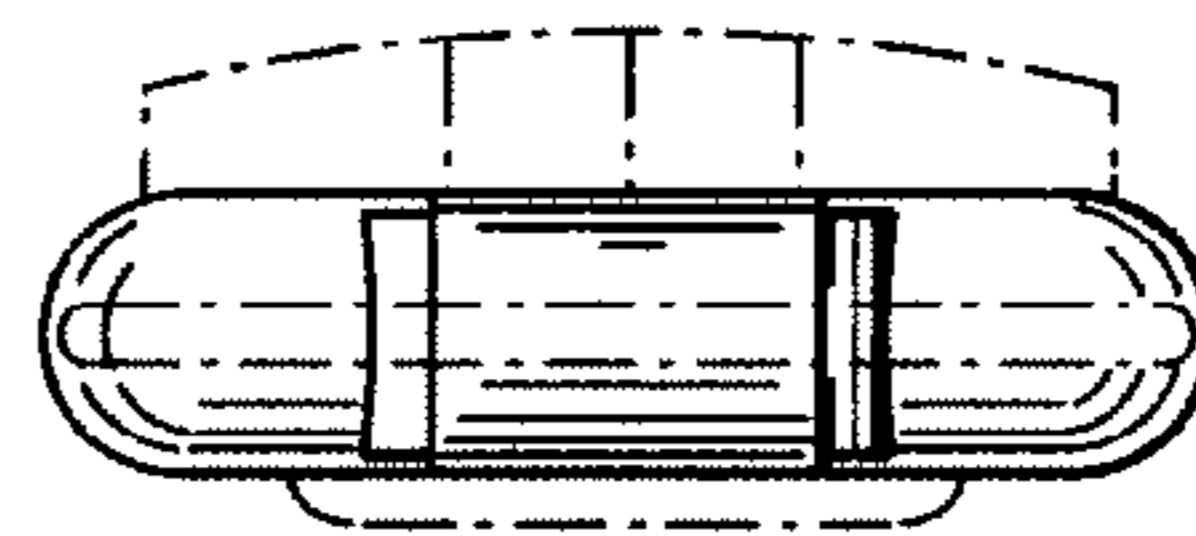

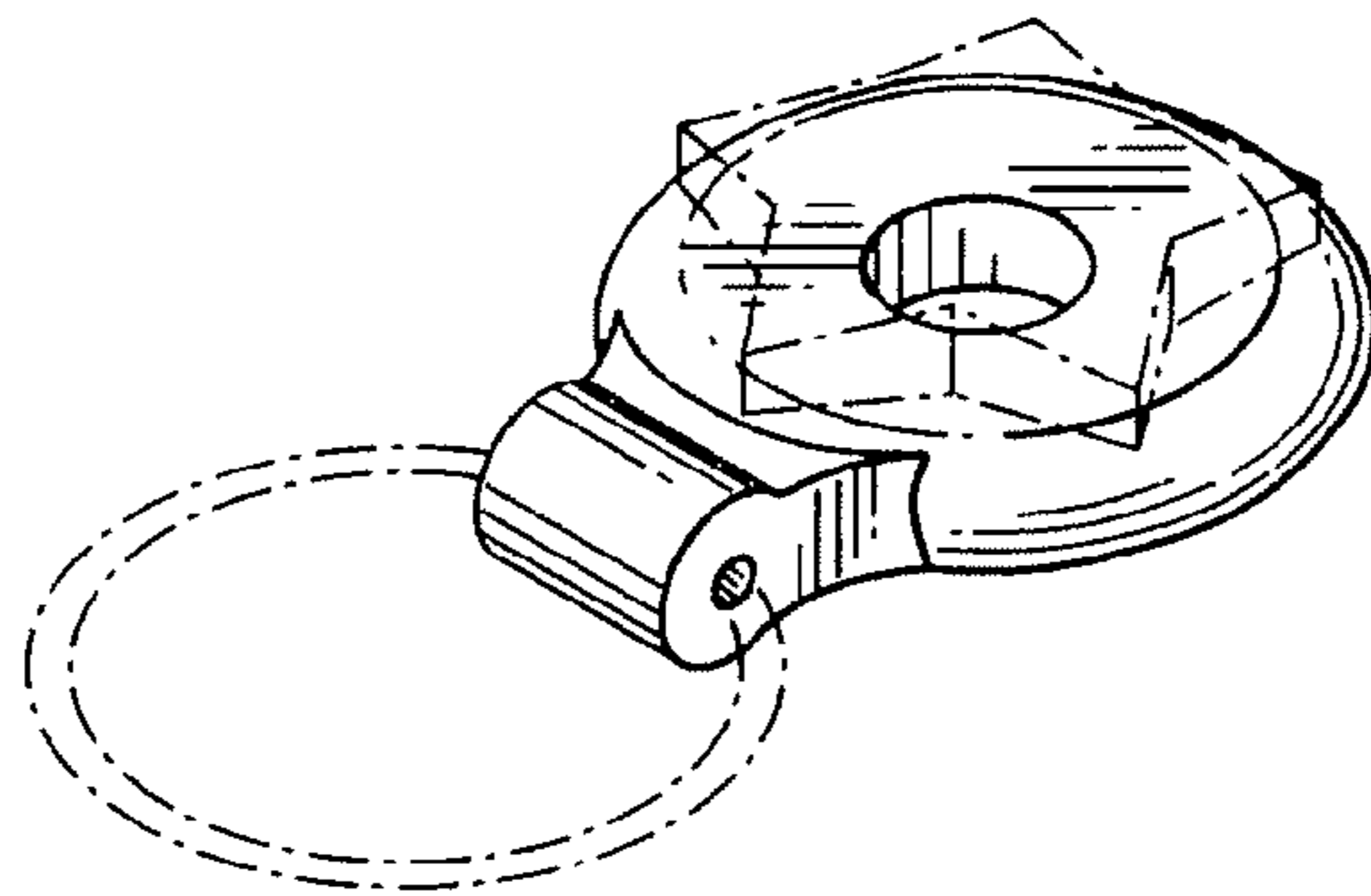

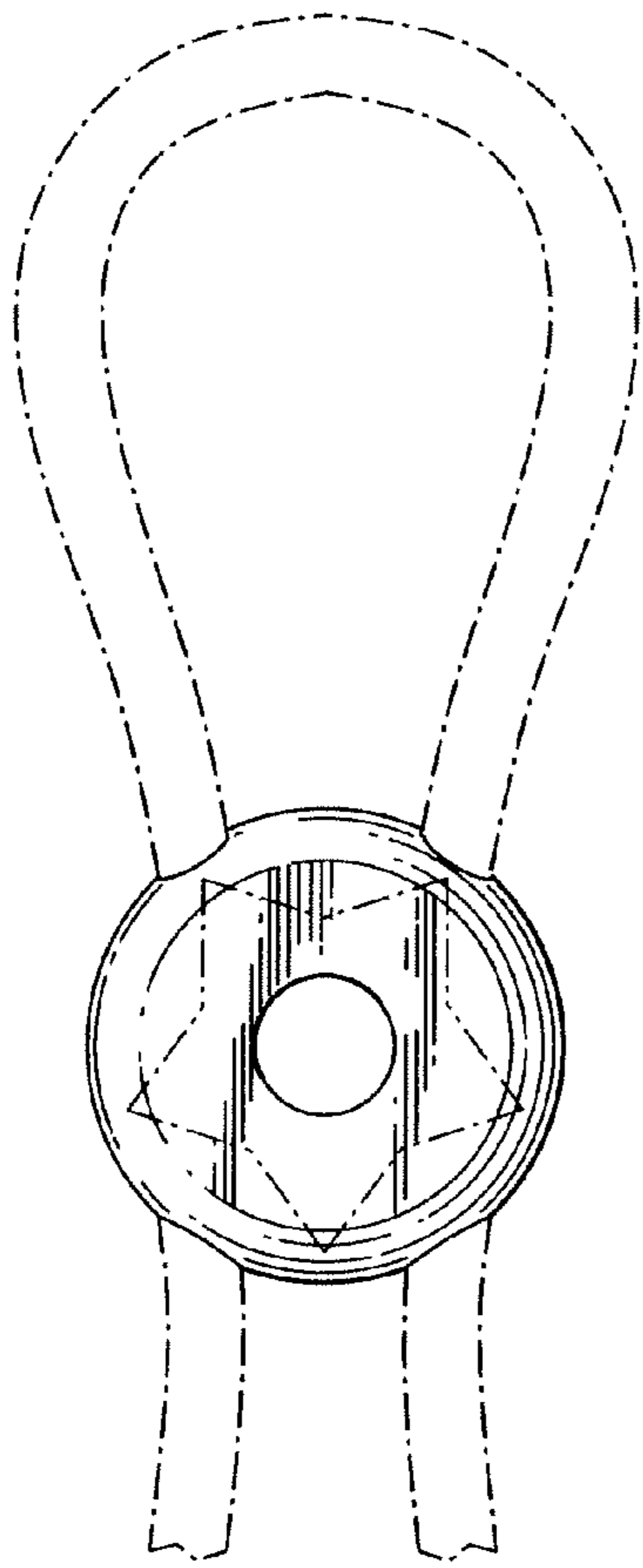

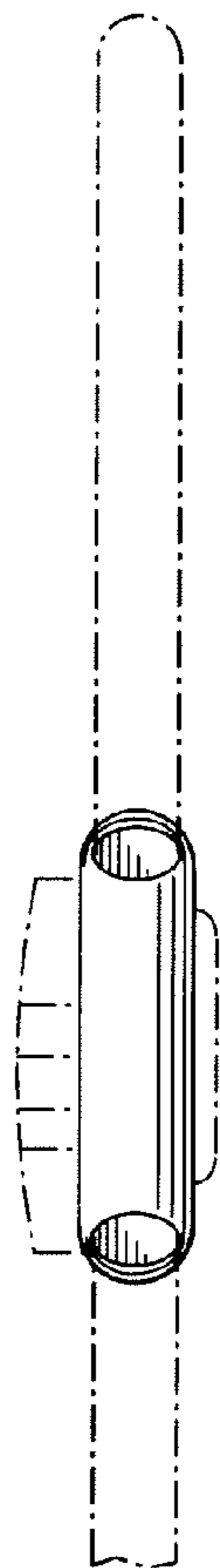

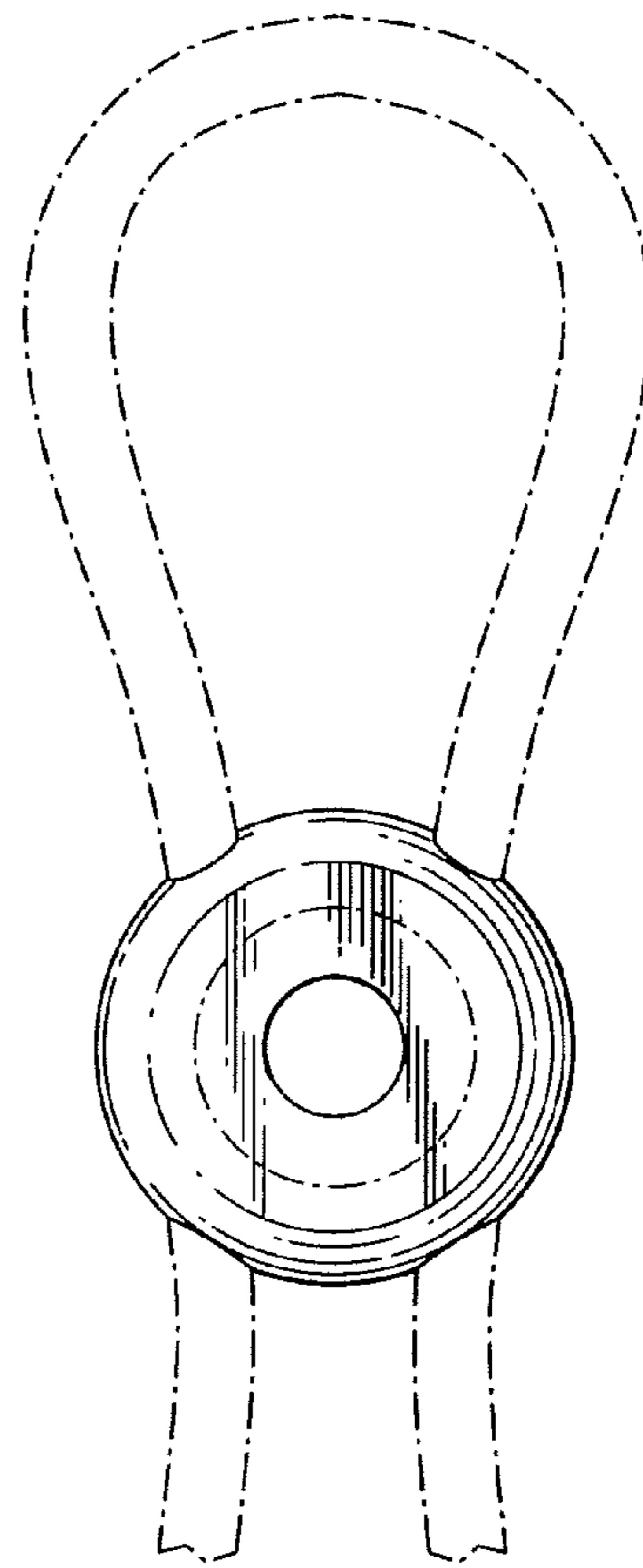

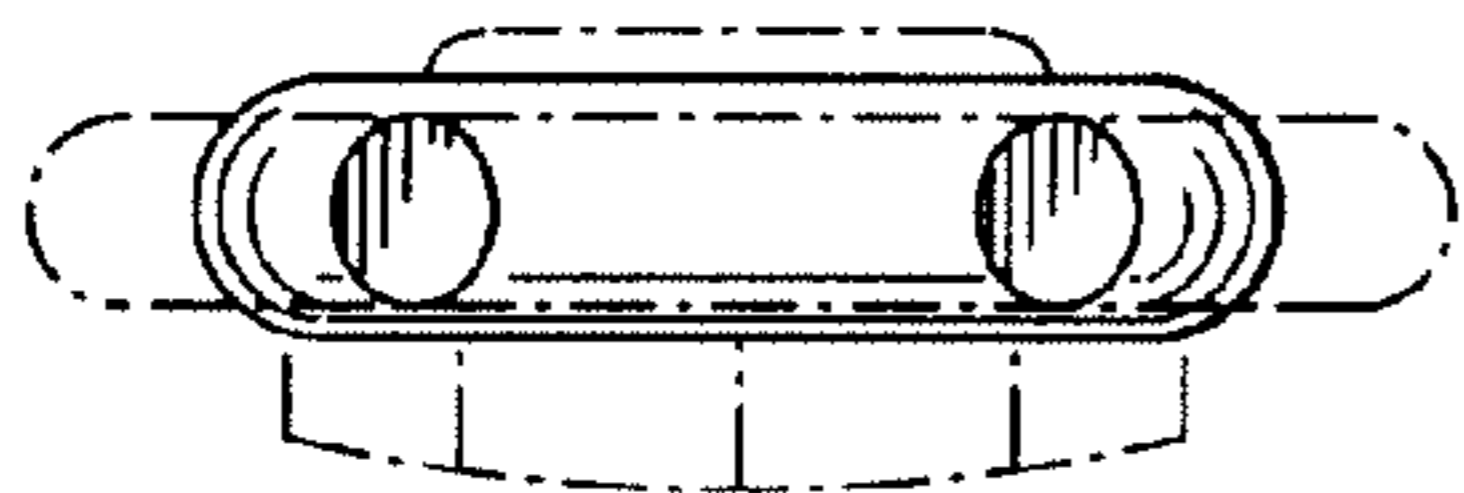

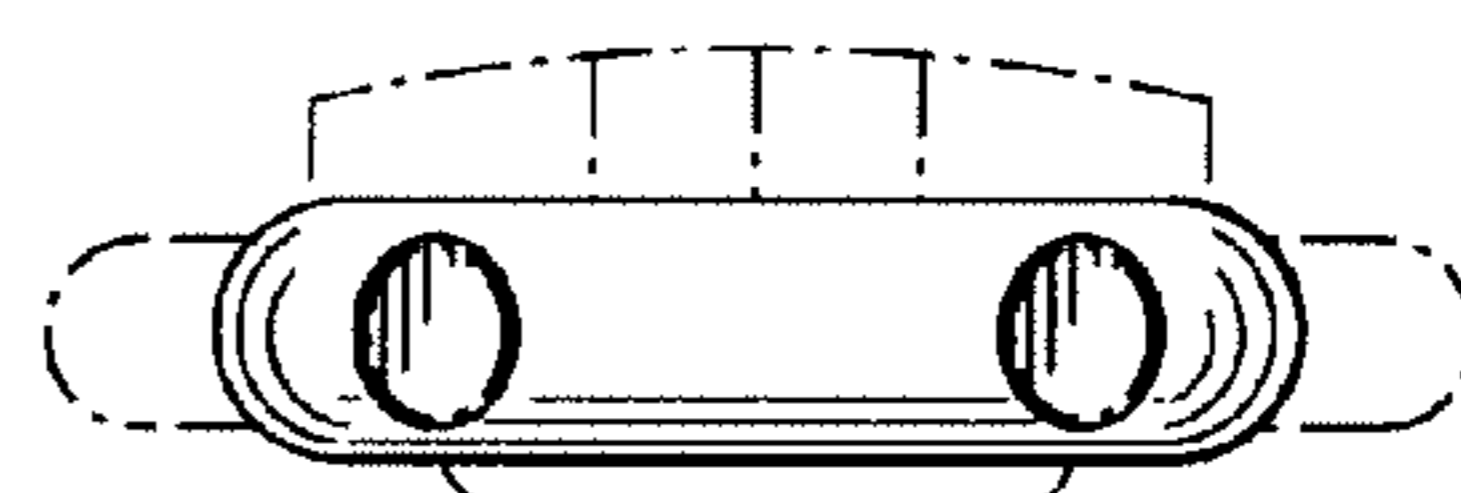

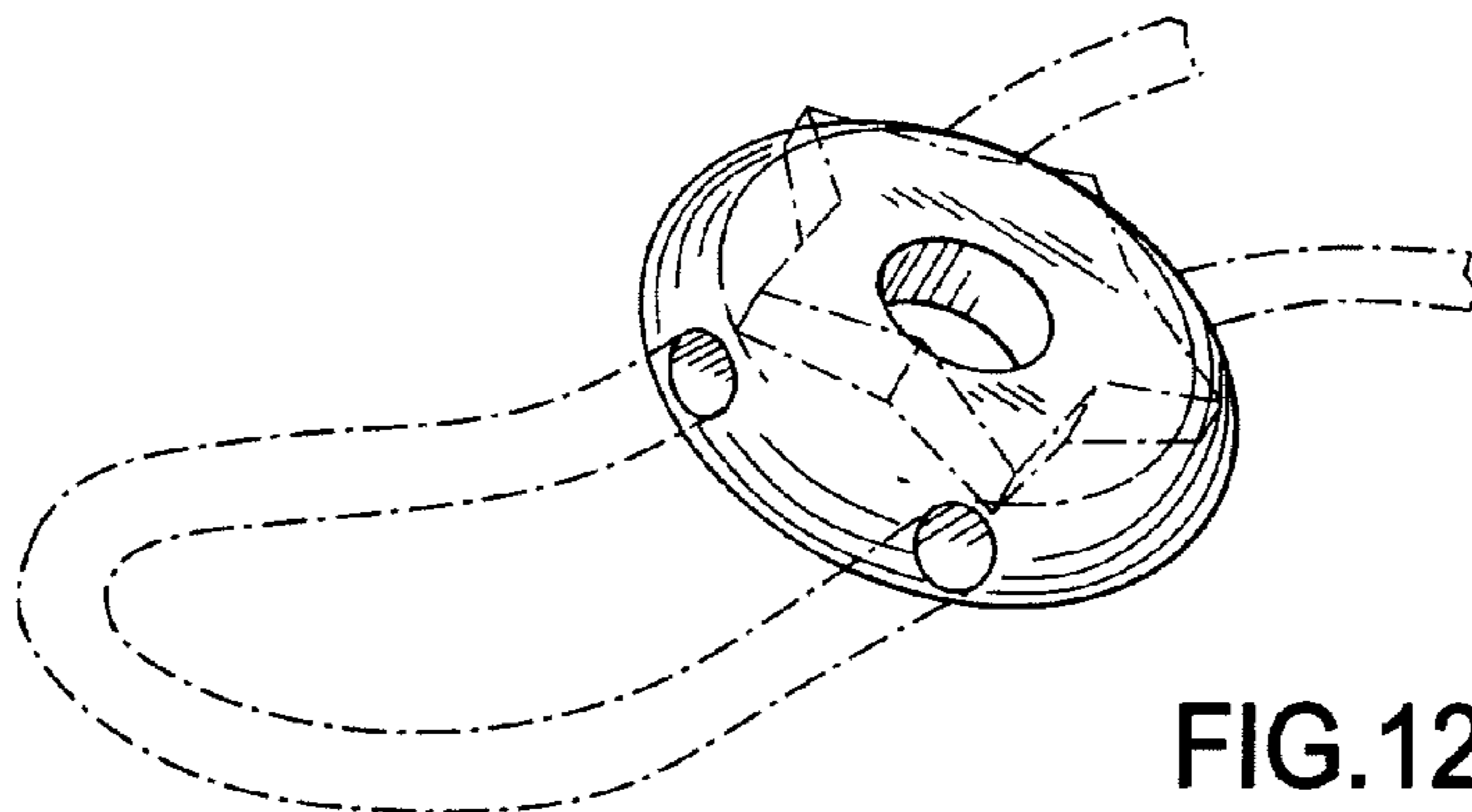

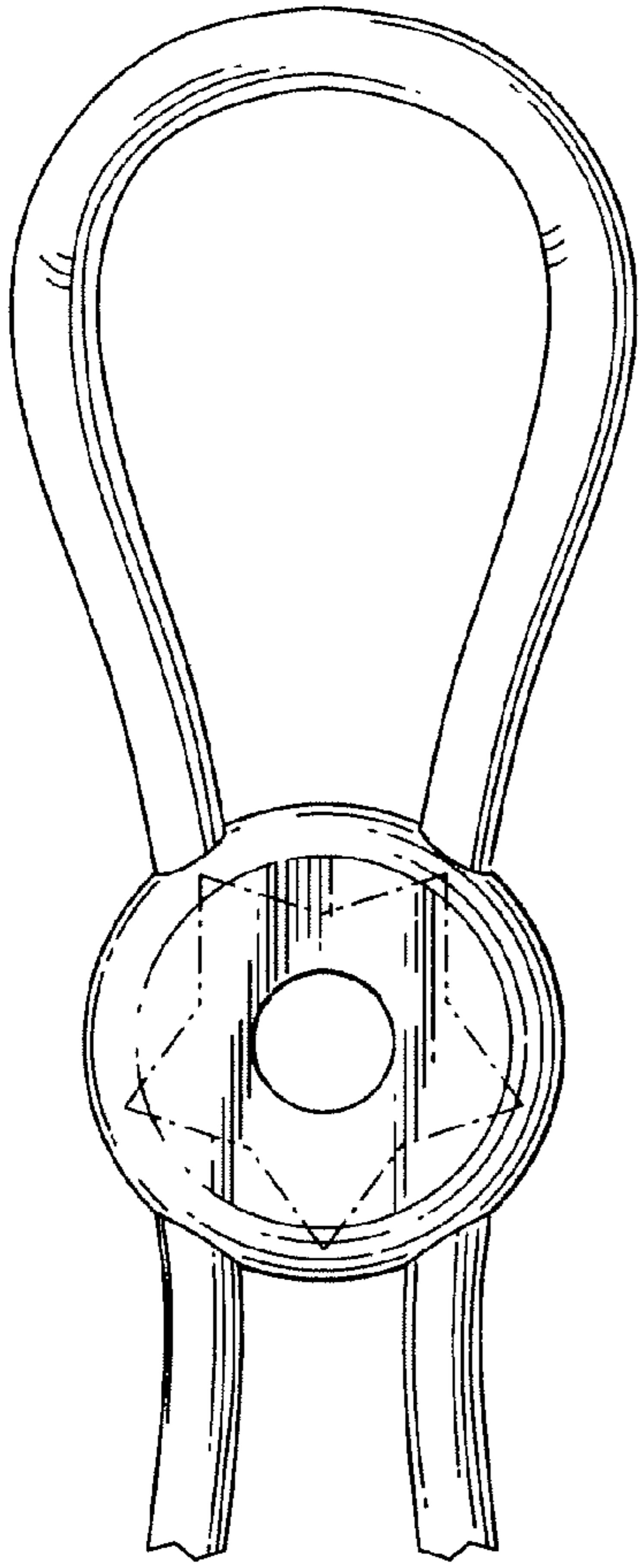

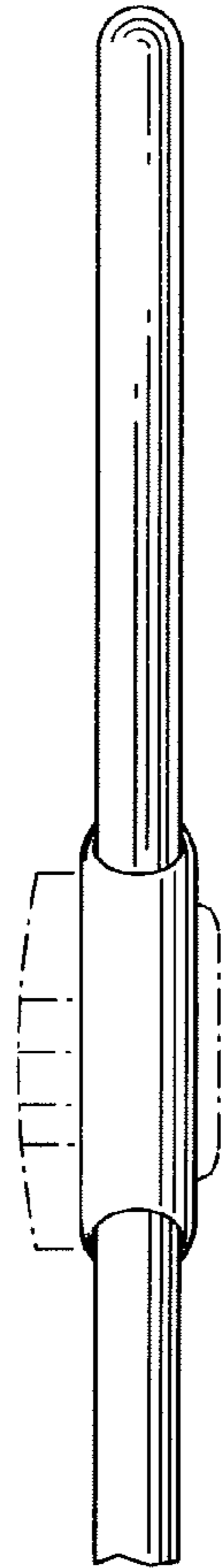

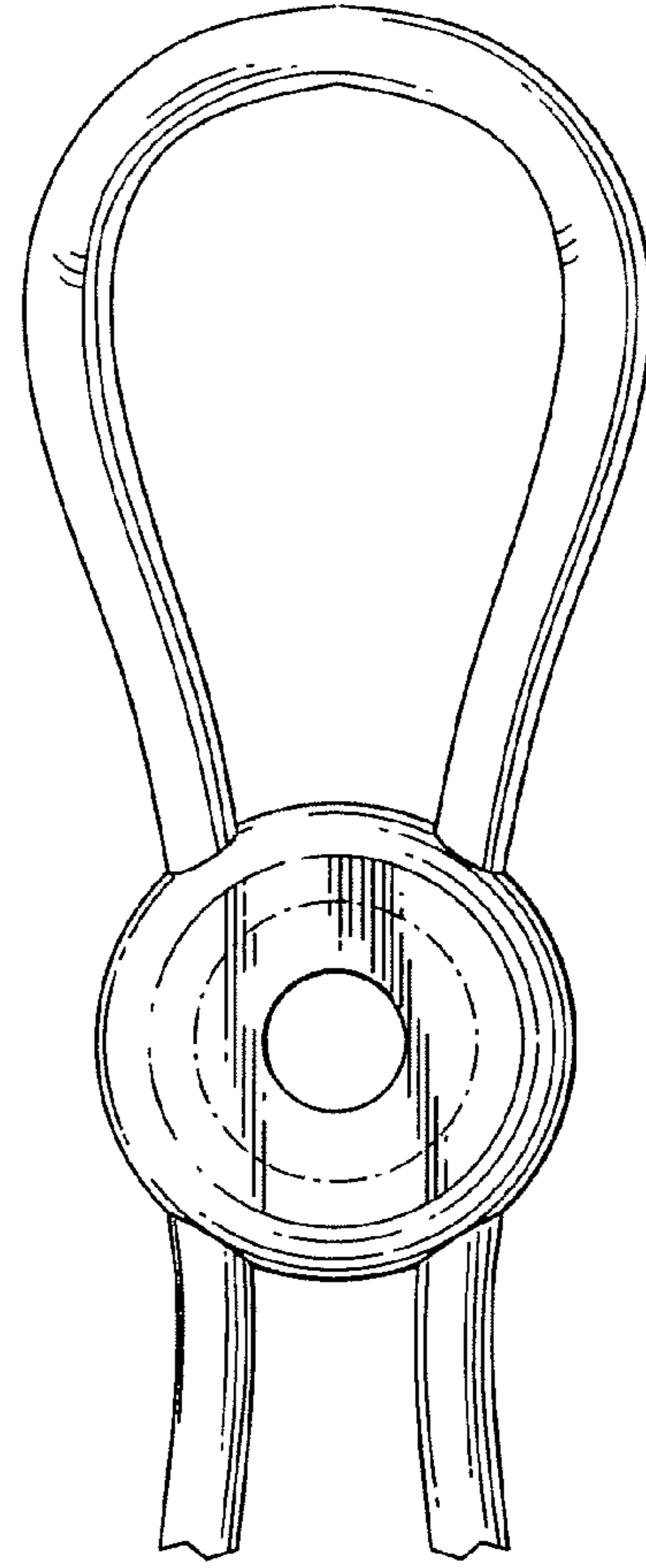

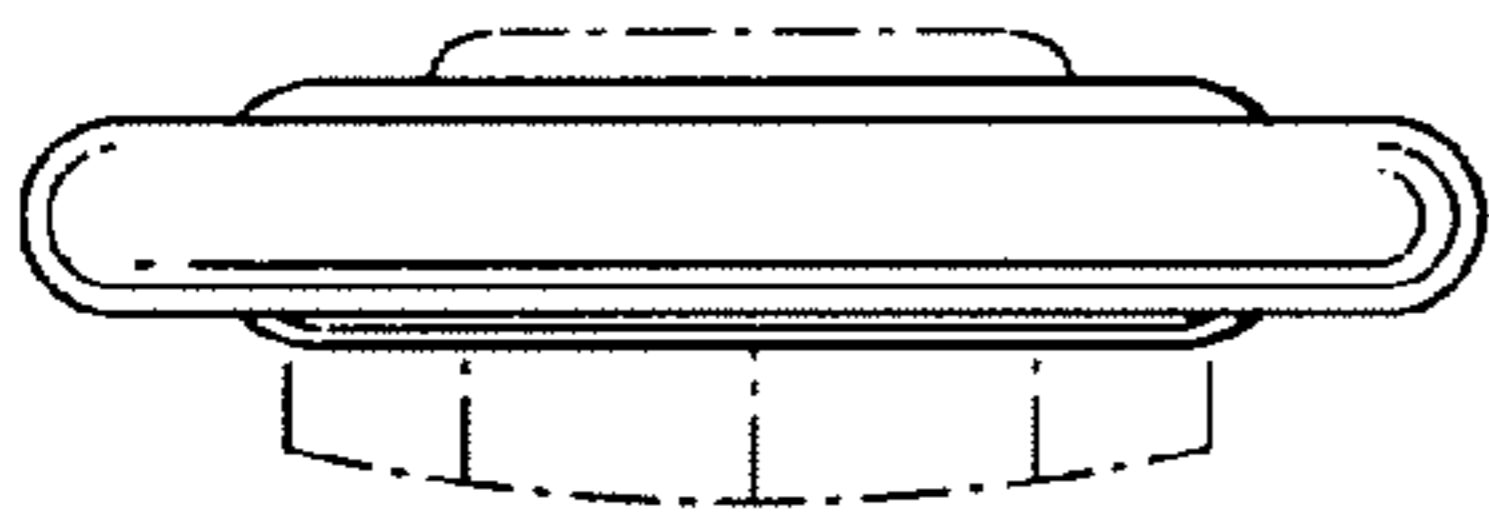

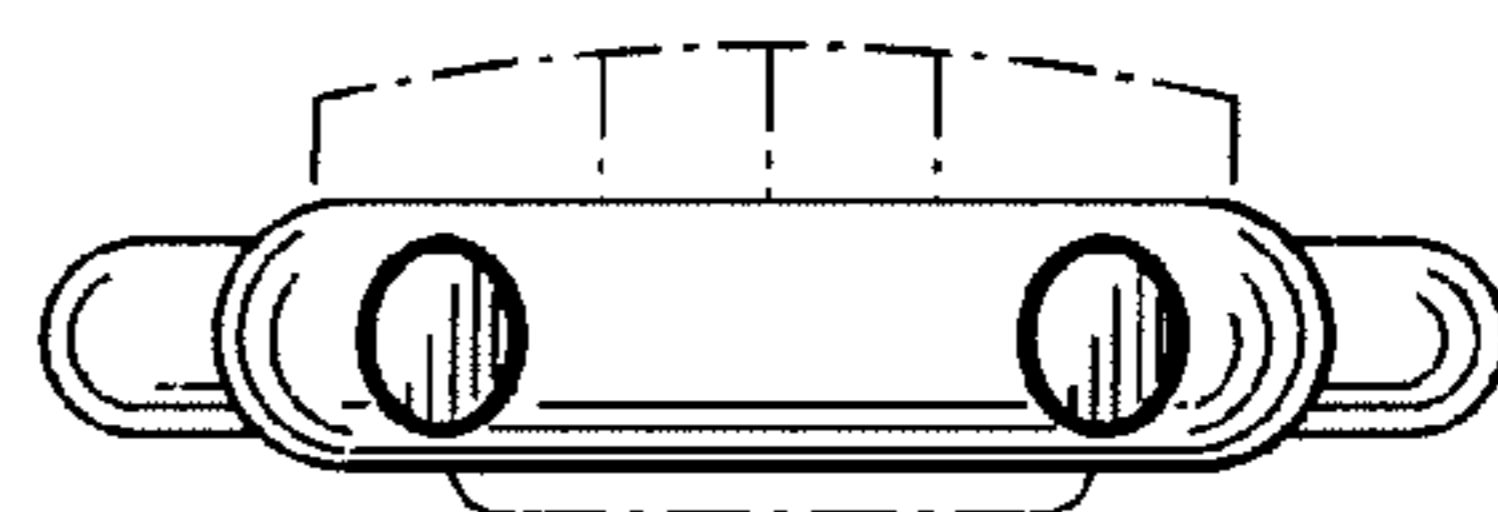

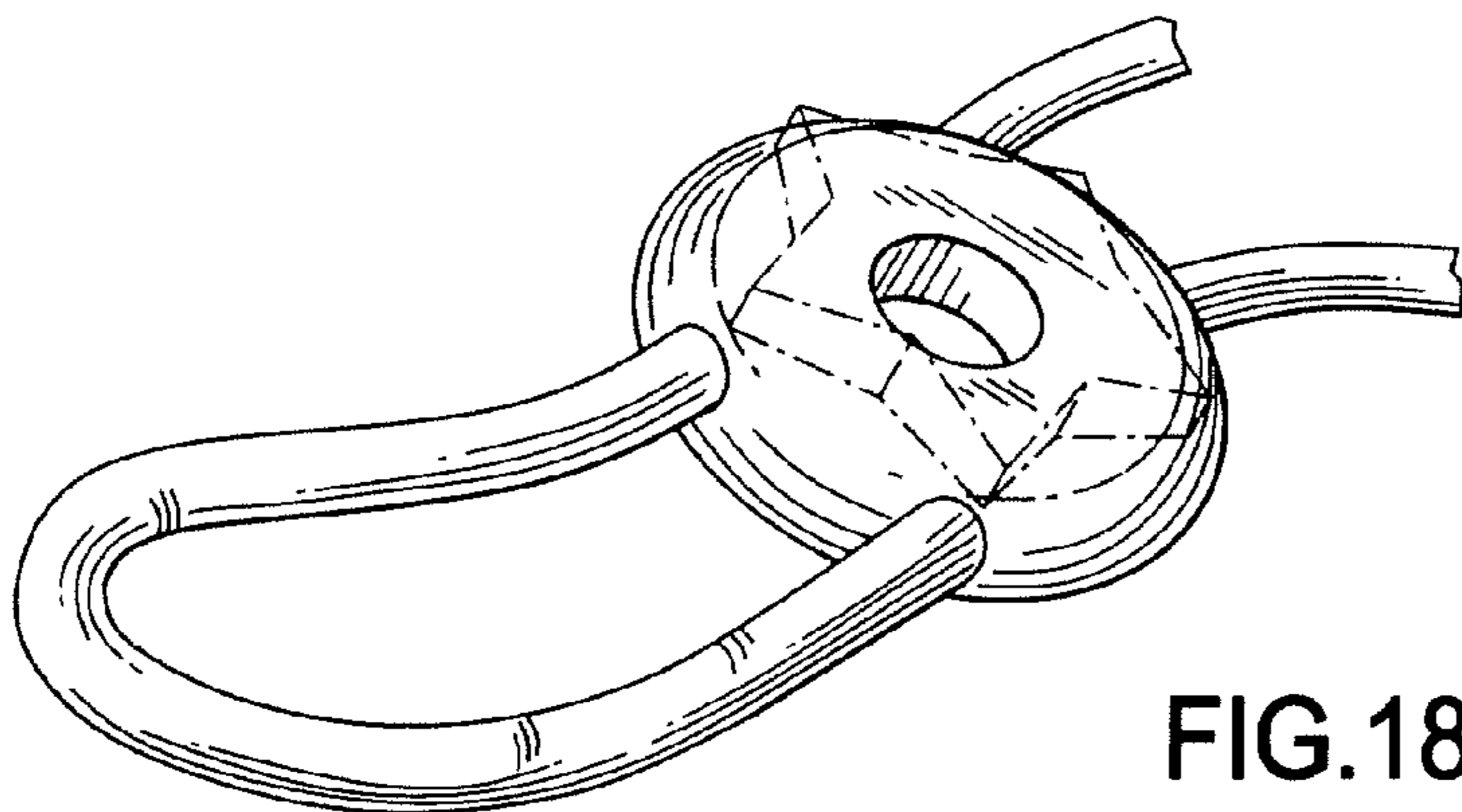
