The ornamental design for a seat for automobile, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the top, front and left side of a seat for automobile showing our new design;

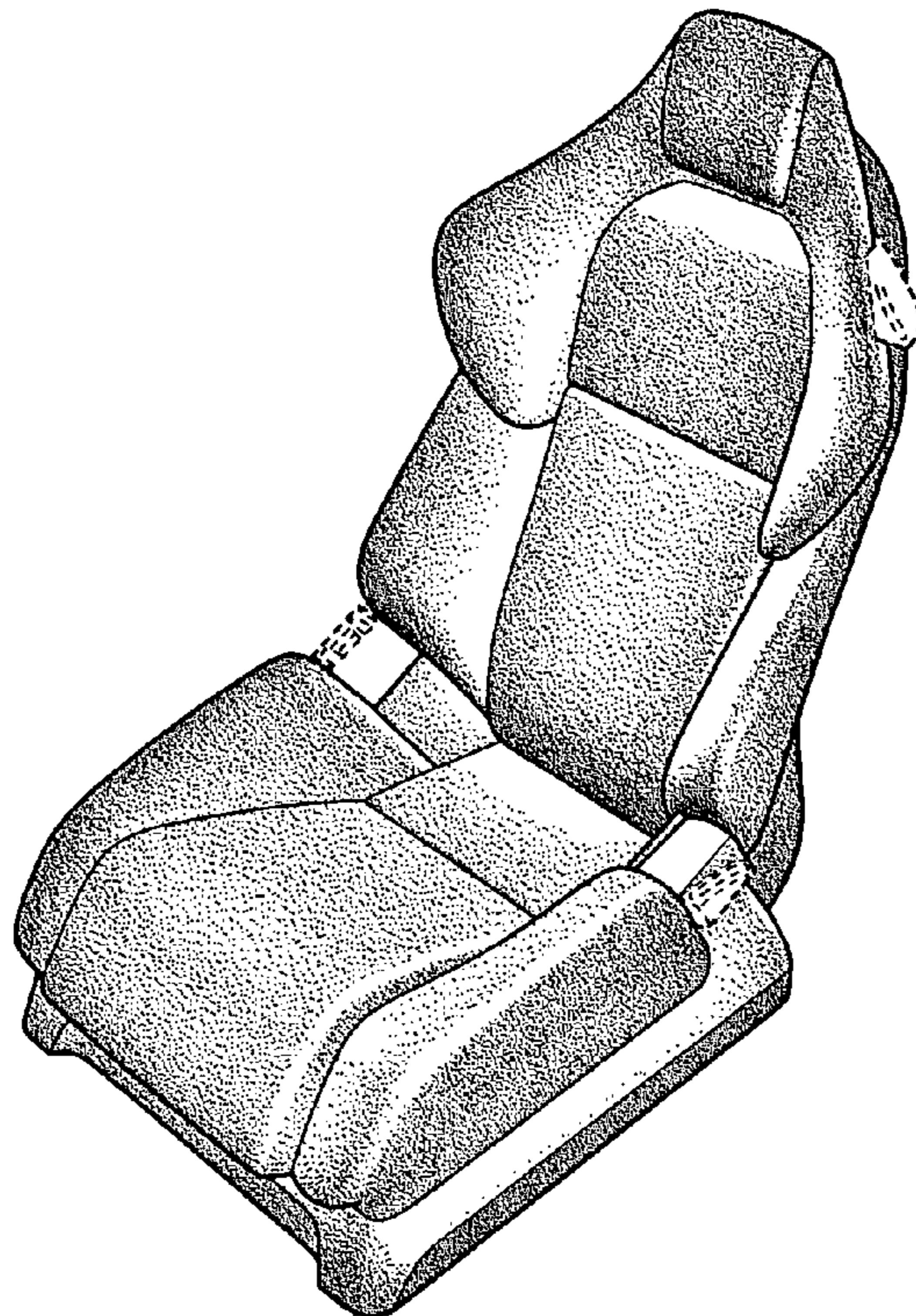

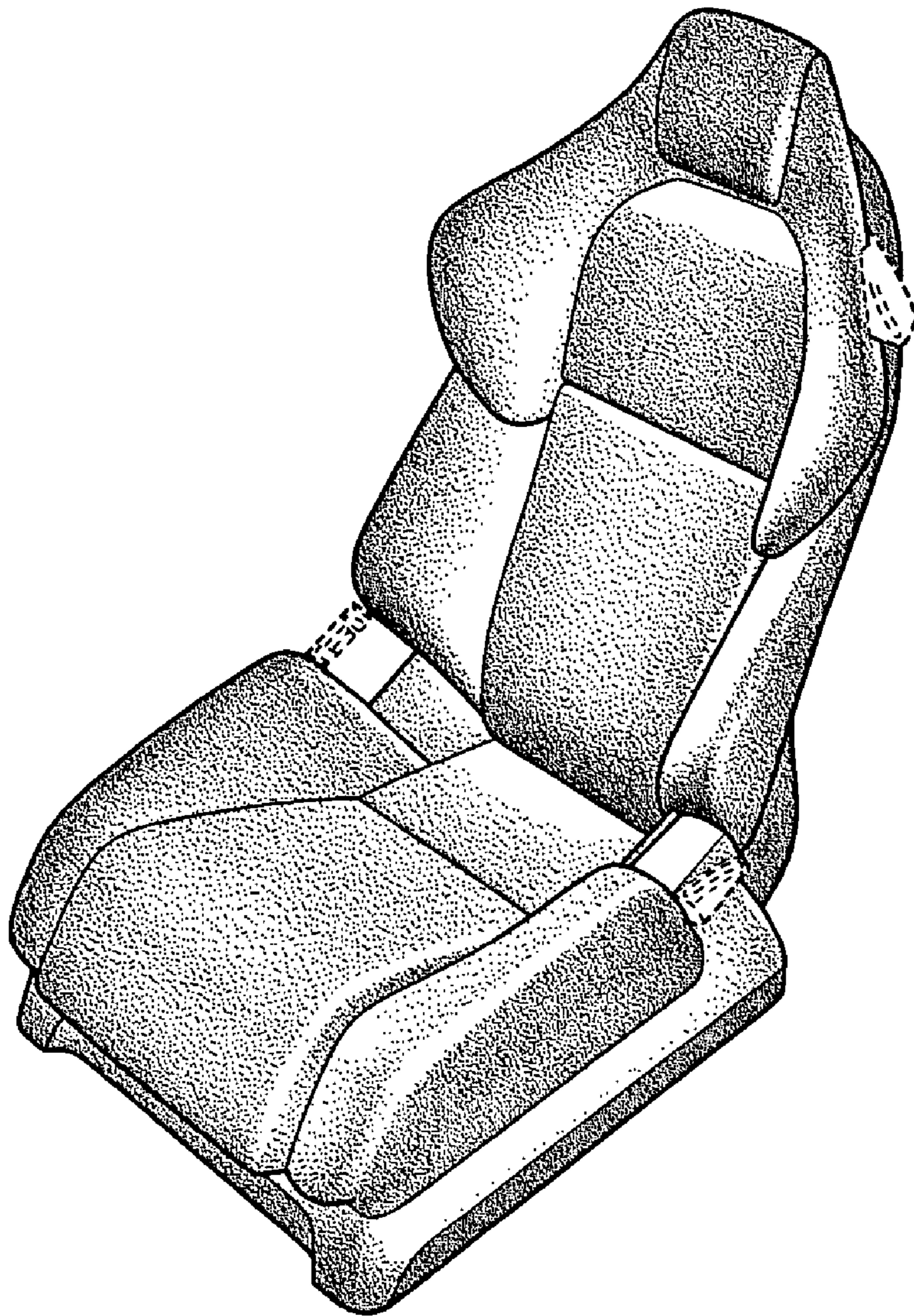

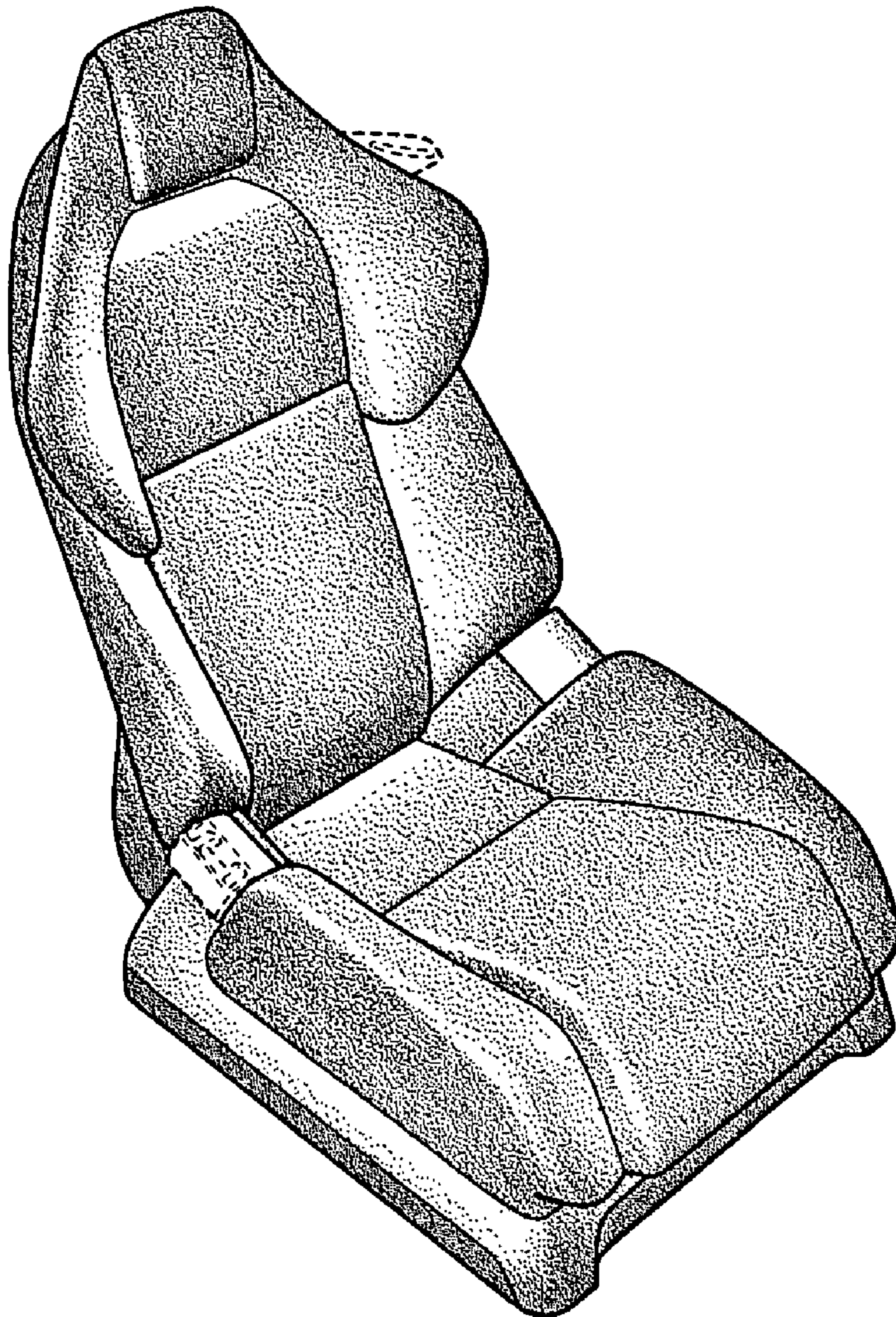

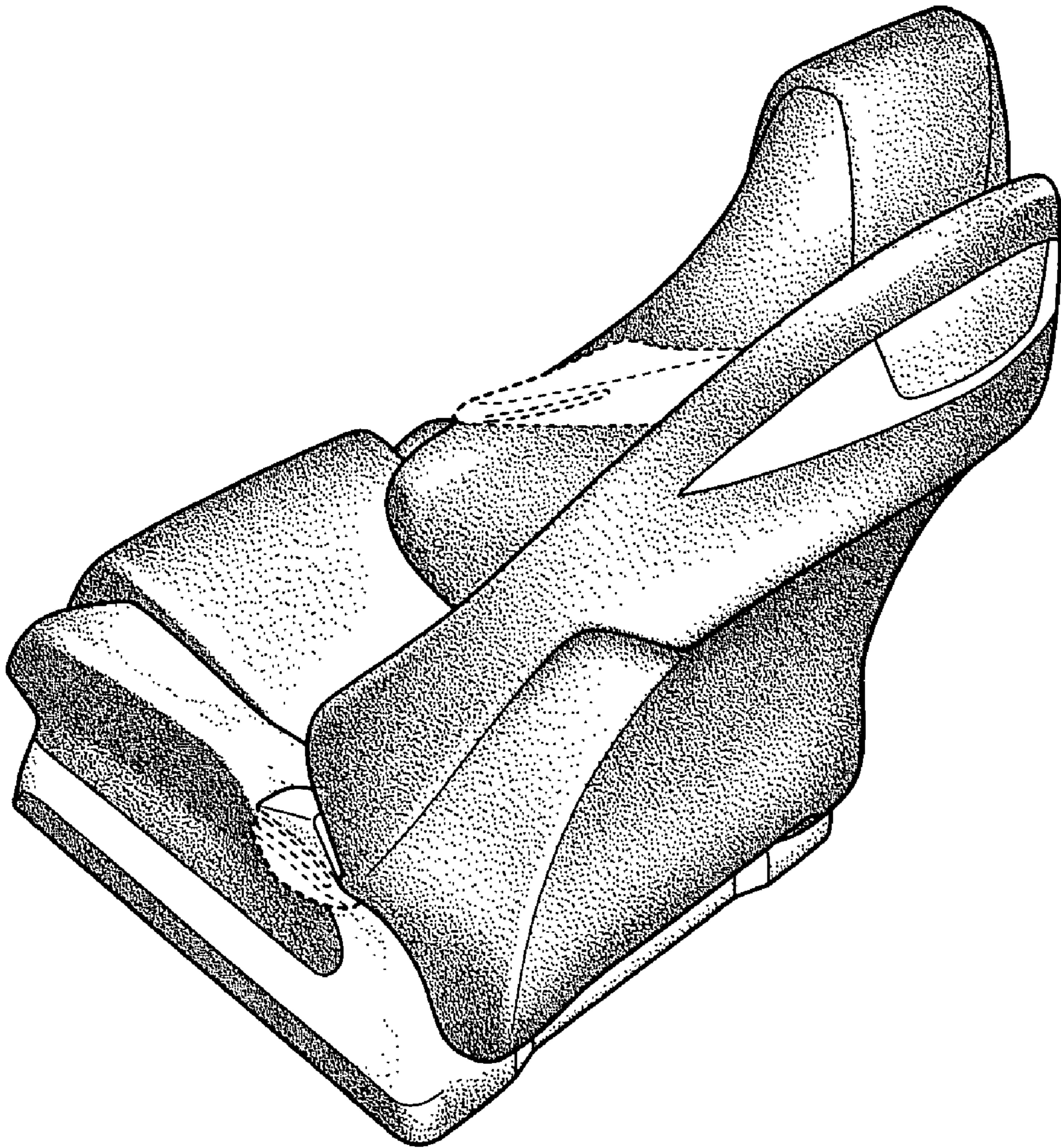

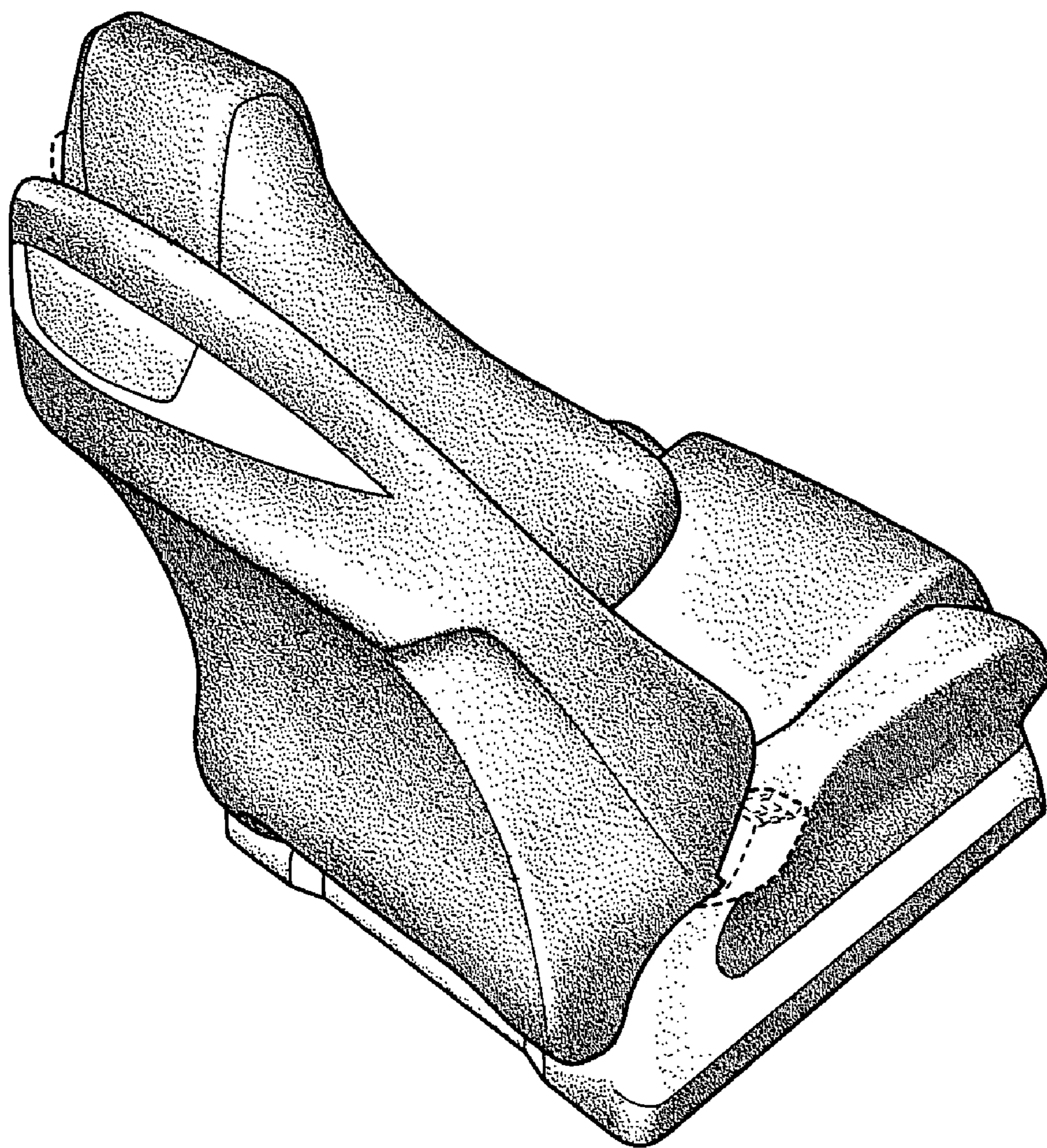

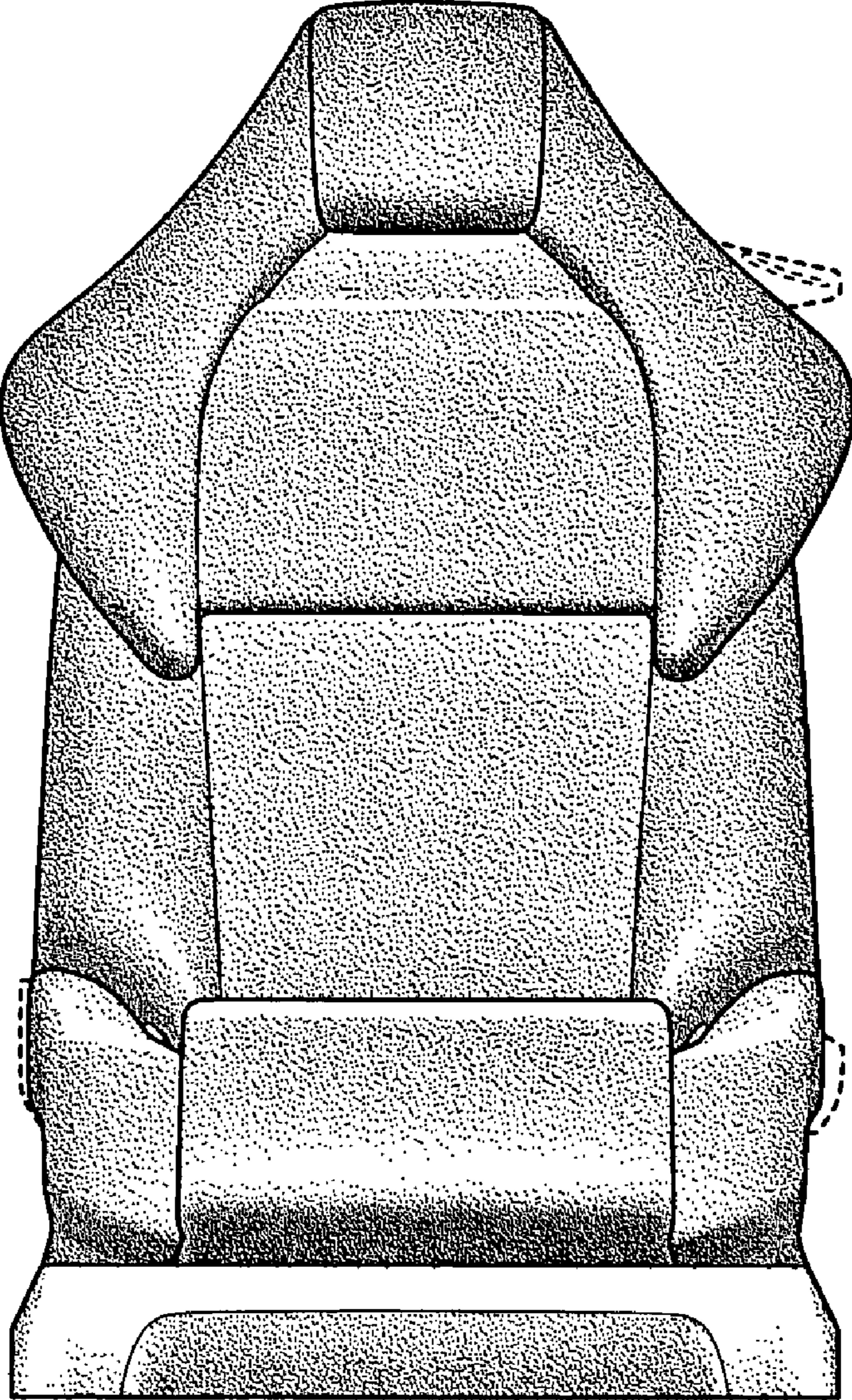

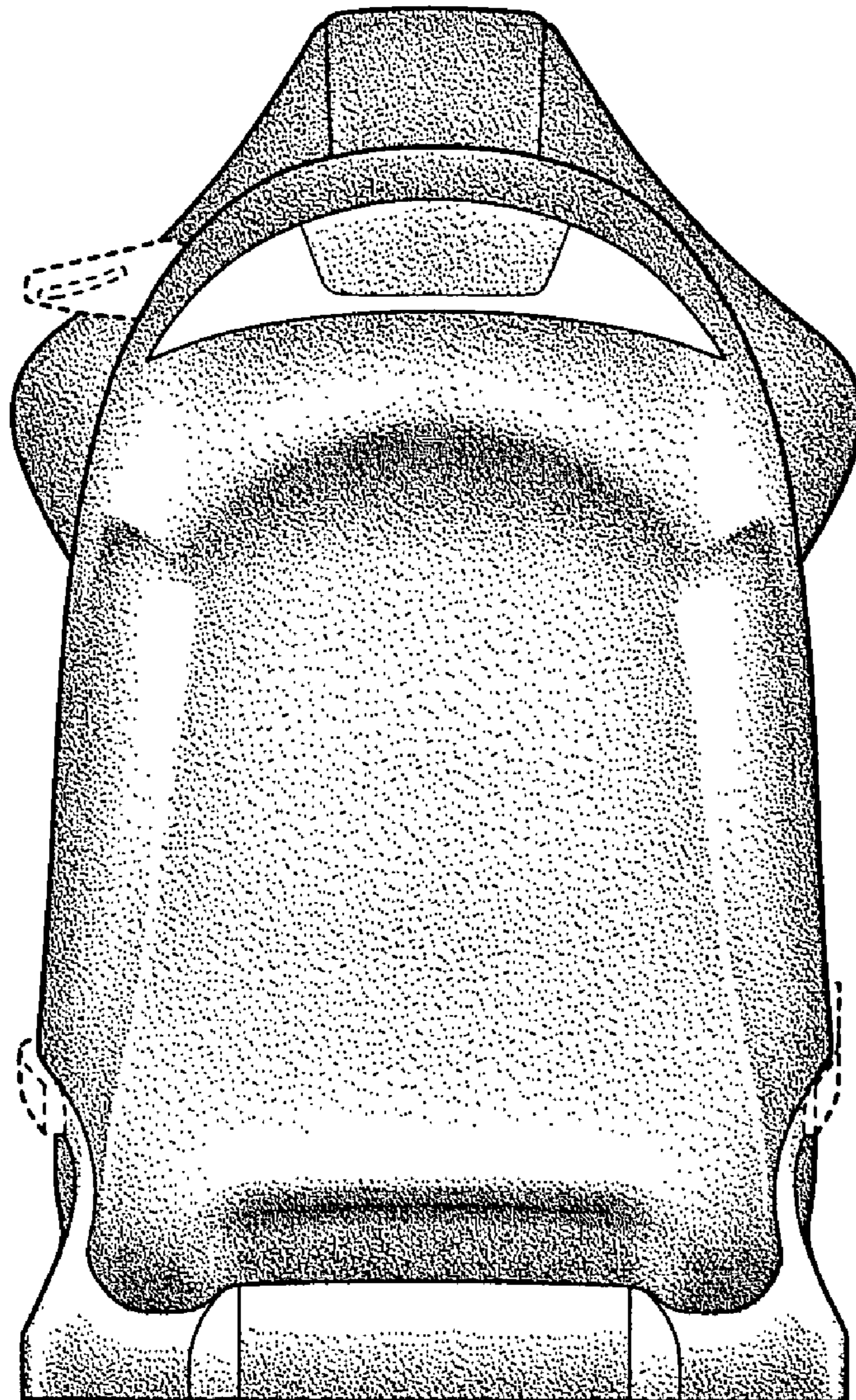

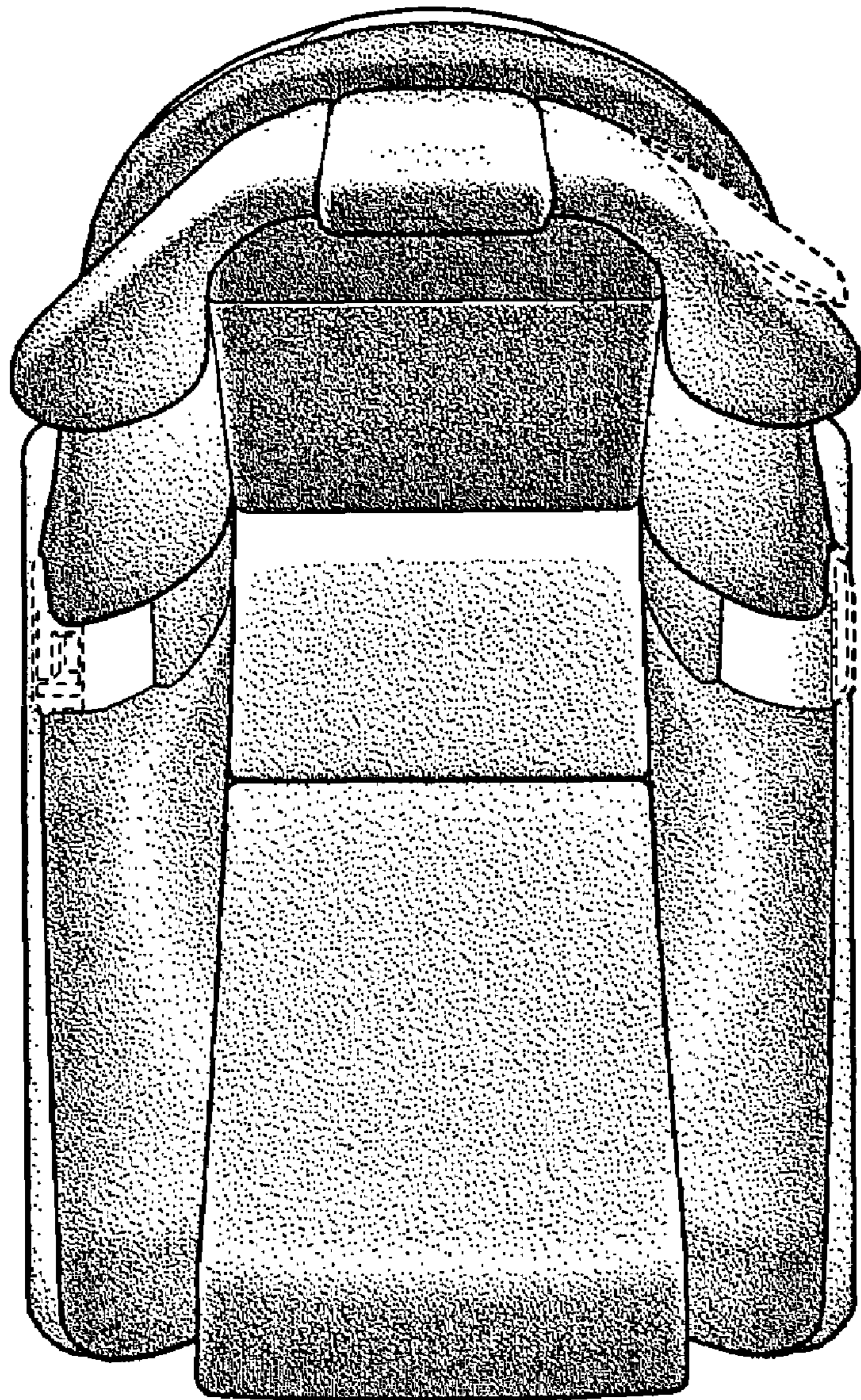

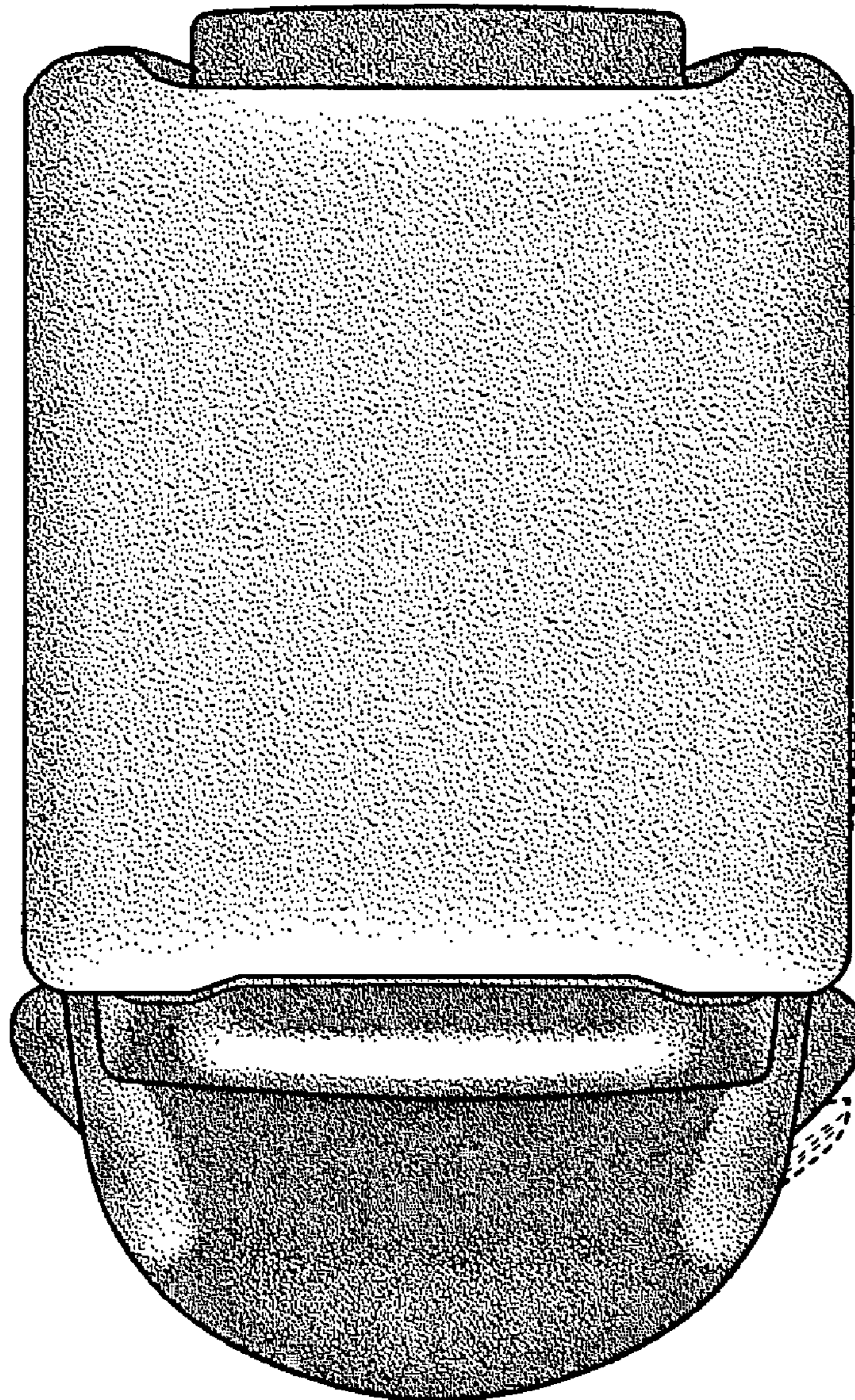

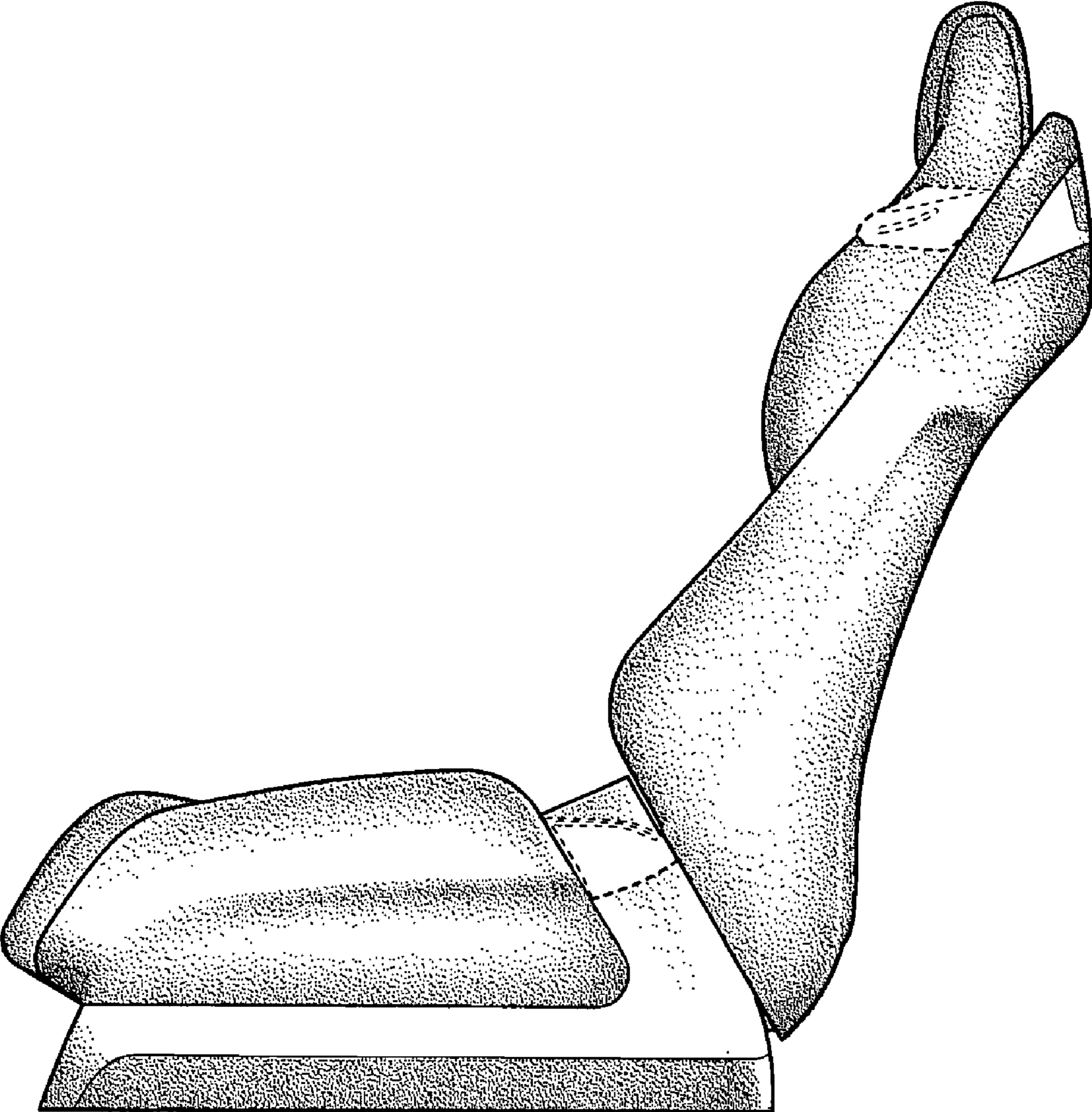
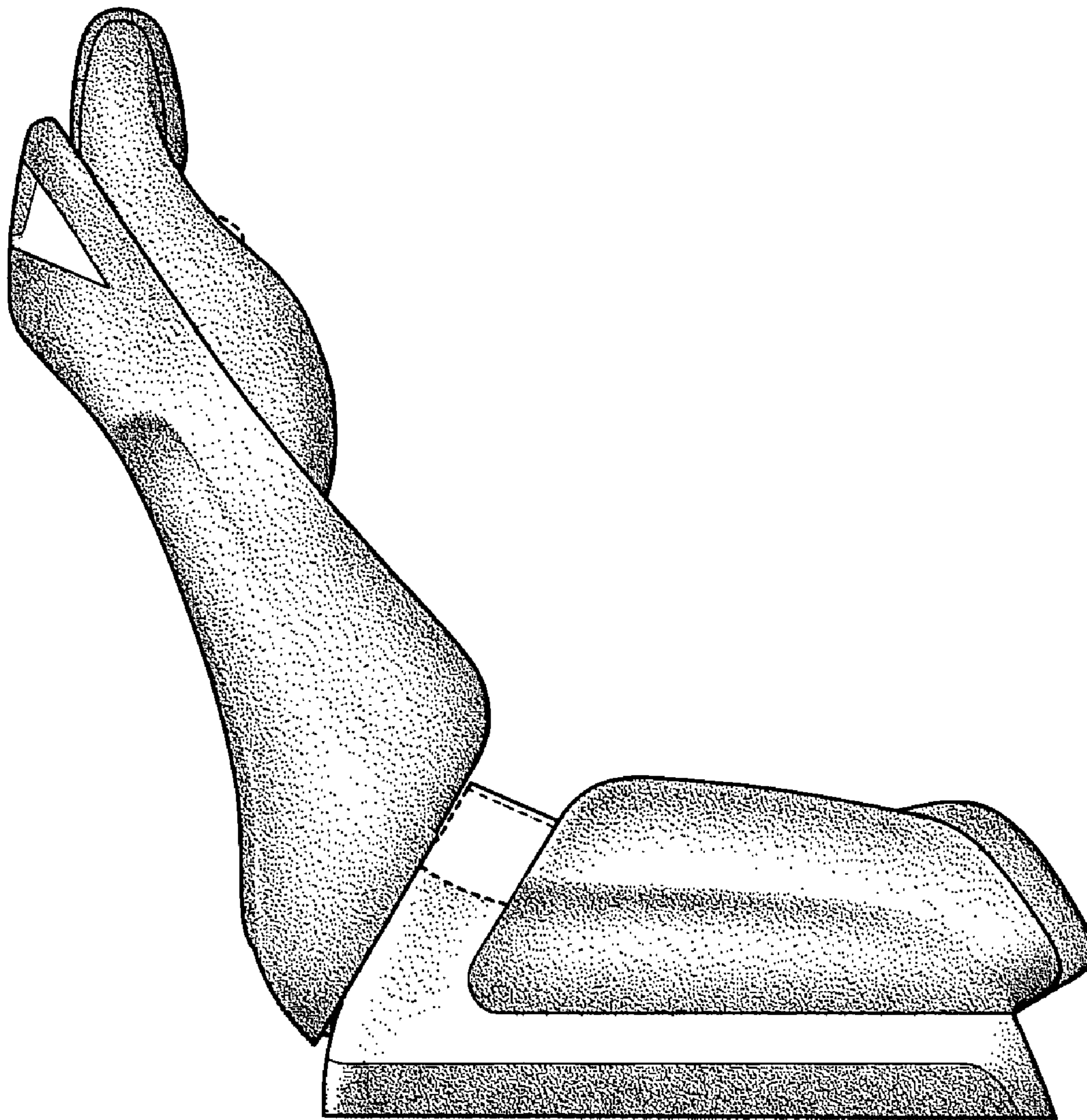
