(57) **CLAIM**

The ornamental design for a free-standing cup holder, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a free-standing cup holder showing my new design.

FIG. 2 is a front elevational view thereof.

FIG. 3 is a side elevational view thereof.

FIG. 4 is a back elevational view thereof.

FIG. 5 is a side elevational view thereof taken from the opposite side to that of FIG. 3.

FIG. 6 is a top view thereof.

FIG. 7 is a bottom view thereof.

FIG. 8 is a perspective view of a second embodiment of a second embodiment of a free-standing cup holder according to the present invention.

FIG. 9 is a side elevational view thereof.

FIG. 10 is a front elevational view thereof.

FIG. 11 is a back elevational view thereof.

FIG. 12 is a side elevational view thereof taken from the opposite side to that of FIG. 9.

FIG. 13 is a top view thereof; and,

FIG. 14 is a bottom view thereof.

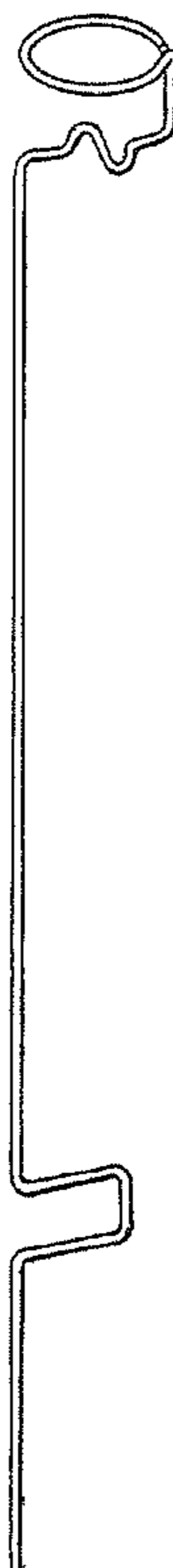

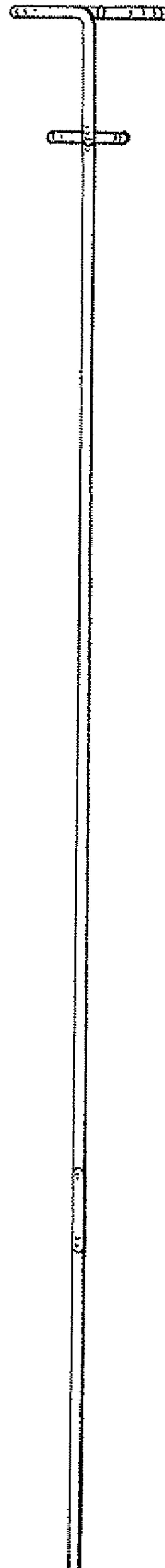

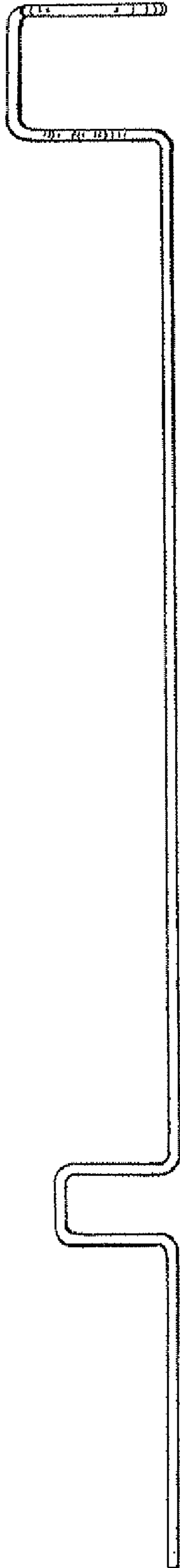

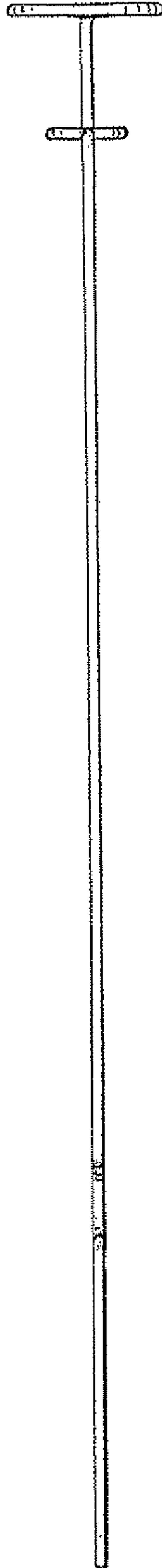

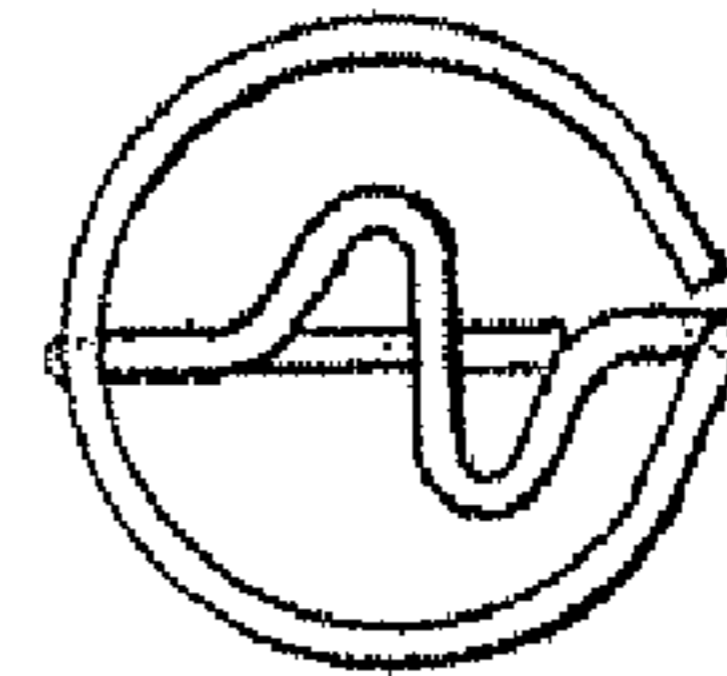
