DESCRIPTION

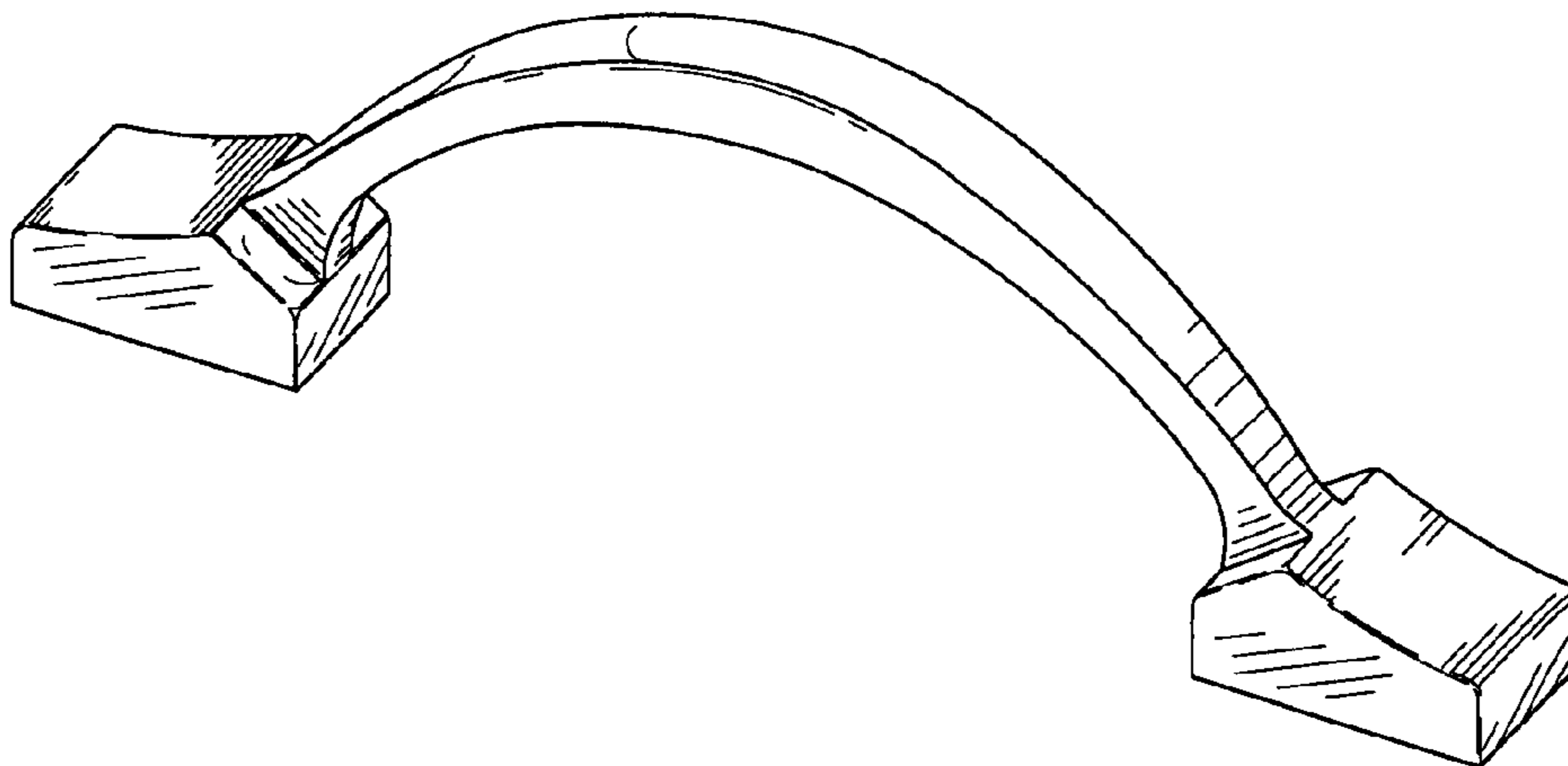
FIG. 1 is a front side perspective view of a pull showing my new design;

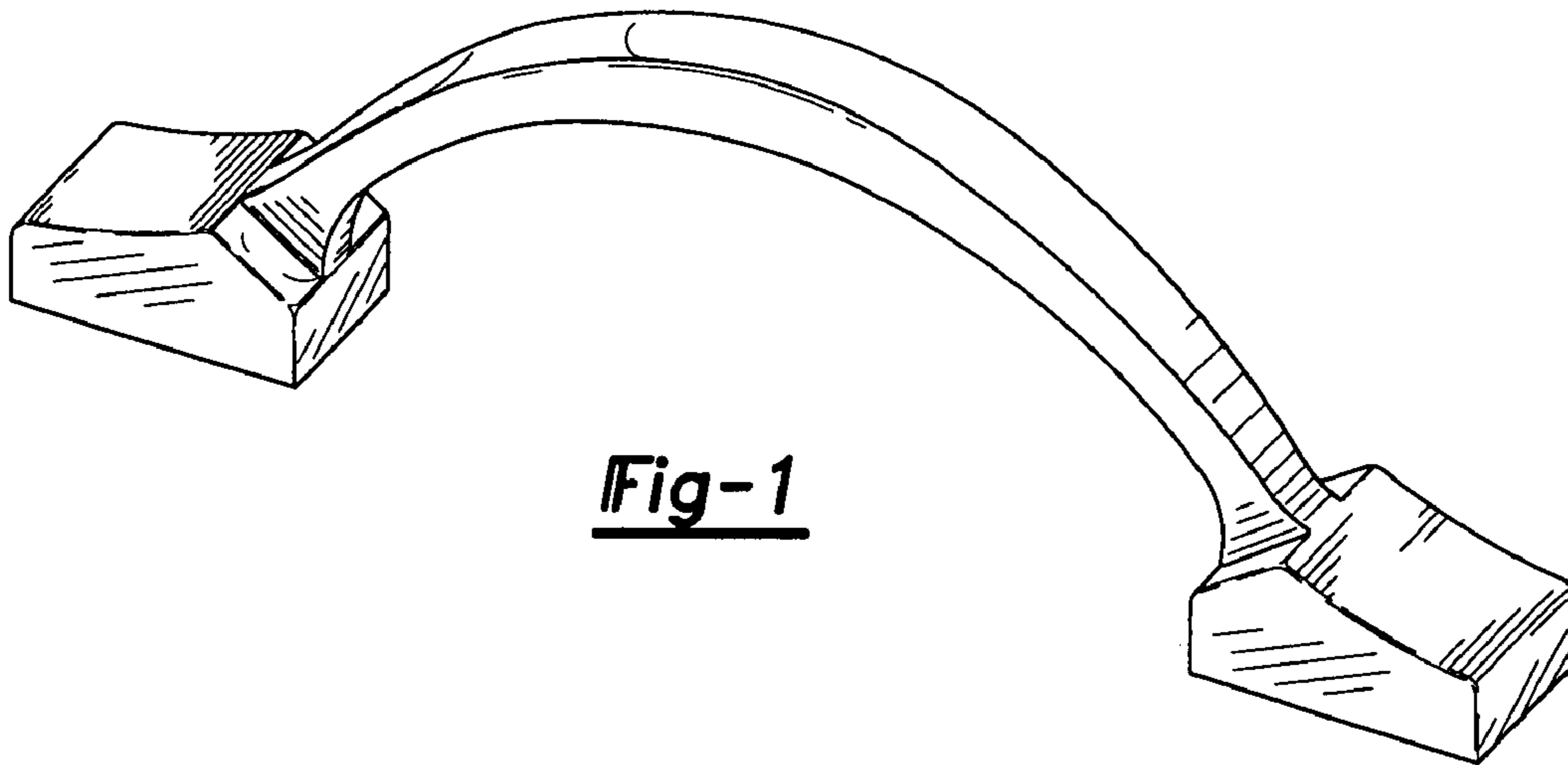

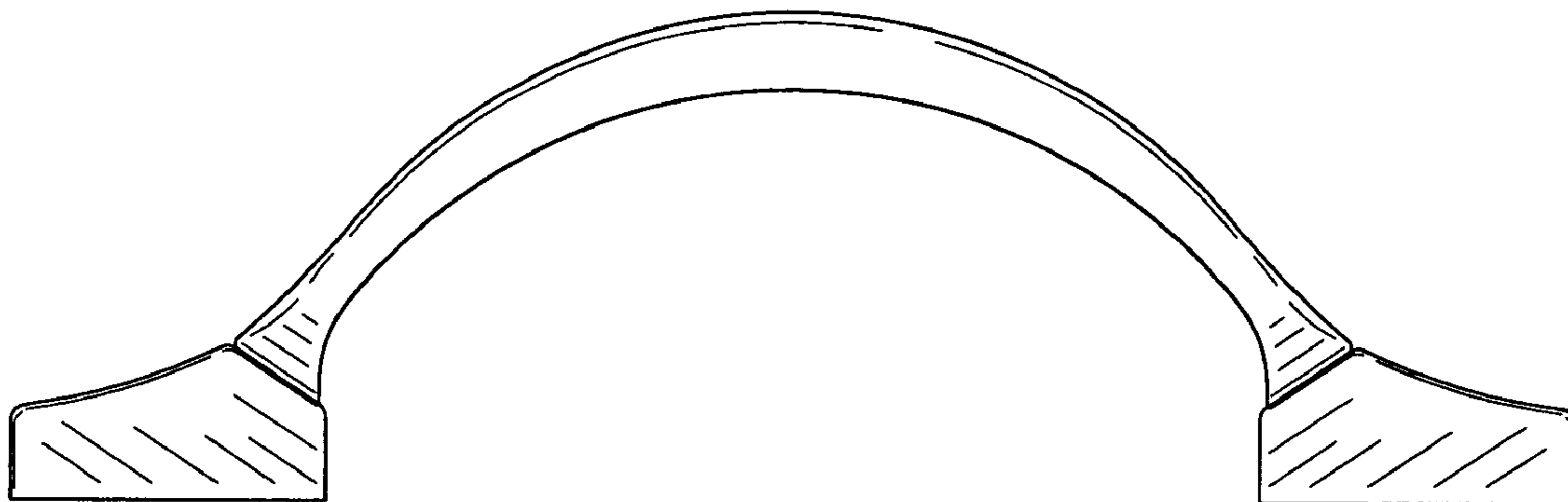

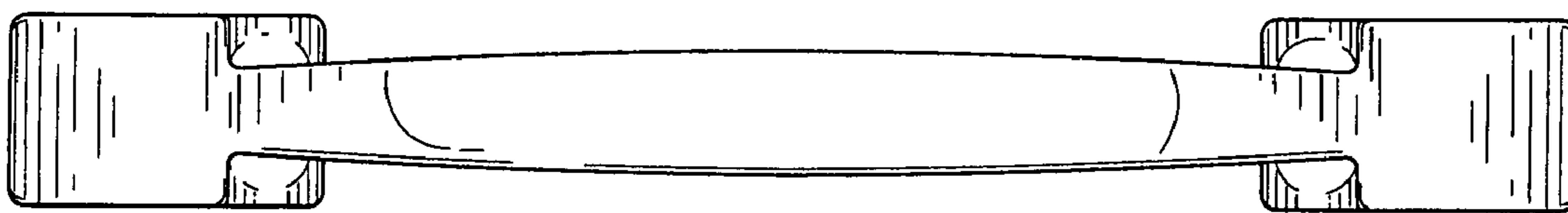

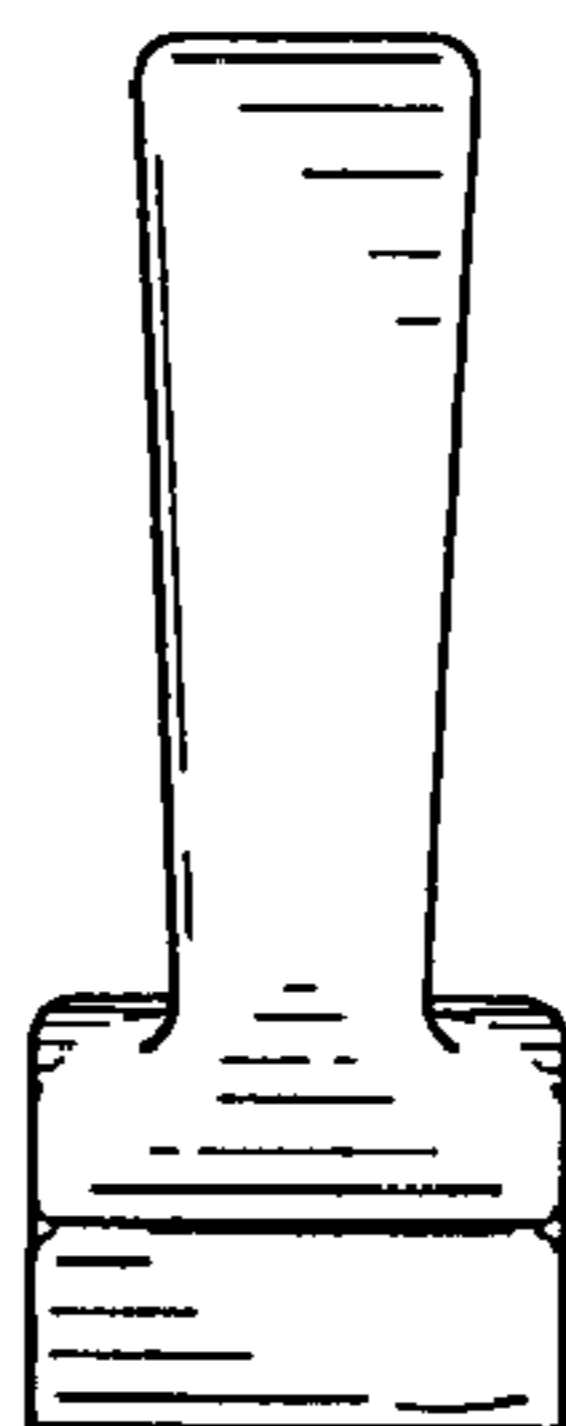
