**DESCRIPTION**

FIG. 2 is a front elevation view thereof;

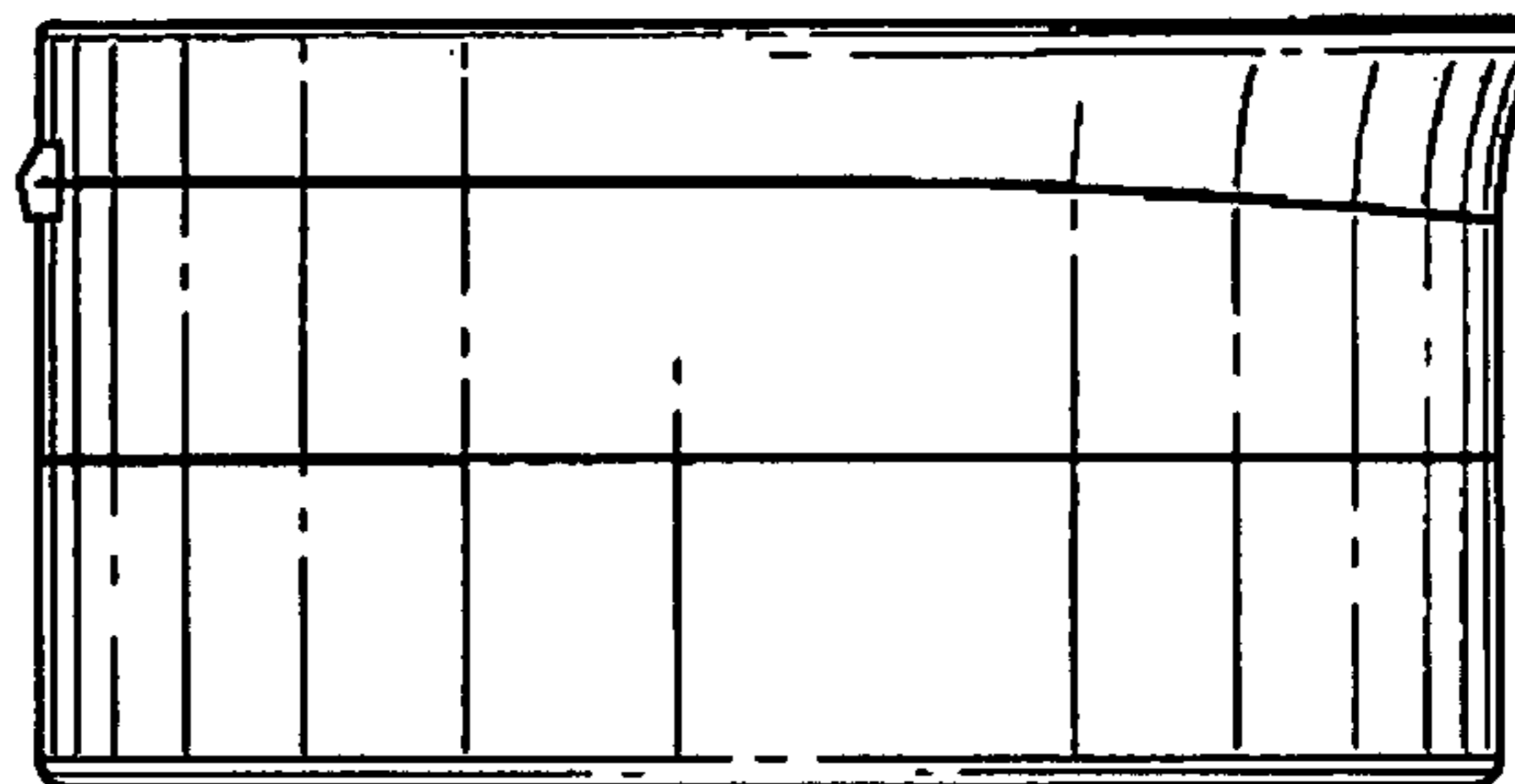
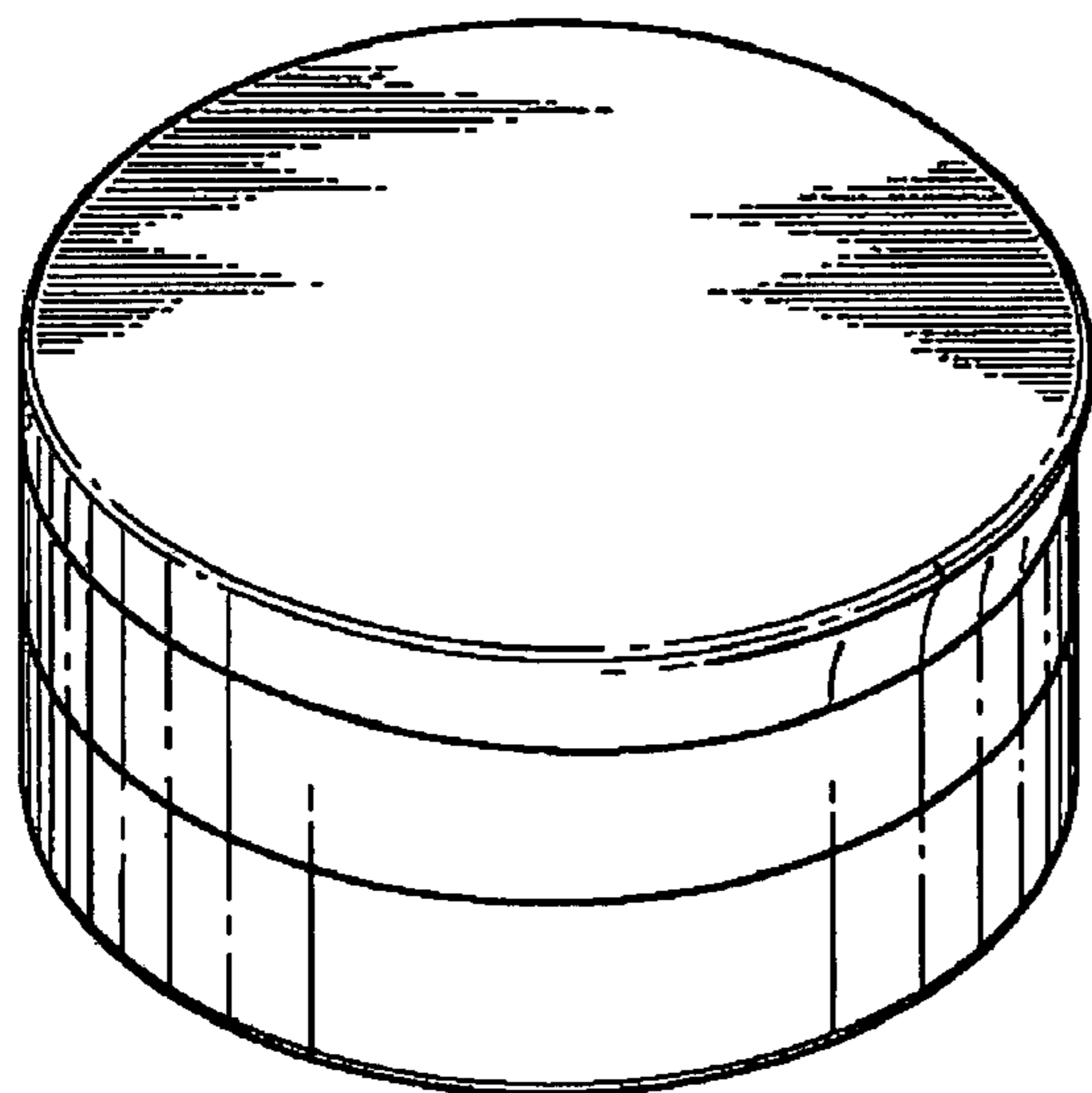
FIG. 3 is a left side elevation view thereof, the right side elevation view being a mirror image;

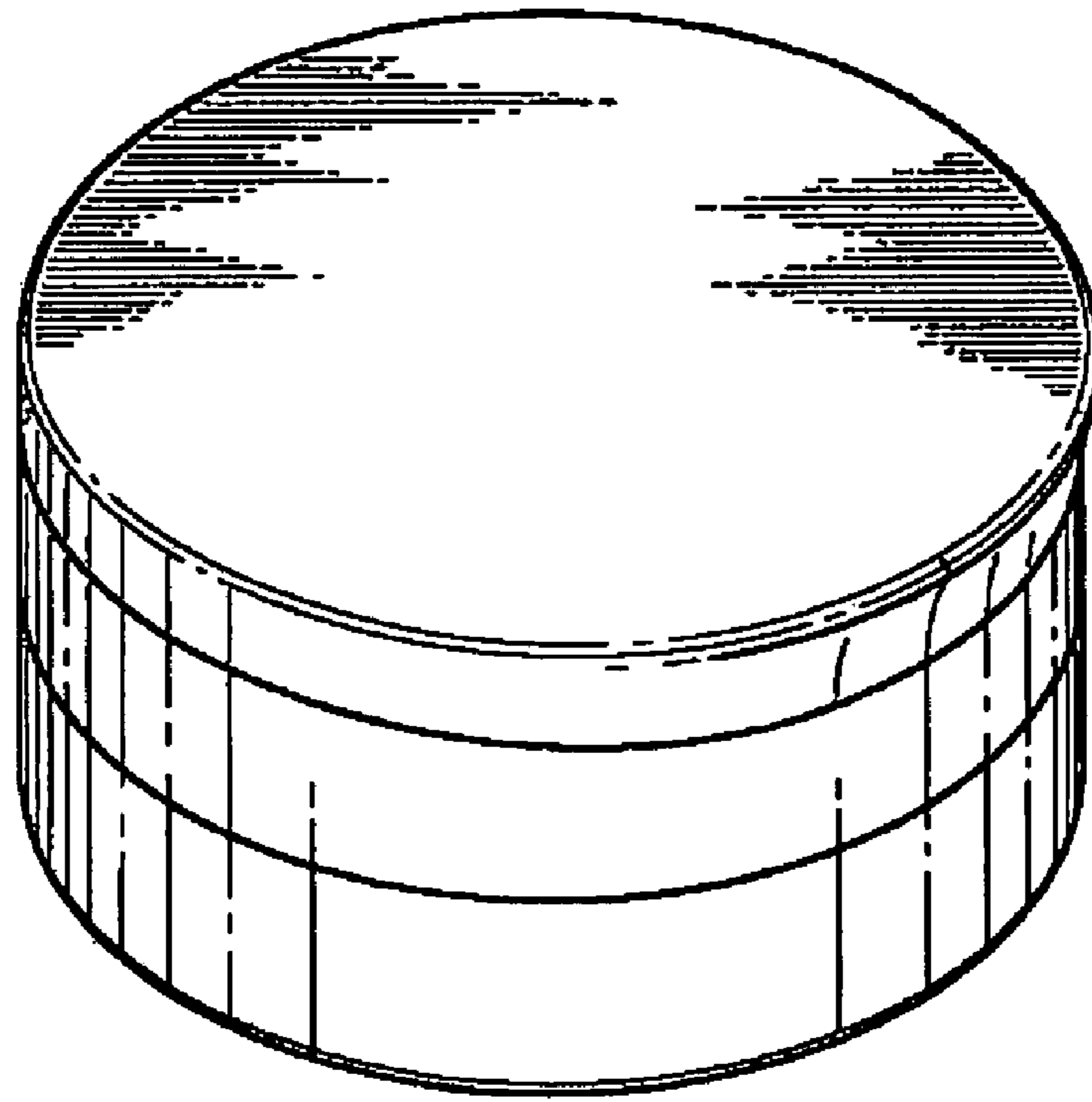

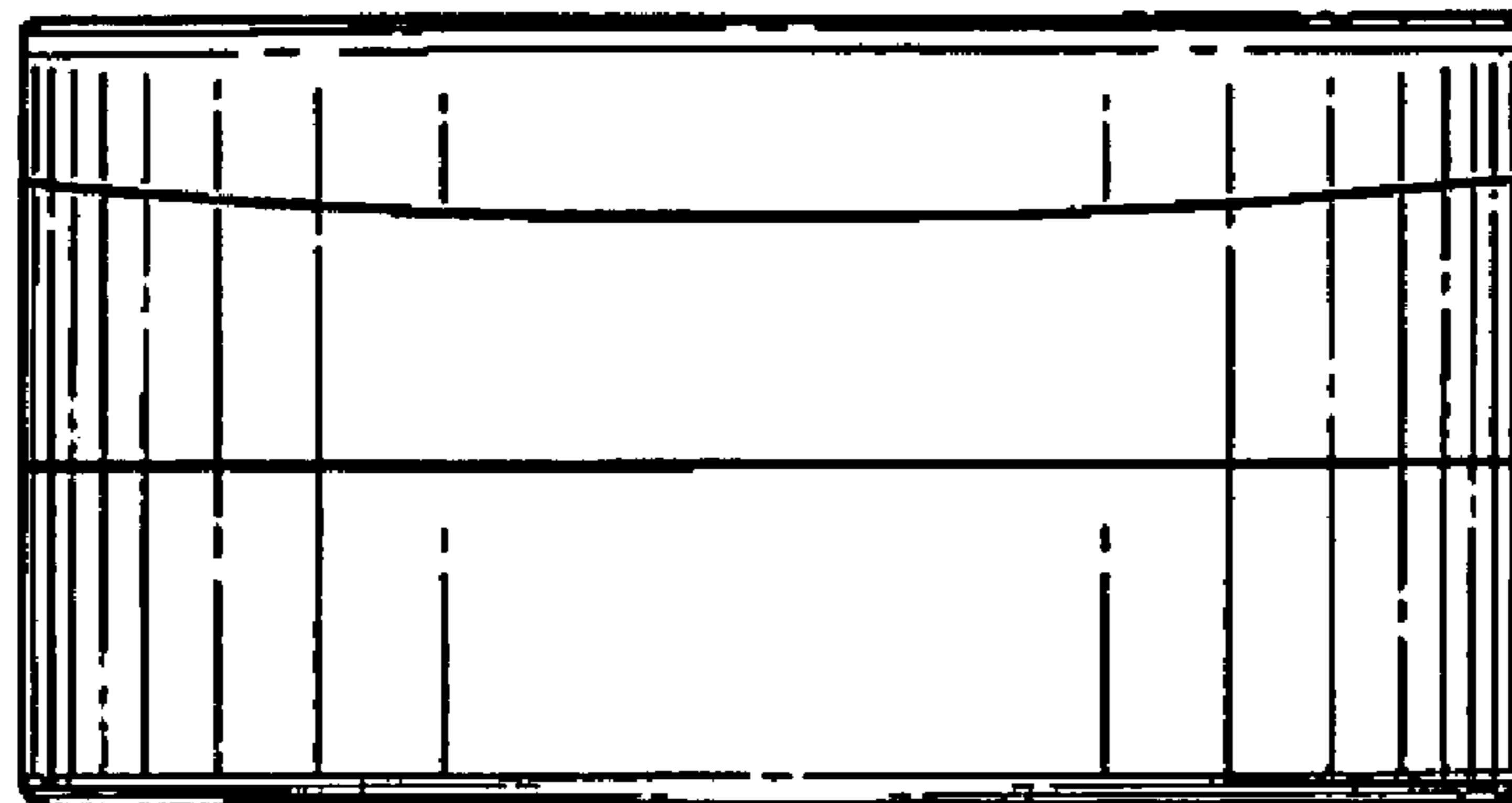

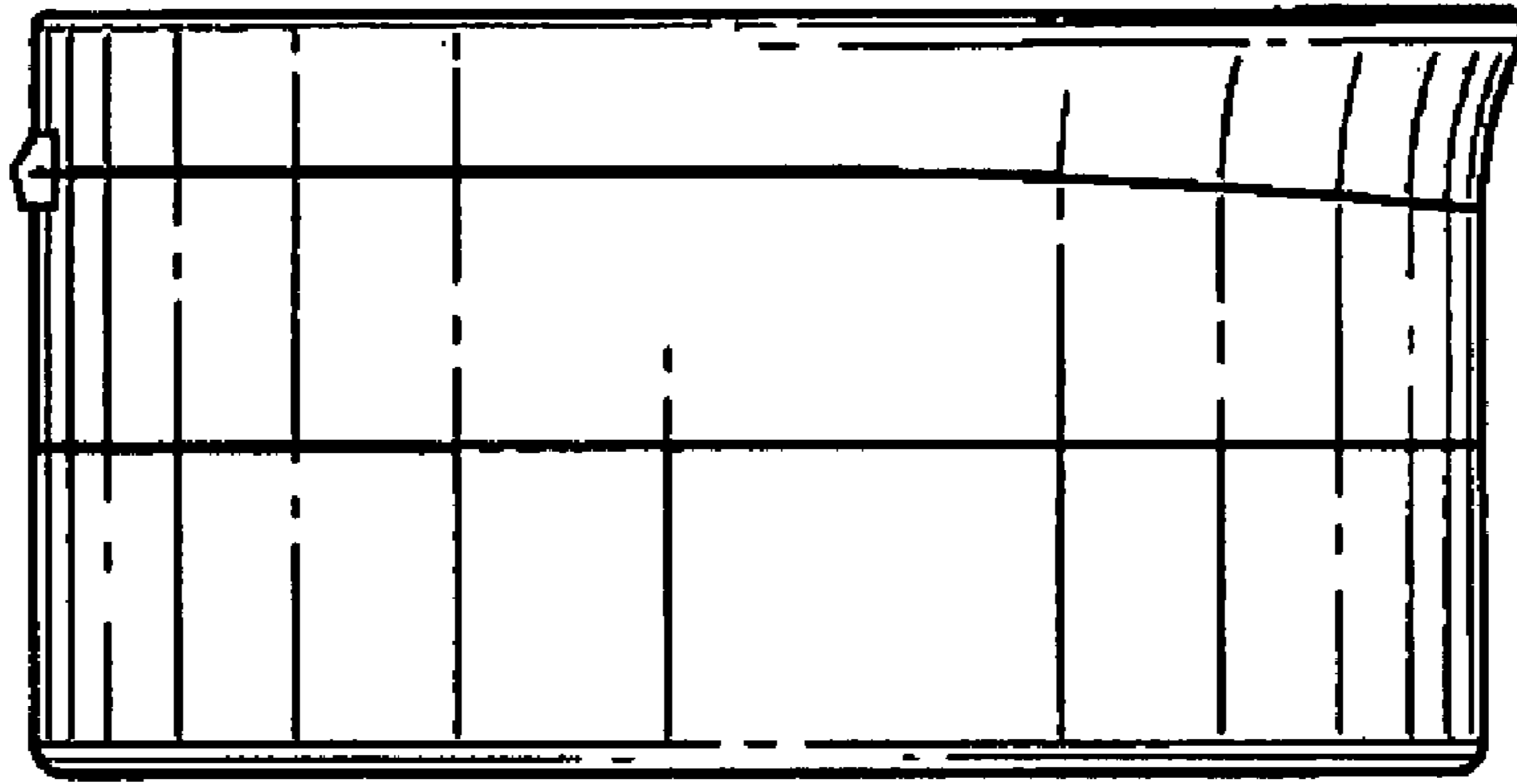

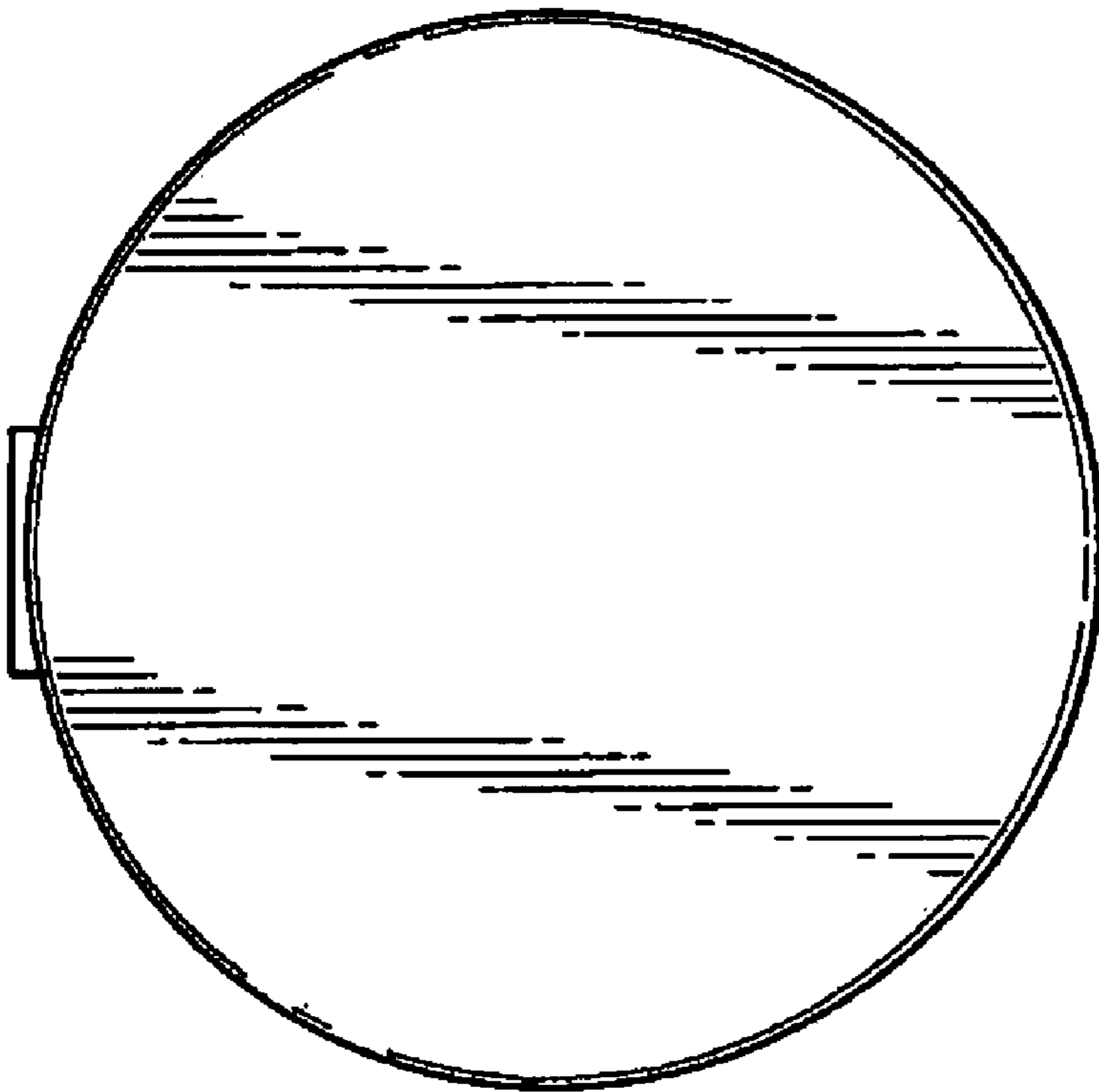

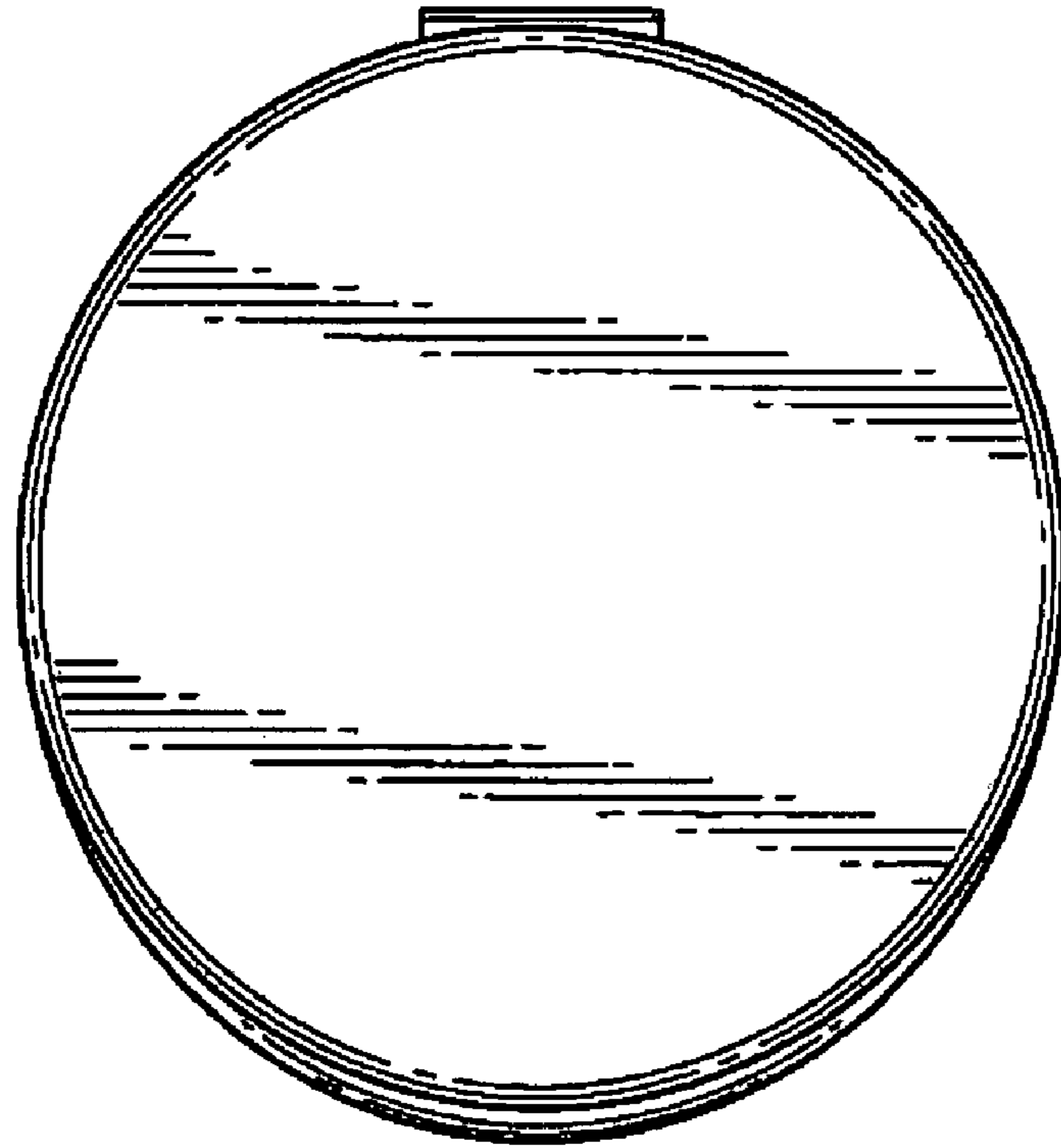

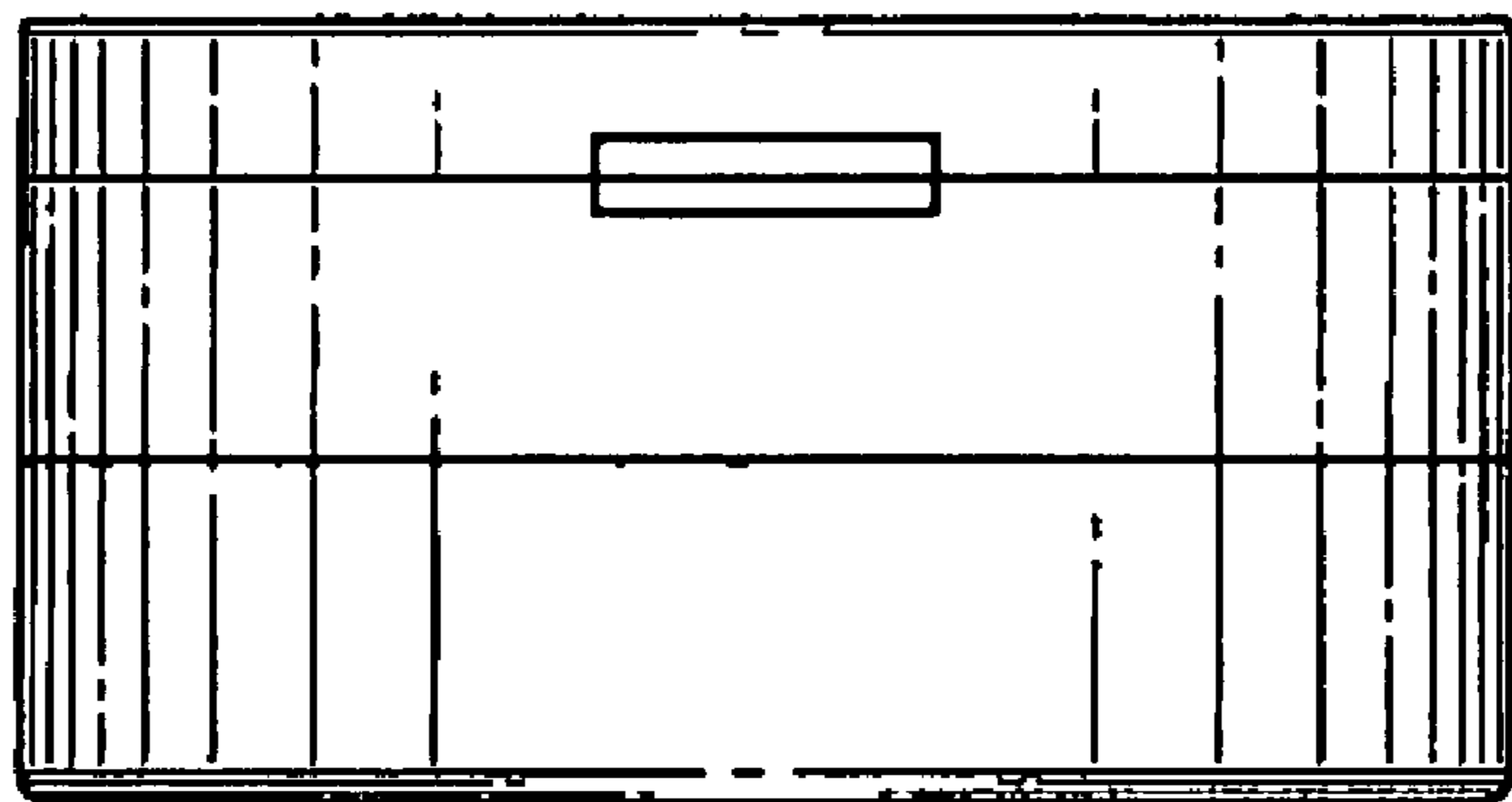
