DESCRIPTION

FIG. 1 is a top and right perspective view of a tube dispenser of the present invention;

FIG. 2 is a left side elevational view of the tube dispenser of FIG. 1;

FIG. 3 is a right side elevational view of the tube dispenser of FIG. 1;

FIG. 4 is a top elevational view of the tube dispenser of FIG. 1;

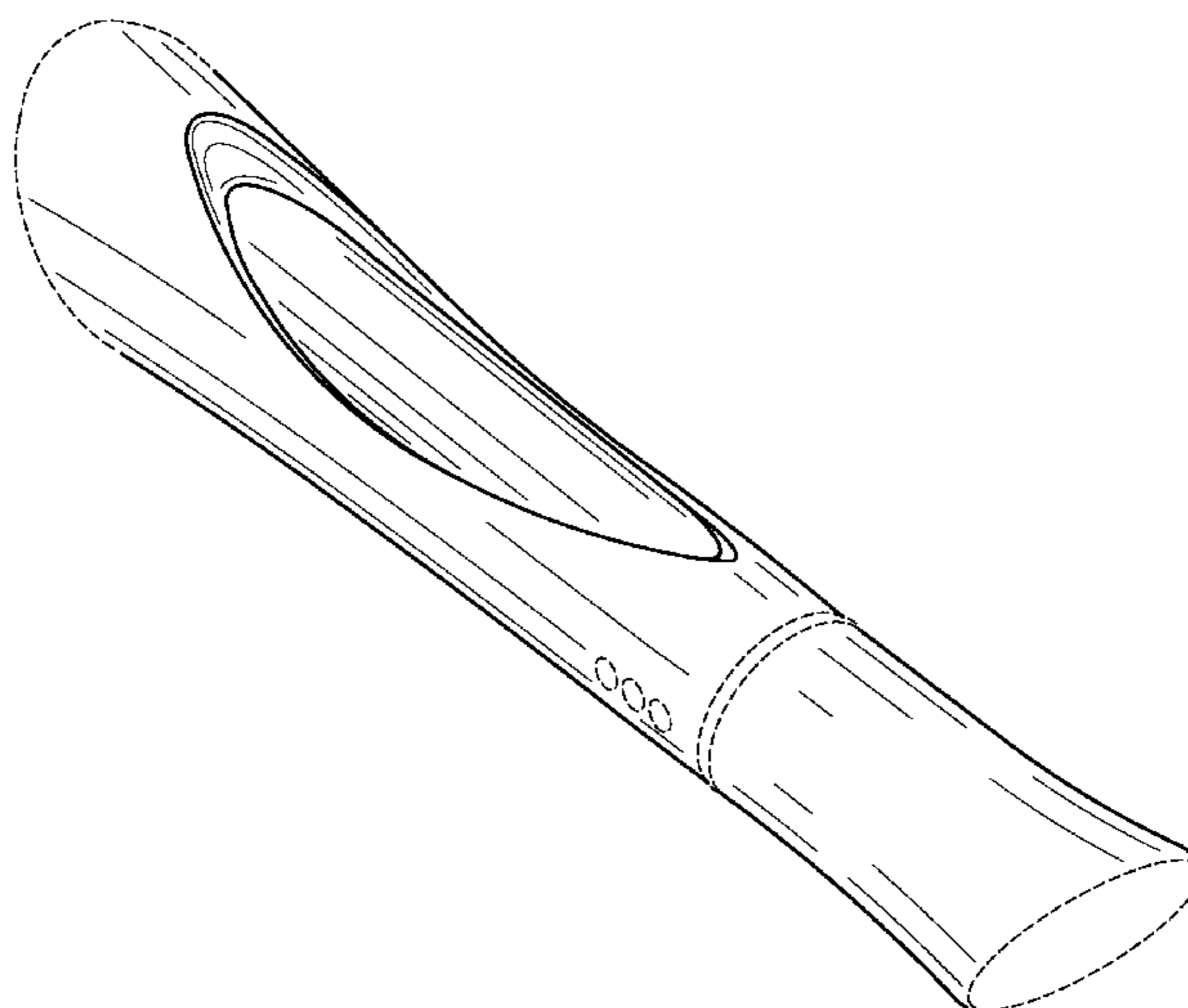
FIG. 5 is a bottom elevational view of the tube dispenser of FIG. 1;

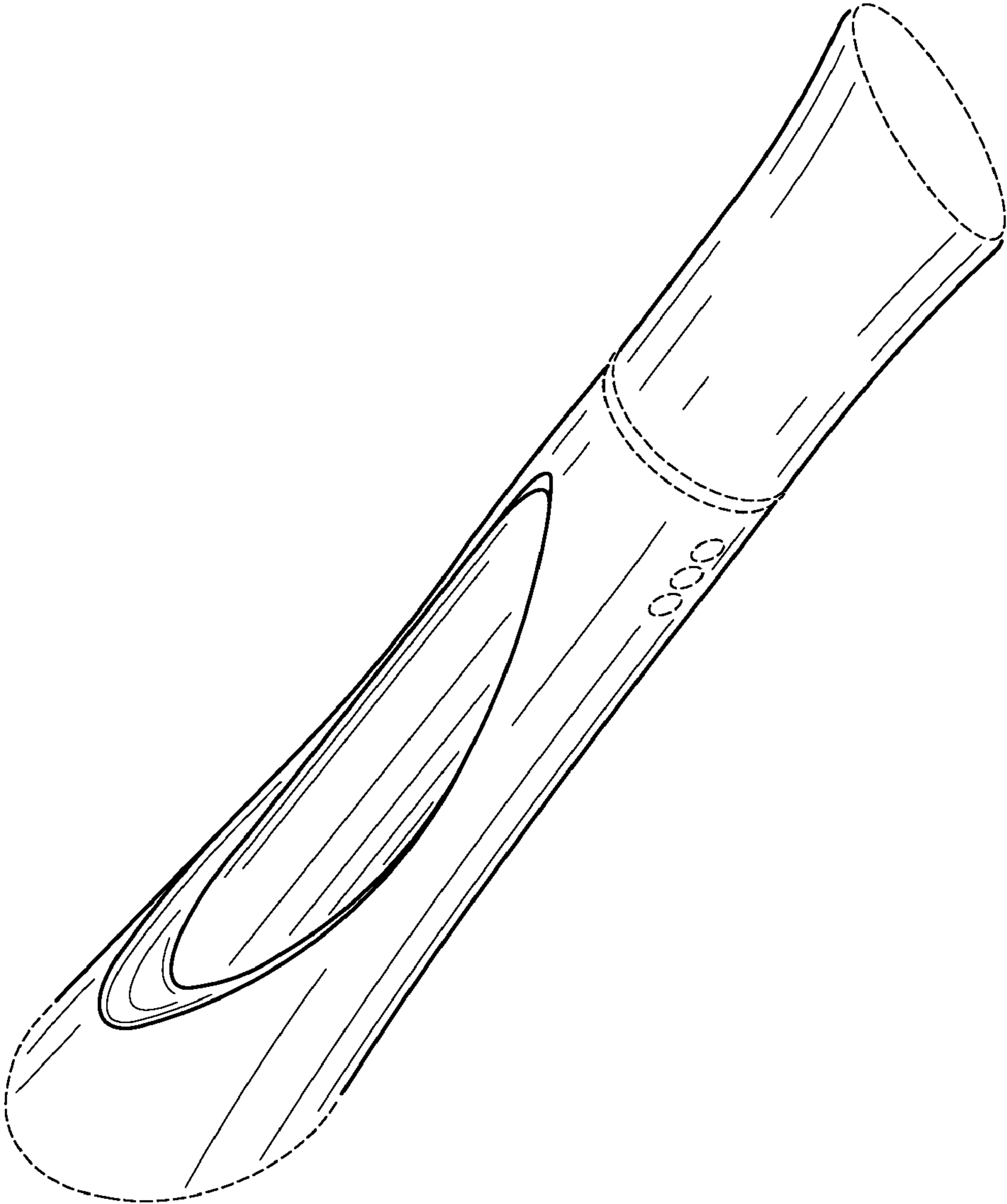

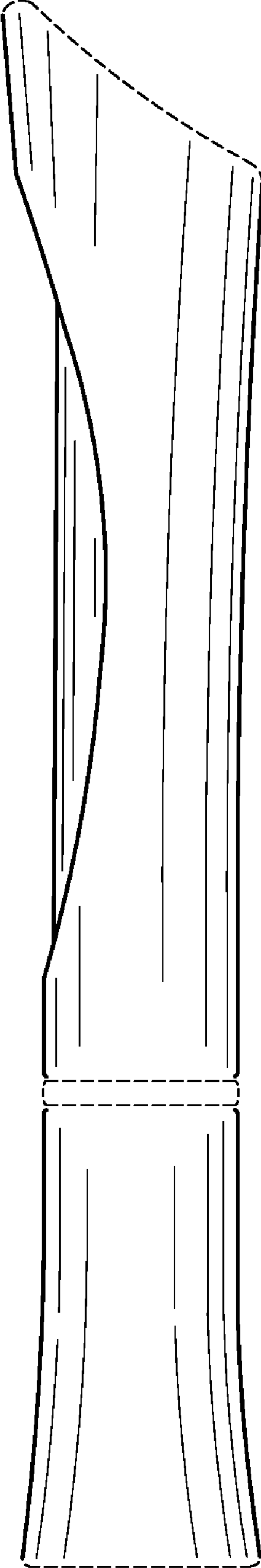

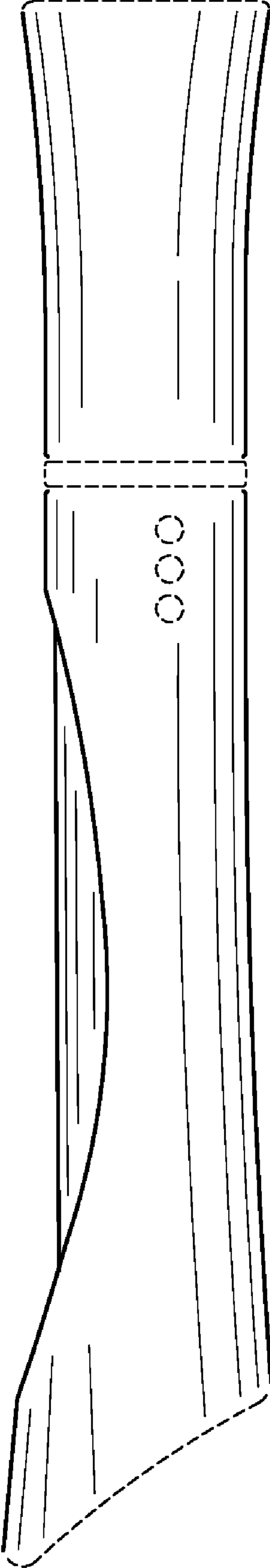

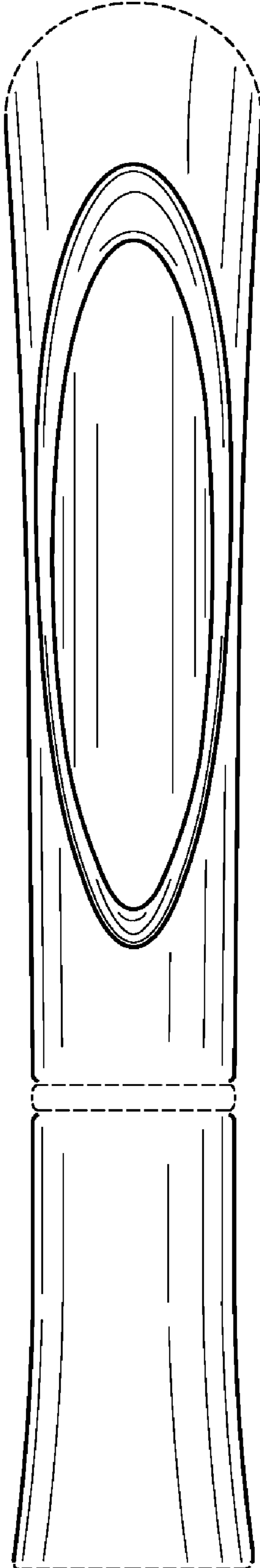

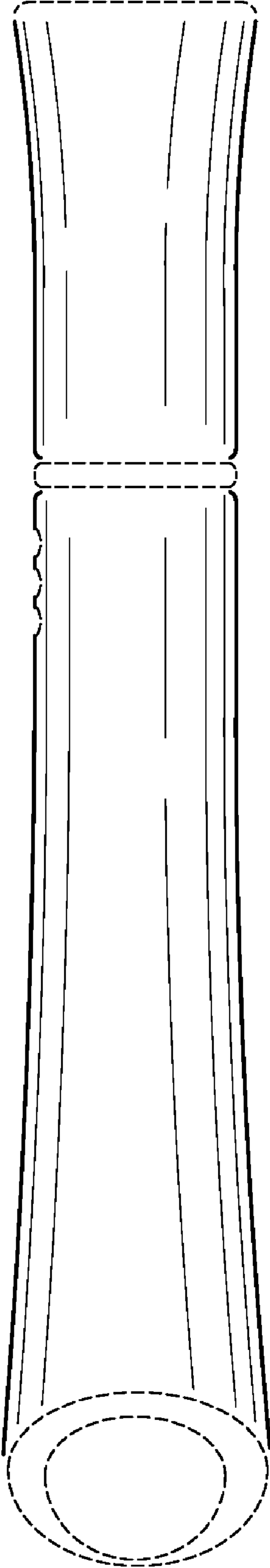

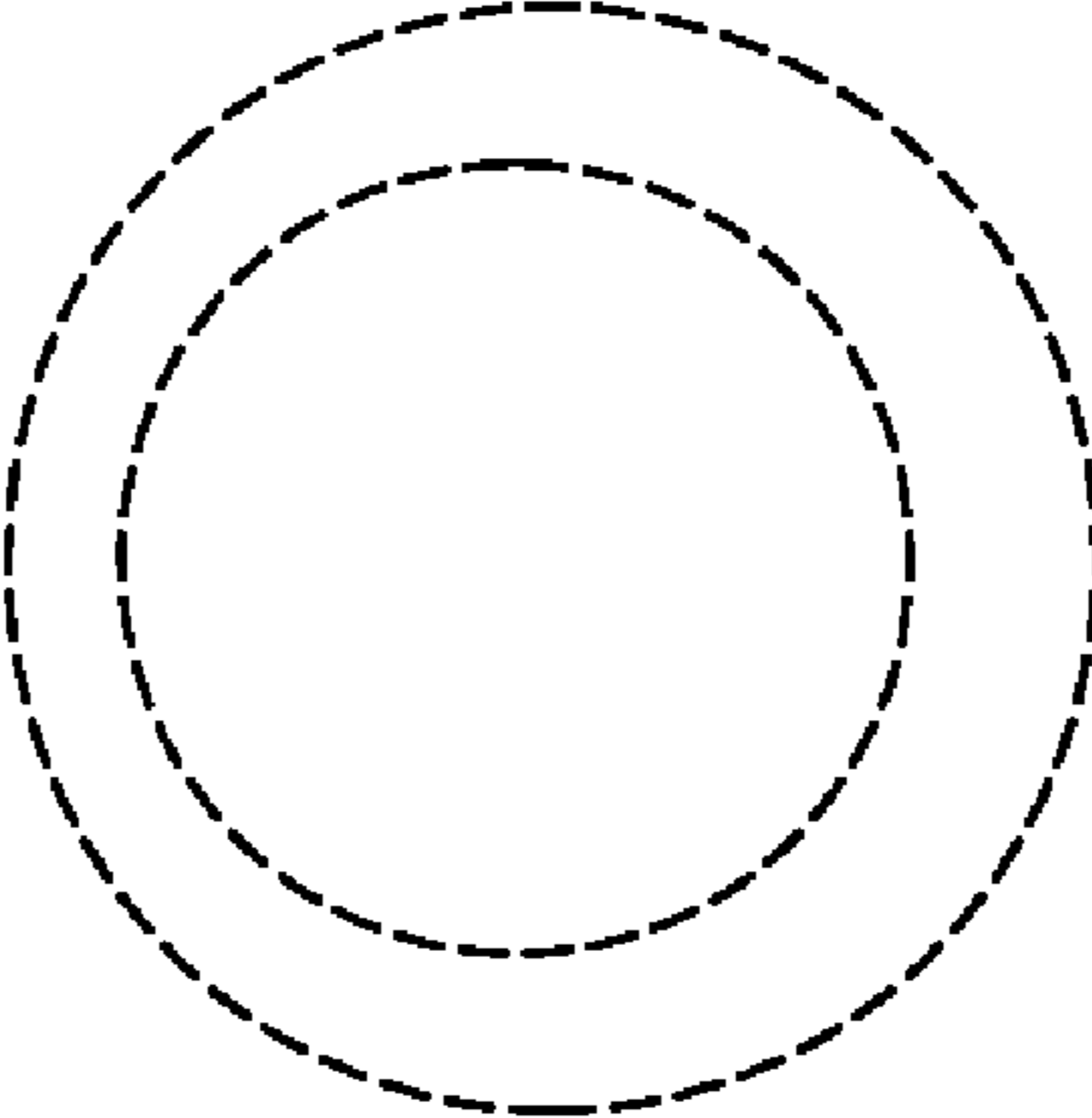
