FIG. 3 is a left side elevation view thereof;

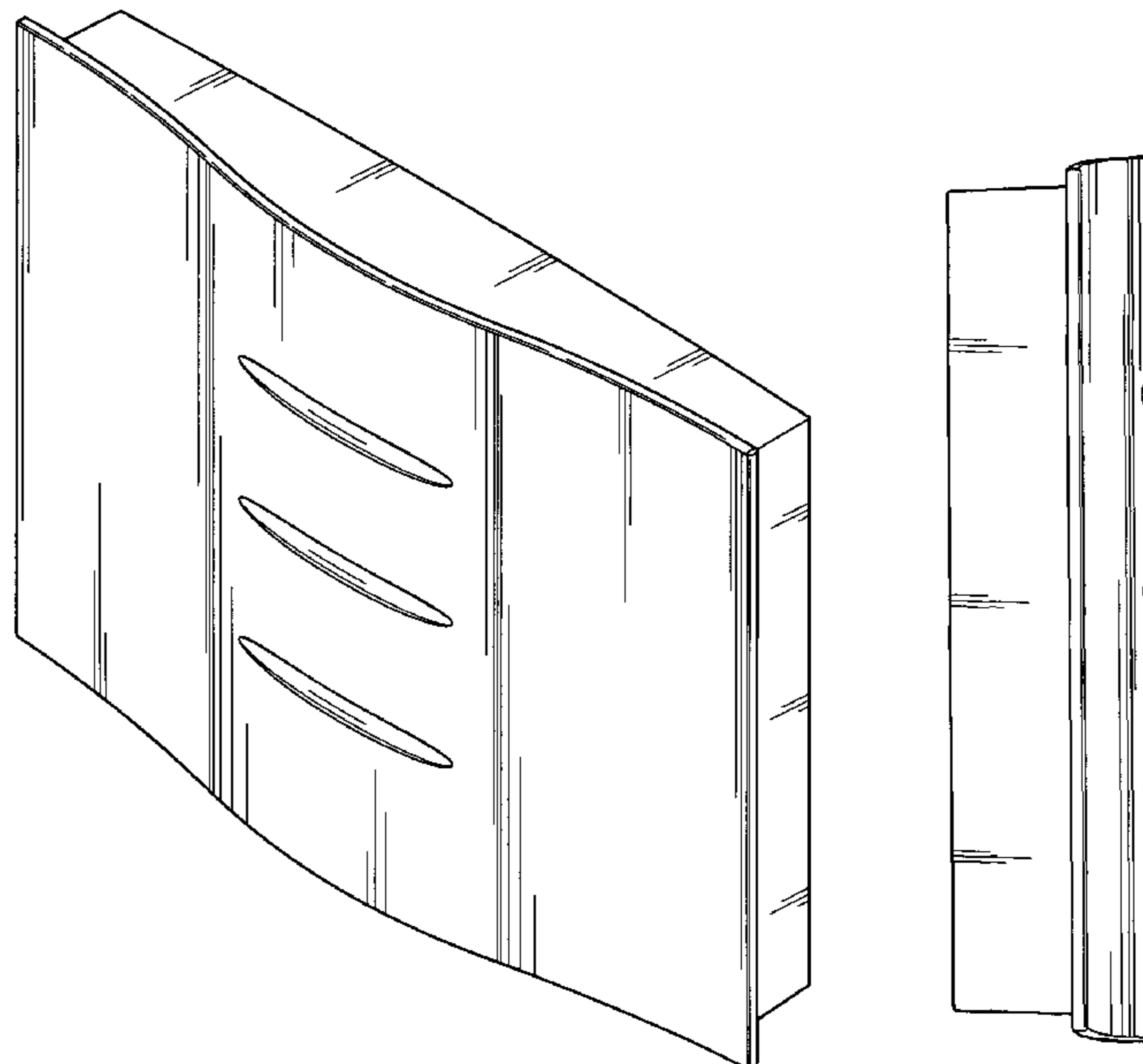
FIG. 4 is a right side elevation view thereof;

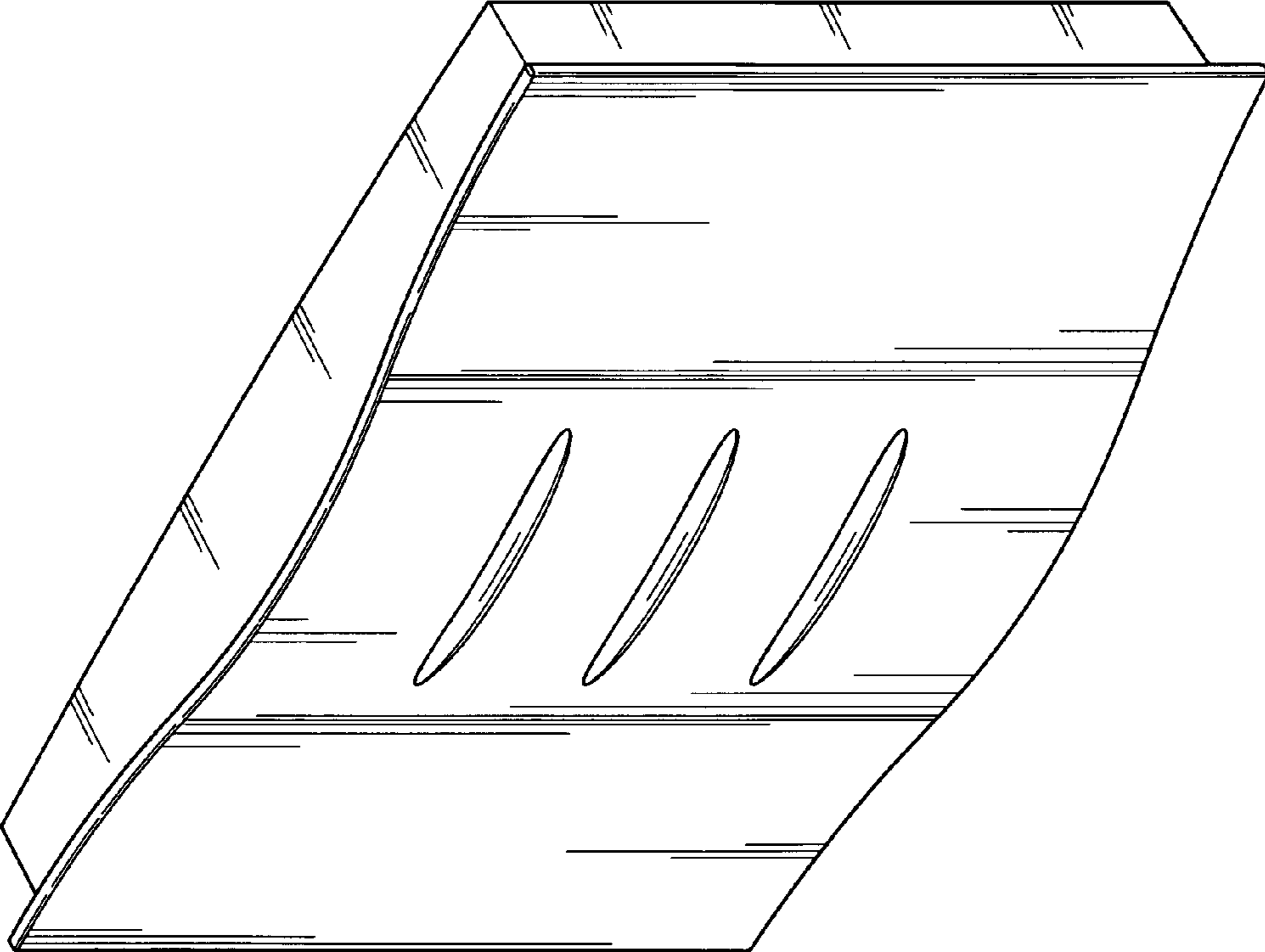
FIG. 5 is a top elevation view thereof; and,

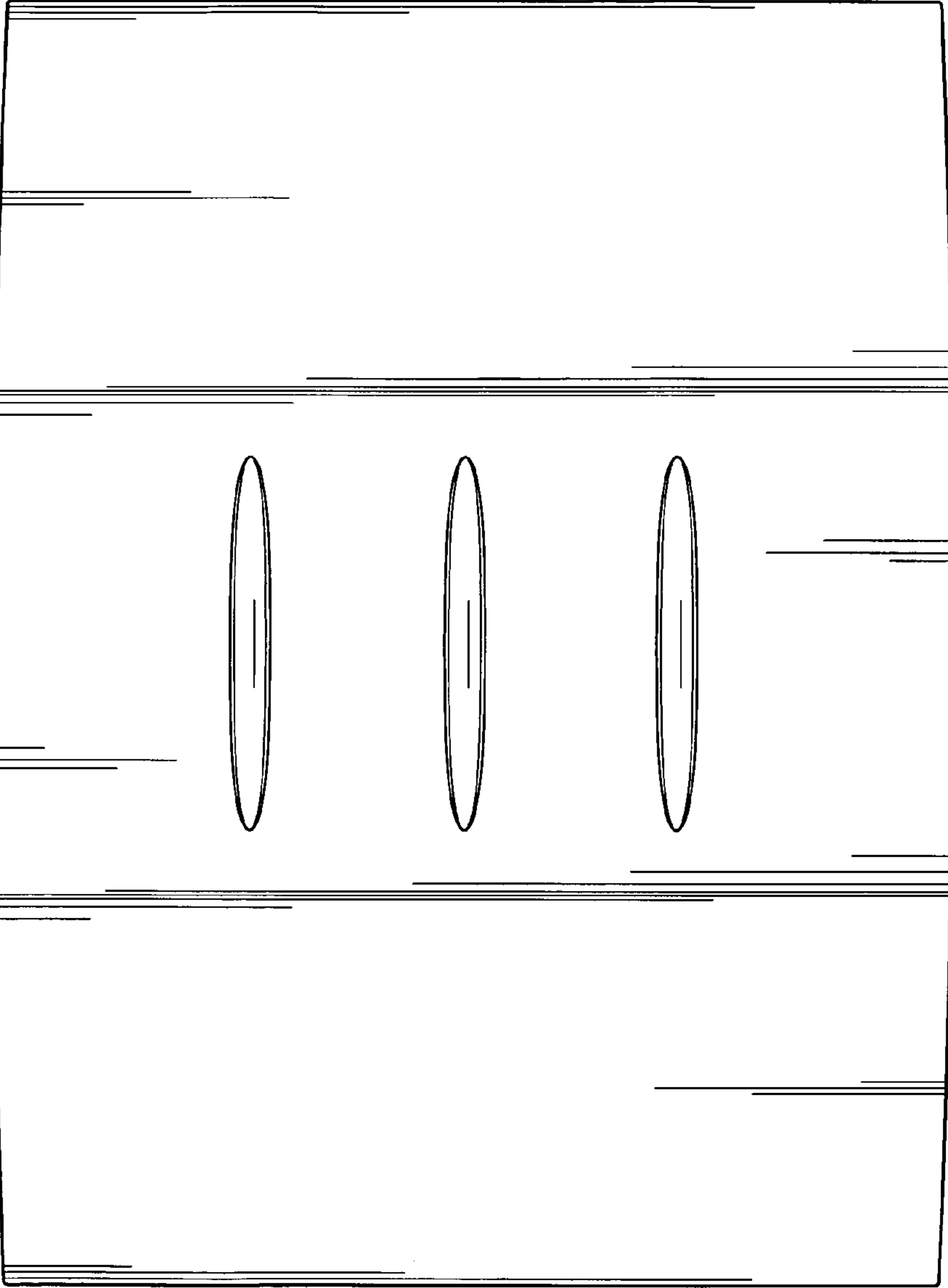
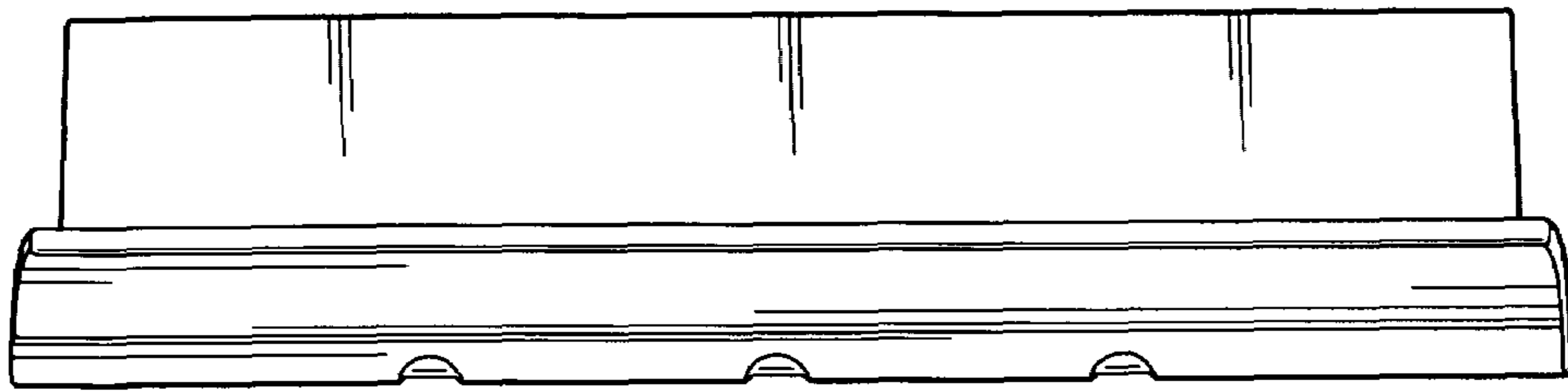
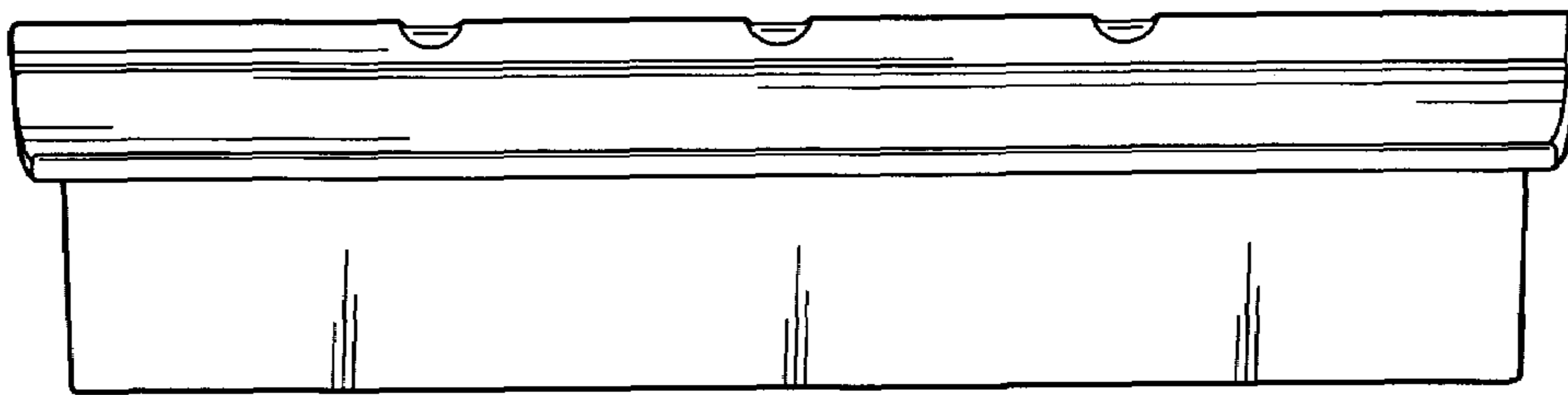


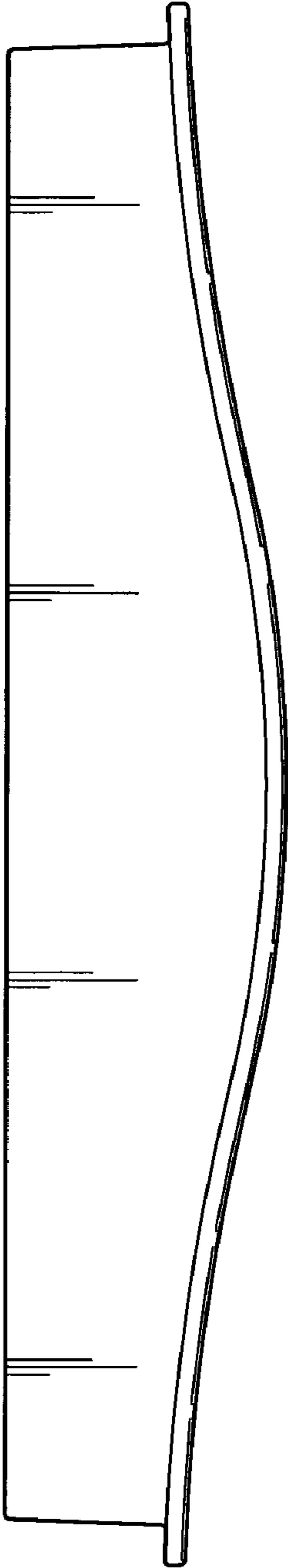

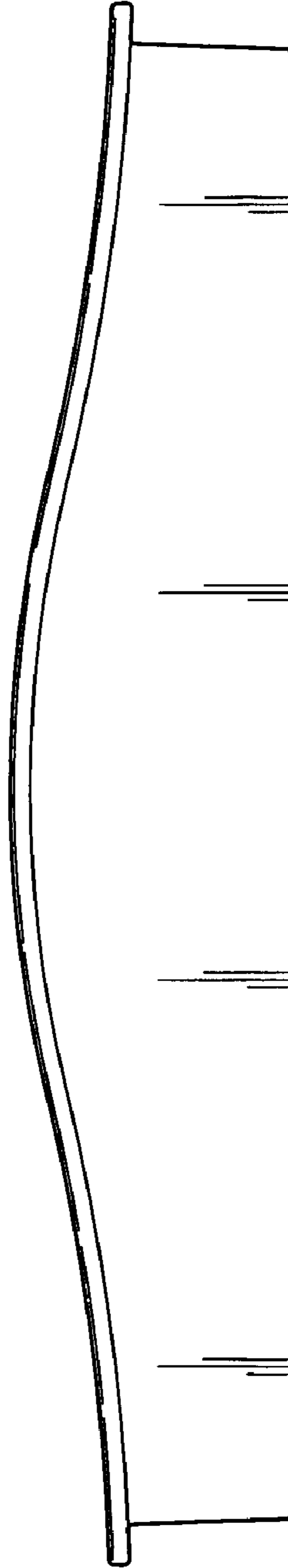
