FIG. 1 is a perspective view of a bell ornament showing my new design;

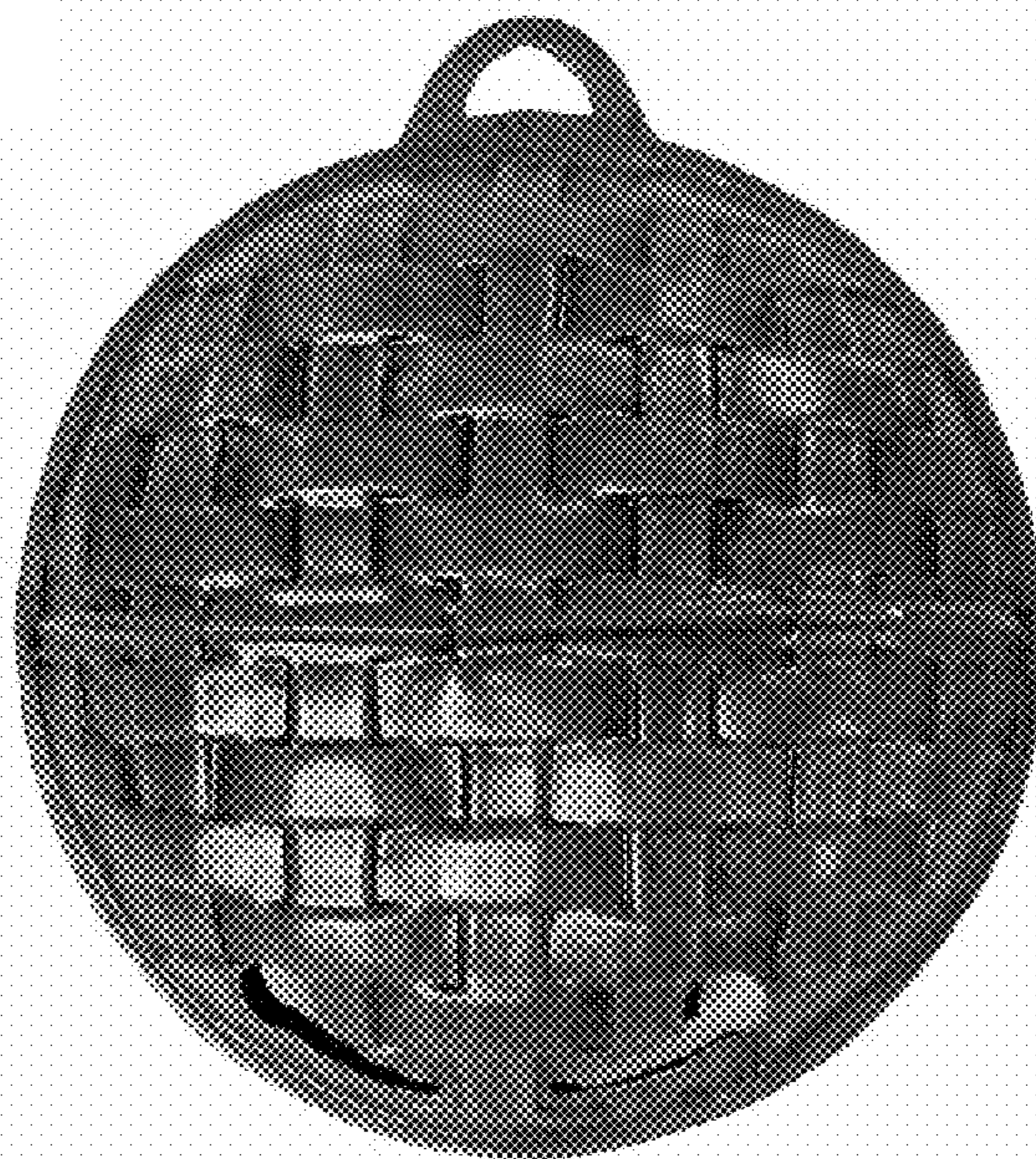
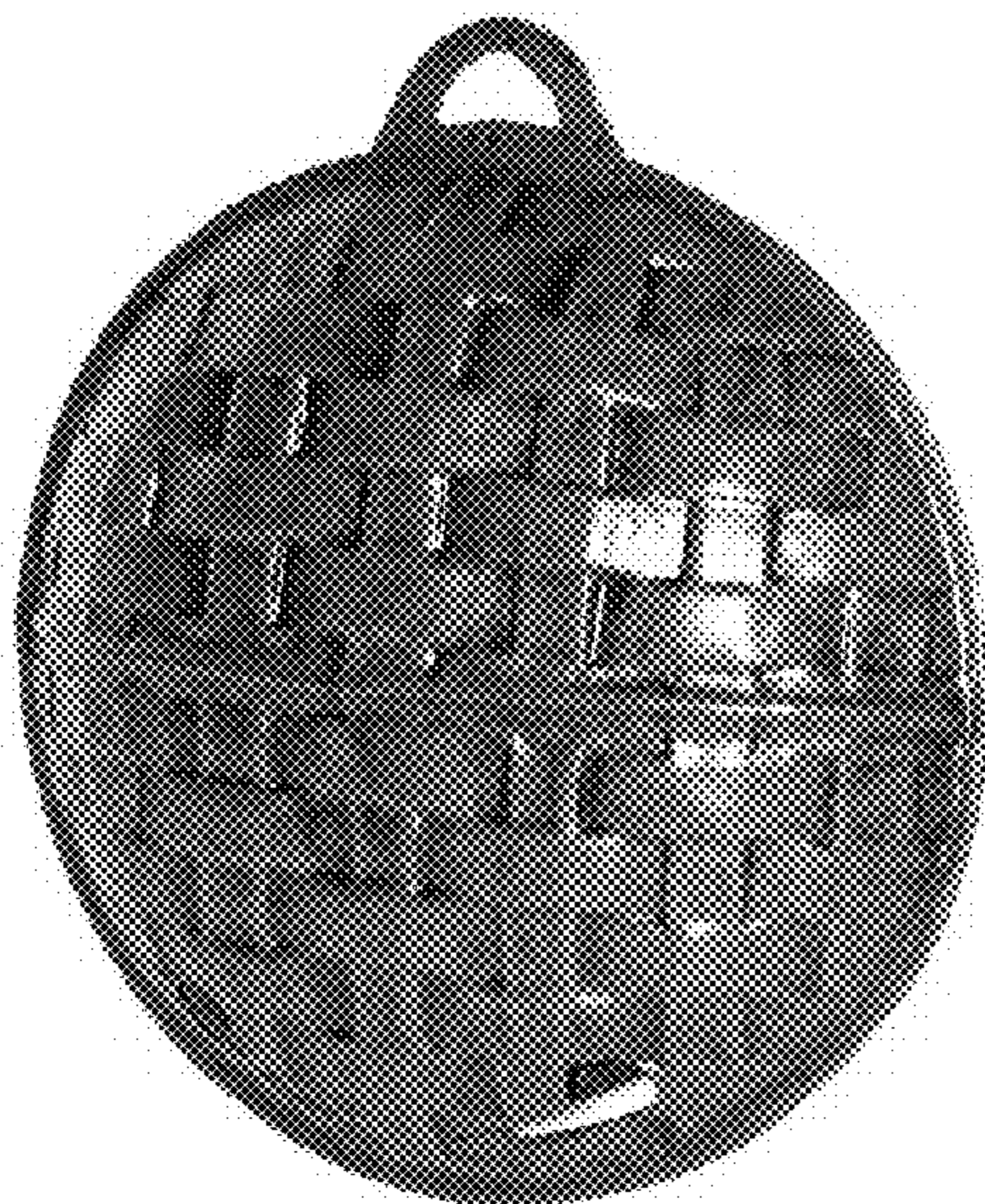
FIG. 2 is a front elevation view thereof, the rear elevation view being a mirror image;

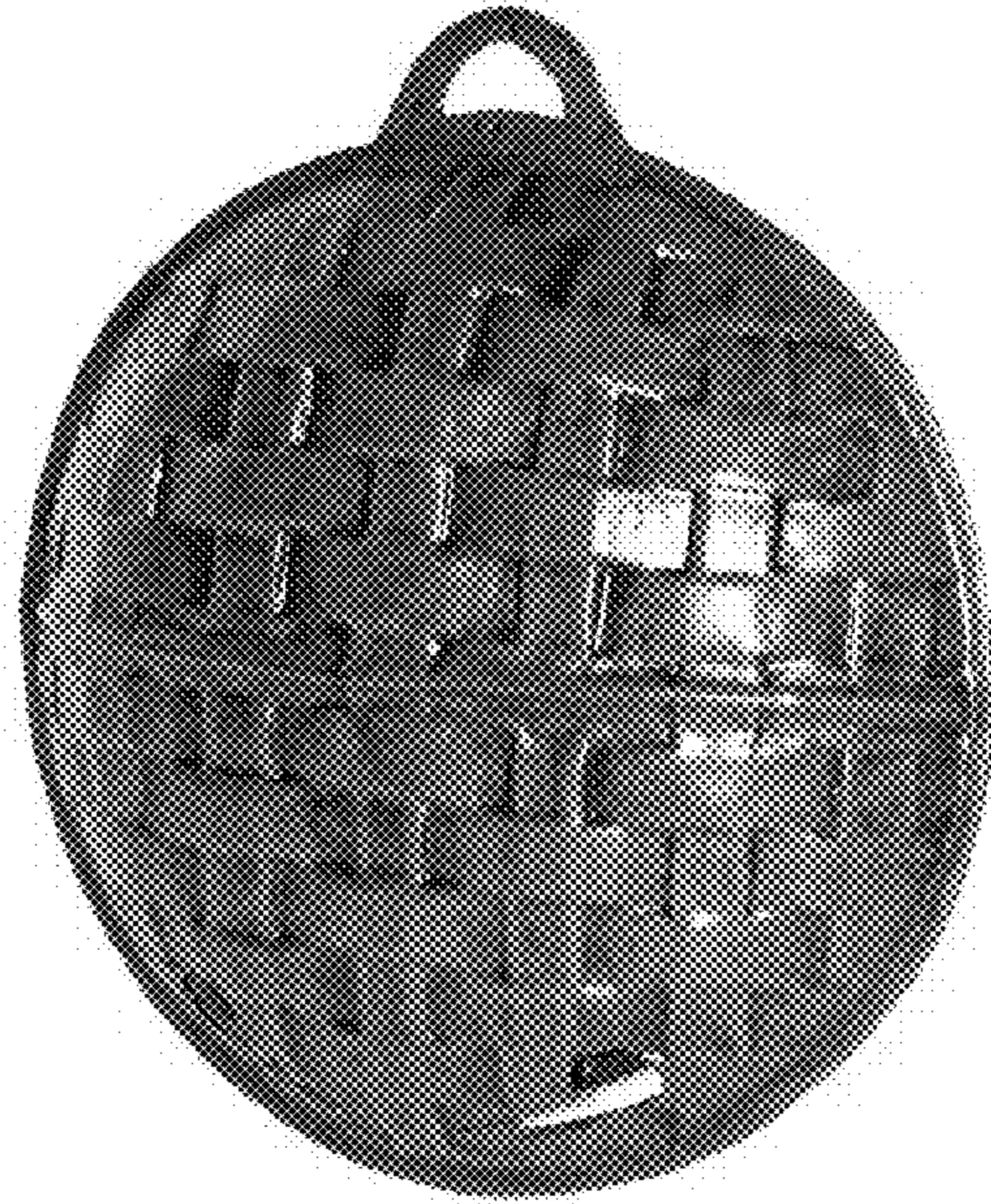

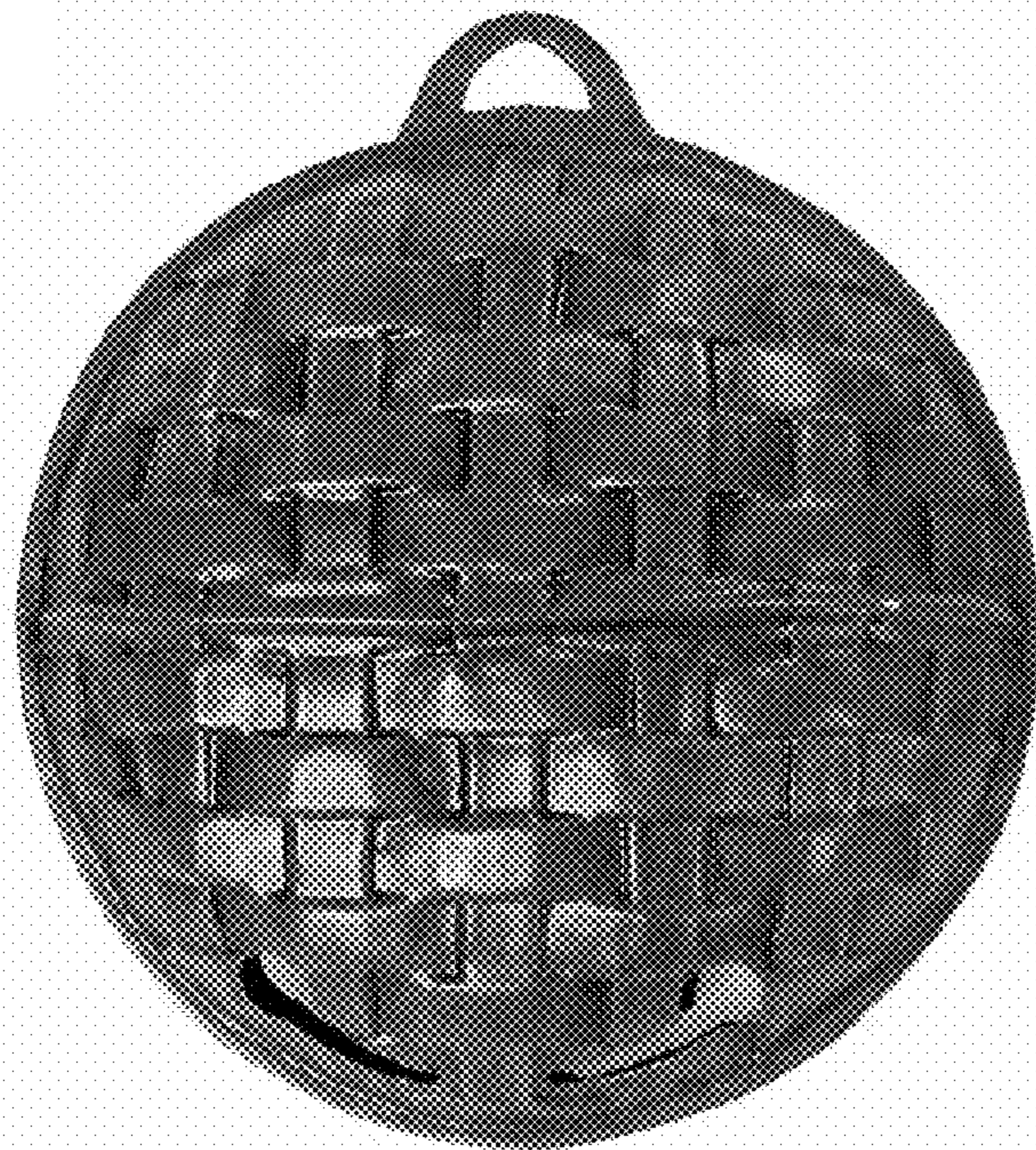

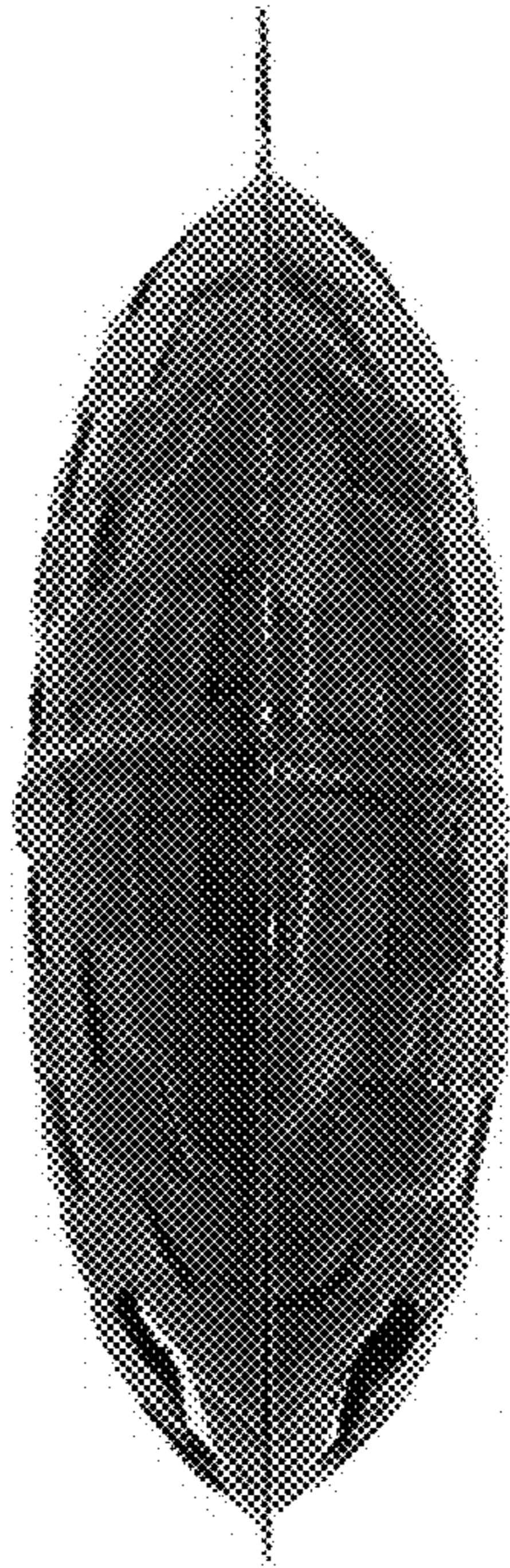

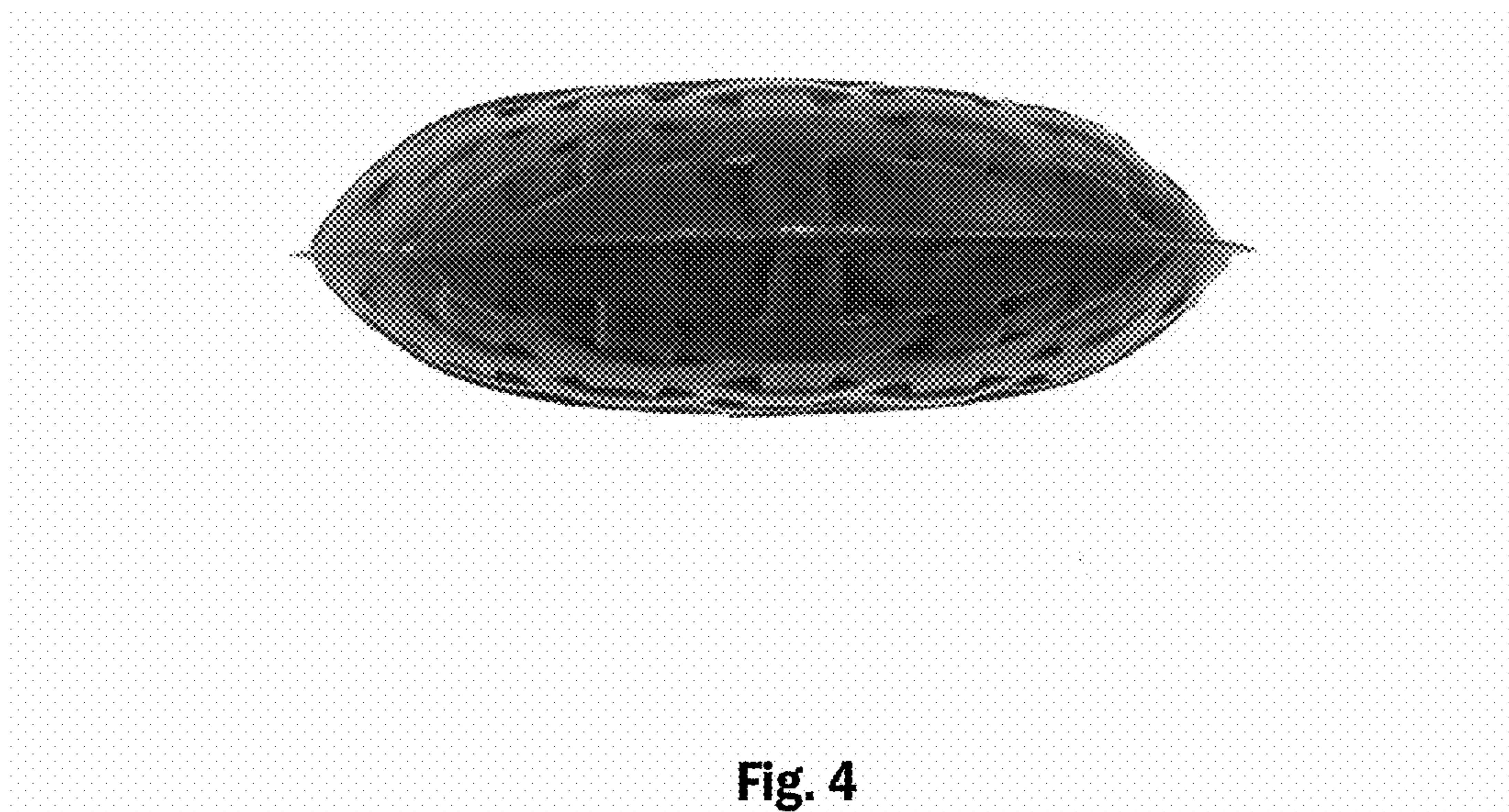

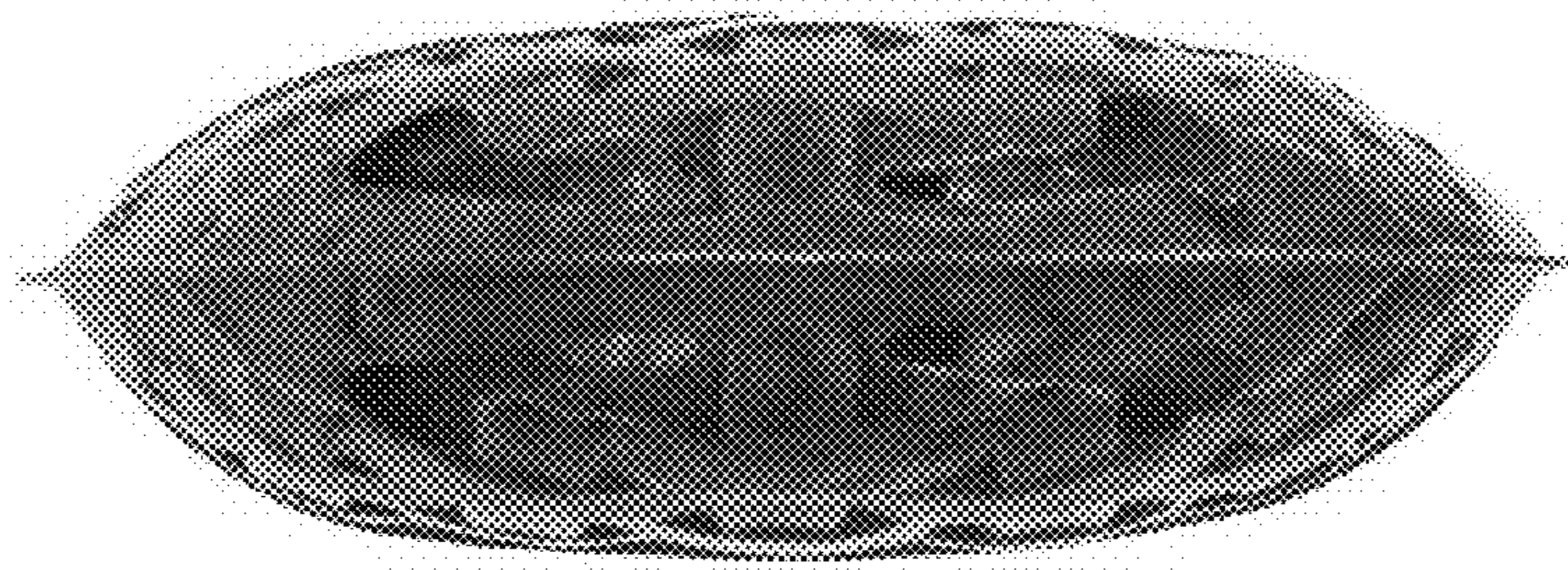
